

# City Council Delays Vote on Park Master Plan

# Recreation and Parks Commission returns to the drawing board By Elisa Osegueda

After a year of preparation, several public hearings, multiple community meetings conducted by the Recreation and Parks Commission, the City Council opted not to vote on the Roxbury/La Cienega Park Master Plan B-3 at Monday's City Council meeting. A unanimous consent by the City Council sent the Park Master Plan back for revisions to the Recreation and Parks Commission.

Over 150 people were present at Tuesday's meeting. Residents and members from the Southwest Homeowners Association, Beverly Angeles Homeowners Association, AYSO, Senior Citizens Adult Club, Beverly Hills Basketball League, and Beverly High students, among others voices their concerns about the conceptual development.

"The Commission was asked to come with a wish list," said Beverly Hills Mayor Jimmy Delshad. It's a matter of deciding "do we need it or wish for it."

According to Recreation and Parks Commissioner Marc O'Krent, the plan present-

ed to the City Council was a direct result of the input received from "eleven meetings, 18,000 surveys and over 5,000 pieces of mail that this commission and staff undertook to create these conceptual designs."

The City Council "really wanted us to do the right thing and go out and get good feedback and come back to them with some strong recommendations," said Recreation and Parks Commission Chairperson Michael Blumenfeld.

The majority of community concerns focused on the Roxbury Park Master Plan. The La Cienega Park Master Plan received no significant opposition at the City Council meeting. According to the Recreation and Parks Commission the La Cienega Park Master Plan received community support for both the concepts and park elements drafted prior to the meeting.

The plan presented to the City Council recommended enhanced landscaping and park amenities. In addition, the following modifications were suggested, a pedestrian bridge,

expansion of Community Center by 6,600 square feet, play area renovations to comply with the Americans with Disability Act, renovations to athletic field, addition of a small snack concession and outdoor seating. Lastly, increased surface parking and enhanced pedestrian entrance to service both the Olympic Boulevard and Gregory Way entrances.

"On La Cienega [Park], there has been little consternation over our deliberations. On Roxbury [Park] there has been much," said O'Krent. "Our plan for Roxbury, called B-3, adds no new recreational facilities to the park. Rather, by reconfiguring the Park to meet current and expected future demands, over 14,000 additional square footage of open, green space is obtained."

The Roxbury Park Master Plan B-3 included recommendation for the construction of a Community Center, enhanced picnic areas, a parking structure to accommodate 169 vehicles with tennis courts on the roof top of the structure, two new park restroom buildings, enhanced parkways and athletic fields, water feature, and 14,600 square feet increase in green space.

Delshad liked the additional 14,600 square feet of extra green space Plan B-3 includes, but he did not agree with moving the tennis courts.

The Park Master Plan was not able to accommodate all of the recreation elements recommended for the Community Recreation Center. Some elements included an indoor pool, a large

### **Crime Gun Identification Act Passed Senate Floor**

The Crime Gun Identification Act AB 1471, authored by Assemblymember Mike Feuer (D-Los Angeles) passed the Senate Floor with a 21-17 vote. The legislation requires that all new models of semiautomatic handgun to be microstamped with its make, modeland identification number for any guns sold after 2010. MIcrostamping is used to identify guns during crimes. The markings are invisible to the naked eye and are difficult to delete. They are also replicated on all bullet casings fired from the gun. Currently, 45 percent of gun crimes in California go unsolved for lack of evidence.

The bill, AB 1471, has the backing of the Los Angeles Police Department, the Peace Officers Research Association of California (PORAC), as well as scores of other police departments and organizations throughout the state.

Parks cause sparks By Rudy Cole

Seven top brass of the Beverly Hills Fire Department will be invited to take examinations for chief in the first step of a process to find a replacement for Chief Dale Geldert who retires next month.

However, all seven may not apply for the top job: In some cases the promotion could mean a loss of income because of overtime pay and, for at least one officer, a second job.

According to our sources, Chief Geldert, who came to the department after a distinguished career with a top state fire agency, has successfully completed a training process making it possible to promote from within instead of going outside the city.

Following the examinations, City Manager Rod Wood will complete the selection process and name a replacement, probably early next month so that Geldert will have some time to mentor his successor.

Our congratulations to Geldert, Wood and all the likely candidates. Promoting from within will be a good morale booster for all city agencies. The city will probably ask Chief Geldert to accept a consultant's job to further assist with the transition.

Plans for major improvements in Roxbury Park created far too much heat and anger despite weeks of talks between residents and park users, and Recreation and Parks staff and Commission. (See story on page 3)

Although the department thought it had reached a compromise with neighbors and a major homeowner association, at Monday's city council hearing, it all came apart.

At the conclusion of a lengthy and often contentious public hearing, the council would not even approve plans for La Cienega which had received no objections from neighbors or those involved in park programs.

What is really on the table is a park's master plan. Approval of the plan would not mean immediate development of each and every element of proposed changes, but a gradual implementation of improvements including an increase in open space, a new community center, a parking facility and improved sports

Dropped were plans for an aquatic facility which had faced strong opposition from some neighbors of the park.

What was most disturbing during Monday's hearing were some not so thinly disguised political threats and a breakdown of the agreements the department thought it had reached.

Elsewhere, you can read about the major elements of the proposal, but let's examine a few that created the most heat.

First, as always, Southwest Beverly Hills Homeowner Association president Ken Goldman was very persuasive and passionate in listing his objections to the plan, this despite reports he had signed off on compromises and changes made since the original, and far more ambitious master plan, was first

Supporting Goldman were representatives of one of the oldest neighborhood associations, Beverly-Angeles, first organized to fight overdevelopment in Century City but largely dormant in recent years.

Although most of those attending the hearing opposed many of the changes, there was universal agreement that Roxbury needed major improvements including facilities and

grounds with no objections to La Cienega improvements.

Most vociferous objections were made against an enlarged community center and basketball facility and a parking structure.

Issues of safety were expressed for an underground parking structure and the most often voiced or implied objection: the possibility that the new facilities could attract "outsiders."

Some realities: Roxbury is NOT a passive park and never has been. It is the most used park in the city with major meeting rooms, programs for seniors, tennis courts, playing fields, lawn bowling, basketball courts, volleyball, croquet and much more.

Do people from outside the city use our parks? Of course, they do. We are not some isolated village far removed from a major urban area and we interrelate with our neighbors, our economy depends on it. We don't tell shoppers our stores are for residents only. We use countless resources in Los Angeles funded by that city's taxpayers- everything from museums to the Greek Theatre and to Los Angeles parks such as Rancho, our nearest public golf course.

Our first priority should be to serve our own seniors, youth, sports teams and others and that is most likely to happen when and if we improve park resources, not by creating artificial fears and barricades.

The concerns of the neighbors, even though they did not suddenly discover they lived near an active park, should, however, be addressed. The improvements and additions should be made in the least intrusive park



As **AJ Willmer** correctly argued, a parking facility should have resident support because it will reduce street parking. It should not be used for any other purpose and numbers of spaces should reflect actual park user needs.

Although raising voices and emotions at public hearings is not a new phenomena in our village, there were some ugly moments Monday night. One speaker, who had before the hearing been reasonable and helpful during the long process, suddenly lashed out at former Mayor **Steve Webb** who had spoken in favor of some, but not all, of the master plan proposal. He said that Webb now "sits behind me" because he did not listen "to the people" and he warned the council that they too would lose the next election if they approved the department recommendations.

I have loads of differences with Webb on all kinds of issues, but all of us should recognize his over 20 years of public service and give him the respect he has earned and the appreciation we don't always express to people in public life. What was disappointing was that no councilmember responded to the personal attack

As for the irate citizen: I hope we judge elected officials on their complete record of service and posture on community issues and not just any single issue.

The city council should consider and further respond to neighbors concerns and make every effort to allay fears, but this problem of services in residential areas is not easily overcome. I doubt if the homeowners near Hawthorne are thrilled with the twice daily arrival of cars delivering and picking up students. As for residents near the high school, try using approaching streets during opening and closing of the high school and you will understand what they face every school day.

Parks and schools serve our whole city and were not just carved out of serene environments to meet new needs. Another generation of residents/taxpayers had the vision to create both Roxbury and La Cienega to serve all the people of our community, especially young people and seniors.

Should we do less? I hope not. Sensitivity to neighbors issues, of course. But this is a beginning not an end product and each element of the Parks Master Plan will have to be funded and approved. What the council needs to do is give the department its consent to go forward

Final thought: The youth of our city, parents involved in youth sports, participants in park programs and all those who appreciate our parks need to take the time to become involved. This is not the time for silence or

indifference. How? Just send me an email and I will make sure it gets to the city council or, better, write them directly.

Three of the four candidates for school board held campaign kickoffs last Sunday. The two incumbents, **Myra Lurie** and **Alissa Roston**, listed major accomplishments while challenger Steven Fenton raised questions about out of district permits and administrator turnovers. A fourth candidate, **Brian Goldberg**, has yet to announce an event although he did do a mailer to permanent absentee voters.

Since the withdrawal of **John Millan**, the election has dramatically changed. First, about Millan. After four years of very laid back service, he has quite suddenly emerged as a very forceful voice in defense of the board and the administration.

Millan, who has special expertise on school construction, has been very helpful in some major school successes. Unlike their cousins at city hall who watched with frustration the enormous overruns when the civic center was built, the major new improvements in our schools, including work at Beverly Vista and the exciting new Science and Technology building came in on time and, are you ready, under budget. This achievement will be a big plus for both Lurie and Roston in their reelection campaigns.

When Fenton first announced, it appeared he would be facing three incumbents and, without him, there would probably not have been an election and without an election, no real opportunity to debate school issues.

With Millan out, Fenton could reinvent himself as almost an incumbent type. He has a long history of involvement in the schools and the community and is emerging as a very vigorous campaigner.

As for Roston and Lurie, and because of the third term issue, Roston is the lone incumbent with any possible reelection problem. For her to lose, Fenton would have to do sufficient damage to the incumbents to elect Goldberg too – probably Goldberg's only real hope for winning. This is exactly what happened when **Barry Brucker** ran his unprecedented successful 1997 write-in campaign that pulled **Gerald Lunn Jr.,** also a political unknown, in with him.

Fenton's issues – permits and turnovers, may have campaign legs. The permit issue is loaded with political overtones and will be hard to defuse. On one side is the argument that without permits, we would have to make very drastic cuts in school services and num-

bers of teachers and administrators and on the other the fact that we could diminish a sense of community based education. Fenton is sharp enough not to favor pulling the plug immediately, pledging not to remove any permit student now in the system. Frankly, to do so would create fiscal chaos.

When you run for office, you need issues. But there are some realities any challenger will have to face: This school board has become very functional and has avoided the horrendous internal squabbles that made the community lose confidence in past boards. We have had a turnover of top administrators, but that began before three of the current board members were elected, when **Gwen Gross** unexpectedly decided to leave the top job for Manhattan Beach. We lost an outstanding superintendent in **Jeff Hubbard**, but he received an offer he could not refuse: A much larger district and tons of benefits and a salary we could never match.

It's a complement to our system that our administrators are so in demand by other districts – none have left for lesser jobs. Our new superintendent may well prove to be one of the finest we have ever found. **Kari McVeigh** is excited about making our schools even better and her enthusiasm is very contagious.

Final thoughts: The teacher's union, BHEA, has endorsed Fenton and Goldberg, in sharp contrast with other districts where incumbents usually are supported. They have an absolute right to endorse even though their decisions may be somewhat naive. In recent years, their victory score has not been too high and widening the gulf with the board, the administration and parents may not be the

wisest strategy.

The incumbent with the least problems is Myra Lurie. It was during her term as board president that the transition of administrators was accomplished with the minimum of angst. She was also an important leader during construction and kept the board focused and very united. As the only lawyer in city or school government, her special talents will not be overlooked by the voters, and she begins with a strong base of support among PTA members.

# BHHS Football Team Still Winless

Norman girls' tennis team defeats Palisades to open season. By Steven Herbert

Two lost fumbles that Santa Barbara scored 10 points off of and a 95-yard touchdown run help lead to Beverly High's 30-20 loss at Santa Barbara Saturday night in a nonleague football game, as the Normans continued their second-worst start in Carter Paysinger's 18 seasons as coach.

Beverly Hills (0-2-1) allowed 16 unanswered points after Norman senior running back Ramon Judkins ran for a 52-yard touchdown in the first quarter, tying the score, 7-7.

On the first play of Beverly Hills' next possession, quarterback Erik Munzer fumbled away the snap, leading to John Uribe's seven-yard touchdown pass to Bryson Lloyd, as the Dons took the lead for good.

Santa Barbara (2-0) scored the second quarter's only touchdown on Tad Slaff's 95-yard run, six minutes, 46 seconds

before halftime, two plays after Norman kicker Monty Zimmerman had a field goal attempt blocked.


Slaff (182 yards on 17 carries) also scored the game's first touchdown on a 31-yard run.

The Dons increased their lead to 23-7 on Ruben Hernandez's 37-yard third-quarter field goal on a drive that began with Lloyd recovering a Norman fumble.

Judkins (84 yards on 13 carries) cut the deficit to 23-13 with 5:15 left in the third quarter on a nine-yard touchdown run. Santa Barbara responded with Uribe (16-for-22 for 147 yards) throwing his second touchdown pass to Lloyd, this time for six yards, with 1:12 remaining in the third quarter.

Munzer, usually a receiver, started at quarterback for Beverly Hills in place of the injured Dex Lucci, completing 12 of

fitness center, and a rock-climbing wall, among others.

"Our job is to meet the needs of 32,000 people and sometimes people are not happy and sometimes some people are. We want to create something that will last for many years and not just a short fix," said Blumenfeld.

According to the Recreation and Parks Commission, concerns about the lack of a budget to implement the Park Master Plan have been voiced. They anticipate for the Park Master Plan to cost from \$19 to \$57 million. The entire Recreation and Parks Facilities fund has approximately \$3,570,000 in unreserved cash fund balance.

"When I heard the cost [of the Park Master Plan] I took pause. If we are going to spend this kind of money we need to do it intelligently,"

said Councilmember Nancy Krasne. "I will be very fiscally responsible. I need more details to move forward. I need more."

The Commission says it is normal for a plan of this magnitude to be developed without a set budget. Currently the City Council has approved \$500,000 for the Park Master Plan effort. Furthermore, the Commissions said they expect to obtain grants, bonds, general fund dollars and outside contributions to absorb the cost of the project.

The Park Master Plan budget was of concern to the City Council and various members of the community.

"We do not need a massive project. We don't need to spend millions for things people are not even clear on," said Beverly Angeles Homeowners Association President Esther Brenner. "It would be imprudent to support something with no accurate price." Delshad agreed that the Park Master Plan needs various revisions. "I am not ready to go there. I need to know a lot more. We are on the right direction," said Delshad. "I want to see a plan with a maintenance budget."

According to Vice Mayor Barry Brucker, "all five Councilmembers believe in fiscal responsibility when dealing with tax payer's money."

In regards to voting on the Park Master Plan Brucker said, "The park is a jewel. I don't think we were ever ready to give the green light. There are some lose ends that need to be massaged. Lets give it back to the Commission to massage," said Brucker.

City Manager Rod Wood suggested bringing forward a "demand study on parking." To assess how the new parking structure would impact resident streets and traffic.

City Councilmember Linda Briskman said

she prefers "to renovate, then to reconstruct. Maybe some things can stay and others can go. We need more conversation on what everyone agrees upon and then see what's more prudent."

All City Councilmembers agreed to send back the Park Master Plan to the Recreation and Parks Commission. They suggested for the Commission to continue dialog with the community and assess ways to improve parking surrounding the parks without the need of a new parking structure and ways to lower expenses

"At the end of the day, whatever directions the council wants us to take we are ready, willing and able to do," said Blumenfeld. "We are excited to help put and be a part of the community and to do something so that 20-30 years from now we can be proud of."

22 passes for 136 yards, including a 10-yard fourth-quarter touchdown pass to Dewayne Taylor for the game's final score. Munzer also had a pass intercepted in the fourth quarter.

Norman senior receiver Dominique Sandifer made eight catches for 111 yards, both game highs.

Beverly Hills' only worse start since Paysinger became coach in 1990 was in 2004 when they started 0-3 and finished the season 3-7, including a forfeit victory.

The slow start is unlikely to have any bearing on whether the Normans will qualify for the Southern Section Western

Division playoffs. The top three teams in the Ocean League, based on their records in league play, automatically receive playoff berths.

Beverly Hills is winless (0-3-2) in its last five games dating back to last season, its longest winless streak since a six-game streak (0-5-1) late in the 2003 season and early in the 2004 season.

Santa Barbara was 1-9 in 2006.

Following a bye week, the Normans are scheduled to play host to Manhattan Beach Mira Costa Sept. 28 in a nonleague game at Nickoll Field beginning at 7 p.m.

# COVERSTORY PARKING RATES RECONSIDERED

### But will the city see the much-discussed return of 2-hour free parking?

Parking rates for the City's off-street parking facilities were presented to the City Council at Monday's informal meeting. After a year and a half of implementing onehour free parking rates the Council was presented with three free parking options for the residents of Beverly Hills.

Based on the Staff Report presented to the City Council during the 2003-2004 budget planning process, the City experienced a large loss in sales tax and transient occupancy tax revenues due to post September 11 economic conditions.

As a result, in order to balance the General Fund budget, the City Council transferred \$2 million of parking meter revenue out of the Parking Enterprise Fund and into the General Fund to avoid a budget deficit. The Council intended to replace the Parking Enterprise Fund revenue by eliminating free parking, but postponed the action due to business opposition.

Currently the city of Beverly Hills operates 15 municipal parking structures.

The Parking Enterprise Fund finances construction, operations, maintenance and improvements of the City's parking facilities. Due to the \$2 million revenue loss the Parking Enterprise Fun experienced a \$1.3 million operating deficit. In order to restore funds free parking was eliminated. Onehour free parking rates were implemented on January 19, 2006 in five City owned public parking facilities. Eliminating the twohour free parking rate previous adopted.

During the first year of operations, the Parking Enterprise Fund obtained approximately \$2 million in revenue.

According to Councilmember Linda Briskman the two-hour free parking was approved to stimulate sales tax at a time when the City needed it. It was intended to be a boost for the business community.

"Over time it became a drag on the economic vitality of the parking operations and the merchants preferred to try a one-hour free scenario provided the City would reinvest the dollars to maintain and rehab the structures which were badly in need of repair," said Briskman.

With over a year and a half of adopting the one-hour free parking rate the Finance and Parking Operations staff conducted an analysis in which they recommended three free parking options and five revenue enhancement options to the City Council.

Councilmember Nancy Krasne played a key role in having the issue placed on the Council's agenda. "I have been asking for it every month since I was elected. It was a promise I made to the voters and I am going to stick to it."

The three parking options consisted of a two-hour free parking program, a resident discount parking plan, and a subsidized validation program.

The two-hour free parking program would affect the 216 S. Beverly Dr., 345 N.

deficit of \$2.7 million in the currently fiscal year and a total deficit on \$19.6 million deficit over a five-year period.

The residential two-hour free program would allow residents the privilege of twohours free parking in the facilities mentioned above. Based on residency verification users would be eligible for the discounted parking rate. This optional resident program is estimated to cause \$340,000 in revenue reduction with a deficit of \$1.2 million in the current fiscal year and a \$3.2 million deficit in the 2008-2009 fiscal year. This type of residential program has already been adopted in Hermosa Beach.

Beverly Hills Vice Mayor Barry Brucker believes that offering "two-hour free parking [to all who come to Beverly Hills] will have a tremendous financial hit on the city."

He agrees with staying with the current one-hour free parking, focusing on smart meters and for monthly parking rates to be

Brucker suggested a 90-day trial offer allowing Beverly Hills residents to take advantage of two-hours of free parking. The trial period "can be implemented after the holiday season and will allow seeing if there are any negative concerns from non-residents and retailers."

Councilmember Frank Fenton disagrees and said that based on statistics and the retailers he has spoken with "the majority of their business comes from non-residents. So although I would like to create benefits for the residents, I think that this measure would make us look bad and I am more concerned with keeping our excellent city services in tact, which I believe is a lot more important for the residents."

Brucker says there are multiple ways that residents could participate in the free two-hour parking trial period. One suggestion is having a resident-type of parking credit card issued by the City, following similar procedures done to obtain a parking permit. The card would be presented to parking tellers to be scanned allowing residents to receive the free-parking credit.

The technology to issue these cards is available but "we are not charting new territory," said Brucker. "I don't think the [free two-hour parking for residents] would hurt at all [the local economy] it may even help it. It will encourage some of our local residents to stay longer and shop more."

The issue is not about residents vs. nonresidents said Brucker, "I really think it was a matter of a lot of residents who were upset that we had to rescind the two-hour parking

In order to generate revenue for the Parking Enterprise Fund five revenue enhancement options where presented to the Council. Recommendations include an adjustment to monthly parking rates, adjusting the off-street parking rates at the Bedford and Camden facilities, adjusting fines for parking citations, adjusting onstreet parking meter rates, and implementing a City-wide parking tax, which would result in annual revenue increases.

Although adjusting parking citation fines by approximately 15 percent would bring as estimated \$790,000 annually, Brucker said he would not want to increase parking citations because "it would really upset a lot of

Beverly Hills Mayor Jimmy Delshad agreed not to raise parking citation fines but instead looking at adjusting on-street parking meter rates. Recommendations received on parking meter rates suggested increasing rates from \$1.00 per hour to \$1.50 per hour, which would generate approximately \$420,000 annually.

Delshad believes the Ad Hoc committee can focus on the parking meters that are credit card enabled.

"People love the credit card meters, people appreciate convenience," said Delshad. "It will also keep outside residents here [shopping].'

There is no reason to "put the city in deficit" said Delshad.

Supporter of the two-hour free parking rates, Fenton said "the restoration of twohour free parking is a signal to the consumer that we welcome them. We want people to come to our city, enjoy a nice meal in our great restaurants and have time to walk around and shop."

Regarding the Parking Enterprise fund, Fenton realizes it could create a deficit in the fund, "but not to the extent of the hit our sales tax revenue will continue to take if we don't get aggressive and welcome the consumer back to our city, our General Fund will take an even bigger hit, which would affect our ability to maintain our excellent public services, including our less than 3 minute response time from the Police and Fire Departments, and our ability to fund the Joint Powers Agreement for our schools."

Recommendations made to the Council by the staff included maintaining one-hour parking rates and adopting revenue enhancement options to eliminate the structural deficit in the Parking Enterprise fund. They also advised to continue with the ad hoc parking subcommittee in order to draft Guiding Principals for parking services. The ultimate goal is for these Principals to be used for the creation of a Parking Master Plan.

"We are a full service, first class city. We are a city where the world meets. We are a little city but everyone knows us world wide. It says everything about the 30,000 people that reside here. And when we start doing things in a second class matter we wont be a first class city anymore," said

Krasne was adamant to bring the parking rate issue up for public discussion.

"The two-hour parking concept should come back to the public agenda at an evening meeting, with a public notice," said Krasne.

Council voted 3-2 to place the topic into the City Council's formal meeting agenda, with Briskman and Delshad voting against.

Briskman said there "was quite simply no material evidence to support changing the one-hour free parking rate in the lots that were tested. The sales tax numbers stayed healthy, the merchants and the Chamber voiced their support to retain the rates and the customer feedback showed no significant number of complaint calls."

Briskman believes there is "no reason to go back to the old rates. None of the data supports it."

Although the Council approved for the parking rate reconsiderations to be placed on the formal agenda no specific date has been set for discussion. Brucker and Fenton both said they hope it will be discussed within the next two council meetings.


