



New bill gives schools authority to punish cyber-bullying

A new bill that would give schools the authority to punish or expel students who engage in "cyber-bullying" could corroborate Beverly Vista School officials who face a 'freedom of speech' lawsuit for suspending a student who posted a video on YouTube of classmates degrading another student last year.

Assembly bill 86, introduced by Assembly member Ted Lieu (D-El Segundo) and backed by the American Federation of State, County and Municipal Employees and the California Teachers Association, passed in the Senate by a 21-11 vote in August. The bill is on its way back to the California Assembly and awaits Gov. Arnold Schwarzenegger's signature.

Assembly bill 86 "adds bullying committed by means of an electronic communication device to the list of activities that school districts, law enforcement agencies and agencies that serve youth are encouraged to prevent," the bill's analysis reads. The bill defines "electronic communication" as any communication "transmitted by wire, radio, optical cable, electromagnetic or other similar means."

The bill will also provide for cyber-bullying prevention education and implementation by school/law enforcement and the statewide safety cadre with no additional cost to the state or schools.

DUI drivers now charged for police costs

In addition to the expense of lawyers, court fines and increased insurance rates, intoxicated drivers can now expect to foot the bill for police officers and firefighters who respond to their collisions under Beverly Hills' new DUI cost recovery system.

Beverly Hills recently implemented a state-authorized program to recover the costs of public safety response to incidents caused by drivers who are arrested under the influence of alcohol and/or drugs (DUI). The cost is separate from any fines or restitution ordered by a court in a criminal prosecution. Typically, DUI incidents involve collisions where the impaired driver is at fault and when DUI drivers are located after police receive 911 calls reporting possible DUIs or reckless drivers.

After the costs of a qualifying incident have been calculated, the driver will receive a personal invoice that could up to total several thousands of dollars and cannot be assigned to an insurance carrier.

An estimated \$280,000 in DUI invoices have been sent out retroactively to cases over the last three years and about \$50,000 has been recovered in payments thus far. The Police Department is also considering a plan to list the names of overdue accounts



Stone And Lawn Signs Of The Times

Hilton Vote: tax dollars do matter By Rudy Cole

Elections, including those in our own village, can have distractions that have nothing to do with the realities of the campaign or substantive issues, but somehow impact voter attitudes.

Think **Dukakis** on a tank and former Mayor **Richard Stone** and lawn signs.

Or **Dan Quayle** being compared to **John Kennedy.** Well, maybe forget Quayle.

Would I have spread pictures of Stone supposedly removing signs, and apparently there is real doubt this is what was happening, in a banner on page one if I owned a newspaper? No, not really. This is hardly page one news or worthy of that much ink. However, that goes with the perks of owning a newspaper, even in Beverly Hills, and the Courier is not likely to ask my advice.

However, there is a tradition we used to follow: Hit hard, but hit fairly.

I don't often agree with Stone, and I of this battle.

certainly don't on the Hilton referendum, but he has long served our city with distinction and merits some respect, even when he is dead wrong. (Translation: When we disagree.)

As for respect, most of my emails on the Hilton Measure H were from partisans of both sides. Hardly any from undecided voters. One was really vicious, and unsigned. Such language! If the No on H people know who "anonymous" is they should maybe curb his enthusiasm and ask him or her to play by the rules of fairness too.

Before getting back to some important questions on Measure H, some other historical distractions: One of the most divisive fights in our city was over a proposed condominium development in what was then called the Industrial Area. You think emotions run high now, think millions of dollars of law suits by both sides of this battle.

In the middle of a campaign, which had, until then drawn a collective yawn in the community, the city council decided to fire Traffic and Parking Commissioner **Betty Harris** because her name was on one of the law suits.

Even a strong supporter of the condo project, former Mayor **George Slaff**, condemned the council for trying to intimidate an opponent. The side issue drew more sympathy and support for the No Condos supporters then their own issues. The No won overwhelmingly.

At the risk of rubbing old wounds, the condo project, had it been approved, would have created far less congestion and traffic in that area than what has followed, including massive office buildings. Some of the largest in our city.

More on lawn signs: If having the most and best placed won elections, **Steve Webb** would still be sitting up there. He had the best designed, far more than his opponents and very strategically placed. He also had the best endorsements: Fire and Police Associations, both newspapers and more community leaders – didn't help.

I do remember the first time I had lawn signs in a city election, and it was at the request of the candidate and not something previously used. The candidate and I were attending last weekend campaign rallies set in four elementary school areas of the city. It went well and later we returned to our campaign headquarters feeling fairly confident. Only one volunteer remained, but the office was filled with our lawn signs and their stakes.

"What are all these?" I asked the volunteer. "We went all over and took them down," he replied.

"Why," the candidate and I demanded to know. The explanation was that the office had received a call from a voter who proclaimed that he would never vote for a candidate who was cluttering our whole city with these ugly signs on our beautiful lawns.

We spent the next few hours trying to put them back up. He won anyway.

What are the purposes of lawn signs? Not just to advertise the voter's name, really a secondary reason: But to give the family that places the signs a sense of involvement and commitment and to let neighbors know, and hopefully the voter is friendly with the Jones, that they are among the supporters of the candidate or issue. Larger numbers matter if you need credibility too. If you have many choices, and don't want to waste a vote, a showing of strength is persuasive.

Back to the Hilton. One of the arguments in a mailer by the NO side was on heights and claimed that it was out of proportion to surrounding buildings.

The mailer denied that there were taller structures in neighboring areas, but then failed to offer any proof. It was ignored. It doesn't take a degree in architecture to see how many far higher structures surround our city. Buildings three to four times taller can be seen within a mile of the proposed Hilton condos. The Hilton is at a city extremity, not smack in the middle of our business area or even abutting residential.

Actually, if we are concerned about massive construction around Beverly Hills, the Hilton project could deter growth elsewhere. Even though it is of far less height and fewer units, it will, because it is in Beverly Hills, actually deter new, competing condos. There is a limit to the market possibilities in all of Western Los Angeles. So, vote for the Hilton and maybe one less monster in Century City and Westwood.

Didn't hear this from the Hilton people, and they probably wouldn't want it even brought into the debate, but some Los Angeles city officials are anxiously watching the results of the campaign. Why? If **Beny Alagem** can't actually build a Waldorf=Astoria here, they would send a city limo to invite him to construct it in LA. Some of the No Sayers may say "let him go," but is that in our real interests?

It would be totally irresponsible for us, as voters, not to consider the financial impacts of the Hilton election. Mammoth up front fees and the transient occupancy tax, a great scheme to let visitors help pay for services we enjoy, are one element of the benefits.

However, hotels are key to a very important part of our whole tax base. Hotel guests are shoppers, they dine in our restaurants and they spread the word of our city as a tourist destination. Not quite the same for visits to medics. Hotel guests do shop on Rodeo, they dine at Spago and The Grill and that too means dollars for cops and firefighters.

How do we continue to provide funding for needs that help define us as a city including the best in police and fire protection unless we continue to support a vibrant business sector? We can't. So, when you cast your vote think street repairs, money for the schools through the JPA and paramedics, not just catch phrases such as "too big" which it isn't.

More thoughts on traffic. Last week, we wrote about the difference in peak hour traffic and the traffic generation from offices, banks and medical compared to hotels and condos, and they are highly significant. Small point about hotel condos: Not year round residents therefore even less automobile movement.

Let's not lose a great addition to our city. Minimum in pain, maximum in pleasure and benefits.

This election should set records for turnout. Normally, ballot measures suffer a voter drop, as much as 20 percent, but probably not this year. The Hilton and the no people are very active as are all the volunteers working for passage of E, the school bonds. Prediction: At least 14,500 voters, almost 4,000 more than normal for a presidential vote. *briefs cont. from page 4* event at Paramount Studios.

Entertainment District to be added to General Plan

Beverly Hills' Planning Commission has requested that the "Entertainment Business District" (EBD), bounded by Civic Center Drive on the west, Santa Monica and Beverly boulevards on the north, Maple Drive on the east and the alley north of Burton Way on the south, be incorporated into the city's draft General Plan, which would guide city development for the next few decades.

The EBD, formerly known as the 'industrial area,' has been considered a separate entity for the purposes of the draft General Plan and has received a "much more focused look, which is one of the reasons why it was separate from the General Plan," according to Beverly Hills' City Planner Jonathan Lait. The EBD, currently home to Beverly High welcomes new ninth-grade parents

city facilities and entertainment-based companies, is being evaluated for future use and for new zoning codes to allow for redevelopment in the 43-acre area.

But at the Planning Commission's meeting last week, it became clear that the EBD project and draft General Plan needed to inform each other if they were to work in harmony.

"The EBD Environmental Impact Review [EIR] identified some specific impacts in residential areas and [the Planning Commission] noted that the General Plan EIR did not carry forward those same impacts into its document so they wanted to fold in the level of traffic analysis that was done for the EBD and incorporate that into the General Plan EIR," said Lait. The EBD's EIR noted an increased traffic

impact to surrounding residential areas.

Lait and his team will separate out the policy statement in the EBD project from the specific zoning standards, including the policies for the EBD in the Plan.

The Planning Commission also requested more traffic analysis and a report on how these policies may affect residential areas

Coverstory DESIGNING WOMAN

Architectural Commission chair Fran Cohen keeps the city's buildings looking sharp

BH Weekly: So what exactly do you do in the Architectural Commission?

Fran Cohen: The Architectural Commission reviews and provides recommendations and makes decisions about specifics of the architecture and development of commercial and multifamily buildings in the city of Beverly Hills. We basically work with the applicant and developer to apply for new buildings or renovations within the city.

The Architectural Commission looks at about 150 different projects each year so they really shape the city's design fabric from signs to landscaping to remodels and entirely new buildings.

We are a seven member commission. When the applicant comes and presents their plan, they sometimes get seven different points of view. If there's an alternative to the design, which might work well with the city, [we tell them.] So for example, an alternative for the door would be where the door is positioned or how the design works better in terms of façade. The commission does not have purview inside the building. It's just the storefront and within 5 feet inside. We review that, so we can give alternatives as to how the store is positioned.

Explain how that works.

First, the applicant applies to the city for a change. For example, a minor 'front of store' change on Rodeo Drive [would be] if they want to change the front façade. They apply for that and work with the planner within the city. The planner gives them the guidelines for the design and the codes for the city. They get an appointment and [the Architectural Commission] meets once a month in the city, every second Wednesday of the month. The applicant comes before us with the design and we make comments accordingly. On conditions, we approve them so they can either come back to the commission or go to the staff and finalize it.

What do you look for during your reviews?

Basically, to enforce city of Beverly Hills criteria in relation to construction and design. That is, the design should conform to the highest standards and contribute to the image of Beverly Hills and that it's a place of beauty, spaciousness, balance and high quality within not only the local arena but the international [arena] as well.

The preferred building or structure is in harmony with its surroundings and it conforms to the standards and codes. We like to promote a unique blend of interaction, fixing an exceptional shopping experience and tourist pathways. Perhaps this is one of the biggest challenges that we face — to have the balance there. In addition, the commission tries to accommodate the applicant and approve the project in a timely manner and we always try to have clear communication and give viable alternatives.

How did you come into this line of work?

About three years ago, I saw an ad in the newspaper and thought this is exactly what I did in the past and it fit with my background and thought I could be a help if I volunteered myself.

My formal education and professional experience includes a cross or multidiscipline of business, architecture and real estate. I have two masters' degrees, a master's of science in architecture from Massachusetts Institute of Technology and a master's in business administrative from Purdue University. I have bachelor's of arts in architecture from Southern California Institute of Architecture. I have about 28 years of experience in architecture, design, urban planning, real estate, construction and management so I thought it would be a good opportunity for me to volunteer and get involved with the city.

My father is a civil engineer. He doesn't practice anymore but that's what I grew up with. I remember always seeing plans and trying to read the plans at 7 or 8 years old. It was very interesting to see how everything works and that's probably why I decided to study architecture.

How did you come to Beverly Hills?

I was born in Iran and moved to Los Angeles in 1979. In the '80s, I moved to the East Coast to attend MIT. After Boston, I went to Israel for a while, then I moved to the Midwest, to Indiana.

My husband and I decided to look for a city that my family can grow and live for a long time to come. Beverly Hills, we decided was the place. My sisters live in Beverly Hills and my parents just live a few blocks away in Los Angeles so that was one of the reason: I wanted my kids to grow up with family.

We moved here two weeks before 9/11. I'm not sure if we had waited that we could have ever moved. Because of 9/11, my family wouldn't have separated. I moved with the children here and my husband stayed at Purdue until he retired from Purdue. So for a number of years I lived with the children here and until my husband could retire from Purdue and join us here. He has been retired for about three years now. It was very difficult for me and the children but now both my children go to dormitories so it's just me and him now. It's an adjustment. At the beginning, it's hard but they tell me it gets easy and I'll enjoy it.

Tell us about your family.

My son, David, is 21, or will be 21 in a couple months. He is a junior at UCLA and studying civil engineering. My husband, Menashi, is a civil engineer, who got his PhD from Stanford. He is a developer in Los Angeles. Also he is a professor emeritus from Purdue University. He taught for 28 years or so.

We met in California when I was a bachelor's student. He was a professor at Northeastern [University] and I moved to Boston and we married there while I was a graduate student. It was 1984.

Then [my husband] got a job at Purdue University so we relocated. My son was born in Indiana in Lafayette. Purdue is in West Lafayette. West Lafayette and Lafayette are just so close to each other. My daughter was also born there. Her name is Sandra. She is a freshman at UC Berkeley and studying civil engineering as well.

Where did your children go to school?

My kids changed several schools before we moved to Beverly Hills. For a couple years, they went to the public schools in Beverly Hills, but they graduated from Harvard Westlake. My daughter went to Hawthorne and El Rodeo and my son went to Hawthorne and Beverly High. He just went to Beverly High for one year and then he transferred to Harvard-Westlake. My daughter went at ninth grade to Harvard-Westlake.

What other work do you do?

I worked in different occupations [in Indiana] then I opened a chain of retail stores in 1992.

It was interesting. I like interaction with people on a daily basis and I had stores in California and Indiana. We were selling electronic music-related items and cell phones, DVDs and video games. [The stores] were called CD Land Corp.

I still have one store in Indiana that I try to mange from here; it's kind of hard to mange a retail store long distance.

I practice in the field of architectural construction and urban planning and I think the future is to work in construction of green buildings and that's the field I'm interested to work in. I believe green buildings, besides the environmental and economical benefits, we get satisfaction by using or recycling the natural resources. So that's the field which I'm interested in getting into eventually. I'd like to get back into the field of architecture and design. I help my husband and work with him at different design projects.

I give recommendations to people who approach me but I don't have an office. My husband has one and the construction that he does when we do the projects together for an optimum design. He also is a general contractor so he fields the projects. It's mostly commercial projects that we work with.

Do you have any hobbies?

I went high Ettefagh High School in Tehran, Iran. It was a private Jewish community school in Iran. I have a group of friends from high school, which we get together. After I moved here, I tried to find my friends from high school and we get together once or twice a week and we get together and get lunch or go to movies and do other things. That's one of the things I look forward to every week.

I have my sisters are here and try to spend a lot of time with them and my parents, which are elderly. I try to attend to their needs and try to spend as much time as possible with them.

My parents came in the late '80s to Los Angeles, but at that time I was living in Indiana. And my sisters— in the '80s, they moved here. I moved to Boston in 1982.

What's in the future?

I like to be more involved in architecture and more designs and open my own office. That's what I'm hoping for.

I enjoy the Architectural Commission very much and I love the people I work with so I'll definitely stay. It's very gratifying to see the designs complete and know what's going on in the city.

For the past two and a half years, I have worked with the Planning Commission and City Council to develop this project. The opposition would have you believe that a "No" vote just means I will come back with a smaller project.

There has not been a luxury hotel built in the United States in over a decade that did not have a residential component or a major government subsidy. That is the only way luxury hotels are economically viable.

If Measure H is not approved – I will not be coming back with a smaller project because it

would not be economically feasible. Simply, the Hilton will stay the same. The ugly parking structure on Santa Monica and the hotel rooms set right on the street along Merv Griffin Way will remain. There will not be 4.5 acres of open space and gardens at the Western gateway to the City.

Without Measure H, the City will not receive \$12 million in new revenue each year.

Without Measure H, I cannot dedicate property for new traffic lanes to reduce congestion. \$5 million will not be spent to synchronize traffic lights and make other traffic improvements

Without Measure H – The Beverly Hills Education Foundation and PTA's will not receive a in the city. \$3 million endowment or \$3.13 million in upfront development fees.

Don't be fooled. This is exactly what a "No" vote means. Did the Four Seasons Hotel come back after it was defeated? No. It went to Los Angeles and Beverly Hills lost millions in revenue, but got

all the traffic impacts.

Measure H is the result of 10 Planning Commission and 9 City Council meetings and numerous community meetings. The majority of elected officials in this City voted for this project. I hope you will join them in voting YES on Measure H.
