I shudder to think of how many other unpleasant surprises they and their like have in store for us.

Instead of worrying in his December 25 column about minor infractions by merchants, he might be better concerned with the billboard industry's insidious creeping blight happening right under his nose.

Would it be too much to ask that Rudy Cole open his eyes and get his hands a little dirty and do some investigative journalism for a change and find out how and why these billboards were placed in our city, under whose authority, how they "comply" with the current billboard ordinances in place and how we get rid of them forthwith.

For months while I have been trying to get this information and Rudy Cole hadn't even seemed to notice these billboards and I can get no further than being told that they were constructed with valid permits.

It is time we get back to having the majority of the city council enforce all of the laws of the city, even those which put a crimp into the profits of their over-development cronies who they shamelessly favor over the general populace and a majority which would never allow this creeping billboard blight to overtake our picturesque environment.

There is a "bill board" at Olympic and

"Spaulding" but those streets are in Los Angeles. I assume my loyal reader misspelled our similar sounding street and meant Spalding and Olympic. The only signage he could possibly be referring to at this and the two other venues he writes about are located on or in bus stop property. These "signs" hardly qualify as "billboards." They are not even close to billboard sizes. The most common boards are 12.3 feet high by 26.8 feet wide. These and even larger boards are banned in our city, as I mentioned in my column.

Aside from their much smaller size, these bus signs do not qualify as billboards because they are not mounted above buildings or on larger constructed frames. Those are the definitions used in Los Angeles which permits but limits placement of boards.

Incidentally, the bus signs are by contract, bring revenue to the MTA and are totally legal and not at all obtrusive.

My letter writer needs to be far more careful with facts and possibly even less insulting. A simple apology would be accepted. As for Councilmember Linda Briskman and the city council, they can speak for themselves, but despite approval of some highly visible projects, Briskman and the whole council vote against more developments than they approve.

Just for the record, this column strongly opposed the William Morris headquarters development on North Beverly and the Casden condos south of Saks Fifth Avenue.

Behrstock honored as Big Brother of the Year



When North Beverly Drive resident Joey Behrstock accepted a friend's invitation to a golf tournament in 2002, he had no way of knowing that it would change his life.

The tournament was thrown by Jewish

Big Brothers Big Sisters (JBBBS) of Los Angeles as a fundraiser for the organization. Encouraged by the event, Behrstock offered to give a donation to the charity.

"But [my friend] said the best thing you can do is become a big brother," said Behrstock. It was the moment that Behrstock says changed his life.

After completing an orientation process, Behrstock was introduced to his "little brother" Matthew, an 11-year-old boy who had lost his father. Now six years later, Behrstock will be honored as "Big Brother of the Year" at the JBBBS annual fundraiser "The Big Event" on Jan. 24.

"I'm so flattered because after a year of being a Big Brother, I knew how special it was. I joined the board and started to cochair their annual golf tournament as chair of recruitment," said Behrstock. They sat me down in July and said we are going to honor you with Big Brother of the Year. You work very hard for the agency and have been very responsible for fundraising dollars and you bring in a lot of people and money."

ITEM: An ordinance of the City of Beverly Hills amending various sections of Chapter 3 of Title 10 of the Beverly Hills Municipal Code regarding permissible encroachments in side yards, street side yards, and rear yards in single-family residential zones. The amendment would allow elevators and elevator enclosures to encroach up to 30 inches into a required side or rear setback, or a greater distance up to 60 inches with approval of a Minor Accommodation Permit. Elevators and elevator enclosures must maintain a minimum distance of three feet from the adjacent property line.

The City Council of the City of Beverly Hills, at its meeting on Tuesday, January 6, 2009, will hold a public hearing beginning at 7:00 PM, or as soon thereafter as the matter may be heard, to consider an ordinance that would allow elevators/elevator enclosures added to an existing residence to encroach into required side and rear yard setbacks. The ordinance would allow such structures to encroach 30 inches into the required setbacks. Up to a 60-inch encroachment would be allowed through a minor accommodation process (with public notice). The Planning Commission reviewed the draft ordinance on December 11, 2008, made certain revisions to the draft ordinance, and recommended that the City Council review and approve the Ordinance with the Commission's suggested revisions.

This project has been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the environmental regulations of the City. Staff has determined that the proposed ordinance qualifies for a Categorical Exemption (Section 15305 of the CEQA Guidelines), Class 5, "minor alterations in land use limitations" because the ordinance would not result in any changes in land use or density and would only allow minor encroachments. Therefore, under the authority provided by the CEQA Guidelines, no significant environmental impacts are anticipated.

Any interested person may attend the meeting and be heard or present written comments to the City Council. If you challenge the City Council's action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the City, either at or prior to the public hearing.

World-famous sculptor Robert Graham, who created the iconic "Torso" sculpture on Rodeo Drive, died Saturday at age 70. He passed away at Santa Monica UCLA Medical Center from an undisclosed illness.

Based in Los Angeles, Graham is wide-





ly known for his civic monuments and public installations a11 over the world. The 14foot-tall "Torso" was installed at the corner of Rodeo Drive and Dayton Way to mark Rodeo Drive as the location of the "Walk of Style" event, honoring designers for their contributions to the worlds of fashion and entertainment. The 2004 work is emblematic of Graham's lifelong fascination with the female form. "We are very



artist," said Mayor Barry Brucker in a prepared statement. "Beverly Hills is extremely privileged to be a permanent home for one of Robert Graham's sculptures and we are grateful for his contributions to our community."

Born in Mexico City in 1938, Graham received his B.A. at San Jose State University and M.F.A. at the San Francisco Art Institute. Since 1964, his work has been the subject of more than 80 solo and two retrospective exhibitions in the United States, Europe, Japan and Mexico. His work is also part of many national and international museum collections. One of his more recent exhibitions was held at the ACE Gallery in Beverly Hills in March and April of 2008.

Local monuments by Robert Graham include "The Great Bronze Doors" for the Cathedral of Our Lady of Angels, Los Angeles, 2002; and "Olympic Gateway" to commemorate the XXIIIrd Olympiad in Los Angeles, 1984; "Dance Door" at the Music Center Plaza in Los Angeles; "Source Figure" at the First Interstate World Tower in downtown Los Angeles; Architectural projects include "Doumani House" and "Huston-Graham House," both in Venice, Calif. where he worked and lived with his wife, actress Angelica Huston.

Notable works outside of Los Angeles include the "Prologue" to the FDR Memorial, Washington, DC, 2001; and "Dance Columns" at the Wright-Runsted Building in Seattle, Washington.

In December 2008, Graham was inducted into The California Museum's California Hall of Fame.

BHHS Boys' Basketball Team Defeats Los Angeles Baptist

Normans girls' basketball team defeat Saugus. By Steven Herbert

The Beverly High boys' basketball team defeated Los Angeles Baptist, 53-47, in a consolation bracket game of the San Fernando Valley Tournament Dec. 19 at Granada Hills High School, ending a fourgame losing streak.

The Normans trailed 24-20 at halftime, but took control of the game in the third quarter, outscoring the Knights, 17-9, with freshman guard Austin Mills scoring nine of his 12 points, including making two 3-point baskets, and Greg Townsend scoring eight of his 27.

Beverly Hills led 37-31 entering the fourth quarter and outscored Los Angeles Baptist, 16-14, over the final eight minutes, with Townsend scoring five points and Mills making a 3-point basket. Guard David Sarkisian scored 10 of his 18 points for the Knights, including making his third and fourth 3-point baskets of the game.

The Normans were outscored 11-8 in the first quarter, with Townsend scoring six points. Townsend scored eight points in the second quarter as Beverly Hills was outscored 13-12.

Aurash Jamasbi added four points for the Normans and Farzan Azinkhan, Alon Kashanian, Torrey Lubkin, Michael Pedram and Markus Silbiger two each.

"We executed a little better on the offensive end and were able to score inside," Beverly Hills coach Derek Bolden said in comparing his team's performance to its 77-55 loss to Clovis in a first-round game a day earlier.

The Normans trailed by four at halftime, but were outscored by 13 in the third quarter and five in the fourth in a first-round game Dec. 18 at Granada Hills High School.

"We played OK for the first half and then in the second half, we ran out of gas and didn't play well defensively to keep the score close," Bolden said.

The Normans were outscored 19-15 in the first quarter, getting seven points from Pedram, including a 3-point basket. Drew Dockweiler, Set Isaksen, Vince Maldanado, C.J. Scott and Justin Williams all made 3point baskets for the Cougars.

Both teams scored seven points in the second quarter, giving Clovis a 26-22 half-time lead. Mills made the first of his five 3-

point baskets, while Scott made his second. The Normans were outscored 26-13 in the third quarter, getting four points from Townsend and another 3-point basket from Mills. Scott made two 3-point baskets for six points while teammate Sukpreet Dhaliwal scored five, including a 3-point basket.

Beverly Hills was outscored 25-20 in the fourth quarter, despite Mills' nine points on three 3-point baskets. Dhaliwal, Maldanado, Aaron Johnson and Scott all made 3-point baskets for the Cougars.

Mills scored a game-high 21 points. Townsend added 13, Pedram nine, Azinkhan and Elliott Peaks four each and Kashanian and Markus Silbiger two each for the Normans.

Burbank Burroughs 73, Beverly Hills 44

The Normans' hopes of overcoming an 11-point halftime deficit ended for all practical purposes when they were outscored 26-10 in the third quarter of a consolation bracket game of the San Fernando Valley Tournament Dec. 20 at Granada Hills High School.

"We didn't handle the ball that well," Bolden said.

Senior Marlon Jimenez scored 14 of his game-high 19 points in the quarter, including his second and third 3-point baskets of the game, giving the Indians a 60-33 lead.

Beverly Hills (2-6) was outscored 22-11 in the first quarter, despite Mills' two 3point baskets. Matt McQuown scored seven for Burroughs, including a 3-point basket, Kyle Hart six and Jimenez five, including a 3-point basket.

Both teams scored 12 points in the second quarter, giving the Indians a 34-23 halftime lead. Townsend scored six for the Normans and Mills making a 3-point basket.

Beverly Hills was outscored 13-11 in the fourth quarter.

Townsend scored 18, 16 over the final three quarters, Mills nine, Kion Alam five, Pedram four, Peaks three, Azinkhan and Lubkin two each and Jamasbi one.

What's Next?

The Normans are scheduled to play at Valencia West Ranch Tuesday in a non-league game beginning at 7 p.m.

Girls' Basketball Beverly Hills 49, Saugus 39 Sophie Payson scored 14 points, including two 3-point baskets, and Morgan Mason 13, 11 after the first quarter, for the Normans in a nonleague game at Saugus Dec. 8.

Beverly Hills outscored the Centurions 17-10 in the first quarter, with Payson scoring seven points, including making a 3-point basket.

The Normans increased their lead to 30-19 at halftime, outscoring Saugus, 13-9 in the second quarter as Mason scored seven points and Natalie Moy and Payson both made 3-point baskets.

Beverly Hills was outscored, 9-8, in the third quarter, cutting its lead to 39-27 entering the fourth quarter.

Both teams scored 11 points in the fourth quarter.

"I thought we played very well defensively," Normans coach John Braddell said. "We struggled a little bit offensively."

Chelsea Austin added eight points, Miranda Abdul-Monsour five, Javonna Young four, Moy three and Jie Ren two for Beverly Hills.

Abdul-Monsour had 10 rebounds.

The Normans made 18 of 54 shots, 32.7 percent.

Inglewood City of Champions Holiday Tip-Off Classic Los Angeles Marlborough 50, Beverly Hills 43

The Normans fell victim to the Mustangs' strong defense against Mason, Beverly Hills' leading scorer on the season, and 18 turnovers in a championship quarterfinal game Dec. 5 at the Hangar Athletic Exchange in Hawthorne.

"We turned the ball over too much," Braddell said. "They limited Morgan. If she has her normal game, I think it's a little closer and we may pull it out."

Mason missed 10 of her 11 shots and both free throws, finishing with two points, after scoring 17 and 20 in the Normans' first two games, both victories.

Beverly Hills trailed the six-time defending Southern Section champions 13-10 at the end of the first quarter, despite Payson's two 3-point baskets.

The Normans trailed 32-23 at halftime after being outscored 19-13 in the second quarter, as senior center Talia Caldwell scored six of her nine points and Stefanie Corgel and Miwa Tachibana both made 3point baskets.

Beverly Hills committed eight turnovers in the third quarter and were outscored 10-9, with senior guard Ashley Lyles scoring five points, including a 3-point basket for the Mustangs.

The Normans entered the fourth quarter trailing 42-32 and outscored Marlborough 11-8 as Young scored four points and Payson made her third 3-point basket of the game.

"I think we had opportunities and we just didn't take advantage of them," Braddell said. "Marlborough is a very good team so it was a good showing against them, but we thought if we played just a little bit better, we could have gotten a win."

Young led Beverly Hills with 12 points, making six of nine shots. Payson had nine sports cont. on page 10

Not Our Best Year



And a movie review By Rudy Cole

Will a date in the calendar make everything better? Probably not, but we still wait for the beginning of each new year as some kind of turning point, and in these very unsettling times, maybe that's what we need.

2008 was hardly a year without drama, both in our village, nation and world.

So, the inevitable reviews:

Nationally, the abrupt collapse of the economy and the election of Barack Obama were dominating news stories, of course. The recession didn't happen all that suddenly, it just seemed that way. As for our selection of Obama as our first ever African American president, that too was more inevitable than we understood. His stunning victory in the Iowa caucuses, a state with only an eleven percent black vote, made his nomination very likely and almost inevitable

In Beverly Hills, we had Hotel Two, to divide and fascinate. It was almost a repeat of the wrenching, overly costly vote by petition that led to the election victory of the Montage in 2005 as voters narrowly approved the Hilton in 2008.

True to form, the same anti-growth leaders who took the Montage election to the courts, and lost, are now threatening to ask the judiciary to overturn the Hilton win. It does seem paradoxical that hotel opponents, demanding that "voters" should have the right to "decide," are now willing to let a judge determine what is best for Beverly Hills.

Statistical side note: Although the "no" vote was also larger in the Measure H (Hilton) referendum, the Hilton's 7,972 easily surpassed the 4482 votes in favor of the Montage in 2005. The Montage election was municipal, the Hilton national, partially explaining the higher vote, but still worth comparing.

Considering the frightening and life altering events in our nation and world, future Beverly Hills historians may indeed wonder about our sense of priorities. However, the battles in Beverly Hills over development projects are important and will affect our quality of life for many generations.

No matter how you voted in the presidential election, most Americans seem to have a sense of hope that Barack Obama will indeed make life better and our nation and world more secure. Not since Franklin Delano Roosevelt has any president entered the office with so many challenges and expectations.

Obama will simply not end the recession or find world peace in his first 100 days, but I share this feeling of most Americans, that he and his mostly excellent team, will indeed make it better.

Before turning back to Beverly Hills and our 2008 turning points, a few thoughts on the middle east: Seldom has any nation had more justification for launching a military action to defend itself than Israel has in the Gaza, and fewer have ever handled their efforts to obtain international support more ineptly.

Let's be clear: The "war" between Hamas and Israel escalated because Hamas launched missiles into civilian Israeli targets. Israel had no choice but to defend its people and make every effort to knock out the launching sites in Gaza. The truce was broken by Hama, not Israel, and it is Hamas that has a stated, very clear national goal of wanting to destroy the State of Israel.

Where Israel failed was in not making every effort to obtain international support for its counter attack. Why not demand that the United Nations take action, even if that was unlikely to work? It would have given Israel a platform to defend what it eventually would have had to do even without UN approval. Why not rallies around the world demanding that the Arab world curb Hamas before not after the air raids? In short, when right and not just might are on your side, tell your side of the story first and just as forcefully as with guns and planes.

But I am not a citizen of Israel. I do not have to live with the same fears and hazards as the Israelis and it is understandable that the tiny democracy feels abandoned by world opinion. I just wished that reaching out first could save lives and bring Israel the support it deserves.

If effective communication is critical for rational decision making in national and international challenges, the same is true in Beverly Hills where the failure to understand the linkage between responsible change and maintenance of high standards is our critical need. It is very unfortunate that so many well intentioned and very smart people line up on the wrong side of so many issues.

Aside from the Hilton referendum vote, these were some of the other news breakers and their likely impacts on our city.

The voters overwhelmingly approved an historic school bond proposal that will, hopefully, make our schools safer and more

secure. The bond election had some distractions: Controversy over out of district permits, the loss of key school administrators and the not-too-surprising resignation of our school superintendent, Kari Mc Veigh, might well have made voters uncertain about the ability of the schools to administer the reconstruction program, but voters continued an historic tradition: kids first.

In a real sense, the bond election helped bring our community together. It did, finally, have the support of all five board members, all five members of the city council, the president of the teacher's union and every single PTA leader.

President elect Obama's plan to fast start the economy by spending on national infrastructure needs, including money for improving the physical condition of the nation's schools, should be carefully watched by our district.

Fortunately, we will have a really significant number of viable and competent candidates for city council this year. Considering the often virulent abuse we unleash on our elected officials, we are lucky that anyone would really want the office.

There are three offices up for election and the contenders include two incumbents: Mayor Barry Brucker and Councilmember and former mayor Linda Briskman. They face some serious challenges from candidates with very diverse kinds of support.

Since Vice Mayor Frank Fenton decided not to seek a second term, the field of contenders expanded. They include:

Dr. Willie Brien, probably the candidate with the broadest based support. Brien, a former school board president, has not been immersed in some of our more divisive city battles and that is mostly a plus. A middle of the road, consensus builder on most city issues, the only disadvantage of his moderation is not having a passionate following from either the pro or anti-growth activists.

Virginia Maas and Richard Stone, also two former board presidents, are also very viable contenders. Stone, because of very high name recognition and his very visible opposition to both the Montage and Hilton hotel projects, and Maas because of her ties to some important community groups, including her activist role in the Jewish community. She and Stone were often allies on the school board but have very different bases of backers in this race although Maas has made it clear she too voted against Hilton.

John Mirisch is the real wild card in the race. Although his family has deep roots here, his own activism is very recent. Best known for his acerbic blog, now dismantled, he is articulate, attractive and all over the you-name-it, we're-against-it forces.

Mirisch is reportedly out walking, a very important tool in our elections, and hit the mails early too. Another early drive for attention has been made by Michael Hakim who was one of the first to announce his kick off and certainly the first to use a citywide telephone mechanized message.

Mayor Brucker has both the advantage and disadvantage of mayoral incumbency. In recent elections, incumbent mayors have not done all that well. Then mayor Steve Webb lost in 2007 even though he had the

support of both newspapers, the largest number of endorsers, the most lawn signs and walked key precincts.

What Brucker has is a whole litany of controversial issues, some that will both help and hurt his election. These range from a very public effort to separate the Chamber of Commerce from the Conference and Visitor's Bureau, his support for the Montage and his opposition to the Hilton. Not yet to be fully aired is his involvement, for better or worse, in the socalled China Sister City effort. Brucker does have a strong list of supporters and the help of his very politically savvy wife, Sue. Although he actively opposed the Hilton referendum, joining many anti-growth leaders, it wasn't that long ago that the North HOA gave him "F" ratings on issues.

Briskman, reversing an earlier decision not to seek a third term, has one big argument in her favor: Experience. There are so many important issues on our civic plate that demand considerable past involvement, that her work as the longest serving councilmember and chair of the Planning Commission, could be persuasive with voters. However, she will also be the target of many anti-growth activists.

One side impact of the Briskman decision to run again is that if she wins, she, and not Councilmember **Nancy Krasne**, will be our next mayor.

More on the other candidates soon, and some are very viable and interesting, just not immediate news grabbers.

Now for a very, for me, unusual bit: A movie review. Although I have not seen all of the films being mentioned for Golden Globe or Oscar awards, "Frost/Nixon" has to be one of the most important and also entertaining movies of our times.

I wanted to see it for its historical meaning, but found myself totally engrossed in the story and, more important, the incredible performances by **Frank Langella** as Richard Nixon and Michael Sheen as David Frost.

Since I had actually seen the real Frost interviews and had a nodding if hardly friendly, casual relationship with Nixon following his defeats by **John Kennedy** and later by **Pat Brown** when he lost a campaign for governor of California, I did not expect Langella to convince me he was Nixon.

But Langella did just that. Forget, the physical difference, it doesn't take long for him to persuade you that he is Richard Nixon brought back to life. Nor is his performance lacking in sensitivity to this complicated, convoluted man that was Nixon.

Langella is simply brilliant and it is the performance of a life. How else can you describe creating emotions about Nixon that are both repugnant and understanding.

While I never met Frost, I was a fan of his work as a perceptive interviewer, at a time when that skill was much appreciated on the tube. He was an equal to Cavett, Moyer and Koppel. I felt then that Frost had been slightly too easy on Nixon in the historic post resignation interview, and that is a recurring theme of the movie. I also did not think Sheen could capture Frost, but he did, totally.

So, not just because it is an historical masterpiece, but for sheer entertainment enjoyment, take the family to see "Frost/Nixon."

I have yet to view, The Reader" but from the reviews, it too seems to be a major award contender. As for best actor, Langella should have the proverbial cake walk, If Sheen is nominated for best supporting, he too would have my vote. Or they could reverse the credits and both win.

Nittany Lions safety Mark Rubin called The Beef Bowl "unbelievable."

"The food was obviously great, but the whole staff made it a truly memorable experience for all the Penn State players," Rubin said after the team's Saturday visit.

The Beef Bowl was conceived in 1956 by Richard N. Frank shortly after he became Lawry's president, out of a desire "to feed the teams."

"We had no idea that it would ever turn out to be the kind of event it is now," Frank, now the company's chairman, said in an interview Sunday.

Frank's son, Richard R. Frank, president and chief executive officer of Lawry's Restaurants Inc., called The Beef Bowl "a unique tradition that allows us to do something unusual."

"We do a lot of things to give back to the community," he said. "This is a different way of giving back. It allows our staff to be part of something that's so much bigger than we are."

Rose Bowl officials said their association with Lawry's the longest bowl-corporate tie. In a 2005 story, The Sporting News called The Beef Bowl, the "best bowl game tradition." It is older than 29 of this year's 34 bowl games -- all but the Rose, Orange, Cotton, Sugar and Sun bowls.

Hundreds of New California Laws Take Effect in 2009

Mandating nutritional information for restaurant food, tougher penalties for drunk drivers, outlawing text messaging while driving and a requirement that property owners take charge of abandoned pets are part of the more than 200 new state laws that take effect today or soon after.

The following is a summary of some of the new laws that residents should be aware of:

Texting While Driving - the new laws provide that a person may not "write, send or read a text based communication" while driving.

The End of Analog - Viewers using an antenna or "rabbit ears" to pick up television shows, will see a blank screen after

Nutritional information at restaurants -By July 1, 2009, all restaurants with 20 or more locations in California must provide brochures containing nutritional information about its food items including calories and grams of saturated fat. Starting Jan. 1, 2011, all menus and menu boards above front counters will have to include the number of calories for each item.

Electronic filing of FPPC Form 700 -This new law establishes a pilot program which permits the electronic filing (with some exceptions) of a Statement of Economic Interest by elected and appointed officials and candidates in accordance with regulations adopted by the Fair Political Practices Commission.

Voter registration over the Internet -Voters with a valid California driver's license or a state identification card may register to vote over the Internet.

Drivers on probation for DUI conviction - Beginning today, drivers on probation for driving under the influence ("DUI") convictions will be subject an automatic license suspension and a possible vehicle impoundment if they drive on California highways with a blood or breath alcohol concentration of .01% or higher.

Animal abandonment - Property owners, including banks or other corporate entities, must take charge of abandoned

However, I have found a solution that needs to be shared. Whole Foods in Beverly Hills has FREE hour-long cooking classes EVERY SATURDAY at 2 PM, with the very knowledgeable Chef Alexx Guevara. The cooking class animals left behind on property that has been vacated following the termination of a rental or lease agreement or property foreclosure. Landlords and property owners must notify immediately an animal control officer, who will then retrieve and take possession of the animal until it can be returned to the owner.

Elder abuse - Local ombudsmen who monitor facilities that care for elderly and dependent adults will be required to report known or suspected cases of abuse to the local district attorney's office. This is in addition to current law that requires reporting to state agencies in charge of licensing the facility.

Tenancy in cases of domestic violence or stalking - A tenant may terminate a rental or lease agreement with a 30-day written termination notice and without financial penalty if the tenant also informs the landlord that the tenant or household member has been a victim of domestic violence, sexual assault or stalking. This law went into effect September 28, 2008 and will sunset on January 1, 2012.

Unsafe product-recall or warning -Manufacturers that have sold products that have been recalled must provide for the retrofit or safe return of such products to the manufacturer at no cost to the consumer or retailer.

Imitation firearms - The existing prohibition against openly displaying or exposing any imitation firearm in a public place now includes any such display on the grounds of a public school.

Hilton wins Measure H by 129 votes Issue 479

After a final ballot tally, Beverly Hills' hotly contested Measure H passed by a margin of 129 votes, according to the Los Angeles County Registrar-Recorder/County Clerk's Office.

Measure H, which would allow the Beverly Hilton to build a Waldorf=Astoria and two condominium buildings on the nine-acre lot, officially passed with a final tally of 7,972 (50.4 percent) to 7,843 votes (49.59 percent). The vote was certified by the Los Angeles County Registrar-Recorded on Dec. 1 and was declared official by the County Board of Supervisors on Dec. 2.

"The citizens of Beverly Hills have spoken

and agree with the City Council that The Beverly Hilton needs to be revitalized," said Marie Garvey, spokesperson for the Beverly Hilton. "We simply could not have achieved this milestone without the hard work and support of the community and look forward to breaking ground on the Waldorf=Astoria Beverly Hills in the coming year."

But the battle is not over, according to Citizens Right to Decide Committee treasurer Larry Larson, who led the unofficial No on H campaign.

"With considerable effort and more tips from voters, we believe that we can ferret out hundreds of fraudulent voters who voted illegally on Measure H. Once we have completed our investigation, Citizens Right to Decide will file a lawsuit in Los Angeles Superior Court based on voter fraud," wrote Larson, who believes that many of the votes that pushed Measure H toward winning came from people who should not legally have been able to vote, in an e-mail.



Local Businesses Say Chamber Audit Results Are Overdue Issue 461/465

It's time for the city, Chamber of Commerce and Conference and Visitors Bureau to work on marketing the Beverly Hills brand in other ways and encourage more day visitors from nearby cities, according to the results of an external performance audit conducted on the Chamber of Commerce that were released on Tuesday.

KH Consulting, who conducted the Chamber's audit, found in part that the city and Chamber need to create a strategic business plan for the many different divisions and organizations in the city in

order to have a standard on which to measure success and set goals, including increasing day visitors to the city.

Even when you don't agree with him, you have to admire Mayor Barry

Brucker's political skills. He took the majority of the council with him on his campaign to take the first steps to separate the Conference and Visitors Bureau from the Beverly Hills Chamber of Commerce.

Not quite a done deal, but remarkable nevertheless. Technically, the decision is really not up to the council. They can vote to have the two organizations split, but the council's power only lies, and that only is a killer for the Chamber, to withhold city funds for both the CVB and the Chamber unless they follow the council's recommendation.

Both the CVB and the Chamber are independent. However, they could not operate as they do without the big bucks the city allocates for promotion of tourism, economic development—which means attracting new businesses and keeping them there.

The city's hotels act as collection vehicles of the TOT and should have a continuing role in how the money is spent. Brucker, and his fellow sub-committee member Council member Linda Briskman, will soon suggest a committee to oversee the likely transition. Hotel GMs will play a major role in coming up with recommendations.

Jimmy Delshad, Barry Brucker was officially sworn in as the 82nd mayor of Beverly Hills on March 18 at Beverly High's K.L. Peters Auditorium. Brucker took the oath of office from Rabbi Laura Geller of Temple Emanuel, of which his wife, Sue, is president.

Councilmember Frank Fenton took the position of vice mayor and was sworn in by his son Steven—a recently elected member of the Board of Education.

"I know, everybody in this room knows that my dad is my hero," Steven Fenton said. "But, dad, you need to know, you

are everyone's hero."

As Brucker accepted his new position in front of an audience of some 250 people including his friends and family, he outlined a few of his plans for the upcoming year.



Board president says McVeigh good fit for New Haven Issue 475

BHUSD's superintendent Kari McVeigh left the district at the end of November 2008 to take a job as a superintendent in the San Francisco East Bay Area's New Haven Unified School District, a 13,000student, 12-school district in a largely working-class area.

"She's a great fit for what we are trying to do," said NHUSD Board of Education president Kevin Harper.

McVeigh, a Bay Area Native, joined

the BHUSD in 2006 from San Diego Unified, where she was an assistant superin- Massachusetts in 2006. The Marshfielders returned the favor in September 2008. tendent. She had previously taught in Las Vegas for several years and held an administrative position in Boston for one year.

Her contract was set to expire with BHUSD on Sept. 30, 2009. The BHUSD Board of Education tabled discussions about her contract extension. McVeigh also received mixed reviews from district faculty and staff.

McVeigh was replaced by interim superintendent Dr. Jerry Gross, husband of former BHUSD superintendent Gwen Gross (2000-2003). The BHUSD Board of Education began the first steps in the search for the next superintendent in December.



Measure E passes, but with lower approval than 2002's bond Issue 475

Measure E passed by nine percentage points with 64.49 percent support and a final tally of 7,494 to 4,126.

Beverly Hills voters on Nov. 4, 2008, approved Measure E, the BHUSD's \$334 million general obligation school bond, by 64.49 percent. The measure, which qualified for Proposition 39, needed only 55 percent approval. Had the measure not qualified for Prop. 39, it would have needed a 66 percent voter approval rate. This support percentage was lower

than the BHUSD's 2002 \$90 million school bond Measure K that passed

with 78 percent of voter approval and 1993's Measure S that passed with 70 percent.



City Council OKs mixed-use project at former Robinsons-May site Issue 446

The City Council gave its approval April 9 to move forward with a mixed-use project to be developed by Lotus, LLC, on the former Robinsons-May department store site located at 9900 Wilshire Boulevard in Beverly Hills.

The vote 3-2, was with Councilmembers Nancy Krasne and Jimmy Delshad voting against it.

The project will include the demolition of the existing 228,000-square-foot former department store building and associated parking structure and the replacement of the structures with a mixed-use

project. The project includes 234 condominium units in two buildings, two commercial buildings consisting of 16,441 square feet of retail and restaurant space with environmentally sensitive or "green" features on an eightacre site.

Beverly High graduate Arash Feyzjou ('91) poured hours into organizing the Beverly High Normans vs. Marshfield Mass., Rams football games.

Beverly Hills Tops County Chart for Increased Property Value Issue 459

Beverly Hills had the highest percentage increase of assessed value last year in Los Angeles County, according to the Los Angeles County Assessor's Annual Report for 2008.

Beverly Hills saw an increase of 11.8 percent in the assessed valuations performed by the county assessor, putting the city at an approximate \$2.1 billion new value.

The money associated with transfer of real property was the largest reason for the property value increase, said LA County Assessor's Director of

Administrative and Roll Service Gil Parisi. Of the \$2.1 billion total, \$1.7 billion came from transfer of properties in Beverly Hills last year.

Over 25 percent of that came from the transfer of ownership at the 9900 Wilshire site, which was valued at \$500 million when it was sold in April 2007, according to Parisi.



Globes Dent Beverly Hills; Could Oscars **Be Next? Issue 433**

For over 30 years, Beverly Hills has welcomed the star-studded Golden Globe Awards Show. But the ceremony that awards the best in the television and film industry saw its longstanding tradition broken this year due to the Writers Guild strike, ultimately affecting local businesses throughout Beverly Hills.

"The Golden Globe Awards Show is certainly the highlight of the year," said Beverly Hilton Director of Public Relations Lynda Simonetti. "We had hoped the show would go on for all the entities involved."

Due to the Writers Guild strike, the Hollywood Foreign Press Association (HFPA) cancelled the awards and replaced it with an hour-long press conference at the Beverly Hilton to reveal the recipients.

Although the Beverly Hilton serves as a venue for over 175 red carpet events per year, the cancellation of the Golden Globes also resulted in loss of revenue from lack of room occupancy to terminations in catering orders.
