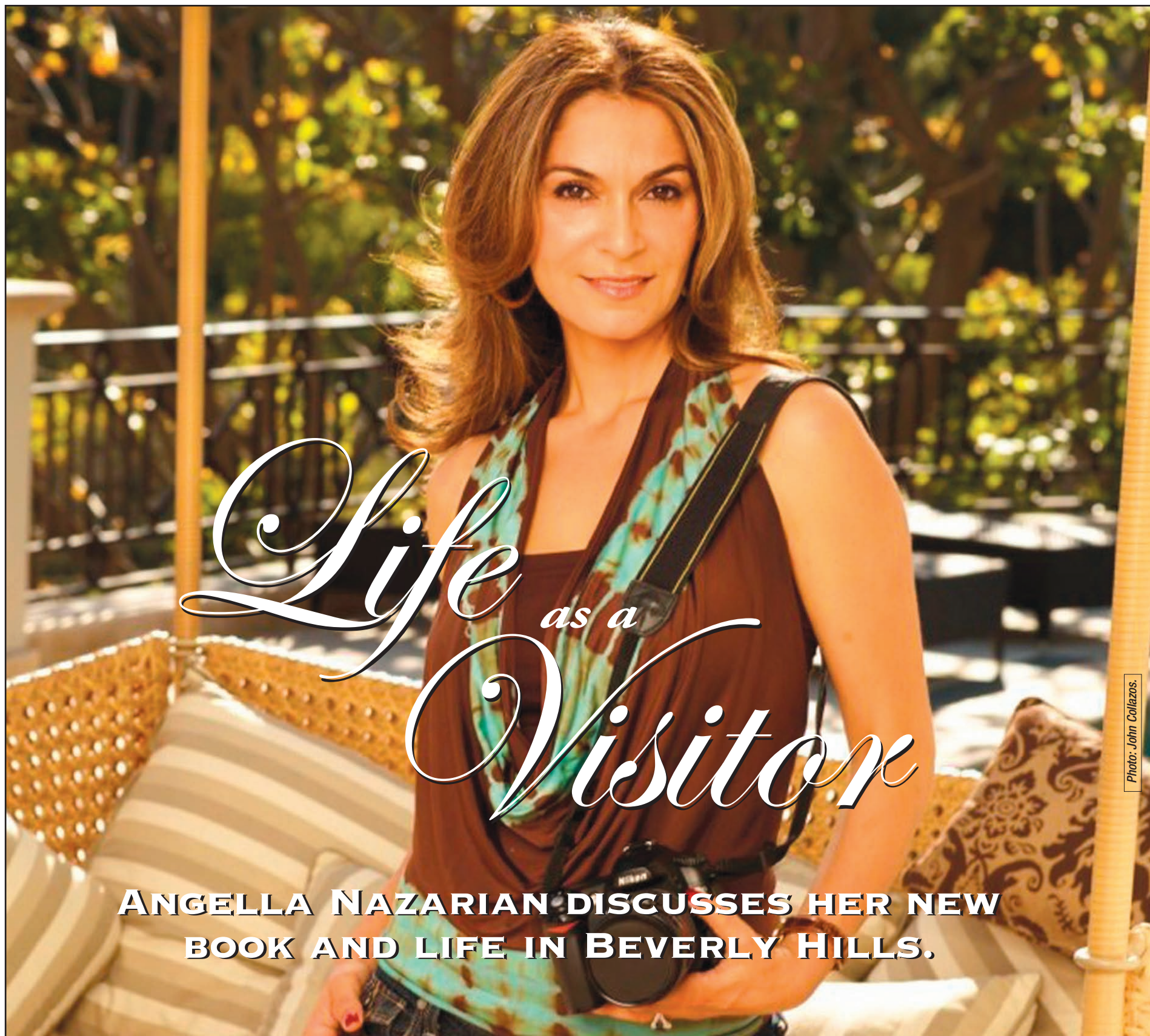

AN OPEN LETTER TO MYRA LURIE:

Dear Ms. Lurie,
Now that The Weekly has exposed Nooshin Meshkaty’s eviction from a Westwood apartment building while her

daughter attended El Rodeo, the residents of Beverly Hills await your investigation into this ethical offense and violation of our district’s residency requirements.

Some have said that your attempt to censure Brian Goldberg because of his involvement in a San Bernardino County civil law suit was politically driven. They say that since Myra Demeter is retiring and Nooshin Meshkaty is up for re-election, you tried to discredit a political rival to preserve your wavering majority coalition. I, for one, don’t believe it.

On the contrary, I know you are even-handed and fair-minded. I know you will investigate Nooshin Meshkaty every bit as intensely as you investigated Brian Goldberg. I know you will present your findings and recommendations in an upcoming Board meeting, before the November elections.

In your impassioned speech, you said that your INTEGRITY lapel pin inspired you to declare Dr. Goldberg morally unfit to serve, even though the civil suit pertaining to the sale of his father’s business is under appeal. Surely, these new ethical questions surrounding your colleague Meshkaty are more compelling than those against your colleague Goldberg. Is Nooshin Meshkaty morally fit to serve and run for re-election? Why was she evicted from her Westwood apartment? How could she have advocated residency checks for non-permit parents when she sent her own daughter to school while being legally domiciled outside the city?

Ms. Lurie, by taking a strong moral

stand against Dr. Goldberg, you have become the conscience of our community; a shining example to our children of righteousness. Along with the people of Beverly Hills, I anxiously await your judgment on Ms. Meshkaty.

With regard to Mr. Bernstein’s letter, while I understand the perception in the community that it is paying to educate other people’s children, this perception is not completely accurate.

The one factor that no one seems to consider in this discussion is the fact that, prior to basic aid, we actually gained more money—far more—from permit students than we spent on them. Anyone who doubts our own district’s figures can check a similar study by Oak Park, available online. Oak Park, with a smaller permit population than we now have, would have realized a net loss of more than \$1.8 million per year by eliminating permit students at the time the study was conducted (2007). The losses to our district would presumably have been even greater in such a scenario.

Yes, under basic aid permit students no longer add to our revenue, and I think no one would seriously suggest that we continue issuing large numbers of new opportunity permits, but when we think about what to do with current permit students, we ought to consider them as being paid

Meshkaty Proposed Permit Plan Flawed, Says Los Angeles County Office of Education

In a Sept. 11 Beverly Hills Courier article, Board Candidate Nooshin Meshkaty offered a permit plan aimed at rectifying the interdistrict permit approval process and its inconsistencies with LACOE policy.

According to the article, LACOE ruled against BHUSD every time a student was denied a transfer permit, allowing more non-resident students to attend Beverly Hills schools.

"It does us no good to take actions that will be overruled every time," Meshkaty said in the article.

Appeals, however, run under a case-by-case basis, said Victor Thompson, LACOE's director of the division of student support services.

"We have members of the staff in an informal meeting to basically find information from both sides, from the parent and student and from the school district," he said. "After that, they go for the formal hearing in front of the entire county board of education."

Parents cannot file an appeal with the county until all other measures of appeal within the district have been exhausted, after which there is a 30-day timeline to do so, said Thompson.

Grounds for approving a permit and overruling the district's denial include child care, transportation, any documentation or rental

agreements and unique education programs offered in one district and not the other.

In the article, Meshkaty also said LACOE requires transfer permits to remain in effect until a natural break — defined as the end of elementary and middle school and the start of high school — in a student's education occurs.

"The natural break is not part of our policy," Thompson said.



Meshkaty Trashes Copies of Weekly

Apparently unhappy with last week's cover story, Board of Education candidate Nooshin Meshkaty threw out copies of the Weekly last week

at the Beverly Hills Unified School District office, according to witnesses.

Copies located at Beverly High were also thrown out before a faculty member rescued them from the trash.

A statute passed by Gov. Arnold Schwarzenegger three years ago makes it illegal for any one person to steal more than 25 copies of free newspapers. Those who violate the law are subject to a maximum punishment of a misdemeanor conviction, along with a fine of \$500 and 10 days in a county jail.

In 2002, then-Berkeley Mayor Tom Bates pleaded guilty to stealing and trashing about 1000 copies of The Daily Californian after the student newspaper ran an endorsement of his opponent. Bates was charged with petty theft and paid a \$250 fine.

"The legislative findings that accompany the statute talk about how newspapers 'pro-

vide a key source of information to the public.'" said First Amendment Attorney Doug Mirell. "Those who take more than the number of copies are injuring 'the rights of readers, writers, publishers and advertisers, and impoverishes the marketplace of ideas in California.'"

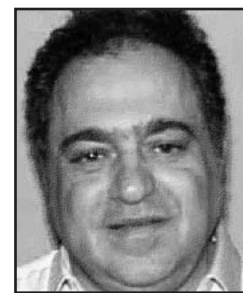
Suspect Arrested in Attempted Home Invasion Robbery Last Thursday

Charles Loftus, 48, was arrested for residential burglary at a home on the 1200 block of Beverly Green Drive last Thursday at 11:50 pm.

The residents — two children and their mother — were unharmed. Officers responded to a call of a burglary in-process and arrived within two and half minutes. They immediately entered the residence and rescued the occupants.

The suspect allegedly acted alone and entered the residence through an unsecured back door. Police found no weapons on him.

"It's so important for residents to make sure doors are secure because it provides opportunists like him a way to get inside," said Lieutenant Tony Lee from BHPD.

Suspect Wanted for Attempted Murder

Adel Hakim failed to attend a scheduled court date on Sept. 24 for charges of attempted murder. The suspect appears to have fled, and a warrant has been

issued for his arrest, according to BHPD.

Hakim allegedly shot his brother several times Feb. 20, 2008 on the 400 block of North Palm Drive. The victim sustained life threatening injuries, and is now paralyzed. Hakim is considered armed and extremely danger-

ous.

Hakim is 49 years-old with brown hair and green eyes. He is 5'8" tall and weighs approximately 200 lbs.

Yom Kippur Services at Nessah Turn Controversial

During Monday's Yom Kippur services at Nessah Synagogue, Associate Rabbi Hillel Benchimol spoke about the three recent tragedies in the Persian Jewish community this year.

After touching on Adel Hakim's attempted murder of his brother and Bianca Khalili's controversial death last summer, Rabbi Benchimol went on to discuss Daniel Levian and berated the community for wanting to send the Persian Jewish driver responsible for Levian's death to prison.

According to reports from congregants, the rabbi said he was going to counsel the drunk driver, 31-year-old Sam A. Moghimi, twice a week for free, adding that he agreed to accompany Moghimi to court to lend his support.

Moghimi only suffered moderate injuries in the crash, which occurred July 12. Daniel Levian, 25, and his brother Korosh, who was critically injured, were passengers in the vehicle when Moghimi crashed into a wall.

Following Rabbi Benchimol's remarks, Lecture Committee Chair Simon Pour Etehad told the synagogue members that Rabbi Benchimol's comments were his opinions and in no way reflected the synagogue's view.

Congregants said the rabbi pointed at Etehad and yelled, "Don't undermine me!" He then told Etehad to get off the stage.

Levian's father Iraj then approached the stage and accused Rabbi Benchimol of taking

Longtime Beverly Vista Teacher Ben Shaver Passes at 84

Ben Shaver, a longtime teacher who taught at Beverly Vista School from 1953 to 1988, passed away on Tuesday, September 15 in Simi Valley.

Shaver was a World War II veteran who served in the US Navy and was one of the first to go into Okinawa after the bombing. He subsequently taught junior high school in Boise, Idaho for 3 years before coming to Beverly Hills where he taught math and history to middle school students for the length of his career here.

With colleagues, Russell Hillman, Bill Porter, and Bob Craig, Shaver took students horseback riding on weekends, and camping in Colorado for many summers. He also led groups of eighth graders on trips to Washington D.C. during spring break for a number of years.

Shaver influenced hundreds of students and their families in this community. His insistence on serious academic performance and decent behavior inspired his students to a high standard of excellence in the classroom and in their future lives.

"One of the things I remember most significantly was that I was successful in getting Eleanor Roosevelt to come in and visit my students," Shaver said in a Nov. 2003 Weekly interview [issue 215]. "She had just completed a world circling trip and she came in with her bevy of photographers and she said, 'Mr. Shaver,' in a very sweet, grandmotherly way, 'I can only spare you five minutes'...She talked for 30 minutes. It was one of the high-

lights of my teaching."

His love of the outdoors was shared with many children for whom, like the Pied Piper, he was a leader, followed with eagerness and enthusiasm.

Shaver is survived by Bunny, his wife of 63 years, Vicki Bennett his daughter, grandchildren Dan Selesnick and Angela Dunn, and great grandson Wade Dunn.

for not by the Beverly Hills community but by the net "profit" we have realized from permit students over the last few years. Nor should we forget the drastic program cuts that the presence of permit students have averted. These cuts would have had a dramatic detrimental effect on the education of resident students. Yes, permit students have gained from being in our district, but we have gained from them as well and should not forget our debt to them.

With regard to the cover story, I worry about how much damage the continued focus on largely irrelevant issues will do to the governance of the school district and in turn to education. The Weekly is only doing its job in reporting the story, but one can only hope your readers will keep the matter in its proper perspective. The allegation against Ms. Meshkaty, if true, relates to a non-criminal infraction from years ago and is no more relevant to the question of her current fitness as a board member than is Dr. Goldberg's tangential involvement in a recent civil suit. While voters can certainly weigh such issues, the most significant question in this and future board elections should be the conduct of the individuals as board members and the policies which they advocate, not their conduct as private citizens.

We are all human and all make mistakes. If local school board candidates are to have small indiscretions, relevant or not, made the focus of public debate, who in their right mind will want to run for school board in the future? Especially in recent years, the job has become a more and more thankless task. We should celebrate those who are willing to make the

sacrifices involved, not denigrate them.

In the Sep. 25 edition of the Beverly Hills Courier, incumbent school board candidate Nooshin Meshkaty offered a poor explanation as to why she rejected the teachers' invitation to consider her for an endorsement in the Nov. 3 election.

Voters will evaluate for themselves the validity of Ms. Meshkaty's reason—she cited conflict of interest—but consider the following. Current Board of Education member Myra Lurie and former board member Alissa Roston ran for re-election in 2007 as incumbents, and both sought BHEA's endorsement. Current City Council member Barry Brucker and former City Council member Linda Briskman each received the endorsement of our local police and fire unions, an endorsement that both prominently touted in their 2009 campaigns. I would never suggest that Mr. Brucker or Ms. Briskman did anything improper by accepting the endorsement of the police officers and firefighters. They worked hard for those endorsements and earned them by respecting the valuable service of our public safety employees. By contrast, Ms. Meshkaty is quoted as saying that it is "inappropriate...to seek a political endorsement from a group you are actively negotiating with." I disagree. Endorsements are not negotiations. Endorsements convey support for broad principles while negotiations deal with specific proposals. Ms. Meshkaty's criticism of BHEA's endorsement process is a transparent attempt to apply a double standard when one considers that her own

campaign chair, Mr. Brucker, accepted the police and fire unions' endorsements, groups of employees with whom he actively negotiates.

Finally, the school board negotiates directly with the city council on the multi-million dollar joint powers agreement. Why, then, does Ms. Meshkaty believe it's appropriate for her to accept the endorsement of Mr. Brucker, an elected city official with whom she actively negotiates the JPA, but not of the teachers' union?

BHEA applauds candidates Jake Manaster and Lisa Korbatov for seeking and earning teachers' support in this election. They, like so many candidates before them, understand and value the critical role that school employees play in the success of our district's students. Let's stay focused on some key school issues that must be addressed in this campaign: Measure E accountability, turnover of staff, and Board of Education leadership.

You know **Sharon Stone** as the highly successful actress, but she could easily move into another career, that of auctioneer. The sultry one did those chores with considerable professional skills last Saturday at the Los Angeles Police Protective League's annual award dinner held at the Hyatt Regency Century Plaza Hotel. (They win the award for the longest hotel name in the area.)

Ran into some old and new friends at the event: Beverly Hills was represented by Clipper boss and owner of the most rental apartments in Beverly Hills, **Donald T. Sterling**, Vice Mayor **Jimmy Delshad** and **Arthur Kassell**, who co-chairs the support group.

Met a very bright and experienced acting chief, **Steve Lieberman**, of a law enforcement agency that was very new to me: the Los Angeles County Police, not to be confused with the Los Angeles County Sheriff.

Setting the record straight: A story about the selection process for a replacement for Strategic Concepts in that other paper had the facts somewhat garbled, as did a letter writer to Beverly Hills Weekly last week.

For the record: I am on two very separate committees. One is the group legally responsible for monitoring of spending of Measure E bonds, called the Independent Citizens Oversight Committee, and appointed by the Board of Education. I also

served on a very separate ad hoc committee as one of two citizen members charged with evaluating the proposals of companies bidding for the project manager contract; they would replace Strategic Concepts. The other citizen member is **Ron Stone**, co-chair of the advisory Facilities and Construction Committee.

We were joined in the evaluation, which we all did very independently, by two members of the school board, President **Nooshin Meshkaty** and Vice President **Myra Lurie** plus two district staff advisors.

What was in error were reports on both the role of this temporary committee and that of school superintendent **Dr. Jerry Gross**. First, we did not "pick" a winner, only made recommendations to the board and the superintendent and second, Dr. Gross gave absolutely no opinion on the merits of any of the applicants. The final choice will be made by vote of the whole board and only then will Dr. Gross give his advice.

The process was laborious. First each member of the committee made an independent evaluation of the written proposals of the 10 applicants based on experience, costs, quality of proposal etc. We did not compare notes, but after scoring the top three and later four were picked to make oral presentations. Again, we did our evaluations privately. There is one more step, and that is site visits to the applicants' works. I have asked **Todd Okum**, a member of the ICOC, to do this chore since he has far more construction experience.

Also, for the record, I asked each of the finalists the same series of questions including any history of law suits on school projects, any contact direct or indirect with Strategic Concepts, any professional or personal relationship with any member of our board of education, any contributions to any of their campaigns etc. With the support of my colleagues on the interview committee, I wanted as open and transparent a process as possible.

Although many, but not all, of the applicants had excellent credentials and none had any conflict, I did feel that one, Parsons, was by far the best choice and that is my recommendation. Ron Stone also gave them the highest rating. This is all a matter of record.

Again, for the record, at no point did Dr. Gross even try to dissuade me from this recommendation and I have no idea of his preference.

A word about my involvement. The letter writer to our publication said I was a "lobbyist" for Measure E. That was not my title, but I do take some pride in my role as campaign coordinator and the success of a campaign that won overwhelming voter approval. I was informally approved for the job by all five members of the board of education, and try making that happen in your spare time. However, I kept arms length from fund raising and campaign financing which was managed by Julie Steinberg since traditionally bond campaigns are sup-

ported by vendors.

It may be immodest, but I have to inform my correspondent that I did, as campaign coordinator, manage to obtain the endorsements of all five members of the then city council, and most former mayors, including both **Richard Stone** and **Robert K. Tanenbaum**, the president of the teacher's union, **Chris Bushee**, and both the Police and Fire Associations. On the other side were both community newspapers and the dynamic duo of former board members **Mel Spitz** and **Herb Young**.

I did feel an obligation to serve on the oversight committee, of which I am first vice chair, to keep my pledge to assure the bond money would be wisely and legally spent. That job is far from complete, but I serve with some very able people. (See school website for full list)

Back to more important news: One of the more fun events each year is the Beverly Hills High School Athletic Alumni Association's award dinner, this year recognizing the school's legendary **Carter Paysinger** with the McCarthy Lifetime Achievement Award.

Others to be inducted into the Hall of Fame are **Tony Behrstock**, **Robert Countryman**, **Stacy Margolin**, **Brad Turell** and **Chris Williams**. Among those honored two years ago were board member Myra Lurie's school athlete husband, **David Goldman**.

The Don Reynold's "Spirit Award" will be presented to **Eric Munzer**, (2009) for football, soccer and baseball.

BHHS Football Team Loses To West Ranch

Normans to play host to Hamilton Friday

Fatigue and Turnovers were the cause of Beverly Hills' 33-17 loss to Valencia West Ranch in a nonleague football game Friday night at Valencia High School, coach Donald Paysinger said.

The Normans led 17-12 on Adam Lansman's 22-yard field goal after Beverly Hills recovered a fumble by the Wildcats on the opening kickoff of the second half.

West Ranch (3-1) scored the game's final 21 points. Connor Eichten threw a 28-yard touchdown pass to Matt Szymanski and Zak Snell ran 29 yards for a touchdown in the third quarter and Eichten threw a five-yard touchdown pass to James McCough with nine minutes, 44 seconds to play.

"We played well in the first half, we got tired in the second half," Paysinger said. "They had a pretty good offensive line and a pretty good fullback and they took advantage of it. We didn't execute the way we should have."

Because A.J. Fortier became fatigued when he played quarterback and defensive back in a 17-15 victory over Santa Barbara a week earlier, sophomore Cameron Countryman became Beverly Hills' third starting quarterback in three games.

Countryman ran for two touchdowns but also had three passes intercepted. The Normans also lost a fumble.

"Turnovers are a major concern," Paysinger said. "You can't win ballgames turning the ball over."

Beverly Hills (1-2) led 14-12 at halftime as Countryman ran 80 and two yards four touchdowns in the final 4:15 of the first half.

"He played great," Paysinger said. "He ran the offense pretty decent. He's only going to get better."

The Wildcats took a 12-0 lead on Trevin Manuel's one- and two-yard touchdown runs in the second quarter.

What's Next?

The Normans are scheduled to play host to Los Angeles Hamilton (3-1) Friday at Nickoll Field in an intersectional game set to begin at 7 p.m.

"They're a physical team," Paysinger said. "They have good outside speed, a quarterback that can throw the long ball. If we don't turn the ball over, we'll be OK."

Countryman will again start at quarterback, Paysinger said. Josh Newman, Beverly Hills' starting quarterback to begin the year, is expected to return for the Oct. 16 Ocean League opener against Hawthorne, Paysinger said.

Newman sprained his left ankle in a season-opening 34-7 loss to Long Beach Jordan Sept. 11.

Running back Kenny Bassett will miss the remainder of the season. He is scheduled to undergo surgery Friday to repair a torn anterior cruciate ligament in his left knee, Paysinger said. Bassett suffered the injury when he made a cut on a second-quarter run against Long Beach Jordan.

Bassett rushed for 1,414 yards and 14 touchdowns on 186 carries in 2008 and had drawn recruiting interest from "three or four" Pacific-10 Conference schools, and "just about every Mountain West Conference" and Western Athletic Conference team, Paysinger said.

Haber made nine saves.

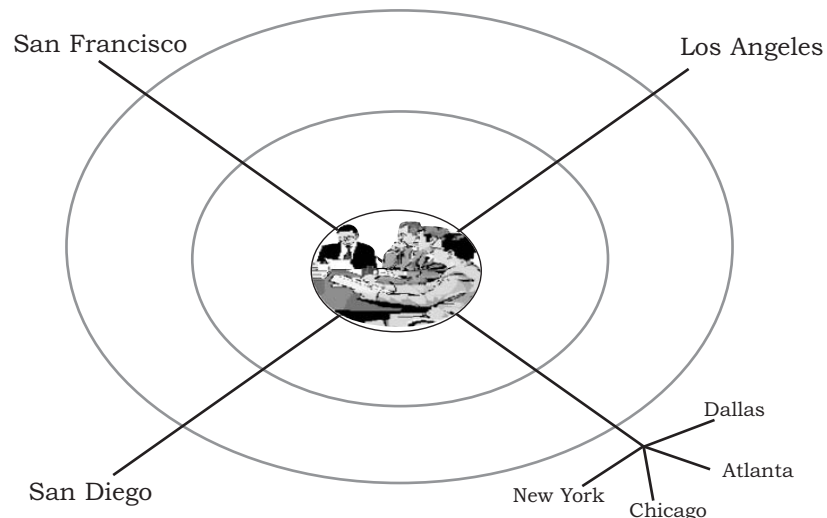

LIFE AS A VISITOR

Angella Nazarian discusses her new book and life in Beverly Hills.

Why do think many young Iranians don't know anything about Iranian history?

It depends on what age they came here. I can only speak from my own experience and I can tell you why I didn't know. I came here very young, and the first thing on my list to do was really try to assimilate to the American culture, and at the time that we came, it was probably one of the worst times for Iranians in general. Iran was involved with the hostage crisis, which was really a very shameful time for us as a community. A lot of people didn't want to say that they were Iranian. They would refer to themselves as Persians, partly to off the edge of Iran being in the news all the time.

And even when you look at the news right now with what's happening, and it's very funny that I'm meeting you today on the 24th because [President] Ahmadinejad is going to be talking in the UN, and there'll be mass protests everywhere in the UN against this guy. He is a leader nobody is proud to be associated with. And on Friday, he was talking about how the Holocaust ever happened and Israel and the U.S. are his greatest enemies. So you see how, when you're a child and you're very self conscious and you haven't had much schooling in Iran, you come here and right away you want to distance yourself from that humiliating experience of what Iran is doing.

Why didn't older generations of Iranians talk about what happened or what was going on in Iran?

I think for a lot of them it had been such a painful experience. The younger people wanted to assimilate, and the older people just found it very hard to adjust. When you think about it, people who were groomed to have a high standing in the government, they were very educated, and they come here, and they have nothing, or they're taxi drivers, or they have to start life all over again. It's very hard to revisit those painful experiences. For example, for my mom, I really didn't know the details of her escape until I interviewed her for the book. And many times when I would ask she would say, "Oh, why do you want to

talk about it?" Because talking about it really triggered a lot of uneasy feelings for her.

Explain pre-revolution Iran and the tensions that were bubbling up until the revolution and your departure to America.

I have to say from the eyes of an 11-year-old, what I saw was a lot of chaos and not knowing what's happening, and the city really being under siege. There were a great many people that were dissatisfied with having a kingship. Perhaps they wanted a form of government where they had more of a say, but what really happened after the revolution is that with the Islamic fundamentalist government coming into place, there's even less freedom for a citizen. I strongly doubted that [the people in Iran] ever thought that it would become what it is right now.

Explain the process of acculturation for you, especially after you moved to the U.S. and attended Hawthorne School.

I think it was quite difficult. I was one of the luckier students because I had gone to a bilingual school in Iran so I studied English. But even those five, six years of study did nothing when I came here, and people were talking so fast with an accent that I had no idea. And you feel lost. Half the time when people are saying remarks or using slang, you don't even know what they're saying. So there was a good one-year period that I would come back home completely disoriented and very lost and overwhelmed, not knowing how I was going to do my homework, how I was going to find friends.

I really give a lot of credit to a lot my American friends. When I look back in 7th or 8th grade, I really had a good core of American friends who always invited me to places. We did things after school, and I do think that even with all being said and done, the American community is one of the most open societies, that they take you in much easier than other countries. So I think it's one of the biggest blessings to be somewhere where people greet you, they ask you some questions, they really

want to know you, they invite you to their home. I don't think you'd have a similar experience in other countries. It wouldn't be as easy.

Tell us what Hawthorne was like at that time.

Actually, I haven't gone inside the halls for a very, very long time, but I pass by Rexford [Drive] all the time, and I see that the south yard has changed so much. But it was a huge difference for me. First of all, although I went to a very progressive bilingual school in Iran, it was a small school. Hawthorne School to me was big, and there were lots of colorful things pasted all over the walls. That was never done in Iran. The teachers were extremely friendly. One thing that happened in Iran is that you had a formal relationship with your teachers. You would have to stand up as they walked into the room. Here, the teachers would crack jokes, which was very refreshing. They were available to help you [after class].

The other thing that I found so unbelievably interesting is that the school had its own library. That was something that we didn't have in our school [in Iran]. And then the fact that physical education was a requirement. Nothing like that in Iran. Nothing. And then all these opportunities for after-school sports and arts. To me, that was, I mean it's like a world opens to you when you look at all the things you can get with a public school education. And I had gone to a private school [in Iran].

Who were some of your favorite teachers at Hawthorne?

I had a great 7th grade teacher, Ms. Miller. She was amazing. They used to call her Momma Miller. She taught history, and she was actually a very strict teacher, but what was amazing about her was the way she taught. She never talked down to people. She really wanted all the kids to succeed. I remember in 7th grade, the first time I took a Scantron test, and I didn't know how to fill [it] in. I mean, [it's] that simple, but when you come from a different country, you don't know. And so, I had completely filled in the wrong bubble for

the answer and [Ms. Miller] knew that I was a really good student so the next day asked me come in and meet her, and she said, "You know, you completely failed the exam, but Angella, I know you knew these things so could you tell me how you answered them?" And she didn't show me the Scantron so I went through each and every one of them, and she said it was obvious I didn't know how to do the directions, that I did the Scantron wrong. And she sat there and said, "Well that one won't count. Your next grade will count twice." She always showed a lot of compassion and during my office hours with her she asked, "How are you doing? How is your family life?" Things that some teachers would never ask, and that was the time I told her that my parents were not around [because they were still in Iran]. The amount of care she put into me that year was quite unbelievable. It tears me up.

Who were some of your 7th and 8th grade middle school friends?

I lost touch with quite a lot of them. I didn't go to my last reunion, but [they were] Ann Rosenberg, Riva Resnick and Michelle Louie, Cheryl Rivin and Teri Goldman. One thing about Teri is I ran into her. I found out that she is writing, and studying with the same writing teacher [as me] with Jack Grapes. He has a really strong following. I couldn't believe that one of my closest 7th grade friends was sitting there writing herself. I seem to have kept in touch more with my high school friends. I run into so many of the Beverly Hills graduates all the time.

James Fogelman. I talk to him all the time. He used to be the class president. And I see him. Yaniv Teper, I see at least once or twice a year at different events. And then I belong to Sinai [Temple] Council, so a lot of Jewish families that use to belong there, they still come there during the high holidays, so you still run into people that you know.

Who do you still keep in touch with on a regular basis?

The Iranians, you keep in touch no matter what because it's such a small community that you're bound to run into each other at one of the parties on a monthly basis. So I actually have kept in touch with a lot of my Iranian friends because they haven't moved. They didn't go to other states. You know one of the things that, for a first generation family, when they moved from a different country their priority is to want to stay together because they've already lost quite a few families in Iran and they want to keep their nuclear family together. So a lot of my Iranian friends are still here, and I absolutely see them all the time. Sheila Kamran, she's actually one of the PTA moms at Sinai Temple right now. Kathy Azizadeh, I've known her since 7th grade.

Do you they still live in Beverly Hills?

No, they don't. One lives in the Valley and one lives in West L.A. I don't even live in Beverly Hills, but we've kept in touch. There's a core group. And then there's also quite a number of girls my age. When we went to Beverly Hills, we decided to form this charitable organization called Looking Beyond, and us Looking Beyond ladies are always working on a yearly basis for fundraising, so we see each other at meetings.

In what ways did you conform to American ways, and in what ways did you stay true to your Iranian roots?

The way I conformed, first and foremost, is that you change your way of dress, you change the way you talk, you change the expressions you use. By nature, Iranians are little more introverted. Americans tend to be more extroverted, so I became more outgoing. I was on the basketball team [in elementary school]. In some ways I've held on to the more traditional aspects of my heritage. I tend to be still more conservative. When I was growing up, even in high school, there were certain things that I couldn't do as a girl that some of my female American friends were allowed to do. Curfew was much earlier. It wasn't really encouraged for you to have a boyfriend or to travel by yourself or with other girlfriends. So there were still a lot of restrictions that I abided by.

At Beverly High, I was one of those girls that took the AP courses, so I was more into my studies and less into sports. Iranian boys were really strong in sciences so there were many [of them] taking AP courses. On the girls side, I was one of the fewer girls. I think [the reason] is the culture of my family. My parents were not around, and the people I looked up to were my siblings, and they were all always academically overachievers, so there was a very strong family value for doing very well in school. Especially because I had two brothers who wanted to be doctors.

How did you try to reconcile the incongruous value systems of the East and the West?

I think I still sometimes have a challenging time with that because some things are different from one to another. One thing I've started doing in the past couple years that has worked for me is not thinking if this is an Eastern value system or a Western but what really fits into my life. And doing that has been much more healthy for me.

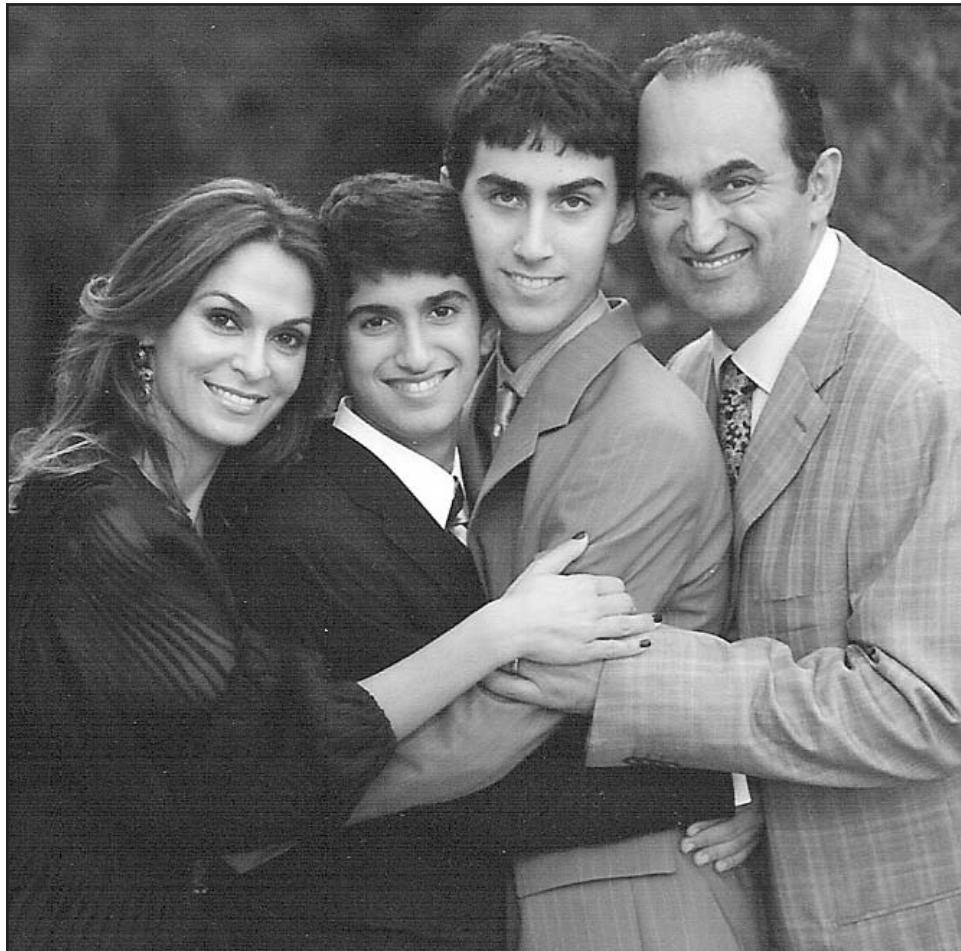
Is it the same idea, as you said in your book, of what your friend told you, that maybe the goal in life is to not try to change but to be who you are?

That's what it is, especially as an immigrant, you come here and you want to blend in and fit in, but you're changing yourself. The people I'm most attracted to

and have the deepest admiration for are the people who are really themselves.

Does it lift the burden of always trying to fit into everyone's ideals?

Well, sometimes there's even a burden by being yourself because you know you're not like other people or people will not cut you the slack of, you know, you stand out. But you're doing it not to stand

out, but as a natural reflection of who you are.

In your book, you said you always felt the need to qualify the fact that you were Iranian by saying you were Jewish. Why?

Especially that was true when we first came here because you'd look at the Islamic republic of Iran and you think about the crazy things they were doing. They were the ones that kept on saying, "Death to Israel and death to America." They were supporting terrorist groups all over the world. Certainly, you don't want to be associated with that. We really wanted to tell people, "No, no, no, I don't espouse that kind of thinking."

In your book you spoke of a defense mechanism you use when you reminisce about your past. What are you defending yourself against, and why?

It's from feeling overwhelmed or being cluttered with a lot of feelings that you don't know what to do about. And I still think that I do that even now. I'm embarking on a book launch, and today

someone told me that my book was number 43 on Amazon for my category. And I'm happy, but I feel like it takes time for me to process things. My first instinct is to be numb. I've had a lot of surreal moments, even with this book.

One of the things I did last week was I wanted to send a copy of the book to her Majesty, the ex-queen of Iran, Queen Farah. And I had her contact information, and I called her offices so I could send her

Here's one thing that has been a tremendous gift. When I wrote this book I said that I didn't know at one point I would be talking to [Queen] Farah. This book has taken me to new experiences that I really cherish and one of them is Lili. Lili and I had known each other earlier, but through this book our friendship has blossomed. I really count her as one of my closest friends. And I think that was one of the gifts of this book as well.

[The book release party is this Sunday] in the evening, and I can't wait. If anybody has ever gone to any of Lili's parties, anything she puts together, it's always done in the most beautiful manner. It's the Jon and Lili Bosse way. Lots and lots [of food and champagne]. She has her guest list, and I have mine, [and it's] over 200 people.

Tell us about your husband and his family.

I really count myself lucky that [my husband David and I] have been married 21 years and known each other for 22. That at that age, I came across someone that I could share my life journey with. More than anything is the fact that he's the type of person that really wants me to grow and that has made me a happier person, which in turn, I want to give back to him and my family. David is in business. I came from a family where we all wanted to be doctors, and David's family is more along the side of being entrepreneurs, businessmen. We have two boys, Phillip [who is 17 years-old] and Eli [who is 14 years-old], and he's a great father to both of them. The way he's involved with their lives, that's also not traditional Iranian. In a formal Iranian family, men tend to be less involved with the kids.

My mother-in-law [Soraya] is an artist. She's a sculptor, and I have a wonderful relationship with all of David's siblings. One of them was my high school classmate, Sharon. She was one who introduced me to David, and now she's my sister-in-law. Parviz [Nazarian] is Younes' brother. They're all entrepreneurs.

What is the main message of your book?

My whole personal journey showed me that we are much more similar than we think we are. But really what made me feel so different when I first came here was not because of my cultural background but it was my sense of feeling different. I think the other thing is that obviously the tone of some of my chapters are definitely sad, but I wanted to express all parts of me.

Why is it important for others to learn?

When you are truly comfortable with yourself and allow yourself to be who you are, you have a far better chance of finding a community where you belong than anywhere else. And I wanted people to really know the story of an immigrant through the eyes of a younger child that comes here.
