

“...Board Members are not on the School Board to represent and promote the interests of particular groups or stake-

The overriding obligation on all Board Members to act in the best interests of the school as a whole arises by virtue of what is known as the ‘fiduciary relationship’ between each Board Member and the school. The fiduciary relationship is a general law notion and simply dictates that Board Members must always and unwaveringly act in the best interests of the school and must act honestly, fairly, loyally, in good faith, and with integrity.



Beverly High Groundskeeper Position Restored

During his installation speech, Board of Education President Steven Fenton pledged his commitment to restoring Beverly High groundskeeper Sylvester Harris' former position and salary.

Now, the 38-year Beverly High employee will see that come to fruition after Tuesday night's board meeting.

"You have Beverly in your blood, and I know that your salary, after 38 years, doesn't match that of a first-year teacher," Fenton said during last month's installation ceremony. "I'm very sorry for everything that happened, and I'm here to tell you that we will make this right."

The board voted 4-1 to restore the additional groundskeeper position at Beverly, as well as Harris' \$54,694 annual salary.

Board member Myra Lurie dissented. Lurie said the recommendation to restore the position and salary for Harris, who has been in the district for nearly 40 years, came from one or more board members and not the administration.

"We normally do not make our decisions with reference to individuals in those jobs, but rather, we speak about positions, and then those people are identified to take those positions," Lurie said. "Also normally, when we're making decisions for many things including human resources, we're doing it with reference to an administrative recommendation. This is being done not at the behest of the administration who feels there's a need for this particularly, but because there's a board member or board members who have directed it."

Beverly High Physical Education Teacher Jason Newman, P.E. Department Chair Howard Edelman and others all spoke on the behalf of Harris.

BHUSD Director of Human Resources Dr. Alex Cherniss said the restoration would be beneficial to maintaining Beverly Hills schools, though there would be "budgetary implications."

"There are budgetary and programmatic considerations here," Cherniss said. "The administration can go either way, so it's up to the board to decide."

Cherniss said Harris' salary would be "added on to the recommended reductions that are coming up." Harris recently rescinded his retirement.

"It all comes from the same pot of money," he said. "So having this would just change the outlook a little bit."

Both Fenton and board member Jake Manaster stressed the need to improve school maintenance.

"Over the past 10 years, two groundskeeper positions have been eliminated," Fenton said. "And it shows."

Harris took a pay cut of thousands of dollars last year as a result of budget reductions; his job within the athletic department was simultaneously eliminated in a 3-2 vote at the recommendation of former Superintendent Kari McVeigh.

Director of Maintenance and Operations Jim Fahey then established a rotation system, where groundskeepers would travel to different BHUSD schools.

"The position to restore the groundskeeper position has potential for changing that system or not," Cherniss said. "That would be up to our director of maintenance and operations."

Update on Kurt Haber Estate

Kurt Haber may have been laid to rest nearly six years ago, as discussed in the Weekly's issue 508 cover story, but his \$8 million trust has yet to be settled.

One of Haber's beneficiaries, Dick Shapiro, has been embroiled in legal battles since his death — battles that have cost Shapiro roughly \$60,000, and left him fighting for his 40-percent share of the trust. As a beneficiary, Shapiro has lost a total of about \$225,000.

But this chapter will come to a hard-fought end. Shapiro and First Bank and Trust, trustees of Haber's estate, have reached a settlement, which will be finalized within three months.

"The bottom line is I'm getting this thing settled, and I'm going to move on," Shapiro said. "I'm signing an agreement to settle this thing with the damn bank to get them the hell out of my life."

Shapiro could not comment on the details of the settlement, though he said the trustees found new bonds in Haber's estate that require court approval in order to add them to the trust.

According to Shapiro, the bank has withheld more than \$100,000 from Shapiro, alleging it had the right to hold the money to defend themselves against mismanagement claims made by beneficiaries. Shapiro said the bank erroneously charged him with multiple fees totaling more than \$292,000.

"If there's ever an industry that absolutely has strict regulations where you have to watch them like a hawk, it's the banking industry," Shapiro said. "These bums couldn't run a nickel and dime fruit stand."

Haber, a 2001 Beverly Hills City Council candidate known for his controversial opinions, left his trust to his friends Shapiro and Ismael "Mike" Soto. Soto received 60 percent of Haber's money and bonds, multi-family building in Cudahy, Calif. and Haber's Beverly Hills Swall Drive residence.

Soto will be entitled to 60 percent of the newly-discovered bonds, while Shapiro will inherit the remaining 40 percent.

First Bank and Trust named Shapiro as a defendant in two lawsuits brought on by the Swall Drive residence. Shapiro said he never had any interest in the property.

"Nobody wants to get dragged through lawsuits over a house they didn't inherit," he said.

Shapiro added that he recently finalized having his sister as the administrator of his trust, and would "rather have [his] feet

boiled" than to let his bank act as a trustee.

"This should be a warning to everybody: don't ever let a bank be trustee of anything," Shapiro said. "Kurt would be turning over in his grave if he saw the way the bums handled his trust. This was never his intent."

Soto could not be reached for comment.

City Council Gives Green Light for Beverly Hills Rose Parade Float

The Beverly Hills City Council recently gave the green light to a committee charged with overseeing the creation of a float for the annual Rose Parade in Pasadena.

"Hopefully, we'll have a lot of fun doing it, and it'll be up to the committee each year to create a design and float that reflects the theme and our city," said Councilmember John Mirisch, who brought the idea to the table. "It's a wonderful opportunity to showcase our beautiful city and attract businesses and visitors."

Fred Hayman, Robbie Anderson,

Courier Publisher Clif Smith and Traffic and Parking Commissioner Brian Rosenstein will jumpstart the process by helping to organize the committee.

"I am honored to have been selected to serve on this committee," Rosenstein said. "I think this is an excellent opportunity to promote Beverly Hills and for our community to come together to create something we can all be proud of."

Rosenstein said the committee will determine whether the float will be created for the city's 100th anniversary in 2014 or as an annual contribution to the parade.

The group has not discussed how the project will be funded, though Mirisch said the float will aim to be cost-neutral by obtaining sponsorships or getting the community involved in a fundraiser. If funds can't be raised to cover the cost of the float, Mirisch said the city has funds set aside in its budget for items such as holiday decorations, which he said would be better-spent on the float.

Mayor Nancy Krasne said she doesn't

Summary of Ordinance

An Ordinance of the City of Beverly Hills Relating to Parking Meter Zones Hours of Operation and Amending the Beverly Hills Municipal Code

The City of Beverly Hills has established various parking meter zones throughout the City. The proposed ordinance amends the hours and days of operation of the parking meters from 8:00 a.m. through 6:00 p.m. on each day except Sunday to 6:00 a.m. through 11:59 p.m. on each day of the week. The actual hours of operation, however, will be set by the Director of Public Works and Transportation. The proposed ordinance provides the Director of Public Works and Transportation the authority to set the parking meter hours and days of operation as well as the maximum legal parking time at each parking meter in those parking meter zones.

A certified copy of the entirety of the text of Ordinance is available in the office of the City Clerk, Beverly Hills City Hall, 455 N. Rexford Drive, Room 290, and is available for public inspection at that location.

RUDY COLE RESPONDS:

I want to thank both Robert and Lee for being such loyal readers. As long as that continues, there is hope for both.

Lee writes: “I can remain quiet no longer.” Maybe he could have tried just a little harder.

As for my too having a political label, a fair question. Even casual readers would know that I am a very old school liberal Democrat, pro-law enforcement, militant free-speech advocate, except possibly for nasty letters-to-the-editor writers. As for my years-long friendship with Myra Lurie’s in-laws, absolutely, but long before Myra became a member of the Board of Education. They are Sooky and Sam Goldman, and few people in our city’s history have given so much of themselves to our community. However, even they often disagree with my columns.

“Letters and E-mails” [Issue 538]

I must admit I was astonished to see the number of column inches dedicated to my father, Dr. Martin H. Prince, and his 1971 campaign for re-election to the Beverly Hills School Board. Letters from Ernest Roseman, Herbert J. Young, and Mel Spitz brutishly hammered home their subjective points about this event of nearly 40 years ago, citing Mr. Young’s scrapbook of “every piece of literature by every candidate, and every newspaper article, advertisement, and editorial” from that election.

My father, too, has a scrapbook. In it are photos and articles about his five children, as well as the numerous other nieces and nephews that are the object of his love and pride. There are photos of high school graduations from Beverly, as well as undergraduate ceremonies at Harvard, Berkeley, USC, and the University of Michigan, among others. There are photos of his grandson at El Rodeo, as well as of those of his grandchildren at other public schools across the country, and at the University of Wisconsin and the University of Vermont. (Hardly the kind of scrapbook of a man who doesn’t value “excellence in education.”)

More important, my father’s scrapbook is about today’s young people, today’s issues and challenges, and today’s solutions.

That’s the kind of Board member my father was – an independent-thinker who built by consensus and led by example as he listened to the teachers, administrators, parents, and young people during that difficult time in our country’s history. My father, and others who served with him like Dr. Arthur Malin and Elinor Nathan, were champions of both education and educators. They are citizens who –like Mr. Young and Mr. Spitz – gave service to our community to the best of their abilities and with the greatest integrity, no matter what anyone might have thought, or might now think of their philosophical approaches.

But, as S.E. Hinton put it, “That was then; this is now.”

Now is the time of new challenges, new issues, new solutions, and a whole new generation of parents, teachers, administrators, and students. Now is the time for new voices to be heard and new points of view to be espoused. Now is the time for us to learn from those who served our community in the past, but not to be held philosophically hostage to the 1971 values, solutions, and largely irrelevant campaign facts and figures which take up far too much space in a newspaper dated 2010.

As for Mr. Roseman’s attack on me, it’s important to note that I am not a member of the Board of Education and made none of the recommendations charged in the letters written last week. I am a private citizen, a parent, a coach, a volunteer, and a passionate believer in our city’s public schools. With such treatment of non-office-holders and non-candidates, no wonder we find it so difficult to inspire a larger slate of candidates to take on the arduous journey of running for public office. With such continued negativity from those who should know better, having served in office, no wonder as well that we find it so hard to inspire the voters to come to the polls in greater numbers.

Rudy Cole’s response to the three letters which ran in Issue 538 of the Beverly Hills Weekly was factually accurate, and we’re appreciative of his response, yet my father and I spoke for many hours about whether we, too, should respond. I must admit that it was my father’s generous instinct to move on, without a response, as he sees that today’s newspapers have concerns far more relevant than this kind of “ancient history.” But when we looked up from the breakfast table at my seventh grade son, we both knew that had it been HIS battle, we would have given him different advice. We both would have advised my boy to write the letter of response, to address the issues, to right the wrongs, and to be heard...

My dad and I appreciate the opportunity afforded us to respond to the letters from Mr. Spitz, Mr. Young, and Mr. Roseman.

One hopes we can all begin to look ahead, no longer staring in the rear view

mirror of our city’s history, so that we can work together to build a bright future in our public schools with intelligence, passion, empathy, and the burning desire to continue to do right by all of our kids.

I’ve been reading the news reports, etc. in the papers for the last month or so about the Beverly Hills educational system, opportunity permits, etc. and would like to discuss one issue that some people have raised – the talk of instituting a dress code at Beverly High.

Both my wife and I attended Horace Mann in the early 1960s and Beverly High from 1966-1970. Between our families, we have seven graduates of Beverly High, from the early 1960s to the last being my daughter in 2005. The school board did away with the dress code back in the 1960s, including that no dress code also applied to the athletes. The cornerstone of what made the Beverly school system always one step ahead of other school districts was the fact that our school system was “progressive” in every respect and on the cutting edge. We were enlightened to know that a dress code did not reflect on the character of the students or how well they did in school. Some of my best friends in the 1960s at Beverly were the ones who had long hair and were wildly and provocatively dressed, and at the same time, they were some of the smartest students at Beverly that went on to Ivy league schools, etc.

As you know I have been involved with the track & field and cross country teams at Beverly for a number of years, and I run the Web site for the program. Some of the young adults I see on a week-to-week basis at Beverly whom I have gotten to know – even those with so-called “punk” or “hip hop” hairstyles and dress – are some of the brightest and smartest students at the school. I take offense with this new backward movement calling for a dress code and singling out one category of student. I was taught at Beverly, like the students before me beginning in 1927, that we should never judge a book by its cover. What a novel idea!

I do not tolerate bad behavior, regardless of how the student is dressed, and I don’t believe you can just categorize students that have a “punk” or “hip hop” style as all being bad or that they do poorly academically at the school. Instead of focusing on a dress code, I would prefer that the school concentrate on character building, new progressive teaching methods, etc., which usually leads to a better student.

As an alumnus of Beverly, my biggest concern is the fact that every year now we have over 250 students, out of 500+ graduating students, that end up attending Santa Monica City College. It is not the grades. I am sure that many of them could get into a decent 4-year college. I have nothing against Santa Monica City College, but for a school like Beverly that proclaims itself as one of the finest, that was never part of the so-called tradition

or future goal of the school. It is no wonder the school, which was once one of the top high schools in the nation, is now ranked 267. So if there is concern why our ranking has declined, it is the fact that, in my observation, everyone does not want to confront the issue that half our graduates are leaving Beverly to attend a community college. It is a mindset of acceptance by the school system, the students and the parents that would not have been acceptable in the past nor should it be acceptable in the future. No dress code or other conservative program is going to solve the educational issues that face Beverly now and in the future.

As I stated before, the history of the Beverly Hills school system was based on “progressive” ideals not bogged down by tradition, and we should not lose sight of that. That is what made Beverly so special, and we can’t live on past so-called glory days – we need to turn to the future of the school and the best interests of the student. We are not dealing with children, but with young adults, who, in their generation, have progressive ideas, progressive electronic and computer-age communication, and we need to tap into their future and not what was our past. The true tradition of Beverly is to move forward.

Will Rogers was asked to write the foreword to the first Watchtower (Beverly Hills High School’s Yearbook) of 1928, and he warned us in the foreword in his rambling way back then not to follow tradition and not to have a tradition in the school system – and that if you are going to have a tradition, it was not to have one. I believe he meant that we always need to look to the future and not rest on our past accomplishments and laurels. In that same first Watchtower, our school motto was set: “Each To-Day Well Lived Makes Every Yesterday A Dream Of Happiness And Every Tomorrow A Vision Of Hope.”

think raising adequate funds will be a challenge for the city. Alhambra, she said, creates a float for the parade every year for roughly \$100,000.

“We’ll be exploring this [project] in a major way in the next couple of months,” Rosenstein said.

Mirisch said Beverly Hills has historically been involved in the Rose Parade.

“It’d be wonderful to rekindle that and build on our historical tie to the Rose Parade,” Mirisch said. “Ideally, we’d have something next year. If not, then the year after that. Certainly get out feet wet so we can do something spectacular for the 100th anniversary of the city [in 2014].”

Further details have not been worked out as the project is in its infancy, Rosenstein said.

**Mayor Krasne Joins Nation’s Mayors
at White House**



Beverly Hills Mayor Nancy Krasne joined the delegation of U.S. mayors last week at the annual U.S. Conference of

Mayors held in Washington, D.C.

The bipartisan group of nearly 200 mayors from around the country was addressed by President Barack Obama, as well as several administration and congressional leaders including Treasury Secretary Timothy F. Geithner, Energy Secretary Steven Chu, Education Secretary Arne Duncan, House Speaker Nancy Pelosi and First Lady Michelle Obama.

Krasne said the big topic of the conference among mayors was funding in the current economy; the concerns felt by most municipalities were over jobs, the prospect of additional budget cuts and efforts to restore prosperity to the nation.

“All of the mayors came to Washington with the hope of hearing about employment gains or how the country will return to robust economic stability,” Krasne said. “Certainly, many of the mayors wanted to meet the president and receive federal money. I didn’t meet the president, but I did meet the U.S. treasurer. She and I became friendly, and she gave me an uncirculated \$20 bill with her signature. So I came back to Beverly Hills with money.”

Krasne said it was interesting to meet other mayors and discover problems different cities face.

“They were discussing job programs, community development block-grant funding,” Krasne said. “A lot of the cities were in desperate need of money. But my big concern was for pension reforms and things we really needed to deal with in our city, [such as] traffic mitigation. Our

city is in a unique position economically, fiscally, globally and visually. People know who we are, and we have a mystique. I don’t want anything to ever hurt that brand, so I’m very protective of that when I go back there.”

The U.S. Conference of Mayors is the official nonpartisan organization of cities with populations of 30,000 or more. There are 1,203 such cities in the country today. The primary roles of the U.S. Conference of Mayors are to promote the development of effective national urban/suburban policy; strengthen federal-city relationships; ensure that federal policy meets urban needs; provide mayors with leadership and management tools; and create a forum where mayors can share ideas and information.

Say hello and goodbye to a Broad art museum in Beverly Hills.

You probably read about the latest saga in the road show called "Where Will **Eli Broad** Place His Art Museum?" We first broke, and that is probably the operative word, the news that he was considering creating a home for his incredible art collection at Wilshire and Little Santa Monica.

Although this has been in the discussion stages for several years, Broad made some very serious moves to create a museum plus a home for his foundation on what was once the Wilson House of Suede and is now, ugh, a Starbucks.

This area begs for some land-use solutions. Three property owners have brought various proposals to the city, any one of which would have meant significant contributions to making the corner more attractive and beneficial at what is a major gateway to Beverly Hills.

Enter Broad, and all the other plans were more or less placed on hold. Since the Broad plan became public, we learned that we were not the only "suitors" for the museum. First,

Santa Monica entered the bidding. Then, there were rumors about a link to the Museum of Contemporary Art, a major beneficiary of the Broad Foundation, and their possible satellite in the Pacific Design Center and now, the latest, becoming part of the Grand Avenue, downtown development.

The Broad family are incredible philanthropists. Their support of a wide range of charities and their involvement in the arts have made them living legends.

But there is not going to be a Broad Art Museum in Beverly Hills. There are too many issues, including who will pay for a parking structure and questions about height, traffic impacts and how this all works out with plans for adjacent and contiguous property that have yet to be answered. Now, with his other viable options, reliable sources have told us he is not coming to Beverly Hills. It is more likely that Broad will work out something with MOCA or even the Los Angeles County Museum of Art.

Now, we should return to finding a viable land-use plan for property west and east of the

Santa Monica and Wilshire intersections.

Last week, five little words were missing in my comments about promoting from within the police department for the chief's job: "When and if Snowden retires."

Fortunately, the highly popular and respected Chief **David Snowden** has no plans to leave anytime soon.

Good to report that a long-time education leader in California and Beverly Hills, **Carol Katzman**, has taken on a new and exciting chore: chair of the board of Vista Del Mar.

Carol had been involved in our school district for over 35 years working as a teacher, child development education coordinator, director of curriculum and last as assistant superintendent.

She also chaired, with then Mayor **Allan Alexander** the very successful and exciting "Education Summit and Technology Faire" two decades back at the Beverly Wilshire Hotel. After leaving the district, Carol had a 16-year stint at top-level jobs in the State Department of Education.

This new assignment for the exceptional Vista Del Mar, a children and family non-profit service agency just outside our borders, follows a Beverly Hills linkage. The late **George Konheim**, who helped define the word leadership for charities, was for many years the moving force for giving Vista Del Mar the support and leadership that helped it grow into such an incredible resource.

Although I found few references to this in Los Angeles area media, one of the most successful medical relief efforts in Haiti was from Israel. Despite major problems other medical teams faced in setting up viable emergency hospitals, the Israelis had a full service unit in place almost immediately.

There is also a Beverly Hills presence in Haiti: Fire Fighter/Paramedic **Glenn Pinson** has joined Team Rubicom, a self-financed and self-deployed group of former Marines, soldiers and health care professionals who provide emergency relief; he is part of the "Bravo Team." His colleagues in our fire department are working "free trades" to cover his absence.

We will try for an interview with Glenn when he returns to give us a first hand report on this horrendous human tragedy. We had to dig for this story; it did not come from Glenn or the department.

Mayor **Nancy Krasne** has been attending the United States Conference of Mayors in our nation's capitol. Some 200 mayors from all over the country will hear from President **Barack Obama** and first lady, **Michelle Obama**, plus a long list of top government officials.

Trading information and learning how other communities deal with economic problems

and other municipal challenges is always good for Beverly Hills. Her report on the conference should be very interesting.

Theatre Forty will work with our outstanding stage support group, the Beverly Hills Theatre Guild to present a staged reading of "In the Middle of Nowhere" by **Kent Brown** Sunday, February 14 at seven p.m. and Tuesday, February 16, eight p.m. at the Reuben Cordova Theatre at the high school campus.

Ryan will star with **Salome Jens**, a lifetime member of the Actors Studio who has an impressive theatrical resume. For reservations: 310.364.0535.

Beverly Hills Bar Association is co-sponsoring an upcoming exhibition at the Museum of Tolerance: "Courage, the vision to end segregations and the guts to fight for it."

The interactive exhibition will open early next month and tells many stories of valor, including that of the **Rev. De Laine's** fire-bombed church, the many people who filed law suits that eventually led to the culture changing United States Supreme Court decision, **Brown vs. Board of Education** and much more.

Our own community-based Beverly Hills Bar Association is helping to raise funding to pay the costs for free access for thousands of area young people to participate. More on this later, but for updates, please call the BHBA at 310.601.2422.

Councilmember **John Mirisch** appears to have won the support of all of his colleagues, Mayor **Nancy Krasne**, Vice Mayor **Jimmy Delshad** and Councilmember **Dr. Willie Brien**, for his project: enter a Beverly Hills float in the Rose Parade.

John and the whole council want to make this a real community-involved experience with fundraising events, volunteer design and creation and much more. Sounds great and could even help make us all remember that we are one community.

William Allen White, the great American journalist and political thinker whose columns in the Emporia (Kansas) Gazette were read and quoted far beyond his small town's readership, once wrote there could never again be an American revolution: On the way to burn down the Capital, the mob would break up into committees and factions.

Interesting to read that the so-called "Tea Party" revolutionaries are now fighting among their own. Who and what are these people and what is their agenda, except fighting the Obama health care reforms?

Nothing is ever too new. One of the goals of the far right, and their most vocal organization, the John Birch Society, active in the 1960s and fading in the 1980s, was to abolish the federal income tax. They had side issues such as "impeach **Earl Warren**" and oppose civil rights laws. In fact, their southern California leader had an office on Little Santa Monica Boulevard.

Which brings us to the Democratic Party's

meltdown in Massachusetts and other recent elections.

First, this should not be surprising. The number of people voting in the Bay State senate election was considerably less than the presidential vote. But there is a mood in the nation of anti-incumbency that moves quickly from one incumbent candidate and majority party to the newest leadership, however seldom as rapidly as President Obama and the Democrats are experiencing. This political honeymoon never made it out of first kiss stage.

Why? The Kennedy name alone doesn't do it, except for the late Senator himself. Remember, **Teddy** came out strong for Barack Obama in the primary, but his state

voted for **Hillary Clinton**.

More important is that while voters were totally stressed about the economy, the president was fighting for a confusing and consistently changing health care reform package that he never explained properly and that never resonated with the people who most would have benefited. The health care industry captured the minds and hearts of voters, even those who might for the first time actually escape the tragedy of not being able to afford life threatening illnesses.

One of the great communicators of our times became a policy wonk, assumed the American people were tuned in and informed on whatever his program, and would rally to his support. Didn't happen.

This administration, with some last minute help from the last, saved the country and the world from a total collapse of our whole economic system. Not every element of the intervention worked, not every dollar spent to bail out the banks and Wall Street was defensible, and the employment rate is still very frightening, but without his economic stimulus and intervention, this nation was ready to face the abyss. Not yet great, but a great deal better than before.

There is another political nicety you may not have noticed and that Obama has followed: You do not criticize your predecessor, personally. **Bill Clinton** did not say unkind things about **Bush** the First; Bush the Second did not scorch Clinton, and Obama does not

fault the last Bush for screwing up the economy. In fact, they are almost buddies and cooperate whenever asked. Obama asked Clinton and Bush to work together on Haitian relief.

Talk to us President Obama. Tell us about the movement in the economy. Explain the health care reform. We need some of your old fire and rhetoric, and we need it now.



"With a young team, I can't complain," Rappaport said. "We could be better had we scored a couple goals. The bottom line is that we are in second place, which is good enough to get to playoffs. If we could accomplish that, that would be great."

What's Next?

WHO IS LACOE?

As the permit battle shifts to the county, meet the seven people deciding BHUSD's fate

The issue of opportunity permits was recently settled in Beverly Hills, but the debate will now make its way to the Los Angeles County Office of Education.

Parents of the 203 students whose opportunity permits will not be renewed have said they intend to appeal the permit phase-out decision that was unanimously approved by the Beverly Hills Board of Education at its Jan. 12 meeting.

Appeals are handled by the L.A. County Office of Education, which is governed by the seven-member Los Angeles County Board of Education.

"Their main responsibilities are to approve our office's budget and to be the appellate body when it comes to expulsions and district appeals," said LACOE Director of Communications Frank Kwan.

Although each of the 80 school districts and 13 community college districts in the county is autonomous, the L.A. County Board of Education has direct authority over interdistrict attendance appeals and expulsion appeals.

Hearings are generally held every two weeks at LACOE in Downey, and the initial hearing can be either open or closed based

on the discretion of parents, said Kwan. The second hearing with the County Board of Education is open to the public.

Since the Beverly Hills Unified School District will be the first basic-aid district in the L.A. County, LACOE will be dealing with appeals resulting from this transition for the first time.

Victor Thompson, director of student support services at LACOE, said appeals are generally a 30-day process beginning after a parent has exhausted all appeal options within a district. The parent must then apply for an appeal with the county's Board of Education explaining reasons for the appeal and attaching any supporting documents related to the denial from the district.

LACOE will review the notice of appeal and schedule a hearing with a consultant within 20 days.

"The purpose of that hearing is it's a fact-finding meeting, where we sit down with the parents, student and school district representative," Thompson said. "Each side has five minutes to present their case. The consultant will ask questions to help clarify the positions from each side."

Historically, during the initial hearing with the consultant, outside parties have not been allowed to testify.

"We've not allowed that unless its pertinent to the matter itself," Thompson said. "Things such as character witnesses are usually not applicable to the case at hand. So we haven't had a history of it."

LACOE staff members will then present and submit their findings to the Board of Education within 10 days.

"When a parent and student come to the LACOE board meeting, our board has received a copy of the findings," Thompson said. "Each side will have the opportunity to present their case in front of the LACOE board, after which the LACOE board will ask some questions to get clarification from each side."

During this public hearing with the board, outside parties are allowed to testify, though few have taken the opportunity. Thompson said outside testimony would only help if it was specific to the case.

"In the open session, they do ask if there are individuals present that want to speak to the matter," Thompson said. "I believe it would be very important that it pertains

specifically to that case as opposed to general statements made of about a school district, a school or personnel. If it isn't specific I don't know how effective it would be."

For example, Thompson said, bringing in law enforcement to testify on matters of safety would strengthen the case.

The board votes immediately after hearing from both sides. If the appeal is denied, parents and students can file an appeal for the next school year. There is no limit on the number of appeals families can apply for.

There are several reasons why an appeal may be granted, Thompson said, though all appeals are handled on a case-by-case basis.

Criteria for granting an appeal include students who want to participate in classes or programs not offered in their home district; evidence of threats or injury to students in their home district; transportation problems; issues of childcare or other substantial family need; students whose family is in the process of moving; and educational continuity for students who have been enrolled in the district for years.

Students may be denied an appeal if the chosen district is impacted or overcrowded, or if the transfer creates an adverse, significant educational or financial impact on the district.

"Financial is a big one," Thompson said. "Our board takes in all this criteria, and they ultimately make their decision based on the merits on a case-by-case occurrence."

Thompson said he could not make any predictions about the outcome of BHUSD's 203 opportunity permit students looking to LACOE for an appeal.

L.A. County Board of Education members are appointed by the five-member L.A. County Board of Supervisors — comprised of Chair Gloria Molina, Mark Ridley-Thomas, Zev Yaroslavsky, Don Knabe and Michael D. Antonovich — to serve either two or four-year terms. The first three members of the Board of Supervisors are

The County Board of Education is also charged with the responsibility of overseeing the operations of the Office of Los Angeles County Superintendent of Schools. The only jurisdiction the County Board of Education has over school districts, both in incorporated and unincorporated county areas, is in the area of interdistrict attendance and expulsion appeals.

The county's Superintendent of Schools Dr. Darline P. Robles was the first woman to be named the county's superintendent in 2002. Robles served as chief of the Salt Lake City School District from 1995 to 2002. She began her 30-year education career in Montebello as a teacher. She eventually became the superintendent of the district.

LAUSD will begin processing applications for interdistrict permits in April.

BHUSD Director of Human Resources Dr. Alex Cherniss serves as the district's school board representative at LACOE hearings.

When asked if one criterion for granting an appeal is weighed more heavily than another, Cherniss said "each board member on the county board will vote how they want to vote."

In the past five months, Cherniss has attended 10 hearings, only one of which resulted in the granting of an appeal by the County Board of Education.

Former L.A. County Board of Education members Maria Casillas and Sandra Jones Anderson could not be reached for comment.

Former County Board of Education member Ron Rosen, who previously served as a Beverly Hills planning commissioner, declined to comment.
