Planning Commission continues work on Trousdale view restoration ordinance

After hours of discussion during the Planning Commission meeting on June 9, the commission decided to expand the code enforcement section of the Trousdale View Restoration Ordinance. The commission will continue to refine parts of the ordinance that involve other methods of resolution.

The Planning Commission has been discussing and reviewing an ordinance to address residential views obstructed by neighbors' foliage in the Trousdale Estates area for more than two years.

Planning Commission Chair Dan Yukelson said the view restoration ordinance will likely follow a three-step process: neighbor outreach, mediation and a hearing before the Planning Commission, if necessary.

"We hope and believe that neighbors will be able to work with their neighbors and be able to resolve whatever differences they have through the early steps of the process without needing to incur the cost and time necessary to appear in front of the Planning

Commission," Yukelson said.

According to the May 26 staff report, the code enforcement section of the ordinance adds objective standards to the code that are clear and measurable, and do not require discretionary review. City employees can use these standards to inspect properties and determine if a view is blocked.

Expanding the code enforcement section should help reduce the number of matters that will go through the three-step process, and therefore reduce the number of matters that come before the Planning Commission, Yukelson said.

"One of the things we decided to do was enhance the code enforcement section to allow the code enforcement department to handle a few additional matters that block people's views without making people go through the view preservation permit process," Yukelson said. "[The enhancements are] mostly dealing with [limiting] the height of fences and bushes that go up the slope of the Trousdale area."

In April 2009, the City Council directed the Planning Commission to consider regulations to protect views in the Trousdale Estates hillside area, at the request of residents. Although the Planning Commission recommended a draft ordinance to the City Council last December, the City Council requested that an ad hoc committee review the ordinance to address issues related to costs to view owners and to the City for the proposed review process, among other things.

The ad hoc committee and Planning Commission addressed the city council's

Escalante to leave BHUSD for Hermosa Beach

Director of Adult and Alternative Education Pat Escalante will take over as principal at Hermosa Valley School, a school for third to eighth graders with about 800 students, in the Hermosa Beach City School District on July 1.

“My sons graduated from there,” Escalante said. “I was an active parent during the time they were there, and I still live in Hermosa Beach. It’s a great opportunity for me to go back to my community.”

Escalante leaves BHUSD after eight years with the district. Prior to her role as director of the adult school, she was principal at El Rodeo for five years, and assistant principal at Horace Mann for two years.

Although the Board of Education recently voted to reduce the district’s adult and alternative education program, Escalante said her decision to take the job in Hermosa Beach was not influenced by the cutbacks.

“I’ve loved working at Beverly Hills,” Escalante said. “It has prepared me to move forward. This is an opportunity that I really feel is the natural next step in my career.”

Tonight, the Board of Education will vote whether or not to discontinue all adult education services except for the ESL program and

classified services required to support it. The Board previously voted to put the director position on the layoff list on March 11, and voted to discontinue certificated and classified positions held by permanent employees on April 12.

Former Director of Adult and Alternative Education Twila Cook appears as a home teacher summer employee on the June 16 certificated personnel report, which the Board will vote on at tonight’s meeting. During the time Cook was director from 2006 to 2010, the program lost money in 2007, 2009, and 2010. During this time, program funding from the state decreased every year except for 2007.

Century City Chamber of Commerce press conference promotes Constellation Boulevard subway station

The Century City Chamber of Commerce hosted a press conference on June 9 at Constellation Boulevard and Avenue of the Stars to promote the proposed subway station at that location, and to release maps showing the area’s workforce population by Gibson Transportation Consulting, Inc. backed by the Chamber of Commerce.

According to the maps, more commercial space exists and more people work in the one-quarter mile radius surrounding the possible station on Constellation Boulevard than in the one-quarter mile areas around possible stations at Santa Monica Boulevard and Avenue of the Stars, and Santa Monica Boulevard and Century Park East, which Metro is also considering for a Century City station as part of the Metro Westside Extension.

Many Beverly Hills residents oppose a station at Constellation Boulevard because it would require tunneling under residences and

Beverly High.

“When you look at a subway, the most important thing is that people are usually taking a subway to work,” Century City Chamber of Commerce President and CEO Susan Bursk said on Friday morning. “[Constellation Boulevard and Avenue of the Stars] is in the heart of Century City, [and would serve the] maximum number of employees and visitors within a convenient walking distance from all directions. Aligning the subway along an employment corridor seems to make sense financially [and logically].”

A map produced by Gibson Transportation Consulting shows there is 11.6 million square feet of commercial space with 27,263 occupants in the one-quarter mile radius surrounding the possible Constellation Boulevard station, 6.6 million square feet of commercial space with 14,819 occupants in the one-quarter mile radius surrounding the possible Santa Monica Boulevard and Avenue of the Stars station, and 4.2 million square feet of commercial space with 9,874 occupants in the one-quarter mile radius surrounding the possible Santa Monica Boulevard and Century Park East station.

Los Angeles City Councilmember Paul Koretz and members of the Century City Homeowners Alliance and the nearby Comstock Hills Homeowners Association also voiced support for the Constellation Boulevard station as a part of the Metro Westside Subway Extension.

“The Constellation stop is the most logi-

cal place for a Century City Station and I will continue to strongly support this project as long as Metro ensures that the issues of concern to local residents are satisfactorily addressed in future engineering studies,” Koretz said in a statement.

Comstock Hills Homeowners Association President Jan Reichmann also called Constellation Boulevard the logical place for a station and listed several reasons her group prefers the location, including that it would serve thousands of commuters and that it would keep construction impacts away from Santa Monica Boulevard.

“Those who would want it on Santa Monica Boulevard fail to consider or even care about the impacts on others,” Reichmann said. “We endured years of construction when Santa Monica Boulevard was transformed into a beautiful transit parkway. With the many rain delays, it took over five years.”

Beverly Hills City Councilmember John Mirisch, who attended the press conference, pointed out that the subway extension will establish two stations in Beverly Hills, one at Wilshire Boulevard and Rodeo Drive and one at Wilshire and La Cienega boulevards.

“We’re going to have the impact, there’s going to be some time of inconvenience, but we’re doing it for the good of the region,” Mirisch said.

Mirisch called the press conference “well-rehearsed and misleading.”

“You had two homeowners groups with

pretty much contradictory reasons for wanting the subway station [at Constellation Boulevard]," Mirisch said.

Century City Homeowners Alliance President Steve Breuer said his homeowners group, consisting of 2,000 units, supports the Constellation Boulevard location because it would accommodate many workers, reduce traffic and be convenient for residents to travel downtown. Breuer's wife Nadine is a former Beverly Vista principal.

"We represent not only 3,500-4,000 residents but probably another at least as many people who come into our community invisibly to work in our various apartments, not to mention who work in [nearby] condominiums," Breuer said.

The Beverly Hills community has launched its own effort in support of the subway alignment along Santa Monica Boulevard. With the help of public affairs firm Sitrick and Company, the Beverly Hills Unified School District maintains a website, centurycity-subway.org, promoting the proposed station at Santa Monica Boulevard and Avenue of the Stars as a faster and cheaper option that would attract more riders than a station at Constellation Boulevard and Avenue of the Stars.

BHUSD also argues that the presence of a tunnel underneath the high school would affect the district's ability to execute future Measure E construction projects.

On April 27, Superintendent Dick Douglas sent a letter and a 24-page report to Ronald Stamm, principal deputy county counsel in

the Transportation Division, explaining how the construction of a tunnel under Beverly High could impact the school district's Measure E construction plans for the high school campus.

"The mere potential presence of the Metro tunnels under a new school building will definitely cause increased expense and delay to the Beverly Hills High School building program and could jeopardize the entire modernization program approved by the voters in 2008," concludes the report.

The City of Beverly Hills has retained Arnie Berghoff & Associates, a Los Angeles-based public affairs consulting firm, to promote the Santa Monica Boulevard route alignment from Beverly Hills to Century City, and conduct meetings with MTA and other elected officials.

Former employees sue Beverly Hills Hotel for alleged harassment

Five former Beverly Hills Hotel employees filed a lawsuit on June 8 against Beverly Hills Hotel Corporation, former hotel general manager Alberto del Hoyo, who reportedly retired last week, and manager Micah Paloff for six causes of action, including harassment, discrimination, wrongful termination, and failure to take necessary steps to stop discrimination and harassment from occurring. The lawsuit demands a trial by jury as well as compensation for damages.

The lawsuit alleges that four former employees—Robert Sulatycky, Nino O'Brien, Wendy Giron and Kelley Morales—were forced to resign due to intolerable working conditions and a fifth former employee, Tim Dupree,

is suing for wrongful termination, which he believes was motivated due to sexual favoritism toward female employees.

According to the lawsuit, employee Desire Cano was allegedly sexually harassed by del Hoyo in 2006 when he allegedly pinned her against a copy machine and grabbed her buttocks. The lawsuit says that the hotel's human resources department was notified, but "defendant Beverly Hills Hotel protected Mr. del Hoyo in this incident by settling this lawsuit and not taking any effective corrective action involving Mr. del Hoyo as his harassment of women continued unabated."

"We would like to see effective corrective action taken by the hotel," said Rob Hennig, attorney for the plaintiffs "My clients filed the lawsuit not just for them—of course they're hoping to be compensated—but they wanted other people to not have to go through what they went through, which is conduct that is illegal [in the workplace] in the State of California."

Wendy Schnee, director of public relations at the hotel, responded to a phone call from the *Weekly* with an e-mailed statement.

"The allegations made about The Beverly Hills Hotel's former general manager and another employee are currently under investigation. The company's values and policies are rooted in respect for all staff members and discrimination is not tolerated," Schnee wrote.

Schnee did not return subsequent phone calls from the *Weekly*.

Giron and Morales were hostesses at the Polo Lounge. The lawsuit alleges del Hoyo would greet them in a way that allowed him

to touch their breasts and that they witnessed him greet other hostesses this way as well.

O'Brien, who is of Indian and Irish descent, began working for the hotel as a sommelier in 2008, and the lawsuit claims he was subjected to differential treatment because of his race/national origin by the hotel and by del Hoyo. According to the lawsuit, O'Brien was also subjected to sexually explicit comments from Paloff.

Sulatycky, who was a food and beverage director, was allegedly subjected to racist and sexist comments from del Hoyo on a "near daily basis." The lawsuit states, "Mr. del Hoyo informed Mr. Sulatycky to never hire blacks" because he believed they were lazy.

Tim Dupree began working at the hotel in 2005 and was terminated in 2010, which was allegedly "motivated by Mr. del Hoyo's sexual favoritism" because Dupree was "forced to be supervised and then supervise Mr. del Hoyo's preferred employees based upon the willingness of these women to accept Mr. del Hoyo's advances," the lawsuit states.

The Beverly Hills Hotel closed for renovations for more than two years between 1993 and 1995. Prior to the renovations, the hotel was unionized. According to Leigh Shelton, spokesperson for Unite Here Local 11, closing down allowed the hotel to fire its workers and open up as a non-union hotel.

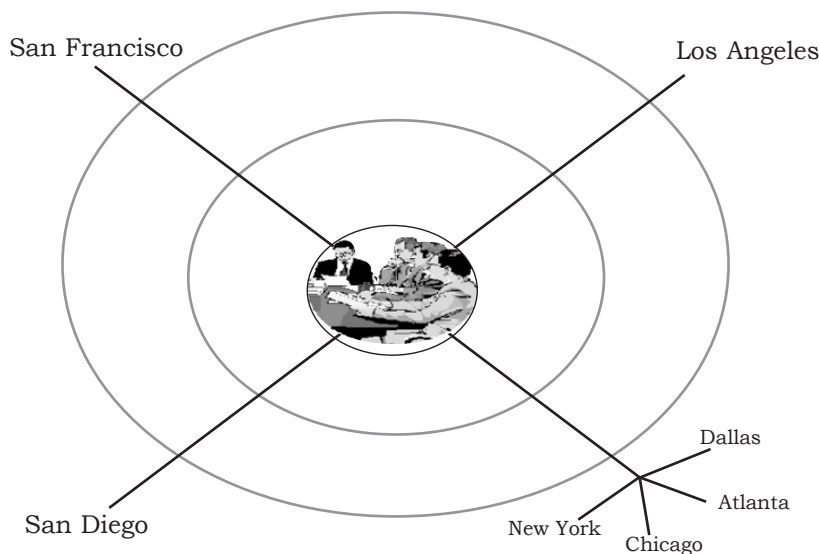
When asked if Beverly Hills Hotel employees were currently organizing, Shelton said, "We're not commenting on that."

The Beverly Hills Hotel is owned by the Dorchester Collection, the same company that owns the Hotel Bel-Air, which is currently closed for renovations. Shelton said

she thinks the Bel-Air is trying to kick out its union by closing the hotel.

Laura Shelby, attorney for the hotel, del Hoyo and Paloff, did not return phone calls from the *Weekly*.

Board of Education members clash over possible Beijing trip

The June 9 Board of Education meeting got off to a rocky start, beginning with an apology from President Lisa Korbatov for the late start-time of the meeting, followed by critical public comments from Beverly High choral director Joel Pressman and a heated discussion about an opportunity for 20 performing arts students and five chaperones to travel to China this summer.

The meeting, scheduled to begin at 8 p.m., did not start until after 9:20 p.m. with only Korbatov, Vice President Brian Goldberg and Board member Jake Manaster present. Board members Myra Lurie and Steven Fenton arrived within 10 minutes once the meeting started.

Bruce and Nanette Cole presented the opportunity for 20 performing arts students ages 11 to 16 to travel to Beijing from August 13 to 20 to participate in a program called "Meet in Beijing" involving students from China, Japan, South Korea, North Korea, India and Australia. The program, produced by China Central Television (CCTV) in partnership with Beijing Municipal People's Government, intends to promote international youth cultural exchanges. BHUSD was invited to submit video clips of student performances for consideration.

Pressman said he did not think the trip was a good idea because the "proposal to send a group to Beijing was very late in the school year and designed for a performing organization we do not currently have in place." He said it would be difficult to hold auditions and select participants in a fair manner.

Bruce Cole explained that the opportunity came about because of the Coles' friendship with Chinese filmmaker Guan LeiMing and her husband Pan Chao, who is in charge of children's programming at CCTV. Bruce is vice chair and Nanette is a board member of Beverly Hills Global Partners, the sister cities organization.

"I understand from Lisa [Korbatov] and [Courier publisher] Clif Smith that the new superintendent will be leading that delegation to China," Bruce Cole said.

Cole said that the visit could lead to a "virtual exchange" between Beverly High students and Beijing high school students, in which they would communicate with each other by video conferencing. Cole said the idea "particularly ties in with the fact that Beverly Hills is teaching Mandarin and has expanded Mandarin now to the third year."

Cole told the Board that expenses of the trip would be paid for by CCTV. The description on the agenda states, "If selected to participate, there is no cost to the students or chaperones."

Korbatov said it was her understanding as well that all costs would be covered by CCTV.

Manaster said he wanted to make sure that the district was going about the trip in a legal, efficient way, and that proper procedures would be followed if district employees travel with the students.

"Any employees going, there has to be

compensation [from] the district," Manaster said. "I'm curious as to whether any of that assessment went on."

According to Assistant Superintendent of Business Services Alex Cherniss, the district is required to pay district employees for a workday for each day they are on a trip when it takes place during the school year. Since the trip to Beijing would take place over the summer, Cherniss said the district would not have to compensate district employees while they are on the trip.

Korbatov said she did not learn about the opportunity until June 7 and never received a copy of the letter informing the district of the opportunity. She said she had copies of e-mails that showed Lurie had been informed about the opportunity on May 25 and had shared the information with Superintendent Dick Douglas on or around May 27. Korbatov read from an e-mail that Lurie had reportedly sent to LeiMing stating that the district would not be able to meet the deadline.

"I copied all administrators on [the e-mail], based on discussions with the VAPA coordinator as well as with Mr. Pressman, who said there was nothing forthcoming [for the video], but luckily we were able to go back and be entitled to simply submit anything [on video] that was representative of the skills and talents of the schools," Lurie said.

Korbatov said it was not in Lurie's purview to decline the offer, and said that Douglas and Lurie should not have waited 13 days to notify her about the opportunity.

"Furthermore it was with the help of Mr. Cole and Mr. Paysinger that we revived this," Korbatov said.

"To which I say this is wonderful. It's all about the kids, it's not about your power," Lurie said.

Korbatov responded, "It's not about you acting nefariously for 13 days."

"My responsibility was to turn [the letter] over to administration so they can deal with it as well as faculty, which is what I did," Lurie said.

Korbatov said she agreed that administration should have notified the Board.

Pressman asked to speak since he said he had decided there was not time to put together a performance ensemble to make a video, but Korbatov declined his request.

"I think with Mr. Pressman's comment about the democratic way in which people are chosen, I understand those are issues," Bruce Cole said. "If you look at it the other way, the Chinese coming don't care about that. All we have is a one-time opportunity. We won't be invited again if we don't do it."

Korbatov explained that the district had to rush to put together four DVDs, including clips from Beverly High's production of *Fiddler on the Roof* and dance performances, to send off in time for the application deadline.

"When images were sent over to Beijing I want to know if parents signed off on the images before they were sent out of the country, because there's a federal law that prohibits that," Manaster said.

When no one responded, Manaster advised that the district obtain releases as soon as possible. He said the federal law is called the Children's Online Protection Privacy Act and carries a \$100,000 fine.

The Board also directed staff to investigate potential costs associated with the trip and

whether the district has an adequate insurance policy to cover students traveling with staff members outside of the country.

Cherniss confirmed on Monday that the district has adequate insurance to cover the trip.

Despite the tense discussion, board members expressed support for the trip.

"I think this is the type of educational opportunity we talk about providing our students," Goldberg said. "[I'm] pleased [with the] opportunity to participate [but] I'm concerned about handling it appropriately to make sure we dot our I's and cross our T's in making this possible."

Lurie was in agreement.

"This is about a wonderful opportunity for our children to demonstrate how talented they are and to build collaborative relationships," Lurie said. "I hope the Board [can] serve [as an] example about friendship and being a class act on behalf of the city."

The Beijing trip is on the agenda for tonight's meeting at 7 p.m. in the Salter Family Theater at Beverly High.

City Council, Planning Commission talk historical preservation

In the interest of historical preservation, Councilmember John Mirisch brought the topic of demolition permits up for discussion at the City Council study session on June 7, suggesting that applicants receive approval for a replacement project before a demolition permit is issued.

Mirisch suggested replacement projects should be required at least for properties appearing or potentially appearing on a registry of historical buildings. Although the City of Beverly Hills conducted two surveys

in 1985 and 2006 to identify historical and potentially historical single-family, multi-family and commercial properties, a register of historical buildings has not been formally adopted by the City of Beverly Hills.

Mirisch pointed out that many cities require replacement projects before demolition, whether the building is considered historically significant or not.

Currently, the City of Beverly Hills allows demolition permits to be issued without a replacement project, but requires landscaping and fencing to mitigate impacts of having a vacant parcel in a residential neighborhood.

Although Assistant Director of Community Development Jonathan Lait told the city council that the demolition permit process and the Mills Act are separate topics, the city council decided to wait until it discusses the Mills Act to consider making changes to the demolition permit process.

"I'm disappointed. I think this is a loophole that we consciously created [and it's] time for us to close [it]," Mirisch said after the meeting. "It's time for us to begin to appreciate our rich heritage before we lose it."

The Mills Act was enacted by the State of California in 1972 and grants local governments the authority to enter into contractual agreements with owners of qualified historical properties that would offer tax incentives for actively participating in the restoration and maintenance of the properties. To qualify for the Mills Act, a structure must be on a local, state or national historic register.

Planning Commissioner Brian Rosenstein, who addressed the city council as a resident and not on behalf of the Planning Commission, said he believed that historical

Reason and not vitriol

Is needed to win the subway fight

Name calling, attacks on public officials and partisan politics is seriously hurting our fight to prevent a subway from going under our high school.

This should not be about settling old political, personal conflicts; and how does it help us to make wild accusations against people we have long trusted and who represent us at all levels of city, county, state and national government?

Do we really believe that County Supervisor **Zev Yaroslavsky**, Los Angeles City Councilmember **Paul Koretz**, Assemblyman **Mike Feuer** or Congressman **Henry Waxman** are all in the pocket of Century City developers?

These are among the most trusted names in government. They have served us with distinction, and well. Now, because they have not yet agreed to join us in opposing tunneling under our high school, have they become "enemies of the people?"

We are losing whatever hope we have of winning their support by hysterical allegations of siding with "the special interests."

Certainly, developers and Century City interests are fighting for a station in their area—the Constellation and not the Santa Monica route we favor. But we cannot win our effort and gain the support of our representatives by simply attacking their motives and integrity.

Add to that the attacks by the school board on the council majority for not being more "aggressive" and what we have is a ludicrous spectacle of divisiveness.

It isn't working and it won't work, and what is happening could harm the safety and security of many future generations of kids in our schools.

Is it just by chance that many of the most volatile voices are Republicans and that all of our representatives are Democrats? Consider one action by the school board: They have hired a well known Washington law firm as lobbyists,

with strong Republican Party ties.

Aside from the wisdom of spending scarce school money on lawyers, lobbyists and public relations "experts" on this effort, how smart is to use representatives totally out of sync with our own Congressman, Henry Waxman—and is it even timely or practical?

Yes, the House has a Republican majority, but even Republicans defer to the congressman of the district on appropriations. Taking the battle to Washington, and on funding for the whole subway project, is very premature and a waste of school funding. The whole board voted approval.

Not only have we alienated our elected representatives, but we have become the paper tigers in this battle for other elected and appointed public officials who serve on the MTA board.

It's time to get our act together, and face some realities:

Aside from the real special interests who have much to gain by working for a Century City route, we face opposition from some natural allies: Homeowner associations in Western Los Angeles. We need to reach out to them, now.

Also aligned against us are transit user groups, powerful construction industry trade unions and neighboring retailers and hotels.

There are some arguments we can use:

1. Santa Monica route choice brings us closer to Century City than the station proposed in Westwood, which is considerably further from UCLA, with a much higher user potential.

2. Costs for Constellation will be at least \$60 million more than Santa Monica.

3. There is simply insufficient technology to assure the safety of tunneling under our high school.

4. The choice of routes endangers the entire subway plan.

Are we simply being selfish and short

sighted? Not at all, but our rhetoric makes us appear that way. The Westwood condo associations successfully blocked a widening of Wilshire Boulevard because it would have impaired their garage access. That fight is not nearly as invasive as the Constellation route proposal, but they kept their act together and succeeded.

As for another powerful western homeowner group, "Tract 7260." They owe us and our schools. One of the founders of this association was **John French**, the long time principal of Beverly Vista. (Just an historical note, although their group is less anti-Beverly Hills than some of the others.)

As for this reporter, I had, and still have, reservations on the whole concept of a subway to the sea. But I have no doubts on the route. There are simply too many unanswered questions on safety to risk going under the high school. I expressed my views on the subway despite two city committees' support of the subway project.

Even the MTA's own traffic study admitted the subway may be traffic neutral and not reduce automobile trip generation. Certainly it could open up more development in West Los Angeles, already too congested, and not promote revitalization of other, neglected areas in Los Angeles.

Santa Monica route supporters insist the council should adopt a resolution of opposition to any subway if it goes under our high school. I might agree that would be a strong statement, but is it realistic? All the decision makers favor the subway—we are throwing a challenge at them they will not support and, considering our divisive approach, it will only weaken our effort.

I have great respect for those who have taken the leadership in this effort, long before the school board or the city council showed any real, active concern. Southwest Beverly Hills Homeowner Association president **Ken Goldman** and other residents of the area, merit our thanks for fighting the good cause. Now, however, we need to think success and political realities, not personal agendas.

Waxman, Yaroslavsky, Koretz and Feuer are trusted, admired and honest public servants. They too will work to protect the kids. We need to stop making them the enemy of the people.

Final thoughts: Mayor **Barry Bucker** and the council too have also been unfairly targeted because they have focused on a cooperative instead of a confrontational approach. As Woody Allen said: "Whatever Works." But infighting hasn't and won't.

Which brings us to Dr. **Willie Brien**, our vice mayor and former school board president. He has no personal agenda, and no history of battles with any school board member. He is respected in and out of our city. When he opposes the route but wants us to use our strength by responsible opposition, we should listen. It may be politically advantageous to make strident

attacks on those with whom we have yet to convince, certainly, at mass meetings, that will win applause, but it won't win the war.

Speaking of political clout, if the map now being proposed for our assembly district is adopted, we could lose considerable influence in Sacramento.

The lines proposed would place us in the same district as Santa Monica, and they have more than double our registration.

Currently, we share an assembly district with parts of Los Angeles and the city of West Hollywood. Because the Los Angeles precincts are not a cohesive community, the influences of Beverly Hills and West Hollywood usually decide the election. We helped elect Assemblyman Mike Feuer who is about to be termed out.

As soon as the changes were revealed, the mayor of Santa Monica announced his candidacy.

We have never in our history succeeded in electing any member of our city council or school board to any state office. Yes, some of the best lived here, including **Alan Sieroty** and **Tony Beilenson**, Sieroty as state senator and assemblyman and Beilenson, all of those and in congress.

However, we could have some future possibilities, this redistricting doesn't help, and it certainly dilutes our voting impacts.

Assemblyman Mike Feuer has been exceptionally sensitive to our community and in working in Sacramento for public education and reform.

Tuesday evening, he flew to Beverly Hills for one night only so that he could attend the annual Beverly Hills Firemen's dinner event.

As for the Ball, it was an enormous success, with the largest participation in its 19-year history. All members of the city council, Dr. **Julian Gold**, **John Mirisch**, **Lili Bosse**, Vice Mayor Dr. Willie Brien and Mayor Barry Brucker attended as did four school board members: President **Lisa Korbatov**, vice president Dr. **Brian David Goldberg** and members **Jake Manaster** and **Myra Lurie**. (**Steven Fenton** was reportedly on his honeymoon, out of the country.) Also both newspaper publishers, our own **Josh Gross** and the *Courier's* **Cliff Smith**. Mayor Brucker opened the event with a tribute to our first responders.

More on the guest list and the honorees next week, but a special nod to **Judie Fenton** and the whole team at FTA. It was, by any standards a major success. Didn't hurt that the general manager of the Beverly Hilton **Sandy Murphy** and husband John were in attendance at the dinner as always, held at their hotel. As expected, the food and service were first rate.

buildings should not be demolished without proper review or mitigation.

"In some cases this flaw in our code could be exploited with the intent to avoid a CEQA [California Environmental Quality Act] review and mitigate the impacts of such a loss," Rosenstein said. "Such a review would normally occur if the applicant submitted a new project for the property prior to the demolition of the existing building."

Rosenstein suggested the city council ask the Planning Department to incorporate into its database the inventory listed in the Beverly Hills Historical Resource Survey reports from 1985 and 2006.

"If an applicant comes forward with a request for a demolition permit on one of these properties, then the Planning Department should withhold the issuance of the demolition permit pending a review of the potentially historical and cultural significance of the existing property and what the mitigations might be according to CEQA. Then when and if the property owner does the necessary mitigations, then issue the permit," Rosenstein said. That way, owners of properties that are not historically significant will not be adversely affected.

Mirisch said he thought this idea would accomplish his goal for closing the loophole.

Councilmember Julian Gold asked if there were elements of the demolition permit procedure that would overlap with discussion of the Mills Act, which could come up for consideration this summer.

Lait said they were two distinct topics, but that both concepts could incorporate a 40- or 60-day "cool-down period" before issuing a demolition permit to allow the property owner time to seek a possible buyer that may want to restore or preserve the structure.

Vice Mayor Willie Brien said he did not support making any changes to the demolition permit procedures.

"I think [there could be] a lot of unintended consequences by making a quick decision about this that creates a slippery slope in the future for many homeowners," Brien said. "If the goal is to give incentives for people to maintain existing structures that have historical value [and are] on some historical list of some sort, through the Mills Act you can give tax incentives to do that in essence." Mayor Barry Brucker agreed that the discussion should wait until the city council considers the Mills Act.

The Planning Commission invited historic preservation expert and consultant Janet Otashay to give a presentation on the Mills Act at the commission's June 9 meeting. "We were presented with a lengthy list of California cities that have passed their own Mills Act and there's been a number of properties in each of the cities, in some cases more than 20, that fall under the Mills Act ordinance," Planning Commission Chair Dan Yukelson said. "There could definitely be a lot of benefits to our city by adoption [of the Mills Act]. Number one, it preserves old buildings by encouraging owners to maintain them and improve them because they get tax breaks from it."

Yukelson said the Mills Act could also potentially enhance land values, attract businesses to historical buildings, and attract tourists.

Human Relations Commission will consider noise ordinance today

The Human Relations Commission will discuss the noise ordinance at its meeting this morning at 9:15 a.m. in Room 280-A at City Hall.

In order to make a recommendation to the city council, Human Relations Commission Chair Sharona Nazarian said the commission would go over the comments, phone calls and letters from the public meetings, as well as comments from city officials from the Police and Code Enforcement departments.

"We're going to deliberate and take all that information into account and try to come up with a recommendation to present to the city council that will benefit the community as a whole," Nazarian said.

The last of three community meetings regarding a possible revision of the City's noise ordinance concluded on May 24. During the meetings, residents expressed a range of objectives for the ordinance. Some advocated for extended hours, some advocated for more limited hours, and some requested no changes to the ordinance.

Current City regulations limit the use or operation of sound amplifying equipment to the hours between 10 a.m. and 6 p.m. daily. The ordinance also presents guidelines for maximum permissible decibel levels. The ordinance is reportedly being enforced by Beverly Hills Police beginning at 10 p.m.

High school perimeter security will cost at least \$85,000 more than previously estimated

BHUSD Chief Facilities Official Nelson Cayabyab told the Board of Education on June 9 that the cost of a previously approved project to increase perimeter security at Beverly High will increase significantly, based on input from maintenance and high school staff, the Beverly Hills Police and Fire departments, members of the PTA and Board of Education members.

A budget of \$121,000 was approved for the project, but it could increase by as much as \$150,000 based on estimates from Cumming architects, \$208,392, and construction management firm Bernards, \$274,392. Cayabyab estimated the total cost to be \$250,000, which the Board voted 5-0 to approve.

On March 7, the Board unanimously approved plans for perimeter security at Beverly High that included outdoor exterior locking gates, vehicle gates, perimeter doors with alarms and additional security personnel. The Board chose this option over the more imposing option of installing an 8-foot-high chain link fence at the front of the school, to preserve the iconic look of the school.

Cayabyab explained that elements such as additional door alarms and electrical motor controls on the gates account for the increased cost. The graduation lawn will not be fenced off.

"This is incredibly expensive from a door lock perspective," Board member Jake Manaster said. "[I was] really concerned this was going to become a runaway train [and] I would say it's come close to that."

Manaster pointed out that many of the security measures would likely have to be uninstalled in a few years when construction starts on Measure E projects at the high school. Vice President Brian Goldberg asked Cayabyab what parts of the project would

remain intact during construction.

"The only thing that is going to remain are the control gates, and some of the fencing we're going to erect [at a] gated area. The locks and mechanisms put in place on these doors are standalone," Cayabyab said. He said that the security measures that would remain intact amount to about 40 percent of the project.

Cayabyab said that in deciding the location of external gates, the need for access by construction and emergency vehicles had been taken into account.

Board of Education discusses city manager's letter about Beverly High oil well

In the middle of the Board of Education's closed session meeting on June 9, the meeting was opened up for a discussion of a letter from City Manager Jeff Kolin regarding the oil well at Beverly High, the lease with Venoco and the city's interim ordinance prohibiting future oil well drilling in the City of Beverly Hills.

In Kolin's letter, he offered to attend or have a staff member attend a future Board of Education meeting to discuss the current Venoco lease, the city's proposed ordinance and to solicit input from the Board regarding oil drilling adjacent

to Beverly High. Both the City of Beverly Hills and BHUSD are parties to the Venoco lease, which expires in 2016.

The Beverly Hills City Council unanimously passed an interim ordinance on January 25 prohibiting future oil well drilling in Beverly Hills, and voted unanimously on March 1 to

extend the ordinance until January 25, 2012. The Planning Commission is currently studying a permanent ordinance, which the city council will consider at a future meeting.

"We put in an urgency ordinance to make certain that nothing is done with any extensions on that lease [with Venoco] until the city can establish [its] municipal code," Mayor Barry Brucker said on May 27. "Neither the city nor the school can enter into an extension of that contract until this municipal code is finalized."

Based on direction from the Board, BHUSD has asked legal counsel Bill Ireland to go over the lease with the Board during its closed session meeting this afternoon. Kolin has been invited to the regular Board meeting on June 28 to address questions about his letter.

Superintendent Dick Douglas said that Kolin had offered to attend the June 9 meeting, but the offer was declined because the "determination here was to see what [the Board] want[ed] to do."

Board President Lisa Korbatov said she found parts of Kolin's letter confusing.

"The letter asserts that somehow we're in some kind of agreement about parts or all of this ordinance," Korbatov said. "I don't recall anyone from the City ever talking to anyone on the Board individually or collectively about this ordinance."

Board member Jake Manaster pointed out that the "agreement" the letter refers to is most likely the lease, but he agreed that was not clear in the letter.

"I know for a fact the reason the letter was written was because of a rumor we had started negotiations with Venoco to extend the lease, which I know to be factually untrue so maybe we need to be clear about that," Manaster said.

Manaster also expressed concern about the

timing of the dialogue.

"I think we have to weigh the impacts of opening up [this] dialogue right now with everything we're doing, because [this] dialogue won't be confidential, it won't be [during] closed session discussion and it will involve at some point very shortly after [a] city council discussion," Manaster said.

Legal counsel Kevin Brogan suggested that Brogan and/or oil and gas counsel Bill Ireland meet with City Attorney Larry Wiener to get an understanding of the scope of the dialogue Kolin is proposing.

Board member Steven Fenton said he objected to using the services of legal counsel to get clarity on the letter.

"I'm not interested in taking money out of the classroom to get clarity from what the city feels," Fenton said. "I would propose [we] have Jeff come in here [and] in lay terms tell us the exact position of the city council and what the timeline is of the city council and have a dialogue with Jeff about this."

Korbatov said she was not comfortable having the conversation without legal counsel present.

"I'd be interested in having a conversation whether the Board thinks the city council should be telling the school board what to do and literally tying the school board's hands in making any decisions, because this decision ultimately will rest in not the next board but the board after that," Fenton said. Vice President Brian Goldberg said he agreed.

Although the agenda did not call for a discussion of Board members' positions on the oil well, Board member Myra Lurie invited her colleagues to share their positions. She said she believed the lease should not be renewed.

Korbatov pointed out that that discussion was not on the agenda, and Manaster said he was not comfortable having the conversation in the near term. However, Manaster said he has already made his position clear, which is to work on other "revenue streams" for the school district. Goldberg said he had not changed his position, which is that he does not support having an industrial zone on school sites. Fenton said he, too, has made his position clear.

Beverly Hills resident Jody Kleinman, who has been an advocate against the oil well for years, addressed the Board before the discussion started.

"The issue of the oil well is part of the same issue you are fighting with Metro rail," Kleinman said. "If you do not want Metro rail here because of methane gas, earthquakes, potential health and safety hazards, then you have to be consistent about not wanting an oil well when you finally have the choice to permanently close it down in 2016."

WHEREAS, cost-of-living is defined as either the change in California per capita personal income or the change in non-residential assessed valuation; and

WHEREAS, population is defined as either the change in City or County population; and

WHEREAS, the information necessary for making these adjustments is attached in Schedules A, B and C.

NOW, THEREFORE, the City Council of the City of Beverly Hills does resolve as follows:

The annual adjustment factors for Fiscal Year 2011/2012 shall be the California per capita personal income change over the prior year and the County of Los Angeles population change over the prior year.
