Newport-Mesa Unified teachers union requests vote of no confidence in Hubbard

The approximately 60-member Newport-Mesa Federation of Teachers (NMFT) Executive Board and Site Representative Assembly voted unanimously Oct. 19 to approve a resolution recommending a vote of no confidence in Newport-Mesa Unified School District Superintendent Jeffrey Hubbard, who currently faces three charges of misappropriation of public funds related to his occupation in Beverly Hills.

The teachers union has sent the resolution out to the union's 1,000 members for a vote, and plans to present the results at the Nov. 3 NMUSD Board of Education meeting.

"A lot of our members have been pressuring the union to do something about the Hubbard situation," NMFT Director of Political Organizing and Treasurer Joel Flores said. "The first and the largest problem that we have is that he asked the Board of Education to take a paid leave of absence to handle issues that stemmed from his employment in Beverly Hills."

Hubbard's approximately five months of paid administrative leave amounted to \$125,000, which the executive board views as a gift of public funds since those funds were not used for the benefit of the NMUSD.

"We're greatly troubled by the fact the Board of Education majority lacked discretion

in approving that," Flores said. "We are not saying he is guilty or that he is innocent; we're just saying he should not have paid leave of absence to take care of problems that he brought with him from a previous job, and no teacher or employee in this district would ever be given that type of favorable treatment."

Hubbard was charged Oct. 11 with one additional count of misappropriation of public funds for allegedly raising the salary of then-BHUSD Credential Analyst Nora Roque without Board of Education approval. Roque followed Hubbard to NMUSD, where she is currently director of classified personnel. Hubbard had previously been charged with two felonies for allegedly allocating \$20,000 to Christiansen without board approval and illegally increasing her car allowance.

The Board of Education majority has stood behind Hubbard since allegations of Hubbard's misconduct surfaced. Board member Katrina Foley was the lone board member to vote against authorizing Hubbard's paid administrative leave in January.

At one time, Hubbard was president of the teachers' union at Rim of the World Unified School District in Lake Arrowhead, prior to coming to Beverly Hills.

Board of Education President Walt Davenport declined to comment. NMUSD Director of Communications Laura Boss did not return phone calls from the *Weekly*.

Golden to return to Beverly High

The Board of Education voted unanimously Tuesday night to appoint Amy Golden as interim assistant principal at Beverly High.

Golden will take over for current Assistant Principal Kelly Tabis, who will soon go on maternity leave.

Golden, who is currently an assistant principal at Redondo Union High School, was an assistant principal at Beverly High from 2005 to 2008.

When asked what Golden was looking forward to about her

return to Beverly High, Golden said, "For me it's like coming home. I'm extremely excited to work with Carter [Paysinger], Toni [Staser] and Chuck [Kloes]. I've worked with them all in the past. I think we'll make a great team."

City cancels furloughs due to "improving economic situation"

In an e-mail to City staff Wednesday morning, City Manager Jeff Kolin announced that 40 hours of furloughs scheduled for the last week of December have been canceled due to "the City's improving economic situation."

"The 40 hours of furlough for non-safety employees originally was approved as part of plan to close a \$4 million budget gap for fiscal year 2011-2012 and would have saved approximately \$320,000," Kolin wrote to City staff. "However, an unexpected increase in the transient occupancy tax from the City's

Horace Mann modernization plans include new middle school building, multipurpose room

The Board of Education unanimously decided Tuesday afternoon to move forward with plans for a \$55 million modernization of the Horace Mann campus that will involve building a new two-story middle school with a 4,000-square-foot multipurpose room and library on the corner of Charleville and Robertson boulevards. The Horace Mann auditorium and Building A, the main campus building that houses the offices, will remain and undergo renovations.

In the interest of \$640,000 worth of savings, the Board decided to renovate the Horace Mann auditorium, instead of demolishing it and rebuilding. The board discussed the possibility of building a new auditorium at the Sept. 27 meeting when Chief Facilities Official Nelson Cayabyab told the board that the cost of current renovations required at the auditorium had increased from \$810,000 to approximately \$3.3 million.

The modernization of Horace Mann will involve tearing down the existing middle school, library and rotunda. Since the new two-story building will be constructed on a different site than the existing buildings, Board of Education Vice President Brian Goldberg said this option could allow the district to save money and minimize the number of students in interim classrooms, because the old building could remain until the new building is built.

Goldberg said the district’s planning consultant DeJong-Richter recommended the addition of a multipurpose room to the campus based on educational specifications. Goldberg said the multipurpose room would also enhance the JPA with the City, since it would be available for the community’s use.

Horace Mann Principal Steve Kessler, who is also a licensed contractor, expressed excitement about the plans.

“I’ve been involved in the process since the very beginning and I was very happy that we had a meeting with our Horace Mann facilities committee that joined the district Facilities Advisory Committee prior to the board meet-

ing yesterday and we unanimously came up with the recommendation that we gave to the board,” Kessler said.

Kessler added that the campus, after modernization, would have a more uniform design.

“I think that the school is keeping the old themes which are so important to our community, but they’re also bringing everything up to 21st century educational standards and I believe it will be a wonderful addition to the BHUSD,” Kessler said.

Final plans and designs will come before the Board for approval. Goldberg said if all goes well, construction would begin in the summer of 2013.

Write-in vote count will delay election results

Due to Noah Margo’s write-in candidacy for the Board of Education election, results of the Nov. 8 election may not be known on

Election Night because write-in votes are not counted until after the official canvass of election returns begins Thursday, Nov. 10. The official canvass lasts until Nov. 21, when the Los Angeles County Registrar-Recorder/County Clerk is tentatively scheduled to certify the election results.

According to Registrar-Recorder/County Clerk spokesperson Marcia Ventura, write-in votes have to go through a verification process to make sure that ballots with write-in votes do not cast votes for more candidates than the maximum allowed.

On Election Night, Vote By Mail ballot semi-final results will be available by approximately 8:30 p.m. and precinct semi-final results become available as ballots are processed. Bulletins are updated and results released approximately every 30 minutes until the last semi-final official results are tallied on Election Night.

This Ordinance would establish regulations and a process to restore certain views in Trousdale Estates. This is a separate ordinance from an ordinance adopted by the City Council in August, 2011, that established additional maximum height regulations for fences and hedges on certain slopes between properties in Trousdale Estates.

Trousdale Estates is defined in the zoning code as all property located north of Doheny Road and east of Schuyler road, except that land zoned R-1.X, and that portion of lot A of the Doheny Ranch Tract northwesterly of Tract Numbers 24485 and 24486, commonly referred to as the Greystone Mansion Property.

This project has been assessed in accordance with the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the environmental regulations of the City, and no significant unmitigated environmental impacts are anticipated; therefore, a negative declaration was prepared. The Planning Commission, on September 8, 2011, adopted a resolution recommending that the City Council adopt the view restoration ordinance and a negative declaration. A Notice of Intent to Adopt a Negative Declaration was issued on January 3, 2011, and a period for public comment on the environmental documentation ran from January 6, 2011 through January 27, 2011.

At the public hearing, the City Council will hear and consider all comments. All interested persons are invited to attend and speak on this matter. Written comments may also be submitted and should be addressed to the City Council, c/o City Clerk, 455 N. Rexford Drive, Beverly Hills, CA 90210. The comments should be received prior to the hearing date.

As of Wednesday afternoon, Ventura said the County had already received 1,074 Vote By Mail ballots for the BHUSD election.

Mayor Barry Brucker became the first successful write-in candidate in California in 15 years when he was elected to the Board of Education in 1997. The *Los Angeles Times* reported that a preliminary count of write-in votes had been conducted on the Thursday after the election.

Since Brucker's election in 1997, at least one other write-in candidate, Beverly O'Neill, has succeeded in California, when O'Neill won a third term as mayor of Long Beach in 2002. O'Neill filed as a write-in candidate because the City of Long Beach prohibits the name of anyone who has already served two terms in an office from appearing on the ballot. It does not prevent two-term officeholders from running as write-in candidates. Los Angeles County does not have such a rule.

In the 2004 San Diego mayoral race, write-in candidate Donna Frye, who received 155,851 votes, was a close second to incumbent Dick Murphy, who garnered 157,959 votes. That election was controversial because a number of write-in votes for Frye were not counted due to some voters' failure to fill in the oval next to the line on which they had written Frye's name. Frye's supporters believed there were around 4,000 intended votes for Frye that were not counted for that reason.

This past August, the California state legislature passed Assembly Bill 461, which added a section to the Elections Code stipulating that

during a recount, each ballot is to be counted if the intent of the voter can be determined, regardless of whether the voter has complied with the voting instructions. The bill, which was authored by Assembly Member Susan Bonilla (D-Concord) in response to the 2004 San Diego mayoral election, will go into effect Jan. 1, 2012.

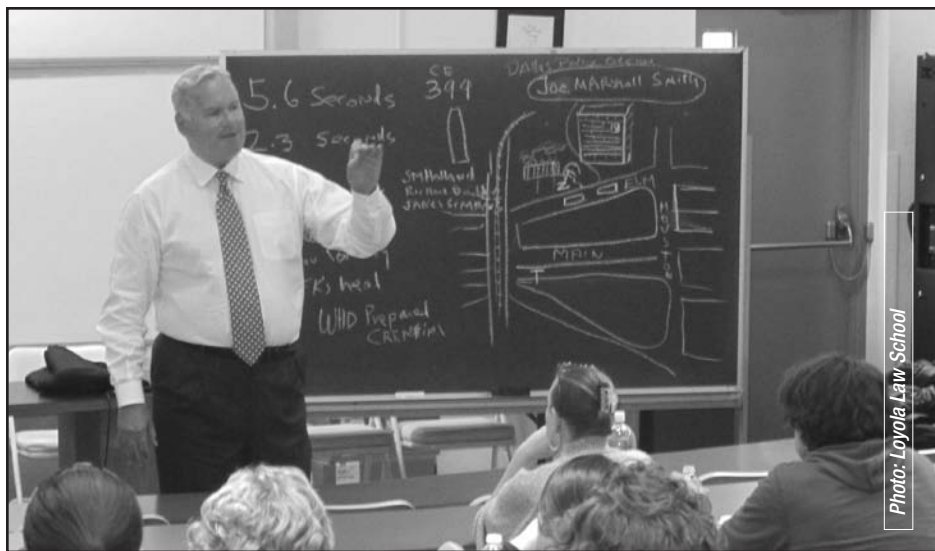

time that worked for all four candidates, Bilak reportedly e-mailed Schwartz telling him she would alert the local media and synagogues of his decision to schedule the debate on Friday evening during the Sabbath.

My choices for board and other notes

My recommendations for school board are **Lewis Hall**, **Dr. Brian David Goldberg** and the write-in candidate, **Noah Margo**.

Although two former candidates, **Damien Bean** and **Andy Licht**, have dropped out of the race, Licht's name will remain on the ballot since he withdrew after the ballots were printed.

So far, the only real excitement in this election has been the departure of the two very viable contenders and the flap caused by candidate **Frances Bilak**'s unseemly dispute with a high school student over scheduling of a candidates' forum. Even though Ms. Bilak issued a kind of apology, her handling of the issue has spiraled into the only real controversy in the election.

In case you missed all the angry emails, what happened, all on record, is that student television reporter, **Max Schwartz**, host of his own program on KBEV, had invited all the board candidates to appear on his show.

After originally accepting, Bilak dropped out, citing her religious issue with appearing on a Friday night that conflicted with her Sabbath. Unfortunately, her emails to Max were tasteless and even somewhat insulting. Many in the community labeled it "bullying" and withdrew their support, including two heavy hitters, Councilmember **Lili Bosse** and Planning Commissioner **Brian Rosenstein**. This was followed by the Beverly Hills Education Association, which also pulled its backing of Bilak.

Max did absolutely nothing wrong and has handled himself with great maturity. He is a sensitive, very talented high school senior, and the adults, including the candidate, could have learned from his behavior.

I was interviewed on his political talk show when I was chair of the Citizen's Oversight Committee, and he was very professional. His questions were on target, balanced and well prepared. Max, if he chooses, could have a career in broadcast journalism. He is certainly a credit to the student-run television station.

However, what is equally troubling is the tasteless injection of religion in the election. There were countless ways the candidate could have handled this, including checking her calendar before she accepted, but at the very least a mature sounding note of regret and dropping it would have helped. This debacle just days before the vote and as many people were mailing in their ballots, raised another problem: the risks of voting too early. Absentee voting was supposed to increase the number, but it hasn't. Instead many votes are cast before last-minute issues are discovered, as happened here. Conceivably, we could elect candidates

who have suddenly changed their position on some issue at the last minute or made some campaign goof, as did Bilak.

Back to my choices. This is not the most exciting list in our history, far from it. There are both positive and negatives attached to all of the contenders, but the district will survive, educational excellence will remain our goal and much of our future depends on the success of the management talents of our new superintendent, **Dr. Gary Woods**, the dedication of our first-rate teaching staff, parent involvement and the able, continuing school administrative team.

In most recent elections, the incumbents have been the fall guys for problems, real or perceived, on both the school board and city council, and they have not done all that well. Incumbents have lost many recent community elections.

Since board vice president Dr. Goldberg is the only current member on the ballot, with **Myra Lurie** and **Steven Fenton** opting not to seek re-election, it was reasonable to assume this election would be a referendum on both Goldberg and the whole board.

That has not exactly happened. Those who disagreed with him or the board, have not mounted any kind of negative campaign, and neither have the challengers.

I do have serious differences with Goldberg, including his handling of the opportunity permit issue. While I, and others, agreed that the opportunity permit student program should be ended, I thought it was unfair to kick out any student—they should be allowed to graduate. I continue to feel that way but Goldberg has the change in funding from state ADA to Basic Aid on his side of the ledger. Fortunately, a minor compromise did help some opportunity kids, but not all.

Goldberg should be re-elected because he brings back to the board four years of experience and a very successful reaching out to the stakeholders, parents in his own area and many in other elementary school zones. The board will miss the very different and often at odds talents of Fenton and Lurie, so if only because of continuity and history, Goldberg merits re-election. Politics and personal differences aside, and worth repeating, he has won the backing of the district's parents.

As for those who will be upset by this endorsement, your silence in this election and failure to find alternative contenders has to be noted. It is my hope that Goldberg, in his second term, will be far less contentious when he has differences with our city council and others; he could help heal community splits in and out of the schools.

Hall presents a different set of criteria for

endorsement. He has absolutely no involvement in past city and district disputes and has made a very impressive showing in reaching out to a broad cross section and very diverse set of endorsers. His newness is really an asset and his technical education skills will be a good addition to the next board. Extremely well intentioned, level headed and not easy to rattle, his kind of temperament will be a valued stabilizer on the board. He has not run any kind of political advertising campaign, and this could hurt his name recognition, but those emails and personal contacts might be sufficient in this strange election. Certainly, the Bilak meltdown helped his chances.

Which brings us to Noah Margo. On the basis of effort alone, Margo has been the real dynamo in this election. He began and continues with a challenge: His name is not on the ballot; to win he will have to convince voters to write in his name. But that worked for **Barry Brucker** when he first ran for board in 1997.

Margo is clearly both talented and well informed. He has paid his dues as a school leader, has kept his focus on education and not politics in his campaign and has across the community support. He will be an excellent board member—just too bad he didn't file earlier when he first considered running and now has to depend on a risky write-in drive. His reason: the change in the cast of candidates and withdrawals.

So, for board, three very different kinds of candidates, but because I am optimistic about their ability to forge a new era of cooperation with less acrimony and more positive approaches to colleagues and the city council: Hall, Goldberg and Margo.

SOME OTHER NOTES:

Two *Los Angeles Times* stories merit some comment. For those who take such pleasure in pointing out my frequent flubs, and they include two J's, **Josette** and **Josh**, a cursory examination of last Monday's sports section would have found some interesting conflicts.

In the "Two Minute" NFL summary, the Los Angeles Raiders loss to Kansas City was 28 to 20, and in a separate report on the same page, the score, this time accurate, was 28 to zero. As a Raider fan, I thought that if I kept searching I might find that the team **Al Davis** built might actually have won.

An omission on a story about a possible lawsuit involving an art collector and an artist, had a very strong Beverly Hills connection, but not mentioned.

The controversy was a challenge to a California law giving artists a small benefit if their works are resold for a higher price. The so-called "resale act" was indeed passed during **Jerry Brown**'s first term as governor, but the story did not mention the name of the bill's author, our own then-state legislator **Alan Sieroty**.

Of course, there is a back story. Artists in California had pushed for a way to protect their interests in their work. An artist may

have had a work sold for very little money, and then when their work became more saleable and popular, sold by a gallery or collector for a much higher price. The artists thought they too should profit from the increased value, at least for five percent.

The local artists formed their first-ever professional association to push for the law and enlisted the support of Sieroty, whose family were also major collectors.

But the gallery owners were not thrilled and hired their own lawyer to fight the artists and the Sieroty Bill, the one-time mayor of Beverly Hills, **George Slaff**.

Slaff and Sieroty were longtime friends and political allies, and their relationship did not really suffer because of their different interests. The artists also had the backing of a very important collector and art patron, Savings and Loan tycoon **Bart Lytton**. At Lytton's urging the artists retained their own PR person, even though it could conceivably cost him personally. So, in the interests of full disclosure, that inexperienced flack was me. Hey, we won.

Now, the Sieroty bill is being challenged in the courts, by some art heavyweights.

For some hard-to-explain connection or reason, the most pervasive critics of my syntax and other violations of good writing skills, and they have a good subject to attack, have mostly been lawyers and doctors, often former mayors with sharp pencils.

Dr. Charles Aronberg takes great delight in finding my usage errors as does lawyer and former mayor **Joe Tilem**. In fact, Tilem was able to identify a press release I had written, without name identification, as being by me because of a frequent usage aberration.

However, the most intense editing of my columns was by the late former mayor **Hugh Darling**, who would routinely blue pencil my mistakes and mail them to me each week. This was when I edited my own weekly newspaper.

It wasn't until I attended his funeral, that I learned from one of the eulogizers, that everyone feared and had been a target for what was a well known "blue pencil."

After receipt of a heavily corrected paper one week, I decided to write Darling. "You are a better editor, I admit, so why don't we exchange jobs. You write my column and I take over as mayor?"

His response was immediate: "My desk is cleaned out and waiting for your arrival." Fortunately for all concerned, I stayed with the paper. Darling would probably not have enjoyed the other editor's duty: Making sure we had sufficient advertising to survive and I certainly did not have the temperament needed to be a mayor, not when half the town was still Republican.

What happened to my newspaper? Sold it to Bart Lytton who then resold it to **March Schwartz**. March changed the name from *Beverly Hills Times* to *Beverly Hills Courier*, but kept most of the columns and even the offices on Wilshire Boulevard. So, in a sense you can blame me for that other paper's existence. No life is perfection.

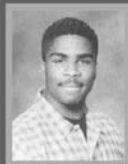

LILLIAN LEADS

Charitable Solicitations Commission Chair Lillian Raffel on her journey to elected politics in Beverly Hills

Like a lot of residents, you first got involved in the community via the schools. Tell us about that.

I was always involved from when my daughter started El Rodeo kindergarten. I really thought it was important that parents participate in their children's activities at school and be seen by the teachers and your child at school. At the time, I was [teaching nursing] at Mount St. Mary's College. I would come over on my lunch breaks or in between classes and volunteer in the classroom or on the playground. I think that's an extremely important aspect of being a parent.

How did you become involved with the El Rodeo PTA?

I became involved when my neighbor Mary Lynn Gottfried, who was treasurer, said why don't you become treasurer? I had worked in a bank and I had those kinds of skills. After that I always seemed to become treasurer of every organization I was involved with, because I have a strong math background.

I was vice president, treasurer, and auditor [for the El Rodeo PTA]. [Former El Rodeo Principal] Steve Fisher was really wonderful to work with. The vice principal at that time was Dick Douglas. He was great. The kids loved him. I just thought that they were a great staff. I worked with [former Beverly High Principal] Ben Bushman. He knew every single student's name in the entire high school. They couldn't misbehave because he would know who they were and I think that was quite remarkable. Sol Levine I thought was a wonderful superintendent. He really understood the teachers and he was a wonderful academic. I also have worked with [Beverly High Principal] Carter Paysinger. I don't think there's a more beloved person on that campus than Carter Paysinger.

How did serving on the PTA influence your decision to run for the Board of Education in 1991?

I think that when you're involved with the PTA at that level, you see how the schools operate. A couple years before I ran, there was a teachers' strike and some of the solutions that were coming up were not constructive in my opinion. I felt that I had a lot to offer. I had worked in education, I had volunteered for the PTA, and I felt I knew somewhat of the motivation of the teachers and administrators, and that I could represent the parents, the students and the taxpayers because they're all interested parties, and I think that's the balance of being on the school board. You have to balance all those interests; you can't just represent one side. So I felt that I had a lot of things to bring to the table and my friends were encouraging me to run.

With this year's Board of Education election less than two weeks away, what advice do you have for the candidates to make it through the final push of the campaign?

I think just getting out and reaching out to voters and concentrating on the people

who actually vote, the high propensity voters. Look at who votes the most consistently and get those people to go out. Go to your friends and supporters and make sure they vote. It's amazing how many people who are your supporters don't get out and vote.

Tell us what you found most challenging about serving on the school board.

The most difficult thing I felt at an emotional level was when you had to have an expulsion hearing. They were sometimes wrenching, [but] the law is the law, and you have to follow certain things when kids act poorly. It was very distressful in certain cases. You're making a decision that's going to affect this child for the rest of their life possibly. Sometimes it's for the best because the kids need this wakeup call, but most of the time it is pretty difficult.

Did you find serving on the board to be more difficult than you expected?

The board was a mix of personalities and it changed over the years I was on it. We had some challenges because we had a board member [Jo Ann Koplin] that resigned [in 1997]. That was difficult to find what to do about that.

A couple of people [on the board] wanted to fire Sol Levine. AJ Willmer and I didn't. We thought he should work until the end of his contract and that was really the big disagreement on our board. If they wanted to renew it or not, that would be the time and not fire him mid-contract. [Then in 1997] there was an election and AJ and I lost, and [Sol] was fired.

How did that make you feel?

I felt really bad for Sol. I thought he did not deserve to be treated the way he was treated and I think a lot of people feel that way, and subsequently you can see what has happened to the school district that they've had one superintendent right after the other. It's been like a revolving door. I think that's unfortunate.

How do you feel about the Board's decision to hire Superintendent Gary Woods?

I really don't know him. I can't comment one way or the other because I haven't met him. I thought Dick Douglas was a brilliant choice. I know they couldn't work the details out with him, which was unfortunate because it was nice having someone with a history of the city. Sometimes things just don't work out.

How did you become involved with the Charitable Solicitations Commission?

I told you I'm treasurer of everything. I had to deal with the Charitable Solicitations Commission because I was treasurer of several charitable organizations and I had to apply for permits. I felt that there were certain things that needed to be improved on the commission and how things were done, so when the opening came up I applied for it. I think I'm actually the only person on the commission that has any history of actually applying to the commission and having to deal with the rules and regulations.

Have you been able to make some improvements?

Yes, there were several things I wanted to change and I have done those things. [One] thing I thought we should change is originally the life of the permit was very short. It was three months. When you're operating a charity and you're preparing [for an event], you're not doing it just three months before; you're doing it over a longer period of time. I felt that permits should be longer, so we changed it to six months.

What is the Charitable Solicitations Commission?

We want to protect residents and make sure their charitable donations are used in a proper manner. We [issue] permits for people to raise money in Beverly Hills. When charities do events like a dinner dance or a carnival, people need permits. If they're going to do a mailing or a telephone solicitation, they need a permit. If it's a first time for the organization filing for a permit they have to prove that they are a charitable non-profit organization by providing a copy of their 501(c)(3) corporation papers. They fill out a form, describing what type of activity they're doing, and when it's going to take place. For a repeat application they have to provide information about how much they grossed on their prior event, how much they spent and how much they netted for the charity. They have to determine how the donations were obtained and [list] what the costs were. We require that they make at least 50 percent for the charity. Organizations that consistently make less than 50 percent [are listed] on [beverlyhills.org]. Our staff people are really good about getting people to turn in their financial statements, but if they don't, we put them on the failure to file list [online].

Tell us about your involvement with the West Hollywood/Beverly Hills Democratic Club.

I have become more and more involved with the club. I just became president in May. In August we started gearing up for our Democrat of the Year [event]. As we were doing that, we were hit with the information that the person who was our treasurer [Kinde Durkee] was arrested by the FBI, so all our funds have been frozen and we're kind of in a state right now. We're not the only one. [Sen.] Dianne Feinstein [and many others were also affected]. We haven't lost the most money, but with a little club it's significant when you lose any money; it hampers you.

How are you dealing with that?

We had the Democrat of the Year event, which raised some money, [but] we're not doing as much as we would like to do. We usually send out a mailer for our candidates that we endorse for school board. Now we're putting an ad in the newspaper, but we can't do a mailer. We're doing the best we can. [Former Mayor] Steve Webb is doing [legal] work pro bono for us, which is very nice of him. There are a lot of filings that we have to do to try to get our money out because it's frozen by the FBI. Durkee affected so many democrats that it's just really unbelievable.

What do you like about being involved with the Democratic Club?

The people are really terrific. I grew up in a house of political junkie type people, my mother in particular. I have pictures of her with Stanley Mosk, Pat Brown, Adlai Stevenson, [who] ran against Eisenhower. She was very inspiring and she felt that if you want to make things happen and change in your life, then get involved.

Tell us about your family.

My daughter [Steph Middler] is an engineering project manager for Apple in Santa Monica. She plays saxophone in a rock funk band called Super Duper. My niece [Kerstin Leavitt] works for Judie Fenton [at FTA Events].

My husband [Stuart Raffel] is in the life insurance employee benefit business. We've been married 27 years, and he's from Chicago originally. He's been very active in the community as well. He used to be president of The Maple Counseling Center. He's involved with a lot of business organizations. I'm on the board of Rotary, and I was on the Beverly Hills 9/11 Memorial Garden Committee. It was such a wonderful project and it was very rewarding to do it as well.

study session on Oct. 18.

The City Council unanimously agreed the issue was worth further study and the City Council Planning liaison was directed to study food truck peddler permit fees and taxes, enforcing the 30-minute limit that trucks are allowed to park in one location, and how to require food trucks to post their Los Angeles County Department of Health rating (A, B, or C).

Food trucks have been serving three main purposes in the City: serving construction workers, service workers and "mobile" workers in residential areas; serving customers in the City's commercial areas; and serving customers at special events like National Night Out.

"I think it's becoming very impactful to residential areas because it's essentially having a restaurant in front of your home," Bosse said in a phone interview. "We try to protect residential areas to not have business intrusion. Essentially, that's what's happening in residential areas."

Bosse also expressed concern that food trucks, when parked in commercial areas, compete with Beverly Hills' restaurants.

Bosse suggested looking into increasing the City's permit fees and tax schedule for the vendors, since currently the total annual tax revenue for 38 active and permitted food trucks operating in Beverly Hills is only about \$2,850. A first-year "peddler" permit costs \$428, and renewals are \$91 a year thereafter. The trucks must also have a Type B business license (\$75 a year), and each employee must purchase an employee ID for \$90 the first year, and \$41 for subsequent years.

According to existing code, food trucks must receive permission from residents to park in residential areas and trucks must abide by park-

ing regulations as posted. Trucks cannot park in any single location for more than 30 minutes and may not return within 500 feet of such a location within four hours.

Bosse said residents have complained that trucks have been parking in the same area for multiple hours.

The food trucks cannot be banned, but the City can regulate the time, place and manner of vending, Deputy City Attorney Lolly Enriquez said.

Vice Mayor Willie Brien agreed the issue warranted further study.

"I think it's worth more study and we should look at all the impacts of this, good and bad, because there may be reasons why these [food trucks] may be of benefit, like at construction sites with finite time periods and more specified rules," Brien said.

Planning Commission studies overnight stays at specialty medical clinics

The Planning Commission discussed on Oct. 13 the possibility of amending the City's municipal code to allow surgery centers that do not have code-compliant parking to apply for overnight stay permits. Vice Chair Craig Corman and Commissioners Noah Furie and Nanette Cole favored looking further into the issue, and Commissioner Brian Rosenstein opposed amending the municipal code. Chair Dan Yukelson did not attend the meeting.

Currently overnight stay permits, which allow up to four patients to stay overnight in any individual clinic, come with numerous conditions and restrictions limiting the time a patient can be discharged, the time surgeries can be performed, and the time deliveries, loading and other activities can occur at the clinics during

overnight hours.

Rafael Gabbai brought the issue forward because he would like to apply for an overnight stay permit for his clinic, but his building does not have code-compliant parking. Current regulations require clinics to provide adequate on-site parking according to code—one parking space for every 350 square feet of office space—in order to even submit an application for a permit to host patients overnight. Applicants that meet the minimum qualifications for permits must appear before the Planning Commission for final approval.

According to the staff report, Gabbai said his building has over 100 parking spaces to accommodate four patients and necessary staff members overnight, without impacting the surrounding neighborhood.

"We discussed it and the conclusion was that it may make sense to think about modifying the code to allow these types of situations, but there have to be safeguards put in place to make sure that in the morning the building isn't over-parked and spilling out onto residential streets," Corman said.

Corman said the Commission recommended that Gabbai apply for a zone text amendment that would relax the parking requirement in order for surgery centers without code-compliant on-site parking to apply for overnight stay permits. City staff would work with Gabbai on appropriate language for the amendment, which would require the Planning Commission's approval.

Rosenstein said he did not see any benefit to the community by relaxing the requirements for qualifying for overnight stay permits.

"Since many of these surgery centers literally back up to residential neighborhoods along Wilshire Boulevard and now Olympic Boulevard with the new surgery center opening in the old Ford dealership building, I am very concerned about impacts on the residents," Rosenstein said. "I do not see any good reason or public benefit to making it easier for surgery centers, already with far less

than code conforming parking, to qualify for these permits."

Trodd takes over as GM at Beverly Wilshire

BHHS Football Team Loses to Santa Monica

The Beverly High football team fulfilled coach Donald Paysinger's goal of continuing to learn, improve and play hard in Friday night's Ocean League game against Santa Monica at Nickoll Field, but lost 36-14, a defeat he attributed to fatigue.

The Normans had cut the Vikings' lead to 20-14 midway through the third quarter of Frank Brown's second touchdown run, but Beverly Hills (2-5, 1-1 in league play) never scored again.

Santa Monica's Sebastian LaRue returned a punt 45 yards for a touchdown early in the fourth quarter.

The Vikings (6-1, 2-0) added nine points in the final one minute, 27 seconds on Elliot Stahler's 42-yard field goal and Donovan Citrowski's 12-yard run, one play after Anthony Martinez recovered a fumble by Norman quarterback Brandon Adams.

"We just got worn down before they did," Paysinger said.

Paysinger said the fatigue was the result of what he described as not a deep team missing four starters because of injuries sustained in the 42-7 victory over Hawthorne Oct. 14 while two reserves did not play because of illness.

LaRue returned the punt for touchdown because of "a couple of missed tackles," Paysinger said.

This was the third time in four games Beverly Hills had allowed a touchdown on a kick return. The Normans allowed kickoff return touchdowns in their games against Alemany Oct. 6 and Hawthorne

Paysinger said allowing touchdowns on kick returns three times in four games is a concern.

Brown's three-yard run gave the Normans a 7-6 lead late in the first quarter, but London Lewis ran for five- and one-yard touchdowns in the second quarter to give the Vikings a 20-7 halftime lead.

The Beverly Hills offensive line "played extremely well," and its defensive line played well, said Paysinger, who also praised Brown's play.

Santa Monica was ranked ninth in the Southern Section Western Division poll entering the game and was eighth on the poll released Monday.

The Normans are scheduled to continue to Ocean League play Friday by playing host to Inglewood at 7 p.m. at Nickoll Field in their homecoming game.

Paysinger said the keys to the game are controlling the line of scrimmage and containing Sentinel quarterback Derrick Woods, who also plays wide receiver and running back.

Paysinger said he hopes that some of the injured and ill players who missed the Santa Monica game will return to face Inglewood (2-5, 1-1) to reduce the playing time of the players who replaced them.

Another way of avoiding the fatigue that played Beverly Hills against the Vikings is that its coaching staff has to "do a better job" of managing its substitutions, Paysinger said.

Paysinger said Saturday he plans to make adjustments to the punt coverage team for Friday's game and would work more on punt coverage during practice leading up to the game.

The teams have one common opponent, Santa Monica, which defeated the Sentinels, 28-15, Oct. 14.

Inglewood defeated the Normans, 28-18, last season, its third victory over Beverly Hills in five games following a 14-game losing streak from 1985 to 2005.

The website Calpreps.com projects the Sentinels will win 27-12. It had projected that Santa Monica would defeat Beverly Hills, 35-19.

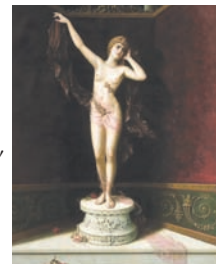

ORDINANCE NO. 11-O-2614

AN ORDINANCE OF THE CITY OF BEVERLY HILLS AMENDING THE BEVERLY HILLS MUNICIPAL CODE PROVISIONS REGARDING OIL, GAS AND OTHER HYDROCARBON DRILLING AND EXTRACTION, PROHIBITING THE DRILLING AND EXTRACTION OF OIL, GAS AND OTHER HYDROCARBON SUBSTANCES FROM SURFACE LOCATIONS IN THE CITY, AND REPEALING ORDINANCE NO. 11-O-2603

THE CITY COUNCIL OF THE CITY OF BEVERLY HILLS HEREBY ORDAINS AS FOLLOWS:

Section 1. Legislative Findings.

The City Council of the City of Beverly Hills is concerned that oil and gas drilling and production is not compatible with other land uses in the City. Such uses generate odors and noise, and reduce the value and enjoyment of nearby properties. No similar industrial activity is currently permitted within the City. Oil and gas extraction is not compatible with the residential and commercial uses allowed in the City. As such, the City Council wishes to consider a permanent prohibition on the drilling and extraction of oil, gas, and other hydrocarbon substances from drill sites that surface in the City and to require that existing uses discontinue no later than December 31, 2016.

Section 2. The City Council hereby amends subsection C of Section 10-5-301 of Article 3 of Chapter 5 of Title 10 of the Beverly Hills Municipal Code and adds a new subsection D to Section 10-5-301 of Article 3 of Chapter 5 of Title 10 to read as follows:

"C. The council hereby finds and determines that the uncontrolled drilling in the subsurface for oil, gas and other hydrocarbon substances, and the uncontrolled production thereof, would be detrimental to the general welfare of the citizens and residents of the city and detrimental to the general public peace, health, safety, comfort, convenience, and prosperity. The council finds and determines that subsurface areas within the city may be explored for oil and gas, and, if such substances are found, they may be produced by directional or slant drilling methods from surface locations outside the city. Such operations must comply with the regulations of the city or county having local control of the drill site area, as well as the limitations and regulations set forth in this article to protect the citizens and residents of the city from odors, noise, dust, and the spreading of oil, dirt, and debris upon the public streets of the city, and to protect buildings and structures from vibrations, sinking, or other damages caused by the drilling for and production of oil and gas in an unrestricted location and manner.

D. Except as otherwise provided in this Article, no person shall drill, produce, or extract oil, gas or other hydrocarbon substances from any surface location in the city."

Section 3. The City Council hereby amends in its entirety Section 10-5-302 of Article 3 of Chapter 5 of Title 10 of the Beverly Hills Municipal Code to read as follows:

"10-5-302: DRILLING AND PRODUCTION RESTRICTED:

A. No person shall drill for or produce oil, gas, or other hydrocarbon substances from any surface location within the city, including any controlled drill site, whether the subsurface operation from such well is within or outside the city except that production of oil, gas and other hydrocarbon substances may continue from controlled drill site no. 1, as defined in Section 10-5-306 B. until the date specified in Section 10-5-323 for cessation of such activity.

B. The council hereby finds and determines that it is, and it is hereby declared to be unlawful and a public nuisance for any person hereafter to erect any derrick or drilling equipment and hereafter to drill a well in order to produce oil, gas or other hydrocarbon substances from drill sites that are located in the city.

C. No person shall drill for or produce oil, gas or other hydrocarbon substances from the subsurface of the city from drill sites located outside the city, except as permitted by this article.

D. The council hereby finds and determines that it is, and it is hereby declared to be, unlawful and a public nuisance for any person hereafter to drill an oil well or produce oil, gas or other hydrocarbon substances by directional or slant drilling methods from surface locations or sites outside the city which said wells pass through or bottom in the subsurface of any property located within the city, except in the manner provided in this article.

E. No person shall drill or redrill or deepen below its present bottom any oil well for the production of or exploration for oil, gas or other hydrocarbon substances where any portion of the surface operation or the subsurface operation of such well is located within the city, except as authorized by this article."

Section 4. The City Council hereby amends in its entirety Section 10-5-306 of Article 3 of Chapter 5 of Title 10 of the Beverly Hills Municipal Code to read as follows:

"10-5-306: DRILLING AND PRODUCTION WITHIN THE CITY LIMITS:

A. The council finds and determines that the location of drill sites on real property within the city is contrary to the public health, safety, and general welfare of the citizens and inhabitants of the city. Drilling from or producing oil, gas or other hydrocarbon substances from surface locations within the city is hereby prohibited except that production of oil, gas and other hydrocarbon substances may continue from controlled drill site no. 1 until the date specified in Section 10-5-323 for cessation of such activity.

B. Controlled drill site no. 1 shall be and embrace the real property in the city of Beverly Hills, County of Los Angeles, State of California, described as follows:

That portion of Lots 843 and 844, Tract No. 7710, in the city of Beverly Hills, County of Los Angeles, State of California, as recorded in Book 83, pages 94 and 95 of Maps in the office of the Recorder of said County, described as follows: Beginning at the most southerly corner of said Lot 843; thence along the southwesterly line of said lot north 30 (30°) degrees 53'05" west 120.00 feet; thence north 59 (59°) degrees 13'04" east 233.00 feet; thence south 30 (30°) degrees 46'56" east 22.50 feet; thence north 590 13'04" east 30.50 feet; thence south 30 (30°) degrees 46'56" east 102.76 feet to a point on the northwesterly line of Olympic Boulevard, which is a curve concave to the southeast and having a radius of 593.11 feet; thence southwesterly along said curve a distance of 79.07 feet to the end of said curve; thence continuing southwesterly along said northwesterly line of Olympic Boulevard south 59 (59°) degrees 13'04" west 184.45 feet to the point of beginning."

Section 5. The City Council hereby amends subsection C of Section 10-5-316 of Article 3 of Chapter 5 of Title 10 of the Beverly Hills Municipal Code to add a new paragraph 11 to read as follows:

"11. Any and all above surface equipment and extraction activities associated with any oil and gas or oil or gas well drilled pursuant to any council permit shall be located at least five hundred (500) feet from any school or park site."

Section 6. The City Council hereby adds a new Section 10-5-323 to Article 3 of Chapter 5 of Title 10 of the Beverly Hills Municipal Code to read as follows:

"10-5-323: CESSATION OF ACTIVITY:

A. Notwithstanding the provisions of Title 10, Chapter 3, Article 41, all drilling, production, and extraction activities occurring from surface locations in the city, including controlled drill site no. 1, shall cease by December 31, 2016.

B. The city council may extend the date set forth in Subsection (A) for controlled drill site no. 1 upon application of the property owner and upon finding that an extension of time would be in the public interest."

Section 7. CEQA Findings.

The City Council hereby finds that it can be seen with certainty that there is no possibility that the adoption and implementation of this Ordinance may have a significant effect on the environment. This Ordinance does not authorize construction and, in fact, imposes greater restrictions on certain development in order to protect the public health, safety and general welfare. This Ordinance is therefore exempt from the environmental review requirements of the California Environmental Quality Act (CEQA) pursuant to Section 15061(b)(3) of Title 14 of the California Code of Regulations.

Section 8. Severability.

If any section, subsection, subdivision, sentence, clause, phrase, or portion of this Ordinance or the application thereof to any person or place, is for any reason held to be invalid or unconstitutional by the final decision of any court of competent jurisdiction, the remainder of this Ordinance shall be and remain in full force and effect.

Section 9. Repeal of Interim Ordinance.

The City Council hereby repeals Interim Ordinance No. 11-O-2603, which repeal shall become effective upon this Ordinance taking effect.

Section 10. Publication.

The City Clerk shall certify to the adoption of this Ordinance and shall cause this Ordinance and his certification, together with proof of publication, to be entered in the Book of Ordinances of the Council of this City.

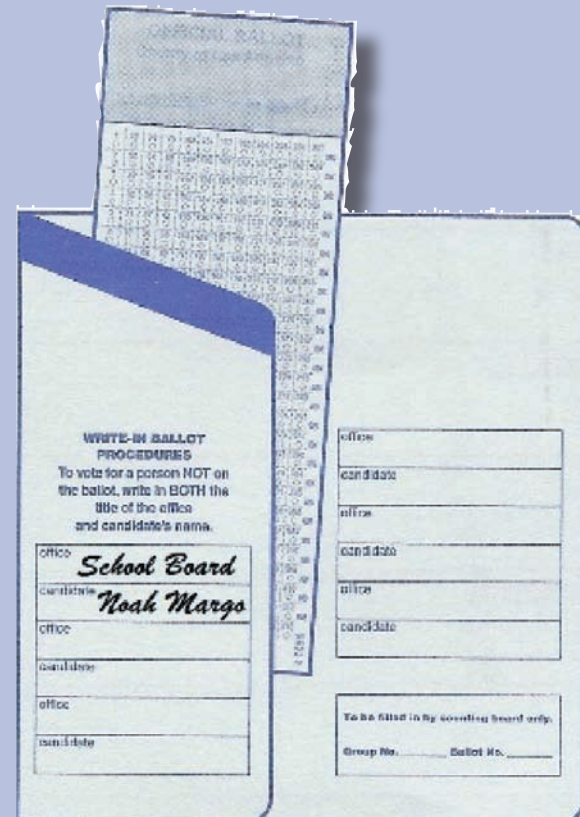
