“Rename South Santa Monica Boulevard”

I would like for the Council to accept this letter as a request to vote to restore the street name of “BURTON WAY” westerly from Rexford Drive to Moreno Drive, which is now “South” Santa Monica Boulevard, commonly known as “Little” Santa Monica Boulevard.

What you may or may not know is that the street Burton Way at one time continued from Rexford Drive to Moreno Drive through the heart of the Beverly Hills Golden Triangle, honoring Burton E. Green, the founder of our city. I did not know this until sometime ago when I noted the legal description of my property, the Barman Building at 9785 Santa Monica Boulevard which houses our tenant, La Dolce Vita restaurant.

The name “South” or “Little” Santa Monica Boulevard is confusing to customers when merchants try to explain their location. Further, the name of another city running through our Beverly Hills Golden Triangle is a wrong image - as a “Little” Venice Boulevard or any other city name would be.

The south portion of Santa Monica Boulevard is improperly named and an affront to Burton E. Green. I would like for the Council to vote to reinstate the name of Burton Way from Rexford Drive to Moreno Drive effective August 1, 2013 and approve the necessary expenses for street signage and other related costs.

Architectural Commission approves second Infiniti property, reviews new commercial building

The Architectural Commission approved a façade remodel to the Infiniti dealership proposed to be located at 9001 Olympic Boulevard at the meeting on April 17.

This location is one of four proposed sites within the City of Beverly Hills. The commission approved the façade remodel for the location at 8825 Wilshire Boulevard at the commission's March meeting. The Wilshire Boulevard location will contain the sales operations for Infiniti. The 9001 Olympic Boulevard location will be utilized for vehicle sales and preparation, and utilized as the official drop off and pick up location for services.

"We approved the building and we asked that the signage and the landscaping come back and that will be handled in subcommittee," said Architectural Commission Chair Zale Richard Rubins.

Additional properties at 9000 and 9031 Olympic Boulevard will be used for vehicle servicing.

A porter would take patrons' vehicles from 9001 to 9031 Olympic Boulevard. The 9000 Olympic Boulevard location would be used for vehicle preparation and washing, associated with sales from the Wilshire Boulevard location.

The commission also reviewed a proposed three-story commercial building at 301 North Rodeo Drive.

Burberry intends to demolish the existing building and replace it with a building with rooftop uses.

"We were very happy with it. We asked for some modifications: a little more modulation in the façade of the building," said Rubins.

Rubins said the commission asked for modulation on the surface in the building so that it would not be flat. Burberry will return to the commission with a new presentation.

The project also requires a Development Plan Review Permit for the construction of a new commercial building and the applicant has requested to participate in the City's In-Lieu Parking Program, according to the staff report. The project will go before the Planning Commission.

Gap, located at 370 North Beverly Drive, had been previously approved by the commission for a façade remodel. They went before the commission because they decided to change the color of the building from all blue to all white building.

The commission approved a façade remodel for Lucky Brand Jeans, which will be located at 370 North Beverly Drive. The commission asked the applicants to bring the signage back because the applicants proposed using neon in their sign.

"We're handling that in subcommittee also," said Rubins. "We want to make sure that it fits the streetscape."

Neon signs are approved by special appli-

BHUSD legal fees top \$400k in three months

The Beverly Hills Unified School District paid over \$400,000 to law firms in the first quarter of 2013, according to records released by BHUSD.

The five law firms that billed the BHUSD for this time period include Loya, Ruud & Romo, Best, Best & Krieger, Quinn Emanuel, Hill, Farrer & Burrill, and Washington, D.C.-based Venable.

Hill, Farrer & Burrill represents the district in the CEQA case against Metro. Venable represents the district in the NEPA case against the Federal Transit Administration. Venable also lobbies for the district.

The fees paid to Best, Best & Krieger are related to special education, human resources, personnel and policy review. The fees paid to Quinn Emanuel were related to Karen Christiansen's case who is appealing her criminal conviction. The BHUSD must send a representative to her hearings.

The fees paid to Venable are related to the NEPA case filed in November. In January, \$74,154 were paid to Venable from the Measure E fund. Board of Education President Jake Manaster said these fees were related to the briefing and filing of the administrative record. Manaster said the administrative record was approximately 26,000 pages long.

The largest payment to a law firm in a single month went to Hill, Farrer & Burrill in the month of January for \$148,281. Manaster said he believed most of that money was paid to Leighton Engineering, consultants hired by the district to complete geotechnical stud-

tion, according to Rubins. The commission also approved revision to a business sign for Tory Burch and façade remodels for Wine Shop, Breguet and Sarah Pacini.

Bomb scare closes Canon Drive for two hours

Just before 11 a.m. on Friday morning, the BHPD received a call about an alleged bomb at the Rite Aid located at 300 North Canon Drive, said police.

Store management and Beverly Hills police evacuated the store as well as neighboring stores. BHPD contained the area and conducted the search of the store.

"Nothing was found to be out of the ordinary -- no suspicious packages," said BHPD Sgt. Renato Moreno.

The store reopened the same day after about two hours of being closed.

Bomb threats have been reported in multiple locations around the country following two successive explosions at the Boston Marathon.

"From various news outlets, I guess this is something that's been happening for the last couple of days," said Moreno.

On Tuesday, Santa Monica College's campus was evacuated at approximately 12:30 p.m. in response to a bomb threat. The campus was cleared by 1:30 p.m.

Moreno said the BHPD's main focus was to ensure the community that it was still

ies at the high school. The firm is paid through Hill, Farrer & Burrill to keep records confidential under attorney-client privilege.

On March 20, Hill, Farrer & Burrill sent a letter to Metro's counsel asking them to withdraw approval of phases II and III of the Westside Subway Extension. The letter followed a letter from the California Geologic Survey, dated March 15, confirming the district's claims that there are no faults located beneath the high school. The letter from CGS clears the campus for construction related to the Measure E bond.

Manaster said the consultants were handling requests from CGS in January and February in anticipation of the letter sent by CGS. Manaster said there has not

been any more significant engineering work since that time.

The BHUSD and its legal team intend to submit the results from the geotechnical studies into the administrative record, which could be met with a fight by Metro's counsel. If Metro will not allow the results to be inserted in the record, it is possible BHUSD's legal team will need to argue that in a separate hearing.

"The information behind the scenes of the CGS letter is significant and substantive and important to be part of the CEQA and NEPA cases," said Manaster.

Manaster said the district did pay Hill, Farrer & Burrill money in March, but believes the firm has not yet billed the district for that work.

"We want to instill the sense in our community that it's still safe, but we want them to be vigilant as everyone has been urged to do," said Renato.

The area was reopened around 12:55 p.m. Detectives were unaware of where the call came from, but were investigating.

BHPD asks community to help identify attempted murder suspect

BHPD is searching for a middle eastern or white male with a thin build in his mid-30's in connection to a road rage attempted murder on April 3. The suspect is described as having dark hair and dark eyes.

On April 3, a driver of a possible 2008 white BMW 328i was involved in an incident involving a bicyclist. The bicyclist punched the driver in the face leading the driver to threaten to kill the cyclist. The driver followed the cyclist into an alley in the 9000 block of Wilshire Boulevard between Wetherly and Almont Drives, according to a media release.

BHPD has secured surveillance footage in which a vehicle rams the bicyclist into a metal rolling trash bin. The victim did not sustain life-threatening injuries.

BHEF fundraiser at 13 percent participation; credits lack of clarity

Beverly Hills Education Foundation Executive Director Matt Zarcufsky said BHEF has raised about \$355,000 from 435 gifts including 20 from the greater community and 415 out of 3,200 – or thirteen percent – of BHUSD families.

Board of Education member Lewis Hall asked Zarcufsky how he felt they could work to increase participation.

"What I've heard in conversations, in going to PTA meetings and individual conversations is that there's still a lack of clarity as to the challenges facing the district beyond the sheer monetary issues," said Zarcufsky.

Zarcufsky said that when the BHEF launched the One campaign, the campaign

was to restore positions and began when certain layoff notices had been given out. The community knew specifically what would be cut, he said.

"The feeling has been that this is a little more vague," said Zarcufsky, who said parents are unclear how the budget affects their child directly and may be under the impression that the crisis is not as severe.

The BHEF launched a campaign asking each family to pay \$1,000 per year per student in the district to help fill the \$3.5 million budget deficit facing the district in the next few years. The first phase of the community campaign began in March.

Zarcufsky said the education foundation intends to begin phase two of the campaign in May. The City of Beverly Hills will match donations dollar for dollar up to \$600,000 in the current campaign, which would constitute a total of \$1.2 million. The City agreed to do this as part of a one-time agreement negotiated between Councilmember Willie Brien and Councilmember Julian Gold and Board of Education President Jake Manaster and Vice President Noah Margo that allowed the City to use part of its \$10 million surplus to help the school district out of a budget crisis for the current year.

Board member Lisa Korbatov asked Zarcufsky if doing a budget drill – a drill where certain programs/services would be so students could experience what future years may be like – would be impactful or gimmicky. Zarcufsky said it would depend on the execution.

Board member Brian Goldberg said it

was a shame that only 13 percent of families had participated and Manaster called the percentage "deplorable."

Goldberg used the discussion to voice his support for a parcel tax.

Manaster said a great education costs money.

Zarcufsky also said that the BHEF had raised approximately \$420,000 as of April 15 in their 2012 to 2013 campaign.

"I'm happy to report that we are on track to receive \$100,000 in corporate sponsorships this year," said Zarcufsky.

Zarcufsky said the foundation was going to receive a grant from the Ella Fitzgerald Charitable Foundation, which will be brought before the board for future approval.

Beverly High ranked in top high schools in state

Beverly High is ranked the 85th best high school in California and number 443 in the country, the *U.S. News and World Report* announced Tuesday.

The *U.S. News and World Report* evaluated more than 21,000 public high schools in 49 states. Beverly High was awarded a gold medal. Schools were awarded gold, silver or bronze medals based on state proficiency standards and how well they prepare students for college.

Superintendent Gary Woods said Beverly High ranked 85 in 600 public schools analyzed at the state level and 443 of about 21,000 schools in the country.

"We are very excited that we are back on the board with *U.S. News and World*

BHUSD Citizen's Oversight Committee Chair Woody Clark spoke before the Board of Education on Tuesday night recommending the district honor in some way people who have been "important to this community."

Clark suggested a plaque for commemorating late COC member Les Bell, an attorney who passed away on April 8.

"Les was an inspiration to the COC," said Clark. "He actually demanded our attention and our goals and our insights and he actually challenged us in so many ways."

Clark said he believed it would be a tribute to Les as well as an honor for the community. Clark said he hoped the district could plan for a memorial at a future date.

"[Bell] was so engaged with what was going on regarding Measure E funds and how we need to pay attention to both its use and what it's focused for," said Clark.

Clark said Bell was very concerned with paying attention to using Measure E funds to protect the health, security and safety of the children.

Clark said he knew the district took this into account with regards to the fight against Metro, but said Bell was concerned about incidents such as the tragic shooting at Sandy Hook Elementary School in Connecticut.

Bell's son Greg Bell attended the Board of Education meeting and spoke briefly before the board. Greg Bell said the family would be interested in being involved in a memorial.

Clark closed his public comment asking for the Board's support to appoint new members to the COC.

"If it can happen sooner than later, I

think it's to all of our advantages and a tribute to the passing of Les, as well," said Clark.

Board sets National PTA Teacher Appreciation Week

The Board of Education presented BHEA President Stewart Horowitz with a resolution thanking educators in the district for their hard work. The resolution also proclaimed May 6 through May 10 as Teacher Appreciation Week.

"Thank you very much. On behalf of all Beverly Hills certificated staff, which includes teachers, counselors, librarians, it's very much appreciated," said Horowitz. "Of course with the PTSA, every week is national appreciation week. They do so much for us, and it's my honor to accept this on behalf of all my colleagues."

Board approves resolution regarding layoffs of classified personnel

The Board of Education unanimously approved a resolution regarding layoffs of classified personnel as part of a fiscal stabilization plan on Tuesday night.

Reductions were made to the Adult ESL and Maintenance programs. One full-time maintenance II worker position, one part-time adult-education specialist, and a 19.5 hour part time instructional assistant position will be eliminated resulting in a cost savings of approximately \$115,000, according to the staff report.

Beverly Hill man sentenced to a year in jail for tax fraud

Beverly Hills resident John Trunzo, 60, a tax return preparer was sentenced to 12 month and 1 day imprisonment, 12

months supervised release and \$67,231 in restitution for filing a false federal income tax returns for himself with the Internal Revenue Service.

According to the sentencing papers, Trunzo said he filed false returns and sent fraudu-

lent receipts to the IRS on behalf of his clients in orders to move from Hollywood to Beverly Hills, so his son could attend BHUSD.

On September 10, 2012, Trunzo, a resident of Beverly Hills, 60, plead guilty to one count of filing a false federal income tax return Form 1040 for the 2007 tax year with the IRS.

According to the plea agreement, he chose to file false returns for three consecutive years, 2005, 2006, and 2007, omitting \$99,505 in income from his tax preparation business on his 2007 federal income tax return. As a result, he failed to pay a cumulative total of \$67,231 in taxes.

In addition to knowingly and willfully filing false returns for himself, Trunzo, attempted to obstruct and impede the due administration of the internal revenue laws by, during audits, sending the IRS his own receipts to substantiate improperly-claimed deductions on returns he prepared for his clients.

District finds trouble filling a communications manager role

The Board of Education previously authorized a request for proposal to try to fill a communications manager position at the district, but the district has not yet heard a response.

On Feb. 12, the Board of Education voted 3-1-1 with Board member Lisa Korbatov dissenting and Brian Goldberg abstaining to move forward with a communications manager that would be in charge of handling public relations for the district. According to the staff report from the February meeting, district staff anticipated the services could cost as much as \$50,000, to be split evenly between the BHEF and BHUSD -- the cost to the dis-

Batra ran the 800 anchor leg on the 1,600 sprint medley relay team that won in a school-record time of 3:29.79, the fourth fastest outdoor time in the nation this year, according to Langer and Track & Field News.

Raehan Poonja, Lucas Brito and Alex Rohani ran the first three legs.

The same quartet had the previous record, 3:29.88, set April 6 at the Arcadia Invitational.

Rohani won the seeded 400 in 48.09.

The Normans defeated Santa Monica and Morningside in an Ocean League tri-meet at Morningside last Thursday.

Rohani won the 100 in 10.88 and 200 in 22.02; Batra the 800 in 2:00.97; Brito the long jump, leaping 18 feet, nine inches; Eli Flesch the 3,200 in 10:00 and Dominic Perlman the 400 in 53.98.

Norman Freshman Sets School Pole Vault Record

Beverly High freshman Amanda Block broke her own school record in the pole vault, clearing 10 feet, 3 inches, to win in the frosh/soph portion of the South Bay Championships Friday night at West Torrance High School.

The previous record was 9 feet, 6 inches, set March 16 in the Redondo/Nike Track and Field Festival at Redondo Union High School. This was the third time this year Block has set the record. She also tied it once.

The Norman girls' varsity team finished second behind Santa Monica and topped Morningside in a tri-meet at Morningside last Thursday.

Beverly Hills goaltender Inbar Avrahami made 19 saves.

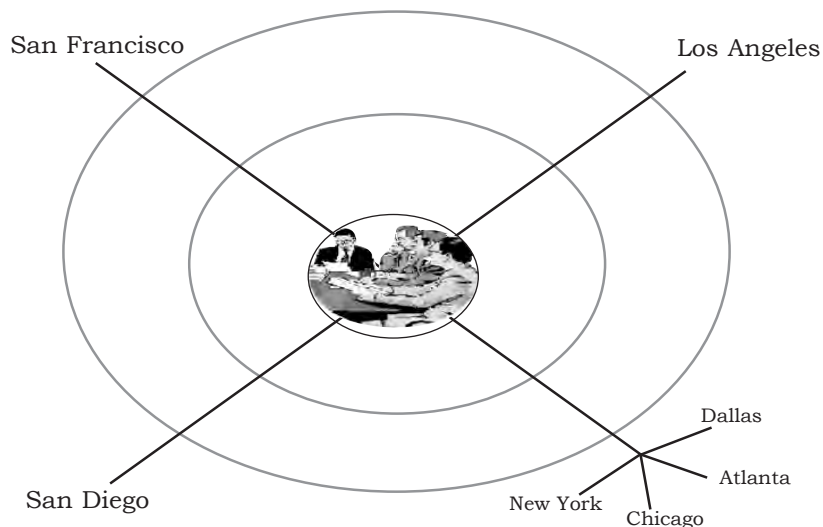

AN APPLE FOR THE TEACHER

A look at this year's BHEF Apple Award recipients

CHRISTY FUHRER

**Horace Mann: First grade teacher
1996-present**

For Christy Fuhrer, joining the staff at Horace Mann "feels like it was yesterday."

Fuhrer, whose 17 year teaching career has been with Horace Mann, has raised \$16,000 for Autism Speaks, a nonprofit organization that advocates autism awareness and \$12,000 for Life Rolls On, an organization for paraplegics and quadriplegics as Horace Mann service learning chair.

Fuhrer said she enjoyed that position because she was able to engage with the entire school. Though Fuhrer is no longer service learning chair, she will be heading Horace Mann's involvement in Relay for Life on May 4.

Though Fuhrer organized assemblies and coordinated fundraisers, she credited the success to the support of the staff at Horace Mann.

"It's the teachers who always show up. We always have the strongest presence at the Relay for Life and I think it's because we all like each other and see the value in helping others and like our jobs and want to be around the kids," said Fuhrer.

Relay for Life, an annual 24-hour event that raises money for the American Cancer Society, will be at El Rodeo School beginning at 9 a.m. on May 4. Fuhrer is breast cancer survivor who was diagnosed in 2001, her fifth year teaching.

"I think it was my fifth year [at the district] and you know that's another thing, the support I got was just incredible -- not just from the staff but from the community," she said.

She fondly recalls parents bringing her meals to ensure she was eating. She also recalled returning to work following her battle with cancer, her hair short due to chemotherapy. One of her first grade students, Sami Siegel, currently in college, cut her hair so Fuhrer would not be the only person with short hair.

"I really think it takes a special community to be so supportive as this place was," Fuhrer said. "I'll never forget it. That's how this community is."

Fuhrer was hired at Horace Mann when Dr. Fields was principal. She has taught Kindergarten, first and fourth grade.

Further emphasizing that Horace Mann is a family, she said that since-retired teachers Cheryl Zinman, Susie Sadlier, and Tina Dagodag were her mentors in her first year of teaching.

"The knowledge that they would share with me was just so helpful and they just took me on as part of their team from day one and just embraced the fact that I was a new teacher, but even though I was a new teacher, I still felt comfortable to be able to share my ideas and they were respectful and they would take on some of the things that I'd bring up," said Fuhrer.

Christian Fuhrer, her husband, is the assistant principal at Hawthorne School. Though many assume they met at the district, they met in Huntington Beach when Christian was a lead singer of a punk band. He later became a teacher.

Christy Fuhrer, who had graduated pre-law from the University of California Santa Barbara, said both of her parents were educators, who frequently suggested she go into teaching.

"I didn't want to admit it but they were probably right. I would enjoy teaching and so I went and got my teaching credential," said Fuhrer. "They were right. I love it."

ANDI BARRON & CINDY REITZENSTEIN

**Beverly Vista: Office Assistant and Office Manager
2001-present, 1998-present, respectively.**

For the first time, two classified employees are being honored for an apple award in the same year. Why? They're best friends.

"El Rodeo is so sweet. They made this congratulatory Apple Ball Award CD for us," said Cindy Reitzenstein. "Congratulations Cindy and Andi for getting the Apple, but really you're just a pear. Isn't that cute?"

**Beverly High: English teacher
2004-present**

For English teacher Minna Kim, her favorite thing about teaching is being part of her students' "discovery."

"Whether it's about the subject of literature -- like when they first like a poem and they've never liked poems before and they look at a piece of literature or poetry and say, 'That's so cool' or 'I never knew that was in there' or even better, when they say that about themselves -- 'I couldn't believe I did that' or 'I didn't know I was capable of writing a 10-page paper,'" said Kim. "It's really cool to be a part of that."

She's been a teacher since 1998, when she graduated college. Kim has worked in LAUSD inner city schools as well as in Irvine.

Kim graduated from UC Berkeley with a degree in Political Science. The fall of her senior year at UC Berkeley, Kim worked as an investigator for the Equal Employment Opportunity Commission where she learned the difference she could make as a teacher. She attended graduate school at UC Irvine where she received a Master's Degree in English and Comparative Literature.

After graduating, Kim returned to the Los Angeles area and was interested in working at a district with high parent involvement.

When Kim started teaching at Beverly High, she recalled Chief Academic Officer Jen Tedford as then English-department chair calling her level of excellence "inspiring."

Kim said Steve Rubinstein shows the teachers how to use technology to be better teachers. She mentioned current department chair Barbara Bader, and past department chair Krisha Deaver.

"They all sacrifice their lives when they take on that position to keep that department running. I feel like I should mention everybody's name because everybody at some point has volunteered their time to help the new teacher or each other," said Kim.

Kim grew up in Torrance and remembers playing basketball in the Beverly High swim gym. "I can't express enough how lucky I feel everyday when I think about my students," said Kim.

**Hawthorne: Fourth grade teacher
1996-present**

When Hawthorne Principal Kathy Schaeffer told Ellen Poltorak she was an Apple Award honoree, she cried tears of joy.

"I'm just so honored to be chosen," said Poltorak.

A Boston native, Poltorak received her master's in elementary education from Wheelock College and taught at LAUSD for a year before joining the Hawthorne faculty.

"I knew that I wanted to teach in a district where the parents were very involved and invested in their children's education," said Poltorak.

She taught first grade at Hawthorne for four years and Kindergarten for eight years. For the last five years, she's taught fourth grade.

Poltorak said then-Hawthorne principal Dick Douglas and assistant principal Rochelle Ginsburg were very influential in her teaching career, as well as veteran teachers including Anita Naiman, Barbara Brilliant, Stephanie Lehrer, Patti Thomas, and Linda DiNoble.

"I think that because they're all intelligent and professional and so good at what they do, they inspire me to be my best," said Poltorak.

Poltorak said her graduate program at Wheelock was a very influential and transformative experience.

"Those teachers taught me to continually renew my teaching practice to always be asking questions of how can I do this better?" said Poltorak.

When asked her favorite part about teaching, she said the amazing children.

"I just think each child is so special and such an individual. I love the challenge of figuring out what each child needs and how I can meet those needs and how to move them from where they are to their own next step," said Poltorak.

Having attended undergrad at UMASS Amherst, she ran the Boston Marathon and moved to Los Angeles where she could go running year round. Poltorak has one daughter, Jordan, who is currently a third grader at Hawthorne School.

BILL BRADBURY
Beverly High Band director
1995 - present

Bill Bradbury rang in 2013 with the Beverly High Marching Band in London, who performed in the London's New Year's Day Parade for the first time.

When asked if that was a highlight of his teaching career, he said "definitely."

Bradbury said he is grateful to work with colleagues in the performing arts department such as Herb Hall and Joel Pressman calling them excellent artists who "strive to work with the kids at the highest level possible."

He said he was appreciative of the administration including Beverly High Principal Carter Paysinger, Assistant Principal Toni Staser, and Chief Academic Officer Jennifer Tedford, but said that all the faculty members make working at Beverly High great.

"I like the faculty members. People enjoy working together," said Bradbury. "It's a positive environment. I also enjoy the students at Beverly High."

When asked what he found most rewarding in being in the band director, he said when the students give a fine performance or when they grasp a new concept.

"To guide [the students] and the focus that it takes to improve and then when you are able to witness them really grasping the concepts and in a certain way having accomplished that and [they] are able to move on to bigger things -- that's one of the greater pleasures I enjoy," said Bradbury.

In recent years, the band began playing at football halftime shows. Bradbury said students are able to applaud their peers in the band.

"It's been enjoyable to work with older students here in the most recent years, just to see students excel in their music, understanding and performance and to see them excelling at that level and play more interesting compositions and music," said Bradbury.

The Beverly High Band played a flash mob at Two Rodeo on April 19 and the jazz band will be opening a free community concert at the civic center on May 5.

"It's exciting to be recognized for investing the time and effort to do my craft well," said Bradbury.

ALYSSA PARA
El Rodeo, physical education
2005-present

For El Rodeo teacher Alyssa Para, the best thing about being a physical education teacher is being able to watch the students grow up.

"I really love everything about El Rodeo," said Para. "Being a P.E. specialist, I have them from Kindergarten to eighth grade with my co-teacher Bill Smith."

When Para joined the BHUSD, she was hired by then-Principal Pat Escalante. Influential colleagues include her co-teacher Bill Smith, Beverly Vista Assistant Principal Richard Waters, Tracy McGregor,

and Beverly Vista P.E. teacher Todd Radonsky.

Alyssa Para has been the physical education teacher at El Rodeo for the past seven years. She was also the pole vault coach at Beverly High for four years.

"I was very surprised [to receive this honor] and actually, I had asked my principal and assistant principal if I had gotten it in error," said Para, who found out via e-mail from the Beverly Hills Education Foundation before speaking to El Rodeo administration.

Para said she was touched and honored to receive the Apple Award. Para said she felt lucky to work with the faculty, the students and the parents.



EFUA PAUL
Beverly Vista: School Psychologist
2001-present

After five years as a social worker, Beverly Vista School Psychologist Efua Paul decided to go back to school for a degree in school psychology.

"When I was a social worker, I worked in social service agencies and hospitals, and so I felt like I was helping a little bit, but it wasn't always getting at the core of helping people change," said Paul, who worked with both children and adults as a social worker.

Paul said she felt that schools were where she could make the most impact on people's lives, especially when working with children.

"A lot of times as a social worker, what I saw was adults struggling [from] things that had started when they were kids or families struggling and affecting the kids in the family," said Paul.

She graduated from Cal State Los Angeles with a school psychology degree. In her final year, she interned for a year with LAUSD.

"I had that experience my first year before I graduated and saw how a larger district ran and saw how hard it was to get things done. It was just more of a process," said Paul. "When I was graduating, I knew I wanted to be in a smaller place."

Paul was the school psychologist El Rodeo for her first seven years. When she was hired, Steve Fisher was the El Rodeo principal who Paul described as extremely welcoming. Paul also noted Nancy Wolfe, Toni Staser, Susie Curtis, Karen Garland and Gene Michelman as helpful colleagues when she began working at the district. Paul has worked at Beverly Vista for the last five years.

Paul is from Boston and prior to receiving her degree in school psychology, she completed her masters in social work from Boston College.

"There are a lot of different aspects to being a school psychologist. Some of it is attending meetings, doing assessments and writing reports," said Paul. "But I would have to say that just daily, my contact with kids and being able to help them be successful in school and overcome all the challenges that are part of school life and seeing those positive changes is really what I find most rewarding."

Paul said she was surprised when Beverly Vista Principal Marty Powers and Assistant Principal Richard Waters told her she was being honored. Paul said because the Apple Award usually goes to teachers, she had not considered the possibility of receiving the honor.

"It felt really special because I'm not in a classroom and I don't work with a large group of students, so to have recognition in spite of that is just a great feeling," said Paul.

Paul works with the preschool aged students up to the eighth graders.



CARTER PAYSINGER
Beverly High Principal
Administrator Award

Beverly High Principal Carter Paysinger was honored as an Apple Award recipient in 2002 as a teacher. Eleven years later, he's being honored as an administrator.

"To be recognized now as an administrator is really humbling to me because we have so many great administrators in our district and to be recognized in this way is really unbelievable for me," said Paysinger.

Paysinger was previously Beverly High athletic director, which he said was similar to being the principal. He said as principal, he is able to be "involved in all facets of the school and [get] a chance to know faculty members and students in other areas a lot better than [he] had in the past."

"I have such a defined vision of where we're going in terms of being one of the best high schools in the country and its just exciting everyday to come to work and work towards that goal," said Paysinger.

Paysinger started coaching at Beverly High in 1979 and has a long history with the BHUSD. This is his third year as Beverly High principal.

Paysinger was honored by the Beverly Hills Athletic Alumni Association with the McCarthy Lifetime Achievement Award in 2009. He was previously interviewed in *Weekly* issue #523, which can be read at bhweekly.com.



MICHAEL LIBOW
BHEF Community Honoree

Though Beverly Hills resident and prominent realtor Michael Libow attended Beverly Hills schools, he said his attachment to the schools comes from being a part of the community.

"I'm a product of the system. I do believe in supporting it and I do feel that it needs support. A lot of things are privately funded and it helps," said Libow.

The CITY's decision will be based on objective evaluation criteria.

The CITY reserves the right to adjust, increase, limit, suspend or rescind the prequalification rating based on subsequently learned information. Contractors whose rating changes sufficiently to disqualify them will be notified, and given an opportunity for a hearing consistent with the hearing procedures described below for appealing a prequalification rating.

While it is the intent of the prequalification questionnaire and documents required therewith to assist the CITY in determining bidder responsibility prior to bid and to aid the CITY in selecting the lowest responsible bidder, neither the fact of prequalification, nor any prequalification rating, will preclude the CITY from a post-bid consideration and determination of whether a bidder has the quality, fitness, capacity and experience to satisfactorily perform the proposed work, and has demonstrated the requisite trustworthiness.

The prequalification packages should be submitted under seal to the **Office of the City Clerk, City of Beverly Hills, 455 North Rexford Drive, Room 290, Beverly Hills, CA 90210**. The following should be clearly marked on the outside of the package "**CONFIDENTIAL PREQUALIFICATION STATEMENT FOR THE GREYSTONE FIREHOUSE RESTROOM PROJECT**".

The prequalification packages submitted by Contractors are not public records and are not open to public inspection. All information provided

will be kept confidential to the extent permitted by law. However, the contents may be disclosed to third parties for purpose of verification, or investigation of substantial allegations, or in an appeal hearing. State law requires that the names of contractors applying for prequalification status shall be public records subject to disclosure, and the first page of the questionnaire will be used for that purpose.

Each questionnaire must be signed under penalty of perjury in the manner designated at the end of the form, by an individual who has the legal authority to bind the Contractor on whose behalf that person is signing. If any information provided by a Contractor becomes inaccurate, the Contractor must immediately notify the CITY and provide updated accurate information in writing, under penalty of perjury.

The CITY reserves the right to waive minor irregularities and omissions in the information contained in the prequalification application submitted, and to make all final determinations. The CITY may also determine at any time that the prequalification process will be suspended for the Project and the Project will be bid without prequalification.

Contractors may submit prequalification packages during regular working hours on any day that the offices of the CITY are open. Contractors who submit a complete prequalification package will be notified of their qualification status no later than ten business days after submission of the information.

The CITY may refuse to grant prequalification where the requested information and materials are not provided by the due date indicated above. There is no appeal from a refusal for an incomplete or late application, but re-application for a later project is permitted. Neither the closing time for submitting prequalification packages for this Project will be changed in order to accommodate supplementation of incomplete submissions, or late submissions, unless requested by the CITY in its sole discretion.

In addition to a contractor's failure to be pre-qualified pursuant to the scoring system set forth in the prequalification package, a contractor may be found not prequalified for either omission of or falsification of, any requested information.

Where a timely and completed application results in a rating below that necessary to pre-qualify, an appeal can be made by the unsuccessful Contractor. An appeal is begun by the Contractor delivering notice to the CITY of its appeal of the decision with respect to its prequalification rating, no later than two business days following notification that it is not pre-qualified. The notice of appeal shall include an address where the Contractor wishes to receive notice of the appeal hearing. Without a timely appeal, the Contractor waives any and all rights to challenge the decision of the CITY, whether by administrative process, judicial process or any other legal process or proceeding.

If the Contractor gives the required notice of appeal, a hearing shall be conducted no earlier than five business days after the CITY's receipt of the notice of appeal and not later than five business days prior to the date of the Notice Inviting Bids for this Project. Prior to the hearing, the Contractor shall, in writing, be advised of the basis for the City's pre-qualification determination.

The hearing shall be conducted by a panel consisting of three members of the Department of Public Works & Transportation senior management staff (the "Appeals Panel"). The Appeals Panel shall consider any evidence presented by the Contractor, whether or not the evidence is presented in compliance with formal rules of evidence. The Contractor will be given the opportunity to present evidence, information and arguments as to why the Contractor believes it should be pre-qualified. Within one day after the conclusion of the hearing, the Appeals Panel will render a written determination as to whether the Contractor is pre-qualified. It is the intention of the CITY that the date for the submission and opening of bids will not be delayed or postponed to allow for completion of an appeal process.
