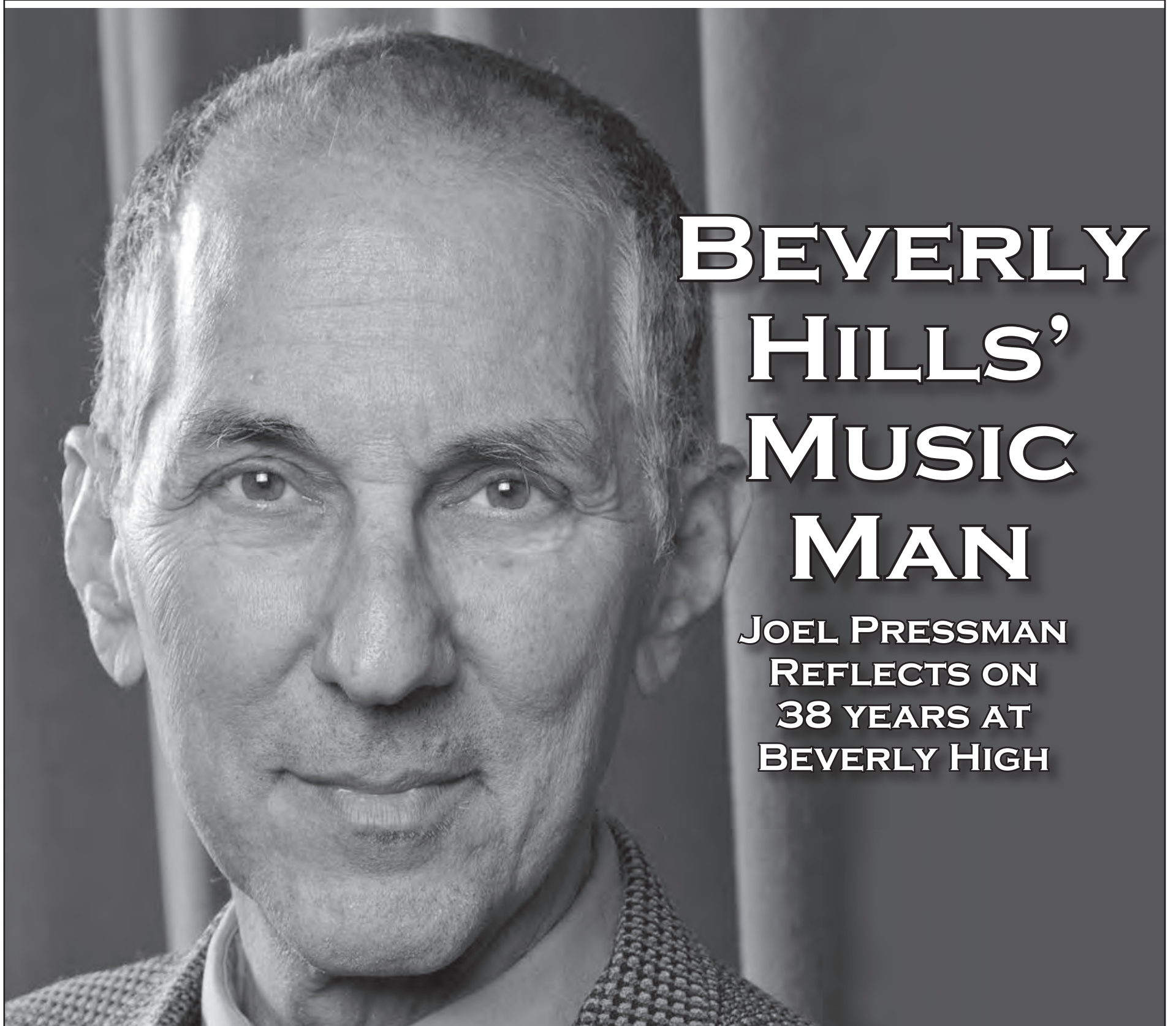

## Christiansen charges dismissed; will the BHUSD have to repay the \$6.6 million settlement?

*Updated from Friday's e-blast.*

Following former BHUSD Facilities Director Karen Christiansen's conviction in November 2011, the BHUSD received an equivalent of a \$6.6 million settlement from with Johnson Controls ["JCI"], one of the vendors with which Christiansen negotiated an agreement, allegedly amounting to a conflict of interest.

A California Appellate Court dismissed all charges against former BHUSD Facilities Director Karen Christiansen on Friday.

But attorney Mitchell Dawson said it is unlikely Johnson Controls would be successful in collecting those monies paid pursuant to the settlement agreement. Dawson said settlements usually include finality.

"I'm not privy to the settlement agreement, which is controlling," said Dawson. "Almost always settlement agreements either include or waive all contingencies. Rarely, but sometimes, fraudulent representations in entering

in the agreement could serve to vacate the agreement -- not likely here in this instance."

Dawson said Johnson Controls was presumably aware of an appeal or the right to appeal by Christiansen and unless the agreement specifically spoke to that issue, the agreement would likely stand.

"Most settlements are entered into to finalize all potential liability and eliminate the unknown," said Dawson.

Steve Madison and Michael Lifrak, attorneys from Quinn Emanuel Urquhart & Sullivan, who represents the BHUSD in the JCI case, did not return calls.

Board of Education President Jake Manaster said the court decision had nothing to do with the JCI settlement and the two were unrelated.

Christiansen had previously been found guilty of four felony counts of conflicts of interest.

"Because Christiansen was not a member, officer, or employee of the relevant public body, section 1090 does not apply to her," said the court opinion. "We therefore reverse her convictions, vacate her sentence and the restitution award, and direct the superior court to dismiss all charges against her."

The district was going to receive \$3.5 million in restitution from Christiansen's prior conviction, but she will no longer have to pay those fees.

She had previously been found in violation of Government Code 1090, which generally prohibits public officials from being financially interested in contracts they make in their official capacity.

"We are disappointed in the decision," said Deputy District Attorney Max Huntsman.

Huntsman said he believed a prior appellate court had made the right decision in convicting Christiansen on the basis that she had been in a position of public trust as opposed to the latest decision, which considered whether or not she had been an employee, as defined by the IRS.

Eric Reynolds, who represents the attorney general’s office, said they were reviewing the court’s decision and have not yet made a determination on whether or not they would appeal to the Supreme Court.

Christiansen had been hired as Director of Planning and Facilities for the BHUSD in 2004. A new contract in 2006 between Christiansen and the district changed her employee status. Christiansen continued to provide services to the district as a consultant.

Christiansen was sentenced to four years and four months in state prison on Jan. 5, 2012 and ordered to pay the district \$3.5 million in restitution, which has also been reversed. She had been free on bond pending appeal.

One count was enhanced due to “excessive taking” based on the allegation Christiansen’s company Strategic Concepts drew more than \$1.3 million in payments from the BHUSD’s Measure E bond fund.

For the remaining three counts, Judge Stephen Marcus ordered Christiansen to serve three two-year sentences concurrently with her 52-month sentence. Those three counts related to Christiansen’s participation in the awarding of contracts to Johnson Controls, Inc. for a total of \$7.5 million while she was a paid consultant for them.

Manaster said he was disappointed with the decision.

## Former BHUSD bond firm scrutinized in L.A. Times article on bond reform

Just a month before the November 2008 election, the *Weekly* reported in Issue #471 that all but \$100 of the \$69,000 that had been raised in support of Measure E from Jan. 1 to Sept. 30, 2008 had come from firms who would financially benefit from the bond’s passage.

The district’s then-bond broker, George K. Baum and Co., had donated \$12,500 of the \$69,000 raised by Sept. 30 and donated a total of \$25,000 of over \$129,000 in total contributions. Jones Hall, the bond counsel, donated \$7,500.

A new bill introduced in the State Assembly would outlaw contributions such as Baum’s.

Assemblymember Donald P. Wagner (R-Irvine) has introduced a bill, which would prohibit government entities from hiring financial companies that provide donations or campaign services for bond measures. State law prohibits school districts from donating to campaigns but not securities brokers.

“In a survey of five major firms that underwrite California school bonds, the *Times* found that in 65 issues over the last three years, virtually every securities broker that was hired by a district contributed to the measure’s political campaign,” according to a *Los Angeles Times* article published on June 3.

The *Times* article highlights the Garden Grove Unified School District who hired George K. Baum and Co. when campaigning

for a \$250-million bond measure. The securities broker donated \$35,000 in campaign contributions, polled voters, wrote ballot language and provided campaign services.

Critics of these firm-district relationships have noted that these deals are generally made before the campaign and without a competitive bid.

In July 2008, the then-Board of Education approved George K. Baum and Co. and Jones Hall as bond consultant and bond counsel, respectively on a 3-1-1 vote. Board of Education member Brian Goldberg, who currently serves on the board, voted against approving either agreement because there had not been a competitive bid process. Then-Board of Education member Steven Fenton abstained.

Goldberg did not return a call from the *Weekly*.

According to the agreement, George K. Baum and Co. would receive 1.1 percent of the value of bonds sold.

“Educators and securities dealers say there is nothing illegal about the practice and no link between a firm’s selection and its political contributions or campaign work,” according to the article.

Three other bills that would have banned donations from underwriters have been introduced in the last eight years and have all failed in committee, the *Times* reports.

Then-Board of Education member Myra Lurie said she would have to go back through her records to comment on the selection process for George K. Baum.

A subsequent board ended its relationship with the firm.

“I was asking to be released from our relationship from George K. Baum because I believed they were conflicted in being both the counsel and the underwriter, meaning that they played two sides of a sword and that I felt that was not the best situation,” said Board of Education President Jake Manaster, who was not on the board when the firm was hired, and said he was only speaking for himself.

The Board of Education has since blamed George K. Baum for unrealistic bond projections, which are leading them now to pursue a possible bond acceleration of Measure E.

The BHUSD hired Keygent Advisors, a financial advisory and management consulting firm, as financial consultants in 2011.

“When Keygent was selected, it was always important to me to select somebody who would be advising us as to the financing and the bonds to make sure that the person would give us independent advice, who would not have financial incentive to steer us one way or the other,” said Lurie.

## Planning Commission agrees on expanding community outreach for development projects

The Beverly Hills Planning Commission agreed on expanding noticing at the commission’s meeting on May 23.

The discussion came at the request of the city council. The 2012/2013 planning division budget plan called for an evaluation of expanding the area noticed from the sur-

rounding 300-feet.

The commission agreed to expand the area, to which mail notices are sent, from a 300 foot radius to a 300 foot radius, as well as the rest of the block. Staff wanted to address a typical comment made by residents, such as "My neighbor has received this but I haven't."

In the hillside, mailed notices would be expanded to a 500 foot radius around a project.

Staff had recommended expanding the radius to 500 feet, but some commissioners were wary of noticing homes that would not be affected by a project. Commissioner Howard Fisher said he was concerned with over noticing.

Staff wanted to simplify the process and make it easier for everyone to understand and use.

The commission also agreed to expand the projects that would require on-site posting. Currently, on-site notifications are required for R4 permits, minor accommodations, notice of overnight stay, second unit permits, open air dining permits, and design review.

Planning Commission Vice Chair Brian Rosenstein said he'd like to see site posting on every project that comes to the City.

Rosenstein called site posting on a commercial project a "no brainer" and said that major renovation on a single-family residence, such as demolition, should also have site posting.

Other recommendations by staff included requiring that all mail notices be sent at least 10 days prior to a public hearing or decision.

Staff will return to the Planning Commission with a draft ordinance. According to the staff report, all noticing requirements are currently dispersed within

the zoning code.

## Board of Education to hold first of three acceleration meetings tonight

The Board of Education will hold a public meeting on a possible acceleration of the Measure E bonds tonight at 7 p.m. at the Jon Cherney Lecture Hall in the Science and Technology Center at Beverly High.

Two additional public meetings will be held on Monday, June 10 at the Ron Brown Auditorium at Horace Mann School at 7 p.m. and Tuesday, June 18 at 7 p.m. at the El Rodeo School auditorium.

The Board of Education tabled a resolution on May 28 that would have accelerated the Measure E bond schedule, increasing the property tax rate for property owners. Board of Education President Jake Manaster said the Board was tabling the item to hold town meetings in order to involve the community.

Whether the Board decides to accelerate the Measure E bond or not, the district may issue \$25 million in bond sales in 2013.

Every school district that expects to issue bonds during the fiscal year of 2013 to 2014 is required to provide the County of Los Angeles a notice of intent to issue such bonds by June 30.

The board will discuss the resolution following the three public meetings at their next formal meeting on June 25 at 7 p.m. in the Salter Family Theater.

## City council officially votes on five percent water rate increase

The Beverly Hills City Council voted 4-1 on a formal resolution to reduce the increase for water rates from seven percent to five percent on Tuesday night. Mayor

John Mirisch dissented.

"I will, as last time, be voting against this," said Mayor John Mirisch. "My point was and still is that although the increase passed through the [Metropolitan Water District] is five percent, the MWD costs are only 37 percent of our entire budget."

The Beverly Hills City Council discussed the issue at the prior city council meeting on May 23. The council was voting on the formal resolution.

Last year, the council voted at its May 15 council meeting to raise the water rates at seven percent for the fiscal year 2012 to 2013 and 2013 to 2014.

## Mirisch seeks to block Bilak appointment

Frances Bilak was approved 4-1 as a new Recreation and Parks commissioner, with Mayor John Mirisch dissenting, on Tuesday night.

Mirisch pulled the resolution appointing Bilak to the Recreation and Parks commission from the consent calendar at the formal meeting. Mirisch suggested the city redo the recruitment process to fill the vacancy on the Recreation and Parks Commission because he had reportedly received complaints about the process.

The interview panel comprised of Councilmembers Nancy Krasne, Julian Gold, Recreation and Parks Chair Robbie Anderson and Vice Chair Howard Rosoff recommended Frances Bilak to fill the vacancy on the commission left by Alan Block.

The council discussed Bilak's appointment at the study session on May 23. Councilmembers Julian Gold and Nancy Krasne said they had chosen a Team Beverly Hills graduate and someone who had not served on a commission before.

"I've gotten letters from applicants who when they heard that one of the criteria afterwards was that someone should have been a member of Team Beverly Hills, were upset with the process," said Mirisch. "They felt that should have been made public ahead of time that that was a deciding factor."

Mirisch said that should not have been criteria.

"Excuse me, there seems to be a misunderstanding. That was not a criteria. That was an added bonus," said Krasne, who added that if it was an issue, it should not be on the application. "She was chosen because she was qualified and really outstanding."

Krasne said almost all candidates who had applied were qualified.

"This candidate was a consensus candidate and I think the notion that we did not pick the best candidate is not true," said Gold.

Gold said there was agreement amongst the interview panel and he was confident in the process.

"Excuse me, Mr. Mayor, but for a guy who picked an entire committee by himself, I think that the fact that four people – two councilmembers and two commissioners – unanimously picked a candidate speaks something for that candidate," said Gold, referring to the Mayor's Sunshine Task Force. "And I think the notion that we redo the process is just disturbing."

Mirisch said the concern was also that

## Taste of Broadway to celebrate 10th anniversary

Taste of Broadway, the City's musical theater program for children, will celebrate its tenth anniversary next week with a special show to close out the program's 26th session.

"This one is a little different because I wanted to celebrate the last 10 years, so we're actually revamping songs from the past 10 years," said Program Director Jenny Gordon.

Gordon usually picks 20 to 25 songs from various musicals to align with an overall theme chosen for each show. Narration is included between the songs, which Gordon also writes.

"Every kid has a narration. Every kid is in at least five or six numbers, and basically I've written 26 shows, and that way every single kid has their moment to shine," said Gordon, who said she structured the show in a way that would be inclusive of all participants.

This year the show's theme will be the program itself, and will include past songs that have been fan favorites and performer favorites. The narration will be reflective of what the program has done in the last 10 years.

Another surprise for the landmark show includes 10 Taste of Broadway graduates who will perform in the show, including some of Gordon's first students who are now juniors in college. The graduates will be joining in on "Seasons of Love" from Rent. Other songs in this year's show include pieces from The Addams Family, Bye Bye Birdie, Les Miserables, and Fiddler on the Roof.

The pieces will be accompanied by Larry Cooper who has been with the program for the last seven years.

Gordon went to Beverly Vista and Beverly High where she was a part of the Madrigals Singers. She said retiring choral director Joel Pressman, profiled in this week's cover story, is her mentor.

"At that time, performing arts was a lot more available than it is now unfortunately," said Gordon.

Gordon said some of the K-8's have musicals for certain grades, but there was not a musical theater program in place when she returned to Beverly Hills 10 years ago.

"I went back to Beverly Vista and saw that the arts were not as prevalent as they were when I was here. They didn't have a musical theater program, per se, so I went to the city to see if they'd be interested in me bringing a musical theater program to the city, and so I wrote a proposal and the rest is history," said Gordon.

"The biggest thing for me, and I've seen it over the last 10 years, is that kids really learn a sense of self when they do this program,"

### City adds lawyers to litigation team in Metro case

The City of Beverly Hills voted unanimously to retain two new attorneys to represent the City interests in state and federal litigation concerning the Westside Subway Extension on Tuesday night.

The item was on the consent calendar and was not discussed.

The City has hired Professor Daniel P. Selmi of Loyola Law School to assist primarily in the CEQA case against Los Angeles County Metropolitan Transportation Authority in California state court. Selmi will also assist in federal legislation.

Selmi is an expert on land use and environmental law both in the Los Angeles area and throughout California.

The City has also retained Philip Karmel of Bryan Cave LLP to assist with the NEPA case against the Federal Transit Authority (FTA).

Karmel is an experienced environmental and land use law litigator with the New York office of Bryan Cave, LLP.

When discussing the City's \$10.2 million surplus, the council set aside \$1.25 million to fund efforts against Metro. Selmi will bill the City at the rate of \$350 an hour. Karmel will bill the City at the rate of \$450 an hour.

The City's litigation team previously had included two law firms: Shute, Mihaly & Weinberger and Gilchrist & Rutter. The lead lawyer at Gilchrist & Rutter recently departed the firm and his new firm would not honor the terms of the City's agreement with Gilchrist & Rutter. The City Council's litigation committee composed of Councilmembers Willie Brien and Julian Gold reexamined the legal team to determine how best to proceed with the ongoing subway litigation. Selmi and Karmel will fill the role played by Gilchrist & Rutter. Shute, Mihaly & Weinberger will continue to lead

the team in both federal and state litigation.

## North Santa Monica Boulevard reconstruction moves forward

The Beverly Hills City Council voted 4-0-1 to approve an agreement with Psomas, a civil engineering consultant, for design services for reconstruction of North Santa Monica Boulevard.

Councilmember Nancy Krasne abstained because she had not read all of the proposals.

The council approved a purchase order of a not-to-exceed amount of \$1.94 million to Psomas to manage a project team for project design of North Santa Monica Boulevard, including conceptual design and public outreach.

Ownership of the boulevard was relinquished by the state of California in 2005. The state did not maintain the boulevard very well, according to Deputy Director of Transportation Aaron Kunz. Kunz highlighted specific problems on the street, such as drainage and poor quality of the pavement.

Kunz said that, as council had directed, the schedule for construction would be revised to begin spring 2015. Construction is expected to last 18 to 24 months.

The request for proposal also includes a desire to incorporate bike lanes on North Santa Monica Boulevard and the need for construction mitigation.

Kunz said a loss of green space would be required to accommodate two bike lanes.

“The notion of taking green space off Santa Monica Boulevard, it seems to me that before we spend a lot of time, energy and money that’s a threshold question that has to be answered,” said Councilmember Julian Gold.

The agreement with Psomas will be divided into two phases. Phase one would include public outreach, geotechnical surveys and necessary studies to accomplish cost of design options, development of a construction mitigation plan and work hours.

Phase two would include project design.

Kunz said the public outreach period would gauge whether or not there would be support for bike lanes.

Councilmember Willie Brien said he would not support a plan that proposed a loss of green space or a plan that did not have a mitigation program. Brien suggested the public outreach engage both residents

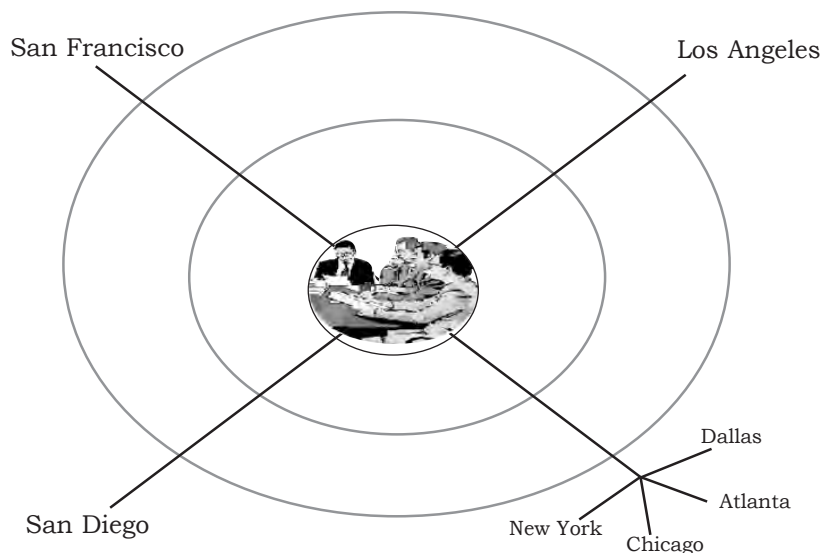

## BEVERLY HILLS' MUSIC MAN

Joel Pressman reflects on 38 years at Beverly High

**You're retiring after 38 years, what does that feel like?**

There's no short answer. There are so many highs and lows [and] so many individual experiences with people and of events that it is hard to imagine it all sort of stopping. But it doesn't really stop because there still are contacts. There are still connections to the school and to the people that I don't see stopping.

**As many of our readers know, you grew up here. Your father was prominent rabbi at Temple Beth Am and in 1975, you returned to Beverly High as a young choral director. Tell us about that.**

My high school teacher, [the late] Robert Holmes, gave us a lot of opportunities to do things. He would ask me to take over rehearsal while he would go and take care of some sort of business in his office, or if he was absent and the substitute teacher was, let's say a golf teacher, I would take over rehearsal. When I went to college, he would sometimes call me and say, "Can you come in and work with the choir? I'm going to be away with Madrigals or I'm going to be at a convention," so I never really broke that connection [to the community] and it seemed like a funny idea when he retired to apply for the job knowing that I wouldn't get it because I was young and just finishing my Masters and 38 years later, here I am.

**Where did you go to college?**

USC. My mentor was a man named Charles Hirt and he was also a man who gave us lots of opportunities. He made me a teaching assistant, had me conduct a group, do a lot of business managing and program developing and all kinds of experiences that were unusual for somebody my age and that also helped prepare me. And he had a love of language -- a love of language in rehearsal and a love of language in the music -- that definitely resonated with me and encouraged that part of me in terms of my own artistic directing.

**Can you expand on what you mean by "love of language in the music"?**

Singing is not just about notes. If you're an instrumentalist, you play the notes and

there are all kinds of communication there, but the subtleties of language go far beyond that. This year, for example, I really looked for pieces where the text meant something important [and] where I thought it would connect with the students and the audiences. For many years now, I've tried to approach the performance not in terms of, how well do we sing? But of, how well do we communicate? And some of that comes from vocal technique, but a lot of it comes from what is it you're trying to say? What's the message? What's the feeling? Do you want them to laugh or cry or both? Do you emphasize this particular syllable a little bit more in order to exploit more meaning? It's like Shakespeare.

Where the emphasis falls can tell you a lot about what he was trying to say.

**When you were first hired, there was some resistance to hiring you because some faculty felt you were too young?**

I switched out of the music education program at USC because I didn't feel I was learning very much. I got my bachelor's in voice [at USC] and most of the choral conducting classes, I took with the conducting majors. I got my Masters in choral conducting and therefore I had almost everything in the credentialed program, but I did not have the teaching credential. At that time, they had what was called a provisional credential where the school district would agree to hire you if the college would agree to give you the credential and the college would agree to give you the credential if the school district agreed to hire you, so they got together and said, "We will do this with this person." When I went to my interview, they said

the very logical question, "Why should we hire you when you don't have a teaching credential?" And I handed out multiple copies of a chart that I'd made saying, "This is what's required for a teaching credential and this is what I've had" and in most cases it was double or triple what was required for the teaching credential in terms of teaching experience, coursework, [and] conducting experience, so that pretty much quieted that.

There were two members of the performing arts department in the theater program who were not at that interview who felt that I should not have been hired. They wrote letters to the Beverly Hills papers saying that it would destroy the performing arts department, that I wasn't qualified, [and] that it was all political. [Superintendent] Ken Peters had made the final decision. The committee had narrowed it down to four finalists and he interviewed each of the four of us. It was a fabulous interview. I don't remember anything we said; I just remember being blown away by how good he was in terms of this interview. He called me and said, "This is not an attack on you. This is an attack on me because I hired you. You just go and teach." And that's exactly what happened.

**How has choral music and music instruction changed over the time you've been a teacher?**

When I was a student at Beverly Vista [in the 1960s], the boys glee had over 40 boys in it singing four part harmony. Everybody read music. Everybody took instrumental music lessons. Now, there are not 44 boys in the school district singing in choruses. The district programs are much more diverse.

The AP program has siphoned off some of our brightest kids. I still get kids who are taking seven or eight classes of APs, but it's not the same numbers as it used to be, so the gene pool is smaller. There are fewer kids to draw on that have been raised in the arts, so that makes it harder. Plus, when I started teaching, all four schools had a yearlong chorus program in the middle schools. Now some of them just have a musical in the spring, which is great training for theater, but does not necessarily keep their skills up musically.

**The Madrigals Singers are a nationally-recognized program. You've won numerous national awards. What makes this program special?**

I don't think that we are a better program than a lot of places. I judge choir festivals and I hear some absolutely magnificent choirs and some absolutely wonderful teaching. I think the thing that we bring, which is

less usual, is what I said about communication. There are choirs who sing with better pitch, better tone, better phrasing than my choirs ever do, but after 30 seconds, you go, okay, now what? And it is a rare choir who really takes each piece and makes a small drama out of it and finds that hook to give that audience something that they can connect with. I've never had anyone come up to me after a concert and say, "I love the way your sopranos lifted the soft palette on the ah vowel," even though that's something we spend a lot of time with. They'll come up and they'll say, "You brought tears to my eyes" or "how joyful" or other things to talk about the emotion of the piece, the connection of audience and performer. That's something that we emphasize and I have had judges who have heard us at numerous festivals say, "This is one of the special things about your choir." It's not unique, but it is rare.

**Many of your students have gone on to fame and fortune in the entertainment industry. Do you find this fulfilling?**

I will go see anything or watch anything or rent anything if a former student is in it. I'm a huge chauvinist for [Beverly High], especially performing arts. A number of years ago we had a board member who didn't much care for the arts. He said, "Frankly, I'm not impressed if our graduate can correctly identify Beethoven on the music while he's cleaning the toilets at Burger King. Our students need to be able to support a family. They need to be able to program on the computer and build a website." So I went home and I called [drama teacher] John Ingle, my initial colleague in my teaching, and we sat down and off the top of our heads, we made a list of 250 grads who were supporting their families. Everything from the people that you've heard of like Richard Dreyfuss and David Schwimmer and Nicolas Cage to people that you haven't heard of, who are doing props for Spielberg, who are writing, who are directing, who are doing Broadway theater and composing -- there's just so many people out there. Michael Lembeck, who is an actor/director, said in an interview once: he can hardly ever walk on to a set where he's directing and not find some connection to Beverly High performing arts. My son and daughter think that it's hysterical that we sit through the credits for everything and I'll say, "Beverly grad. That's a Beverly grad." There are a lot of us out there.

**A number of your former students have also found success in other industries outside of entertainment. Tell us about that.**

I've had a lot of people say, "The confidence that I got by standing up and having to sing in front of people helped me as a teacher, as a lawyer, as a doctor, as a cantor," [and] that there is a direct connection to putting yourself out there in a performing situation. I've also had people come up to me and say, "You are the only reason that I stayed in school." Now, they don't really mean me. They mean having a place to come and make music every day. One girl came to me and said, throwing up hurts her voice. I said, "Yes, have some yogurt and rest it for



a couple of days,” and she said, “What if you do it every day?” We talked and of course, she had anorexia or bulimia and we got her counseling and it was because she was concerned about her singing that she said anything. It was that important to her. To me, that’s as important a teaching victory as a kid who wins an award in a singing competition.

#### **Now that you’re retiring, do you know what the plans are to fill your position?**

I have not heard much. I’m hoping to be part of the process. I think I have something to offer in terms of perspective of the program. I know there are some wonderful teachers out there and I’m hoping that we are quick enough and smart enough to get somebody like that.

#### **You’ve been critical of the Board of Education in recent years. Explain.**

The constant comment that I’ve made is that according to its own standards, the California State School Boards Association lays out the responsibilities of a school board, individual members, and school administrators. School boards are not supposed to micromanage. They’re supposed to set broad policy goals and then allow their administrators to work with staff to find the best way to achieve those goals. Recent school boards have micromanaged to an extent I’ve never seen before. They ignore the recommendations of staff way too often. We had a school board president say at his installation, “We’ve done our homework. We know what to do. Trust us,” and then proceeded to say how individual school board members would be responsible for enforcing this policy or that policy and that’s not their job. I’ve seen too many really good people drive off the campus after having been fired by the school board because they weren’t “yes men” or “yes women,” and I’ve seen too many people quit because they could not do their job with integrity. This is not universally true of all board members, but as a general trend, over the last 15 years or so, it is a change.

When I started, the feeling was that the school board was honored lay people to help do the business of running a school district. That same Ken Peters, who was the one who hired me, made it really clear what the board’s role was, what the superintendent’s role was and what the administration’s roles were. He trained the school board into what their proper function was and I don’t mean

that he ordered them around. I meant that what exactly is in the state standards was what I think was much more what was happening at the time.

#### **Tell us some colleagues and administrators you’ve particularly enjoyed working with.**

Toni Staser who is my assistant principal now -- she [oversees] the performing arts department -- is a former music teacher, is insanely dedicated, [and] is one of those people that says, “What can I do to help?” and not “You’re doing this wrong, stop it.” Over the years, we’ve had many administrators who have come in and said, “What’s been working for you, you can no longer do and the reason is because we didn’t do it at my old school district.” Toni has been great.

[Former Principal] Ben Bushman, I was actually surprised. All I knew was that he was a head football coach, and I thought, what does he know about the rest of the school? And he dedicated himself to that school. If a custodian was called to clean something up and they didn’t come, he went to a custodial closet, grabbed a broom and cleaned up. If you called him and you had a problem and he wasn’t available, he would show up on your doorway during the morning and say, “How can I help?”

I think he set a good tone for [former Principal] Dan Stepenosky who followed him and I complimented [Principal] Carter Paysinger last week because he has really opened himself up. The same way that he was dedicated to the sports program, he’s dedicated to the entire school. I think most people feel that he is in their corner. I think it has been difficult for him because he is a principal in an era where people at the district do not want their administrators coming up with reasons to do something different from what the board is proposing. They don’t particularly want that much input. We’ve seen people driven out because they did not bow down. We had a superintendent, who I will not name, who left and just prior to leaving said to me, “I have never been in a district with so much bullying.” I said, “Are we talking about the kids?” He said, “No, I’m talking about parents, board members, [and] teachers.” There’s an adversary relationship that is not healthy.

I know there are people in the district who are trying to change that, so this is not a blanket indictment of everybody at the district

office because there are some tremendous, supportive people there, but as a tone, things still need to shift back towards something that is more collegial. Over the years, I’ve stood up at teacher’s union meetings and at board meetings and told the grownups when I thought they were not behaving in a mature and respectful way. I’ve been bawled out by both sides for that, but generally speaking, I haven’t had to backtrack because what’s right is right and while opinions about policy may differ, the way we treat each other shouldn’t.

#### **Are there any other colleagues you’d like to mention?**

Well, there are so many. I’m very fortunate that when I do what I do, I go out in public. There’s an audience and people applaud and you get that kind of feedback. There’s a lot of teachers who are here countless hours, go home, work countless hours more -- far beyond what they’re paid for-- and are brilliant teachers. Their students notice, but the community doesn’t necessarily notice. If your kid is not in that person’s class, they may not know. There are plenty of people who have not gotten the kind of attention I’ve gotten for retirement, and I think it’s because what I do is much more public, so I’ve always tried to take the opportunity of a bully pulpit to speak up on behalf of all the teachers because not everybody gets the chance to spout off like I do.

#### **What are your plans now that you’re retiring?**

To heal. My number one priority is to get healthy and then see what I’m up for like continuing to judge choir festivals, teaching voice lessons and traveling. I want to go to New York and see some Broadway shows. I want to go snorkeling. I’m waiting to see how quickly things change.

#### **How do you want to be remembered as part of the Beverly High faculty?**

I want to be remembered as somebody who really cared -- sometimes, too much -- and who made a difference, whatever that is. Whether it’s the relocation of the wheelchair ramp outside of Salter Theatre, which was going to replace the stairs -- I interrupted the architects who were there with their plans and said, “You know there’s a theater in there.” And they glared at me and I said, “Well what if you start it there

and ran it around the side of the building? You could have your stairs and you could also have your ramp.” And they said, “It’s our job,” and then they did what I wanted and I’m sure took credit for it. There are lots of little things all over the school. I like problem solving and the kids have allowed me to meddle and it’s been fun. I can think of very few jobs where you would have the opportunity to do as many different things as I’ve done with the technology committee and with the facilities committee -- not that anybody listens to the facilities committee. We would have these long discussions and great detail and do our research and the school board would say, “Yeah, but we want to do this.” Anyway, people are complicated. I would hate to say I want to be remembered in 25 words or less.

#### **Looking back on 38 years, would you have done anything differently in your teaching career?**

I probably would have spent more time on the teaching and less time on all the other committees and outside things because I know I have not been as good at recruiting as some of my colleagues and I know I haven’t taught everything I would have like to have taught, but who knows? It’s one of those, each according to his gifts. I seem to be interested in things beyond just the music. I told a teacher once who said, “I don’t care about that. My job is to teach chemistry,” “No, your job is to teach kids,” and that’s how I feel. I don’t know. Every day I say I have to do something different. And every time you have a bad day you say, what can I do differently tomorrow? If I had any day or year or decade to do over, I would do something different. I had a communication from a board member recently that said, “Teachers have forgotten how to fail. They cover up their failures. They hide behind their unions.” And I so disagree with that. Teachers know that they fail every day. The difference is that you get back out of bed and you go back in and you try something different the next day. My students have heard me say, “My mistake,” or “That didn’t work,” or “Let me try it differently.” I don’t understand why anybody would make such a statement that we’re afraid to fail. We’re not necessarily allowed to, but we fail all the time. Anybody who is paying attention knows that, that’s human beings.
