“Bike lanes on Santa Monica”

With the second of three meetings under now behind us, my fellow members of the Santa Monica Boulevard Blue-Ribbon Committee and I have narrowed our focus to key issues that will shape our design recommendations to City Council.

These include corridor character; traffic flow and connectivity; road user safety; and the extent to which we will anticipate future mobility needs on this corridor.

Several aspects of the \$16 million project are certain. Flow will not decrease; the corridor will remain two travel lanes in each direction. Access to northside streets and the business triangle won't be negatively affected whichever options are recommended. And our beloved Beverly Gardens will continue to be the park jewel we treasure.

The committee requested of our consultant Psomas more information about street engineering, enhancements costs, and the safety implications of introducing bicycle lanes. Now, I trust that our consultants (and state requirements) will guide the engineering. And I have faith that councilmembers will view this project as the most significant, visible capital improvement we'll make in a generation and choose a design accordingly - with cost a secondary factor.

As a driver and rider myself, I feel road safety remains the paramount concern. Those who choose to ride a bicycle in Beverly Hills (for transportation, health, or pleasure) are a tiny minority - perhaps only half of 1% of all road users. Yet city-wide traffic data provided by BHPD to the Traffic & Parking Commission show that riders make up more than ten percent of collision injuries reported to police. And that trend is on the upswing: rider injuries as a share of all collision injuries

City Council to consider expansion of Design Review Program to include Hillside neighborhood

The Council unanimously agreed to consider the Design Review Commission's petition to extend the City's single-family Design Review program, which currently only applies to the central area of the city, to all of Beverly Hills, including the area north of Sunset.

The Design Review Commission saw the issue as one of neighborhood equality. "Neighborhoods that are wealthier, north of Sunset, are not being reviewed," said Chair Ilene Nathan.

The Commission was established in 2004 with jurisdiction limited to the central city, "because it was a new commission and they wanted to see where it would go. I think we've proved our worth," said Nathan. "There's no reason why Hillside should be exempt if the rest of the city is included."

"It creates a little more work for us, but that's what we're there for. To protect the city from poorly-designed houses, houses that are bulky and massive-- and I think that we're doing a great job," Nathan said.

The Council unanimously agreed to discuss the expansion of the program, which "reviews proposed single-family residential development and its impact on the streetscape by controlling the mansionization of the City's residential neighborhoods which will degrade and depreciate the character, image, beauty, and reputation of the City's residential neighborhoods with adverse consequences for the quality of life of all residents," according to the Design Review Commission website.

"I'm trying to be optimistic [about their vote], for the sake of all of the residents. I think the Council will agree that we're doing a good job," said Nathan.

Traffic & Parking Commission elects Andy Licht Chair; consultants lay out plans for Santa Monica reconstruction

At the Traffic & Parking Commission's December 5 meeting, Vice Chair Andy Licht was elected Chair and Commissioner Lester Friedman was elected Vice Chair.

The city's consultants briefed the Commission on the plans for the Santa Monica Blvd. Reconstruction Project.

The project, which consultants estimated will take between nine months and a year, involves repaving, replacing damaged curbs and gutters, replacing storm drains, and adding decorative street lights.

Because the base material of the street will

be completely removed during reconstruction, cars will not be able to drive over the pavement until it is replaced. The consultants recommended that the Commission plan to close down one lane at a time.

to decide what time of day to recommend that the City plan construction. Midday constructions limits noise disturbance to residents at night, while night construction provides a longer construction period and a sooner completion date.

"Thursday was a preliminary briefing. We're going to be spending a lot of time

The consultants presented various options for the reconstruction, such as introducing bicycle lanes in either one or both directions.

The Traffic & Parking Commission will also have

gathering information for the project," said Licht. "It's going to be one step back, two steps forward."

Santa Monica Boulevard, part of the historic Route 66, was relinquished to municipalities in 2005. Since then, West Hollywood and Los Angeles have already reconstructed their portions of Santa Monica Blvd.

Southeast Residents Council takes Infiniti project Grievance to City Council

Last Thursday, the City Council directed the city staff to meet with Southeast Resident Council's regarding their request for a configuration of the Infiniti facility that minimizes disruption in the location's residential neighborhood.

David Peyman listed the Residents Council's requests, which include limiting the number of appointments per day to 40, restricting Infiniti facility traffic to major streets, and requiring Infiniti to close operation on Saturdays out of respect for its Jewish neighbors.

Infiniti's attorney Murray Fischer responded.

ed that it was too late to change the configuration of the Infiniti plan. "Infiniti has already acquired vested rights to continue construction," said Fischer.

"Would evidence of fraud lead the City

to reconsider the preferred figuration?" said Peyman, who argued that the City had previously agreed to a configuration that was preferential to residents, but changed their decision after "aggressive lobbying" by Infiniti.

The Council disagreed, citing again their reasons for denying the Residents Council's

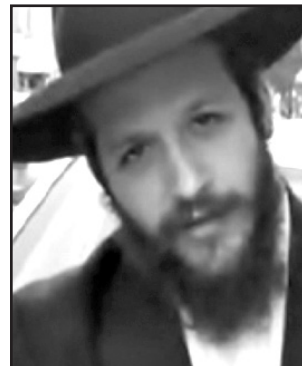
preferred configuration: a grade differential between the street and the commercial alley, concerns about interrupting traffic flow on major streets, and a number of "mature trees" near the alley where the Residents Council would like to divert Infiniti traffic.

The discussion took up over an hour and a half of the city's two hour study session. "All of us are listening and care," said Vice Mayor Lili Bosse. "This isn't a debate club. Can we please move on?" said Councilmember Nancy Krasne.

Ultimately, the Council denied Peyman's accusations and promised to work on a compromise that best served the residents, without modifying their agreement with Infiniti. "The real problem isn't some sinister conspiracy, but that residents are treated as second-class citizens. If anything can be concluded, it's that we failed," said Mayor Mirisch.

"The residents welcome the City Council's direction to city staff to meet with us at the earliest opportunity to address our concerns. During our meeting with city staff, we will seek an explanation as to why an Environmental Impact Report was not conducted," said Peyman in a letter cosigned by fellow residents Bradley Gibbons, David Galst, and Jason Morgan. "We will continue insist that the city engage the neighbors and the Southeast Task force before future development plans, not after residents are forced to investigate and uncover wrongdoing."

Tevel out on bail

Mendel Tevel, a local rabbi at the JEM Center arrested by the BHPD on October 29 in connection to a warrant issued by the NYPD, awaits trial after pleading not guilty in Brooklyn on November 8. Tevel was charged with molesting a minor and released on \$100,000 bail. He was extradited from Los Angeles to New York on November 7, according to the Jewish Journal.

The Journal reported in August that four men, who live in Brooklyn, have accused Tevel of abuse when they were minors (ranging from ages 6 to 14 at the time of the alleged abuse). According to the Journal's reports, the men claimed Tevel performed acts that included spanking on bare skin to sexually suggestive rubbing.

Tevel's former lawyer, Dana Cole of Beverly Hills, declined to comment on the case, and said that Tevel was working with a new attorney in New York.

City Council approves amendment to executive employee compensation plan

Mayor John Mirisch cast the only dissenting vote in a motion to approve a three-tiered amendment of the Executive Compensation Plan at last Thursday's City Council meeting.

The first tier of the amendment modifies the Executive Compensation Plan to adjust down-

wards salary ranges based on the latest survey conducted in April 2013. Although individual salaries will not be decreased by this amendment, management pay tiers will be lowered to match the brackets of surrounding areas, as indicated by the survey.

The second tier provides a onetime cash-out of vacation and administrative leaves in excess of 80 hours use overpayments to reimburse the City. The modification aims to reimburse the City for excess medical cafeteria plan benefits that were wrongly given to certain executive employees between 2011 and 2013. Those employees who received these overpayments are already being required to reimburse the City in full. This modification allows the employees to cash out accrued leave in order to make the repayment.

The third tier of the amendment allows existing Fire Association members promoted into the Fire Chief and Deputy Fire Chief positions to be eligible for retiree medical benefits currently available to those employees who were members of the executive group before January 1, 2010.

The amendment to expand the retiree medical coverage is expected to cost the city approximately \$6,000 for the Current Acting Deputy Fire Chief and \$26,000 annually for future promotions, according to City Manager Jeffrey C. Kolin.

"The other two proposed modifications have no fiscal impact at this time, although the downward adjustment of certain salary ranges limits future potential salary increases for certain positions," said Kolin in his recommendation to the Council.

Beverly High English teacher Julie Goler to travel to Russia with State Department

Beverly High English Teacher Julie Goler has been selected to travel to Russia in the spring to participate in the Teachers for Global Classrooms Program. The program is

funded by the Bureau of Educational and Cultural Affairs of the U.S. Department of State. "It's an opportunity to understand how other countries are educating their kids. We'll travel, but we'll also look at schools, have conversations with other teachers and in general, see how other countries are preparing students for the 21st century," said Goler. "The coursework has been some of the richest professional development that I've done since I left graduate school."

Mayor Garcetti, LAPD Announce Gun Buyback Program on December 14

Mayor Eric Garcetti announced last Thursday that people will be able to turn in firearms -- no questions asked -- in exchange for up to \$200 in Ralph's grocery cards at three Los Angeles locations on Saturday, December 14.

"The goal is to take these guns off the street and make sure they don't fall into the hands of criminals or children," Mayor Garcetti said.

The amount exchanged per firearm will depend on its type -- up to \$200 for assault weapons as specified in the State of California

and up to \$100 for handguns, rifles, and shotguns. The LAPD Gun Unit will be on site to determine the types of firearms surrendered.

This year, for the first time, a statewide buyback is taking place. Other cities holding buybacks on December 14th include Oakland, San Jose, and San Francisco.

continues to increase even as the proportion represented by walker and motorist injuries decreases.

Many commission members and stakeholders have remarked on the perils of mixing bicycles with traffic on Santa Monica Boulevard and I agree: that is exactly what we should avoid. It's hazardous for cyclists and it actually slows down motorists. If our charge is also to look ahead to future mobility needs, we need to keep in mind that the number of bicycle riders is forecast to increase. And riders' expectations regarding regional connectivity will evolve as well.

Here in Beverly Hills we must plan for it with streets that accommodate alternate modes of travel. We can start by choosing

to install dedicated bicycle lanes on Santa Monica. Our plans already call for us to "walk and ride a bicycle whenever possible." And as our General Plan advises, "Functional traffic patterns can only be achieved in connection with well planned development where alternatives to the driving are realistic options (taking public transportation, bicycling, and walking)."

Where safety and future mobility demands are concerned, I hope that our committee and City Council can agree that a recommended design must provides riders with safe transit and practical connections to the larger bikeway network.

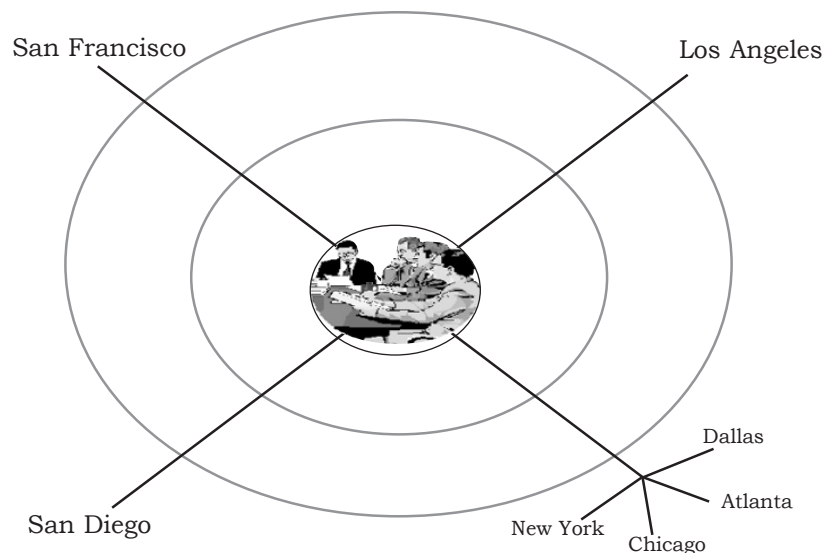
Beverly High students spread holiday cheer

Lou Karlin

Deputy State Attorney General

Last month, Lou Karlin, Deputy State Attorney General and Beverly Hills resident, argued in front of the Supreme Court in the case of *Fernandez vs. California*. The case involves a 2009 police search of Fernandez' home in Los Angeles while Fernandez was not present. Fernandez—sentenced to 14 years in prison for robbery, gang activity, and illegal gun possession—appealed his arrest on the grounds of his fourth amendment rights. The case went to the U.S. Supreme Court on November 13, where Karlin, along with an Obama administration attorney, urged the court to uphold the search and seizure as reasonable. Karlin spoke with the Weekly about his experience arguing in front of the Supreme Court.

What was it like to argue in front of the Supreme Court?

It was very exciting. It was a great experience.

How did you prepare?

There was very extensive preparation within my office and with the attorney

generals. I also did a practice in the court in the office, and I did another practice in the court in Washington, DC.

Did your wife [Olivia Weinstein Karlin, also an attorney with the California Attorney General's office] give you any advice before you argued?

She's a great lawyer, but no. We really didn't talk that much about the specifics.

She just encouraged me.

Were you nervous?

I was very nervous. I get nervous before most arguments anyway, but this was much more so. But I did so much preparation with the office that by the time the

argument came, I was pretty calm.

How do you think it went?

It went fine. I was able to answer the questions. I think I gave answers that made sense, whether or not the court would agree. But overall, I think it went fine.

Was there anything unexpected about the Supreme Court, even after all the preparation?

Well some things are surprising, even though people tell you about them. One of them is how close lawyers are to the judge. The courtroom itself is not large. Lawyers argue directly in front of the justices—the space between us is very small.

But the courtroom is very beautiful, and the atmosphere is—how should I describe it—very serious, but in a good way. I don't know. You definitely get a sense of the importance and the history. It's quite and honor to just be part of it.

Was there anything disappointing? Was it as grand as you expected?

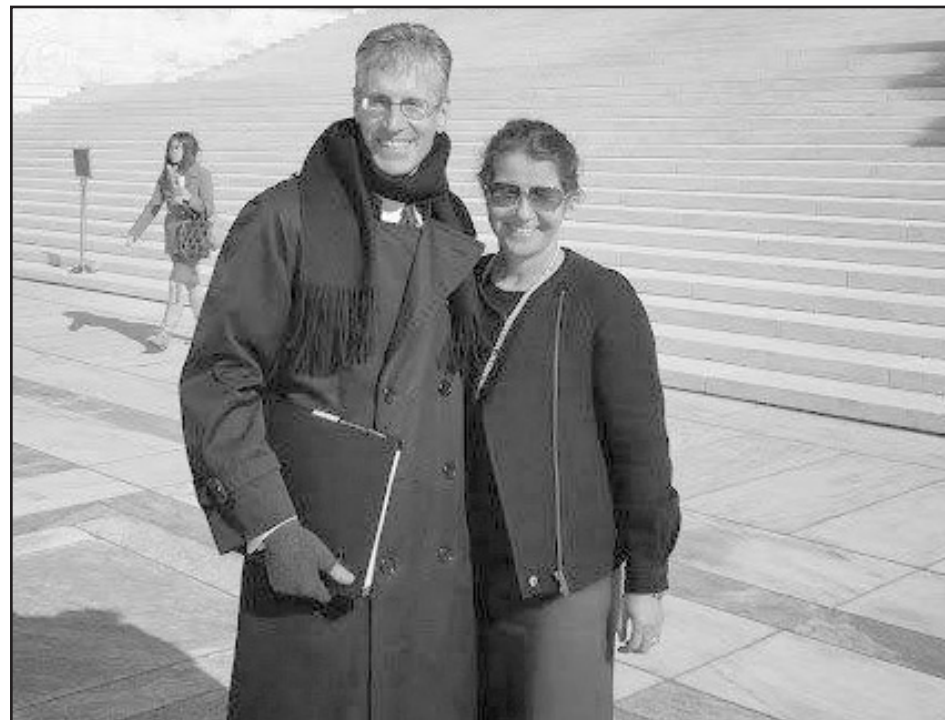
Yeah, it really was. A huge thing that helped was that I went to watch argument

the day before, so I got a sense of how one gets into the building, security, what it looks like to argue, how the judges ask questions. That helped a lot, so it wasn't such a surprise walking in. I didn't walk in cold.

How do you think your late father in law [former Board of Education member Jerry Weinstein] would have reacted?

I'm sure he would have been very proud. It is pretty cool that he was a lawyer, and my father-in-law was a lawyer, and I think they both would have been very proud. My mother attended, along with my brother-in-law and my wife, so it was quite wonderful.

I recognize how lucky I am to have had the opportunity and I'm really grateful for it.

'BIG WIN' FOR WEEKLY

Court grants Weekly's SLAPP motion; Courier to pay legal fees

Tuesday Los Angeles Superior Court Judge Maureen Duffy-Lewis granted *Beverly Hills Weekly's* SLAPP motion in a lawsuit brought last summer by competitor *Beverly Hills Courier, inc.*

The SLAPP (Strategic Lawsuit Against Public Participation) statute is a vehicle in which a defendant can file a motion if they were sued for matters related to freedom of speech.

"The court ruled in favor of the *Weekly* on two of the three causes of action

[intentional interference with prospective economic relations and negligent interference]. As for the third cause of action, unfair business practice, the court ruled that there's no first amendment issue, which is not necessarily a loss for the *Weekly*," said *Weekly* attorney Ronald Richards. "The *Weekly* expects to prevail on that issue at trial; however, if corrective action is necessary, the *Weekly* will be happy to do so."

"The complaint was filed on May 13,

2013. Without ever calling the *Weekly*, the *Courier*, in an attempt to interfere with the *Weekly's* business by filing this lawsuit, which has now been found to be a meritless SLAPP, carelessly filed this complaint" said Richards.

"The most important part about the ruling is that the first and second of causes action, which have now been dismissed by the court, were the only

ones seeking a money judgment for tort damages. The third cause of action simply advances a frivolous argument that fictitious business name statements need to be a certain font size, when in fact the government code imposes no such requirement," said Richards. "The *Weekly* will now be seeking a large attorney's fees award against the *Courier* which cannot be stayed by the filing of an appeal. The *Weekly* is grateful to the court for recognizing its constitutional right to publish articles and notices in the manner in which it sees fit, without the fear of a being subject to independent tort liability."

"The ruling is a huge win for us," said *Beverly Hills Weekly* publisher Josh Gross. "We are gratified to have excellent legal representation from Ronald Richards and Associates and also the Sedgwick law firm."

"I'm personally satisfied to defend a Beverly Hills business that's owned by a Beverly Hills resident," said Richards.

"This was yet another unsuccessful attempt by [*Courier* publisher] Clif Smith to obtain a monopoly in Beverly Hills. Clearly he has failed," Gross said.

NEW BOARD OF EDUCATION SWORN IN TUESDAY

Howard Goldstein joins Board, Brian Goldberg elected VP

Noah Margo was elected Board of Education President and Brian Goldberg was elected Vice President at Tuesday night's Board of Education induction ceremony at Beverly High. Board member Jake Manaster left the Board after a four year term. Howard Goldstein was sworn in for his first term on the Board.

Margo presented a mock report card to Manaster, in which he gave Manaster top marks in all but "Self Control." "He has a tendency to ramble," said Margo.

"I'm going to be uncharacteristically brief," Manaster said in his own speech, which thanked his fellow Board members and praised Superintendent Gary Woods. "He's still standing after four years," said Manaster.

Manaster left behind the Board's traditional jug of glue, and added his own bottle of super glue: "It's stronger and

faster, for the toughest jobs on earth," Manaster said to the new Board.

Howard Goldstein was sworn in by former Superintendent Dick Douglass. Vice President Brian Goldberg, Board member since 2007, was sworn in by Supervisor Mike Antonovich. Antonovich represents a San Gabriel and Antelope Valley-based district that does not include Beverly Hills.

"We should focus more on long range planning, and avoid the micromanaging of the day-to-day operations," said Goldstein.

Lisa Korbatov, board member since 2009, was also sworn in by Antonovich. In her speech, Korbatov she addressed recent Board obstacles.

"We will never cede the campus to Metro, or to any other government agency, now or ever," said Korbatov.

Korbatov also responded to parental concerns about the quantity of "bad teachers that don't inspire or relate to students" in Beverly Hills Unified.

"The inability by some in our district to make decisions is not patience. It holds the district back," Korbatov said. "Bad teachers are the result of even weaker administrators."

The Board members offered their encouragement to Noah Margo. "You follow the Golden Rule of teaching: 'Never be boring,'" said Board Member Lewis Hall.

Korbatov praised Margo for his effectiveness.

"I do forgive you for your cheeky ways," Korbatov said.

Margo thanked the Board for their welcome.

"Does everyone love the staunch conservative [Korbatov] giving the liberal [Margo] praise for being conservative?" said Margo. "I want to welcome the return of Mrs. Korbatov. If that sounds like a horror story, it is. For Metro."

"I want to make the private schools nervous," Margo said.

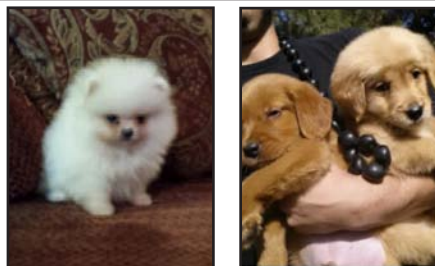

SUBCONTRACTORS' LICENSES AND LISTING - At the time of the Bid Deadline and at all times during performance of the Work, each listed Subcontractor must possess a current and active California contractor's license appropriate for the portion of the Work listed for such Subcontractor and shall hold all specialty certifications required for such Work.
