Yaroslavsky says he's open to a settlement on the subway route

In an appearance on Beverly H i l l s View that will air next week, retiring LA County Supervisor Z e v Yaroslavsky said that he is open to a settlement in

the ongoing legal battle with the BHUSD over the subway route to Century City.

"If they [the Board of Education] come back, we will meet them halfway," Yaroslavsky said.

Yaroslavsky said that the Purple Line extension proposed to run underneath the high school would be "the most direct and inexpensive route," but he has discussed alternate routes with BHUSD officials.

"As a face saving measure," Yaroslavsky said the Metro Board offered to spend millions of dollars to move the subway south of the school building and north of the Konheim athletic building. He said that the Board of Education did not accept that route.

"The way that Beverly Hills looks when it says, 'We don't want subways under our schools,' says to people in other parts of Los Angeles county, 'Well it's okay to have subways under those schools but not our schools,' like our kids are more important than their kids," Yaroslavsky said. "The fact of the matter is none of the kids are jeopardized."

When news broke out that ISIS would attack American transit lines, Yaroslavksy said that he was "shocked" to see Superintendent Gary Woods and Board of Education President Noah Margo argue that a potential subway bombing was a valid reason to reject the subway from going under the high school.

"That's nonsense," Yaroslavksy said.

On the topic of pension reform, Yaroslavsky mentioned that the LA County Board of Supervisors in the early 2000's rejected the "3-50" pension which would give public safety employees three percent per year of their highest salary when they turned 50 years of age, saying that it was an "absolutely absurd thing to do."

"Those who did it are threatened with bankruptcy and we didn't do it," Yaroslavsky said.

The Beverly Hills City Council adopted the "3-50" pension plan in 2002, which is now costing the city millions in increased pension and benefit costs.

"We didn't do it," Yaroslavksy said.
"We stood up to those who wanted us to do it. Whatever our personal likes or

dislike of each other are, when it comes to doing what's in the best interest of the county, for the most part, all the boards I've worked with have done an incredible job."

Sale of public parking spaces to be banned

The City Council passed an ordinance prohibiting compensation for the exchange of a public parking space with a 3-2 vote at their formal meeting on October 7.

Councilmembers Willie Brien and John Mirisch were against the ordinance.

Brien said that emergency ordinances are "rushed" and all information is not yet available.

Mirisch said that though he is against the sale of public spaces, he is open to providing a program that informs users of available parking in Beverly Hills.

Parking Operations Director Chad Lynn said that the department has been working with other companies that would provide information on available parking, and even connect with a vehicle's GPS system to prevent distractive driving.

The ordinance specifically addresses compensation for a public parking space. Valet parking will be exempt in the ordinance.

The application "Parking Monkey" has advertised on their website that the application is available in Beverly Hills. The app connects the seller, the person occupying the public parking space, to the highest bidder, who pays for the seller's parking space. The seller is only paid if the bidder occupies the space.

Lynn said that though Parking Monkey has not been marketed in Beverly Hills, a Craigslist ad advertised to potential employees who would be paid \$13 an hour to occupy parking spaces and then vacate them to the bidders.

A second reading of the ordinance will occur at the next City Council meeting. If passed, the ordinance will take effect after 30 days from that date.

"We definitely want to be forward thinking in terms of making it easy and accessible for people who want to come to our city to find parking," Mayor Lili Bosse said. "Mobile applications such as this encourage price-gouging and driving while texting and is a disadvantage for anyone who does not have the latest mobile technology."

Margo says bond acceleration will be put to a vote in March

Board of Education President Noah Margo discussed the board's plan to put the bond acceleration to a public vote on the March 3, 2015 ballot at the PTSA meeting on October 10.

"Our tentative plan is to go out for election in March that would accelerate the bond and put it to the residents to vote," Margo said. "Outside of that, it then becomes a decision of the board to do it without the community's consent or wait [until] 2017 [for the next bond issuance]."

Waiting for the 2017 bond issuance would delay projects for two to three years, according to Margo.

The Board of Education wanted to give the voters the opportunity to vote for the acceleration since the original platform for the Measure E bond in 2008 was to maintain the property tax rate of \$49.71 per \$100,000 assessed property value, and not raise taxes.

The Planning Commission of the City of Beverly Hills, at its REGULAR meeting on Thursday, October 23, 2014, will hold a public hearing beginning at **1:30 PM**, or as soon thereafter as the matter may be heard to consider the following:

Zone Text Amendment. A request for a Zone Text Amendment to Chapter 3 of Title 10 of the Beverly Hills Municipal Code to create a new entitlement called a Historic Incentive Permit that would create incentives for property owners to landmark historic buildings. The incentives relate to establishing provisions for modifying development standards for landmarked properties in order to accommodate new additions/development on a property while preserving historic buildings;

Historic Incentive Permit. A request to allow a proposed new addition to the existing residence at 1000 North Crescent Drive to encroach into the required front setback. The request is for a two-story addition for a garage and security office, which will result in an approximately 10' encroachment into the front setback. The request is being made pursuant to the proposed Zone Text Amendment described above, and would be contingent on the approval of the Zone Text Amendment by the City Council.

Minor Accommodation. A request to allow the proposed addition to be aligned with the existing, nonconforming side setback for the residence. The request is being made pursuant to BHMC §10-3-2506, which allows for the issuance of a Minor Accommodation to extend legally nonconforming side yard setback; and

Hillside R-1 Permit. A request for a Hillside R-1 Permit to allow cumulative floor area on the property in excess of 15,000 square feet, on a site exceeding two acres in size. Approval of the addition would result in a cumulative floor area of approximately 27,584 square feet.

This project has been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the environmental regulations of the City. The project qualifies for Class 1 and Class 5 Categorical Exemptions. The exemptions are applicable for additions to existing structures, as well as minor changes in land use limitations such as the creation of the Historic Incentive Permit, and the project has been determined not to have a significant environmental impact and is exempt from the provisions of CEQA.

Any interested person may attend the meeting and be heard or present written comments to the Commission.

According to Government Code Section 65009, if you challenge the Commission's action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the City, either at or prior to the public hearing.

E in March, the last set of bonds would be issued in 2034, which may delay the proposed projects.

If the acceleration were to be approved in March, the earliest the acceleration could take into effect would be in the 2015 - 2016 fiscal year and would be distributed in consecutive years. The acceleration would increase the tax rate to the maximum allowed by Proposition 39, which would be \$111 per \$100,000 of assessed property value, and eventually decline to \$60 per \$100,000 of assessed property value around 2034.

Margo said that the majority of the

current bond money is going towards the Horace Mann construction, which broke ground over the summer. El Rodeo and Hawthorne are both in the design phases, with Beverly High being the closest to completion.

Beverly High's designs will be incorporating the State Seismic Mitigation Program (SSMP), where the BHUSD will be eligible for state funds, specifically to provide upgrades to buildings that are not structurally sound and are susceptible to failure in an earthquake, according to Facilities Acting Director Tim Buresh. Currently, nine district buildings are eligible for the SSMP.

Rexford Drive, Beverly Hills, CA 90210, will hold a public hearing to consider:

AN ORDINANCE OF THE OF THE CITY OF BEVERLY HILLS AMENDING THE BEVERLY HILLS MUNICIPAL CODE DEVELOPMENT STANDARDS FOR SINGLE FAMILY PROPERTIES IN THE CENTRAL AREA OF THE CITY TO ADDRESS ISSUES RELATED TO BUILDING SCALE AND MASS AND PARKING.

The proposed Ordinance would amend various sections of Chapter 3 of Title 10 of the Beverly Hills Municipal Code regarding development standards for single family properties in the Central Area of the City. The amendments as proposed address development standards, including but not limited to:

- 1) Definitions of roof types for single family houses;
- 2) Total maximum building height and maximum roof plate height for houses;
- 3) Minimum required front setbacks for houses north of Santa Monica Boulevard;
- 4) Minimum required side setbacks for houses south of Santa Monica
- Boulevard: 5) Permissible encroachments in side yards including regulation of light wells
- and porte cocheres;
- 6) Setback and landscaping standards for walls and fences located in front
- 7) Landscape standards including required landscaping in side yards and required mature trees in front yards;
- 8) Parking standards for new houses or for bedrooms added to existing houses.

A resolution recommending City Council adoption of the Ordinance was previously reviewed and adopted by the Planning Commission on September 29, 2014.

This Ordinance has been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the environmental regulations of the City. It can be seen with certainty that there is no possibility that the adoption and implementation of the Ordinance may have a significant effect on the environment. The Ordinance does not authorize construction. This Ordinance is exempt from the environmental review requirements of CEQA pursuant to Section 15061(b)(3) of Title 14 of the California Code of Regulations.

All interested persons are invited to attend the public hearing and speak on this matter. Written comments may be submitted c/o City Clerk, 455 N. Rexford Drive, Beverly Hills, CA 90210. 

BHHS Football Team Routed by **El Segundo**

Normans to play host to Hawthorne in homecoming game Friday.

Turnovers and tipped punts leading to advantageous field position for El Segundo were among the reasons for Beverly High's 50-0 loss in the Ocean League opener for both teams Friday night at El Segundo, Normans coach Charlie Stansbury said.

Injuries also contributed to the loss, Stansbury said. For the second consecutive game Beverly Hills (1-5) played without Joe Kolko, its leading rusher entering South Pasadena game Oct. 3, because of an injury.

The Normans trailed 14-0 at the end of the first quarter and 43-0 at halftime.

Stansbury said before the game his goal for his team was to "step up in our level of execution on both sides of the ball."

When asked after the game what he thought of his team's execution, he replied, "Offensively, it was very poor. Defensively, we were playing without (the injured defensive back) P.J. Goolsby. We did a nice job when we blitzed."

Beverly Hills junior Jake Wolken completed two of nine passes for 52 yards, with 51 of those yards coming on a completion to Rashard Ysaquirre.

Ysaquirre was the Normans' leading rusher, running for 41 yards on 12 carries on a night as a team Beverly Hills rushed for 22 yards on 24 carries.

Quarterback Lars Nootbaar completed 13 of 15 passes for 252 yards and five touchdowns for the Eagles (6-0).

When asked who played well for his team, Stansbury cited Ysaquirre and sophomore center Genesis Wilson who "did some things well and at times had a rough go of

"It was a learning experience for him," Stansbury said.

The loss was the Normans' sixth by at least 44 points in Stansbury's 16 games as their coach.

El Segundo was ranked second in the Southern Section Western Division polls released Oct. 6 and Monday.

What's Next?

Beverly Hills' homecoming game at 7 p.m. Friday will be a true homecoming for Hawthorne coach Donald Paysinger, a 1977 Beverly High graduate and the Normans coach from 2009-2012.

25 YEARS AFTER THE TEACHER'S STRIKE

Has anything changed?

AJ WILLMER FORMER BOARD OF EDUCATION MEMBER

My wife's and my eldest daughter was in kindergarten at Horace Mann. We had been living in Beverly Hills [since about] 1983, but [we hadn't] really paid too much attention to the local politics.

I walked [my daughter] to Horace Mann in the middle of October in 1989 and the teachers were on strike. I was horrified, upset and unprepared. I did not even know there was any labor strife going on. Why is this affluent community not willing to pay its teachers?

Frank [Fenton] was serving on the school board at that point. Judie [Fenton] was very involved [at] Horace Mann. Laura Adler was the PTA president and a very good friend of Judie's. I walked into a PTA meeting furious.

Judie called me up [and said that] I really did not know what the issues were and that the PTA was the wrong place to make changes. The right place to make changes and get involved was at the level of the school board. When I ran for the school board in 1991 it was with Judie Fenton's support and with Laura Adler as my campaign manager.

I very rapidly learned that we were not really able to fund our own schools. We were funded through the State of California like everybody else, and that was why we had funding problems. [I was] still frustrated, but probably no longer as angry at the school board as I had been.

[I] helped create an organization called "Children First" to show concern about [the] teachers' strike and why their compensation was poor. We helped create a meeting with the board, [the] teachers and [the] parents. A lot of us learned the fundamental problems with how the school district was financed.

We were trying to [raise] \$600,000. We felt that might bring everybody to the table. We raised several hundred thousand dollars. A little bit because of that, but primarily because the school board and the teachers were talking, the strike was settled several weeks later.

We realized that there was a financing problem and the school board asked Judie Fenton to run a parcel tax in the summer of 1990. To this date, it was probably the single, largest, retail, political campaign in Beverly Hills. Knocking on everybody's door, I got a taste of how relatively small the town is from a [political] point of view. Unfortunately, that parcel tax failed by four votes in June 1990.


I did run for the school board in 1991. It was a combination of being provoked by the strike, being provoke at how poor the funding was for the school district, and then having been involved in a rather extensive election effort for the parcel tax.

There was always an awkward relationship between me and the teachers' union because of the conflict of where dollars should be spent. I got along very well with individual teachers [but] I did not always get along that well with the union. But the relationship was cordial and open and we shared information.

I believe very strongly in collective bargaining, and I believe that the teachers' best interest are indeed served by their union looking out for salary, health benefits, and working conditions. But when you're in a policy decision as a board member, you have a broader set of priorities and that creates some conflicts. A lot of that conflict remains to this day and I think it's healthy. Sometimes it gets represented as a little more friction than [what] really occurs.

The school district is in a lot better financial shape than it was in the early 1990s. The school district is now a Basic Aid school district, so it gets more money from our property taxes. There's been about a 50 percent increase in Joint Powers Agreement, after adjusting for inflation. I think the school district has about 50 percent greater funding per student than it did in my early years on the board. It's appropriate that the majority of that extra funding go to compensating teachers and administrators.

I was very concerned about the school district a few years ago when their budgets were not in balance. But they seem to be in significantly better shape in the last couple of years. A lot of that is because our property taxes have increased dramatically in the city and the school





district gets a solid amount of funding directly from the property taxes. If the property taxes drop there will be some strong issues, but I know that the board has put a significant amount of money aside.



JUDIE FENTON FTA MARKETING

The thing that surprised me the most was the tremendous support that this community gave the school board, which in this day probably would not happen. In this day, they would support their teachers.

[Board of Education members] Betty Wilson and Frank Fenton went to a parent town hall meeting at the Beverly Hills Hotel and Frank spoke. [The community was] respectful. They supported the board, they believed Frank, and they believed the Board when they said there was no money. [The school district] audited the books several times. The union audited the books several times, and

[people from] Sacramento audited the books. There wasn't any money.

But when you have a group of people and they're all riled up, they start to believe everything. I think that the teachers at Horace Mann asked Frank how long did he think the strike would go on. He made the comment, "I think you should take your Christmas ornaments with you." All he meant by that statement was there was no way of giving them something they didn't have and this became a real problem. It was just a trust factor.

I remember one day AJ Willmer was striking with the teachers. I didn't even know who he was and I [asked] somebody, "Who is that man walking with the ponytail and the hat?"

He called me because he had some questions, and I went after him with a vengeance. I said, "You're sitting there and you're criticizing my husband [on] the school board and you don't have clue what's going on." A couple years later he came back and said, "You were right," because he didn't know until he became a school board member.

[The teachers] decided that they were going to strike [for the] first time in history. The kids didn't know what was going on, the parents were really angry at the teachers because they weren't going to fill out referrals for colleges and the less the teachers did, the [angrier] the parents got.

They just didn't understand this at all. We had substitutes that came in to try and keep the schools open. They called them "scabs." [The teachers] weren't brutal to them, but the police were there every day to make sure that [the substitutes] got into the parking lot safely and got home safely. I didn't realize the extent of it [until] it got a little bit longer. I hid at my friend's house on North Sierra almost every day because I felt safe there with my kids.

[The teachers] started picketing, and they didn't have to picket. Teachers were given choices of where they picketed. We had some people picketing in front of our house and [former Board of Education member] Dana Tomarken lived a block away [on Almont]. She called me to say, "The guy in the hat is on his way to your house."

I tried to get out of my driveway several times and [the teachers] just laid there. I said, "If you continue to lay there I'm just going run you over. I have to take my kids to school." I fought the picket line every day and made a point of taking my children to school because that's where they belonged. Teachers thought that parents would keep their kids home. [The parents were worried the first couple of days but then] they sent their kids to school.

I remember that the ACLU came in to start picketing with them. That was when it really became scary because now they were bringing outside forces in. They let my dog out of my backyard. My girlfriend was driving down the street on her way to see me and she saw the dog. She put the dog in the car and brought the dog back.

After that we had security in the front and in the back. When the strike was over, the bill went to the school district for \$88,000 for security. You should have heard them screaming about the bill. I thought to myself, "We were picketed for almost three weeks, and we needed protection."

They were really serious. In the middle of the night, [Frank and I] tried to figure out a way where we could give the teachers a small raise and not have it interfere with the budget. We came up with the parcel tax. We called [former Board of Education member] Mark Egerman at three o'clock in the morning, and asked him, "Legally, can you raise the tax and give it to the teachers?" He researched it [and] we figured out that we could do a parcel tax. We could give a small percentage of this parcel tax to the teachers.





We worked our butts off trying to get a parcel tax passed. To this day there are certain teachers I won't look in the eye. 25 years later, if you're still a teacher during that time I probably would never speak to you. I was so upset. I didn't think their union president served them right.

I am still as proud as I've ever been of Frank and the members of that board because they held tough. Even though they got a lot of criticism from a lot of people. They really hung tight. [Former BHUSD superintendent] Sol Levine was the hero in this strike because he was the glue that kept us all together. He was the one who called me and said, "Judie, I really think we're going to have a better day today and I think that you don't have to worry." But I worried every day.

I still say this to the day, who would have thought that the parents wouldn't have supported their teachers? They were angry. They didn't like what was going on and they wanted their teachers to come back to work. They loved their teachers, but the union really misled them and I blame the head of the union at the time. Now I love the union.

[Former BHEA president] Chris [Bushee], he's fabulous. One time I wanted to go in to talk to the union about how [to] give more support in the community, get involved in elections [and] be a part of the community, which they weren't at the time. Chris was very receptive. They've been involved in elections, walked for candidates, and now people respect their teachers.

When Steven [Fenton] was on the board [20 years later], the board relationship with the teachers [was] fabulous because he tried to make it work. The only time it doesn't work is when you sit down and you want [a] seven percent raise and they're not moving. You can't even go to two percent [which is the] cost of living. But they're much more willing to go to the table now than they were before.

I think that the Board of Education of today is very supportive of their faculty and tries to really work with the unions. The unions today are much more agreeable to sit down with members of the school board and try to iron out the problems. They're younger, they're smarter, and I don't think they want acrimony. I think they really want to try and get along.

When you're talking about money, sometimes you can't make it work because the numbers are not there but the willingness to do it is what's important.



STEVE KESSLER HORACE MANN PRINCIPAL

It was definitely a very sad situation in that I believe that our Board of Education, administration and teachers all wanted the same things, but there were financial issues that got in the way. To see the heartbroken faces of our students who were not being taught by their regular teachers deeply affected many of us. Many of us were there the day the buses rolled in with the large number of substitute teachers. Again, the look of disappointment on the students' faces really affected many of us. We were really happy when things were worked out because we really wanted to get back with our students.

But we did believe in our union and what we were doing. Even though our union was not successful, we really didn't get any concession from the Board of Education, it was just a very, very tough time where a lot of very good people were put into very tough situations.


I am very happy that a situation has been agreed upon [for the teacher salary raises] and that's what's most important. Our teacher union, our board and administration have agreed upon this situation of splitting the extra money that is coming through property tax.

When I started in Beverly Hills in 1976, we were not only one of the highest paid districts in California but in the United States of America at that time. To see us dip down as we did was a really hard thing for me to accept because I came here during the lighthouse district era. There was money available and a lot of great programs.

I'm very happy to see that the pendulum is switched back now to where the teachers are getting raises. In other words, it's just something that has been agreed upon by both parties and they're both benefitting. This raise in teachers' salaries I know will help the overall situation for the Beverly Hills Education Association because obviously, when you have very good salaries I believe you tend to attract some of the best teachers.

[Board and teacher relationships] are much better now than they were. At that time when there was a strike, obviously there were strained relations, but we knew many of those board members. Not all, but many of us, myself included, knew what a tough situation they were in. As far as them being receptive to the needs of the union and the teachers and everything, I'm just very glad that

this current board is so receptive. It just goes a long way towards the betterment of everything in the district, which ultimately helps the kids, which is what it really should be about.



STEWART HOROWITZ FORMER BHEA PRESIDENT

It was one of the greatest experiences of my life.

1989 was the start of my fifth year [as a teacher]. The relations between the teachers and the district had not been good for several years.

In the era before I got there, the district always had however much money needed to do whatever it wanted to do for the students and for teachers. Beverly [Hills] teachers were among the very best teachers, not just in California but among the best paid in the United States.

But in the decade after Prop 13 and in the years after a famous court case called *Serrano-Priest* [that happened in the 1970s], that was increasingly no longer true. Funding in California was not keeping up and Beverly [Hills] no longer got its funding from local property taxes. The money came from Sacramento. We were discussing a pay raise and the district said, "Well, we can't afford that."

What most teachers will not remember was we were actually offered a fairly decent pay raise. Over a two year period we were offered a 12 percent pay raise, seven percent for one year and five percent for the next year. But it wasn't just [a salary raise] we were asking for. We felt that a number of board members were very disrespectful to teachers [and] there were issues of the high school [schedule] and benefits.

The strike was a long process. The contract expired, we started working that year without a new contract, and negotiations didn't get anywhere. When we got back to school in September of 1989, we took a vote to strike. The vote was overwhelming in favor of a strike. We turned in our keys, turned in all of our supplies and whatever was school property and boom we were outside and we were on strike. Out of 300 teachers, there [were] only four or five teachers in the entire district who did not go on strike.

In the first few days we were optimistic that we would get a settlement that things would get worked out. At first the atmosphere was very positive. We thought that this was going to work out okay and that we'll reach a settlement and that would be the end of it. But the strike ended up going on for I think it was 13 days. It got more and more difficult.

Negotiations continued [and] the community was very split. There were many parents who supported us, but many other parents did not. A lot of kids were not going to school. [The school district] brought in substitute teachers. We called them "scabs." It's an old union term for someone who crosses the picket line. There were several hundred "scabs" that were hired. The district was paying them a lot of money. Of course the official releases from the school district, [was] "We have hired hundreds of quality teachers. Send your kids to school, there's nothing to worry about. We have a qualified teacher in every classroom."

What we learned later was most of these people were disasters. No work was getting done, it was chaotic in the classrooms, and a lot of these people couldn't' get jobs anywhere else. But the district was so desperate to get all these people that they just hired whoever. A warm body and a teaching credential was all that you needed.

The strike went on for 12 or 13 days, a settlement was finally reached and we went back to work

It was very difficult afterwards in the sense that there were a lot of bitter feelings by both sides. The one positive thing is that at most of the school sites the administration [had] longtime administrators. Even though we'd been on strike, and now we're back, the fact that at most of the school sites [had] really meaningful and long term relations with the school administrators, that made coming back a lot easier. Even though everybody was upset at what had happened, things at the various schools by and large went back to normal fairly quickly.

But relations between the union and the district were very bad the next few years. That was exacerbated by the fact that the country went into a bad recession in 1990-91. There wasn't money for anything. It was a very difficult time economically after the strike.

[The] five percent raise that teachers [got for the 2014-2015 school year] brought a maximum salary to just about \$95,000. That's fair. Understand that there are many districts where teachers are making well over \$100,000 right now, and who have benefits that cover not just themselves but their entire families. Beverly Hills teachers, if you're working and your spouse is taking care of the kids, and you're the one who has to earn the wages for the family and provide health care, you can easily be paying \$6,000 or \$8,000 a year out of pocket for health benefits for your family. There are many districts where your family benefits are covered by the school district.

When I [went] to Beverly Hills in the 1980s in the few years before the strike, we had a very stable school district. Teachers that got a job in Beverly Hills [would] have their whole career in Beverly Hills. Very few teachers left because there was no reason to leave. It was the best place to be a teacher. That's what teachers thought back in the 1980s. That is not what teachers think today.

Every administrator at Beverly High when I began, had been working at Beverly Hills for years if not decades. The only one who was relatively new was the principal who'd been there [for] seven or eight years. The assistant principal at the high school, the principal at all of the elementary schools, all of the them were long time veteran teachers who had strike cont. on page 10

become principal at the four elementary schools so it was a very stable teaching staff, a very stable school administration and there was a lot of trust between teachers and administration.

That's not the way it is today. The turnover of administration is constant turnover. I believe there are many school districts where the turnover is not as great as it is in Beverly Hills. Particularly if it's a really well paying district, if it's a good district with good achievement, good students, [and] well paid, people don't leave good situations.

The strike happened because of a level of mistrust that existed between the teachers and the Board of Education and the district administration. There was a breakdown in communication. I believe what happened as a result of the mistrust was an unwillingness to give little and reach a compromise. The strike was really unfortunate. It was not a good thing, not for the district, not for the teachers, not for the union, and not for the students.



ROSE KAISERMAN FORMER BEVERLY VISTA PTA PRESIDENT

[I was a senior at Beverly High]. I went to school every day. I was sitting in classrooms where there were no teachers, just substitute teachers. The substitute wasn't always there. They had to go sometimes to another room. I do remember one time a kid threw a chair out the window. It got very chaotic. Without the teachers, the schools clearly couldn't function the way it should.

I remember the sports teams could not function as well. The football games couldn't continue either because of [the strike]. I was a captain [on the cheerleading team] and we skipped a few games. It was really sad for us to miss that sense of high school

community.

[The strike] wasn't that long. It was a little bit tough catching up [with school] but it wasn't too bad. I think the teachers kind of prepared for that.

It was more or less a vacation for the students.

I was in ASB so I did know a little bit [about the teacher and board relationship]. But I do feel that the board, the administrations, and the teachers have a better relationship [today]. The board listens more.

I think [the recent teacher salary raise] is a good thing. It's a positive thing. It should have been done a while ago. We could have retained some really good teachers. But we're doing it now so it can only say good things.

I hope that this attracts more qualified teachers into the city and that we can retain all the phenomenal teachers we have currently.

ORDINANCE NO. 14-0-2665

ORDINANCE OF THE CITY OF BEVERLY HILLS AMENDING THE BEVERLY HILLS MUNICIPAL CODE REGARDING THE WA-TER CONSERVATION STAGES

THE CITY COUNCIL OF THE CITY OF BEVERLY HILLS HEREBY ORDAINS AS FOLLOWS:

Section 1. The City Council hereamends and restates paragraph B of Section 9-4-303 ("DECLARATION OF WATER CONSERVATION STAGES") of Article 3 ("Emergency Water Conservation Plan") of Chapter 4 ("WATER REGULATIONS") of Title 9 ("BUILDING AND PROPERTY HEALTH AND SAFETY REGULATIONS") of the Beverly Hills Municipal Code to read as follows:

DECLARATION OF WATER CONSERVATION STAGES:

"B. The resolution by the city council implementing or terminating conservation stages shall be published within 10 days after its adoption at least once in a newspaper of general circulation within the city and the implementing resolution shall be posted in a least three (3) public places and shall continue to be posted until such time as the restrictions of each stage are repealed by resolution of the city council."

Section 2. The City Council hereby amends and restates paragraphs B, C and D of Section 9-4-304 ("REQUIREMENTS FOR WATER CONSERVATION STAGES") of Article 3 ("Emergency Water Conservation Plan") of Chapter 4 ("WATER REGULATIONS") of Title 9 ("BUILDING AND PROPERTY HEALTH AND SAFETY REGULATIONS") of the Beverly Hills Municipal Code to read as follows:

9-4-304: REQUIREMENTS FOR WATER CONSERVATION STAGES:

- "B. Stage B Requirements:
 - 1. A stage B shortage shall be declared when the city manager determines that a ten percent (10%) reduction in potable water use is required.
 - Stage B compliance elements shall include the following mandatory elements:
 - a. Restaurants shall serve water upon request only;
 - b. All public restrooms in the city and private bathrooms in hotels shall no-. tify patrons and employees of water
 - conservation goals; c. Plumbing and irrigation leaks shall be repaired as soon as practicable. The city may issue notices to repair visible leaks;
 - d. Except for single family and multifamily residential users in Tier 1 who will remain in Tier 1 for the next billing cycle, all users shall reduce water usage to ninety percent (90%) of the amount in the baseline period as determined by the City Council.
 - 3. Except for single family and multi-family residential users in Tier 1 during the current billing cycle, a water penalty surcharge of up to two (2) times the basic water rate shall be charged for water usage in excess of ninety percent (90%) of the amount in the baseline period as determined by the City
 - 4. Violation by any person of the stage B mandatory requirements shall constitute an infraction and, upon convic-

tion, shall be punished by a fine not to exceed one hundred dollars (\$100.00). The violation of each element, and each separate violation thereof, shall be deemed a separate offense, and shall be punished accordingly.

C. Stage C Requirements:

- 1. A stage C shortage shall be declared when the city manager determines that a twenty percent (20%) reduction in potable water use is required.
- 2. Stage C compliance elements shall include the following mandatory ele
 - a. Restaurants shall serve water upon request only:
 - b. All public restrooms in the city and private bathrooms in hotels shall no-tify patrons and employees of water conservation goals;
 - c. Plumbing and irrigation leaks shall be repaired as soon as practicable. The city may issue notices to repair visible leaks:
- d. Except for single family and multi-family residential users in Tier 1 who will remain in Tier 1 for the next bill-ing cycle, all users shall reduce water usage to eighty percent (80%) of the amount in the baseline period as determined by the City Council.
- 3. Except for single family and multi-family residential users in Tier 1 during the current billing cycle, a water penalty surcharge of up to three (3) times the basic water rate shall be charged for water usage in excess of eighty percent (80%) and not more than one hundred percent (100%) of the amount in the baseline period as determined by the City Council. A water penalty surcharge of up to ten (10) times the basic water rate shall be charged for water usage in excess of one hundred percent (100%) of the amount in the baseline period as determined by the City Council.
- 4. Violation by any person of the stage C mandatory requirements shall constitute a misdemeanor and, upon conviction, shall be punished by a fine not to exceed five hundred dollars (\$500.00). Water supply through irrigation water services may be terminated for continued excessive use. The violation of each element, and each separate vio-lation thereof, shall be deemed a separate offense, and shall be punished accordingly.

D. Stage D Requirements:

- 1. A stage D shortage shall be declared when the city manager determines that a thirty percent (30%) or higher reduction in potable water use is required.
- 2. Stage D compliance elements shall include the following mandatory elements:
- a. Restaurants shall serve water upon request only;
 b. All public restrooms in the city and
- private bathrooms in hotels shall notify patrons and employees of water conservation goals;
- c. Plumbing and irrigation leaks shall be repaired as soon as practicable. The city may issue notices to repair vis-
- d. Landscape irrigation shall be restricted to selected days and times as determined by the city manager, unless such irrigation uses reclaimed wastewater;
 e. Refilling of swimming pools, spas or
- ponds shall be prohibited unless required for health reasons:
- f. Operation of water fountains shall be prohibited;
- Exterior washdown of buildings and washdown of vehicles shall be prohibited, unless:
 - (1) The washing is done on the immediate premises of a commercial car wash or commercial service station or with reclaimed wastewater: or

- (2) The health, safety and welfare of the public is contingent upon frequent vehicle cleaning, such as the cleaning of garbage trucks and vehicles to transport food and perishables:
- h. Water usage from fire hydrants shall be limited to firefighting, related activities or other activities necessary to maintain the public health, safety and welfare;
 Except for single family and multi-
- family residential users in Tier 1 who will remain in Tier 1 for the next billing cycle, users shall reduce water usage to seventy percent (70%) of the amount in the baseline period as determined by the City Council.
- 3. Except for single family and multi-family residential users in Tier 1 during the current billing cycle, a water penalty surcharge of up to four (4) times the basic water rate shall be charged for water usage in excess of seventy percent (70%) but not more than one hundred percent (100%) of the amount in the baseline period as determined by the City Council. A water penalty surcharge of up to ten (10) times the basic water rate shall be charged for water usage in excess of one hundred percent (100%) of the amount in the baseline period as determined by the City Council.
- 4. Violation by any person of the stage D mandatory requirements shall constitute a misdemeanor and, upon conviction, shall be punished by a fine not to exceed one thousand dollars (\$1,000.00). Continued excessive use may result in termination of water supply through irrigation water services and/or restriction of water supply through domestic meters. The violation of each element, and each separate violation thereof, shall be deemed a separate offense, and shall be punished accordingly."

<u>Section 3.</u> <u>Severability.</u> If any section, subsection, subdivision, sentence, clause, phrase, or portion of this Ordinance or the application thereof to any person or place, is for any reason held to be invalid or unconstitutional by the final decision of any court of competent jurisdiction, the remainder of this Ordinance shall remain in full force and effect.

Section 4. <u>Publication.</u> The City Clerk shall cause this Ordinance to be published at least once in a newspaper of general circulation published and circulated in the City within fifteen (15) days after its passage in accordance with Section 36933 of the Government Code, shall certify to the adoption of this Ordinance and shall cause this Ordinance and the City Clerk's certification, together with proof of publication, to be entered in the Book of Ordinances of the Council of this City.

Section 5. Effective Date. Ordinance shall go into effect and be in full force and effect at 12:01 a.m. on the thirty-first (31st) day after its passage.


