## COC members disagree on legal fees

The Citizens' Oversight Committee Legal-Ethics subcommittee's recommendation that the COC vote to admonish member Mary Weiss for publishing a letter regarding the Board's improper use of Measure E funds was tabled until a later date during the December 18th meeting.

"I support you and I think you've been wronged," said former Hawthorne teacher and COC member Craig Davis, addressing Weiss. "On what grounds does someone have the right to question you given that you're a citizen? I'm taking the layman's perspective."

Sections from Weiss' letter appeared in the *Weekly's* November 27th issue.

"Although the MTA litigation is not among the project expenditures listed on Ballot Measure E, the district has already expended approximately \$3 million of Measure E funds on MTA litigation," Weiss wrote. "The District and/or some or all of its Board members have asserted that the language of Measure E is so broad that it encompasses the expenditure of funds for MTA litigation."

The Legal-Ethics subcommittee met on December 5 to discuss the e-mail letter that Weiss had sent to media outlets and COC members in November about the expenditure of Measure E funds for Metropolitan Transit Authority (MTA) litigation being improper. Weiss was not able to attend the subcommittee meeting due to a court appearance.

"The letter being sent did violate the Public Comments Policy because of the manner in which it was styled, reference to certain code sections and that it indicated that the COC had discussed the manner in which Measure E funds should be used," said Legal-Ethics subcommittee Chair Jerid Maybaum. "And then it gave the inference—at least the Legal-Ethics subcommittee felt—that it was an opinion that was reached by the COC and that the COC had in fact concluded that the funds were either wasted or misused."

The supposed Public Comments Policy that Weiss' letter is believed to have violated does not appear anywhere on the BHUSD website. Administrative Assistant

Barbara Beach confirmed that the policy was not recorded in the August minutes. The policy is also not mandated by the State.

"If it's an official document it should be put on the website for transparency purposes," said COC member Isabel Hacker.

The Public Comments Policy was prepared by the Legal-Ethics subcommittee and brought to the full COC to be voted on during an August meeting. Its intended purpose is to prevent COC members' individual opinions from being misconstrued as opinions of the entire committee.

"I didn't intend for [the letter] to look like it came from the COC," said Weiss. "As soon as I found out that the COC—or several members of the COC—thought that it was misleading, or it looked like it was something officially authored or issued from the COC, I immediately went to the next board meeting and I explained that it was not the opinion of the COC. It's solely my opinion and it's solely an issue that I've been raising for several months."

Due to the uncertainty surrounding the Public Comment Policy's legitimacy, Maybaum and committee members decided to postpone the vote.

## Kate Mantilini Woodland Hills closing its doors

The last remaining Kate Mantilini location in Woodland Hills will be closing its doors following CEO Adam Lewis' unsuccessful attempt to negotiate a

less costly lease with landlord Douglas Emmett, according to the *LA Times*.

In his October interview with the *Weekly* in issue #784, Lewis mentioned that upgrades were being made to the restaurant's menu and seemed generally hopeful about the Woodland Hills branch.

"In Woodland Hills, we're seeing an increase in weekday customers, and we're seeing an increase in our happy hour as well, which bleeds into dinner," Lewis said in the interview.

Earlier this year in June, the restaurant's iconic Beverly Hills location shut down after 27 years because a new lease deal could not

be established. Lewis and his family were honored at the Maple Counseling Center's Masquerade Ball in October.

## Health and Safety Commission re-instates awards

The Health and Safety Commission continued its re-instatement of the Health and Safety Awards during a meeting on December 15.

The Commission decided over the span of two meetings that a Beverly Hills Community Health and Safety Award will be given to individuals who have made significant efforts towards fulfilling the mission of the Health and Safety Commission.

During the meeting last week, Commissioners discussed and considered three different options for the nomination process and how often the award will be presented. Option 1 involves monthly shout outs recognizing individuals who have made important contributions to the mis-

sion of the Health and Safety Commission. Option 2 also entails monthly shout outs, but it requires that a single individual then be chosen from those recognized to receive a final award. Option 3 only involves an annual award.

"I'm leaning more towards Option 3," said Commissioner Daniel Nazarian. "I believe that if we do it on a monthly basis, after two or three months it won't have the same affect anymore—after a while people will become immune to it."

Commissioner Gary Ross expressed support for Option 1, praising its ease, informality and continuity. Ross then proposed that a Commissioner be appointed every month to select an individual for recognition from the community's pool of nominees.

Option 1 received three votes, meaning the Commission will move forward with it during its January 2015 meeting. A Commissioner will take a leadership role every month and select the award recipient.

The Planning Commission of the City of Beverly Hills, at its REGULAR meeting on Thursday, January 8, 2015, will hold a public hearing beginning at **1:30 PM**, or as soon thereafter as the matter may be heard to consider:

A request for a Conditional Use Permit to allow the establishment of an educational institution (Futures in Education) within the commercial building located at **8484 Wilshire Boulevard**, at the southeast corner of the intersection of Wilshire Boulevard and La Cienega Boulevard. The proposed educational institution would occupy approximately 3,000 square feet of floor area on the second floor of the existing commercial building. The request would allow the educational institution to offer tutoring to students on a one-to-one basis. Pursuant to Beverly Hills Municipal Code §10-3-1604, educational institutions may be located in the C-3 zone of the City with the approval of a Conditional Use Permit.

This project has been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the environmental regulations of the City. The project qualifies for a Class 1 Categorical Exemption for operational changes within an existing commercial facility, and the project has been determined not to have a significant environmental impact and is exempt from the provisions of CEQA.

Any interested person may attend the meeting and be heard or present written comments to the Commission.

According to Government Code Section 65009, if you challenge the Commission's action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the City, either at or prior to the public hearing.

## BHPD reports increase in identity theft

Sergeant Max Subin of the Beverly Hills Police Department delivered a report on the City's crime trends for the month during the Human Relations Commission meeting on December 18.

"We've seen an increase in identity theft through the USPS blue postal boxes," Subin said. "I don't want to say we shouldn't use those boxes but our philosophy is that they should only be used in the morning time up until pickup."

According to Subin, residents have been noticing a sticky substance on the lid of the USPS boxes, applied to prevent the mail from dropping to the bottom of the box so that it can be easily stolen. Thieves will also "fish out" the mail using a device that they slip inside the postal box. These thefts always occur in the early mornings between 3 and 5 am.

Subin recommends that individuals use the USPS boxes from 6 am to 12 pm, so that their mail does not sit inside the containers

overnight, where the likelihood that it will get stolen is much higher.

Subin also reported that the BHPD has extended patrol hours to 8 pm in the Business District in response to complaints by restaurant owners about panhandlers. He suspects that the extended hours will continue until mid-January.

Vice Chair Ori Blumenfeld believes more needs to be done to combat the panhandling issue.

"I'm speaking from personal experience sitting outside—I don't think it's enough," Blumenfeld said. "I sit nightly at restaurants in the city and I patron restaurants on Beverly and Canon and I speak with business owners and I don't think enough is being done. Panhandling is a serious issue; during the holidays it's becoming a more serious issue."

Subin reported that there were no hate crimes this past month.

## Beverly Hills prospective host town for 2015 Special Olympics

The Recreation and Parks Commission discussed the Special Olympics World Games organizing committee's request for Beverly Hills to be an official host town for the World Games 2015 occurring in Los Angeles this summer during a meeting on December 16. Commissioners expressed general support for having Beverly Hills host 100 of the 7,000 participating athletes.

"A host town's responsibility is to host those athletes and give them the opportunity

"Something that was very moving [about the White House's Hanukkah celebration] was that after a short and powerful speech by President Obama, the candles were lit by Rabbi Angela Buchdahl of Central Synagogue in New York City. What was meaningful about that is that she is a Korean-American rabbi. I doubt that my parents and certainly my grandparents could have ever imagined something like that taking place."

Kliger also remembers the moment when guests began singing the classic Hanukkah song "Maoz Tzur," or "Rock of Ages."

"The sound of a Hebrew song filling the air in the White House was particularly moving and heart opening," Kliger said.

to be exposed to a variety of things within that respective community," said Director of Community Services Steven Zoet. "As the games actually occur they will then consolidate and be on campus at both UCLA and USC in the dormitory housing."

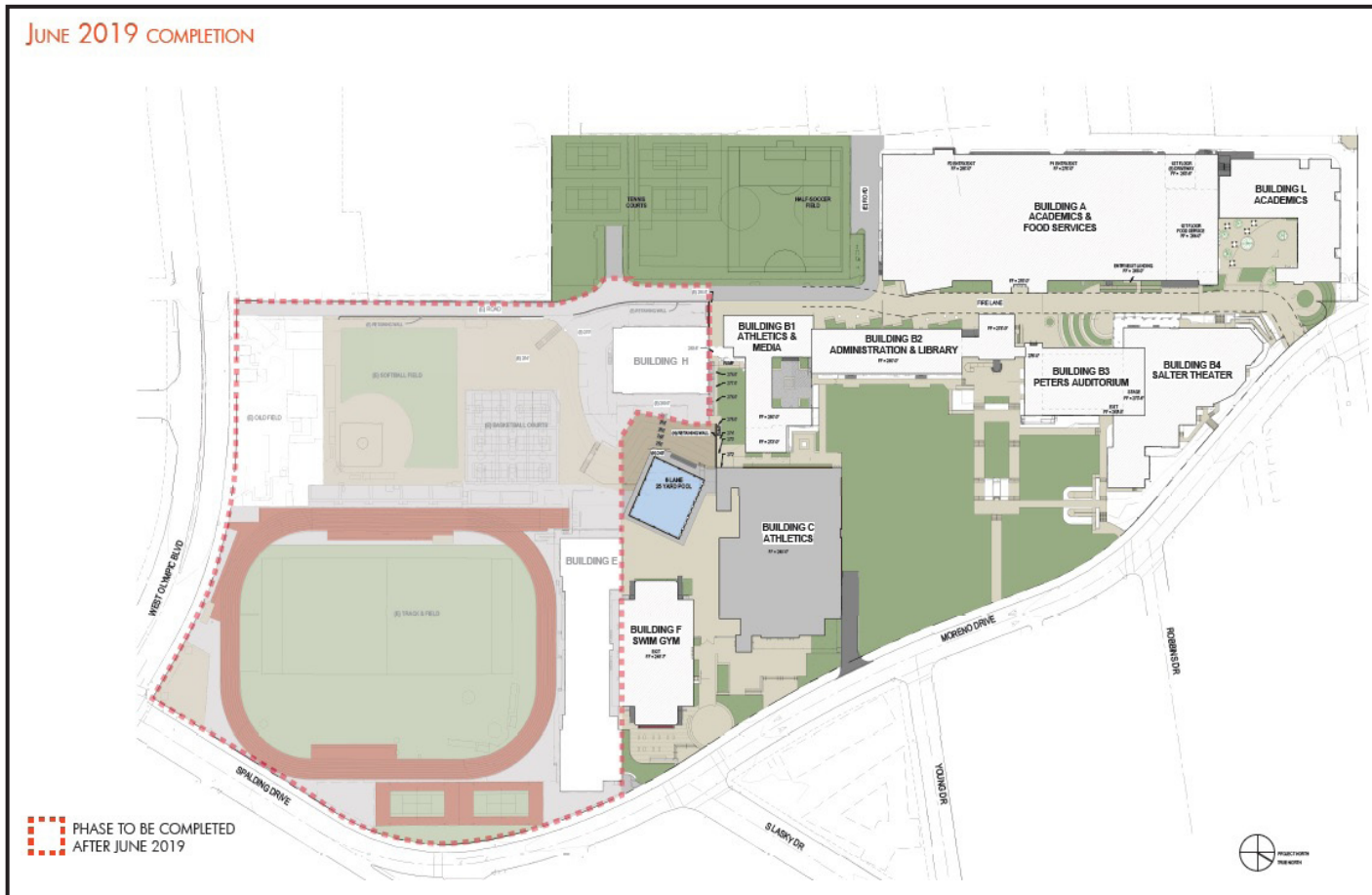

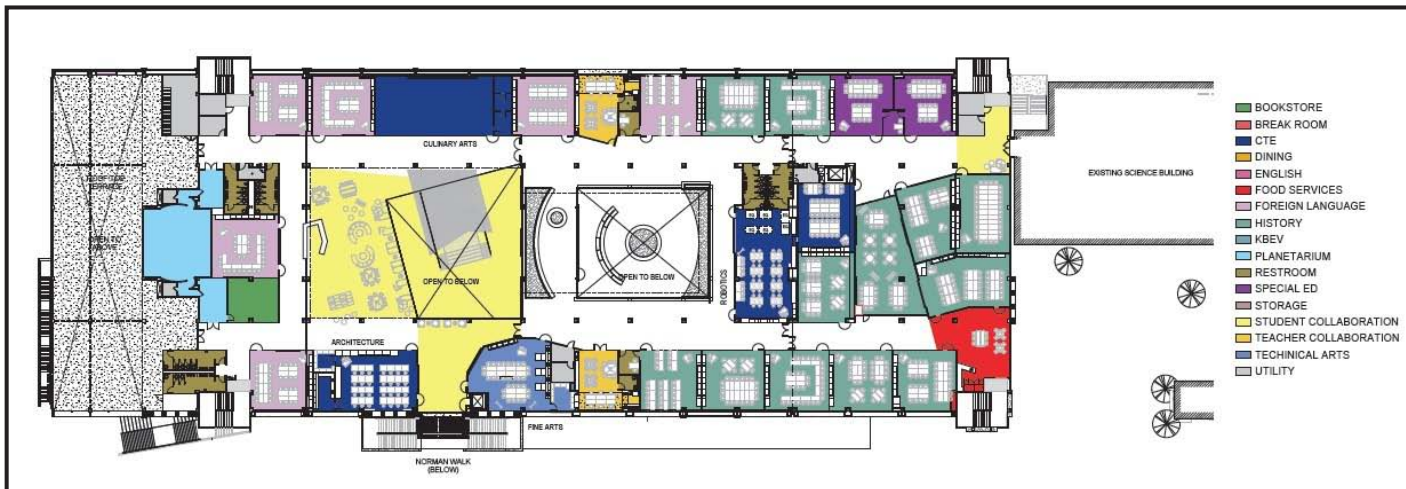

## Proposed Beverly High modernization schematics



The structural buildings are scheduled to be completed by 2019, and completion of CIF sized baseball, softball, track, and football fields are scheduled until after 2019. Projections are based on the Measure E bond being accelerated. The Board of Education has not set a date for acceleration.

According to Board of Education member Noah Margo, the proposed modernization plans are subject to future board and DSA approval.

"Everything now in my mind is conceptual," Margo said. "There are projected dates and projected concepts, but until you're actually approved by the DSA with the final plans nothing is final. It would be our hope that the projects move forward and the funding comes into place and everything can continue."

The projected completion date for the main buildings is June 2019, but that date is contingent on when the Measure E bond acceleration will be put to a vote. The Board of Education decided to not put the Measure E bond acceleration to a vote on the March 2015 ballot.

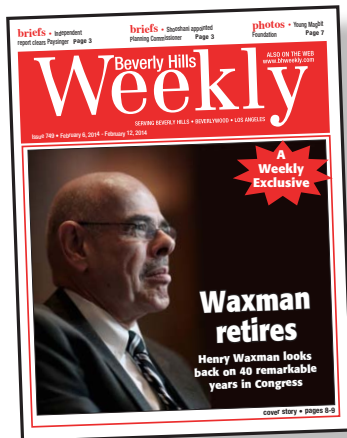


## “Centennial Sing-Along Celebration” [Issue 748, January]

Beverly Hills launched its centennial year with a Centennial Concert Sing-Along at the Saban Theater on January 28. The evening's songs were from Beverly Hills composers and songwriters. The LA Lawyers Philharmonic performed first, led by founder and conductor Gary Greene. Mayor John Mirisch later sang “Raindrops Keep Falling On My Head” and Betty White crooned the Beverly High fight song.

**Update:** The Centennial Concert Sing-Along was followed by a slew of events celebrating the city's 100-year anniversary. February marked the start of the Arts of Palm installation, which introduced the city to artworks by Brad Howe, Kenton Nelson

and Anne Shutan, among others. The Centennial Rose Planting, Hawthorne Centennial Spirit Day and Beverly Hills artSHOW also filled the Centennial Events Calendar. Planting of the Centennial time capsule will round out the festive year in late December.



## “Waxman Retires” [Issue 749, February]

Shortly after announcing his retirement in late January, Representative Henry Waxman (D-California) sat down for an exclusive interview with the Weekly in which he reflected on his 40-year career as a Congressman. Waxman passed a number of landmark legislation during his term, including the Clean Air Amendment in 1990, the Ryan White Care Act in 1990 and the Tobacco Control Act in 2009.

“I’m proud of all the bills that we have been able to pass,” Waxman said in his February interview with the Weekly. “Some are more momentous than others, but I think all of them are an example of how government can do important things that help the American

people.”

Los Angeles County Supervisor Zev Yaroslavsky also announced his retirement after 40 years in City and County government.

**Update:** In a December 16 interview in the *LA Times*, Waxman said he would like to spend his retirement years teaching, serving on corporate and non-profit boards and working on the issues he cares about. The lifelong Angeleno said he will be dividing his time between Los Angeles and Washington.



## “Metro ruling slams BHUSD” [Issue 758, April]

Los Angeles Superior Court Judge John A. Torribio ruled on April 2 that Metro conducted adequate environmental studies and provided substantial information in selecting a Century City station location. The proposed nine-mile Westside subway extension will cost approximately \$5.6 billion and is scheduled to open in 2035.

In his ruling, Torribio wrote that tunneling under Beverly High will not have an additional impact. The BHUSD claimed that Metro “lacked enough information to make an informed decision about the station location” and did not conduct a comprehensive Environmental Impact Report (EIR). Over \$700,000

was spent on legal fees regarding the Westside subway extension tunneling underneath Beverly High from April 2013 to December 2013.

**Update:** On December 11, Inglewood Mayor James Butts defeated Pam O’Connor for the Southwest Corridor cities on the Metro Board of Directors. According to Councilmember John Mirisch, Butts’ win means that transit issues affecting Beverly Hills, including the Westside subway extension, will be better addressed.



## “A Day in the Life of ‘Walk with the Mayor’” [Issue 759, April]

Mayor Lili Bosse was sworn-in as mayor in March, becoming the ninth woman mayor in the city’s 100-year history. Bosse launched a Walk with the Mayor program in an effort to improve the health of the city’s populace. The weekly Monday strolls start from the Crescent Drive side of City Hall.

“I want to say that people will have looked at this year and have felt that it was really positive [and] productive,” Bosse said in an April interview with the Weekly. “That people felt that we personally, within ourselves, got healthier and more balanced. That our business community became more robust and that our government, our city became more accessible.”

**Update:** Bosse’s Walk with the Mayor was profiled in an *LA Times* story on December 14. According to the article, Bosse’s exploratory jaunts throughout the city attract 100 to 200 participants every week.

“This mayor walks the talk and talks while walking,” wrote reporter Martha Groves.



## “Paysinger Sues BHUSD, Lewis Hall” [Issue 772, July]

In July, Beverly High Principal Carter Paysinger filed a lawsuit against the BHUSD and Board of Education member Lewis Hall on eight causes of actions including retaliation and discrimination. The first complaint was filed on July 12, 2013 concerning Hall’s threats to Paysinger and his family. A second complaint followed on January 30 alleging that the District ignored Paysinger’s complaint and that the District and Hall “had engaged in a continued and pervasive pattern of retaliation and racial discrimination.”

**Update:** U.S. District Judge Philip S. Gutierrez denied Hall’s first motion to dismiss Paysinger’s claim against him in October 2014. In December, after considering the pleadings and evidence submitted by both sides, the Court denied Hall’s anti-SLAPP motion to strike the California Labor Code 1102.5 retaliation claim against him.

The first deposition of the case took place on December 17 with former BHUSD assistant superintendent Alex Cherniss, who is now the San Marino Unified School District superintendent. Cherniss’ deposition did not conclude; the deposition will continue at a later date.

**“BHUSD legal fees for first quarter fiscal year exceed \$750,000” [Issue 786, October]**

For the first quarter fiscal year between July 1 and September 30, the BHUSD legal expenditures totaled



\$777,336.44 paid to various law firms. As reported in the Weekly's issue #778, legal fees totaled over \$2.8 million for the 2nd quarter of the calendar year 2014.

By contrast, Las Virgenes Unified School District—which has almost triple the number of students as BHUSD—reported legal fees that totaled \$676,000 for the entire 2012-2013 school year. This includes special education and general legal fees.

According to Chief Administrative Office LaTanya Kirk-Carter, the budget amount changes when the Purchase Order (PO) amount changes because the district committed to spend that amount of money, and should be changed in the report.

The Measure E fund has a purchase order amount of \$2,580,000, with a budgeted amount of \$640,000. The first quarter legal fees for the Measure E fund amounted to \$650,197.96.

**Update:** In early December, Curbed Los Angeles reported that the school board had commissioned the Beverly High television station to create three anti-subway videos collectively entitled *Why We Fight*. The videos, which feature Board of Education member Lewis Hall, have supposedly been produced entirely by BHHS students. BHUSD consultant Tim Buresh had a role in shaping the videos.

*The Weekly* recently requested copies of the fees that Buresh billed the District with regards to the three videos. As of press time, the District has not yet provided the requested information, stating that they require additional time to locate the documents.



**“EBI defaults on contract” [Issue 789, November]**

The BHUSD's campus security program, Evidence Based, Inc. (EBI), announced on November 6 that it will no longer provide services to the BHUSD campuses due to financial difficulties. The City Council approved to cover half of EBI's cost to the district for the 2014-2015 school year during a meeting on October 21, which would have been \$440,712 of the total \$881,423.

The BHUSD gave a notice of termination on November 4, and according to contract stipulations, EBI would have to continue providing its services for nine days after the notice. EBI officers vacated the campuses on November 5.

**Update:** The BHUSD is seeking to recover approximately \$128,000 from EBI for services not rendered after their termination. According to BHUSD Superintendent Gary Woods, there were three installation payments in the contract totaling to \$881,423.

“We are going to consider all of our options [to retrieve the cost],” Woods told the Weekly in November. “[EBI] is going to have to go through bankruptcy, so it's going to be connected to whatever they're doing on their end.”



**“Weiss criticizes use of Measure E funds for legal fees” [Issue 791, November]**

Citizens' Oversight Committee member Mary Weiss sent an e-mail letter to the press and COC members explicating why the BHUSD's use of Measure E funds on legal fees may be improper.

In her letter, Weiss pointed out that district has expended approximately \$3 million of Measure E funds on MTA litigation, even though MTA litigation is not among the project expenditures listed on Ballot Measure E.

Weiss mentioned the case of Taxpayers for Accountable School Bond Spending v. San Diego Unified School Dist in her letter, where expenditures for items not specifically stated in the ballot measure's project list are

unlawful.

Weiss, an attorney with 13 years of construction experience, had been raising the issue within the COC for several months.

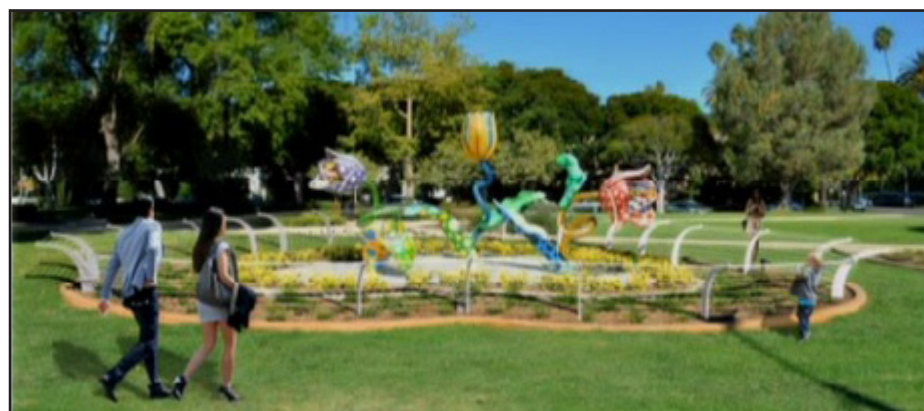
**Update:** The Legal-Ethics Subcommittee's recommendation last week that the COC vote to admonish Weiss based on her letter violating a Public Comments Policy was pushed to a late date after discussion of the policy's exact date of implementation revealed its origins to be shrouded in ambiguity.



**“March election canceled” [Issue 793, December]**

The March 3 election was cancelled after no candidates filed prior to the December 5 deadline. Mayor Lili Bosse and Vice Mayor Julian Gold were automatically reelected. The 1999 City Council race was also cancelled due to a lack of candidates.

**Update:** Bosse and Gold were each appointed for four-year terms last week.



**Fine Art, Recreation and Parks Commissions protect local art piece**

Fine Art and Recreation and Parks Commission members met with designer John Lavezzo at the Hymn of Life: Tulips by Yayoi Kusama sculpture in Beverly Gardens Park on December 5 to evaluate the design, placement and material samples for the proposed fence that would be installed around the perimeter of the piece in an effort to protect it from further damage.

Fine Art Commission Chair Sandy Pressman, Commissioner Carolyn Hiller, Recreation and Parks Commission Chair Howard Rosoff and Commissioner Susan Gersh were joined by department staff at the on-site meeting.

“We really did consider various proportions and took many elements into consideration and came back with recommendations,” said Gersh during the Recreation and Parks Commission special meeting on December 16.

There was a consensus among everyone present at the December 5 on-site meeting regarding the placement and style of the fence, which features a finer and less distracting cable. Due to the loss of perception that a finer cable causes, Risk Management will have to evaluate the revised design.

“Risk management always finds something wrong with whatever it is we're putting up here,” said Commissioner Robert Anderson.

The Kusama Tulips of Life sculpture is the first public outdoor sculpture in the United States by Japanese artist Yayoi Kusama and the first work of art commissioned by the Fine Art Commission. The piece was installed in September 2007.

As a next step, the Recreation and Parks Commission will work with the Fine Art Commission and the City Council to settle on a solution.



**Architectural Commission rejects Free People project**

Blaise Diroll, a representative from Urban Outfitters Inc., attended the Architectural Commission meeting on December 17 to request the approval of a façade modification, a construction barricade graphic, two business identification signs and a sign accommodation to allow a non-entry elevation sign to exceed 30 square feet for the Free People store on 370 North Canon Drive.

Wale Falade of NewStudio Architecture applied for architectural approval of the proposed changes on behalf of the property owner, 370 North Canon Drive LP, and the tenant, Free People.

The façade modifications include the removal of patterned awnings and the addition of glazed steel entry doors with side lights. Approval of the project will also result in the mounting of a 60 square-foot, halo-illuminated sign on the entry façade adjacent to North Canon Drive and a second 67 square-foot, halo-illuminated sign on the non-entry façade adjacent to Brighton Way. Both signs will read “Free People.”

Commission members expressed concern about the Brighton Way façade, which will be entirely stucco. Commissioner Gidas Peteris recommended adding a mural to the blank wall, which faces a neighboring restaurant's outdoor seating area and might detract from the vitality of the street.

“There's a lot of character inside,” said Commissioner Michelle Kaye of Free People stores. “It's not a clean, stark, minimalist feeling at all—it's got a lot of character. And this building is just the antithesis of what you really represent.”

An ad-hoc committee consisting of Commissioners Kaye and Peteris, AIA was formed to review the project with the applicant. The project will be revisited during the Architectural Commission meeting on January 21.

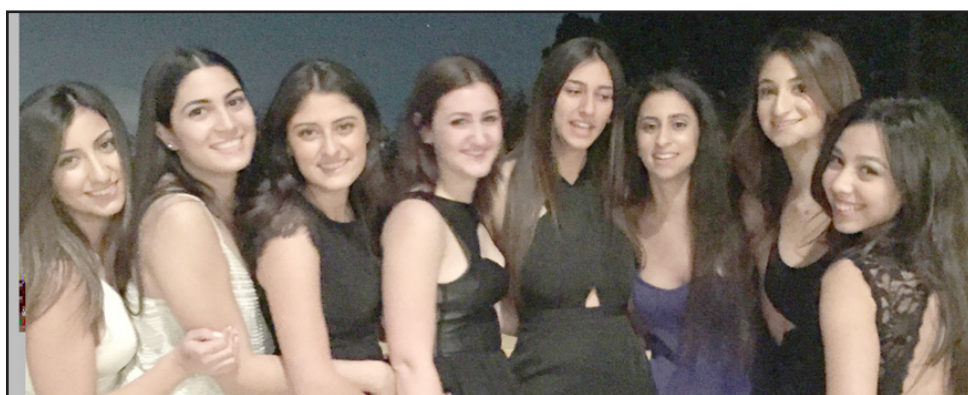

### LA City Atty: Nestdrop must stop delivering pot

Los Angeles City Attorney Mike Feuer announced Tuesday that Nestdrop, a medical marijuana delivery smartphone app founded by Roddy Radnia and Michael Pycher, must cease its pot delivery services.

“This app is a flagrant attempt to circumvent the will of the voters who passed Prop D and we are pleased the court ordered Nestdrop to stop facilitating medical marijuana delivery,” Feuer said.”

Judge Robert O’Brien granted a preliminary injunction against the business on the grounds that its pot delivery services violate Proposition D, a Los Angeles measure passed last year to regulate pot shops with the goal of minimizing their number in the city.

*The Weekly* profiled the Nestdrop founders in issue #780. Radnia—a 2007 Beverly High graduate—and Pycher created Nestdrop after noticing a lack of on-demand delivery services for specialty goods like liquor. The app, which can be downloaded for free through the iPhone App store and Google Play, delivers liquor, beer and wine in addition to marijuana.

Pycher told the *LA Times* that Nestdrop is merely a communication technology and does not handle or distribute the marijuana itself. The co-founder believes that Nestdrop should not be subjected to Prop. D regulations. According to Pycher, Nestdrop will continue delivering alcohol and is expanding to other cities.
