# Guilford Glazer, philanthropist and real estate developer, passes at age 93



Guilford Glaze

Guilford Glazer, a real estate developer and dedicated philanthropist committed to supporting Israeli universities, died in his Beverly Hills home on December 23. He was 93.

"Guilford was my mentor," said Councilmember Nancy Krasne, a friend of Glazer's for more than four decades. "He made me a better person because he made me think of all the intended and unintended consequences of any action that I took."

Born in 1921 in Knoxville, Tennessee, Glazer served in World War II before taking over his father's welding business and eventually renaming it Glazer Steel Crop. He later moved to Los Angeles, where he developed shopping centers, including Torrance's palatial Del Amo Fashion center in 1971.

A devoted philanthropist, Glazer established the Glazer Institute of Jewish studies in Nanjing, China and was the chief supporter of the business school at Ben-Gurion University.

Glazer is survived by his wife Diane, two children Emerson and Erika, and five grandchildren.

His memorial service was held at Wilshire Boulevard Temple on December 26.

# Omrani project approved by Design Review Commission

Developer Hamid Omrani's proposed design for a new two-story single-family residence located on 508 North Roxbury Drive received approval by the Design Review Commission during a meeting on December 4. The project was previously reviewed during meetings on September 4 and October 2. Omrani made substantial revisions to the initial model following the Commission's request for a redesign.

Omrani redesigned the roof, reduced the railing height and decreased the height of the formerly 5-foot ground floor door and windows to 4 feet.

"I am very impressed with the work that you've done," said Design Review Commissioner Susan Strauss. "I think that because it's such a beautiful house, if you were to get rid of the fences in the front that would make it a lot better."

Though Vice Chair Arline Pepp agreed the project would be an enhancement to the neighborhood, she also expressed disapproval of the front fence.

"I'm having a terrible time with the front fence," Pepp said. "And I think when you look at the elevation drawing of this front fence it is very tight, very conspicuous and I feel it doesn't look anything like what the rendering fence looks like with big spacing."

Chair John Wyka commended Omrani for producing a design vastly superior to what was previously presented to the Commission, but also disapproved the fence. Homeowners Farshid and Nahal Moossazadeh, parents of three young children, feel a fence creates a safe barrier between the front yard and the street.

The Commission unanimously approved the project on conditions that every one-gallon plant be increased to at least five gallons and the height of the front fence be reduced to 36 inches. A planting bed will also have to be integrated into the fence.

Relieved to have reached the end of a lengthy process, Farshid Moossazadeh thanked the Commission for their involvement and recommendations.

# Architectural Commission conditionally approves EH National Bank signage

Raffi Varozian of Ampersand Contract Signing Group requested the approval of a sign accommodation for multiple building identification signs for the EH National Bank located on 8484 Wilshire Boulevard during an Architectural Commission meeting on December 17. The Commission decided during an October 15th meeting that the project required further refinement.

The project would result in the addition of two 39 SF, internally illuminated signs. One sign would be mounted on the building façade located on Wilshire Boulevard and the second sign would be mounted on the building façade located on La Cienega Boulevard. Both signs would read "EH National Bank." The previous proposal included one building identification sign located on the building facade nearest the Wilshire and La Cienega intersection. Commissioners believed this created a cluttered aesthetic.

"I am not happy with the energy between the E and the H pushing the back panel, creating no negative space," said Commissioner James Blakeley, III. "That's my biggest problem."

As stated in the Beverly Hills Municipal Code (BHMC), the Architectural Commission may approve a sign accommodation to permit multiple building identification signs as long as the total signage area does not surpass 2% of the vertical surface area of that elevation, excluding penthouse walls.

Based on the EH National Bank building dimensions, the maximum building identification sign area is 1,720 SF. The two existing signs located at the top of the building are each 168 SF in area, totaling 336 SF. The proposed signage would increase the overall area to 414SF.

"I really don't think the sign will work particularly well sitting at the CORT elevation only because it's probably going to be somewhat obstructed," said Commissioner Gidas Peteris, AIA. "And from a humanscale perspective, as you start walking up,

The Planning Commission of the City of Beverly Hills, at its REGULAR meeting on Thursday, January 8, 2015, will hold a public hearing beginning at 1:30 PM, or as soon thereafter as the matter may be heard to consider a request to allow the construction of a new 20-unit multi-family residential building located at <u>425-429 North Palm Drive</u>. Construction of the proposed project requires the following entitlements:

**Development Plan Review.** A Development Plan Review is required for all new multi-family residential projects. The subject project is located at 425-429 North Palm Drive, at the intersection of North Palm Drive and Beverly Boulevard. The proposed 5-story multi-family residential building would have a maximum height of 55' measured to the roof deck, with a 10' tall canopy covering the central area of the roof deck. The building would have a footprint of approximately 10,350 square feet with a total floor area of approximately 55,090 square feet. The building would have a setback of 25' from North Palm Drive, 13' from Beverly Boulevard, and 10' setbacks from the adjacent building to the north and from the alley to the rear.

**Zone Text Amendment.** The project includes a request to amend portions of the Beverly Hills Municipal Code. The proposed Zone Text Amendment would amend BHMC §10-3-2806E.3.b. and §10-3-2850 to allow deviations, through an R-4 Permit application, from code provisions that require a specific percentage of the front façade of the first two stories of large-scale multi-family residential projects to be built to the front setback line.

**R-4 Permit.** The proposed project includes a request for an R-4 permit to allow for the construction of two rooftop bathrooms associated with a rooftop swimming pool/spa. The R-4 Permit would allow the bathrooms to have a maximum height of 10' when measured from the adjacent roof deck. Additionally, the R-4 Permit would allow for additional paving within the front setback equivalent to one, five-foot walkway in per fifty feet of frontage along the front lot line. Finally, an R-4 Permit is being requested pursuant to the abovementioned Zone Text Amendment to allow less than 60% of the front façade of the first two stories to be built to the front setback line. This provision is contingent upon the approval and implementation of the proposed Zone Text Amendment.

This project has been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the environmental regulations of the City. The project qualifies for Class 32 and Class 5 Categorical Exemptions. The exemptions are applicable to projects characterized as in-fill development, as well as minor changes in land use limitations such as the amendment to the zoning code to allow an R-4 Permit to alter the front façade requirements, and the project has been determined not to have a significant environmental impact and is exempt from the provisions of CEQA.

Any interested person may attend the meeting and be heard or present written comments to the Commission.

According to Government Code Section 65009, if you challenge the Commission's action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the City, either at or prior to the public hearing

# Giving Thanks update: Angelina Mattos remains hopeful

Angelina Mattos' ongoing and inspirational recovery from a 15-hour surgery that resulted in the removal of her tongue was profiled in the *Weekly*'s Thanksgiving installment, issue #791. Prior to the October operation, Mattos had been diagnosed with Squamous Cell Carcinoma, an oral cancer. Her sister Darlene Rodrigo updated the *Weekly* on Mattos' condition Tuesday, two months after the surgery.

"Right now Angelina is undergoing her fourth week of treatment and the symptoms from all the radiation treatments that she's been receiving daily as well as the chemotherapy treatments that she's been receiving biweekly are really taking a toll on her," Rodrigo said. "She's lost nearly 50 pounds in the past two months and she's very weak and extremely irritable, especially when it comes to anything involving her mouth, inside and outside. She's experiencing an extremely dry mouth with very thick saliva that is causing her to choke and her skin on the outside is extremely dry and irritated."

In her November interview with the *Weekly*, Rodrigo mentioned that Mattos' insurance company was not covering the costs of her feeding formula. Mattos had to privately pay around \$500 a month for the nutrient-providing formula. According to Rodrigo, recent donations have covered the costs for approximately six months.

"Angelina is going through the worst type of symptoms and signs," Rodrigo said. "Everything has hit her and it will continue to get worse for the next three weeks but she has her mind set on finishing this treatment and continuing with her life. Right now she is pretty much just suffering but she remains hopeful and is trying to stay as positive as she can be."

The project had been previously reviewed at a November 6th meeting, during which the Commission advised applicant Farzin Maly of Maly Architects to restudy the project because it necessitated further refinement.

The applicant responded to the Commission's comments and made a number of changes. The width of the entry columns was reduced, the lower façade window was raised to 18" above the slab and the entry door was revised to a wrought iron door with a simpler design.

"We would like to thank you for your suggestions," said homeowner Matthew Bahrami. "We feel like the changes made our overall design better. This house looks better than what we had originally."

Though both Vice Chair Arline Pepp and

Commissioner Ilene Nathan appreciated that the project had been simplified, they called for a more definitive landscape plan.

"I appreciate you responding to all of our comments at the last meeting, especially regarding the iron work in the front of the house," said Nathan. "I still feel that the land-scaping needs to be addressed—needs to be a little bit more in front of the house. To me it just looks a little bare."

Commissioner Susan Strauss commended the applicant for not erecting a fence around the house. None of the other homes in the neighborhood have fences.

The project was unanimously approved by the Commission based on conditions that a rectangular inset panel is inserted above the entry door and the landscape plan is revised and clarified.

# Hunter and Hounds to become Veterans' War Memorial

The Fine Art Commission discussed an initiative presented by the Veterans' Memorial Committee to transform Hunter and Hounds at Beverly Gardens Park into a formal Veterans' War Memorial during a meeting on December 18. The Committee has been working with the Friends of Beverly Gardens Park, a group dedicated to restoring the century-old public park that runs along Santa Monica Boulevard.

The proposed changes include the removal of shrubbery surrounding Hunter and Hounds and the addition of an enclosure built around the sculpture. Four benches would be placed near the statue and a planter would be added to the centerpiece. The finished work would also feature the seals of the five different military branches. Residents have proposed slightly raising Hunter and Hounds so that it can become more visible from Santa Monica Blvd.

"Has anyone considered the safety of raising this piece?" Chair Sandy Pressman asked. "Do we need somebody to take a look to see if ultimately—if they want to raise it 18"—that it can be done safely?"

Assistant Director of Community Services Nancy Hunt-Coffey recommended waiting to address the potential problems associated with raising the piece once the decision has been finalized.

The proposed improvements will be funded by an anonymous donor's verbal pledge for approximately \$400,000. The assumption is that the donated amount will cover the renovation costs.

Hunter and Hounds was unveiled at the Longyear estate on Beverly Drive on November 11, 1925 and was later donated to the City. For many years, memorial services were held there each armistice day. The bronze sculpture was produced by French artist Henri Alfred Marie Jacquemart.

Commissioners expressed general support for the projected modifications, with Commissioner Alan Kaye calling it "exciting" and Pressman saying it's a "lovely idea."

The proposed reconfiguration has already been endorsed by the Recreation and Parks Commission and the City Council liaisons. It is now scheduled to go before the entire City Council during a Study Session meeting on January 13.

# Residents discuss La Cienega Park renovation plans

Residents and patrons attended the first-ever community meeting for La Cienega Park & Community Center on December 10. Mayor Lili Bosse, Recreation and Parks Commission Chair Howard Rosoff and Assistant City Manager Mahdi Aluzri joined more than 50 others to address the renovation plans for the public park located at 8400 Gregory Way.

Meeting attendees discussed the playground, tennis center, picnic area and landscaping, among other topics. The most popular topic of discussion during the community meeting was "other amenities," which encompasses outdoor event space, increased parking, security and cameras, bike paths and improved drinking fountains.

Though not in attendance at the December 10th gathering, Councilmember John Mirisch believes the park facilities are in need of upgrades.

"I think we want to look at a whole master plan; not only the park itself but the tennis courts as well," Mirisch said. "We need to take a good long look at what we can do to improve it long-term."

AJ Willmer, a member of the Southeast Task Force, also believes in expanding development plans to include the tennis center, which currently features 16 lighted courts, showers, locker rooms and a pro-shop providing tennis instruction.

"I'm concerned that we are going to look at the development of La Cienega Park in isolation and not really plan it into a general plan for the southeast of Beverly Hills," Willmer said. "I think we need to look at the tennis center—the west side of La Cienega along with the park on the eastside as one project. I think that requires us to decide whether we can afford to and whether it's appropriate to put a bridge across La Cienega—it's already been talked about several times."

Willmer would also like to see more attention given to adult recreation at La Cienega Park, noting that the matter was poorly addressed at Roxbury Park. According to Willmer, adults need indoor and outdoor court space. The issue of a large-enough gymnasium did not carry forward at Roxbury, which has four tennis courts, one full basketball court and one half-court; the half-court shares court space with the tennis hitting wall.

The impact of the anticipated Wilshire/La Cienega subway station on La Cienega Park will also require deliberation, Willmer mentioned.

La Cienega Park opened in 1928, followed by the Community Center's establishment in 1981. The City Council expressed interest in renovating the park and community center earlier this year. For the next few months, the City will be soliciting feedback from residents in order to best determine the community's vision for the park and community center.




