



State Senators Allen and Pan introduce legislation to end vaccine exemption

State Senators Ben Allen (D-Santa Monica) and Richard Pan (D-Sacramento) introduced legislation on Wednesday that

"The high number of unvaccinated students is

jeopardizing public health not only in schools but in the broader community," Allen said in a statement. "We need to take steps to keep our schools safe and our students healthy."

Under California's personal belief exemption, parents may choose to opt their child out of school vaccine requirements that bi-partisan legislative majorities passed to protect students. Pan, who is also a pediatrician, authored a measure in 2012 that requires parents who exempt a child from school vaccinations to talk first with a licensed health care practitioner about the impacts to their child and the community.

In the law's first year, 20 percent fewer parents used the personal belief exemption.

According to a database provided by the Los Angeles Times last month, two Horace Mann kindergartners, seven Hawthorne kindergartners and three El Rodeo kindergartners were exempted from vaccines because of a parent's personal beliefs in the fall of 2014. No Beverly Vista kindergartners were exempted from vaccines.

California will join 32 other states that don't allow parents to opt out of vaccination requirements using a personal belief exemption if this legislation is passed.

Council will not move forward with Baccarat chandelier acquisition

City Councilmember John Mirisch requested that the Council consider acquiring the Baccarat chandeliers that appeared on Rodeo Drive as part of the City's 2014 Holiday Décor Installation at the Study Session meeting on Tuesday.

"It seems to have been a very popular installation," Mirisch said. "We don't have to have something new each year—we just have to have something great. And this is great. I think the Rodeo Drive Committee supports this idea as well. Having Baccarat chandeliers on Rodeo Drive is a very special kind of event."

Although the display's 16 crystal chandeliers total \$520,000, the total purchase cost is \$610,000 due to infrastructure expenses related to poles and storage boxes. The annual cost of installing, maintaining and storing the chandelier display is \$205,000. Baccarat believes the chandeliers will last approximately 20 years.

"Councilmember Mirisch, just to save you, there isn't support so I think we should move on," said Mayor Lili Bosse, who cited budgetary concerns.

Luxury retailer GEARYS of Beverly Hills originally sponsored ten chandeliers and Baccarat covered the cost of the remaining six. Ten years ago, Baccarat purchased the poles and boxes that support the chandeliers for \$250,000. Based on depreciation, Baccarat has offered to sell the equipment to the City for \$50,000. The City will also need to purchase 16 new plexi glass display boxes and eight base boxes, estimated to cost a total of \$40,000.

The 2014 citywide holiday décor program, which included Rodeo Drive and other commercial areas, required an investment of \$1,027,260 and was funded through the Tourism and Marketing budget and CIP no. 854 Southeast Enhancements.

"I think it's a big mistake," Mirisch said. "I suggested that the Baccarat chandeliers were a homerun and Dr. Brien said they weren't just a homerun—they were a grand slam. I agree. The fact is, if we can hit a grand slam each year on Rodeo Drive—which is certainly one of the focal points of our holiday celebration—why wouldn't we do that? It's good to establish some unique traditions that help define who we are as a city."

The 16 chandeliers are currently being stored at GEARYS.

Four COC members to term out in June

The Planning Commission of the City of Beverly Hills, at its regular meeting on Thursday, February 12, 2015, will hold a public hearing beginning at **1:30 PM**, or as soon thereafter as the matter may be heard to consider:

AN ORDINANCE OF THE CITY OF BEVERLY HILLS AMENDING THE BEVERLY HILLS MUNICIPAL CODE TO EXPAND THE IN-LIEU PARKING PROGRAM

The City's in-lieu parking program currently allows owners of properties located within the Business Triangle that meet certain criteria to pay into the City's inlieu parking fund rather than provide all required parking spaces on-site. The proposed Ordinance would amend Article 33 of Chapter 3 of Title 10 of the Beverly Hills Municipal Code to add areas along five commercial corridors as additional districts that qualify for participation in the City's existing in-lieu parking program. The additional areas consist of:

- The area consisting of properties that front on, or have a street side lot line adjacent to South Beverly Drive north of Olympic Boulevard and south of Wilshire Boulevard, including the properties facing Olympic Boulevard between South Beverly Drive and El Camino Drive and the properties facing Olympic Boulevard between South Beverly Drive and Reeves Drive.
- The area consisting of the properties that front on, or have a street side lot line adjacent to South Robertson Boulevard north of Whitworth Drive and south of Wilshire Boulevard,
- The area consisting of the properties that front on South Santa Monica Boulevard west of Wilshire Boulevard and east of Moreno Drive,
- The area consisting of the properties that front on, or have a street side lot line adjacent to Wilshire Boulevard west of San Vicente Boulevard and east of Crescent Drive, and
- The area consisting of the properties that front on, or have a street side lot line adjacent to Olympic Boulevard west of Robertson Boulevard and east of South Rexford Drive, including the three commercial lots on each side of Doheny Drive that are north of the intersection of Doheny Drive and Olympic Boulevard, and the two commercial lots on each side of Doheny Drive that are south of the intersection of Doheny Drive and Olympic Boulevard.

This Ordinance has been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the environmental regulations of the City. The adoption and implementation of the Ordinance is eligible for a class 5 categorical exemption for minor changes in land use limitations and will not have a significant environmental impact. Accordingly, the Planning Commission will consider the recommendation to find the Ordinance exempt from the environmental review requirements of CEQA pursuant to Section 15305 of Title 14 of the California Code of Regulations.

Any interested person may attend the meeting and be heard or present written comments to the Commission.

According to Government Code Section 65009, if you challenge the Commission's action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the City, either at or prior to the public hearing.

BHPD provides recruitment update

T h e Beverly Hills Police Department received 2,632 applications for the police officer position Fiscal Year 2013/2014. Five candidates, 0.2% of the

applicant pool, were ultimately hired by the City.

"One of the messages that I wanted to communicate to the Council is that we do have a lot of applicants, but we'd like to get more qualified applicants," said Division Commander Erick Lee at the City Council Study Session on February 3. "Every agency in this region is competing for that same group of people."

Lee provided Councilmembers with a detailed breakdown of the applicant pool. Of the 2,632 applicants, 67 submitted an incomplete application; 166 did not meet the minimum qualifications; 148 withdrew from the process or did not confirm their appointment for the written exam; 1,518 did not show up to the written exam; 483 failed the written exam; 132 failed the physical agility test; 102 failed the oral interviews; 11 failed the background and clearance process. Five applicants were hired.

"When you have 87% of the people failing the oral interview after they've passed the written [exam] and the physical [agility test], I think one has to begin to look at the oral interview process and understand exactly what's going on in that process," said Councilmember Willie Brien. "That's a high failure rate."

Comparatively, the City of Burbank received 2,277 applicants and hired 9 for a hiring rate of 0.40% for Fiscal Year 2013/2014.

The City requires its police officers to have an Associate's Degree or complete at least 60 college units by the end of their probationary period.

Beverly Hills completes biennial homeless population count

City staff, police officers and volunteers documented 29 homeless in dividuals within Beverly Hills' six census tracts during a onenight count of the City's

homeless

population that started at 8 pm on January 28th and lasted until 1 am on January 29th. The 44-person team also counted one camper, one car and three-make shift shelters.

According to Human Services Administrator Jim Latta, since joining the Greater Los Angeles Homeless Count in 2009, the City has observed a reduction in the local homeless population. In 2009, the count documented 42 homeless individuals; in 2011 that number dropped to 37

Through the City's social service net, nine individuals who previously lived on the streets now live in permanent supportive housing.

Fine Art Commission rejects sculpture-acquisition proposal

Fine Art Commissioners considered a proposal by Diane Rosenstein and Jerry Magnin, Chairman of the Board at the Wallis Annenberg Center for the Performing Arts, that the City purchase the Roy Lichtenstein sculpture Coups de Pinceau from the Roy Lichtenstein Foundation, so that it may remain at its current location, on the northwest corner of Little Santa Monica and Crescent.

Rosenstein's brother Arnie Rosenstein is Vice Chairman of Operations at the Wallis Annenberg Center.

"[The Roy Lichtenstein Foundation] has given me a truly extraordinary and unique opportunity to offer this sculpture to the City on extremely privileged terms, discounted terms and on a long-term payment," said Rosenstein, who represented both the Foundation and the Wallis Annenberg Center at the meeting.

According to Rosenstein, the asking price for the sculpture is \$6 million. The Foundation has suggested a multi-year loan to have Coups de Pinceau sited at its current location.

"When we got the sculpture on loan the price was \$11 million," said Magnin. "So it's already been discounted by \$5 million."


Commissioner Alan Kaye wondered whether the Wallis Annenberg Center had considered entering a joint venture with the City, pointing out that a substantial amount of the Fine Art Commission's funds, totaling around \$2.5 million, have already been committed to other proj-

"My concern is this is more money than we have every looked at," said Vice Chair Brenda Potter. "We would be projecting what we take in, which we can't do. We would be basically bankrupting our fund. There are just a lot of concerns."

Commissioner Carolyn Hiller agreed, stating that it is not appropriate for the commission to spend money that it does not possess.

"Of course Roy Lichtenstein meets the Fine Art criteria—he would meet the Fine Art criteria for any city in any place," said Chair Sandy Pressman. "It really isn't an issue of liking it or not, or endorsing it. We didn't select it, it wouldn't matter. It's beautiful, it's a Roy Lichtenstein and we're proud to have it in the City. I am not sure if the Fine Art Commission has the ability—we don't purchase art at this price point. We have a fund but we don't borrow money from the City. As far as I know, we have never borrowed money, nor have they given us money."

Due to the fiscal obligation associated with purchasing the sculpture, the commission unanimously agreed to not pursue acquisition of the art piece.

istics. Though Psomas also considered the Hollywood Basin, the Central Basin offers better production capability.

"We're proposing that you look at a 25% independence [from MWD]," Gobas said. "To do that will involve getting your treatment plant back up and running where it's capable of producing or treating about 1 MGD of flow-that equates to 1,120 acre feet (AF) per year. You would also be looking at bringing in approximately 1,700 AF of new water from other sources."

The commission voted unanimously to proceed with financial analysis of the water portfolio scenario presented by City staff

Based on the City Council's instruction, the commission would need to solidify a recommendation for the Council's consideration no later than March 12, 2015.

Public Works Commission moves forward with Water **Enterprise Plan**

The Public Works commission continued its discussion of the Water Enterprise Plan during a special meeting on January 22 with engineering firm Psomas that lasted three hours. Chair Ron Shalowitz scheduled the special meeting at the January 8th hearing.

"Today's objective is to create scenarios," said Assistant Director of Public Works Services Trish Rhay.

A "scenario" refers to any combination of the nine water supply alternatives that could potentially become the City's water portfolio. Upon selection of a scenario, the commission will enter Phase 3 of the process: financial analysis.

The nine water supply alternatives are the Metropolitan Water District (MWD), water banking, conservation, groundwater - develop Central Basin (CB) wells, conservation, drought insurance, potable water exchanges, ocean desalination and groundwater - develop Hollywood Basin (HB).

The purpose of the Water Enterprise Plan is to create a planning document that identifies the options that make up the City's water supply portfolio and pinpoints strategies for achieving a more reliable water supply. Several factors including cost, risk and system reliability are evaluated with consideration of the different alternatives.

At the meeting, Psomas Vice President Harvey Gobas presented a water portfolio scenario for the commission's consideration which encompassed the following four alternatives: Metropolitan Water District, water banking, groundwater develop Central Basin wells, and conservation - comply with SBx7-7 and a tailored program for unique City character-

Architectural Commission approves salon redesign

During their January 22nd meeting, Architectural commissioners considered a request by hair salon Farro for a façade remodel, business identification sign and construction barricade. The renovations would be made to the existing George Michel hair salon on 9845 South Santa Monica Boulevard. Architectural firm Milan Lojdl is the project agent.

"It's a very clean contemporary look that you've designed," said Commissioner Michelle Kaye to project architect Babak Azimi, who attended the meeting last week.

The salon would be remodeled to feature a white stucco facade with an angled cut-out directly above the entrance, a polished aluminum storefront system with clear gazing and a polished aluminum door handle and kick plate. A kick plate is a protective plate fixed to the bottom of a door or cabinet.

One 6.3 SF non-illuminated sign in a polished aluminum finish reading "Farro" will be mounted directly above the entrance.

A construction barricade with signage is also being requested. According to the Beverly Hills Municipal Code 10-4-612, construction barricades may include 12 SF of signage that features the business name, company logo and the opening date of the business.

An ad hoc committee consisting of City Staff and Commissioners Kaye and Gidas Peteris will review the façade illumination after its installation to determine whether it achieves the desired light spread.

The commission unanimously approved the project under the following conditions: the architectural plans shall be revised to indicate a polished aluminum material for the storefront system and business identification sign; the storefront shall be recessed from the front façade to obtain appropriate shadow casting and a parapet detail shall be provided to City

STOP CRIMES AGAINST CHILDREN

COVERSTORY SNOWDEN SETS THE RECORD STRAIGHT

The *Weekly*'s exclusive with Chief Dave Snowden By Mina Riazi

Chief Dave Snowden addressed the EBI school security controversy in an exclusive, on-the-record interview with Beverly Hills Weekly.

How did EBI first approach you and how did that relationship first start?

One of my employees, Lieutenant Mark Miner, approached me about having outside employment with EBI. At that time, EBI was doing - as I understand it - work in Riverside [County] with the court system for processing or vetting out potential foster parents as ordered by the court. They wanted to venture out into other avenues having to do with law enforcement, outsourcing. And Mark Miner asked me if he could go to work helping them form a unit to do forensic investigations-computers, digital cameras, cell phones, that kind of thing. So Mark said that they really liked the concept that we had of a task force but we couldn't take on any more clients because we were too busy. So their concept, under Mark, was to have a bunch of experts that work for EBI that could be farmed out to different agencies. They would go work that case onsite so the evidence would be maintained and then they would give them the evidence for the court and then leave. Then they would come back to testify how that was obtained. So I approved Mark. And then Mark came back to me and said, "You know, I told them about some of your ideas and he'd very much like to talk to you." And I said, "Fine, set it up." I went and had coffee with him and he approached me about going to work as a consultant with the very things that you read in here— I don't have to reiterate it. Well I said, "Write it up and let me see it." He wrote it up—that's what I have here. I said I can't start doing this until I get approval from my supervisor. I'm going to do that, I'll submit it. I did that in around April 2013. I got it back from [City Manager] Jeff [Kolin] in June, which would have made that effective and I went to work as a consultant

You were retained at \$2,500/month flat fee. You did not receive any portion of profit, you were a flat-fee consultant?

We discussed a moment ago that it's standard in other cities that other chiefs do have consulting agreements?

That's correct.

And so in entering in this agreement there was nothing unusual about it because, again, other chiefs have done it and your City Manager had approved it?

That's correct.

At what point did you realize that we were going to have a problem with EBI in terms of the school district?

When they started going bankrupt. I heard about all the stuff going down and I went to Mark and I said, "Hey, we've got to regroup here because if they're not going to be on campus then we need to make sure our schools are safe." In fact, I heard not from John but I heard it from Joe Chirillo.

When the school board retained them and paid them that front fee that was between the school board and EBI. You weren't involved in those discussions?

Absolutely not involved. Anybody here can tell you that.

You have close to 50 years in law enforcement next year and we want the readers to know that you don't feel this in any way influences your career or any of the contributions you made to Beverly

Hills just because school board got involved with a bad deal?

That's exactly right. I want to make sure that your readers know that if I have created the impression that there was a conflict of interest by maintaining that relationship [with EBI] I humbly apologize for that. Because that was not my intention.

I don't think a lot of us think you jeopardized your career for a \$2,500/month consulting arrangement.

I don't think so.

We personally saw that you had the approval of your supervisor, [City Manager Jeff Kolin]. That's right.

Do you think the school board or anybody else should retain a different security firm? What do you think is the solution to this?

First of all, I want to tell you that in my humble opinion, Jeff Kolin and the work he does as a City Manager here, if he would have perceived this to be a conflict

would have perceived this to be a conflict of interest—and he was seeing what was going on— he would've told me to drop it. He was a hands-on manager, there's no way he would have let me continue that if he viewed my integrity was going to be impugned or if he thought there was a problem with it. It wouldn't have happened.

One of the issues that came up this morning is that I attended a liaison meeting with our City Manager- I don't know if he was there, it's just what's on the list-[Community Services Director] Steve Zoet and [Mayor Lili Bosse] and [Councilmember John Mirisch] and we talked about campus security and in that they were asking the City how to subsidize the schools. In that meeting, and I really don't remember a lot about the meeting, but apparently there was a recommendation to add from EBI a second security officer at the schools. And apparently I either made the recommendation or said that after listening to the conversations. The reality was, I

was no longer employed with EBI.

That was July 24th; my last day with them was July 1st.

So by that time your agreement was over, it was not renewed and you did not receive any additional consulting fees?

mentioned you had the best experience here and the proudest aspect of your career is working for Beverly Hills. Can you address that briefly?

I applied here in 1985 and was offered the job by the City Manager. The Council intervened and they appointed another gentleman, [Marv Iannone], who was Chief here for 18 years and did a phe-

nomenal job. He set a lot of things in motion that I was able to pick the baton up and move with. It didn't take me very long to realize— after some minor adjustments in management—that this is the finest police department ever claimed to wear a badge and I mean that. And I've been the president of every organization in California that matters: California Police Chiefs, LA County Police Chiefs, Orange County Police Chiefs and on and on, where I've had first-hand experience of dealing with every level of police officer from the ground level up. I've been on the panel to select no less than 35 police chiefs in the state and I couldn't even tell you how many lower ranks. And the entire quality of the officers in this City is light-years ahead of what any neighboring community has—and I believe that.

It makes me very proud to walk out and stand in front of these men and women that serve this community. We have a response time that is under three minutes for emergency calls—it's unheard of anywhere. When I go out on the street and hear from our community members on a daily basis about how proud they are, about how every officer treats them with courtesy and respect and compassion— whether it be from losing a child or missing a cat or recovering a stolen dog or having a birthday party where officers go out and shoot hoops with the guys and the kids to attending events for seniors citizens and on and on and on. I mean, if you've got four days I could tell you all this stuff. It's been the highlight of my career, sitting here and being able to work side by side with these men and

And you want to continue? Of course.

Newly appointed Human Relations Chair Ori Blumenfeld on aggressive panhandlers and the landlord/tenant forum

Why did you decide to join the Human Relations Commission?

I knew, especially after Team Beverly Hills, that I not only wanted to get involved—because Team Beverly Hills is, I believe, the first step to involvement in the City— I wanted to get more involved. I learned that joining a commission is the next step. So after reading all the various requirements of all the commissions and what they do, and after reading the Human Relations Commission, it was just a symbiotic relationship—their mission statement and their goals. More than anything, it just seemed a perfect fit to get involved in the City.

You mentioned in your interview with Beverly Hills Courier that the Commission will be taking on more landlord/tenant disputes. Why do you think landlord/tenant disputes are an important issue?

[Landlord/tenant disputes] are actually something that I'm very passionate about. I have a background in landlord/tenant disputes, as I used to represent low-income tenants. The City Council has charged us with becoming the public forum for landlord/tenant disputes including rent stabilization, which is a hot-button topic. We also plan on potentially involving the Beverly Hills Bar Association to help us with that, if it's not something the commission can handle. We are a commission, not a legal body. If lawyers need to get involved it's not something our commission can resolve.

What do you think will be your greatest challenge as Human Relations Chair?

The landlord/tenant forum. The Council charged us to address the needs of the community but there's no template, there's no

precedence for this, but we expect great things from this forum to address the issue. It's an issue that really hasn't been put at the forefront or in the spotlight. I think the landlord/tenant forum, as well as solving the panhandling issue, are going to be my two main platforms as Chair.

How do you respond to people who question the Human Relations Commission's relevance?

It's almost like a "stay tuned." People have not stopped talking about One Book, One City and what we've done to bring the residents together. I think we've become very relevant. We definitely do have visibility in the City, but in terms of relevancy, it's kind of like, just wait for the landlord/tenant forum to kick off soon.

You expressed concern during the Human Relations Commission meeting in December that not enough is being done to tackle the panhandling issue. How do you hope to alleviate this problem?

It's become almost a passion of mine to try and tackle the panhandling issue. At a previous City Council hearing, [Mayor Lili Bossel and the City Council expressed their interest in making this the hot-button issue and my goal is to work with both the police department, as well as the Chamber [of Commerce], in terms of educating not only the residents but also the businesses, as to what exactly aggressive panhandling is and how to stop it. And that's one of the things that we're working on right now. At the last hearing, we actually started to listen to staff reports on possible solutions for increasing authoritative visibility to get [aggressive panhandlers] to stop. I think it's going to take educating the residents, as well as the business owners and the employees, to teach them that aggressive panhandling needs to stop. Panhandling is of course a First Amendment right—aggressive panhandling is not. If anything, [Human Services Administrator] Jim Latta, our staff member on the commission, said

The first go-around was a resounding success and there's absolutely no reason why the One Book, One City train

shouldn't continue going along. We have City Council's support and [Mayor Lili Bosse] has personally expressed interest in starting it again. I actually just asked the commission to bring it up at the next hearing to start the process of selecting the book and going from there. I'm that much more excited for the second version. I call [Rochelle Ginsburg] the Chair extraordinaire and I have very big shoes

to fill. I definitely intend on using her guidance because she did a fantastic job.

What sparked your initial interest in local politics?

I've always been involved in government and been fascinated by how government works and what it takes to run a city. And that passion to become involved lead me to the Human Relations Commission and I suspect will continue to lead my involvement in the City.

What one goal would you most like to accomplish on the Commission this year?

If I can somehow get aggressive panhandling to end, I'd be very proud of that. It requires collaboration with the Chamber [of Commerce], City Council and the police department, as well as the cooperation of the residents. How many times do I sit out on a nice day with family and friends and I'm not only interrupted by an aggressive panhandler putting his hand over the railing and asking for money but having it done right in front of a waiter who doesn't just see it and doesn't say anything but looks away? And I actually go on South Beverly now and I talk to employees and wait staff and they just don't know the rules. And that's especially where we need to get the Chamber of Commerce involved. Sergeant [Max] Subin said they have two foot patrol officers in the business district, but that's

Tell us about your family.

I have two fantastic, supportive parents, Shoshana and Benny. I have a younger sister, Donna Hinkes, who is married with two kids. I'm first-generation American, my parents are Israeli. Council deliberates bicycle sharing program

The City Council considered implementing a bicycle sharing program similar to the one authorized by the Santa Monica City Council in November 2014 at the Study Session meeting on February 3. Santa Monica will be the first city in Los Angeles County to adopt a bicycle sharing program.

The estimated first-year cost to execute and operate a 50-bicycle bikeshare program is \$327,000. Yearly contractual operating costs for the next 7-8 years are approximately \$109,000.

"To see this come forward as a transportation initiative is gratifying," said Better Bike founder Mark Elliot. "I would just caution against going with too small a system. We want to make sure that it connects and gets people where they want to go."

The Santa Monica City Council awarded

a \$10.4 million, 8-year contract to bike share company CycleHop in November 2014 for the procurement, installation and operation of a bikeshare system that includes 500 bicycles and 1,000 racks at 75 locations.

"I'll make it simple," said Vice Mayor Julian Gold. "I'm really uncomfortable about bikes without helmets and I don't think we can seriously advocate for bikes without helmets. I just think that's wrong."

According to Deputy Director of

Transportation Aaron Kunz, West Hollywood is presenting a bikeshare program to its City Council in a few weeks.

"I have been waiting for this moment since we talked about it," said Mayor Lili Bosse. "I am absolutely in support of it and looking forward to moving forward."

The program implementation is anticipated to require 12-18 months.

Architectural Commission considers Emporio Armani project

Phil Tollios, a project manager at Burnham Nationwide, applied for architectural approval of a façade remodel, a business identification sign and a construction barricade graphic for an Emporio Armani store on North Rodeo Drive. Tollios attended the Architectural Commission meeting on January 21 on behalf of property owner ECA Capital and the tenant Emporio Armani.

"First of all, the design of this building is smashing," said Commissioner Michelle Kaye. "It's really stunning. I think it's striking and wonderful."

The project design features a multi-story black metal storefront system with clear gazing, LED light coves at the top and bottom of the storefront system to provide a wash of illumination, black aluminum door handles and bronzed stainless steel metal rods on the interior of the storefront system. The applicant is also requesting a construction barricade graphic with signage.

The original design featured a marble façade. However, due to a shortage of materials, the revised version will instead involve Marmorio Veneziano, a stucco.

"Right after we submitted the design package, I got a phone call from Armani back in Italy and they said the proposed marble sample size is not sufficient for what our design intended to do," said George Fu, an architect with Antunovich Associates.

Both Chair Barry Bernstein and Commissioner Gidas Peteris expressed an aversion towards the stucco finish, which is less glossy and more muted than the marble

"Obviously I prefer the stone to the stucco," said Peteris. "I think that switch is going to make a difference in the aesthetic, the way that it's perceived."

Despite their preference for the marble façade, the Commission unanimously approved the project with a 4-0 vote. Commissioner James Blakeley was absent from Wednesday's meeting.


