A REPONSE TO A LETTER IN LAST WEEK'S ISSUE:

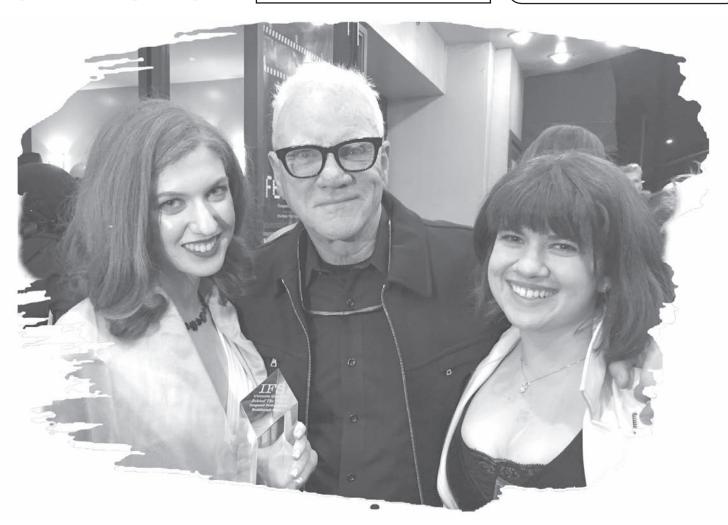
Dear Mr. Bernstein,

Paysinger lawsuit settled

The BHUSD reached a settlement agreement with retiring Beverly High Principal Carter Paysinger following a mandatory settlement conference held before Judge Jay C. Gandhi on May 28.

Gandhi ordered the Board of Education to consider the proposal during a closed session meeting Friday morning.

"The closed session cannot approve concepts, it has to approve contracts," said attorney Fred Fenster, who represents the district. "So when the settlement agreement is ready and is submitted to the Board in closed session, it will act on it."

The Board is expected to vote on the proposed agreement at its next regularly scheduled meeting on June 18.

Paysinger filed a lawsuit against Hall and

the district on nine causes of actions including discrimination and retaliation last July.

Paysinger's attorney Reed Aljian said he could not disclose details of the closed session meeting as it would be in violation of the Brown Act.

Southwest Homeowners, Municipal League file amicus brief in Metro case

The Southwest Beverly Hills Homeowners Association and the Municipal League filed a joint amicus curiae brief with the California Court of Appeal earlier this week in support of the Beverly Hills Unified School District's lawsuit against Metro.

"The purpose of the amicus brief is to bring to the Court of Appeals' attention that numerous studies have been performed after the trial court made its decision which, if considered, should persuade the Court of Appeals to reverse the trial court's decision," said Fred Fenster, the attorney representing the Southwest Homeowners and the Municipal League. "This new information is highly germane and demonstrates the fal-

The brief notes that Metro made the decision to relocate the Century City subway station based on seismic studies that were prepared after the close of the public comment period. The 20-page document also points out that the BHUSD, Municipal League and Southwest Homeowners have been "consistent in opposing the realignment approved by MTA." The subway route

"As a member of the Board of Governors of the Municipal League of Beverly Hills, we decided that it was in the interest of the citizenry to bring this new information to the attention of the Court of Appeal," Fenster said.

The appeal is expected to take one to two years.

Heilman returns to West Hollywood Council



John Heilman

John Heilman, a fixture in West Hollywood politics since the city's incorporation in 1984, was reelected to the West Hollywood City Council Tuesday.

According to WeHo.org, as of Tuesday night at 10 pm, Heilman had 2,026 votes. Heidi Shink had 1,185 votes, Larry Block had 637 votes and Cole Ettman had 384 votes.

Though narrowly defeated in the March 3rd general election, Heilman had an opportunity to run again during the June 2nd special election to fill L.A. County Assessor Jeffrey Prang's former council seat.

A Southwestern and USC law professor, Heilman became West Hollywood's second Mayor in 1985. Heilman is also the longestserving openly gay elected official in the United States.

Recreation & Parks Commission discusses Greystone Mansion library, dog parks

Following a 5-0 vote, the Recreation & Parks Commission moved forward with a proposal presented by Friends of Greystone (FOG) members to restore the Greystone Mansion library to its 1928-era condition and convert the space into a museum.

According to Design Review Commission Vice Chair Arline Pepp, who attended the Monday meeting as a Friends of Greystone Board member, the original library was stripped of its paneling in the 1950s. The room is therefore not considered historic, which allows for design flexibility.

Friends of Greystone Chair Susan Rosen said the library has been an important

8600 Wilshire Boulevard

Architectural Commission green lights revision to Wilshire Blvd. mixed-use building

The Architectural Commission unanimously approved a revised entry for the new five-story, multi-family, mixed-use residential building located at 8600 Wilshire Boulevard at their May 20th meeting. The project was previously approved by the Commission at their meeting on August 20.

At the time, the Commission had expressed concern with the lack of a defined pedestrian entrance on the side of the building facing South Stanley Drive.

Project agent Jill Wagner, an associate partner at architecture, planning and urban design firm Gruen Associates, provided the Commission with a blueprint of the modified entry.

"The pedestrian entry has been relocated to be a pedestrian entry all on its own, completely separated from any vehicular entry," Wagner said. "It occurs between the glass retail area that occurs along Wilshire [Boulevard] and then right in front of the building signage."

The secondary entrance, adjacent to a loading zone, will exist at its original location. "I'm thrilled you finally have a pedestrian entrance," said Commissioner Michelle Kaye.

The mixed-use building will contain commercial space on the ground floor along Wilshire Boulevard and 26 residential condominium units.

Wagner said they "hope to break ground in July."

awareness-raising and fundraising tool for the non-profit organization. Rosen said that the Friends of Greystone currently has over \$230,000 worth of artifacts from the Doheny Family in their possession.

The appraisal does not encompass the entire collection, which includes oil paintings, silverware, plates, wallets and linens that have been purchased, donated or found over the past 30 years.

"My concerns are that this may be a very nice idea, but we don't know if you have the money to do it and we don't know, really, what the quantity or size of any of the items that are going to go in the museum will be," said Commissioner Howard Rosoff.

Rosoff, who called the project "premature," expressed concern that the items in the museum might not be "monumental" enough to "draw people in for a tour."

"I do understand where Howard is coming from in terms of having important pieces," said Commissioner Susan Gersh.

The Commission voted for a 6-month renovation schedule priced at \$349,062. The project includes staining all new and existing woodwork within the library and implementing a barreled ceiling with two bands of detail work running around the perimeter.

The Friends of Greystone will contribute \$100,000 to the project. As a next step, City Council liaisons will consider the project during a meeting with Recreation & Parks Commission liaison members Robert Anderson and Rosoff.

Fine Art Commission contemplates restoration plans for Kusama sculpture

The Fine Art Commission deliberated a \$60,000 projection for the construction of custom fencing around "Hymn of Life: Tulips," a sculpture by Yayoi Kusama at Beverly Gardens Park, at their meeting on May 21.

The Commission approved a fence design submitted by John Lavezzo of Craft Design Build at their Feburary meeting and is currently seeking bids for the manufacturing of the enclosure.

The cost of the fence will not be finalized until the Commission receives the bids.

The art piece was originally surrounded by plants, but the Fine Art and Recreation & Parks Commissions began considering fencplants did not provide a protective barrier.

Commissioner Alan Kaye said he feels

"For a year we have not had the designer show up one time to have a conversation with anybody," Kaye said. "It's a year later and the Kusama is still imprisoned, and I think we should all be a little embarrassed."

The Community Services Department has



ing options after it was determined that the Rendering of proposed fencing for Kusama sculpture

consulted with several different designers, including Mia Lehrer & Associates, Johnson Favaro and Bronze Age.

"I'd like to see this get finished, as everybody does," said Commissioner Michael Smooke.

At their May 5th meeting, the City Council considered several different fencing options, including an "inverted barrier" solution with a cost estimate of about \$100,000, which they rejected.

The Commission voted 3-1 to seek three competitive bids for the manufacturing of the fence. Kaye objected.

Vice Chair Brenda Potter was absent from the meeting.

At the same meeting, the Commission continued a longstanding discussion about bringing a dog park to the City.

"It makes no sense to have a dog park immediately next to Olympic Boulevard," said Southwest Homeowners Association

President Ken Goldman, who does not support a dog park at Roxbury Park.

At the April 28th Recreation & Parks Commission meeting, resident Mark Elliot addressed the Commission about his support for having Roxbury Park reconsidered as a suitable location to host an off-leash

dog park.

Reggie Sully of McCoy Construction read a statement on behalf of Beverly Hills Courier publisher Marcia Hobbs: "The official position of the Courier is that there

bers also joined the discussion, including Cultural Heritage Commissioner Noah Furie, who established the City's first-ever Historic Preservation Ordinance in collaboration with former Planning Commissioner Brian Rosenstein in January 2012.

"The draft before you today reflects many of the changes to the concerns that commission members had, and as far as I'm concerned, I fully support what's before you," Furie said.

If approved by the Council, the ordinance would result in amendments to several sections of the Beverly Hills Municipal Code, including Article 32 (Historic Preservation) and Article 32.5 (Historic Incentive Permit).

"I come before you tonight unfortunately concerned, again, that despite all of the

time everyone has spent on the document it's still not where it should be for the City of Beverly Hills," said Cultural Heritage Commissioner Rebecca Pynoos.

The amended document includes several definition changes, as well as revisions to the intent and purpose of the ordinance and the powers and duties of the Cultural Heritage Commission.

"I think we can make further changes in the future, but my feeling is we've spent a lot of time on this, we should take it as it is, we should approve it, get it going and stop the logjam," said Cultural Heritage Commission Vice Chair Lisa Greer.

CHECKING IN WITH THE CHA

Chamber of Commerce President Kelly Scott on his priorities for the year

How did you become involved with the **Chamber of Commerce?**

I'd have to let you in on a little secret: my firm [Ervin Cohen & Jessup] asked me to join because we usually had a partner as part of the Chamber. And to be honest with you, I wasn't originally too thrilled about it. I envisioned a group of guys wearing fezzes and smoking cigars. But much to my surprise it wasn't that at all, it was in fact a diversified group of highly motivated individuals and organizations that very much want to make Beverly Hills a better place. Lee Silver was a big part of me joining-Lee Silver had been [Chamber of Commerce] President and he suggested that it might be a good thing to do. Let me just say that in general, I think Chambers have struggled to maintain relevance. But what we have here in Beverly Hills transcends what other Chambers are doing in other areas. We have a very active [Board of Directors] and we have really reinvented what it means to be a Chamber of Commerce—it's pretty exciting. [We have had] a series of insightful and creative presidents, we have a great staff, we have a great Board, and I think that they were open to doing things differently in a way that's resulted in a new Chamber—a world-class organization. Chambers have traditionally been about business and facilitating business and business meeting business, but I think that this Chamber has become much more than that. It has become a source of information in terms of government, economics, consulting and industry-specific events. So this is a Chamber that's not just informing business, but changing the way people do business.

Tell us about your priorities for the coming year.

As an attorney, I love strategy. What we're starting to do now is to go back and look at the organization inside out. I counted that last year the Chamber provided 113 different world-class events and programs for its members. My feeling is that all of this opportunity is out there and I know that members know about one or two or three or more, but do they know enough? I have the feeling that for some members, a membership is like not knowing you have a Lamborghini in the garage and you're not going to use what you don't know. So, I have termed this year "The Year of the Member"—which is not the next Austin Powers movie title-it's about making sure that all of what's happening is accessible to every member at every level. The array of available programs and events, again, is staggering. There are opportunities to have consulting that can literally change the way a business does business by working with professionals that are experienced

in various areas. There are opportunities to contact with businesses in a given industry; there are opportunities to connect with people that are actually running this town. Again, it's staggering.

Do you have a strategy for attracting new businesses and retaining existing businesses in Beverly Hills?

We have some programs that we're already doing: we meet with a number of businesses in New York, for example. We're looking at extending that to other areas. We might have meetings with businesses in a given city maybe even outside of the country. In terms of [attracting new] businesses here, it's about doing some of the things that I'm talking about: revisiting how we communicate with these businesses, reconsidering the nature of the initial connection-what information is provided and how we follow up with those people so they're getting what they need out of it. I know the Chamber works. For example, Lesley Gilmore, the manager of Fleming's, has said that as a result of the Chamber providing assistance to them, they directly attribute 17-20% of attendees at a particular event to the Chamber connection, Deborah Henderson, who is Director of Communications at K and B Surgical Center, informed us that she obtained new patients directly from attending a Chamber event. She was also able to secure additional medical space through a connection at the Chamber. The success stories are out there.

Last year we interviewed outgoing President Marc Wolf in our issue #763 cover story, and he said: "We really want to make sure we enhance the business community in Beverly Hills. It's doing so well [already and] we want to make sure it's doing better. We really want to make sure we're connecting the local residents

with the Beverly Hills businesses." How was the Chamber able to achieve these goals?

Well, I'm lucky, because a lot of the hard work has already been done. The past presidents, Marc being one of them, John Bendheim before him,

Steve Ghysels-these are people that reinvented the Chamber and took it to the next general, I think Chambers level. If you look at the events, some of those 113 events that I mentioned a moment ago, they're blowing up. They're selling out. The FLARE (Finance Law Accounting Real Estate) events are packed to the gills, the Beverly Hills Tomorrow event sells out. And it's not just about the event. [The events are] informative and entertaining, but it's about the opportunity. Both before and after [the events], people meet and discuss and there are even more pointed opportunities for, as I said, small business consulting sessions.

These are events, or programs, that are designed to assist a business in improving how it does business within the city. My job at this point is to make sure that it happens more often to keep expanding the availability of all of these programs and events for all the

How will your background as an attorney help you as Chamber President?

I love strategy, so it's fun for me to bring that to the table. Also, in my area, which is litigation and employment law, I get to work with a variety of clients and all kinds of businesses and that's really what a Chamber does, so I think it gives me some insight into how different businesses work, which in some ways can make what I'm talking about easier.

What are some of the things that you've learned from Wolf?

Marc is an accountant; he's an audit partner at a large CPA firm. So one thing he's forced me to do is take a hard look at numbers and budgets which is a necessary part of any organization and Chamber. That's something that I don't always love to do but

it's something that he's made me do and it's been informative. Marc is a good listener and he's good with people. I think that Marc ran the Chamber in a way that really allowed others to feel good about contributing. And that's something that I would like to continue to do.

What advice has your law partner and former **Chamber President** Lee Silver given you?

Well I wouldn't be here if it wasn't for Lee Silver. He's always touted the organization and encouraged me to keep an open mind about it and I guess the most substantive

thing that he said is go to as much as you can, attend the events, go and see what they're like-that's how you'll really understand what's going on and how to make things better. The other day I attended a membership orientation event which I had never done before and these go on, I guess, twice every month. And it was lovely. Just seeing how new members are introduced to each other and what they're offered initially—it's a lot of information for people to absorb and it gave me some insight into how we might follow up with that because it's so much for people to understand.

Tell us about your family.

I have a wife, Meghan Scott, and two wonderful kids. My daughter Riley is 14; she's starting [Notre Dame High School]. Keaton is 10 and he's going to be going into the 5th grade [at Laurel Hall]. He's wonderful as well and very active in sports. My wife is amazing; she runs the practice of a cosmetic surgeon here in town: Dr. John Diaz. She's a practice manager right here in Beverly Hills and she does it all: she helps with the kids, she manages the practice and there's a lot on her plate but she does it seemingly effortlessly.

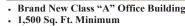
