Rabbi opposes proposed dog park

Although they rescheduled a September 29th meeting to October 13, the Recreation & Parks Commission is still facing resistance from local rabbis who oppose a dog park proposed for the industrial area.

In an email to Commission Chair Simone Friedman on September 18, Beverly Hills Synagogue's Rabbi Pini Dunner outlined his opposition to the dog park being considered for the southeast corner of Foothill Road and Alden Drive, calling the project "ill-thought through."

"The thought has struck me, and many others who feel the same way, many of whom are Beverly Hills dog-owners, that either no one is reading the detailed emails I have sent, or that they are reading them but cheerfully ignoring everything I have written," Dunner wrote.

Dunner had requested that the Recreation & Parks Commission change the date of its September 29th meeting as it overlaps with the Sukkot Holiday. Although Friedman highlighted the challenges of carrying out such an action, the City announced Wednesday that the meeting date had been changed.

"It is not easy to change a meeting, there

are five commissioners, at least six staff and the need for availability for our meeting room," Friedman wrote in her response.

The proposed dog park, which neighbors several synagogues, has received pushback from rabbis who insist that the park not operate during the hours of their services and Jewish High Holy days. According to Dunner, the project "guarantees problems and conflict in an area of Beverly Hills that has hitherto been peaceful and wonderful."

Friedman wrote that she hopes to send her Commission's recommendations to the City Council in time for the Council's October 20th meeting.

"If it emerges according to your plans, [the dog park] will be a blight on our local area and a blight on Beverly Hills," Dunner wrote in his email.

Attorney Philip Kaufler, who represented former BHUSD Facilities Director Karen Christiansen in her multimillion dollar judgment against the district, was CC'ed in the email.

Hall responds to the Weekly

In an email sent out Sunday, Board of Education member Lewis Hall addressed the Weekly's September 17th cover story:

People ask me if I'm angry at Beverly Hills Weekly's attempt last week to denigrate my character with a cover story that reads on the front page, "Three depositions support allegations that Hall retaliated against Paysinger." In answering, I'm reminded of a scene in "Ikiru", a Kurasawa film about a character named Watanabe who has a short time to live and devotes the rest of his life to building a playground for an underprivileged section of his city. While waiting to see the mayor, some gangsters threaten and rough him up to keep him from his good purpose. After the gangsters leave, the character's assistant exclaims, "Doesn't this make you angry?" The character replies, "I don't have time to be angry."

Like the character in the film (though I'm not dying!) I too don't have time to address all the unfounded and malicious attempts by the *Weekly*'s publisher and his cohorts to smear my name. Still, perhaps I owe my supporters and those who are following me a response.

I never retaliated against Carter

Paysinger when he was principal and he has never proved the contrary. In fact, at his deposition, Carter could not point to a single act of retaliation that I supposedly engaged in against him and the reason is obvious: namely, it did not occur. My motive for running for school board has been and continues to be my unwavering and single-minded dedication to serve our students and the Beverly Hills residents.

During my tenure on the school board over the last three and a half years, I've been guided by two watchwords: transparency and honesty. I believe the votes I've taken have consistently reflected my desire to do what is best for the students, our teachers, and the community - for now and for the future. Sometimes my positions have not been popular, but I refuse to succumb to political pressure of the vocal minority, like the *Weekly*, whose sole desire is for my defeat.

It is unfortunate that the *Weekly* and its cohorts prostitute themselves by fabricating statements without any basis and distorting the truth. Having the right people serving on the Board of Education is critical for the well-being of our students and the health of our community and it is time to vote on the facts rather than false innuendoes.

By moving forward with "Option 2," the Board has essentially green-lit site preparation for interim housing units at both schools. The plan does not involve construction projects or the development of a new parking lot at Beverly High. Under "Option 2," Building A at the high school will not be evacuated.

"I have pledged not to put kids in portables until we have the finances to complete the projects and my option accomplishes that," Margo said. "The situation at El Rodeo showed that there are some structural deficiencies that are evident on the exterior of the buildings and that similar deficiencies may exist on the interior and should be addressed sooner or later."

Building A does not qualify for State Seismic Mitigation Program (SSMP) funding, so Margo recommended leaving it out of the equation, which frees up funds and saves student parking. By accomplishing the latter, Option 2 ensures that Theater 40 operations remain undisrupted, as the theater relies on the student parking lot for patron parking.

"If the seismic concerns at Beverly High and El Rodeo carry over to Hawthorne, then it would be foolish not to address those concerns prior to constructing any new build-

SANTA MONICA BOULEVARD RECONSTRUCTION PROJECT PUBLIC OUTREACH - TRAFFIC MITIGATION

The City of Beverly Hills Traffic & Parking Commission will hold two public outreach meetings to receive community input on potential traffic mitigation measures for the Santa Monica Boulevard Reconstruction project.

The Santa Monica Boulevard Reconstruction project is planned to break ground in spring 2016. The City Council-approved project design includes reconstructing the roadway and upgrading the century-old drainage system between Doheny Drive and Wilshire Boulevard.

The format for the meetings begins with a 30-minute "open house" to provide the public an opportunity to learn about the project and ask questions of the project team. The "open house" will be followed by a presentation and public comment.

Options for mitigating traffic during the reconstruction project fall into three primary categories:

- 1. Public Information Program
- 2. Measures to prevent traffic diversion to residential streets
- 3. Measures to maintain access to the business triangle from South Santa Monica Boulevard through parking changes

Following the public outreach meetings, the Traffic & Parking Commission will develop recommendations for the City Council specific to traffic mitigation. Additional meetings may be scheduled. The City Council will make the final determination as to what mitigations will be included in the reconstruction project.

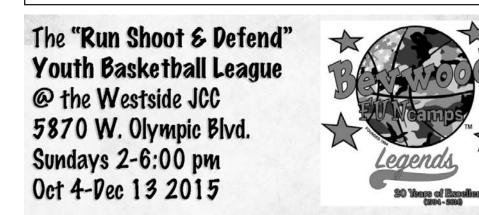

ing," Margo said.

Buoyed by Interim Facilities Director Tim Buresh, Board member Lisa Korbatov reiterated claims that the school buildings are unsafe.

"I'm trying to paint a picture for you, folks, it's dangerous," Korbatov said. "I mean, I'm not sure how else to keep saying it because I've been saying it for several years-it's really, really dangerous. You have a competing idea here called money and then you have precious life."

Gold warns Board against breaching JPA contract

In an unprecedented move, Mayor Julian Gold sent a strongly worded letter to the Board of Education on September 11 advising the Board against removing City access to outdoor fields that are "at the heart of the Joint Powers Agreement (JPA).'

"As the Board is aware, the City of Beverly Hills pays approximately \$10 million annually to the District in order to ensure that the children of our community have access to outdoor fields as well as auditoriums, libraries and classroom facilities for after school programs and weekend recreation," Gold wrote in the letter.

Under the JPA, the district agreed to make various school facilities available to the City, including the parking lot inside Beverly High's Building A, which the Board was considering vacating until their special meeting last Thursday.

"In total, it appears that the City's use of District facilities under the JPA will be reduced to a fraction of the facilities originally covered by the Agreement," Gold wrote.

Board President Brian Goldberg told the Beverly Hills Courier that he "cannot help but wonder if this is politically motivated given the upcoming school board election."

Gold cautioned the district against awarding contracts to remove any other facilities subject to the JPA.

Three auditoriums at Beverly High, El Rodeo and Hawthorne remain closed indefinitely.

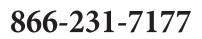
Assessor **Prang's** annual report shows 9.1 percent growth in Beverly Hills

The 2015 Annual Report released by Los Angeles County Assessor Jeffrey Prang on Monday lists Beverly Hills as the second fastest growing city in the County with a 9.1 percent growth rate. The City of West Hollywood tops the list at 9.8 percent.

According to the report, Beverly Hills' total assessed value stands at \$27.8 billion, putting it in front of Santa Clarita (\$27.3 billion) and behind Los Angeles (\$500.3 bil-

Many unanswered questions in high-speed street race

Qatar national Sheikh Khalid Hamad Al-Thani has been connected to the yellow Ferrari involved in last week's highspeed street race, BHPD Chief Dominick Rivetti announced at a press conference on September 17.

Nevertheless, many unanswered questions still surround the incident: the BHPD reported that it is unlikely the drivers involved have diplomatic immunity and Al-Thani is believed to have fled the country.

"The police department will pursue prosecution if legally possible by seeking a criminal complaint through the District Attorney's Office against the suspects involved," Rivetti said in a statement.

The BHPD has tightened enforcement

measures for reckless activity in the neighborhood where the incident took place.

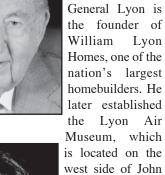

What inspired you to establish Beverly Hills Heritage?

Having grown up in this community during my formative years, I was very much impressed with the architecture in the community and the history and it's something that I carried with me even when I left with my mother in the late 1970s. Without sounding too clichébut it's the truth-no matter where I was living in my life, I was never happy like I was when I was here in Beverly Hills. With the advent of social media and reconnecting with childhood friends and seeing photographs of the City, I became, once again, sort of enamored and felt a longing to return here. While I was trying to do that, I found myself searching and researching for historic images of the City. Through those images, I learned a lot about the history of the City. The development of this City occurred the most during the 1920s and 1930s, and that's a period of history and architecture that I loved the most-the Art Deco era—so it was a natural marriage of history, facts, imagery and personal love for the City, etc. I created a Facebook page while still living outside of Los Angeles called "Beverly Hills Historic Preservation." I worked on that page for two years and build quite an archive of images and followers. It wasn't until I actually moved back to the City in 2013 and took a course at USC about historic architecture [that] I decided to turn my hard work on Facebook into an actual organization that would serve the community. In essence, it was the allure of my love for the community and its history that brought me back here.

How does Beverly Hills Heritage achieve its mission of recognizing, preserving and promoting the architectural, cultural and historic resources of the City?

I've endeavored to do that through social media, through community events, through personal relationships and being civically involved. We're always working on new plans and forming new ideas as to how to achieve that. We also have a growing archive collection of historic memorabilia which includes artifacts from buildings and the City's resources. For instance, when the Electric Fountain was in the beginning stages of remodeling and they were breaking all the historic tiles, when they were done keeping the pieces that they wanted to keep, I came and picked up the scraps before it headed to the trash. All of these remnants and artifacts of in a display someday in a museum. Over the last six months, we've had to reevaluate our goals and objectives as an organization in light of the changing [Historic Preservation Ordinance] and the charge of the Cultural Heritage Commission and also by gauging public interest. Any non-profit, in its inception, is going to be a work in progress and we are trying to find our way around achieving our mission in a community that is not that preservation friendly. I've always been in this for the long haul and I've always been realistic about what can be done and know that it's going to take time. Right now, our biggest goal is education and increasing membership. What do you think

history I hope to put

What do you think is the single greatest threat to historic preservation in Beverly Hills?

I would say that the single greatest threat to historic preservation in this

City is the lack of interest in it by the people who are investing in real estate. [Additionally], the need for revenue that's generated as a result of the investments that the City relies on to further the goals of the community. Just having a better budget, I guess you could say.

What is Beverly Hills Heritage currently working on?

Right now we are doing a lot of internal work with Board structure and trying to find the right people to fill gaps in what we need to have assistance with. We recently appointed a membership director who will be handling growing our member base and putting events together. Over the last year, we lost a couple of members and gained a few, so it's always a work in progress and finding the right combination. Currently, I'm working on creating informal house tours of landmarked properties where we can not only teach about the architecture and the history of the home within the City's

timeline, but also raise funds to place plaques on the front of the house, like they did at Greystone [Mansion]. There doesn't seem to be any bona fide way with which to do that. There's nothing on the outside of the homes or the properties that indicates that it's a landmark and I'd really like to see that done. One project that is very near and dear to my heart but that proves to be difficult is to somehow find a way to acquire some of the artifacts that are lying around the City that are historic in nature and are sitting in Public Works buildings and lots and locked compartments or locked closets. It drives me crazy that that stuff is there because I don't know what's happening to it and I worry about things getting thrown away. But there's not

precedence with the City for acquiring these kind of artifacts and so it gets stuck in limbo because the City has never had a program for maintaining anything that's historic. We have a shield sign—one, last, original shield sign—that we'd like have restored and placed somewhere in the [Business Triangle], but getting that accomplished is a daunting task. I think people care but people don't know how to go about doing it, so I have to try and find a way.

Tell us about your educational background.

From the time that I graduated high school, I wanted to go right into interior design. I was discouraged out of it by my father and I pursued a business degree and got an A.A. from Santa Monica College and then went on to study psychology at Cal State University, Northridge. I decided not to pursue that and went back to UCLA Extension to study interior design. So design and architecture have always been a really large part of who I am. During all of that time, though, I worked at my father's advertising agency in Century City and I learned a lot about marketing and advertising from him. Later, I went on to receive my bachelor's [degree] in religious studies, which I think is one of the single greatest courses of studies that anybody could ever take because it teaches you about history and politics and infused in that is culture and architecture and humanity. Essentially, it creates tolerance as a way of life and it mostly helps with the skill of critical thinking.

How do you a deal with a situation where a councilmember that you're friends with votes against a preservation project?

In all honesty, I respect all the councilmembers, but I find that my true friendships lie with those who have a similar perspective and belief system as I do. This is not to say that I'm not friendly with those that vote against the way I believe, but I don't find that we have much in common otherwise. The notable exception to that is [Mayor Julian] Gold, who has been wonderfully supportive but yet voted to pass the revised preservation ordinance, and I understand why he did it, I don't fault him for it. I think more than anybody I blame the Cultural Heritage Commission. I blame them for not fighting harder, but I also understand that their fight was a great one and there had to be compromise. It doesn't mean I agree with it, but I still have to get along with everybody. Not everybody is going to like me and I'm not going to like everybody and that's just how it goes. But our City is big on civility and that's how we conduct ourselves. It doesn't mean that I don't get angry, but I have to separate the policy from the person.

What is your number one goal as the president and founder of Beverly Hills Heritage?

My number one goal is longevity and the organic appreciation of the City's culture and heritage and lifestyle by all residents. I hope to put programs in place in the long run, but these things take time, and now, more than ever, I understand the investment and the dedication it takes to affect real change and I'm in it for the long haul.

The Chamber of Commerce sponsored an untelevised debate between the five candidates for the November 3rd Board of Education election at the Chamber Boardroom on September 17. Former Mayor and Board of Education member Mark Egerman moderated the forum. Highlights include:

• "The word is out that this is the way we function, which translates to total dysfunction," said candidate Isabel Hacker, who

"Measure E was predicated on a promise that there would be no tax increases for this community without approval of the community-that has been broken twice. I want to remind everyone that everyone running for the school board as an incumbent has taken the vote at least once to accelerate."

• Through her research, Hacker painted a portrait of a Board that has overstepped its boundaries by personally hiring teachers, coaches and principals when its main goals are to "set policy and hire a Superintendent."

• "I tried getting a tape once [of a Board Study Session] and they said to me, 'There is no tape, these are not taped and they're not televised." So what's the point of transparency if only five people are showing up?""

• Hacker pointed out that on top of its bimonthly meetings, the Board held 22 study sessions last year. Manhattan Beach Unified School District, on the other hand, held three study sessions.

• After being told by several audience members to "speak up," candidate Lewis Hall sidestepped Egerman's question about subway litigation and instead delivered a familiar response centered on the dangers posed by constructing a subway route underneath Beverly High.

"Academy-Award win," which the Weekly called into question in last week's issue. Hall claimed that Otis College of Art and Design had put together his faculty page and he therefore had no knowledge of the exaggerated statement.

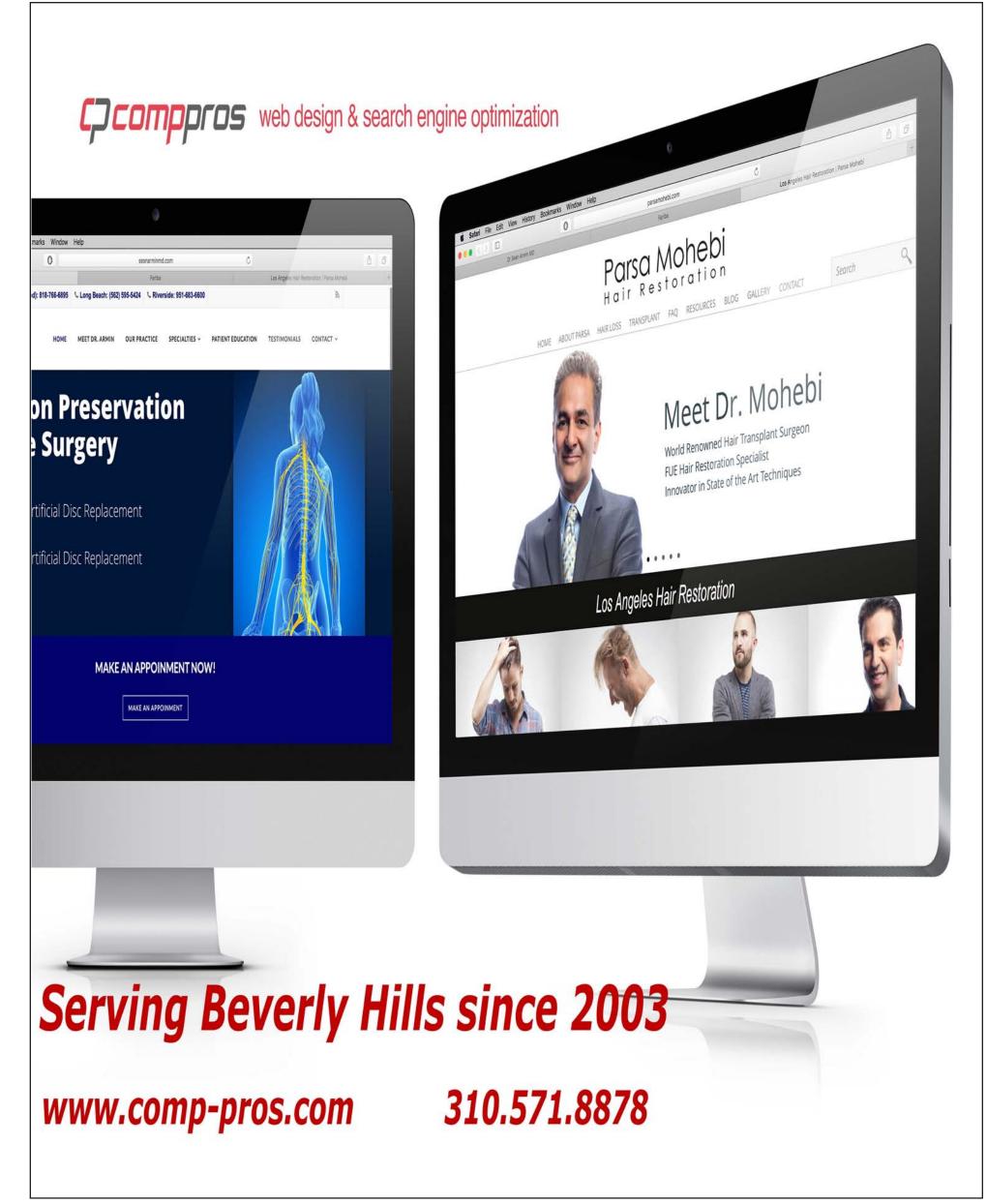
