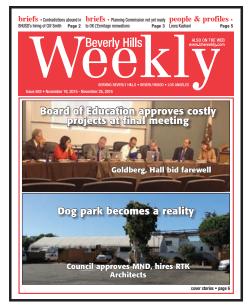

Is the Fine Art Commission's charge acquiring or maintaining art?

Though the Fine Art Commission's main charge is acquiring art for the city, oftentimes, the discussion at monthly meetings focuses on the topic of art maintenance.

Public art enhances the aesthetic quality of communal spaces, but sometimes the pieces are treated like interactive installations and climbed or stepped on.

At the Commission's November 19th meeting, Community Services Assistant Director Nancy Hunt-Coffey pointed out that Carol Bove's *IO* sculpture, installed in September at Beverly Gardens Park, is

Yayoi Kusama's "Hymn of Life: Tulips" sculpture sits at Beverly Gardens Park, a popular stop for tourists.

The hand-painted tulips were originally surrounded by plants, but the Fine Art and Recreation & Parks Commissions have been considering fencing options after they determined the sculpture needed a sturdy

and clearly defined barrier. The process has exceeded a year.

Rec & Parks OKs ordinance prohibiting adults from city playgrounds

An ordinance that first surfaced on a City Council consent calendar in September

got the green light from the Recreation & Parks Commission at their meeting Tuesday. If autho-

rized by the

Council, the



ordinance would have *Frances Bilak* prohibited

adults eighteen years and older from city playgrounds, unless accompanied by children aged 12 or younger.

Vice Mayor John Mirisch and Councilmember Nancy Krasne had pulled the item, requesting the Commission deliberate the proposal first.

But at their meeting last month,

Recreation & Parks commissioners seemed skeptical.

Commission Vice Chair Frances Bilak had asked Human Services Administrator James Latta whether the ordinance is "directed towards the homeless or drug paraphernalia and other things?"

In his response, Latta mentioned that since the city's ambassador program broke ground, people who normally slept in parking garages "are dispersing to other areas, and that's anywhere their clan go, which includes our parks."

Commission Chair Simone Friedman said although the ordinance is not perfect, it does have some value to it.

"This is a vehicle that will enable us—if people are using [parks] as housing at night—this gives us something to address that issue with," Friedman said. "If we don't even have this, then you're going back to loitering, which seems very fuzzy."

Though once enforceable, anti-loitering rules are now consider unlawful, Latta pointed out.

"No loitering could mean all kinds of stuff," he said.

Friedman joined Commissioners Susan Gersh and Robbie Anderson in supporting the ordinance, which will apply to playgrounds at La Cienega, Coldwater Canyon, Reeves and Roxbury parks, if backed by the Council.

According to the staff report, violation of the ordinance would be a misdemeanor unless specified or prosecuted as an infraction. The perpetrator would receive a citation.

Community Services Director Steve Zoet defined playground as an "area of play where children would otherwise be present."

Statewide, the cities of Santa Monica and San Francisco have already implemented ordinances regulating adult access to playgrounds. Nationally, two Florida cities—Hollywood and Miami Beach make the list, as well as New York City.

Commissioner Howard Rosoff said he understands the concerns driving the ordinance, but is not convinced of its efficacy. "I don't see a whole lot of value in this

BHUSD legal fees for first quarter fiscal year exceed \$119K

BHUSD legal expenditures for the first

quarter fiscal year totaled \$119,177, a sharp decline from the \$1.76 million paid during the last fiscal quarter of 2014-2015. Of the \$119K, about \$32K was charged to the general fund and almost \$82K to the Measure E fund.

Though the first quarter encompasses July, August and September, there were no expenditures marked for the month of July.

"July is a closing month to pay expenses for the prior fiscal year," said Fiscal Services Director Angeli Villaflor in an email. "No expenses show because the payments default to June 30."

The \$119K was paid to three different law firms: Greenberg Glusker Fields Claman & Machtinger, Horvitz & Levy and Murphy & Evertz.

"Perfect Timing" to play at Theatre 40 until Dec. 21

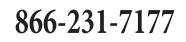
A contemporary drawing room comedy, Perfect Timing opened at Theatre 40 last week and will close December 21.

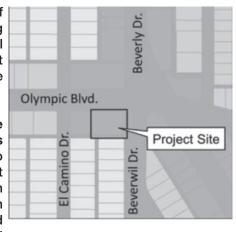

The Planning Commission of the City of Beverly Hills, at its REGULAR meeting on Thursday, December 10, 2015, will hold a public hearing beginning at 1:30 PM, or as soon thereafter as the matter may be heard to consider:

A request for a Conditional Use Permit and Extended Hours Permit to allow renovations to the existing gas station located at 9460 Olympic Boulevard, between South Beverwil Drive and South El Camino Drive. The proposed project involves converting all



four existing vehicle service bays into additional convenience store space. The proposed conversion would increase the floor area of the existing convenience store from 550 square feet to 2,890 square feet. The proposal would not result in any changes to the existing building setbacks and height, and would include sufficient on-site parking to meet the City's requirements for the proposed retail space.

The gas pumps on-site and the convenience store portion of the gas station currently operate 24 hours a day. Expansion of the size of the convenience store area operating 24 hours a day requires an Extended Hours Permit, which would also be considered as part of this request.

This project has been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the environmental regulations of the City. The project qualifies for a Class 1 Categorical Exemption for operational changes within an existing commercial facility and additions to existing structures provided that the additions will not result in an increase of more than 10,000 square feet, and the project has been determined not to have a significant environmental impact and is exempt from the provisions of CEQA.

Any interested person may attend the meeting and be heard or present written comments to the Commission. Any comments submitted will be considered as part of the public record.

Patrice Martineau Executive Chef at Montage Beverly Hills

You've been the Executive Chef at Montage for around six months. How has it been so far?

It has gone by very fast, which is always the case when you start a new executive chef position, [because] of all the changes. You have to change all the menus for the restaurants as the new leader of all the kitchens. It's been a lot of fun and I've enjoyed it very much so far.

What are your primary duties?

My main responsibility is to oversee all the kitchens, except the Scarpetta kitchen, which is managed by Freddy [Vargas], the executive chef there. My main duty is to manage and lead all the culinary teams, change the menus, do the training and establish the culinary teams as very good cooks.

Who do you work closely with on a daily basis?

Pradeep Raman is our Executive Assistant Manager of Food and Beveragehe's basically the person who hired me. The other person I work very closely with is our Executive

Sous Chef Oscar Fonseca.

Tell us about Montage's holiday menus.

We're having an a la carte brunch featuring menu Thanksgiving dish-

es at the Rooftop Grill restaurant on Thanksgiving Day; of course, turkey will be the main dish that day. We also have a very nice buffet at Scarpetta from 12 p.m. to 5 p.m. [on Thanksgiving Day], which will feature mushroom risotto and turkey and pasta. The next day we're starting our Holiday Afternoon Tea, so we will have different pastries and scones and cookies and six different sandwiches. That will start the day after Thanksgiving and go until January [3] at Parq Bar. We have a partnership with Ruinart Champagne, a very well-known champagne. They will partner with us [so that we can] serve the champagne to guests who want it with their afternoon tea. On December 3, we are doing a champagne dinner at the Rooftop Grill restaurant for 30 guests and every dish will be paired with a different champagne. Beginning in December, we will have a Christmas lunch at the Rooftop, and at Scarpetta we're doing all kinds of different sit-down dinners on the 24th and 25th of December. For New Year's Eve we are doing a gala dinner in our ballroom, which will be called

out...

years and every year I do what's called turducken, which is turkey that's stuffed with duck that's stuffed with chicken. It's basically a boneless piece of meat that takes a lot of time to prepare. The past couple of years I've been putting a whole

foie gras inside, and then you basically cook it for 12 hours at a very low oven temperature. And then you have the spices and sage and bread and the meat juices coming together. It's very easy to carve because there are no bones. I have basically made it better every year for the last couple of years-I used to not put the foie gras inside, but it really holds the moisture of the dishes. So for the holidays, even though I'm French, it has to be turducken.

Roast turkey or roast beef?

Your career has taken you all over the world-from New York to Tokyo to London to Palm Springs. Why was **Beverly Hills the next step?**

I always wanted to work in Los Angeles; it made sense to me after Tokyo, London and New York. I really wanted to find a five-star hotel that was going to be the next step in my career, so when Montage Beverly Hills contacted me at the beginning of this year, I thought, That's the one I was looking for-because we all know what Montage is, and what its mission and vision are in terms of food and beverage. So for me it was the perfect match between what I was envisioning with my career and what they were looking for in an international chef.

What's your advice to home chefs planning their first holiday dinners?

I advise them not to overcook the turkey. Here in the U.S., [people use pop-up timers] that are put inside the skin and then, when the turkey is cooked, the timer pops out. But most of the time when [the timer] pops out, the turkey is already dry. Of course, it's all about the temperature of the oven and the size of the turkey, but most of the time it can be dry. The advice I have is to cook the turkey upside down so that

all the juices go to the turkey breast. And then 30 minutes before the time is up, flip it back, so the top of the skin can become crispy and beautiful for the pictures and



ing] the turkey upside down so the juices go inside the breast.

You're from Champagne, France. Tell us about.

I was born and raised in Champagne in a village called Troyes. I grew up gardening and going to the farm and going to get the snails directly from the fields. We used to go to our farm every weekend to get eggs and rabbits and chickens. My mom was a really good cook and she really developed

the passion I have for classic French dishes. Once a year, we would kill a pig—a very large, 500-pound-which was a festivity. With all the meat we'd make ham, pâté, blood sausages—we'd use the whole pig, basically. There was no waste.

Tell us about your family.

I live in Beverly Hills with my wife Hilary and our twelve-year-old son Lucas, who goes to Hawthorne.

What are you preparing for your family this Thanksgiving?

I will do the turducken, because we do it every year. My wife loves cooking, too,

so she does all the stuffing, desserts and garnishes, and I'm in charge of the plat de résistance. We always do Thanksgiving on the following Sunday because I'm a chef and I always work on Thanksgiving.

do you How define your cuisine?

I've always said that everybody can follow a recipe and cook. The [essence] of my cuisine is international and I'm very much influenced by the six years I spent in Tokyo; I use a lot of Japanese flavors. Japanese cuisine is very good at presenting things very simply. I think less is more-we don't need many

different ingredients and flavors to make a dish taste good. To me, simplicity is key, as well as choosing the right ingredients. You can't make a great chicken if the quality of the chicken isn't good. At Montage, we work a lot with our providers to make sure we [provide] the best to our guests in every kitchen.

In our 13th annual "Giving Thanks" issue, Beverly Hills resident Barbara Fleeman discusses her two-year journey to a cardiac microvascular disease diagnosis.

How did you find out you have heart disease?

I discovered the Barbra Streisand Women's Heart Center [at Cedars-Sinai Heart Institute], picked up the phone and called, not knowing if I could even get in. By that point, it had been two years that I had been going through this journey. I gave a brief synopsis of what I was experiencing. The next Thursday, I went in to see Dr. C. Noel Bairey Merz. She listened to my history and recommended I have a series of tests, including a cardiac MRI with nuclear stress. I was a little reluctant at first because I had just had so many tests, including a nuclear stress [test], and they [had] said it was all normal. It was explained to me that the coronary microvascular disease I have is very common in women and it's oftentimes missed and misdiagnosed because coronary microvascular disease doesn't show up in all the standard tests that they use to look for heart problems. I went back to her office a week later to look at the results and it just so happened that while I was at the office, I had a very serious episode where it felt like I was having a heart attack. She treated me right there and then gave me the result of my cardiac MRI, which was that I have coronary microvascular disease. After that, I underwent a cardiac catheterization and angiogram which showed the cause to be endothelial dysfunction. I finally knew what was hurting me after all this time. And now that I knew, I could move forward to treating it and becoming healthy again.

Your disease was misdiagnosed by doctors for two years. Tell us about that.

I remember that I started out with a chronic cough, that really wasn't a cough as we know it, and it was accompanied by a feeling of tightness and pressure right in the middle of my chest. In addition, I was experiencing shortness of breath, fatigue and insomnia. So I talked to my doctor and described what I was feeling and I was trying to be very specific. I was continually referred to doctors that were looking at every place but my heart, [even] when I would say, "My heart hurts." They continually tried to explain to me that what I was experiencing had nothing to do with my heart, and I just knew that there was something wrong with my heart. I know my body, and I think we all have to be our strongest protectors and advocates for our health.

The good news is I found an amazing gastroenterologist over at Cedars-[Sinai] hospital, Dr. Leo Treyzon; he's the clinical chief of gastroenterology there. He's been my protector during this frustrating journey. At the end of a year and a half of going to different doctors and having all kinds of tests, everything came back normal. Around this time I walked into Dr. Treyzon's office-I was in bad shape-and he just kind of looked at me and said, "I'm really worried about you." And I burst into tears. He said, "I've done everything that I can as a GI and more, and I'm not finding anything. I want to help you, so I'm open to suggestions if you have any ideas." I asked if I could see a cardiologist, so he referred me to a cardiologist, a very well-respected doctor. [The cardiologist] put me through every test he had at his office and actually had me go to a pulmonologist. I went back to see him about a week-and-ahalf later to learn the results of all my tests and he said my heart was perfect. When I asked why my heart hurt, he said he didn't know. Fortunately, shortly after that, I heard about Dr. Bairey Merz and the groundbreaking work she does in women's heart disease. I went to see her and that's when I started to get better.

Explain women's heart disease.

Even though it can be the same diagnosis, the symptoms [of heart disease] present themselves differently in women. A lot of doctors are simply not aware of what the symptoms are that are gender specific to women. Historically, and even up until now, a lot of the tests that you are given when you go into your doctor's office and complain of heart ailments or pains are tests developed for men using men as research studies—they've all been based upon a man's male pattern heart attack. In the past ten years, it's been identified that women have specific, different symptoms that these particular tests don't normally show.

What's your advice to women who are experiencing heart pain?

Call your doctor and arm yourself with as much information as you can to discuss with him/her at your appointment. If you are experiencing any of these symptoms and it's a life threatening emergency, call 911 and tell them you are experiencing a heart attack and need help.

Tell us about your work as a WomenHeart Champion with WomenHeart.org.

I'm a Women Heart Champion Community Educator. My role is to go out into the community and provide the information that WomenHeart.org offers, so that women understand how they can prevent the disease and what they can do to enhance their quality of life.

What are you thankful for this Thanksgiving?

I am thankful that I have my old life back; I'm thankful that I have my health; and I'm thankful that I have the ability, the foundation and the partnership with WomenHeart.org to share my journey with other women out there with the message that there is a light at the end of the tunnel.

UPDATE ON PAST "GIVING THANKS" PARTICIPANTS



ANGIE MATTOS, profiled in last year's "Giving Thanks" installment, issue #791, has been cancer free for one year and is expecting her first child December 26. Just last October, Mattos lost her tongue to cancer. Though doctors said she would likely never eat again, Mattos has made significant progress, eating everything from strawberry ice cream to sirloin steak to broccoli cheddar soup.

"One year ago today I was knocked out and they were cutting off my tongue, cutting into my throat and neck and my right arm and my left thigh," Mattos wrote on

Facebook October 22, the one-year anniversary of her life-altering surgery. Two months after Mattos underwent the 15-hour procedure that removed her tongue, she began chemotherapy and radiation. At first, Mattos subsisted on feeding formula, but she exceeded doctors' expectations by quickly moving on to more solid foods.

Mattos continues to document her emotional journey on Facebook, spotlighting both the hopeful moments and the frustrating ones. On July 7, she returned to her job at In-N-Out after nearly 11 months.

At her baby shower earlier this month, a beaming Mattos was joined by friends, family and her boyfriend of five years Albert Madrigal.

"I stand here one year later in love with life," Mattos wrote. "[I'm] doing all the things not promised to me: [speaking, eating, breathing on my own.] I am elated with happiness and love [and] also a baby on the way."



First profiled in the *Weekly*'s 2009 "Giving Thanks" installment, issue #530, **JACQUES MOUW** says his health has been "really great" since his recovery from stage four metastatic renal cancer.

Mouw, who said there is no sign of a cancer reoccurrence, was once told he only had 18 months to live. Today, the local jeweler enjoys spending time with

his family and playing golf at the Brentwood Country Club—nine years ago, those things were not on the horizon.

"It is truly a miracle that I survived stage four metastatic renal cell cancer," Mouw said. "It [has been] nine years now. [I] thank my supportive family and the wonderful doctors at Cedars Sinai hospital—positive thoughts are also important."



JAMES BRUBAKER, interviewed in "Giving Thanks" issue #373, passed away on January 2, 2014 at Harford Memorial Hospital in Maryland. He was 80.

After suffering from liver failure, Brubaker received a kidney and liver transplant in 2006 at Cedars-Sinai hospital. He later moved to Havre de Grace, Maryland with his wife Joyce, who predeceased him, and his grandson Brian. In the 2013 "Giving Thanks" follow up, Brubaker said

he felt thankful to be alive. He cited accomplishments like the release of his cookbook Classic World Cuisines, a

compilation of 125 recipes he accumulated during his travels abroad.



Shahs of Sunset star JESSICA PARIDO reflected on

her battle with leukemia in "Giving Thanks" issue #739. Diagnosed a week before her 15th birthday, Parido soon learned that her sister was a 10/10 bone marrow match. Four months after her initial diagnosis, she received a successful transplant.

Today, 26-year-old Parido, a registered nurse, says she has "never felt better."

"Once every other month, I do a four-day juice cleanse and I've also been doing a lot of detoxing and hot yoga," Parido said. "I had a checkup three months ago where they did a full scan of my body and I'm a 100

percent healthy." Parido feels thankful for friends and family who have supported her throughout her ups and downs.

AN ORDINANCE OF THE CITY OF BEVERLY HILLS AMENDING THE BEVERLY HILLS MUNICIPAL CODE REGARDING STREETS DESIGNATED FOR HEAVY VEHICLE

ORDINANCE NO. 15-O-2694

THE CITY COUNCIL OF THE CITY OF BEVERLY HILLS DOES HEREBY ORDAIN AS FOLLOWS

Section 1. The City Council hereby amends and restates Section 7-2-203 ("STREETS DESIGNATED FOR HEAVY VEHICLE USAGE") of Article 2. ("Commercial Vehicle Restrictions") of Chapter 2 ("TRAFFIC REGULATIONS") of Title 7 ("TRAFFIC, PARKING, AND PUBLIC TRANSPORTATION") of the Beverly Hills Municipal Code to read as follows: read as follows

7-2-203: STREETS DESIGNATED FOR HEAVY VEHICLE USAGE

A. The following streets are designated for use by vehicles having a gross weight, including the vehicle and its load, of three (3) tons or more:

Monica Boulevard; Doheny Drive; Foothill Road from Burton Way to Santa Monica Boulevard

(south); La Cienega Boulevard; Linden Drive from Wilshire Boulevard to Santa Monica

Boulevard (south); Maple Drive from Burton Way to Santa Monica Boulevard (south);

Olympic Boulevard; Rexford Drive from Santa Monica Boulevard (north) to Burton Way;

Robertson Boulevard; Roxbury Drive from Wilshire Boulevard to Santa Monica

Boulevard (north); San Vicente Boulevard

Santa Monica Boulevard (north roadway); Santa Monica Boulevard (south roadway except from Wilshire Boulevard to Beverly Drive); Third Street

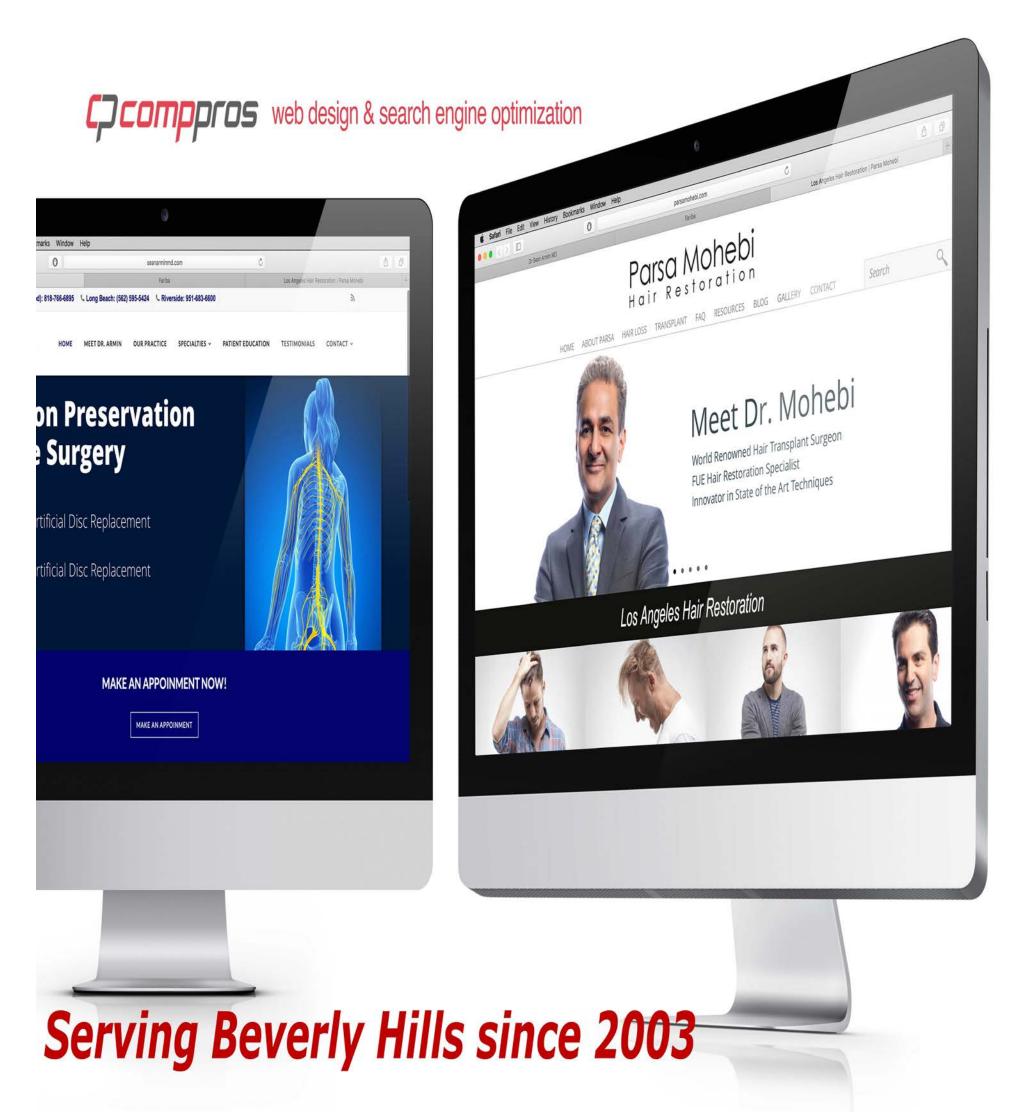
