Planning deliberates One Beverly Hills draft EIR; Peninsula objects

At a meeting last Thursday, the Planning Commission reviewed a draft Supplemental Environmental Impact Report (SEIR) for One Beverly Hills, the luxury development planned for the former Robinsons-May site.

“From our perspective, the Planning commissioners were very focused on the key issues and we thought many of them— if not all of them—had been addressed

through the EIR analysis and the information we provided,” said Athens Group COO Jay Newman.

The development is helmed by the Athens Group and partner the Wanda Group.

Unlike attorney John Peterson, who represents the Peninsula Hotel, the Commission did not identify any significant environmental impacts associated with the new project.

In a five-page letter May 12, Peterson outlined several objections to the draft SEIR, and called it “woefully inadequate.”

“The Beverly Hilton and Waldorf Astoria projects are 50 feet away from the proposed project,” Peterson wrote. “Together, these projects and their intended uses will turn this section of Beverly Hills into an area reminiscent of the Las Vegas strip.”

REMEMBERING A LEGEND RODEO DRIVE

On Sunday, Rodeo Drive paid tribute to the legendary fashion retailer and entrepreneur Fred Hayman, who passed away April 14 at the age of 90.

Newman said that all of Peterson's concerns are "properly" addressed in the draft SEIR.

If the Commission and the Council approve the final EIR, One Beverly Hills can set in motion plans to convert a portion of the previously approved project from condominiums and retail into a hotel with ancillary uses.

In April 2008, the city adopted the 9900 Wilshire Specific Plan and in December 2012, approved an administrative modification to the plan. The original project imagined 235 residential units and around 16,000 square foot of commercial building area.

The revised project tacks on a 134-room hotel and shaves off 42 residential units.

"I really want to thank you very much, because I know this is a huge project, and I appreciate you going through this process," said Commissioner Lori Greene Gordon.

The public comment period for the project is scheduled to end on May 31, which is when the city will prepare responses to any comments received and create a final EIR.

Commissioner Craig Corman recused himself from the discussion, because he is a member of Los Angeles Country Club, which is adjacent to the proposed project.

Avec Nous to remain open while Council reviews CUP

At Tuesday's meeting, the City Council adopted an "urgency" ordinance that will allow L'Ermitage dining facility Avec Nous

to remain open to the public while the Council reviews the Conditional Use Permit (CUP) pushed forward by the Planning Commission earlier this month.

"We're going to reevaluate the whole CUP that the Planning Commission put in place and look at all of it," said Vice Mayor Nancy Krasne, who had called up the Commission's decision. "I promise you I have made no decisions whatsoever—in any way shape or form."

Under normal circumstances, Avec Nous would have had to close its doors until the Council finished its assessment.

The French bistro closed to the public last month, after it was discovered it had been operating under a long-defunct CUP.

West Hollywood Mayor Lindsey Horvath earned the highest number of votes among female competitors in the 28th district. The top male vote-getter, Estevan Montemayor is Communications Director for LA City Councilmember David Ryu. Delegate Heidi Shink ran in last year's West Hollywood City Council election, but lost by approximately 800 votes to John Heilman.

Prominent civil rights attorney Gloria Allred received the second highest number of votes among female candidates in the 33rd district, behind former Assemblymember Betsy Butler (D-Marina Del Rey).

Mirisch proposes change in hiring process for department heads

At Tuesday's study session, Mayor John Mirisch requested the city restructure its procedure for hiring top management staff.

"I look at it as a way to help establish institutional control, and I think we've lost some of that," Mirisch said.

Currently, all department heads are selected at the discretion of City Manager Mahdi Aluzri. Mirisch would like councilmembers involved in the process and requested that they be given the authority to approve the selections.

"I do believe that our oversight and our scrutiny of what happens is important, and I actually do believe in the concepts of advise and consent, and in this particular case I really do think that our role is to advise," said Councilmember Julian Gold.

Though the matter was discussed at two separate meetings in 2013, a formal policy has not yet been developed.

Beverly Hills operates under a "council-manager" form of government, meaning Aluzri acts as the chief administrator with the vested authority of hiring, evaluating and terminating department heads. The Council carries the ability to fill the City Manager, City Attorney and City Clerk positions.

In 2007, more than 3,500 of the 7,171 U.S. cities and towns with populations of 2,500 residents or more operated under the council-manager form.

The cities of Bell, Huntington Beach, Torrance and Vernon align with the "council-manager" structure, but allow more room for Council input and approval. In the City of Torrance, for example, the Council is able to appoint the Director of Finance upon the City Manager's recommendation.

The Council expressed interest in pursuing Mirisch's request, meaning that staff will begin working with the City Attorney's Office on developing alternatives for the selection and retention process.

As members of an ad-hoc committee, Vice Mayor Nancy Krasne and Councilmember Lili Bosse will "work out

the specifics," according to Mirisch.

Wenker named Beverly High AP

Formerly Assistant Principal at Malibu High, Philip Wenker was appointed Beverly High AP last week.

Beverly High Principal Dave Jackson joined district on the heels of an interim principal position at Malibu High, which he held for one year. Jackson's son Gregory was appointed to a counselor opening at the high school in March.

Wenker will replace former Assistant Principal Kevin Brown, who was recently named athletic director.

Replacing Renee Cobbs, Luke Pavone was named Beverly High Assistant Principal last month.

Tuesday's Council talks reveal several issues with application process

Earlier this month, the City Council approved the application process for selection of Willie Brien's successor. And although the option was viewed as being more streamlined than a full-blown election, Tuesday's Council discussion revealed several issues associated with the application route.

The Council plans to set aside one day to publically interview all applicants during a town hall meeting. But, as Mayor John Mirisch pointed out, if the number of applicants increases significantly in the next few days, it will be difficult to carry out the interviews in one session.

As of Wednesday, Ann Anooshian, Barry Pressman, Alexandra Polin, Deborah Termeie, Kevin R. Davis, Jerrold Felsenthal, Myra Demeter, Gloria Seiff, Sidney Aaron Green, Darian Bojeaux and Barbara Linder had submitted applications. Forms can be found on the city website and are due May 20.

The city has reached out to homeowner's associations soliciting input on the questions they would like asked. Residents have until this Friday to submit their questions.

Mirisch has recommended the Council ask the following questions: Why did you apply for this Beverly Hills City Council appointment? Why do you feel you are the most qualified to serve? What do you hope to achieve?

Though applicants must state whether they plan on running in the March 2017 election, the pledge is not legally binding. Brien's replacement will serve for the remainder of his term, which will end in March 2017.

BHHS swimmer wins two Southern Section championships Normans finish sixth in finals

Amy Okada won the 100-yard butterfly and 50 freestyle and swam legs on two Beverly High relay teams that set school records in the Southern Section Division 3 girls' swimming and diving finals last Thursday.

Okada won the 100 butterfly in 53.96 seconds, .03 a second off the meet record set by Ella Eastin of Crean Lutheran in 2012. Okada won by 2.49 seconds over Pasadena Poly junior Gabriela Maarse.

Okada swam the opening 50 in 28.53, putting her 1.86 seconds ahead of Templeton junior Amanda Wilson, who was second after the first 50 and finished third.

Okada won the 50 freestyle in 23.49, 0.82 ahead of Pasadena Poly sophomore Grace Carey in the meet at the Riverside Aquatics Complex at Riverside City College.

Okada, who has signed a letter of intent to accept an athletic scholarship from UCLA, was 0.1 off the meet record set by

Lindsey Engel of Crean Lutheran in 2013.

Okada swam the opening leg on the Normans 200 freestyle relay team that finished second in a school-record 1:40.51. Pasadena Poly won in 1:39.70.

Okada swam her leg in 23.63, which put Beverly Hills in first. The Normans remained in the lead thanks to junior Jacqueline Dumouch swimming her leg in 25.44 and freshman Eugene Chi swimming her leg in 26.05. Senior Skylar Smith swam the final leg in 25.39.

Okada also swam the opening leg for the 400 freestyle relay team that finished fifth in a school-record 3:40.43, .24 behind fourth-place Marlborough. Pasadena Poly won in 3:35.74.

Jamie Dodd, who has signed a letter of intent to accept an athletic scholarship from San Jose State, Dumouchel and Smith swam the other legs.

Dodd was the only other Beverly Hills swimmer to swim in an individual final, finishing ninth in the 500 freestyle in

5:16.53. She was also 16th in the 100 butterfly in 1:01.78.

The Normans were sixth in the team competition, four spots higher than 2015, with 129 points, seven behind fifth-place Sierra Canyon. Pasadena Poly won with 361.

Boys' Swimming

Southern Section Division 3 Finals

Junior Greg Ayzenberg tied for third in the 100 freestyle and swam the opening leg on Beverly Hills 400 freestyle relay team that set a school record last Thursday at the Riverside Aquatics Complex at Riverside City College.

Ayzenberg swam the 100 freestyle in 47.98, tying Webb senior David Albers. Nate Biondi of Sierra Canyon won in 46.57 and Andreas Langen of Flintridge Prep was second in 46.65.

The team of Ayzenberg, senior Daniel Choi, senior Shota Ishizawa and sophomore Seong Min Youn were fifth in the 400 freestyle relay in 3:16.18, a school record.

The team of Ayzenberg, Choi, freshman Alboroz Hosseini and Ishizawa were seventh in the 200 freestyle relay in 1:30.76.

Ishizawa was 12th in the 200 individual medley in 2:00.60, junior John Kim 13th in the 100 breaststroke in 1:02.95, Youn was 13th in the 100 backstroke in 54.63 and 15th in 100 butterfly in 53.92.

The team of Youn, Kim, Hosseini and Choi were 16th in the 200 medley relay in 1:43.52.

The Normans finished 11th, 17 spots

higher than 2015, with 106.5 points, 7.5 behind Temescal Canyon, which finished 10th and 8.5 behind Sierra Canyon and Webb which tied for eighth. Walnut won with 209 points.

Ocean League Finals

Kim won the 100 breaststroke in 1:02.77, finished third in the 500 freestyle in 5:32.69 and swam legs on the 200 medley and 400 freestyle relay teams that finished second in 1:42.36 and 3:40.43 May 5 at the Swim-Gym.

Beverly Hills finished second in the team competition with 326 points. Santa Monica won with 397.

Boys' Track and Field Ocean League Finals

Beverly Hills senior Rashad Ysaguirre won his second league championship in four days, with a discus throw of 126 feet, 10 inches, May 5 at Culver City High.

Ysaguirre had won the shot put three days earlier, in an event teammate Solomon Nwankwo finished second, also qualifying for the Southern Section Division 3 Prelims.

Junior Jonathan Cohen was the other Norman to qualify for the Southern Section Prelims in an individual event, finishing second in the 1,600 meters in 4:26.89 and third in the 3,200 in 9:54.45.

The Beverly Hills 400 relay team of Stanley Wu, Carl Wehba, Jordan Getty and Brandon Kim qualified with a third-place finish in 44.66.
