Council to take up issue of slow mail delivery

At the Dec. 20 study session, Mayor John Mirisch requested City Council discuss concerns with the United States Postal Service in Beverly Hills.

Recently, Councilmembers have received several complaints from their constituents regarding ongoing mail delivery issues from the Beverly Hills Post Office, according to the staff report.

"Specifically, the Beverly Hills Post Office has lost mail, been late in delivering mail, delivered mail to incorrect addresses, long lines and wait time, and other service delivery and customer service relate issues," the staff report from Senior Management Analyst Cynthia Owens stated.

The report also noted city staff discussed the issue with the City's federal lobbyist and examined potential avenues for resolution.

Options suggested included:

• Meeting with local Post Office staff.

· Sending letters on behalf of the City to Congressional representatives and the Postmaster General detailing the City's concerns.

• Through the City's federal lobbyist, arrange to meet with Congressman Ted Lieu and Post Office staff in Washington, D.C.

• Requesting the community become involved by reporting mail delivery issues to the U.S. Post Office by calling (800) 275-877 or visiting usps.com.

· Asking the community to directly contact Lieu by sending letters to his field office at 5055 Wilshire Blvd., Suite 310 Los Angeles, CA 90036.

Recently the Beverly Hills sorting location was moved to the West Hollywood facility, so letter carriers now travel from a further location.

The item was on the Dec. 20 study session agenda; however, the Council ran out of time during the meeting before they could deliberate on the issue.

Planning Commission approves changes to second unit regulations to follow new state law

The Planning Commission adopted an ordinance during its meeting on Dec. 8 amending the City's Municipal Code to update second unit regulations pursuant to changes in state law.

The Commissioners approved the ordinance by a 3-0 vote. Commissioners Alan Block and Howard Fisher were absent.

The law changes the terminology from "second units" to "accessory dwelling units," which are defined as units containing independent living facilities on a property such as a kitchen, bathroom, living room, and usually a bedroom according to Associate Planner Timothea Tway.

"Sometimes people refer to guest houses or cabanas [as accessory dwelling units], [but] those are different," Tway said."Those would not be impacted by these regulations. These regulations only pertain to units on a property that have a kitchen and a bathroom facility."

Chair Joe Shooshani and Commissioner Lori Greene Gordon agreed the ordinance will provide the City with the most protection possible while also abiding by the state's law.

"I think it's very good for the entire state," Shooshani said. "As the Planning Commission for the City of Beverly Hills, I see it as a problem for us. It's going to [increase] density, but this is something we have to do as a state."

Commissioners also asked that staff include a recommendation regulating the length of time individuals can rent out their accessory unit dwellings and requiring them to register and pay taxes on these rental units.

'Our recommendation is that specific means be exercised to inform people of their responsibilities to register and pay taxes on these units if they are renting them out," Greene Gordon said.

Some of the additional changes include allowing accessory dwelling units converted from existing garages or other accessory structures to have no setback requirement (expect those required for building and safety reasons), allowing an accessory dwelling unit on an R-4 lot that houses a singlefamily dwelling unit, and allowing parking for accessory dwelling units to be provided on an existing driveway, according to the

Oakhurst Drive), with a majority portion located in the City of Los Angeles (easterly portion). The proposed project would have a maximum height of 3 stories and 39' for the portion of the building located in Beverly Hills, and a maximum height of 4 stories and 52' for the portion of the building located in Los Angeles. The portion of the building located in Beverly Hills would contain a total of 7 units, with the remaining 19 units located in Los Angeles. Approval of the project requires approval of a Vesting Tentative Tract Map and a Development Plan Review.

The Planning Commission, at its regular meeting on October 13, 2016, voted 2-1 to conditionally approve the requested Vesting Tentative Tract Map and Development Plan Review. On October 24, 2016 an appeal of the Planning Commission's decision was filed. On November 15, 2016, the City Council voted to set a public hearing regarding the appeal for the January 10, 2017 City Council meeting.

ENVIRONMENTAL REVIEW

This project has been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the environmental regulations of the City. The subject property is partially located in the City of Beverly Hills, with a majority portion located in the City of Los Angeles. As the designated lead agency for this project, the City of Los Angeles prepared an Initial Study to determine the proposed project's potential impact on the environment. After reviewing the Initial Study, the lead agency determined that this project may have a significant effect on the environment, but by implementing certain mitigation measures, the project's potentially significant effects could be reduced to less than significant levels. Accordingly, a Mitigated Negative Declaration (MND) was prepared and adopted by the City of Los Angeles. The City of Beverly Hills, as a responsible agency, will consider the MND prepared and adopted by the City of Los Angeles.

At the public hearing, the City Council will hear and consider all comments. All interested persons are invited to attend and speak on this matter. Testing shows Beverly Hills drinking fountains in compliance with EPA lead requirements

The Public Works Commission received an update at its meeting on Dec. 15 on the lead sampling that was done from the City drinking water fountains located in parks, buildings and schools.

The testing for lead was to confirm that all public drinking water fountains are in compliance with the Environmental Protection Agency lead requirements, according to the staff report.

All 70 of the City-owned public drinking fountains were tested, according to Assistant Director of Public Works Chad Lynn. Water Quality Specialist David Hillyer reported the results show all samples were well below the action level set by the EPA.

"Residents, students, customers and visitors can have continued confidence that lead is not an issue in our entire system," Hillyer said.

The collection of samples was performed in three phases. Staff coordinated with the BHUSD to collect samples from each of the schools. All samples went to an indepen-

dent State certified laboratory for water quality validation, according to the staff report. The testing was prompted because several years ago Los

Angeles schools were surprised to find some drinking fountains had higher levels of lead than what is considered healthy, according to Commission Chair Sandra Aronberg.

In 2008, a sampling of drinking fountains at schools in the Los Angeles Unified School District, found amounts of lead up to

Fine Arts Commission receives extra \$250.000 in new development agreement

An additional \$250,000 was allocated to the Fine Art Fund from the Public Benefit Contribution following City Council's approval of One Beverly Hills' development agreement on Nov. 29.

At the Dec. 15 Fine Arts Commission meeting, staff explained the additional monies were paid by the developer, Wanda Group, to the City as part of the new development agreement.

The added \$250,000 brings the total payment to \$500,000, according to the staff report.

Because development agreements supersede the Fine Art Ordinance, Chair Alan Kaye asked if it is possible for staff to notify the Commissioners when future development agreements are being negotiated at public meetings.

However, Community Services Director Nancy Hunt Coffey explained "that has never been the process to date."

"Staff and Commissioners are not involved in negotiation of developer agreements," Hunt Coffey said. "There's not really a request for public commissioner feedback."

The Commissioners and staff also discussed the gateway project. Prior to issuance of Certificate of Occupancy for any portion of the One Beverly Hills project, the developer is required to construct or install two "gateway statements" to enhance the significance of the entry to Beverly Hills, according to the staff report.

One gateway statement will be located along Wilshire Boulevard and the other will be located along Santa Monica Boulevard.

The Architectural Commission is responsible for reviewing and approving the proposed gateway statements. However, if the proposed gateway statements include public art then the Fine Arts Commission shall review and approve the art prior to its installation.

City Council presents proclamation to Israeli war heroes

City Council presented a proclamation to two heroes of the Israeli War of Independence at the study session on Dec. 16. Mitchell Flint and the late Aaron "Red" Finkel, both former Beverly Hills residents, were honored for their extraordinary contributions to the formation of the state of Israel.

Entertainer Pat Boone spoke about the birth of the Israeli Air Force.

Finkel and Flint, both World War II veteran pilots, were founding members of "Machal," a group of non-Israelis who fought in the 1948 War for Independence and whose heroism contributed directly to the creation of the nation of Israel. They also were original members of the Israeli Air Force's first fighter squadron and helped train Israel's first military pilots.

Traffic will be temporarily re-routed during the installation to Merv Griffin Way or South Santa Monica Boulevard.

What's it like to be in the Electoral College? Laurence Zakson California elector (28th District)

"I have spoken out

publicly for the

abolition of the

Electoral College"

Tell us about how you became an elector.

In California our [national] senators and members of Congress [select the electors.] If you are a democrat, that's how

democrat. Our member of Congress [in West Hollywood] is Adam Schiff and he selected me. I expressed interest in this and he knows me because

I'm a member of the Democratic National after that we passed one resolution, which Committee.

Describe what happened on Monday in Sacramento.

Interestingly, there was a big protest outside the Capitol building as we got there. [Protestors] were calling on electors to reject [President-elect Donald] Trump. Obviously none of the California electors were voting for Trump, but that was what the demonstration was.

We walked past that. Then we checked in at the Governor's Council Room, which was quite a nice experience. After, we

went into the Assembly Chamber and we were convened by the Chair of the Assembly Rules Committee, given the oath of office by the Secretary of State, elected our internal officers, and then we you are selected for any seat held by a cast ballots for president on one paper and a separate ballot for

vice president.

Those were tallied at 55 each for [Presidential candidate Hillary] Clinton and [running mate Tim] Kaine. Then

I was fortunate to second, calling for the investigation of Russian interference in the U.S. elections.

As you know, electors have been in the news lately. Members of the Electoral College demanded a briefing from U.S. intelligence officials on any ongoing investigations into Trump's ties to Russia. Did you think this was warranted?

I was one of the 67 electors who signed the letter. The Beverly Hills Congressional District Representative Ed Buck did as

well. What I know and what I've heard is that the use of all this technology is an aggressive move by Russia. I think we need to know why they're interfering in our election, or trying to. That is both important for the integrity of our elections and important for our national security.

Several of the California electors were children or grandchildren of members of Congress. Do you think it's inappropriate to choose electors based on any criteria other than merit?

We saw this time seven people [out of 538] were faithless electors. What that means is that there are people who were elected by the people in their states to vote for a particular candidate and didn't do that and didn't select another candidate who was also voted on by the voters in their state. Instead, they voted for some person of their own choosing.

I think that one of the reasons why you end up getting people selected the way that they are is because the people who are making the selections are looking for folks they can rely on to carry out the will of

the voters. Sometimes that means they're picking people that they know very well, which could be relatives or other people that they know very well. It's a great honor to represent your state and I certainly support the idea of spreading that opportunity out among as many people as possible.

How do you feel about proposals to abolish the Electoral College?

I have spoken out publicly for the abolition of the Electoral College. I am working on a resolution I am hoping to present to the Democratic National Committee to call for the abolition of the Electoral College. I think that it is remnant of a time when the South was over represented because of the Three-Fifths Compromise. They were suspicious of directly electing people to the White House in part because the North was more populous and it still remains the case that less populous states have disproportionate influence. I don't think that it's warranted.

After having cast your ballot, do you feel like you did your civic duty?

I do. I feel like I did what the people of California elected me to do. I was very proud to vote for Secretary Clinton and Senator Kaine and I still think she would be an excellent president and he would be an excellent vice president. I did go with my spouse Peter Kreysa and my two nieces Abri and Zara Aiken. They came to watch and witness democracy in action and that was also very special for me. I know that everybody else who brought guests also found it to be a special occasion.

Incoming President John Jameson on what's coming up for the Maple Counseling Center in the New Year

You grew up in Beverly Hills. Your background is in legal recruiting. Tell us about that.

I went to Hawthorne and then Beverly High. I went up north to go to Berkeley, [and then] came back down to go to USC where I got a J.D. and an MBA. I moved back to Beverly Hills in 1997.

I'm a lawyer, but almost 30 years ago I became a legal recruiter. My company is the Jameson Group and we're located in Beverly Hills. I specialize in recruiting and placing very high value partners at law firms.

I chaired the legal division of the Jewish Federation. I'm the past president of Hillcrest Country Club. I also participated in the Team Beverly Hills program. I've been involved in a lot of various programs in the community.

I was in high school from 1970 to 1974, and the Maple Center was actually formed while I was at Beverly High in 1972. It was formed to deal with drug and alcohol problems, which were affecting a lot of local school children at that time.

I've known the Maple Center name since I was a sophomore in high school. A number of my classmates, all who were class of 1974, have also been involved [with the Center]. Mason Sommers, who I have known since elementary school, was the president for many years. He and also one of my very close friends Jeff Lapin got me involved. Jeff was the immediate past president of the Maple Center. [See the Weekly's interview with Lapin in Issue #743]

And prior to Jeff, Gail Millan, who is also a classmate, was a past president. Prior to Gail, it was Mason.

Mason, Jeff and I actually used to play in a band together when we went to Hawthorne. We're all really interconnected and our particular high school Class of '74 has a number of people that have been involved with the Center.

What's new at The Maple Counseling Center?

At the Maple Center, we're not only trying to figure out how we can continue our current programs and counsel as many people as possible, but we're also trying to work to expand the programs. We had a full strategic plan put together highlighting [how] we can expand the programs, [how] we can help service more clients, etc. For example, we're looking at expanding kids programs possibly [by growing] Community Circle. Community Circle is the program where we go into the schools and help kids by dealing with issues like bullying.

We're entering into some new partnerships with outside agencies to expand our reach. We're beginning a partnership with Alexandria House, a transitional shelter for women and children located in Koreatown.

We've talked about getting more involved in the addiction area, which requires special expertise and programming.

Right now, our space is located on the corner of Doheny and Wilshire and our lease is running up. We're not sure if the building is going to extend our lease although we hope they will. We're also very actively looking to find a new space. We're doing everything we possibly can to stay in Beverly Hills because that's our home. [But] spaces for about 10,000 feet that we can afford are fairly limited.

Of course, if any of your readers has a building about 10,000 feet that they want to talk to us about we would love to chat with them.

What did you learn from outgoing board president Jeff Lapin?

We're best friends. Jeff is an exceptionally smart guy and a terrific businessman. He calls himself a change agent. I know it was his goal to help [the Center] solidify [its] funding and I learned a lot watching him in that regard, especially when it came to financial analysis.

My strengths are different from Jeff's. I'm more on the people person side, in terms of pulling the programs together. Jeff really did a terrific job getting us more financial stability, even though it's always a struggle to raise money in the mental health area.

We've been able to put together a wonderful board. It's a meaningful place where your input makes a difference in what the organization does. Watching Jeff was a great learning experience for me.

Organizations need different people leading them at different times, and I think Jeff was absolutely the right person to lead the Maple Center for the last several years. I think I'm a good choice, right now, to follow up on all the things Jeff was able to do.

What are your priorities this term?

First of all, as incoming board president, I want to thank everybody that's been supportive of the Center: our board, our CEO Marcy Kaplan and all the staff. But I also want to thank the City of Beverly Hills, and I want to thank Cedars-Sinai because they have both been long-term supporters of the Center in many ways but especially when it comes to funding. We have a lot of people and companies who have been long-term supporters, but truly nobody more important than the City and Cedars.

Right now, priorities are in flux because for every program you add you've got to figure out financially how to support it and raise money for it. There are a number of programs we're involved in that include counseling for individuals, couples, families and groups. There are so many [additional] areas of need.

We're really looking to figure out how we can give more counseling to children through Community Circle or other programs. We've also considered the idea of developing a program to help kids who have addiction because that is rampant in the country, certainly in our community and in Los Angeles.

That also requires many additional features and funding that we have to figure out before we make a decision in terms of going that route. The strategic plan was completed only about two months ago and the new board needs to look at it and set our priorities.

First and foremost is the space, as I mentioned, but then we'll really be able to focus our attention on continuing the current programs, giving first rate training to the interns, and looking at where the need is. There's so much need for mental health counseling and so many people who simply can't afford it.

[With the new administration], organizations like the Maple Center where anybody can get counseling regardless of how much they can afford to pay are going to become even more important. We have to figure out how to serve more people and be available to more people.

Former President Gail Millan told the Weekly, in Issue 733, "The biggest issue right now that [TMCC] is facing is really location. [We] really need to settle on our home so we're currently negotiating and hoping we'll be able to stay here. [We] may need to move outside the borders, but Beverly Hills adjacent." Will the center be staying in Beverly Hills?

It is by far the biggest issue I will be facing in the beginning of my term. I'm officially starting in January and our lease runs out in four or five months. We are actively looking for space in Beverly Hills. We're hopeful that our building will consider extending our lease. We are also looking in Beverly Hills adjacent. We're really looking at any possible space that's big enough to house our need.

Without the space there is no Maple Center, so absolutely it is the primary issue.

When Gail was president, we were running into this issue and at that time we were very happy that our landlords extended our lease. That extension is now coming due, so that's why we're in the current situation again.

You also previously served as the Hillcrest Country Club President. What made you want to serve on that board?

My dad [Irwin Jameson] was very involved with Hillcrest Country Club. He loved Hillcrest and served on the board for many years.

Growing up, I could never figure out why he was gone for so many hours on Wednesday nights at these meetings. As I became older and became an active member at the club, my dad wanted me to become more involved. He enabled me to serve on the board and on the admissions committee at a younger level.

The truth is, I had never thought about serving on the board but when some friends made it known that I may be a good person for the board I went and asked my dad about it. Even though at that time he couldn't really speak, his eyes lit up.

I was lucky enough to be selected by the board to become the president, which I really do consider to be a true privilege because very few people have that experience.

What impact has TMCC had on Beverly Hills?

The Maple Center was created while I was in high school and drugs and drinking was a big problem back then in the early '70s. [That's part of] why the parents made the effort to create it. It's existed ever since then.

What's interesting is so many people in the City and the surrounding area know the name but it's shocking how few people really know what the Center does. They don't realize, not only is it a place where anybody can get counseling, but it's also one of the top training centers in the country where psychologists get their necessary training to become licensed.

In many ways, the impact is probably broader than people realize.

It consists of approximately 50,000 square feet in one story, two story and three story portions of the building.
