779 residents sign up for community dog park

Since opening on Sept. 6, 969 dogs have been registered to use the Beverly Hills Community Dog Park, according to the Recreation and Parks Commission staff report.

At the Commission's special meeting on Dec. 13, Management Analyst Stephanie Harris reported there have been 7,787 recorded dog visits as of Dec. 6.

Staff has also received requests, applications and calls expressing interest from nonresidents to use the dog park. There have been 148 inquires from non-residents, including those who have gone to the park trying to get in and those who have tried to register online.

"We were noticing that if you [live on]

streets that cross through Beverly Hills, but are technically in West Hollywood there was an ability for you to register," Harris said. "As I verify addresses daily we contact those individuals to let them know at this time the park is open to residents, those that are working inside the City limits, hotel guests and [guests of residents]."

Harris also explained to the Commissioners that there have been two minor incidents, which required administrative staff to follow up on the wellbeing of the dogs. An incident of aggression caused the City to place a temporary 30-day ban on one dog's access to the park.

"We've been working with Code Enforcement to set up a meeting with the City of Los Angeles Animal Control," Harris said. "We will be meeting with them next month to hash out some other details. But we wanted to check protocol [before allowing the dog to return to the park.] The dog was placed on a 30-day hold until we got more information, but the dog was a little hyper and everything seemed to work out fine. The dog is welcome back."

A separate incident occurred where a dog was scratched by a structural metal bolt in a park bench. The dog received eight stitches for a cut over its eye, according to Chair Frances Bilak.

"Somebody very kindly on their own had gone and put some electrical tape on some of the benches but the benches at the small dog park are still exposed," Bilak said.

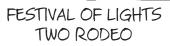

Harris assured the Commissioners that a request with facilities was made right away and the bolts will be shaved down as much as possible. It was also suggested they receive rubber caps to prevent additional injuries.

"I think we need to do something because certainly it's a hazard," said Vice Chair Susan Gersh. "[There could be another accident] and someone may not be as kind, feeling that we knew about the problem and have been negligent which we will have been if we don't do anything.

The dog park is notably more active in the early morning hours, between the 8:00 a.m. to 10:00 a.m. timeframe, then slower during the afternoon hours. Dog use increases in the early evening with the 5:00 p.m. to 7:00 p.m. hours being the busiest, according to the staff report.

It was the City Council's direction to have rangers present at the park during all working hours during the first six months of operation, which will conclude at the end of February 2017.

Staff will conduct a survey to gather additional information and compile for a comprehensive report on park usage, the facility, and any concerns and or suggestions patrons may have regarding the dog park, according to the staff report.

Potential survey question include park hours, number of visits a week, duration of visits, registration process, amenities at the park, park capacity and safety.

Staff is expected to report survey findings to

the Commission at the January meeting seeking recommendations for the future operations of the park that can then be presented to Council in February.

City Council divided on internal/promotional recruitments

SUMMARY OF ORDINANCE NO. 16-O-2719

AN ORDINANCE OF THE CITY OF BEVERLY HILLS ADOPTING AN ADMINISTRATIVE CODE AND ABATEMENT OF DANGEROUS BUILDINGS CODE, AND ADOPTING BY REFERENCE THE 2016 CALIFORNIA BUILDING CODE; THE 2016 CALIFORNIA RESIDENTIAL CODE; THE 2016 CALIFORNIA ELECTRICAL CODE; THE 2016 CALIFORNIA MECHANICAL CODE; THE 2016 CALIFORNIA PLUMBING CODE; THE 2016 CALIFORNIA ENERGY CODE; THE 2016 CALIFORNIA FIRE CODE; THE 2016 CALIFORNIA HISTORICAL BUILDING CODE; THE 2016 CALIFORNIA HISTORICAL BUILDING CODE; THE 2016 CALIFORNIA REFERENCED STANDARDS CODE; THE INTERNATIONAL PROPERTY MAINTENANCE CODE, 2015 EDITION; INCLUDING CERTAIN AMENDMENTS, ADDITIONS, AND DELETIONS, AND AMENDING TITLE 9 OF THE BEVERLY HILLS MUNICIPAL CODE

This is a summary of the above entitled ordinance of the City of Beverly Hills. This summary has been prepared and published in accordance with the requirements of Government Code Section 36933.

This ordinance adopts the Beverly Hills Administrative Code and Beverly Hills Abatement of Dangerous Buildings Code and adopts by reference the 2016 edition of the California Building, Residential, Electrical, Mechanical, Plumbing, Energy, Fire, Green Building Standards, Historical Building, and Referenced Standards (collectively known as the California Building Standards Code, 24 C.C.R., Parts 1 through 12), as well as the latest edition of the International Property Maintenance Code, together with certain amendments, deletions and additions.

The California Building Standards Code, as amended, establishes requirements for the structural, plumbing, electrical and mechanical systems of buildings and structures, including historic buildings, fire and life safety, water conservation, energy conservation and sustainability. The new City amendments include; changes to wood, structural steel, and seismic design provisions. The other codes and administrative provisions adopted establish standards for property maintenance.

SUMMARY OF ORDINANCE 16-O-2720

ANURGENCY ORDINANCE OF THE CITY OF BEVERLY HILLS AMENDING THE BEVERLY HILLS MUNICIPAL CODE TO UPDATE SECOND UNIT REGULATIONS PURSUANT TO CHANGES IN STATE LAW, INCLUDING TERMINOLOGY FROM SECOND UNITS TO ACCESSORY DWELLING UNITS

Mayor Mirisch, Vice Mayor Krasne and Councilmembers Bosse, Gold and Reims voted for the adoption of the Ordinance (Ordinance No. 16-O-2720). The Ordinance goes into effect immediately upon adoption. A summary of the Ordinance, which has been prepared for publishing in accordance with the requirements of Government Code Section 36933, follows.

Summary of Ordinance

The Ordinance includes but is not limited to, modifications to BHMC 10-3-409 to ensure compliance with newly adopted state law (SB 1069 and AB 2299) pertaining to regulation and permitting of accessory dwelling units, and to replace the term "second unit" as used in the Municipal Code with a new term "accessory dwelling unit". Changes resulting from the Ordinance include modifications to accessory dwelling unit parking requirements and configuration of parking on a site, accessory dwelling unit setback requirements, as well as accessory dwelling unit size requirements.

The Ordinance also includes modification to procedures for review of applications for accessory dwelling units, and requires that the City approve or deny by-right applications for accessory dwelling units within 120 days of receipt of the application. Further, the Ordinance modifies regulations pertaining to the charging of utility connection fees and the installation of fire sprinklers for certain accessory dwelling units, among other things.

He also challenged the integrity of the staff report because it did not include the total number or percentage of open recruitment positions given to applicants already employed by the City.

"That's basic information we should have provided because I think you will find that a significant percentage of employees who got jobs in an open recruitment process were current employees," Mirisch said. "You gave slanted information here."

Reims suggested Mirisch follow up with staff if there is additional information he'd like to discuss during the meetings.

"If you want further information, ask for it and you'll get it," Reims said. "It's disrespectful to attribute a certain agenda."

Staff is expected to return to the Council with the additional information.

Health & Safety Commission works on strengthening City's current smoking regulations

The Health and Safety Commission continued working on strengthening and expanding the City's current smoking regulations at its meeting on Dec. 19.

At the Dec. 6 City Council study session, Staff presented information on the City's cur-

> rent smoking regulations and the Council tasked the Commission with exploring potential areas where the regulations could be made stronger, including open air dining, hotels, sidewalks and a complete ban in public areas.

Recently. the Commission has also been working on drafting an ordinance regulating smoking in multi unit housing.

Each year, the American Lung Association issues its

State of Tobacco Control report, which designates a letter grade to local cities on their overall tobacco regulations. Currently, the City has a designated "C" grade for not having smoking regulations in multi-unit housing, according to the staff report.

Once a policy is in place, it is expected that the American Lung Association will designate a local grade for the City as an "A" as this is the last major section of smoking regulations within the City.

Additionally, the staff report discussed a potential citywide ban on smoking by examining two cities currently implementing citywide regulations.

Manhattan Beach prohibits smoking in all public places, places of employment and any area within 20 feet of any door, window, opening or vent into a public place except for such areas on private residential property, according to the staff report.

The report also noted Calabasas regulates smoking everywhere in the City, including but not limited to public places, places of employment, multi-unit residence common areas and enclosed/ unenclosed places of hotels, businesses, restaurants, bars and other public accommodations.

"Calabasas does not have the international visitors; they do not have the hotels," Commissioner Myra Lurie said. "It's not a fair comparison. I know that we will want to be very balanced recognizing that we are dealing with a lot of international visitors."

Lurie noted during the meeting that state law currently permits smoking in up to 20 percent of guest rooms in any hotel or motel; however, the City has the power to modify this law and make it more restrictive. She requested staff return to the Commission with more information regarding the hotels' occupancy in rooms where smoking is available.

The Council also approved an ordinance on Dec. 20 amending the municipal code to prohibit smoking in Beverly Canon Gardens and codifies a smoking prohibition in City parks

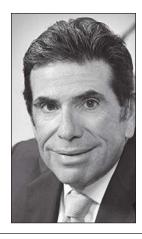

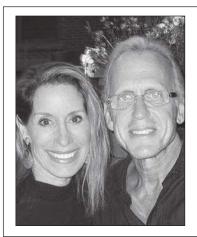

Barrett graduated from Beverly High in 1969. She got her start in public service in Beverly Vista's student government. In high school, she served as ASB secretary and junior class secretary. Her other activities included Highlights and Girls League.

What are some of the initiatives and priorities that you're working on at the moment?

I'm very interested in tourism, natural resources and agriculture as economic engines. I very firmly believe that the things that are the assets of the region, same things that can be the economic drivers. We have been working on several different initiatives around agriculture, around tourism and making sure that we preserve the farmland so that it doesn't get built over and turned into shopping malls or parking lots, which is something we have to fight to do.

[We're] working [with one of our community colleges] on training the next generation of tradespeople to work on our historic properties. We have some of the same challenges you have [in Los Angeles] around mental health and substance abuse. Those are also initiatives that I'm quite involved in.

You have been meeting with constituents on your Diner Stop Tour. What [have you] learned from meeting them?

We happen to have these great iconic diners throughout the Hudson Valley, so I've made it a signature initiative to travel around my district and create a

> mobile office in these diners. It's one of the favorite things that we all do. We buy coffee and tea and people come and talk to us about absolutely everything.

> Sometimes it's just issues in the community at large that they want us to know about or want our help on. Every year we start up again and do the circuit. It makes it convenient for [constituents] to come. [My team and I] walk down the main streets of the little communities, see what's going on and get that firsthand look, and then we support a local business, which we love doing. It's a win-win-win.



[You serve as first vice chair of] the Legislative Women's Caucus. What are you working on with this

All my life I've been an advocate for women and girls and this was a natural place for me to gravitate in the legislature. This is special because it's bipartisan and it includes both houses, the Assembly and the Senate. In general the State Senate in New York has been in Republican hands and the Assembly in Democratic, so it's really an opportunity to try to find the common ground that women care about. Our focus has been to a certain extent [on] child care and making sure that the suffrage centennial is recognized throughout the state. We continue to look for areas, whether [it's] economic development or equal pay, where the Republicans and the Democrats can share and advocate for together.

[What are] some of your favorite memories of Beverly?

I certainly enjoyed being involved in student government at the high school and being actively engaged. We've been commenting during this visit with my brothers [about] some of the places that I remember that are no longer [here, like Wil Wright's ice cream parlor]. South Beverly Drive-and all of Beverly Drive—is a totally different kind of street, but that was the shopping street. Rodeo Drive had a few pretty stores but that's all. It didn't have an identity of its own. Being a Brownie and a Girl Scout, I had dinner recently with an old classmate who was visiting the East Coast and we were reminiscing about when Eleanor Roosevelt came to our scout troop way back in the day. [I have] lots of really good memories.



What drew you to [the Hudson Valley]?

I was born in New York. I think I always felt my sensibilities were fundamentally east coast but with a west coast overlay. I was really drawn to the beauty of it, the agricultural sector, the history. I always loved those things and it's just a very special area and I fell in love with it.

Your late father [Don DeWitt] served on the Beverly Hills Planning Commission in the 1970s. Did your parents' involvement in local government spark your interest in public service?

I do think of myself much more as a public servant and not as a politician at all. I think that very much was informed and shaped by [my father] playing a civic role and [his] interest in the community. That's one of the things I love about what I do. There are 20 municipalities that I represent, but there's a larger sense of community, too. Certainly when I grew up in Beverly Hills, it was much less of a global destination and more of a real community, and so his involvement in that and my enjoyment of growing up in that kind of a community defi-

What has been most surprising about serving in the New York state legislature?

It's really the way that the politics can get in the way of actually getting things done, that's been the most surprising and disappointing. But, I think that most of the people who are serving are there for the right reasons. It's a really wonderful group of people and I learn a lot, which I love, but unfortunately, as we see at all levels of government, sometimes politics really is an obstacle to effectiveness.

What has been most rewarding [about] this experience?

The most rewarding thing has really been to be able to make a difference in the lives of my constituents and this very special place. Also, I really want to be a role model for girls growing up to understand that this is what elected officials look like and encourage girls and women to be part of the decision

ORDINANCE NO. 16-O-2718

AN ORDINANCE OF THE CITY OF BEVERLY HILLS AMENDING BEVERLY HILLS MUNICIPAL CODE SECTIONS §10-3-2509, §10-3-2409, AND §10-3-100 TO ALLOW DECKS LOCATED AT FINISHED FIRST FLOOR LEVEL THAT COVER PORTIONS OF DRIVEWAYS THAT LEAD TO SUBTERRANEAN PARKING AS PERMISSIBLE ENCROACHMENTS IN REQUIRED SIDE YARDS, STREET YARDS, PAD EDGE SETBACKS REAR YARDS IN THE HILLSIDE CENTRAL AREAS OF THE CITY, TO EXPRESSLY EXEMPT THE SUBTERRANEAN SPACE CREATED BELOW THE DECKS FROM COUNTING AS FLOOR AREA.

THE CITY COUNCIL OF THE CITY OF BEVERLY HILLS HEREBY ORDAINS AS FOLLOWS:

Section 1. On August 25, 2016, the Planning Commission held a duly noticed public hearing after which it adopted Resolution No. 1784, recommending that the City Council amend portions of Title 10 (Planning and Zoning) of the Beverly Hills Municipal Code to include provisions related to allowing decks located at finished first floor level that cover portions of driveways that lead to subterranean parking as permissible encroachments in required side yards, street side yards, pad edge setbacks, and rear yards in the Hillside Area of the City, to ensure consistency with the existing provision that allows said decks in the Central Area of the City, and to exempt the subterranean space created below the decks from counting as floor area (collectively, the "Amendments"). On December 6, 2016, the City Council held a duly noticed public hearing, received public testimony, and thereafter introduced this Ordinance.

Section 2. This Ordinance and Amendments were assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the environmental regulations of the City. The adoption and implementation of the Amendments would allow the construction of new, small structures accessory to a residence, as well as minor changes in land use limitations such as the amendment to the zoning code to allow decks located at finished first floor level that cover portions of driveways that lead to subterranean parking as permissible encroachments in required side yards, street side yards, pad edge setbacks, and rear yards in the Hillside Area of the City. Furthermore, allowing such decks in the Hillside would not result in additional grading as driveways that lead to subterranean parking are currently allowed structures in the Hillside, and the proposed decks would be covering the already-approved driveway structures. Therefore, the City Council finds that the Amendments are exempt from CEQA pursuant to Section 15303 (New Construction or Conversion of Small Structures) and Section 15305 (Minor Alterations in Land Use Limitations).

Section 3. The Amendments are consistent with the objectives, principles, and standards of the General Plan. General Plan Policy Land Use "2.1 City Places: Neighborhoods, Districts, and Corridors" encourages the maintenance and enhancement of the character, distribution, built form, scale, and aesthetic qualities of the City's distinctive residential neighborhoods, business districts, corridors, and open spaces. General Plan Policy Land Use "2.3 Hillside Development" requires that natural landforms that define the City be maintained and that development on hillsides and in canyon areas be located, designed, and scaled to respect the natural topography and landscape. Furthermore, General Plan Policy Land Use "2.4 Architectural and Site Design" requires that new construction and renovation of existing buildings and properties exhibit a high level of excellence in site planning, architectural design, building materials, use of sustainable design and construction practices, landscaping, and amenities that contribute to the City's distinctive image and complement existing development. Additionally, General Plan Policy Land Use "6.2 Housing Character and Design" requires that new, renovated, and additions to housing be located and designed to maintain the distinguishing characteristics and qualities of the neighborhoods in which they are located, including prevailing lot sizes, building form, scale, massing, relationship to street frontages, architectural design, landscaping, property setbacks, and other comparable elements. Lastly, General Plan Policy Land Use "6.3 Housing Scale and Mass" encourages the regulation of renovations and additions to single-family housing to ensure that they do not adversely alter the contextual scale, mass, and design qualities of existing structures.

Section 4. The City Council hereby amends Section 10-3-2509 of Article 25 of Chapter 3 of Title 10 of the Beverly Hills Municipal Code by adding one new permissible encroachment as subsection L of Section 10-3-2509 with all other provisions remaining in effect without amend-

"L. Decks located at finished first floor level, covering portions of a driveway that leads directly to subterranean parking for residences, provided, further, that required handrails for such elements shall not extend more than forty two inches (42") above the deck floor level and that the length of the deck shall be limited to 24' or the width of the opening into the subterranean parking, whichever is less, provided that a substantial landscape buffer is provided between the deck and any adjacent

<u>Section 5.</u> The City Council hereby amends subsection D of Section 10-3-2409 of Article 24 of Chapter 3 of Title 10 of the Beverly Hills Municipal Code with all other provisions remaining in effect without amendment:

"D. Decks located at finished first floor level, covering portions of a driveway ramps that leads directly to subterranean parking for residences, provided, further, that required handrails for such elements shall not extend more than forty two inches (42") above the deck floor level and that the length of the deck shall be limited to 24' or the width of the opening into the subterranean parking, whichever is less, provided that a substantial landscape buffer is provided between the deck and any adjacent property."

Section 6. The City Council hereby amends Section 10-3-100 of Article 1 of Chapter 3 of Title 10 of the Beverly Hills Municipal Code by clarifying that the subterranean space created below the proposed decks is exempt from counting as floor area. Additionally, the City Council also amends this section by listing the floor area exemptions under the single-family residential zone floor area definition. All other definitions in the section re-

The "Floor Area" definition applicable to the single-family residential zone (Subsection B of the definition) is amended to read as follows:

"B. Single-family residential zone: "Floor area" shall mean the area of all portions of floors and levels which have a roof or floor level above and are enclosed by exterior walls by more than fifty percent (50%). Further, "floor area" shall include the area of that portion of an upper level not separated from a lower level by a floor/ceiling assembly, but shall not include basements, crawl spaces, up to four hundred (400) square feet of garage area, and the space created below a deck located at the finished first floor level of a residence that extends over a driveway that leads to subterranean parking.

For the purposes of determining floor area in a single-family residential zone, "basement" shall mean any floor level below a story which has a finished floor level that is a maximum of three feet (3') above grade at any point along the perimeter of the building facing a front or street side setback line and which has no windows exceeding eighteen inches (18") above grade at any point along such perimeter of the building. A basement may extend beyond the perimeter of the building provided that such portion of the basement is below the natural grade. For the purpose of determining whether a floor level is a basement, grade shall be defined as it is defined in California Building Code as adopted and amended in title 9 of this code.'

Section 7. Severability. If any section, subsection, subdivision, sentence, clause, phrase, or portion of this Ordinance or the application thereof to any person or place, is for any reason held to be invalid or unconstitutional by the final decision of any court of competent jurisdiction, the remainder of this Ordinance shall be and remain in full force and effect.

Section 8. Publication. The City Clerk shall cause this Ordinance to be published at least once in a newspaper of general circulation published and circulated in the City within fifteen (15) days after its passage in accordance with Section 36933 of the Government Code, shall certify to the adoption of this Ordinance, and shall cause this Ordinance and his certification, together with proof of publication, to be entered in the Book of Ordinances of the Council of this City.
