
#### **City Council campaign** kickoffs to take place early January; 50th Assembly Delegate election to be held Sunday



DOT is providing approximately \$1.6 billion to the Los Angeles County Metropolitan Transportation Authority (LACMTA) for the second phase of the Westside Purple Line Extension. Federal funds include a construction grant agreement for \$1.187

billion through FTA's Capital Investment Grant program, a loan agreement for up to \$307 million through DOT's Transportation Infrastructure Finance and Innovation Act program, and \$169 million through the Congestion Mitigation and Air Quality program.

#### City Council combats unfunded liabilities; City Treasurer suggests "Section 115 Trust"

The City Council continued its conversation from the Dec. 6 meeting regarding unfunded liabilities, during the study session on Dec. 20.

The Dec. 6 staff report transmits to the Council a recommendation to setup a Section 115 Trust to manage potential increases in the City's unfunded liabilities.

Unfunded pension and retiree medical obligations represent significant liabilities to the City, according to the staff report.

In addition, recent Governmental Accounting Standards Board (GASB) statements are requiring that these liabilities be recognized on governmental employers' balance sheets.

The staff report stated the City's current unfunded pension liability per the CaIPERS actuarial report as of June 30, 2015 is \$129.1 million for the safety plan and \$82.8 million for the miscellaneous plan, totaling \$211.9 million.

The City's unfunded Other Post-Employment Benefits (OPEB) actuarial accrued liability, calculated by Bartel & Associates as of June 30, 2015, is \$99.3 million. "There is no other way of saying it; the current pension system is a disaster," Mayor John Mirisch said. "It's a systemic problem. It needs to be fixed."

To address the funding of these liabilities, the Budget Review Committee had several meetings throughout the summer and fall of 2016 to discuss establishing a Section 115 Trust, according to the staff report.

Establishing a Section 115 Trust would allow the City to "pre-fund" its CaIPERS unfunded liability, which will allow for greater local control over assets invested by a professional fund management team selected and monitored by the City.

The Budget Review Committee met with potential vendors, including Public Agency Retirement Services (PARS) and The Public Financial Management (PFM) Group regarding their programs. A Section 115 Program offered by CaIPERS was considered as well.

At its Oct. 5 meeting, the Budget Review Committee recommended that PARS be selected to administer the trust.

Additionally, City Treasurer Eliot Finkel and Director of Administrative Services/ CFO Don Rhoads drafted an Investment Committee Policy to facilitate the trust's administrative and investment management functions.

"Whether or not we would go bankrupt, at some point it's deciding what makes sense or not," Councilmember Kathy Reims said. "The fact that we can afford something that other cities can't doesn't mean that it makes sense to, in my view. Cities including us are continuing to kick it down the road, it seems to me, instead of having really hard decisions, hard conversations about it.'

The Council members did not come to a consensus on establishing a Section 115 Trust; however, all were in favor of exploring the option further and asked that Finkel and Rhoads return more information.

#### City Council appeals permit for residential additions to 9570 Virginia Place


The City Council unanimously overturned the Planning Commission's decision approving a permit, which would have allowed a reduced rear setback for a corner property at 9570 Virginia Place.

On April 28, 2016 the Planning Commission approved a Central R-1 permit for a rear setback adjustment at 9570 Virginia Place, the "Tallman-Stern House," to allow for new residential additions to the existing residence.

The project would have included elements such as the addition of approximately 345 square feet to the existing two car garage to allow for the parking of four cars within the garage, around 104 square feet of new floor area to the kitchen, and approximately 262 square feet of open-air deck to the existing 92 square foot open-air deck above the garage.

A timely appeal of the Planning Commission's decision was filed by Stan Kahan, owner of the neighboring property, who claimed the construction of the "massive garage and deck" would cause "egregious violations" to the permits standards for privacy, light and air.

"Privacy is an important aspect of your life and your home," Kahan said. "The intrusion of my neighbor's eyes the exposure of undue noise is unacceptable. The privacy issue effects me, my family and the neighbors because of the deck."

Councilmember Lili Bosse felt the addition of the deck would interfere with the structed in 1935 by Master Architect Gerard Colcord, according to the staff report. On Aug. 23, 2016, the owner of the property, Lawrence Stern, submitted an application to the City to designate the property as a historic landmark.

The Cultural Heritage Commission subsequently nominated the property as a historic landmark, and the Council decided to continue the hearing for landmark designa-

privacy of not only Kahan's property but also the neighbor's directly across the street. She also suggested the addition of the garage alone would be intrusive of the streetscape.

"I think the [garage] is imposing to the streetscape and the area," Bosse said. "The garage, even without the deck, is too massive and it changes the character of the streetscape."

9570 Virginia Place was originally con-

tion of the property to Dec. 6, 2016, so the appeal and the historic designation could be considered at the same meeting.

However, following the Council's decision to approve the appeal of a Central R-1 permit at, the project applicant requested the matter of historic designation be tabled to a later date.

"Under the current ordinance, there is a time limit for the City Council to act on any kind of landmark nomination," said Cultural Heritage Vice Chair Noah Furie."I'm perfectly fine with the applicant asking for more time to table it, but I would think they would need to waive the timeframe for the Council to take action."

Currently 33 properties in Beverly Hills are designated as landmarks listed on the Beverly Hills Register of Historic Properties, which is viewable at beverlyhills.org/preservation.

#### BHPD to add Assistant Chief of Police position

The City Council unanimously approved Beverly Hills Police Chief Sandra Spagnoli's request to add the Assistant Chief of Police position.

The Assistant Chief of Police will serve as the second in command to the Chief of Police and will be responsible for supporting daily operations of the Police Department such as directing, managing and coordinating assigned activities with other divisions, departments, and outside agencies.

The proposed annual salary is \$236,388 and total compensation including benefits is \$393,589, according to the Dec. 6 staff report.

Benefits total about \$157,201 and the majority is made up of the pension rates and the health/ medical benefits, according to Director of Administrative Services/ CFO Don Rhoads.

Councilmember Kathy Reims requested additional information about the specific details making up the compensation included in the salary. "That's a lot of money," Reims said. "[That] total puts it into a whole different perspective when you're trying to understand what we spend on our safety employees."

Presently the Police Department Executive Command Staff consists of the Police Chief, two Police Captains and a Civilian Division Commander, which is currently filled by rotating Acting Captains.

It is unusual to have a Deputy Chief in a department of this size.

According to the staff report, a vast amount of experience and expertise has left the Department due to the retirements of experienced sworn personnel.

Forty-seven percent of Police Officers have been with the Beverly Hills Police Department less than 10 years; 31 percent have been with the Department less than five years; and 17 percent have been with the Department less than two years.

"Right now, [we have] a minimum standard of staffing," Spagnoli said. "With a person on sick leave or away on training, once one other person can't make it into work for one reason or another [we're back] filling on overtime. So we need to have a solid shift schedule that allows for more than two people to be away from the shift."

Spagnoli will return to the Council early next year with a completed proposal for a strategic plan. The staff report noted the Assistant Chief of Police Position is expected to be filled as early as April 1, 2017.

# Beverly Hills City Council March 7th

#### AUMA requires City Council reevaluate marijuana regulations in the City

An overview of the control, regulate and tax Adult Use of Marijuana Act (AUMA) was scheduled for discussion during the City Council's Dec. 20 study session; however, the Council members ran out of time before reaching the item on the agenda.

The staff report noted the AUMA was "overwhelmingly approved by the voters in Beverly Hills." 9,288 people voted in favor of the AUMA and 5,183 voted against it, according to data obtained from the Los Angeles County Registrar-Recorder/County Clerk.

The AUMA legalizes the possession, use and cultivation of non-medical marijuana for those who are 21 years of age or older.

Although the City currently prohibits medical marijuana dispensaries, store, coops and cultivation operations in any zone or overlay zone of the City, this prohibition will not be sufficient to prohibit the establishment of non-medical marijuana businesses in the City, according to the staff report.

Additionally, the City does not currently prohibit outdoor marijuana cultivation at

PLEASE TAKE NOTICE that on January 10, 2017, at 7:00 p.m., or as soon thereafter as the matter may be heard, in the Council Chamber of the City Hall, 455 N. Rexford Drive, Beverly Hills, CA 90210, the Council of the City of Beverly Hills will consider adopting an ordinance entitled "Ordinance of the city of Beverly Hills amending the Beverly Hills Municipal Code to update second unit regulations pursuant to changes in state law, including terminology from second units to accessory dwelling units." A summary of that Ordinance, which has been prepared and published in accordance with the requirements of Government Code Section 36933 follows:

#### **Summary of Ordinance**

The Ordinance includes but is not limited to, modifications to BHMC 10-3-409 to ensure compliance with newly adopted state law (SB 1069 and AB 2299) pertaining to regulation and permitting of accessory dwelling units, and to replace the term "second unit" as used in the Municipal Code with a new term "accessory dwelling unit". Changes resulting from the Ordinance include modifications to accessory dwelling unit parking requirements and configuration of parking on a site, accessory dwelling unit setback requirements, as well as accessory dwelling unit size requirements.

The Ordinance also includes modification to procedures for review of applications for accessory dwelling units, and requires that the City approve or deny by-right applications for accessory dwelling units within 120 days of receipt of the application. Further, the Ordinance modifies regulations pertaining to the charging of utility connection fees and the installation of fire sprinklers for certain accessory dwelling units, among other things.

The AUMA permits a city to adopt and enforce local ordinances to regulate nonmedical marijuana businesses, or completely prohibit the establishment or operation of non-medical marijuana businesses within its jurisdiction

The AUMA grants State agencies the authority to create, issue, renew, discipline, suspend, or revoke licenses for non-medical marijuana businesses. The State can begin issuing licenses to non-medical marijuana businesses by Jan. 1, 2018.

The City can prohibit all commercial marijuana activity, according to the staff report. Adopting a prohibition on commercial marijuana activity should prevent the State from issuing a license to nonmedical marijuana business to legally operate in the City. The City can also prohibit all outdoor marijuana cultivation on private residences.

When the item returns to the agenda, it is recommended by city staff that the Council provide direction as to whether the City wants to prohibit outdoor marijuana cultivation at private residences, adopt reasonable regulations regarding indoor marijuana cultivation at private residences, prohibit or regulate commercial marijuana activity in the City, and explore imposing a local excise tax on non-medical marijuana businesses.

#### The Weekly's interview with Public Works **Commission Chair Jeff Wolfe**

#### **By Madelyn Pariser**

#### Why did you initially want to become a member of the Public Works **Commission?**

When my children got older and went to college, I had a little bit of extra time that I was able to devote to giving back to the community. I went through the Team Beverly Hills program and one of the first things we did was take a tour of the Colorado Aqueduct, hosted by the Metropolitan Water District (MWD).

I was fascinated, not just by the aqueduct and the tour itself, but also [because I was] learning a lot more about the City and Public Works through talking to people who were on that trip. From that moment on, I became very interested in Public Works and realized with my background I would probably be a good fit.

All areas of infrastructure, whether it be streets, sidewalks, stoplights or pipes, are actually very interesting to me. It's pretty boring to a lot of other people but infrastructure is always something I've enjoyed learning about, so it was a natural fit.

#### Tell us about your professional background.

I went to Beverly Vista [school] and graduated from Beverly High in 1980. [Then I went to] the University of Pennsylvania where I got a business degree and an engineering degree.

Around 1988 or 1989 I moved back to Los Angeles. I have spent most of my

career in technology management, consulting and implementation. I spent a number of years at American Management System in both Arlington, Virginia and Los Angeles, working on management consulting and software implementation projects for the federal government, financial institutions and hospitals.

The mindset [in Public Works] is very similar to the work I was doing with technology. When it comes to things like [infrastructure or technology] there's a certain element of "when things work, no one knows about it." You have to still pay attention even when things are working, even when things aren't getting noticed, to make sure that they are working correctly.

I have completed Team Beverly Hills, CERT, and participated in the Beverly Hills portion of the Greater Los Angeles Homeless Count. I have also been on the board of Beverly Hills AYSO for the last 10 years or so.

#### What are the biggest challenges facing the Public Works Commission in the new year?

The City has issued an RFP (Request for Proposal) for its solid waste provider. The Commission is going to be involved in helping review those responses, and then [we will] make a recommendation [to the] City Council.

[We may recommend] continuing with the same provider, assuming they provide a bid, or we [may] pick a new one depending on who puts proposals in. That's pretty significant because that affects everybody. It affects the trash pickup of all of our residents as well as the commercial entities.

On the residential side, the City actually picks up the trash, but the City then takes the trash to a facility run by whoever [is selected] as the provider. [The provider determines] things like whether or not we have separate bins for recycling. Right now, we don't because the facility does all the separation. That might change depending on who the new provider is. Things like that might have an impact on all the residents, and of course the company that gets the solid waste franchise actually does all the

pickup for all the commercial entities in town.

Water use efficiency is something I've been very involved in. We're coming out of some fairly severe penalties related to water conservation. We've removed those penalty surcharges, but we

have to use this little respite we have before the State moves in with new policies.

In order to adjust our thinking [and] get away from policies that [use] surcharges to reduce usage, [we need to] apply something that is more fair and equitable. People [will be] gauged on, for lack of a better term, a budget or allocation based on [factors like] the size of their house or the size of their business.

These are policies that we have to put in place so that water efficiency becomes standard. We can get away

from these surcharges that we had in place last year [by implementing] policies that will encourage more efficient use of water in the long term, as if it's a new [part] of living all the time instead

of treating it as an emergency.

#### Projects such as the Maple Yard Wells are in the early design stages. How will these help the City generate its own source of water?

Wolfe

In the past, I'm talking 30 or 40 years ago, the City had a number of wells and that's why we have our own treatment plant where we can actually treat and service the water.

[But it became] more cost effective to get all our water from MWD. Now, there's a pushback to reopen some of these same sources. Those wells are still there, so we can get more water from local sources. Being less reliant on external sources of water will [help us] control our water supply a little better.

We're not going to get to 100 percent independent. Right now, the next goal is to get to about 25 percent [independent]. On the macro level, it's something that even the MWD is encouraging all its member agencies to do.

The more we are able to tap into the local water sources, the less water we have to import from the Colorado River. It's the right thing to do in terms of everyone working together to try and come up with alternate sources of water.

#### In our interview with former Public Works Commission Chair Barry

Pressman [Issue #673], he said, "Our citizens and business people expect to be able to come to work, turn on the sink, have a little water, be able to flush their toilets and we need to provide that, we can't do that if we start trying to save a percent here and a percent there on rates when our rates are going up." What's your take on the water rate increases?

The water enterprise is an independent utility. It's intended to operate as an independent utility and it's supposed to function financially independent, so its costs have to be made up for by the revenue.

Every time you go into a water rate analysis, you have to look at all the costs associated with the utility and then determine if you have the revenue to cover your costs and leave enough of a buffer so that outside entities looking at the utility understand that you're a responsible water enterprise.

I agree completely with what Commissioner Pressman said there.

As a municipal entity, you can't set your rates at what you think the market will bear in order to generate profit. That's not how it operates. Rates are set directly upon what those costs are. It provides a little bit more of a challenge when people hear about increases, specifically by the percentage.

You might have an increase in a percentage that might sound high, but when you look at the actual rate itself and compare it to rates of other utilities and you look at the costs associated with running that utility you understand how you get there.

There are policies that the Council makes to ensure we have reliable water and that's what Commissioner Pressman was relating to. Having our own treatment plant is going to benefit the City in terms of issues related to reliability. At the end of the day, you do have to look back on the costs and how it's going to affect the rates.

#### Tell us about your family.

My kids [Ginelle and Aaron Wolfe] were born here. They went to Horace Mann and graduated from Beverly High. Taking them back to the high school for the first time and going into some of those same halls was a little odd

They participated in sports, like Little League and AYSO.

#### What is your top priority as Chair?

As Chair, your priorities really aren't any different than the Commission's priorities. I'd like to raise the visibility on some of the other operating departments.

Water gets a lot of attention and rightly because it's a major function of public works.

[However,] you don't hear about a lot of the other folks in different departments because they're doing a great job. Our sidewalks and streets are better maintained than in surrounding cities.

You can walk to the edge of the City and you will see the City boundaries because you can see the differences in the pavement. There's almost no graffiti in Beverly Hills. Why is that? Because there are folks in Public Works when the second they get a call, they're out there cleaning it and getting rid of it.

From a daily operational standpoint, I'd like to highlight, from time to time, that these are some of the things we do.

## BHHS alumnus, former coach hired to coach college team Louise Lieberman draws praise from U.S. national team coach

Former Beverly High standout midfielder and coach Louise Lieberman was hired as the University of San Diego's women's soccer coach, the university announced Friday.

Lieberman spent the past eight seasons as an assistant coach at UCLA, including helping guide the Bruins to the 2013 NCAA championship.

"I am extremely honored and proud to represent this extraordinary program and the University of San Diego," said Lieberman, a 1995 Beverly High graduate. "I am eager to continue a winning tradition here at USD and to working with an elite group of student athletes."

Lieberman succeeds Ada Greenwood, whose firing was announced Nov. 15, 11 days after the Toreros completed a 10-8-1 season. Greenwood had been USD's coach for 14 seasons, guiding the team to the NCAA tournament seven times, most recently in 2014.

USD Executive Director of Athletics Bill McGillis called Lieberman "a really special leader."

"Her warm and dynamic personality, bril-

liant soccer mind, outstanding pedigree as a player and assistant coach in one of the nation's elite programs at UCLA and her Southern California roots make Lou a terrific match for the University of San Diego," McGillis said.

Lieberman received multiple MVP, all-Ocean League and all-Southern Section honors during her playing career at Beverly High. She coached the Normans to a 17-7-1 record and a playoff berth in the 2001-2002 season.

Lieberman had seven goals and 17 assists for UCLA from 1995-98, was a secondteam All-Pacific-10 Conference selection in 1995 and twice received the team's Most Inspirational Award.

Lieberman played for the Washington Freedom during the Women's United Soccer Association's inaugural 2001 season with record-setting forward Mia Hamm among her teammates.

Lieberman was an assistant coach for the men's and women's teams at Cal Poly Pomona in 2002 and was director of coaching for the Woodland Hills-based club team Tickets are \$10 for General Admission, \$8 for Students and Senior Citizens and \$5 for the student body members at Beverly High.

and more that covered the Artsakh Stallion.


