Standoff Between Council and Board Continues Over JPA

The Board of Education and City Council still have not reached an agreement regarding the future of the Joint Powers Agreement (JPA), whose current \$9.7 million in funding will expire at the end of June.

The standoff follows two City-school liaison meetings last week, where the school district representatives told City officials they wanted the new JPA amount to increase to \$13.5 million. The district could lose approximately one-sixth of its operating budget without a new contract.

In a press release issued on June 26, BHUSD shared its proposed one-year extension of the JPA, stating that the \$13.5 million would recoup the last 5 years' \$2.4 million reduction. Additionally, the letter noted that the amount is less than 2.5 percent of the City's total Reserves of \$570 million.

"The City Council has historically supported the school district," wrote BHUSD Superintendent Michael Bregy. "Given the City's significantly increased reserves, this is an opportunity for the City to spend a very small portion on its residents, organizations, and public schools."

But some City officials disagree with the district's analysis, contending that teachers already receive an overly generous "salary formula," which is linked to "extraneous factors" like property values.

"[The analysis is] the ultimate in 'alternative facts,'" Councilmember John Mirisch told the Weekly.

In his most recent blog post on www.reelectmirisch.com, Mirisch explains that the relatively new "salary formula," which has been in effect for a few years, is falsely painted by BHUSD as "great" for the community.

"While I have been a strong supporter of the JPA in the past, I simply cannot overlook a fiscally absurd policy which will damage our schools and could damage the City," Mirisch wrote. "It's just not worth it."

The proposal will be further discussed at tonight's City Council meeting.

Metro Holds Contentious Public Hearing at Roxbury

A variety of speakers expressed their opposition of the Purple Line Extension at a public hearing on June 22 at the Roxbury Community Center.

The event featured a prepared presentation by Interim Senior Executive Officer for Metro Countywide Planning and Development David Mieger. In it, he explained the project's Draft Supplemental Environmental Impact Statement (SEIS), which a federal judge in 2016 ruled must be produced for this portion of this portion of the Metro's subway extension project.

The presentation addressed the four major concerns of the plan—which is currently

impacts to parks, recreation and historic sites.

Geier concluded the presentation by stating that the project poses no significant impacts to the aforementioned concerns, and remains environmentally and federally approved at the state and federal level.

But at the hearing, several speakers expressed their dissatisfaction with the project analysis, contending that it wasn't thorough enough. BHUSD Superintendent Michael Bregy used his allotted two minutes to emphasize that he doesn't oppose the progress he believes the Purple Line is fueling; he simply opposes the fact that it will run under the high school.

"The current assignment has become a barrier of our mutual goals," he said.

Additionally, several current Beverly High students shared their concern for the potential health impacts on future students. "These risks to student safety should not be accepted under any circumstances," said BHUSD Student Board Member Jonathan Artal.

Other speakers included Board of Education members Lisa Korbatov and Howard Goldstein.

Once the public comment period ends on July 17, the FTA will publish a final report that includes responses to both written and public comments.

Bussel Calls Rec & Parks Meeting Notice 'Misleading'

Resident Ari Bussel wrote an email urging the Recreation and Parks Commission to deny a proposal for reconstruction of the Crescent Drive Mini Park, whose details he contends don't reflect what the public notice referred to as "renovation."

In the letter, he notes that the staff report alludes to the fact that if the proposal is approved, the park would serve as a temporary construction staging area for two years.

"The public is informed and invited to provide input in a discussion about 'renovations,' where clearly there are no 'renovations' but a reconstruction from scratch," Bussel wrote.

He goes on to suggest that the meeting—or at least any major decisions—should be deferred, as the public did not receive proper notice and therefore, could inadvertently

park at 100 North Crescent Drive, as a part of a larger development project that will add two new stories above that location's existing three-story building.

Indeed, the proposal does specify that although the proposed modifications would include things like a removal and replacement of existing trees and addition of new trees along the northern edge of the park, it also states that the proposed alterations to the park wouldn't be completed until after the building construction is complete—roughly 23 months.

In agreement with Bussel, Commissioner Alissa Roston said, "To me, it would be a big disappointment to have the park out of use for two years."

The proposal would also result in a loss of about 2,000 square feet of green space, which Commissioner Susan Gersh called "disturbing."

After reading out loud several letters of concern and hearing input from the City's Urban Forester Ken Pfalzgraf, the Commission decided to hold off on making any decisions without a site visit.

"My feeling is definitely that we should go as a commission and open it up to the community," said Vice Chair Simone Friedman. "[That way] we can see what is actually in this park."

Board of Education Approves 2017-2018 Budget

Board of Education Members Isabel Hacker and Mel Spitz expressed their reservations about the 2017-2018 school budget at Tuesday's meeting, which ultimately passed 3-2 with Hacker and Spitz dissenting.

The \$68 million budget was approved and was prepared to incorporate Board priorities, the necessary reserve level, and information about state budget and local property tax revenue. But both Spitz and Hacker pointed out that this total assumes the City and Board will reach a meaningful consensus on the Joint Powers Agreement. They have not done so yet.

"This is not the time and place to discuss the merits of the board's strategy in negotiating JPA negotiations with the City," said Spitz, "but it is absolutely the time and place to discuss the reliability of the budget, consider the consequences of that strategy as they may impact the certification of this budget, and the ability to meet cash flow requirements during the upcoming school year."

Board member Howard Goldstein countered by noting that the district would not even see the money from JPA for several months, likely not even until January of next year, but Hacker said that she can't in good faith vote for a budget that contains a missing piece of one-sixth of the total budget.

"The budget present tonight has a 9.7 million dollar hole, so I'm at a crossroads," said Hacker. "It's unfortunate we find ourselves in this situation."

Hacker also voted against the three-year extension of Chief Administrative Officer La Tanya Kirk-Carter, expressing that there

are other, more pressing budget concerns that must take precedence.

Kirk-Carter's extension was approved 3-2, with Hacker and Board member Noah Margo dissenting.



Blu Apartments to 'Raise the Roof'

At its June 20 formal meeting, the City Council unanimously approved an ongoing proposal for Blu Apartments to remodel its existing outdoor rooftop area.

The decision comes after the City approved an original project proposal in 2003 for the conversion and renovation of the existing building into 37 apartment units. The planned development allowed 7,400 square feet of outdoor living space.

Blu's rooftop contributes about 3,400 square feet to that outdoor living space. The purpose of the request to amend the original plan is to create a better rooftop experience and improve views by raising the roof deck.

The proposal filtered through the Planning Commission several times, which considered issues like noise, traffic, and views/privacy impacts. They eventually made a unanimous recommendation for approval with conditions including (but not limited to) limit the use of rooftop to residents of the building and their guests; prohibiting commercial use of the rooftop area; installing signage on rooftop restrictions; retaining city jurisdiction over the rooftop use area; and a maximum rooftop occupancy of 75 people.

"The suggestions that were made by the Planning Commission alleviate a lot of the concerns I had," said Councilmember Lester Freidman at the meeting.

Councilmember John Mirisch did express concern about the potential effect it would have on neighbors, but ultimately voted for the proposal because the city will retain jurisdiction. "It's one thing to do a noise study; it's another thing to actually live through something, so we should monitor it and ask for adjustments [if] need be," said Mirisch.

With the City's approval, the overlay zone that governs the 8601 Wilshire Boulevard building allows rooftop uses to exceed the existing 116-foot-height by up to 12 feet.

Planning Commission Denies Project Proposal on North Oakhurst

The Planning Commission denied a proposed development of a two-story home at 331 North Oakhurst Drive on June 20.

The decision comes after the Planning Commission originally considered a request for six variances and a Development Plan Review at this site for a three-story, 3,724 square foot one-unit building on August 11, 2016, at which point the applicant received comments and was advised to return with a redesigned project.

Then, on January 12, the Commission considered a three-story, 2,145 square foot one-unit building, which they again instructed the applicant to redesign. The project proposal on June 20 was for a 2,865 square foot one-unit building, and has implemented changes like decreasing the property from three stories to two stories, reducing the front setback from 25' to 20', and decreasing the height of the project from 32'-2" to 22'-2".

"Last time we were here you gave me very clear instructions," said architect Hamid Gabbay, "and we followed every single one of them."

But several residents used the public hearing to state their opposition of the project, including the owner of 337 North Oakhurst Drive, Philip Blustein, who called attention to the proposed variances of the home. "This project wants nine variances, but they're really not variances—they are violations of the municipal code," he said. "Why should they be allowed to violate the municipal code?"

At deliberation, the Commission oscillated at length between whether or not to pass the proposal. They offered compromises like creating a third parking space and removing the basement in order to lessen the variances, to which Gabbay wasn't receptive.

"I consistently believe that this city has given out variances too frequently in the past," said Commissioner Craig Corman. "We give out variances a lot—people expect them, and we need to be more careful than we've been in the past."

The project was dismissed 3-2, with Alan Robert Block and Farshid Joe Shooshani dissenting.

Seemann Named BHUSD Assistant Superintendent

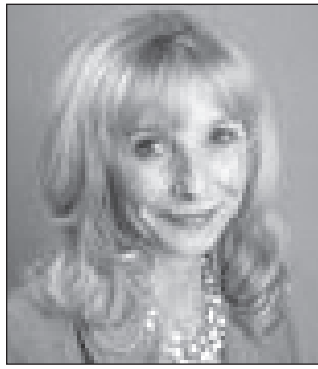
We do both local and international philanthropic work. On an international scale we have a number of projects that we are collaborating with other clubs around the world. A lot of them have to do with providing sources of clean, safe water for populations that don't presently have that. Among the international

and Columbia, mobile medical projects in Ghana, schooling in Kenya, a facial deformity clinic in Paraguay, education supports in Kenya, and college scholarships for orphans in Mexico.

Locally, we support many worthy organizations including most recently the following: Imagine LA, The Colburn School, The Wallis Annenberg Center, The International Dyslexia Association, Theatre 40, Friends of the Griffith Park Observatory, The BHPD Pancake Breakfast Jewish Big Brothers Big Sisters, and the BHFD 911 Memorial. Colombia in March where will be bringing wheelchairs to people who don't have them, we are going to be bringing supplies and infrastructure to women to learn how to make shoes for a living so they will have a sustainable income stream. There's

going to be a lot of projects in Colombia—I think a total of 13 projects between two cities—one of them is in Bogota and the other is in a place called Bucaramanga.

And then we do other kinds of things—hands on projects.

Explain the process by which one becomes president.

There's a long succession plan in Rotary. I was President-elect; I served in the office as secretary of the club for two terms. One is nominated by a nominating committee for this role but we usually have members who have had a significant amount of experience in different leadership roles and getting to know the club. So I was nominated as President-elect last year and I actually have been president since May.

In issue #872 of the Weekly, former Rotary President Adam Heller said, “[Rotary] is not political, and my opinion is that we can always do more good from inside a situation than from outside a situation.”

Do you agree?

Yes. That's one of the tenets of Rotary

is that the organization is very deliberately not political in so being that around the world we're known as an organization that brings humanitarian work in places that other organizations are frequently not allowed.

Tell us about your family.

I'm married to David Goldman who went to Beverly [High]. He was student body president in 1965. His family was very active civically in the City of Beverly Hills also—my [late] mother-in-law was Sooky Goldman and she was very philanthropically and civically active in Beverly Hills and she herself was a Rotarian. I have two wonderful sons—my older son is named Max Goldman. He went to Beverly also, and then he went to Yale and Loyola Law School. Currently he is a disability rights attorney for autistic children. And then my second kid is my son Zack Goldman. Zack is 26 and we're very proud of the work he's done; he has a creative agency and he specializes in soccer and other sports-related marketing and branding.

A year from now, what goals do you hope to have accomplished as president?

I hope to bring in more members; I hope to engage every member; to attend and to take part in our events; and for everybody to feel that their Rotary membership has great value in terms of the fellowship.

MEET MARK MEAD

The newly appointed Beverly High Principal discusses his goals for the school

You previously worked as an English teacher at Beverly High. Why did you choose a career in education?

I chose a career in education before I even knew I wanted a career in education. When I got out of college, I ended up teaching ESL. Growing up in Arcadia, we had a lot of immigrant Chinese people, and I had studied Chinese in college, so I found myself working with kids in that demographic. I did as much to be around their language as to be an educator. So, like I said, I kind of fell into it. Then I found myself teaching K-8 P.E., which again was just another thing I enjoyed doing. So I found myself teaching before I had any idea I wanted to do it.

Tell me about your experience as the ASB advisor.

When I came to Beverly Hills High School, I came as an English teacher and that was in '06. And almost immediately I became coach of the wrestling team as well. I was assistant coach for a couple of years, and then when the head coach retired I became head coach. Then I transitioned from coaching into ASB, which is a whole different kind of coaching. Almost like my introduction to education, I had no idea I wanted to do it until it happened. There was an opening in the position and it wasn't at the beginning of the year, it was kind of mid-year. I was approached by a couple people who I deeply respected and they suggested maybe I considered it. I basically was cajoled and asked to maybe look into it, which I did, and I chose to take the position really without knowing almost anything about ASB. I knew very little going in, to be honest.

What made you want to go into administration?

I've always cared about the kids at the school and how they connect. They can connect in a lot of ways, including athletics. ASB was a different way of trying to get students to connect. Obviously it's a leadership class, but to me the most important part of the leadership role for kids in the ASB class to, as leaders, think about everyone else. There are some people who are more engaged and those who are less engaged. We always talked about thinking in the margins—how can we get the people who aren't involved, involved? It was a really difficult task. That transition opened my eyes up to a lot of the great things our school was doing, and also areas where there was room for our school to improve. So as I was doing that, I found myself taking on more administrative-like tasks, from culture and

climate surveys to supporting elections and campaigns and things like that. It was kind of a natural flow, and in fact when I was doing my administrative credential, we had 80 hours of field work per class which is quite a lot when you're already doing all that other stuff. But a lot of those hours were already designed into what I was doing for ASB. So in terms of the academics and preparation for administration, ASB was a really great place to start.

Specifically, in what areas does the high school need improvement right now?

Well, I want to emphasize that I think our school has way more things that are going well and positive than it does for improvement. I am fortunate to inherit a school full of really strong teachers who care about kids. Areas for improvement—I would like to measure, a little more successfully, engagement in our school. By engagement I mean people who are involved in a sport, a co-curricular, an extra-curricular. All the research says that kids who are engaged have better attendance, they have better academics, they have a more successful, robust high school career. What I'd like to do is find ways to better quantify that, the idea being that if you know who's engaged, you're going to also be able to figure out who isn't. And I'd like to backward plan events for kids who aren't so involved.

A couple years ago we had a talent show in ASB and I cast the kids who were creating it, and they did most of the work—that's the whole idea, but I said, "I want you to be really careful about who you select. I don't want it to be one group of people; I want it to be as diverse a group as you can—age-wise, skill-wise, ethnicity, culture, everything." A third of the kids who were in that talent show had never been involved in any kind of school activity before. We were super proud of that event for that reason. One girl was this amazing ballerina, and after that event she chose the next year to join the school's dance team, and was on the dance team for two years.

And that's kind of what I mean by backward planning—finding out who's not engaged, and instead of just designing events, designing them in a calculated way to get people involved.

In issue #910 of the Weekly, Superintendent Michael Bregy shared his belief that there's too much of a concentration on using standardized test scores to measure whether or not kids are learning. He said, "I'd like to see a focus and a concentration on the individual students and their growth. If we lose sight of that then we're stuck on one number and one statistic." What are your thoughts on this?

I really agree with him. I mean, the game is set up in a lot of ways for standardized tests. I think any educator is forced to acknowledge that reality to some degree. And we do here—our kids are generally ready for those tests. But I agree with him that the research shows that things like the growth mindset and allowing students to work on maybe more of a rubric-based style of assessment where instead of measuring a score at the end that's basically "Here's how many you got right and here's how many you got wrong," more on a kind of growth and proficiency rubric type of a way. So what you would do with that is you would actu-



ally have a class where everybody would walk in and essentially start off failing. The rubric doesn't really work if they come in and they're all advanced. You would want them on the "below proficient." They would start there, and they would get used to "Alright, I'm not doing it right. That's the whole plan and it wouldn't work if I was doing it right. What am I doing wrong?" [They would]

better. All of the evidence says that when students assess themselves, and usually this works best with [things like] rubrics, they'll grow. And they'll grow quickly in a way that's different than our typical, standardized model.

I agree completely. I think a lot of our teachers are doing things like this, but I think we can improve in making it a school-wide culture rather than individual teachers doing awesome stuff on their own.

Tell me about your family.

I am married to [a woman named] Francesca. She's a native Italian, so when

we visit her mom, dad, sister, and everybody, it's all spoken in Italian. We're actually going there this July. With my new administrative responsibilities, that's getting harder and harder to do, but it's something we really value: staying connected to them. So her side is all over there. My people are all over here—my mom, my dad, and my sister. I have two kids. Victor is six,

and Phoebe is three. We're very happy right now [because] Victor just finished his first year of an Italian-immersion program so I'm looking forward to the experiment playing out in Italy in about a week or two.

A year from now, what goals do you hope to have accomplished as principal?

I'm very much a growth-mindset, goal-oriented person and some goals are stretch goals. But for me personally, I really have two goals that are kind of the fundamentals. Underneath they all have data-driven stuff like research and different strategies. But the two main things that are my goals this year are to continue to make Beverly Hills a safe school. Obviously I'm not really talking about the stuff that's in the union contract or the emergency plan—I don't think kids come to school and feel like they're in any physical danger. But I want them to feel like it's a safe place for them to fail and grow. It goes back to what we were just talking about before. I would like [students] to be able to learn and grow, but also have a feeling like, "You can come here and you can fail at the beginning." In fact, we're even designing it that way because we expect them to learn from that and grow from that. I would like to work on that a little bit because our teachers are awesome and have a lot to cover, so it's a balancing act between pushing kids to work hard and stay engaged in a high-intensity curriculum, but at the same time letting them know that, "We know you're going to face some hurdles and it's going to be a challenge to do it all, and while you're juggling it you're going to fail, but that's okay. We're here to support you, and we're going to help you continue to grow." So that's a big one for me.

The other one is called "Every Minute Counts." The idea is that when you're with your family at home, we value that. We want you to feel like those minutes count. But when you're here, every minute counts. Every classroom minute counts, every strategy you can use to get an extra edge and give your kids a little bit more knowledge and a little bit more skills. And what I love about "Every Minute Counts" is that it works for attendance, and it works for every staff member—whatever role they have.

So, keep everyone feeling safe and supported, but push everybody to get as much as they can out of every minute—that's my goal.
