

Planning Commission OKs New Wilshire Boulevard Project

At their meeting on July 27, the Planning Commission unanimously approved a Development Plan Review for a new commercial building on 9000 Wilshire Boulevard.

The decision comes after applicant Sean Youssefi submitted a request on January 26 to demolish two existing buildings, one of which is currently a rug gallery, at the location and construct a 3-story, 31,702 square-foot office building. It will also include a 2,049 SF rooftop lunch room.

At that first meeting, several residents spoke at the public comment section of

the hearing with regards to traffic concerns, spurring staff to conduct an in-depth analysis of parking and loading, traffic, construction, and historic uses. The report indicates that the revised project poses "no significant adverse impacts."

"This project has gone through a tremendous amount of scrutiny by staff as to the elements of the building, including a thorough environmental analysis, historical analysis, Indian burial ground analysis, traffic analysis, etc.," said project attorney Murray Fischer. "We are pleased to say that all of these issues have been reviewed, scrutinized, and addressed."

Among other conditions, the staff report states that in order to mitigate parking concerns, the project site must offer one hour of free, validated on-site parking for patrons of all tenants of the building. Day-time leasing of parking to anyone other than building occupants is prohibited.

"There's no question that this project will generate more traffic than is there

now, but that's not really the analysis," said Commissioner Craig Corman. "The question is whether under our guidelines, it's a legally significant increase in traffic, and the answer we've seen from the IR is no."

Water and Wastewater Rates Expected to Increase

In order to address the immediate revenue needs of the Water Fund, water and wastewater rates are expected to increase next year.

The dilemma was first discussed at the May 9 Public Works Liaison Committee meeting, where staff discussed the proposed water rate implementation schedule. They recommended an adjustment be applied as soon as possible and that the costs of implementing the Water Enterprise Plan be removed from the analysis and incorporated into a new water reliability per unit charge.

The revised plan includes a two-phase process: 1) Rate Adjustment to Address Five-Year Water & Wastewater Revenue Requirements; and 2) WEP Unit Capital Charge and Cost of Service Study.

If approved, a three percent rate increase will begin on January 1, 2018, followed by 2 percent rate increases in 2019, 2020, 2021, and 2022. Expenses include forecasted payments to the City of Los Angeles Bureau of Sanitation for wastewater treat-

ment and improvements to the Hyperion Treatment Facility; and costs for maintaining and rehabilitating the City's collection system.

The Public Works Commission heard the proposal at their meeting on July 24, where several Commissioners expressed desires to ensure they have the right numbers for a long-term and treatment plan. Commission Chair Jeff Wolfe said he was "not comfortable" with the presented \$14 million estimate for the rehabilitation of the Hollywood Basin, which has declines in recent years.

"Maybe there's a separate report that has [an analysis], but if so I haven't seen it," said Wolfe. "I'm still not comfortable, at least based on the information I've seen, [that \$14 million] is a reasonable estimate."

Wolfe then suggested the commission take some more time to visit other scenarios, stating that as of now, he's "torn" as to whether or not the commission should support the recommendation.

"In my mind, the issue was never 'Are these problems solvable?' The issue was simply 'What's it going to cost? How much is it going to take? And before we

know how much it's going to cost and how much time it's going to take, it shouldn't be approved," said Wolfe.

Commissioner Jerrold Felsenthal noted that the City's reserve is 50 percent, significantly higher than others. The State of California has enacted several pieces of legislation supporting the notion that everyone has the right to affordable water. This will require substantial subsidies for lower-income areas.

"Given what's going on in California particularly, the state of California's Public Utilities Commission is seriously of the mind that everybody has a right to water, that water is an inalienable right," said Felsenthal. "An increase would be good to build up our reserves because I think we will have to subsidize in some cases."

Ultimately, the commission voted 4-0 to support the staff recommendation, with Wolfe dissenting. The proposal will now be presented at the City Council Study Session on August 15.

The paparazzo was transported to a local area hospital with non-life threatening injuries. Bieber cooperated with the investigation and was subsequently released.

Goldwyn Theater to Hold Screening of "Beverly Hills: 100 Years, 100 Stories"

City Could Receive Peace Tree

The Recreation and Parks Commission has decided to further consider a request to plant a Peace Tree in Beverly Hills.

The proposal was initially brought forth under Oral Commission by resident Munni Irone at the January 24 meeting. A philanthropist, global peace leader, and founder of the nonprofit organization Art 4 Peace, Irone has planted Peace Trees in many areas around the world.

Her intent is for the tree to signify peace and harmony amongst the residents and those that visit the City of Beverly Hills. If approved, the City will be Irone's very first planted peace tree in the United States.

"This tree planting will bring a positive change since our beautiful Mayor is working on Healthy City," said Irone. "Why not have [one] that has a medicine purpose and is a positive good-luck tree?"

Irone has suggested that Beverly Hills plant a Moringa tree. While they are not indigenous to the United States, many places grow Moringa trees, including California's Moringa Farms. The Moringa tree can grow over 20 feet tall in its first year, and the branches will grow about three to four feet wide. It requires much sunlight, warmth, and water to thrive.

But Commissioners Alissa Roston and Frances Bilak expressed concern regarding the maintenance of planting trees, given the drought situation facing the state. Bilak also stated the Commission is "confined" as to what they can do since the City has very strict policy as to what, when, where, and why trees are planted.

"As I understand it, we don't have any trees like this in the City," said Bilak. "I don't even know if we as a Commission can go around the policy of what the City has for tree planting."

The last formally planted tree was the Centennial tree, which City Arborist Ken Pfalzgraf said he is quite familiar with in terms of performance. He isn't, however, familiar with the Moringa tree as it is "rare" and has never before been planted in the



City.

"I certainly don't want to put a tree in the ground for an event that is recognized by everybody and then have it do poorly," said Pfalzgraf.

C h a i r H o w a r d Rosoff noted that in order for the project to be approved, it requires much more research in addition to meetings with liaisons from the City Council.

"I think everybody agrees it's a good idea," said Rosoff. "Getting it implemented and all the things that go around getting it to that point is another issue."

Commission will further consider the proposition of a Peace Tree by establishing and Ad-Hoc Commission to meet with City Council on a liaison basis, perhaps in time for the International Day of Peace on September 21.

New Art Piece Could Grace Beverly Canon Gardens

At their July 27 meeting, the Fine Art Commission considered accepting a donation of art piece "Aurora Beneficent" by Ira Reines.

Reines is an American Master Sculptor who began his career when he was selected by the Father of Art Deco, Erte to implement the Deco master's haute couture drawings into a series of 70 bronze sculptures.

The sculpture pays homage to the history of Beverly Hills and its "persistence and determination to create an environment which enhances the quality of life of its residents, merchants and visitors," wrote

curator Daniel Winn in a letter.

Staff was contacted by the Chamber of Commerce on behalf of the Winn Slavin Fine Art Gallery, who wishes to donate the bronze sculpture to the City with the intention of placement at Beverly Canon

In his letter, Winn said the piece is valued at \$1.2 million but did not provide documentation validating the pricing. Commissioner Alan Kaye noted that because the commission wasn't provided with any auction records, he's unsure as to the actual value of the piece.

"My question is whether we're helping the artist and the gallery more than we're helping the city," said Kaye.

The commission directed staff to gather more information from the gallery regarding Reine's past work and pricing validation before determining next steps.

National Night Out

The Beverly Hills Police Department hosted its annual block party "National Night Out" on August 1.

Suspect Arrested on Alleged Sexual Assault

The Beverly Hills Police Department has arrested sexual assault suspect Carlos Omar Pichinte.

On May 13, the BHPD received a report of a sexual assault. The suspect in that case, allegedly posing as a ride service driver,



picked up a female passenger in the City of West Hollywood. The victim believed the suspect was the legitiride mate service driver she had requested. The suspect

drove a short distance before he pulled over in Beverly Hills and assaulted the victim.

On May 20, Beverly Hills detectives conducted surveillance and ultimately identified and arrested the suspect in connection with the sexual assault.

Pichinte was booked on the primary charge of Rape (261 (a)(1) Penal Code) in addition to other felony charges. Hs bail was set at \$1,350,000.

Pichinte remains in custody. His next scheduled court date is August 3.

Beverly Hills detectives have been actively investigating this sexual assault since Pichinte's arrest and believe he may be connected to additional sexual assaults in the Los Angeles area.

At the time of Pichinte's arrest he was driving a silver 2015 4-door Kia Rio.

Dog Park Seeks Community Feedback

The Beverly Hills Community Dog Park is currently undergoing evaluation of its operations through community outreach efforts.

In June, staff provided an update to the Recreation and Parks Commission regarding the status of the dog park. The City Council liaisons decided to continue with operations of the park for another full year. They also decided to gather community feedback by conducting a 10 question survey that would compile a comprehensive report on park usage, the facility, and any questions or suggestions patron's had. 248 people submitted responses.

Now, the liaison committee has directed staff to conduct further public outreach for several key aspects of the park, including hours of park operation, restricting park access, the registration and permit process, and the necessity of a park ranger at the park.



At their July 25 meeting, Commission Chair Howard Rosoff raised the question of whether or not the summer heat is deterring people from visiting the park.

"I think that may be keeping people away. When I was there what I saw was one tree with a couple of benches around it," said Rosoff. "It would seem to me, especially in the weather we've been having, that if we had some more shade, people would be able to stand there [and] not be sunburned."

Management Analyst Stephanie Harris said that the dog park staff has "finally made progress" regarding the shade concerns by ordering two umbrellas to rest near the benches, which should arrive by August 10 at the latest.

Ultimately, the commission supported staff's recommendation to conduct another public survey—including the heat issue—to determine the future of the dog park.

Staff will conduct public outreach from

August until mid-September. They will likely mail or email the survey to all dog park members, and to surrounding neighbors within 500 feet of the dog park.

The community feedback period will occur from August until mid-September.



Fine Art Commission Denies Louchheim Donation Proposal

The Fine Art Commission decided at their July 27 meeting to deny a donation proposal from artist Marlene Louchheim for the City's Fine Art collection.

Louchheim was a longtime resident of Beverly Hills and participated regularly in the Beverly Hills Art Show. She had an installation of stained glass art in Le Grande Passage near Caffe Roma on Canon Drive.

She was also considered through the priority setting exercise that the commission conducted in 2014.


The piece in question is a series of bronze casts called "Ohia Series." The commission debated whether or not they should pursue the piece

outside of the commission, as most Commissioners didn't feel it fit their definition of "Fine Art."

"I think an argument can be made that she meets the criteria. The question is, 'Is this something you feel strongly about that you want to have?' I like her stuff. I don't feel strongly about it one way or the other," said Commissioner Alan Kaye.

The commission opted to ask Louchheim if she'd like to bring the piece to City Council to potentially be placed somewhere else in the City, so that it's not "stymied" by the Fine Art criteria.

"It's just such a generous thing to offer, and they have been leaders of this community for many, many years, and I want them to know that we recognize that," said Kaye. "We are very encouraging of this; we just don't feel it falls under our purview."



Ringo Starr Donation Proposal Garners Mixed Feelings

Representatives of musician Ringo Starr have offered to donate a Peace and Love hand sculpture to the City—a proposal that was met with some resistance from the Fine Art Commission.

According to the staff report, Ringo Starr has been promoting Peace and Love as a Beatles member and solo artist by allowing a moment on his birthday every year where he "asks people to stop what they are doing and say peace and love to those around them."

At the m meeting on July 27, Commissioner Carolyn Hiller said that Starr's sculpture doesn't meet the criteria because it doesn't seem to have been to an auction, in museums, or in national and international collections.

"I think it's very kind and very generous, but I don't think it's something that we can really accept," said Commissioner Carolyn Hiller. "Somebody could be a self-made billionaire and be an artist, and if the work qualifies as fine art internationally and nationally, then it [meets the criteria]," said Hiller.

Commissioner Alan Kaye said that perhaps the piece does in fact fit the criteria if the commission takes on a "wide interpretation. He suggested that perhaps the City does accept the piece, but move it to a place other than the Peace Garden, where it was intended to go upon donation.

Staff will now reach out to Starr's representatives to figure out if the musician/artist has other pieces of art, gallery representation, and what the resale value is.

Ed Massey Artist of Portraits of Hope

How did you first become interested

I'm homegrown in a sense. I [attended] Beverly Vista. If you want to go way back, I had my first art class in elementary school. I took everything from metal sculptures to ceramics to painting, but then there was a big void after high school. I didn't think I would ever continue with art. I was not able to get into studio art classes at the time because there was a conflict with my schedule. So I did art on my own, continuously over the course of [a few] years. I ended up going to graduate school later as a Sociology and Spanish major. I did go to art school later and my thesis was on public art. I always had a huge interest in bringing art to the masses. The Tower of Hope, [on the Beverly Hills Oil Well], was our first large-scale physics and public art project which incorporated thousands of participants.

How did you get involved in working on Tower of Hope?

That tower, 9865 Olympic Boulevard, was falling apart. [It was] just sitting idly; it was the only building I knew of in a

metropolitan area where the walls would come down and reattach. Most brick that flower symbolismwho can't get to it. You couldn't bring eight year olds, ten year olds and even fourteen

year olds to an area where you couldn't get up unless you were on scaffolding. So that building, when I found out it was removable, was that perfect ingredient of "Hey, we can bring the walls down to the level of these children, whether they're in wheelchairs or whether they can run, we can bring the walls down and then they can be active participants and contributors to really cool public art. The tower in Beverly Hills was really the launching of what now has become over 100,000 participants.

How do you feel now that the oil well is being shut down?

Well that had a beautiful life of its own during its exhibition days, which was only supposed to be for

four years. So for everyone at Portraits of Hope, we're very happy that it had a great, vibrant life. Like the life of a flower, it started to fade. Years ago, I was getting calls: "Hey, it's starting not to look like it did [before]. It was time years ago, so it's definitely time now. I think all the participants and the thousands of volunteers who worked on it, the thousands of kids-we had a glorious, shining moment. It's been time, so I'll be happy when we say goodbye.

How would you describe your artistic

There's a separation between my own work and Portraits of Hope work. Portraits of Hope is definitely [more] col-

The flower symbol [in Portraits of Hope projects] became an integral part from the inception because when I was visiting hospitals, the children I was visiting were painting flowers and drawing flowers. It didn't matter what part of the world they came from: there was a common thread. Sometimes it would be middle school aged kids very young toddlers painting flowers. Then, when we were starting to pursue the project, that flower symbolism—of healing, of beauty, of inspiration, of patience, of love, of all of that goodness-just made a meeting with Mayor [Lili] Bosse and

Tell us about the impetus behind the creation of Portraits of Hope.

I was invited to do a book reading of a

book that I had written back in 1995, called "Milton." I was invited to a children's hospital in Orange County, and while I was doing the reading I saw that kids were drawing. That was my first real interaction with youth, especially hospitalized kids. They were drawing and painting in the playrooms which were part of creative therapy programs. It's a wonderful departure for the children and their fami-

lies while they're going through some very serious circumstances, to keep their mind off—whether it's physical therapy, music therapy, or visual art therapy. So doing my book reading introduced me to children in hospitals and getting their minds off their day to day pain medications and so forth.

Did your involvement with that organization inspire your latest art installation, "Portraits of Hope: Neon Nights in 3D"?

The Lily Pond is extremely exciting. It brings me back to my roots. [My brother] Bernie and I went to [BHUSD schools]. So, to go back to Beverly Hills is special for us because we travel a lot and we're like, "Wow, we're going back to Beverly Hills 20 years later!" A lot of the participants from the elementary schools came

up to me at the market came up to me and said, "My kids worked on your first project." It's great.

The [Lily Pond] participants painting flotation elements. They're made out of very rigid foam. They have a painted surface on the top. They can float but they also use an artist canvas. So we'll have hundreds and hundreds of these floating art pieces

that will be anchored into the pond, each one individually. We're using fluorescent paints which have this magnificent daytime feeling, and then at night it coincides with the B.O.L.D program. I had

I wanted to do a photo shoot one day of our painted discs, and Mayor Bosse goes "You know, I really like this project. Why not extend it from a one day photo shoot to the month of August during out B.O.L.D initiative. People are going to be coming into the City for those late nights and this will be one of the added benefits. Our volunteers will be holding large black lights up at night from 8:00 p.m. to 10:00 p.m. on Thursdays through Saturday nights, and then we will distribute 3D glasses [to] elevate the colors.

What's next for you?

We are currently transforming the LA County Animal Shelter. Most people in the Beverly Hills community who adopt pets may not realize they're adopting a pet that came from the LA County shelter. 80,000 animals get processed every year and end up in the smaller clinics. Our mission is to get these homeless pets out of there. What we're doing is beautifying these shelters into visual knockouts. [Much of] the general public may say, "I'm not going there. That looks a little bit depressing." So when people go into these shelters, they'll see something much more joyful and whimsical at a minimum. We also just got federal approval for a very big initiative in Chicago, which is transforming the eighteen downtown bridges. The state of Illinois has more movable bridges than any other place in the world. But eighteen of those downtown bridgeswhen they start to move up twice a week about 200 linear feet in each direction, you would see a massive canvas elevate

around the juxtaposition of the buildings behind it. So you would see purples and lavenders and bright oranges. When they elevate, it's almost half of a football field going straight up in the sky, and then they would lower. So if their mind off—whether you don't catch it, you'd have to see it on one of the boat tours or on your bicycle in the park, but it becomes this pop-up of magical

colors when the bridges go up.

The art installation took place at the Beverly Hills Lily Pond on August 2.

A COMPOSER'S

Actor/pianist Hershey Felder discusses his new show at the Wallis "Our Great Tchaikovsky"

By Olivia Anderson

You're a pianist, actor, playwright, composer, producer, and director. Which came first?

It had to be the piano. It had to be. I was always acting as a kid onstage, but it had to be the piano because that's the thing you have to devote the most time to. It just takes that kind of time. It was a combination of two that was the issue, and that started when I was in my teens. I had this idea of combining these two things. It was something that everyone said, "It'll never work. It'll never go together. Nobody does it, and there's a reason nobody does it-because it's crazy and it's hard." But I put it together and made it work.

Tell us about the impetus behind "Our Great Tchaikovsky."

I got asked to do a premiere down south. I had to do the premiere here, so I promised them a premiere down there. I said, "How about we do Tchaikovsky? I've always loved Tchaikovsky." So that's how that happened.

How much do you see yourself in Tchaikovsky?

He was a rather troubled guy. I'd

like to see a bit of his genius, but no. It's a character. And the music is so brilliant. But no, I don't see myself [in him] at all. He had a terrible childhood because h i s mother

doned him and

aban-

then she died. So that imprinted on him. Psychiatrists and psychologists say that a lot of his sexual problems and his love for young men was expressed because

this happened to him when he was so young, but his love transferred from his mother to schoolmates. He stayed stuck in that kind of environment. These are real things—things I don't really know about because I'm not a psychiatrist,

but they talk about these kinds of things. This influenced his entire life and made it very, very complicated for him. Of course, living as a homosexual man in Russia in those days, he had to live secretly. I mean, there were people who were out, but

you didn't want to be famous and be out. There was also the risk that they decided you were the one they were going to punish because it was against the law. They could send you to Siberia. They were highly intolerant, and today there are similar problems. What's interesting about seeing Tchaikovsky in his days is that we're seeing Tchaikovsky through today's lens as well. It's a very com-

plicated thing.

Tell us about the composition of the show.

It's structured both what's happening today, and what happened back then, and joining those two things. But basi-

cally, my character introduces his character who introduces a whole lot of other characters. And then my character ties up the show by explaining what exactly happened, because there's a mystery surrounding his death. There [are] a lot of characters.

And you play all those characters. What's that like?

Well, nuts. You have to find voices for every one of the characters. You have to find attitudes. They have to be within

the context of the story. They have to make sense. And they happen this fast.

How do you find it within you to give your all to every performance?

Strangely, that's easy. The how is

easy; the doing it is hard. You're sitting in front of people who have taken earned cash hard have made the effort to buy a ticket. Then they made the effort to drive themselves to Beverly Hills or any venue, park, get out, [get] babysitters sometimes.

Whatever it is, they've made a real effort to be there. [I] have no business calling it in. [I'd] better do my job and [I'd] better get out there. There are people sitting out there. I'm a big fiend about that. To me, the notion of taking responsibility of charging people money—you

give them everything. They may not always like it and there's nothing you can do about that, but you have to give them everything you have. That's the responsibility. And I grew up with that responsibility. I don't think there's an alternative. There is no being

lazy; there is no "Tonight I'm not feeling so well." There's no "I have trouble at home." The histrionics that people go through-no, you go and you do your job. And then after that, you're exhausted. But I never complain because look how lucky I am. People are there, and they're actually wanting to see. There's a responsibility. And that's why it's easy to want to do the job; it's very hard to do the job. But there's no question about finding it in yourself. That's the gig. Do it. It's worth it in that I'm proud of the work that I do, and I'm proud of my work ethic. Knock on wood-it's been over 4,500 performances and I've



never missed one.

You also played Irving Berlin in "Hershey Felder as Irving Berlin." Why do you think it resonated with so many people?

The Irving Berlin show premiered here in 2014 and replayed in 2015 I think, but that was performed at another theater. It's been a huge hit. I'm going to London with it. It's this true American patriotism that I think people are looking for and really want to feel about people who really did love this country. He was one of them.

You're married to former Canadian **Prime Minister Kim Campbell. Tell** us about that.

Well, she's infinitely more famous than I am, so that's fun. She's doing a lot of international things now. She's got great perceptions of everything and she's so whip smart [which is] wonderful to have in a partner. She's a great lady. We've been together 21 years so we're sort of an old couple. We made

news because she's quite a bit older than I am in a day when that wasn't fashionable, but now about that, but you have it's totally fashionable. So we're totally boring now. It's nice to have somebody to be there and give you [an]

honest report about what it is you're actually doing, and be really that smart.

What's next for you?

A lot of travel this year with four different shows. Heaven help me. And then, I'm working on new pieces—one I'm directing. So on and so forth.
