### “Do Not Increase the JPA”

For many years, our schools were one of the main attractions bringing families to Beverly Hills. Today our district spends over 50% more per student than comparable districts, \$15,600 versus \$10,000 or less, yet lags in both test scores and college acceptances. The direction of our schools is no secret; many residents, including those who attended Beverly Hills schools themselves, choose to send their children to private schools. This is a travesty.

Our Board of Education is failing our community. Faced with reduced revenue and enrollment which has dropped from 6,000 to less than 4,000 the Board has shirked its fiscal responsibility and faces a deficit of \$3.5 million, a deficit they saw coming years ago. Instead of being open and transparent about its finances the Board has been secretive and opaque. As if this isn't sufficient proof of poor governance, the Beverly Hills Unified School District has had five superintendents in seven years.

Now the District has asked the City for a \$3.7 million annual increase to the Joint Powers Agreement (JPA). The District paid

## Rodeo Drive Temporary Seating to Continue through the Holiday Season

Even though the Businesses Open Later Days (BOLD) initiative concludes today, the bistro furniture will remain on Rodeo Drive through December 31.

As a part of BOLD, during the month of August 48 bistro tables and 192 chairs were placed at 24 locations on Rodeo Drive with 24 protective K-rails and 96 hedges.

According to the staff report, the overall consensus regarding the bistro furniture is that it “created a warm and inviting environment for consumers, residents, and visitors on Rodeo Drive by encouraging them to relax and enjoy one of the City’s premiere areas.”

The furniture was schedule to be

removed tomorrow, on September 1, but at last Tuesday’s meeting, the City Council unanimously approved a four-month extension of the temporary bistro furniture. This will provide staff with an opportunity to evaluate the effectiveness of this program for the potential development of a permanent installation.

“I’ve been out there, I’ve seen these tables really getting a lot of use, contributing to the café society [and] the atmosphere that we like,” said Councilmember Robert Wunderlich.

During questioning, Councilmember Lester Friedman inquired about the potential negative impacts of keeping the bistro tables and shrubs. Senior Management Analyst Cynthia Owens said that aside from potential theft, people may also feel more

inclined to stay overnight in the area.

“That’s why we’re bringing the ambassadors on—[it] would not only be for security, but would also be to help them find other accommodations for the evening,” said Owens.

As for the future of the Rodeo Drive seating, Councilmember John Mirisch suggested that barring any concerns from nearby stores, the City should make it permanent. Mayor Lil Bosse agreed, noting that many stores on Rodeo Drive have said BOLD has increased their business traffic, making the City more of a “pedestrian experience.”

For now, though, the Council will use the remainder of this year to examine the effectiveness of the bistro seating and make any long-term decisions at a future date.

“We need to make sure that Rodeo Drive is not just a place to shop [but] that it is an experience,” said Friedman. “I am fully supportive of continuing the project at least through December 31.”

## Bove Piece Now a Legal Matter

Carol Bove’s IO sculpture has officially become a legal matter with the City and will now only be discussed with City Council during closed sessions.

Despite being installed in September 2015, the piece has already developed significant scuff marks, pushing staff at a liaison meeting to suggest that Rosa Lowinger and Associates restore the piece entirely and that amount of money be taken out of the final payment.

The liaisons did not like that option, however, expressing that perhaps “outside of the box options” could be explored before resorting to an entire restoration. Examples of such options include coating that would make the piece less susceptible to scratching and marking, and potentially remanufacturing the piece out of different materials.

At a prior Fine Art Commission meeting, Commissioner Stephanie Vahn had suggested putting the piece inside a pond to prevent the public from touching, climbing and posing with the

Moss Adams LLP \$60,000 for a study in support of their request. The study, dated August 14, indicates the District received \$10 million for services in 2008-09 which cost the District \$7.5 million. In 2015-16 the District received \$9.8 million for services costing \$9.2 million. The District wants the City to restore the 25.4% rate of profit received in 2008-09.

A strong school system is of paramount importance to our children, our community and our future. Our residents should have all the information they need to assess the performance of our schools. A detailed budget going back five years and projecting revenues and expenses five years ahead, exactly what the city provides, is needed. With this information our community can come together and deal with the school district’s fiscal issues.

I implore our City Council DO NOT INCREASE THE JPA until such time as a budget similar to the City’s is produced by the District. To that end I, City Treasurer for 12 years, and, I am sure, city staff are available to support the District with our time, knowledge and budget experience.

Chair Michael Smooke had also suggested the piece receive a higher base than it currently sits on, but Director of Community Services Nancy Hunt-Coffey said that Bove didn’t initially want any base at all, but instead to place the piece flush to the grass.

Staff subsequently checked to see if the contract actually prohibits the commission from installing a more durable base based on artist preference. They also reached out to the artist’s gallery to see if these alternatives are an option, which was met with “legal correspondence.”

City Attorney Larry Wiener could not be reached for comment.

## Board Approves El Rodeo Temporary Parking Project

On August 22, the Board of Education approved an agreement with Asphalt, Fabric and Engineering, Inc. for the El Rodeo Temporary Parking Project.

The decision follows the completion of an onsite temporary parking area for staff before the 2017-2018 school year. Teachers and administrators will now be able to park in the onsite lot behind the building, adjacent to the instructional facilities during construction.

Previously, El Rodeo’s parking lot was removed due to construction, which created a need for 60 staff parking spaces. As a result, nearly one dozen BHUSD cars began parking on residential streets, sparking concern from residents.

Then, in March, the Traffic and Parking Commission cited resident resistance when they dismissed a proposal to issue temporary parking permits for City streets. Instead, faculty had been using shuttles to get from El Rodeo to the City parking lots.

But at their latest meeting, the Board unanimously approved the \$20,875.00 temporary agreement.

“The staff is glad to be back on site,” said El Rodeo Principal Kevin Allen. “It only adds to the collegiality in the El Rodeo community.”

## City Council Amends Legal Agreement

At their August 22 meeting, the City Council unanimously approved an amendment to the agreement between the City and Richards, Watson & Gerhson (RW&G). They also approved a change in a purchase order for \$200,000 for special legal services related to rent control administration.

RW&G was originally approved in April 2015 to provide general legal counsel services for the City. With the amendment, however, staff will increase the monthly retainer and add “Rent Control Services” as additional services provided under the agreement.

As City Attorney Larry Wiener is a partner in the

firm, he recused himself before the item was discussed.

Although City Manager Mahdi Aluzri assured that the legal fees would not be billed unless the services are actually provided, several people expressed concern for the purchase order at public comment.

Apartment Association Representative Fred Sutton encouraged the Council to refrain from taking any formal action in regards to the rent control program until all the mediation meetings have taken place and been presented at the September 5 meeting.

“We would fully support \$200,000 going to code enforcement to expand potential investigations into possible habitability issues and things of that nature, but we just do not think any more funding needs to go to any aspect of the rent control program until it’s formalized,” said Sutton. “We do think there’s better use of City funds.”

During deliberation, Councilmember Lester Friedman pointed out that an overall increase hasn’t been implemented in over two years, since the contract was first initiated. He also noted that the \$200,000 is simply a placeholder and that it is required for city government to reserve an allocation for a service in case it needs to be provided if over \$50,000.

“With that in mind, that’s all it is—a placeholder, and I do support that,” said Friedman.

Councilmember John Mirisch said that

while he supports a three percent increase for the coming fiscal year, he feels rent control “is a legislative issue.”

“We have a retainer. I believe that should be included in the scope that Richards, Watson & Gershon provides so I will not be supporting this,” said Mirisch.

The Council approved 4-1 the Amendment No. 1 and change purchase order to RW&G, with Mirisch dissenting.

### Hacker Questions Board’s Legal Agreement

At the School Board meeting on August 22, Board of Education member Isabel Hacker questioned a \$500,000 purchase order for the law firm Kasowitz Benson Torres LLP.

“I don’t think the Board has had a discussion yet about what our budget looks like,” said Hacker. “I don’t even think we have a budget.”

Hacker then proceeded to ask how staff arrived at that number, to which Chief Administrative Officer La Tanya Kirk-Carter said she believes the number was derived from the prior fiscal year.

“What it would be is us setting the purchase order amount to cover to cover the invoices that we [have today],” said Kirk-Carter.

She said that with this particular purchase order, staff didn’t have enough authority to pay the bills, so in order to make the payments they increased the purchase order.

“That’s why it’s a round figure,” said

Hacker also noted that the purchase order was erroneously paid from the Board’s General Fund rather than the Measure E budget, a mistake that also occurred last year. She then went on to contend that the Board should be the one to develop the budget for the continually increasing legal fees.

“I really do not appreciate that lawyers get the phone call from staff [saying] ‘How much do you need for this year?’” said Hacker. “If we really are serious and sincere about getting a hold of our legal fees, I think the discussion has to come from this body and not from the lawyers.”

While Superintendent Michael Bregy said that a typical function of the cabinet is to make estimates based on the prior year’s expenses, Hacker reiterated that the District should still aim to be “more organized when it comes to legal[s].”

### 9701 Wilshire Boulevard Could Have Fine Art Obligation

The Fine Art Commission heard a proposal for an art installation at 9701 Wilshire Boulevard to meet the Fine Art Obligation.

The Fine Art Obligation, listed under the Beverly Hills Fine Art Ordinance, states that “any construction, reconstruction or additions, to a commercial/industrial building or mixed use building in

the city of Beverly Hills shall be assessed with the obligation to provide fine art.”

If the total construction costs between \$500,000 and \$1,000,000, fine art must be installed that has a value equal to or exceeding one percent of the total construction costs. Alternatively, the obligation may be satisfied through a payment of an in lieu fee to the fine art fund equal to ninety percent of the value required by the first option.

Currently located in the lobby area, the two pieces by artist Randy Bloom will be \$8,100 to satisfy the Obligation.

At their meeting on August 17, the Fine Art Commission decided whether or not this particular proposal meets the criteria in terms of artist and location.

Commissioner Alan Kaye said that while he believes the artist and art were “great,” he didn’t know how they are visible to the public, one of the main criteria.

Property owner representative Brad Adams responded by saying that one of the pieces is hanging in the elevator lobby which is indeed visible to the public. The other, however, is only visible when inside the building.

Ultimately, the commission directed the applicant to either move the second piece so that both are located in the lobby so as to be visible to the public, or to return at a later date with “a bona fide art appraisal.”

“I think that’s required anyway, which we didn’t get,” said Commissioner Zale Richard Rubins. “So if you came back next month we could look at it that way.”

founder of investment firm Omninet and former board member of the technology company Qualcomm, has been described as a “positive thinker whose love of Israel and his family were the driving forces of his life.”

At 17, he traveled to Italy and fought with the Haganah in Genoa. Later, he moved to Israel and served with the Israeli armored forces in the War of Independence. After being injured in war, he was unable to fight and became the chauffeur for then-Foreign Minister Golda Meir.

In 1957, he returned to Iran, found success in the construction business, married and started a family. He left for good in 1979 during the Islamic Revolution and eventually moved to Beverly Hills with his family.

Several years later, in 1984, Nazarian co-founded Omninet which later joined forces with Qualcomm to develop a satellite-messaging system for the long-haul trucking industry.

He then donated to many organizations including Sinai Temple. The first floor of

the Westwood campus is named for him and his wife, Pouran Toufer. He was also a donor to the Nessah Educational and Cultural Center.

Additionally, he founded the Magbit Foundation, which promotes education for those seeking to complete their university studies.

“His legacy will be as a shaper of the Persian Jewish community here and as a major pillar of the Diaspora support of the state of Israel,” said Sinai Temple Senior Rabbi David Wolpe.



Nazarian’s survivors include his wife; four grandchildren Dora Nazarian Kadisha, Dalia Nazarian Sassouni, Daphna Nazarian Salimpour and Benjamin Nazarian; 12 grandchildren; and two great-grandchildren.

His memorial service was held on August 30 at Sinai Temple. Sinai Temple and the Nessah Educational

and Cultural Center are accepting donations in his honor.

## BHHS Loses 35-0 in Football Opener

Junior Nick Sullivan ran for 114 yards on 25 carries for Beverly High in a season-opening 35-0 loss to Carnegie Schools Riverside in a nonleague football game Friday night at Culver City High.

“It shouldn’t have been probably the score that it was,” Normans coach Steve Geanakos said. “I think it was a little bit of a closer game.”

“Field position was poor. We need to work on our special teams.”

Beverly Hills also has “to play better in the first half to keep the thing closer so we can have a chance,” Geanakos said.

Geanakos described Sullivan as “a chubby little kid” in elementary school who has “turned it around and now he’s stud that’s out there playing his heart out” and “making a difference for the team.”

After earlier mentioning how “a lot of players on the team take the summer off” to “visit relatives” and “go on vacation” Geanakos praised Sullivan for “coming to practices over the summer” and in the spring and being in the weight room “all the time.”

“He is one of those kids that we will use to inspire others,” Geanakos said.

Geanakos also praised the play of middle linebacker Charlie Green and tight ends Jonathan Tansey and Sam Moezinia.

“Our line pass blocked well,” Geanakos said. “We got to work on the run blocking a little more.”

The Normans came closest to scoring in the fourth quarter, driving to the Wolverines 4-yard line when Jeremiah Klapper’s fourth-down pass intended for Thomas Goolsby fell incomplete in the end zone.

Decklan Eaden ran 96 yards for a touchdown on the next play, his final carry in a game he rushed for 164 yards on eight carries.

Francis Bemiy ran for one- and 11-yard touchdowns on Carnegie’s first possession. The 6-foot-4, 220-pound Bemiy also ran for a five-yard touchdown in the second quarter and a four-yard touchdown in the third on his final carry.

Bemiy ran for 59 yards on 10 carries. He has made a nonbinding verbal commitment to accept an athletic scholarship from Connecticut to play football, Wolverines coach Jason McMains said.

Klapper completed five of 13 passes for 43 yards in relief of Goolsby, who threw three incomplete passes on the Normans first, second and fourth possessions. Thomas Recupero threw three incomplete passes in the fourth quarter.

“The quarterbacks threw well,” Geanakos said. “(The ball) bounced off some receivers’ hands. Obviously, we need to work on that also.” Because installation of the new artificial turf field at Beverly High’s Nickoll Field has not been completed, the Normans are forced to

## LET'S TALK SPORTS

### Athletic Director Kevin Brown on the future of Beverly High Athletics

#### Tell us about your role as Athletic Director.

My role is to be in charge of our athletic department and its operations. I'm managing and supervising and overseeing our coaches. I work with our coaches on making sure that the school and our core values are connected. A big thing with athletic directors is that it's a team effort to get the job done. I'm working with our administration, I'm working with my administrative assistant, I'm working with of course coaches. It's definitely a team approach to all this.

#### Tell us about your teaching background before Beverly High.

I actually started my teaching and coaching career at Beverly High in 1994. I was the varsity basketball coach at Beverly High. I was an adaptive P.E. teacher. I was a social studies teacher at Beverly High. Then from '97 to 2010, I coached college basketball. I spent a year as the national coach of a country in Africa, the Ivory Coast. And then I spent five years as an administrator at Inglewood High School where I served as principal in [the] 2013-2014 school year. Then I was the assistant

principal at Beverly High for two years, and now I'm in my second year as the athletic director. So I do try to bring an administrative mindset to this position, meaning how to work in collaboration with the school and making sure that we have a safe, healthy environment, and that we are creating a culture where students are getting a great experience in extracurricular activities. So, [my background] has helped me with that type of mindset.

#### Of the 1,500 total students at Beverly, approximately how many are involved on athletic teams?

I'd say about 65 percent.

#### Has lower enrollment affected filling the teams?

We still have great participation across the board. When we measure success and when we define success, it's not always wins and losses. We want to create a culture for our students to have a great experience and a positive experience where it's just a by-product where what you learn as a student in our school system [along with] work ethic, enthusiasm, gratitude, resiliency, listening skills, collaboration, teamwork. All that is a by-



product of being a student in our system. When our [athletics] participation is still 65 to 70 percent of the school, and we say "How do we define success?" it's measured in many ways. You can look at wins and losses and you can look at the experience and we like to look at the experience. But if you look at just in the last three years and you want to talk about winning, the boys' basketball team won the CIF championship. The girls' basketball team won the CIF championship. Our cross country boys' varsity team went to the CIF finals. Our boys' tennis team went to CIF. Our baseball team went to the playoffs. We're still fielding 23 sports. You look at across the board [and] we're still competitive in our sports.
