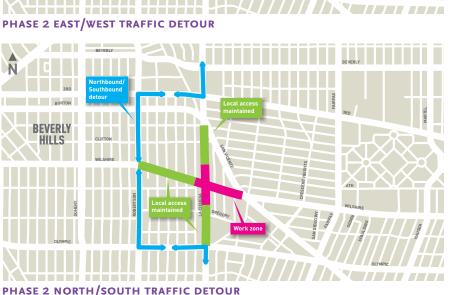

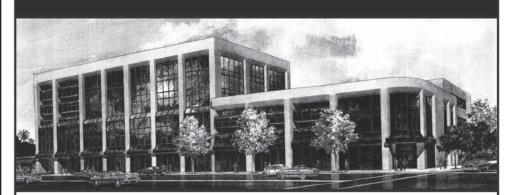

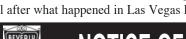

The Planning Commission of the City of Beverly Hills, at its regular meeting on Thursday, October 12, 2017, will hold a public hearing beginning at 1:30 PM, or as soon thereafter as the matter may be heard to consider:

AN ORDINANCE AMENDING BEVERLY HILLS MUNICIPAL CODE SECTION § 10-3-1528 PERTAINING TO THE OCCUPANCY PRIORITY FOR AFFORDABLE HOUSING UNITS BUILT IN THE CITY PURSUANT TO THE CITY'S RESIDENTIAL DENSITY BONUS REGULATIONS.

The proposed Ordinance would amend § 10-3-1528 of the Beverly Hills Municipal Code (BHMC) in order to revise and refine the existing priority list that establishes the order in which income qualified individuals and households are considered for occupancy in affordable units built in the City pursuant to the City's Residential Density Bonus regulations (BHMC Article 15.2). The proposed Ordinance establishes the following six tiers of individuals and households that will be prioritized for affordable housing units:

- Tier 1 Senior households being displaced from the project site due to the development of the new project;
- Tier 2 Other households being displaced from the project site due to the development of the new project;
- Tier 3 Senior households that have been recently displaced or will be displaced from a multi-family property in the City due to redevelopment;
- Tier 4 Other households that have been recently displaced or will be displaced from a multi-family property in the City due to redevelopment;
- Tier 5 Senior households;
- Tier 6 All other income qualified households.

The Ordinance will require final approval by the City Council at a future noticed public hearing.

This Ordinance has been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the environmental regulations of the City. The adoption and implementation of the Ordinance appears to be eligible for a class 5 categorical exemption for minor changes in land use limitations and the Ordinance could be found to not have a significant environmental impact. Further, it can be seen with certainty that there is no possibility that the adoption and implementation of the Ordinance could have a significant effect on the environment. The Planning Commission will consider finding that this Ordinance is exempt from the environmental review requirements of CEQA pursuant to Section 15305 of Title 14 of the California Code of Regulations and Section 15061(b)(3) of Title 14 of the California Code of Regulations.

Any interested person may attend the meeting and be heard or present written comments to the Commission.

According to Government Code Section 65009, if you challenge the Commission's action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the City, either at or prior to the public hearing.

Spitz Raises Concerns About Salary Formula

Despite being passed by the Board of Education last Tuesday, Board President Mel Spitz has expressed frustration with the new faculty/staff salary increases.

The increase will apply to unions such as the Beverly Hills Education Association (BHEA), California Teachers' Union, the



Assistants Unit, **BHEA** Office Technical Unit, and the California School Employees Association Effective on July

1, the salary formula will start at 2.174 percent for the cur-

rent fiscal year, upping to 3.003 percent for 2018-2019 and back down to 2.805 percent for 2019-2020.

But Board President Mel Spitz believes that the automatic increase—which is built into the union contract that ties salaries to property tax revenue—is "unsustainable."

"That is one of the conditions that lead to operating deficits," said Spitz. "There's no control."

Spitz says that as a possible solution, the district should discontinue the salary

Traditionally, salaries are determined through negotiations, but if the union won't agree, Spitz said the negotiations will go to impasse and the Board would unilaterally discontinue the salary formula model.

But not everyone opposes contractual increases. BHEA President Telly Tse called these increases "fair" and "necessary" for the educators. He said that if not for the formula, some people would actually be taking home less money this year than they did last year.

"It's a good thing that should stay in our contract indefinitely," Tse told the Weekly.

When asked about Spitz's contention that the formula is unsustainable, Tse called his reasoning "flawed," explaining Spitz's argument that property taxes have the ability to decrease.

"But if you look at the history, the property values have gone up," said Tse. "The reason he thinks it might be unsustainable simply isn't an accurate statement."

Negotiations between the Board and unions are ongoing.

Council Approves Tree Lighting Décor

The City Council approved a proposal for Southeast Tree Lighting Décor at their Study Session on October 3.

The decision follows an August 8 meeting staff provided an overview of enhanced holiday décor for the Business District, including Bacarat lighting on Rodeo Drive and enhanced holiday lighting elements for streets like North and South Beverly Drive.

Staff consulted with the City holiday program contractor Utopia Worldwide Inc. to look at various options for enhancing the lighting on La Cienega and Robertson Boulevards. The proposed holiday lighting consists of off the shelf designs this year, as it is too late for any custom designs to be built for the area.

The first of four options was to continue with the current scope of work defined in the City's current contract: the installation of warm LED lights on 18 trees on La Cienega as well as the installation of banners on both La Cienega and Robertson. It would require no additional costs.

The second consisted of expanding the warm white LED tree lights on La Cienega to include 23 additional trees on La Cienega north of Wilshire and one block south of Wilshire. Additionally, 32 trees on both sides of Robertson from Clifton to Gregory would be wrapped with multi-colored LED tree lights. It would require \$10,875 in additional funding.

The third option would add colored, snowfall LED lighting in the trees on both La Cienega and Robertson. It would require \$200,801 in additional funding.

But the Council unanimously went with the fourth option, which will consist of LED tree lights in option 2, but will add various colored spheres in different sizes to the 41 trees on La Cienega in lieu of snowfall LED lights. Robertson will be decorated with the multi-colored LED tree and snowfall lights outlined in option 2 as the vendor for the spheres does not have enough LED spheres in stock to decorate the trees on both La Cienega and Robertson. It will require

Mayor Lili Bosse said that this will encourage people to open businesses and walk on Robertson more, saying the street "will come to life."

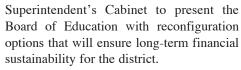
"I think this is an investment in our future," said Bosse. "It will bring forward a more vibrant business community."

Future Focused School Members Named

The BHUSD has announced the members of the Future Focused Schools Team-a 21-member committee that will work to develop reconfiguration options for the five campuses.

The members were selected from a pool of 54 applicants, to "represent a diverse group of community stakeholders," according to a press release. They include teachers, parents, and administrators.

The team will work with the

Beginning this month, they will be meeting several times to research and analyze the configuration of the BHUSD, culminating in a December presentation to the Board.

City Council Moves Lago Vista Appeal Again

At Tuesday's meeting, the City Council moved the appeal hearing for 1260 Lago Vista Drive to November 7.

City attorney Larry Wiener said that the City inadvertently failed to produce

> all Public Records Act Request documents that applicant attorney Benjamin Reznik had requested.

> He said that because one chain of emails had the phrase "Concerns—1250 Lago Vista Experience"-which did not come up in the search-certain documents were overlooked.

> "My recommendation would be to continue [the hearing to November 7] so you can get this set of emails as well as any others that may have had similar mistakes," said Wiener.

> The decision to continue the hearing to November comes after the Planning Commission denied a Hillside R-1 Permit to the property on May 11, which would have allowed the property owner from exporting not less than 2,498 cubic yards of earth material.

> Just a week later, Reznik filed an appeal of the Planning Commission's decision. At that

point the City Council set the appeal hearing for August 8, but staff prepared a written interpretation regarding the Municipal Code's definition of "basement" and how to determine what portions of a singlefamily residence qualify and therefore exempt from counting toward the maximum allowed floor area.

It was found that 1260 Lago Vista doesn't comply and would require a re-design prior to the appeal hearing.

On July 27, Reznik filed an appeal of the basement interpretation. As the appeal was pending, City Council agreed to continue the hearing to Tuesday, and now November

Attorney Ronald Richards called the basis of the basement argument "frivolous," arguing that there is "nothing wrong" with interpreting the municipal code and that it happens frequently.

He also noted that Council would be doing a disservice to the community by upholding the appeal, as residents are collectively against the project.

"We still have unanimous opposition," said Richards. "Not a single resident is in favor of the project. You have every home owner in the vicinity against the project."

City Council Municipal Election Date Moves to

The City Council decided to move its municipal election dates to March 3, 2020.

Because it was extended a year, Councilmember Robert Wunderlich is

expected to become mayor prior to the 2022 election.

Senate Bill 415, known as the California Voter Participation Rights Act amended the state Elections Code pertaining to municipal election dates. It requires cities that currently hold standalone municipal elections to eventually change their election dates to coincide with statewide election dates.

Beverly Hills' most recent municipal election (held in March) was significantly lower than the average rate for the past four statewide elections, which means it will have to consolidate its municipal elections with statewide elections.

The Council had the choices of opting for a November consolidation plan or March consolidation plan. November would have meant that those elected in March would have their terms reduced by four months, so that they serve three year, eight month terms and continuing for two election cycles.

But because a March election falls exactly 12 months before or after the City's election, the City chose to increase council member terms. It will continue for two election cycles.

The City's decision doesn't need to be implemented until the November 2022 statewide general election date.

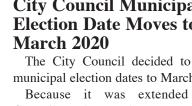

BHUSD Raises Hurricane Relief Funds

The Beverly Hills Unified School District is launching a fundraising drive to help fellow students, teachers and families in Texas recover from Hurricane Harvey.

Donations in the form of cash and checks made payable to the Beverly Hills PTA Council, are being collected at #BH1 for the Gulf hurricane relief tables and events at each of the district's five schools from Wednesday October 4th through Friday October 13th: Beverly Vista, El Rodeo, Hawthorne, Horace Mann, and Beverly High.

"This is the first activity in a series of hurricane relief efforts that will continue throughout the school year," said Beverly Vista Principal Christian Fuhrer, who along with the district's Service Learning Coordinators is helping to launch the #BH1 for the Gulf program, "It's all about students helping students, teachers supporting teachers, and families reaching out to families - to really show how we can make a difference by working together."

Money raised will go directly to the Alief Independent School District located in southwest Houston, Texas. Dee Jones, the Alief ISD Business and Community Partnership Coordinator, estimates around 200 teachers and staff members lost vehicles, belongings, and in some cases their entire homes in the storm.

"One of our BHHS staff members with colleagues in Houston alerted us to the great need in this school community," said BHUSD Superintendent of Schools Dr. Michael Bregy, "It's clear that recovering and rebuilding following an event like this will take time. Our BHUSD community is committed to offering ongoing support to our fellow school districts hit so hard by hurricanes this year."



Wallis to Remember Gregory

The Wallis will launch its 2017-2018 theater season with the West Coast premiere of the Off-Broadway show, "Turn Me Loose," a comedic drama by Gretchen Law.

Produced by John Legend and Mike Jackson, the show follows the life of comedian and civil rights activist Dick Gregory—who passed away on August 19 at age 84.

The production, under the direction of John Gould Rubin, will open in The Wallis' Lovelace Studio Theater, which will be transformed in part into a comedy club, on Friday, October 13 at 8pm.

It stars Emmy and NAACP Image Award-winner Joe Morton (ABC's "Scandal") as the pioneering satirist.

The play also features actor John Carlin, as well as an original song by Legend. The limited engagement runs Thursdays through Sundays and has been extended through November 12.

"Turn Me Loose" explores the influential life of 1960s comic genius Dick Gregory, the first Black stand-up to make white audiences laugh at the absurdity of bigotry. The play reveals how the power of activism enticed Gregory from one of the most successful show business careers of the postwar era into a life of sacrifice and danger alongside Martin Luther King, Medgar Evers and other Civil Rights leaders.

"The Wallis is honored to both present this wonderful piece of theater and celebrate Mr. Gregory's legacy, making sure that as many people as possible will be made aware of his life, his achievements, his involvement in the civil rights movement, his beliefs in social justice, and his comedy that revealed a wisdom and truth," said Paul Crewes, The Wallis' Artistic Director.

PLANNING COMMISSION APPROVES 9200 WILSHIRE

The final project addresses modulation, noise, and traffic

During a special meeting on the evening of October 2, the Planning Commission approved the final project of a Planned Development Permit on 9200 Wilshire Boulevard.

The hearing followed the commission's denial of an application to modify the building at their July 13 meeting, telling applicant New Pacific Realty to reduce the number of residential units, "and address issues of modulation, privacy, noise, and traffic."

The original permit allowed the development of a six-story mixed-use building that consists of ground floor retail uses and 54 residential units above. The modified project would have added an additional 36 residential units.

It also would have reduced the amount of ground floor retail space, shifted the building modulation, changed the site circulation, and removed one level of

subterranean parking while increasing the total number of parking spaces on site.

At an Ad-Hoc Committee meeting on July 27, the applicant proposed a modified design that would have reduced the number of residential units from 90 to 84.

After further consideration, the applicant reduced that number even further to a once-again 54 residential unit project with six stories and 6,119 square feet of ground-floor retail.

However, not all neighbors are satisfied with the final project.

"As much as I appreciate the developers hearing the residents' concerns and revisiting a more tempered design, I would be remiss in not pushing my outlandish agenda of more green space," said Board of Education member Noah Margo, who lives near the project on South Palm Drive, in a statement. At deliberation, Commissioner Craig Corman said that the touchstone is whether the proposed project will "advance the objectives" of the mixed-use Overlay

including Objective B which states that the mixed-use development must be "compatible with the scale and massing of the surrounding neighborhood through appropriate height modulation upper story setbacks."

Corman went on to point out that New Pacific wants to bring the proposed project further forward and add rooftop decks—something he suggests will make the project "look much larger than everything else in the street."

Corman said that he believes the current proposed project-specifically the size and location of the retail space and the rearrangement of the building modulation—will hinder the overall objectives

Commissioner Joe Shooshani commented that the applicant should build additional commercial parking.

New Pacific applicant Arnold Rosenstein responded to this by agreeing to turn part the subterranean level into retail parking and move residential parking down below. Rosenstein also agreed to expanding the retail square footage, decreasing the courtyard size and increasing the rear modulation.

The project was ultimately approved 4-1, with Corman dissenting.

coverstory **METRO HOLDS PURPLE LINE EXTENSION MEETING**

Metro aims to alleviate community concerns

Last Thursday evening, Metro held the Section 2 community meeting for the Purple Line Extension.

About 20 to 30 community members showed up to hear progress updates regarding the Century City/Constellation station and the Rodeo Drive station.

Currently underway City/Constellation station Telecommunications line work. The work days are Sundays through Thursdays from 7:00 p.m. to 6:00 a.m. through the end of September. Upcoming work includes DWP (Power) cable pulling/splicing, beginning this month until early 2019. The anticipated work hours will be Sundays through Saturdays from 7:00 p.m. to 6:00

Additionally, potholing/geotechnical surveys will begin in November which will cause temporary lane closures, pile drilling will begin in spring 2018, and

decking installation will begin in summer

"We would dig up the street curb to curb, put down steel beams across the street, and then fill [it] in with concrete deck panels," said Metro Community Relations Manager Kasey Shuda, adding that Constellation will be closed for likely nine months.

After that, the station construction will be entirely underground. The only surface activities will include deliveries, soil removal, and concrete pumping.

"You won't see us, hear us or feel us," said Shuda.

As for the Wilshire/Rodeo station, the presentation began with an announcement that the Southern California Edison (SCE) relocation has been approved. The first stage of the 44-day process began on September 5, and will have no conflict with the Santa Monica Boulevard project.

Stage 2 will take 15 days. It will occur

on Sundays from 10:00 a.m. to 6:00 p.m. and Mondays-Wednesdays from 9:00 a.m. to 4:00 p.m. Stage 3, six days, and stage 4, seven days, will follow the same schedule. Stage 5, 11 days, will occur on Mondays-Fridays from 9:00 a.m. to 4:00 p.m.

In her presentation, Shuda also discussed the scope of work for geotechni-

cal site investigation and traffic surveying, the latter of which is obtained by setting up video cameras at each intersection. There will be 2-4 cameras per intersection and all survey locations will be completed

within the same work week.

The survey locations include Santa Monica Blvd. & Beverly Blvd., Rodeo Dr. & Wilshire Blvd., El Camino Dr. & Wilshire Dr., Robertson Blvd. & Burton Way, Robertson Blvd. & Wilshire Blvd.. Wilshire Blvd. from Rodeo Dr. to Crescent Dr., and Santa Monica Blvd., north of Wilshire Blvd.

Shuda said all video cameras will be mounted on poles outside of the public right of way and that there will be no impact to traffic.

Geotechnical site investigation—the gathering on additional soil information to validate existing data and examine the subsurface conditions for construction of stations and tunnels—begins this month and will run through November. The proposed work hours are nighttime-8:00 p.m. to 6:00 a.m. and/or daytime-7:00 a.m. to 4:00 p.m.

During the question and answer portion, several residents expressed concern regarding the Purple Line extension, citing

the potential health risks of the subway running beneath Beverly High.

"I'm not opposed to Metro," said longtime resident Nadine Glauberman. "What I worry about is the earth beneath where you're working,

[which] would be at Beverly Hills High School.'

Shuda responded to this complaint by stating that Metro conducted an environmental study back in 2012 that deemed the construction safe. Then, following several BHUSD lawsuits, Metro conducted a supplemental environmental impact statement, which will be officially released in November.

"We would not do anything that we deemed unsafe," said Shuda. "There is no way that Metro would enter into that liability."

Metro will now seek City Council approval for the next steps of the Wilshire/ Rodeo station.
