## Attorney: More Claimants Have Come Forward in Spagnoli Case

BHPD Captain Mark Rosen’s attorney Bradley Gage says that new claimants have come forward in the discrimination case against BHPD Chief Sandra Spagnoli.

At the end of March, Rosen initially filed a complaint alleging that he was subjected to discrimination, harassment and retaliation by the BHPD for being Jewish and over 40 years old.



Spagnoli was named in the *Bradley Gage* complaint as one who allegedly made “derogatory comments” toward Rosen. Spagnoli has denied all allegations.

“Other witnesses have confirmed it too. You’ll start to see it in these governmental claims we’ve done,” said Gage.

Some of these claimants include former Traffic Department employees David Brandon and Lisa Weller, who have filed claims of retaliation, discrimination,

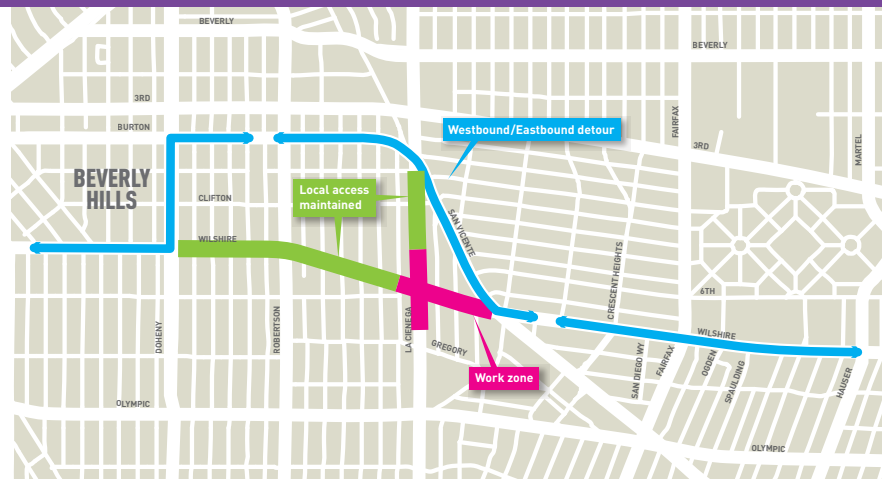

harassment, among others.

In the governmental claims provided by Gage, the claims allege that “there is also ratification by Chief Spagnoli of racial comments and derogatory comments.” Specifically, the report claims, such comments pertain to anti-black, anti-female, sexual orientation comments and age comments.

Allegedly, Spagnoli told Brandon, “I know you have 37 years here and are of retirement age, if you consider retirement as an option, all of this will go away” according to the document.

City Attorney Larry Wiener was unavailable for comment as of press time.

Gage says the case will likely go to trial in the coming months.

### Robin Thicke Performance to Cost Over \$100,000

The Rodeo Drive Committee has announced that singer/songwriter Robin Thicke will be the headlining performer at this year’s annual Rodeo Drive Holiday Lighting Celebration.



The celebration, which kicks off *Robin Thicke* the Holiday season in Beverly Hills, will take place on November 16. Time is TBD.

Out of a budget \$150,000, Thicke was hired for \$110,000. There will also be another \$10-15,000 in tech, hospitality and transportation costs, according to the City’s Public Information Manager.

### Planning Commission Votes to Support Zone Change on 128 and 130 South Carson

At their meeting last Thursday, the Planning Commission decided to direct staff to create resolution recommending that the City Council approve a zone change of two parcels at 128 and 130 South Carson Road.

The request would rezone the two parcels from R-1 zone (one-family residential) to R-4 zone (multiple residential). There is not a development project proposed at this time.

Ten years ago the City Council approved a five-story mixed-use project at 8600 Wilshire Boulevard containing up to 26 condominium units and approximately 6,000 square foot which would be used for retail space.

At that time, the property owners of the two single-family parcels located adjacent to the project, 128 and 130 South Carson Road, requested that the City consider the rezoning of their parcels from single-family to multi-family zoning.

In December 2007, the Council directed staff to send the request through the

Planning Commission. Then, in 2016, the Planning Commission and City Council Liaison Committee directed staff to process this request and bring the item forward for consideration by the Planning Commission and City Council.

Staff then consulted with the owners of the two properties to clarify the request. In a letter sent to the Planning Commission in September owner Eileen Finizza stated her reasoning for submitting the request, citing issues like concerns for impacts of privacy

Former Planning Commissioner Nancy Krasne urged the commission to approve the project, noting that she advocates for the request “only because it was a promise that was made when I was on the Planning Commission in 2007.”

“These ladies have waited a long time,” said Krasne. “Nothing is going to change. They’re not going to build there.”

But during the public hearing last Thursday, several neighbors objected to the proposal, citing issues like a lack of adequate notice to the neighbors, increased traffic, and health risks.



loss, parking loss, traffic and garage traffic from the adjacent development, and loss of value to her property due to the mixed-use project.

“If we knew it would be upzoned, we would have never bought this house,” wrote Finizza. “The City Fathers originally designed Beverly Hills as an R-1 Residential Community. They did NOT design it as a Commercial/Multiple Condos in an R-1 area.”

“I think there will be significant health and safety impacts by changing the zoning,” said neighbor Mark Rosenfeld. “They’re not asking to go from an R-1 to an R-2; they’re asking to go to R-4.”

Rosenfeld also noted that the change could affect many families and kids, pointing to Horace Mann which is located just down the street.

At deliberation, Corman criticized for City Council approving in 2007 an overlay

zone so close to residential properties, calling the decision “unconscionable.”

That said, Corman also added that an R-4 is still a “big ask” from the property owners. He pointed out that they could potentially combine the two properties together to create a large box that’s a multiple family building and would have a great density. This, he argued, could also decrease property value of surrounding properties.

He suggested creating an overlay zone, which Chair Lori Greene Gordon expressed reservations but said she was willing to explore more than the current proposal.

Ultimately, the commission voted 3-2 to prepare the recommendation, with Gordon and Corman dissenting.

### Water Rates Could Increase

The Public Works Commission unanimously voted last Thursday to recommend that the City Council move forward with the proposed water rate increases and pass-through authorization.

Previously, on July 24, the commission recommended to the Public Works Liaison (Vice Mayor Julian Gold and Councilmember Robert Wunderlich) that the City Council initiate its public noticing process.

Staff initially presented a scenario to the Public Works Commission that recommended a three percent increase in the first year with a two percent increase in years two through five.

The Liaison Committee recommended that the proposed rate adjustments be modified from what had been recommended by the commission in years two through five to be three percent.

The benefit of increasing the rate adjust-

ment in outer years is that it reduces the need for the Water Enterprise Fund to utilize its reserves, according to the staff report.

Commission Chair Jeff Wolfe noted that while he was initially opposed to the proposal—citing his discomfort with the financial analysis—what the commission is now supporting is a notice that legally allows the commission to raise up to three percent per year without going through the same process.

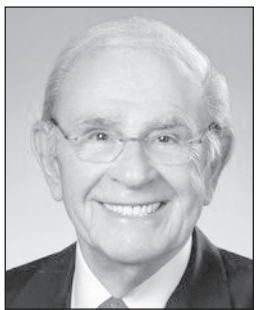
“We are not voting yet to actually make the increase; we’re simply voting to start that process and allow those rates to go up,” said Wolfe. “I bring that up because the decision to spend the money is going to be an independent decision that will be made separate from these discussions.”

There will be a public hearing for the proposed water rate increases at the November 7 City Council meeting. If a majority of affected property owners protest the increased rates in writing, they can’t be increased.

If approved, the rates would become effective on January 1, 2018.

### Goldsmith to Receive Posthumous Alley Naming

The City Council voted on Tuesday to approve a proposal for a posthumous honorary naming of a public alley in recognition of Bram Goldsmith and his contribu-

# NOTICE OF PUBLIC HEARING

The Planning Commission of the City of Beverly Hills, at a regular meeting on **Thursday, October 26, 2017**, will hold a public hearing beginning at **7:00 PM**, or as soon thereafter as the matter may be heard to consider an ordinance to amend development standards generally pertaining to basements in the residential zones of the City, and development standards generally pertaining to grading and retaining walls in the Hillside Area of the City. The proposed ordinance includes the following measures, which may be further modified by the Planning Commission:

- The definition of “floor area” in single-family residential zones is proposed to be amended to define a “basement” as an area that is located directly below the portion of a story above which has a finished floor level that is a maximum of three feet (3’) above finished grade at any cross-section cut through the building with certain exceptions for driveways, light courts, pools and water features, and stairs and access ways that might otherwise cause a basement to be exposed by more than 3’ above grade. The proposed amendments would also require a basement that extends beyond a story above to be located entirely below both finished and natural grades. (Proposed amendment to Beverly Hills Municipal Code [BHMC] § 10-3-100.)
- A definition of “light court” is proposed to be added to the BHMC. As proposed, a light court would be an excavated area adjacent to a building that extends more than 4’-0” from the building perimeter that is enclosed on four sides, open on the top, and allows light into a below grade level of a building. The BHMC does not currently contain a definition of light court. (Proposed addition to BHMC § 10-3-100.)
- The definitions of “finished grade” and “natural grade” are proposed to be added to the BHMC to ensure clarity of the code and consistency in its application. (Proposed additions to BHMC § 10-3-100.)
- The language governing the maximum height of walls, fences, and hedges within the Hillside Area of the City is proposed to be amended to limit the total height of any wall fence or hedge to 12’-0” regardless of the side of the wall, fence, or hedge from which a measurement is being taken. (proposed amendment to BHMC § 10-3-216.)
- The language governing the construction of series of walls in the Hillside Area of the City is proposed to be amended to allow for a maximum cumulative height of 12’-0” for all walls constructed on the same property within any 50’ perpendicular section. A 10’-0” landscaped horizontal distance must also be provided between each wall. (Proposed amendment of BHMC § 10-3-2516.)
- The calculation method provided in the BHMC that defines the total cubic yards of landform alteration (cut/fill) allowed on a site in the Hillside Area of the City within a five year period is proposed to be amended. (Proposed amendment of BHMC 10-3-2521.)
- The regulations regarding import/export of earth material within the Hillside Area of the City are proposed to be amended to state that within any five year period no more than 2,400 cubic yards of earth material may be imported or exported from a site in the Hillside Area on a street that is 24’ wide or wider, with clarification that cubic yardage will be based on in-ground earth volumes. Current language in the BHMC allows up to 3,000 cubic yards of earth material to be imported or exported from a site in the Hillside Area during a five year period, but does not stipulate whether this is in-ground compacted earth material or excavated un-compacted earth material. (Proposed amendment of BHMC 10-3-2521)
- The regulations regarding import/export of earth material within the Hillside Area of the City are proposed to be amended to state that within any five year period no more than 1,200 cubic yards of earth material may be imported or exported from a site in the Hillside Area on a street that is less than 24’ in width, with clarification that cubic yardage will be based on in-ground earth volumes. Current language in the BHMC allows up to 1,500 cubic yards of earth material to be imported or exported from a site in the Hillside Area during a five-year period, but does not stipulate whether this is in-ground compacted earth material or excavated un-compacted earth material. (Proposed amendment of BHMC 10-3-2521.1)
- The findings pertaining to Hillside R-1 Permits are proposed to be amended to add a provision that the total number of construction-related vehicle trips associated with a project as a whole may be considered by a reviewing authority when considering a Hillside R-1 Permit for import and export of earth material. (Proposed amendment of BHMC §10-3-2550)
- Other non-substantive changes to reorganize and reorder Article 25 of Chapter 3 of Title 10 of the BHMC, which contains development standards applicable to the Hillside Area of the City.

This Ordinance has been preliminarily assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the environmental regulations of the City. The Planning Commission will consider whether to recommend that the adoption and implementation of the Ordinance be found exempt from CEQA pursuant to Section 15061(b)(3) as there is no possibility that adoption and implementation of the Ordinance may have a significant effect on the environment because the Ordinance does not authorize construction and it would impose greater restrictions on certain development in order to protect the public health, safety and general welfare. Additionally the Planning Commission will consider if adoption and implementation of the Ordinance is eligible for a Class 8 categorical exemption pursuant to Section 15308 of Title 14 of the California Code of Regulations for actions taken to assure the maintenance and protection of the environment.

Any interested person may attend the meeting and be heard or present written comments to the Commission. Any comments submitted will be considered as part of the public record.

According to Government Code Section 65009, if you challenge the Commission’s action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the City, either at or prior to the public hearing.

tions to the community.

The proposal, brought forth by former Planning Commissioner Ron Rosen and former Mayor Vicki Reynolds, suggests that the naming of the north-south alley that runs between the 400 blocks of North Roxbury and North Bedford Drives (City National Bank), which is approximately 580 feet in length.

In their initial request, Rosen and Reynolds wrote a submission highlighting many of Goldsmith's contributions. Amongst others, such achievements included building 32 buildings in the City, including the Academy of Motion Pictures Arts and Sciences, serving as the CEO and Chairman of the Board of City National Corporation, Chairman of the Wallis, and serving on the Beverly Hills Economic Development Committee and the Greystone Blue Ribbon Task Force.

"Bram Goldsmith has provided a lifetime of leadership, support, and dedication for the betterment of the City of Beverly Hills for over 60 years," read the submission.

While the City's policy is to not officially rename public streets or other rights of way in recognition of individual people or businesses, it has previously engaged in the unofficial renaming of several rights of way within the City. Some celebratory naming include Fred Hayman Place (an alley) and Herzl Way (a street).

But at public comment, several people argued that the Council should not "rubberstamp" the proposal without sending it to various other commissions first.

While the Council did ultimately support the proposal, they also agreed that in the future, they'd like to establish criteria for similar proposals so that the public could provide input.

The renaming will be celebratory and honorary in nature, and will not cause the subject alley to be officially or permanently renamed.

The Bram Goldsmith alley will involve the placement of signage within the alley, a monument on private property, and hard-scape enhancements to specific portions of the alley adjacent to Brighton Way.

Because all costs incurred by the City for elements like street sign production will be reimbursed, the proposal does not pose any fiscal impact.

### Planning Commission Formally Approves 9200 Wilshire

At their meeting last Thursday, the Planning Commission formally approved a mixed-use development at 9200 Wilshire Boulevard.

The decision follows a special meeting on October 2 where the Planning Commission instructed staff to prepare a resolution for approval that would include several stipulations like modulation, privacy, noise, and traffic. They also requested that applicant New Pacific Realty reduce the number of residential units.

The final project was approved after the commission directed the applicants to include an increase of 600 square feet of retail and 40 more subterranean parking spaces.

"I think the applicant has tried hard to meet our request, and has done so," said Vice Chair Andy Licht.

At the October 2 meeting, Commissioner Craig Corman said that the touchstone is whether the proposed project will "advance the objectives" of the mixed-use Overlay Zone.

He recited several objectives of the Overlay Zone, including Objective B which states that the mixed-use development must be "compatible with the scale and massing of the surrounding neighborhood through appropriate height modulation upper story setbacks."

Corman went on to point out that New Pacific's proposal to bring the proposed project further forward with rooftop decks

would have made the project "look much larger than everything else in the street."

"I think we're all trying to find an acceptable version of a project that is fundamentally flawed," said Corman.

At the latest meeting, Corman maintained his opposition, but Commissioner Joe Shooshani also expressed concerns regarding parking space after originally voting for the resolution last week.

Ultimately, the project was formally approved 3-2, with Corman and Shooshani dissenting.

### Planning Commission to Hold Special Meeting

The Planning Commission will hold a special meeting on October 26 to consider an ordinance to amend development standards generally pertaining to basements and to grading and retaining walls in the City's Hillside area.

The proposed ordinance includes measures included but not limited to an amendment of the definition of "floor area", the addition of a definition of "light court," "finished grade" and "natural grade," and an amendment of the language governing the maximum height of walls, fences and hedges within the Hillside Area of the City.

Anyone interested in the proposal is invited to attend the meeting to be heard or present written comments to the commission.

The meeting will begin at 7:00 p.m. in the City Council Chamber.

### BHHS football team routed by El Segundo in delayed home opener

Ilai Dardashti ran for 118 yards on 27 carries, including a one-yard touchdown with nine minutes, 47 seconds to play for Beverly Hills (0-7, 0-2 in Ocean League play).

"I'm proud of the kids for what they're giving because they're giving everything they've got," Geanakos said after his team's 17th loss in his 17 games as coach over two seasons.

The Normans trailed 35-0 at the end of the first quarter as Danny McEntee caught two of Matthew Romero's three touchdown passes and returned a punt 65 yards for another score and Jorge Montani intercepted a pass by Thomas Recupero on the Normans first possession and returned it 25 yards for a touchdown.

Joey Gorte and James Fraelich ran 12 and 42 yards for touchdowns in the second quarter for El Segundo (6-1, 1-1). Eagles

running back Alex Heflin ran four yards for the game's final touchdown with 5:15 to play.

Dardashti and fellow running back Nick Sullivan drew praise from Geanakos for their play.

Beverly Hills will play its homecoming game Friday at Nickoll Field, facing Santa Monica (2-5, 1-1). The opening kickoff is set for 7 p.m.

The teams have one common opponent, Hawthorne, which defeated the Normans, 50-18, Oct 6, and lost to the Vikings, 42-14, last Friday.

Beverly Hills most recent victory came against Santa Monica on Oct. 30, 2015.

Geanakos said his team has "some surprises" in store for the Vikings in plays they decided not to use against El Segundo after the score became too one-sided.

## TURN ME LOOSE PREMIERES AT THE WALLIS

Actor Joe Morton discusses portraying controversial activist and comedian Dick Gregory

**How would you describe Dick Gregory to a younger person today unfamiliar with his career?**

First, I would say that he [was] an enormously unique individual. He's a guy who not just wore lots of different hats; he lived lots of different lives. He started off as a poor man in St. Louis who decided that he was going to be a comedian. He suddenly found himself in the position where he was doing his acts at

the Playboy Club which, in that time, was enormously unusual. The first time he [did] it, he [performed for] mostly a southern audience. We're talking about the 1960's now, so civil rights is very much what's going on in the world. And [he was] not only doing well there, but then ends up

being invited onto the Jack Paar Show, which, for younger folks who don't know—that's the original Tonight Show. [He] turns down going on the Tonight Show because a friend of his, Billy Eckstine, pointed out that when black performers went on the show, they were not allowed to sit on the couch and talk with Jack Paar afterwards. They would just be told to leave, so he turned it down and made that a deal-breaker. That bent

to his will, and Jack Paar invited him on the show and he got to sit on the couch. He broke the color line in that way on television, and then went on to make millions of dollars as a comedian, [performing] all around the world. He met [Civil Rights Leader] Medgar Evers, and it was Medgar and it was he was doing in terms of voter registration in Mississippi that really made Dick think, "You know what? This is making people laugh about racism.

Understanding the absurdity of racism is one thing, but actually becoming someone who is actively involved is something quite different." Not only did he get involved in the Civil Rights movement; there was a point where he actually gave up doing comedy. He went to college campuses to give speeches, to give lectures, to give talks about what was going

on in the world. And then he would protest by way of fasting. He would protest the war in Vietnam and wrote something called the Bahamian Diet as a result of what he learned about how to safely fast. And then, towards the end of his life you could see him all over YouTube still talking about the world and still talking about what's necessary in terms of, as he might say, "occupying one's life."

**What made Gregory so controversial at the time?**

I think the fact that he was a public figure who was famous [for] being comedian but now talking about, in very clear terms, racism—either on television or in large gatherings. He was the guy you would see standing next to Martin Luther King in a march or he would be the guy in front of the march. He would be the guy who was going to jail and speaking out against racism.

So I think that's why—because he was famous, he garnered a great deal of attention because he was always being thrown in jail.

**Gregory later became a social activist and opponent of the Vietnam War. How did this affect his career?**

Ultimately what happened was the Vietnam War finally ended, with all kinds of protests. The Civil Rights Movement was, for all intents and purposes, successful. The way the world seems to work around those kinds of things is that everybody thinks, "Oh, it's done! We're finished," and they go off. People were not paying as much attention to what [Gregory] had to say as they had in the past, until recently. I think maybe because of the play and maybe because of some other things now, but his name was sort of on the floor once again because we were out there talking about him.

**What part of playing Dick Gregory appealed to you?**

I think the politics, firstly and mostly. He's saying things that I wish I could have penned myself, so it made it really easy to play a character whose point of view was very similar to my own. The biggest nut for me to crack in this play was to have the opportunity to speak out loud those kinds of politics, to be in a position to let people know that racism is not over, to be in a position to let people know that we live in a capitalist society that continually tries to take advantage of the middle class and the poor. All of the opportunities were opened to me in

this play.

**"Turn Me Loose" is staged not in the larger Bram Goldsmith theater at the Wallis, but rather in the smaller, more intimate Lovelace theater, which is more like a nightclub. How does that contribute to the performance?**

Well, a lot of it is in a club. The very first time I come out onstage, I'm supposedly in a nightclub. That kind of intimacy and the fact that I spend most of the play talking to the audience and interacting with the audience, really makes it a very intimate setting. So it's perfect for our purposes.

**Dick Gregory passed away a few months ago. Did he see or know of the show before he died?**

He came to the opening night in New York when we were off-Broadway. He actually came twice. He

and his wife, Lil, came opening night, and then the following night, once again.

**What aspect of Dick Gregory's life or career is most relevant to viewers in 2017?**

I think a great deal of what's going on today, especially in this country. And that's kind of the sadness, if you will, of the play is that I can speak a line about racism or I can speak a line about capitalism from 40 or 45 years ago that's still relevant today. One of the things he says is that you have to keep people poor and ignorant to fuel bigotry, and that's exactly what's going on today. He talks about the fact that, "You all think that democracy is the supreme law in this country. Well, capitalism is the supreme law in this country and we have a hell of a job to get those capitalists behind the constitution." I think that's what makes the play vibrant and alive, because he's talking about things that are still going on today, even though he was saying those things 45 years ago.
