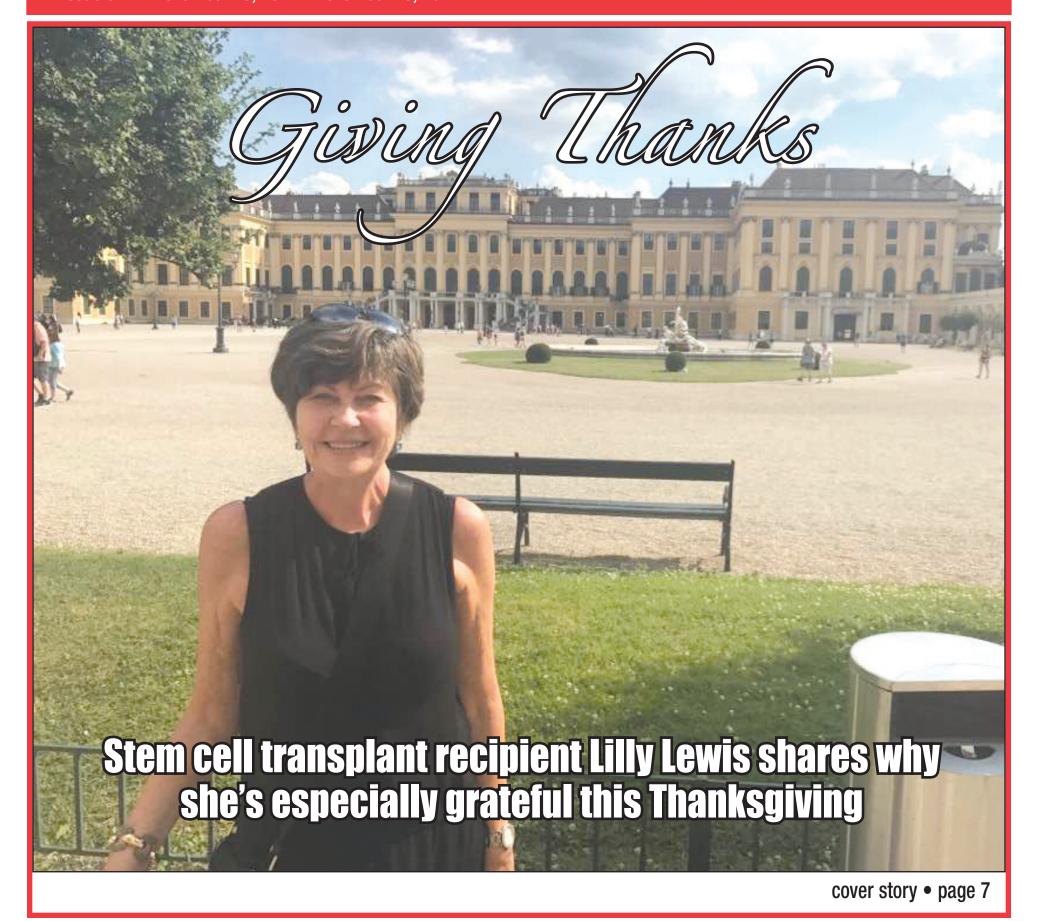

"Holiday Lighting Budget to Exceed \$2 Million" [Issue #941]

A particular letter to the editor appearing last week referenced an abundance of 'holiday' decorations and the request by a rabbi for \$15,000 to have another more visible menorah in the City. The letter correcting the approximate percentage of Jews in Beverly Hills (previously noted by the rabbi) brings thoughts of the selection of Jews at the time of the Holocaust.

The \$2M approved by the City Council for Xmas decorations is our money. Beverly Hills stopped lighting Hanukkiahs for years until I wrote to the City Council, and so perhaps 5 years ago, the festivity was reinstated. The Hanukkiah located at Rodeo 2 (provided by Chabad) was then lit for the first time. This does take place, but it is on private property, while the other holiday decorations are dangling all over public City

As regards festive holiday décor, I am sure we have all seen Santa Claus hung across streets, as well as Bethlehem stars

on Rodeo Drive. Obviously, there is nothing Jewish about them, but why is the Menorah along Santa Monica Boulevard gone?

Also, have you ever noticed the "Electric Fountain" on the corner where Wilshire crosses Santa Monica? That statue is of a priest kneeling and was recently refurbished to the tune of \$1.5M City money plus donations. FYI, the statue represents an American Indian from the Tongva or Gabrieleño tribes depending on which mission was close to them. They lived in this area and convertedto Christianity since 1770, thanks to the missionaries. So it is not an Indian pagan, but rather a Christian kneeling and praying. So I wonder how is it that the City was willing to invest so much money in it if this is a religious motif statue?

I thereby deduce that a mere \$15K in comparison should be given without question to the rabbi requesting to extend out thecelebration of the Jewish Holiday.... Hanukkah.. It is more than minimal in comparison to the \$2M spent for Xmas festivities.

Wanda to Sell 9900 Wilshire

The Wanda Group plans to sell five major assets to a single buyer for an alleged \$5 billion, according to South China Morning Post.

Among these projects is the \$1.2 billion One Beverly Hills, along with the \$1 billion One Nine Elms in London, the \$900 million Vista Tower in Chicago, the \$1 billion One Circular Quay in Sydney and the \$900 million Jewel Resort in Gold Coast.

The luxury hotel complex would-

have been developed at 9900 Wilshire Boulevard, after Wanda agreed to pay over \$60 million to build it.

Wanda also split from Phoenix-based developer Athens Group.

One Beverly Hills General Manager Rohan a'Beckett declined to comment when reached by the *Weekly*.

City Hires Consulting Firm to Analyze Rent Stabilization Ordinance

At their meeting on Tuesday, the City Council opted to hire HR&A Advisors to sort through the economic impacts on the rent stabilization policies.

HR&A was interviewed along with two other consulting firms: RAND Corporation and Economic Roundtable

on November 6 by the Ad Hoc committee, consisting of Mayor Lili Bosse and Councilmember Lester Friedman.

"They have a really good grasp on our community [and are] very aware of the issues that had been before us all of these months," said Bosse.

The committee found that HR&A best understood the scope of work at hand and plans to provide the City with an independent analysis of particular policy issues that deal with recent changes to the Rent Stabilization Ordinance (RSO).

More specifically, HR&A representative Paul Silvern said that the consultant group will hone in on questions about relocation fees and whether buildings with two units or less should be exempt. He also noted that several jurisdictions have faced similar challenges which has yielded "a good body of research to draw from."

The proposed cost for consultant services of research and analysis is \$87,750, plus a contingency of \$17,550 from the General Fund. HR&A estimates that their work will be completed in about 18-22 weeks.

At public comment several neighbors expressed support for the staff recommendation to hire HR&A Advisors, including Rent Stabilization Tenant Committee Representative Alma Ordaz.

"You could not hope to make a better investment than investing in us, the residents," said Ordaz, noting that HR&A would lead to a more comprehensive RSO and thus, benefit "vulnerable groups" like children and seniors.

During deliberation Councilmember Robert Wunderlich said that while he supported the hiring of HR&A, he felt the Council should engage in a discussion about the overall objective of the RSO. Friedman and Vice Mayor Julian Gold echoed these sentiments, with Friedman saying that the ambiguity of the ordinance has "troubled" him from the beginning.

"I think that is something we as a

Council could have a meeting exclusively discussing those issues so we could get a clearer picture as to what we want to see from the RSO," said Friedman.

But Councilmember John Mirisch contended that the end goal was actually "fairly clear."

"It's giving tenants and landlords predictability and stability," said Mirisch, adding that he was "heartened" by the fact that both parties have approved HR&A.

The RSO will likely be back on the December 5 City Council meeting agenda

Could the Citizen's Oversight Committee Get a Subcommittee?

The topic of attendance shaped a portion of Thursday's BHUSD Citizen's Oversight Committee (COC) as the group discussed ways to increase member turnout and the potential of altering the frequency of future meetings.

The discussion began when COC Chair Bradley Gibbons asked toward the end of the meeting how the group can achieve better attendance. It should be noted that there were only about 6 members in attendance, out of a team of 15.

Several members expressed frustration that a larger percentage of the time the COC hears about projects or issues facing the Board of Education after they have already made a decision.

"There's this feeling of 'if I'm a participant I want to feel it's worth my time'

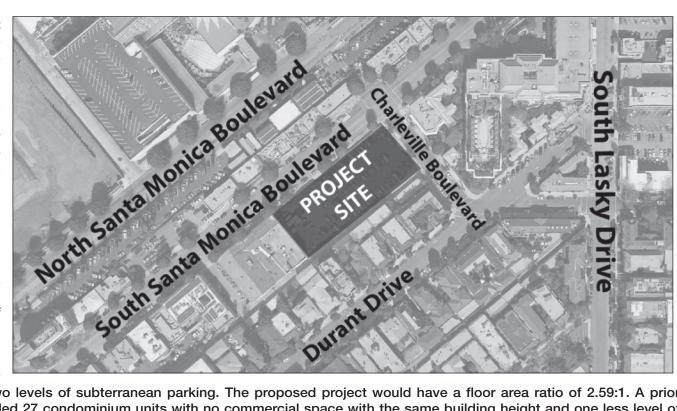

The Planning Commission of the City of Beverly Hills, at a SPECIAL meeting on Tuesday, November 28, 2017, will hold a public hearing beginning at 7:00 PM, or as soon thereafter as the matter may be heard, to consider a request for a General Plan Amendment, Zone Text Amendment, Planned Development Permit, and Vesting Tentative Tract Map for the property located at 9908 South Santa Monica Boulevard as follows:

General Plan and Zone **Text** Amendment. The property at 9908 South Santa Monica Boulevard is currently zoned C-3A. The Proposed Project seeks to amend the General Plan and General Plan Land Use Map to create a Residential Overlay Zone and apply it to the subject property to allow residential uses in the zone. A Zone Text Amendment is also requested to amend the Municipal Code to establish the Residential Overlay Zone and associated development standards and other provisions.

Planned Development. The proposed Residential Overlay Zone includes language requiring Planned Development to allow construction of the proposed mixed-use project, which consists of 27 residential condominium units and 3,541 square feet of ground floor commercial space in a 5-story



building with a height of 66'-0" and two levels of subterranean parking. The proposed project would have a floor area ratio of 2.59:1. A prior iteration of the proposed project included 27 condominium units with no commercial space with the same building height and one less level of parking with FAR of 2.5:1.

Vesting Tentative Tract Map. The proposed project includes a request for a Vesting Tentative Tract Map to allow the subdivision of 27 residential condominium units and 2 commercial condominium units for individual sale.

A Development Agreement is also being proposed by the applicant in conjunction with the proposed project, and the Planning Commission may discuss and provide recommendations on the terms to be included in the proposed Development Agreement.

This project has been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the environmental regulations of the City. The City of Beverly Hills has prepared a Final Environmental Impact Report (Final EIR) to analyze potential environmental impacts associated with development of the project. The Planning Commission previously held a public hearing to review the Draft EIR during the Draft EIR circulation period, which studied a prior iteration of the proposed project including the same number of residential condominiums and the same building height, however with no commercial space and one less level of parking with an FAR of 2.5:1. Specifically, the Final EIR analyzes the following potential environmental effects of both iterations of the project:

- Aesthetics
- Land Use and Planning
- Hazards and Hazardous Materials

- Air Quality
- Mandatory Findings of Significance Noise Greenhouse Gas • Traffic

The Planning Commission will consider the Final EIR, and may adopt a resolution recommending its certification to the City Council.

Any interested person may attend the meeting and be heard or present written comments to the Commission.

but unfortunately everything is after the fact," said COC member Jason Rund.

Gibbons suggested that the COC only hold meetings quarterly come the new year, noting that many other COC groups around the country have a similar structure.

Another option, proposed by BHUSD Construction Manager Don Blake, is to assemble a subcommittee of the COC called the construction oversight committee. Blake has had experience with this subcommittee during past school construction projects and calls the structure valuable.

"I've found great success in bringing in people from the community who have that acumen," said Blake.

The one challenge with a subcommittee, though, would be to ensure that it does not overlap too much with the content of the COC meetings.

Regardless, Board of Education member Howard Goldstein called the work of the COC important. "Discussions are had internally with comments that are made from the COC," said Goldstein. "The issues you bring up proactively are not forgotten. We rely on this citizen group to keep [the Board] honest."

The proposal of a smaller construction oversight committee will appear before the Board at a future date.

BHHS girls' basketball team opens season with victory

Norman boys' basketball team to play season opener Monday

Chantal Moawad scored 15 points as the Beverly High girls' basketball team opened its season with a 60-45 victory over University Tuesday in a first-round game of the Tip-Off Classic at Culver City High School.

The Normans trailed 15-10 at the end of the first quarter, then outscored the Wildcats 18-7 in the second quarter to take a 28-22 halftime lead.

Sophomore guard Arbri Gillis scored seven of her 12 points in the second quarter and freshman guard Michelle Duchemin five of her 11. Gillis and Duchemin both made 3-point baskets in the second quarter.

Moawad, a sophomore forward, scored six points in the third quarter as Beverly Hills outscored University, 17-13, increasing its lead to 45-35.

Moawad and Duchemin both scored four points in the final quarter as the Normans outscored the Wildcats 15-10.

"I thought we came out a little tight," Beverly Hills coach John Braddell said. "I through we struggled a little bit in the beginning but then we pushed the ball in the second quarter which really helped us

"(We) put the pressure on in the third and fourth (quarters). I thought we played pretty well in the second half."

Braddell said his goals for his team in the tournament are to improve and play

"We're just trying to build the team, trying to be aggressive and try to run and try to learn how each other plays and

defensively take away what the other team does best.'

Dominique Petrie added five points, Megan Saghian four, Krystal Brown and Sherin Ebrahimi three each and Julianne Araullo and Isabel Rund two each for the Normans.

Brown made a 3-point basket in the third quarter and Ebrahimi one in the fourth.

Beverly Hills was scheduled to play Oaks Christian, which reached the Southern Section Division 1AA semifinals last season, in a championship quarterfinal Wednesday that began after the Beverly Hills Weekly's deadline.

A victory by the Normans would advance them to a championship semifinal against the Culver City-Thousand Oaks winner at 7:30 p.m. Friday while a loss would relegate them to a fifth-place semifinal against the Culver City-Thousand Oaks loser at 3 p.m. Friday. Either game would be played at Culver City High.

The tournament will conclude Saturday. Beverly Hills is scheduled to begin pool play in the Brentwood Winter Invitational Monday at 3:30 p.m. at Beverly High against Collins Family. It is also scheduled to play pool play games Tuesday at 3 p.m. at Beverly High against Milken and Wednesday against Marymount at Marymount at 7 p.m.

The Normans return all five starters and lost only one player to graduation from last season's team that won the Southern Section Division 4A championship.

Stem cell transplant recipient Lilly Lewis shares why she's especially grateful this Thanksgiving

For Thanksgiving this year, Beverly Hills resident and Myelodysplastic Syndrome (MDS) survivor Lilly Lewis plans to spend time with her familysomething she wasn't sure she'd be able to do seven years ago.

In 2011, life was not as simple for Lewis. Even though she had no symptoms and felt perfectly fine, a regular checkup to the doctor's yielded the unfortunate news that Lewis' white blood count was very low. She was sent to a hematologist (also known as a blood specialist) to conduct further testing.

Lewis was then diagnosed with MDS, a blood disease that occurs when something disrupts the production of blood cells. The body produces imma-

years, Lewis felt fine. Her MDS didn't progress until about 2013. when the "bad"

blood cell blasts started multiplying. The more blasts one possesses, the closer one is to acute leukemia.

"That's basically not really treatable," said Lewis. "I was on that path."

Doctors began treating Lewis with immunosuppressants-to inhibit or prevent activity of the immune system-in case her condition turned out to be an immune disease. The treatment didn't work, however, and her blasts continued to multiply.

That's when it was determined that Lewis would need a bone marrow transplant, which she said was a very peculiar feeling since she still felt pretty healthy.

"When you don't feel sick and people are telling you you are sick, it's kind of strange," said Lewis.

But at that point, the number of blasts was still too high to perform an effective stem cell transplant, so Lewis underwent her first chemotherapy sessions in May, 2015. Fortunately she was able to continue work during this time and didn't lose any hair, as the chemo was low-dose.

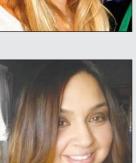

Some of this faith, she says, was due to the support she received from her family and friends. During the recovery process, Lewis rented an apartment near City of Hope in order to simplify her biweekly visits to the hospital.

Nearly every night, her husband, David, drove an hour from Beverly Hills to Duarte to administer her medicine, a task he says he was more than willing to do.

"That's not a big deal compared to when someone is putting poison into your blood," said David Lewis. "It puts into perspective a bit."

This Thanksgiving, Lilly and David Lewis will be spending time with the rest of their family in New York. She says she's excited to help out her eldest daughter, Stephanie, who is seven months pregnant with Lewis' first grandchild.

And even though the recovery process has rendered her quite weak, Lewis makes sure to carve out time for exercise as much as possible in order to fully regain her strength.

"Otherwise my daughter won't let me hold the baby," said Lewis. "It's good motivation.'
