

AAGLA Opposes Measure RH

The Apartment Association of Greater Los Angelels (AAGLA) recently sent out an e-Blast encouraging its members to vote against Measure BH, a proposed school bond that will appear on the June

5 ballot.

"Sadly, Beverly Hills' strict rent control makes supporting a bond measure unaffordable for us," reads the email.

The email also reproduced a Beverly Hills Weekly editorial from Issue #971 in opposition to Measure BH.

An advocate for affordable quality rental housing, AAGLA aims to serve the interests of multifamily owners, managers, developers and suppliers in the housing industry, according to their website.

The Planning Commission of the City of Beverly Hills, at its REGULAR meeting on **Thursday**, **June 14, 2018**, will hold a study session beginning at 1:30 PM, or as soon thereafter as the matter may be heard to provide an opportunity for the public and the Planning Commission to discuss the potential to establish a new Hillside R-1 Permit for certain single family residential projects in the Hillside Area of the City. At the April 24, 2018 City Council study session public comment included a proposal to require an R-1 Permit for any new homes or projects that would increase the existing floor area by more than 50% on a site in the Hillside Area of the City. The suggested purpose was to provide the Planning Commission with the opportunity to review such projects and impose conditions as necessary to address identified potential impacts. The City Council indicated a willingness to study this proposal and directed that the item to be agendized for review by the Planning Commission.

At this study session the Planning Commission is expected to discuss the merits of the proposal and potentially direct staff to undertake further work on the subject. This could include Planning Commission discussion of what projects would be subject to any new review established, if any projects would be exempt from review, and what the findings could be for the new R-1 Permit, should it be established.


Because this is a study session, no decisions will be made at this meeting. Any decisions by the Planning Commission on this topic will be made at a future noticed public hearing. A study session is an opportunity for the public to provide comments and the Planning Commission to consider this change and provide staff with direction.





Mitchell Dawson on Thursday. The company will now be able to provide food and beverage services on the rooftops and allow guests to utilize these rooftop facilities from 8:00 a.m. to 10:00 p.m. Monday through Friday, and 9:00 a.m. to 10:00 p.m. Saturday to Sunday.

The project will function as an ancillary component of a new co-working office use located within the first two levels of office space in the 9800 Wilshire Boulevard building, and the first and fourth office levels of the 121 Spalding Drive building.

The office space on the third floor of the architecturally distinct 9800 Wilshire Boulevard building will continue to be occupied by the Gores Group.

The vote was 4-0 with Commissioner Andy Licht absent.

The Weekly looks back 50 years later



LINDA BRISKMAN FORMER MAYOR

"I was actually totally self absorbed at that time planning a wedding on June 8th and the news sure put things into perspective for me. I was in disbelief that tragedy could have stuck not only our country but the Kennedy family once again!"



MICHAEL BROIDA

"I was working at the then drugstore at the Beverly Hilton Hotel where Senator Eugene McCarthy was having his campaign event waiting for the California primary results. It got very quiet and people just started leaving in disbelief. All were saddened by the event

and the election was forgotten for a few hours to get a grasp of the situation."



MITCHELL DAWSON FORMER PLANNING COMMISSIONER

"I was a major supporter at UCLA. As soon as my hero Robert Kennedy pronounced excitedly, 'On to Chicago,' I turned off my TV and went to sleep. Awakened early the next morning...broken-hearted and missed all my final exams."



HARVEY ENGLANDER ENGLANDER, KNABE & ASSOCIATES

"I was at the victory party in Ambassador Hotel when Senator Kennedy was shot. I had been a volunteer organizer and then a driver in the campaign during my freshman year in college. There was pan-

ic and pandemonium. Everyone was crying. We had no idea about his condition and rumors were flying to the extremes – he was wounded but okay or he was dead. It ranks as one of the worst evenings of my life."



WENDY GOLDBERG PHILANTHROPIST

"I had gotten home from dinner and turned on the news to hear the results of the California primary and was horrified to find out that another Kennedy had been shot. I had been to the Ambassador Hotel several times on different occasions for happy cele-

brations but it would never be the same after this tragedy. It was very sad day for the Kennedy family and the country."



GLORIA MOLINA FORMER LA COUNTY SUPERVISOR

"I was a young woman working on the campaign as a volunteer and like most was devastated when we lost such a hopeful leader for all of us."

"I found out that RFK was assassinated on the morning of June 6th. I was resting at home recovering from an appendectomy. My mom came in that morning crying saying that Robert Kennedy
