Board of Education President Lisa Korbatov and Superintendent Michael Bregy met with controversial activist Erin Brockovich on June 15.

According to Bregy-who went into detail about participants upon questioning




from Board member Isabel Hacker the meeting i n v o l v e d touring Metro's staging site in back of the high school. B r e g y

Erin Brockovich said that the walkthrough followed re-

ports from custodians that Metro "busted" through the school's property line wall during demolition.

"This is a huge concern. We have a responsibility that this be stopped. This is not conducive to any learning environment and I would hate to think that just because we're Beverly Hills, we're being overlooked," said Bregy. "It's important

for us to share this information as it becomes available and we will continue to monitor the progress for the Metro laydown area."

Other participants included BHUSD Attorney Terry Tao, likely Board candidate Marvin Winans, former Board member Lewis Hall, student Board members Jonathan Artal and Sean Toobi, and Board member Howard Goldstein.

Hacker said that she was not informed of the meeting and therefore not in attendance. Other Board of Education candidates were not invited.

Bregy referred to Brockovich as a "special guest," adding that she was there because of an interest in "learning more." She allegedly asked questions about the district's legal standing in regard to the fight against Metro.

In 2003, Brockovich, along with the late Ed Masry, unsuccessfully sued the BHUSD alleging that several Beverly High graduates had contracted cancer from exposure to the campus's oil well.

The BHUSD and the City of the Beverly Hills signed a joint defense agreement and the case was later dismissed.

The saga led to significant media coverage, including a book by Joy Horowitz entitled "Parts Per Million."

City Attorney Larry Wiener, who represented the City in the Brockovich matter, was on vacation and could not be reached for comment.

Mirisch Wants Tighter Regulation of Signature Gatherers

The City Council discussed potential new regulations aimed at enhancing transparency and curbing abuse of the local referendum and initiative process at Tuesday's Study Session.

During the discussion Vice Mayor John Mirisch suggested the idea of a sting operation in order to mitigate abuse of the referendum.

"The City is permitted to disseminate information to the public about the referendum's consequences and the City may enforce state laws that make it a misdemeanor for petition circulators to provide misleading information to those whose signatures they seek," reads the staff report.

The sting operation, offered Mirisch, would allow a police officer with a camera to engage with petition circulators. The officer would ask questions in a misleading way and use that information to prosecute the violator.

"I think we should really look at that and work with the police to place an anti-fraud sting unit," said Mirisch. "Signature gatherers then will know, 'Hey, [I] may be filmed. [I'm] in a public place and have no expectation of privacy.' The person you're lying to may actually be a police officer and if you lie to that police officer, we are going to prosecute you to the fullest extent of the law."

Assistant City Attorney Dave Snow said that this "might be possible."

The item follows the Council's request that staff research various approaches to designing new regulations to minimize potential abuse after opponents of the recently-passed Basement Ordinance began to circulate a referendum petition calling for its appeal.

The referendum petition was deemed insufficient because it lacked the required number of valid signatures, but neighbors have expressed frustration about the "deceitful" methods in which petitioners gathered signatures.

"Until we close this loophole, anyone willing to get signatures by deception will be able to slip through and maybe get their projects passed," said Lago Vista resident Debbie Weiss.

The City could enact a suspension ordi-

nance: if a referendum petition is properly submitted the ordinance challenged by the referendum is suspended while the Council considers whether to repeal the ordinance or submit it to voters.

Staff's suggestion is that if the Council does not repeal the ordinance, it must submit the ordinance to the voters at an election, and the ordinance remains suspended until a majority of voters approve it.

If the Council repeals the ordinance, or if voters do not vote in favor of the ordinance, it cannot be reenacted by the Council for a year.

Could Hillside Projects Receive a New R-1 Permit?

The Planning Commission discussed last Thursday a request to add an R-1 Permit for certain Hillside Area projects. Commissioner Peter Ostroff recused himself because he lives in the Hillside.

Requested by Loma Vista resident Debbie Weiss, the permit would apply to any new homes or projects that would increase the existing floor area by more than 50 percent on a site in the Hillside Area of the City.

According to the staff report, the suggested purpose was to "provide the Planning Commission with the opportunity to review such projects and impose conditions as necessary to address identified potential impacts."

At a meeting earlier this year the City Council indicated a willingness to study the proposal and directed that the Planning Commission agendize the item.

In a letter, Weiss identified numerous concerns about the effects of new development projects located in the Hillside.

Core concerns were excessive land form alteration and grading that could result in projects with greater bulk and mass, and scale of the projects that could result in safety issues, both temporary during construction and permanent.

Weiss then went on to present seven issues with Hillside development projects, including but not limited to excavation/ grading calculation accuracy, construction hauling and "inadequate" construction management plans.

During the meeting, commissioners agreed to direct staff to further research the request and bring it back to the next meeting.

La Cienega Park Project **Underway with Public** Outreach

After several months of inaction, the City Council is finally moving forward with the La Cienega Park renovation project.

During their June 19 Study Session, the Council discussed how to best develop a public engagement plan to gather public feedback on the needs at the site.

At staff's recommendation, the Council will engage the services of a firm that specializes in public outreach so that the data collected is neutral and "not influenced by any specific architectural 'vision' for the site," according to the staff report.

This will include partnering with the Consensus and Collaboration Program (CCP) for California State University, Sacramento on behalf of its College of Continuing Education.

CCP will conduct the public engagement process through community meetings, stakeholder interviews and surveys at both the La Cienega Park and Community Center as well as other City locations on behalf of the Community Services Department.

The process is intended to create "an atmosphere of open dialogue that respects and honors the diverse opinions of the community.'

At the meetings, CCP will provide facilitation services and deliver information and background about the planning, park design and associated program elements and requirements throughout the process.

Incoming President Jim Jahant on his plans for the philanthropic club

Tell us about becoming the incoming president at Rotary. How do you feel?

I am truly, truly looking forward to it. It's an outstanding club. We have a little over 150 members and it's just an amazing club. I'm looking forward to working with the organization. Rotary is an organization of business and professional people and we help people worldwide, provide humanitarian service, and encourage high ethical standards. We in Beverly Hills focus a lot on the Beverly Hills community. We gave out close to 50 donations from Rotary to specific organizations in Beverly Hills like the Maple Counseling Center. We try to keep a lot of the focus in Beverly Hills, and then we do humanitarian trips around the world too.

You've also had long career as a retailer at Brooks Brothers for many years, which you talked about in Issue #765. Tell us about that.

It was an amazing organization to work for. I wanted to retire and I gave my notice to Brooks Brothers, and they're a wonderful company but it took them almost two years to accept my resignation. I was also involved in a lot of [other organizations as well]. At one point I was president of the Chamber of Commerce, for three years I was president of the Rodeo Drive Committee, and I'm on a lot of different boards throughout Beverly Hills.

It's important to me because being retired and being from retail, I love to be around people. I love the fact that I have an opportunity to help many people. They're lasting relationships because when you help someone, maybe even in another country, it lasts even after I leave and whatever we did there. It continues on, whether it's bringing wheel chairs or building schools or digging water wells.

It's leaving a legacy in a way. That's a very good way to put it.

What projects is Rotary is working on this year?

Members of the Rotary Club bring to our charity foundation different charities they would like Rotary to get involved in. We don't do anything political. We also want to make sure we're giving our money to the right type of charities. We focus on some of the local charities, like the Maple Center, or smaller charities where we know our money will actually do good. We don't necessarily want to go to some national charities where the money could get lost in all the other millions that they collect; we want to make sure that Rotary makes a statement.

We are currently working on several International programs. [We're] helping to cure Malaria in New Guinea by suppling mosquito nests that are treated with insecticides and need to replaced every five years. [We're] building water wells in Northern Uganda and Kenya, where villagers must walk several miles, one way, for their family water. We are in partnership with the Rotary Club in Panama on an e-learning project where technology will be used to improve the learning and teaching in primary schools in rural communities in Panama. Support Operation Smile in Paraguay. Rotary Club endowing a clinic. Operating on children born with cleft lips.

Local Projects include [the] Youth Exchange Program – Our club will be sponsoring a student to travel to France for one year [and] High School Scholarships – [the] Club donates three \$1.000 scholarships to BHHS students.

Rotary allocated to 18 local organiza-

tions: Friends of Robinson's Gardens, The Maple Counseling Center, Beverly Hills Police Officer's Association, Jewish Big Brothers and Big Sisters, Beverly Hills Police Foundation, just to name a few.

In collaboration, Rotary, the City of Beverly Hills and Music Mends Minds is an organization that facilitates the organization of musical groups for seniors with forms of cognitive decline such as Alzheimer's, Parkinson's Dementia, stroke and other disabilities. Our group is called the "The Beverly Hills Treble

Makers" and it meets every Tuesday at Roxbury Park from 1:30 till 3:00. It is a sing-a-long experience for seniors with and without cognitive disability. Every person who comes becomes part of the band and is offered some type of musical instrument such as maracas or drumsticks. We get up to 40 participants from their early thirties up to 104.

What advice did outgoing President Myra Lurie give you?

Well, she is going to be hard to follow. She had an amazing year; she is exceptionally well liked. But the nice thing is that I know she's there and will have my back. She keeps saying, "Anything you need, I will be there for you." It is [a special community]; the whole club is that way. It's about how someone can help someone else. If somebody in the club has an illness or something happens within their family, the club offers to go in and help.

What would you like our readers to know about Rotary?

When you think about Rotary, you think about eradicating Polio. That's really what Rotary was known for. 30 years ago, there were a little over 350,000 people infected with Polio. Just four years ago, through rotaries around the world, it went down to 359 children. Then three years ago, it went down to 74. Two years ago, it was 37. Last year, it was 21. In 2018, we've only had one child fight Polio. So it's really worked. Polio won't really be completely eradicated until a certifying commission can make sure there hasn't been a polio infection for three years. Some of the things we're going to this year are digging water and making water wells for some of these villages where children are drinking out of sewer water, [much of which] is infected. So we're really traveling around the world building schools, digging water to do [what we can].

One of the nicest things I've heard is a story that Rotary took 30 wheelchairs over to a city in the back woods that had never had wheelchairs before. There was a young man who was carrying his father on his back and he was probably about 30 years old. He carried his father because his father could not walk, and when we put him in a wheelchair and the father pushed himself for the first time, his son cried, his father cried, the whole room cried. Those are the feelings that you get with Rotary.
