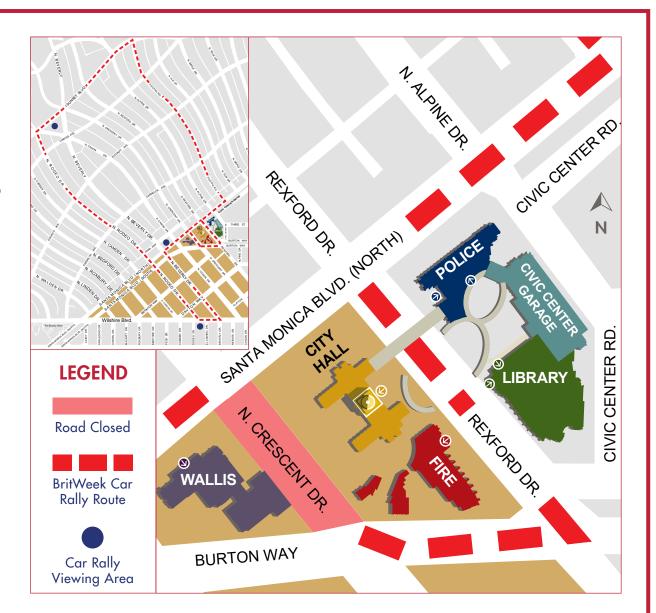

"Rent Stabilization Ordinance" [Issues 1019, 1020]

Reply to Renter Advocate, Mark Elliot Come on Mark Elliot! You are an able-bodied young man, and obviously in great shape as is evident from your enthusiasm for biking. So, why the burning need to subsidize your lifestyle on the back of the poor, innocent family that owns the apartment building you're living in? Is your building's owner obligated to help buy that new, expensive road bike or to help subsidize your next biking adventure? I understand that you work in the technology field, so why the need to use your landlord as your personal cash register?

I must hand it to you, though. You have certainly advanced your cause with the help of our City Council that have legally thrust your hands in the pocket of your landlord. But, doesn't your landlord have his or her own family to support? Why should he or she have to support you?

At your age, I just worked hard to support my family and through it all, we were able to save enough money to buy property. Yes, my wife and I were once renters like you, but we made every effort possible to eventually own property. It came with many hours of labor, time away from my family, and a great deal of sacrifice. You obviously chose a different route in life which is all well and good, but why is that your landlord's problem? I say "manup" Mark Elliot and stop your whining about your rent being too high – it probably isn't and I doubt your landlord has ever gouged you other than to increase your rent to keep up with the costs of maintaining the 80 year old or so building you are living in.

As a rental property owner, I share the concern about those in our City that have been long-term residents, or that may have transitioned to fixed incomes or others that suddenly find themselves in a job loss situation or other financial crisis. For those in our community so unfortunately situated, the City should utilize the \$2.5 million and growing rent stabilization budget to actually help those who need help, and not force the rental property owners in our City to provide subsidies to everyone, including wealthy renters like you, Mark. That is the fallacy of rent control and Julian's Folly, it rarely helps those that truly need it. I agree there are people in need, but I do not agree with the solution fashioned by our City Council.

I love how you have alleged, Mark, that our "Rent Stabilization Ordinance is full cost recovery" knowing full well that the fees we as property owners are now required to pay have increased 300% per unit, and that is probably only the beginning. At the same time my ability to increase my rents are being "squeezed" through new price controls while at the same time my property insurance is increasing 10%+ due to California's fires, more and more bonds are added to my property tax bills, and potential costs of compliance with the City's Rent Stabilization Ordinance might be astronomical for small property owners like me (such as "Just Cause Eviction," relocation benefits, etc. just to remove a renter that might be conducting criminal activity or disturbing other renters at my property).

Cities such as Pasadena and Glendale, recognizing the uniqueness inherent in their cities, did not pursue retreaded and failed housing policies adopted by cities such as Berkeley, San Francisco, West Hollywood, and Los Angeles. Look at these cities with their soaring rents, huge housing shortages and growing homeless populations – is that what we want for Beverly Hills?

Pasadena's and Glendale's solutions were far more creative. Even more creative, the City of Denver recently launched a voucher program to subsidize rent burdened tenants in partnership with private industry and non-profit organizations. Sadly, our elected officials are obviously not very creative. As a result, we in Beverly Hills, the city of the Golden Triangle, have followed the old rent control playbook led by our Santa Monica based consulting firm. To say I am extremely disappointed and annoyed with the members of our City Council over this excessive regulation and these draconian price controls would be an understatement. These millionaire robber barons on our City Council have stolen my property rights, increased my risk, and are robbing me and other property owners in our City of our investments. Wake up Beverly Hills voters! Let's vote these fools out of office pronto.

OBITUARIES Edith Newman 1923-2019

Edith Newman passed away peacefully Wednesday April 17, surrounded by her three children. Born in 1923 to Russian immigrant parents in Bayonne, New Jersey, she learned to be resourceful from a young age, eventually becoming the matriarch to a large extended family. At age 19, Edith moved her ailing brother to Tucson, Arizona and took a job in military intelligence at Davis Monthan Air Force base. It was there that she began a 70 year love affair with her husband Ben who had been assigned to the base after recovering from injuries suffered when his Liberator was shot down during his 42nd bombing mission over the Ploesti oil fields during World War II.

Always up for a challenge, Edith tried her hand at many careers, while raising three children Jason, Gary and Deena. She worked as an executive assistant for Dr. Theodore Von Karman, founder of the Jet Propulsion Laboratory, for whom she called Albert Einstein daily, modeled for the top department stores in Los Angeles in the 1950s, and wrote a weekly column for a local Westside newspaper. She was president of the PTAs at Beverly Vista, Beverly Hills High School and the PTA Council. Under her leadership, she expanded the PTA to include student representation forming the PTSA. She volunteered and was on the Board of the American Heart Association, President of the American Cancer Society and recipient of its state of California Volunteer of the Year, presented by Mrs. Betty Ford. She was chairman of the Beverly



Hills' chapter of the Mother's March on Polio, March of Dimes, and the first woman selected to serve on the Board of Trustees of the Beverly Hills YMCA.

But she finally found her true calling as a realtor in Beverly Hills. Getting her start in 1977, initially with Harleigh Sandler, and later with Coldwell Banker, she was later recognized as one of the top ten performers nationally for Coldwell Banker. She loved going to work and helped countless people find their homes in Beverly Hills and the surrounding area. She became a surrogate mother and grandmother to many of her clients. She finally retired at age 86, only because Ben had suffered a brain hemorrhage and she stayed home to care for him. She loved people, was a wonderful storyteller and her memory will be treasured by her family and many friends. In addition to her three children, all three of whom are members of the Beverly High Athletic Alumni Hall of Fame, Edith is survived by seven grandchildren and one sister.

You're currently an Executive Producer at Fishbowl Productions. What types of projects have you had experience with and what are you working on?

Fishbowl is a partner company of Vin Di Bona Productions which is primarily known for America's Funniest Home Videos which has been on ABC for the last 29 years. We also just had Videos After Dark with Bob Saget air its first episode on ABC. However, since I started at the company 3 years ago, my focus has been on expanding Fishbowl into a different marketplace. I have developed documentary projects primarily around talent in hip-hop, urban culture, global subcultures and art. I have a passion for music and telling stories and although the projects I have created might not be under the wheelhouse of what Fishbowl has been known for in the past, I have

been given the freedom to create content that I feel is right in the zeitgeist of our contemporary culture. How did growing up in Beverly Hills help shape your career as a producer?

It has played a major role. My whole family is in the television business. Growing up in Beverly Hills was a fascinating bubble. I was surrounded by movers and shakers and never really understood what that meant until I was an adult. I was around the entertainment industry my whole life, but I always thought I was going to be a fine artist. I have had a deep need to create and I always knew I wanted to work in music or art. It wasn't until I was given an opportunity to direct a rap music video that I really understood what life outside of Beverly Hills was. I was suddenly exposed to a world I had been sheltered

from my whole life, and I was captivated. It inspired me to develop a project about the underground rap scene in Los Angeles. Fishbowl completely supported the idea and we shot my first sizzle reel at the company and pitched major cable networks. If it wasn't for my understanding of the industry through my roots in Beverly Hills I would have never been able to apply the world I saw outside of it to create a series. I now live in Beverly Hills and I find that shows like Shahs of Sunset or Real Housewives of Beverly Hills are exactly the world I grew up in and it helps fuel the content I create.

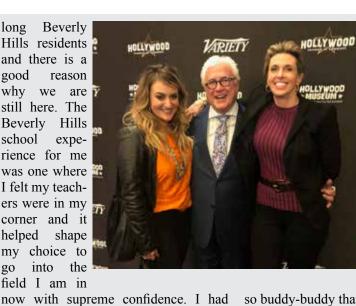
Does your experience as a Beverly Hills High graduate and lifelong resident have an effect on your work?

ORDINANCE NO. 19-0-2780

AN ORDINANCE OF THE CITY OF BEVER-LY HILLS AMENDING THE BEVERLY HILLS MUNICIPAL CODE REGARDING SPEC-TATORS AT ILLEGAL STREET RACING AND RECKLESS DRIVING EXHIBITIONS

THE CITY COUNCIL OF THE CITY OF BEV-ERLY HILLS DOES HEREBY ORDAIN AS FOLLOWS:

Section 1. The City Council hereby adds Chapter 7 ("SPECTATORS AT SPEED CONTESTS OR RECKLESS DRIVING EXHIBITIONS") to Title 7 ("TRAFFIC, PARKING AND PUBLIC TRANSPORTATION") of the Beverly Hills Municipal Code to read as follows:

> Chapter 7. SPECTATORS AT SPEED CONTESTS OR RECK-LESS DRIVING EXHIBITIONS

7-7-1: PURPOSE.

5/2,9,16 2019

Pursuant to California Vehicle Code Section 23109, motor vehicle speed contests and exhibitions of speed (more commonly referred to as street racing or drag racing) conducted on public streets and highways are illegal. In addition. California Vehicle Code Section 23103 prohibits reckless driving, which is defined to mean driving a vehicle upon a highway or in an off street parking facility in willful or wanton disregard for the safety of persons or property. Reckless driving includes performing vehicle stunts (commonly referred to as sideshows), including but not limited to, driving in tight circles (referred to as doughnuts) and exiting a car one is driving and dancing around or on top of it (referred to as ghost riding). Such street racing and reckless driving threatens the health and safety of the public, interferes with pedestrian and vehicular traffic, creates a public nuisance. and interferes with the right of private business owners to enjoy the use of their property within the City. Spectators tend to gather, blocking the streets and sidewalks to traffic, forming a racetrack area, placing bets, and otherwise encouraging, aiding and abetting the racing process or reckless driving exhibitions (sideshows).

Illegal street racers and exhibitors of reckless driving can accelerate to high speeds and engage in reckless driving behavior without regard to property, oncoming traffic, pedestrians, or vehicles parked or moving nearby, and use their electronic devices, social media and the internet to communicate with each other and attract spectators. In most cases, illegal street races and reckless driving exhibitions attract hundreds of spectators. The mere presence of spectators at these events fuels the illegal street racing and reckless driving exhibitions and creates an environment in which these illegal activities can flourish.

This Chapter is adopted to prohibit spectators at illegal street races and reckless driving exhibitions. The Chapter targets a very clear, limited population and gives proper notice to citizens as to what activities are lawful and what activities are unlawful. In discouraging specta-tors, the act of organizing and participating in illegal street races will be discouraged.

7-7-2: DEFINITIONS.

For the purposes of this Chapter, the following definitions shall apply:

"Illegal motor vehicle speed contest" or "illegal exhibition of speed" means any speed contest or exhibition of speed referred to in California Vehicle Code Section 23109

"Preparations" for the illegal motor vehicle speed contest, illegal exhibition of speed, or reckless driving exhibition include, but are not limited to, situations in which:

1. A group of motor vehicles or individuals have arrived at a location for the purpose of participating in or being spectators at the event;

2. A group of individuals have lined one or both sides of a public street or highway for the purpose of participating in or being a spectator at the event:

3. A group of individuals have gathered on private property without the consent of the owner, operator, or agent thereof for the purpose of participating in or being a spectator at the event;

4. One or more individuals have impeded the free public use of a public street or highway by actions, words, or physical barriers for the pur-pose of conducting the event;

5. Two or more vehicles have lined up with motors running for an illegal motor vehicle speed contest or exhibition of speed;

6. One or more drivers is revving their engine or spinning their tires in preparation for the event:

7. An individual is stationed at or near one or more motor vehicles serving as a race starter.

"Reckless driving exhibition" means any exhibition of reckless driving referred to in California Vehicle Code Section 23103.

"Spectator" means any individual who is present at an illegal motor vehicle speed contest, exhibition of speed, or reckless driving exhibition, or at a location where preparations are being made for such activities, for the purpose of viewing, observing, watching, or witnessing the event as it progresses. Spectator includes any individual at the location of the event without regard to whether the individual arrived at the event by driving a vehicle, riding as a passenger in a vehicle, walking, or arriving by some other means.

7-7-3: SPECTATORS

A. It is unlawful for any individual to be knowingly present as a spectator, either on a public street or highway, or on private property, at an illegal motor vehicle speed contest, exhibition of speed or reckless driving exhibition.

B. It is unlawful for any individual to be knowingly present as a spectator, either on a public street or highway, or on private property, where preparations are being made for an illegal motor vehicle speed contest, exhibition of speed or reckless driving exhibition.

C. An individual is present at the illegal motor vehicle speed contest, exhibition of speed or reckless driving exhibition if that individual is within 100 feet of the location of the event, or within 100 feet of the location where preparations are being made for the event.

Section 2. Severability. If any section, subsection, subdivision, sentence, clause, phrase, or portion of this Ordinance or the application thereof to any person or place, is for any reason held to be invalid or unconstitutional by the final decision of any court of competent jurisdiction, the remainder of this Ordinance shall remain in full force and effect.

Section 3. Publication. The City Clerk shall cause this Ordinance to be published at least once in a newspaper of general circulation published and circulated in the City within fifteen (15) days after its passage in accordance with Section 36933 of the Government Code, shall certify to the adoption of this Ordinance and shall cause this Ordinance and the City Clerk's certification, together with proof of publication, to be entered in the Book of Ordinances of the Council of this City.

ORDINANCE NO. 19-0-2779

AN ORDINANCE OF THE CITY OF BEVERLY HILLS REGARDING SMALL WIRELESS FACILITIES AND AMEND-ING THE BEVERLY HILLS MUNICIPAL CODE REGARDING THE SAME

THE CITY COUNCIL OF THE CITY OF BEVERLY HILLS ORDAINS AS FOL-LOWS:

Section 1. Findings:

(i) On September 26, 2018, the Federal Communications Commission ("FCC") adopted its Declaratory Ruling and Third Report and Order ("Report and Order") relating to placement of small wireless facilities in public rights-ofway. The Report and Order went into effect on January 14, 2019.

The Report and Order purports to give providers of wireless services rights to uti-lize public rights of way and to attach so-called small wireless facilities" to public infrastructure including infrastructure of the City of Beverly Hills, subject to payment of "presumed reasonable", non-recurring and recurring fees. The ability of local agencies to regulate use of their rights-of-way is substantially limited under the Report and Order.

Notwithstanding the limitations im-(iii) posed on local regulation of small wireless facilities in public rights-of-way by the Report and Order, local agencies retain the ability to regulate the aesthetics of small wireless facilities, including location, compatibility with surrounding facilities, spacing, and overall size of the facility, provided the aesthetic requirements are: (i) "reasonable", i.e., "technically feasible and reasonably directed to avoiding or remedying the intangible public harm or unsightly or out-of-character deployments"; (ii) "objective", i.e., they "incorporate clearly-defined and ascertainable standards, applied in a principled manner"; are (iii) published in advance. Regulations that do not satisfy the foregoing requirements are likely to be subject to invalidation, as are any other regulations that "materially inhibit wireless service", (e.g., overly restrictive spac-ing requirements.)

(iv) Local agencies also retain the ability to regulate small wireless facilities in the public rights-of-way in order to more fully protect the public health and safety, ensure continued quality of telecommunications services, and safeguard the rights of consumers.

It is the intent of the City Council in adopting this Ordinance to supersede regu-lations of the City that conflict with the Report and Order, and to establish consistent regulafacilities in order to more fully protect the public health, safety, and welfare. The City Council declares that it adopts this Ordinance with the understanding that the City expressly reserves all rights to re-enact and/or establish new regulations consistent with State and federal law as it existed prior to adoption of the Report and Order in the event the Report and Order is invalidated, modified, or limited in any way.

Section 2. Section 6-2-403 of the Beverly Hills Municipal Code is hereby amended to read as follows:

"ANTENNAS FOR TELECOM-MUNICATIONS SERVICES:

Title 10, chapter 3, article 45 of this code sets forth the regulatory requirements that apply to telephone corporations and other utility service providers with regard to the siting and construction of various categories of antennas, including wireless telecommunications antenna facilities, that are commonly used in transmitting or receiving telecommunications services.

B. Notwithstanding any provisions in ti-tle 10, chapter 3, article 45 to the contrary, all small wireless facilities as defined by the FCC in 47 C.F.R. § 1.60002(I), as may be amended or superseded, shall comply with the "City Wide Policy Regarding Permitting Requirements And Development Standards For Small Wireless Facilities" adopted by city council resolution, and all small wireless facilities on private property must comply with that policy.

Section 3. Section 10-3-4508 of the Beverly Hills Municipal Code is hereby amended to read as follows:

"FACILITIES WITHIN PUB-LIC RIGHTS OF WAY:

All wireless antenna facilities proposed in the public rights of way in any land use zone must, unless exempt under paramount state or federal law, comply with all applicable provisions of title 8, chapter 7 of this code.

B. Notwithstanding any provisions in title 8, chapter 7 to the contrary, all small wireless facilities as defined by the FCC in 47 C.F.R. § 1.60002(I), as may be amended or superseded, are subject to requirements of the "City Wide Policy Regarding Permitting Requirements And Development Standards For Small Wireless Facilities" adopted by city council resolution, and all such small wireless facilities must comply with that policy.

<u>Section 4</u>. <u>CEQA</u>. The City of Beverly Hills has determined that the adoption of this Ordinance is exempt from review under the California Environmental Quality Act ("CEQA") (California Public Resources Code Section 21000, et seq.), pursuant to State CEQA Regulation §15061(b)(3) (14 Cal. Code Regs. § 15061(b)(3)) covering activities with no possibility of having a significant effect on the environment. In addition, the City of Beverly Hills has determined that the ordinance is categorically exempt pursuant to Section 15301 of the CEQA Regulations applicable to minor alterations of existing governmental and/or utility-owned structures.

Section 5. The City Council finds and declares that it is adopting this Ordinance in order to more fully protect and preserve the public health and safety with respect to City rights-of-way in light of the adoption of the Report and Order. Notice is hereby given to any and all wireless providers obtaining a permit pursuant to the Beverly Hills Municipal Code as amended herein, that the City expressly reserves any and all rights it possessed prior to the adoption of the Report and Order concerning its authority to regulate its public rights-of-way. In the event the Report and Order is invalidated, modified, or limited in any way, the City Council reserves the right, subject to reasonable notice and due process, to modify the terms and conditions applicable to any permit issued hereunder including, but not limited to, the term, fees charged, and scope of any future wireless deployments within the City's rights-of-way. Section 6.

Severability. If any sec-

tions, subsections, sentence, clause, or phrase of the Chapter adopted by this Ordinance is for any reason held to be invalid or unconstitutional by the decision or legislation of any court of competent jurisdiction, or by reason of preemptive legislation, such decision or legislation shall not affect the validity of the remaining portions of the Chapter. The City Council declares that it would have passed this Ordinance, and each section, subsection, sentence, clause and phrase thereof, irrespective of the fact that one or more of the sections, subsections, sentences, clauses, or phrases thereof is declared invalid or unconstitutional.

Section 7. Publication and Certification. The City Clerk shall certify the adoption of this Ordinance and cause it to be published in the manner required by law. Adopted: April 16, 2019
