## Council OKs Citywide Tobacco Ban

In a historically unprecedented move on Tuesday, Beverly Hills became the first place in the nation to implement a city-wide ban of all tobacco products.

Effective January 1, 2021, the prohibition will include any product "containing, made or derived from tobacco or nicotine that is intended for human consumption," as well as electronic cigarettes and any accessory "reasonably expected" to be used with a tobacco product.

"This reflects the values of our community," said Mayor John Mirisch. "We are a City that has taken the lead on restricting smoking and promoting public health. Somebody has to be first, so let it be us."

The decision follows the Council's February 5 direction that the Health and Safety Commission study and recommend key policy provisions for an ordinance that would ban all tobacco sales. The commission subsequently discussed key policy provisions and options to assist tobacco retailers mitigate associated impacts of a ban.

There are currently 28 places in the City with active Tobacco and Electronic Cigarette Retailer permits. Three are cigar lounges, two are grocery stores, six

are gas stations, eight are associated with hotels, and nine consist of convenience stores or pharmacies.

The three cigar lounges include the Buena Vista Cigar Club, the Grand Havana Room and Nazareth's Fine Cigars.

CVS has banned tobacco sales at its locations.

19 have held permits since 2010—when the City first adopted such requirements. One has held its permit since 2011, two since 2012, four since 2015, one since 2017, and one since 2018.

Under the new proposed ordinance, the cigar lounges will be exempt; hotels may only sell tobacco products to guests through concierge services; and all other tobacco retailers (including gas stations and newsstands) will not be able to sell any tobacco products whatsoever.

According to the staff report, no city in the United States has adopted a regulation to ban the sale of all types of tobacco products.

Neither Federal nor California law would preempt a comprehensive ban on tobacco sales.

"Since the California legislature has not fully occupied the field of tobacco sales," the report reads, "California cities are free to implement any tobacco sales regulation or restriction provided they do not involve

the collection of taxes or the penal aspects of tobacco sales to minors."

Courts haven't reviewed the citywide tobacco sales bans, though, so it remains unclear as to whether a court would uphold this type of ban if challenged.

The Council is expected to take a formal vote of approval on June 4.

## Chabad Center to Build Temple

The Planning Commission unanimously approved on April 11 a Historic Incentive Permit (HIP) to establish a temple



within the Chabad Center.

Located at 9145 Wilshire Boulevard, the building was constructed in 1959 for Howard F. Ahmanson Sr., founder and president of Ahmanson Bank. The existing design was designed by Millard Sheets, one of the most prominent figures on the Southern California art and design community. Sheets has been placed on the City's list of Master Architects.

The Planning Commission of the City of Beverly Hills, at its REGULAR meeting on Thursday, May 23, 2019, will hold a public hearing beginning at **1:30 PM**, or as soon thereafter as the matter may be heard to consider:

An amendment to a previously approved project involving a Development Plan Review (DPR) and R-4 Permits, and a new Tentative Tract Map (TTM), to allow the construction of a new 63,841 square foot, 55-foot tall, five-story, 20-unit condominium development at **425-429 North Palm Drive**.

**Development Plan Review (DPR):**

Pursuant to the Beverly Hills Municipal Code (BHMC) §10-3-3100(A), a DPR is required for the construction of the proposed building. The proposal is an amendment to a previously approved project involving the construction of a new 5-story, 55-foot tall, 20-unit residential building.

**R-4 Permit:** Pursuant to BHMC §10-3-2804 (B), the reviewing authority may issue an R-4 Permit to allow a maximum of two rooftop bathrooms associated with rooftop swimming pools or spas to exceed the height limit of a building in an R-4 zone. The proposed project involves two rooftop restrooms associated with a rooftop spa that would exceed the height limit of a building in an R-4 zone.

**R-4 Permit:** Pursuant to BHMC §10-3-2813(E), the Planning Commission may grant the equivalent of one 5-foot wide walkway in the front yard per 50' of frontage along the front lot line of a site, in any configuration. The proposed project is requesting front yard paving that is the equivalent of one 5-foot wide walkway in the front yard per 50' of frontage in any configuration.

**R-4 Permit:** Pursuant to BHMC §10-3-2808(E), the Planning Commission may permit a reduction in the required rear setback for large scale multiple residential projects to a minimum of five feet. The proposed project is requesting a five foot setback along the rear setback.

**Tentative Tract Map (TTM):** Pursuant to BHMC §10-2-202(E), the proposed project involves the subdivision of the site to allow 20 for-sale residential condominium units.

This project has been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA, Public Resources Code Sections 21000 et seq.), the State CEQA Guidelines (California Code of Regulations, Title 14, Sections 15000 et seq.), and the environmental regulations of the City. The project appears to qualify for a Class 32 Categorical Exemption (Infill Development Projects) under CEQA. This exemption is applicable to infill projects which are consistent with local general plan and zoning requirements, and would not have any significant impacts to traffic, noise, air quality, or water quality. Accordingly, the Planning Commission will consider a recommendation to find the project exempt from the environmental review requirements of CEQA pursuant to Section 15332 (Infill Development Projects).

Any interested person may attend the meeting and be heard or present written comments to the Planning Commission. Any comments received after Tuesday, May 14, 2019, but prior the public hearing, will be distributed to the Planning Commission under separate cover.

According to Government Code Section 65009, if you challenge the City's action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the City, either at or prior to the public hearing. More recently, the site was a “First Bank” location.

With the approval, the site will now change from a bank to a religious institution. According to the staff report, the project involves tenant improvements to the existing building like onsite parking lot enhancements, landscaped areas, and perimeter walls. The project promises to “rehabilitate and restore the character defining features of the project site,” reads the staff report.

On-site improvements will also include renovation to the basement restrooms, a new steel security fence along the perimeter of the site, the removal of a non-original, interior partition wall, removal of a non-original window at the north elevation, reconfiguration of the existing parking lot to provide 16 on-side parking spaces, and the creation of a new outdoor playground through the elimination of three parking spaces.

The HIP will allow for deviations in the Municipal Code requirements for vehicle parking, loading and wall height.

To qualify for a HIP, a property must be designated as a local historic landmark or must merit formal consideration by the Cultural Heritage Commission for nomination. The City Council designated the project site a historic landmark in August, 2014, which makes it eligible for HIP consideration.

During deliberation, the commission expressed enthusiasm for the project as a whole.

“I think it’s a perfect match, it’s a beautiful building, and I hope you keep it this way. I’m sure you will,” said Commissioner Joe Shooshani. “I like this project and I wish you luck.”

Gordon expressed concerns regarding parking, noting that signs surrounding the area only allowed for public parking until 6:00 p.m.

“Maybe this is something that Traffic & Parking could address if neighbors come forward this intervening year and say

that their home areas are over-parked,” said Gordon. “In light of [this approval], please make your congregants aware of the fact that this is a residential neighborhood and that if this is an evening event that they don’t just park up the street.”

The commission also approved a Conditional Use Permit and an Extended Hours Permit.

Following the approval, the project will likely be brought back to the commission for review within one year to assess operation of the facility and compliance with the conditions of approval.

## Richards Wins California Supreme Court Case

After a multi-year battle of advocating for the rights of California lenders and borrowers, Beverly Hills attorney Ronald Richards emerged victorious in the California Supreme Court last week.

Since 1992 state lenders had been subject to a judge-made rule that restricted credit to existing borrowers.

California law provides that a creditor cannot collect a deficiency judgment — that is, the difference between the amount of indebtedness and the fair market value of the property — if the property is sold for less than the amount of the outstanding debt.

According to the ruling, “this does not preclude a creditor holding two deeds of trust on the same property from recovering a deficiency judgment on the junior lien extinguished by a nonjudicial foreclosure sale on the senior.”

The landmark case set out to change 27 years of intermediate court rulings that did not adhere to prior Supreme Court rulings on the subject pronounced in the 1960’s, thus invalidating four appellate court rulings that created the additional rule.

“With the assistance of a great team, I did what attorneys and all Beverly [High] graduates should always do, never be afraid to challenge to take your case all the way to the Supreme Court if you have to,” said Richards. “This is precisely what

happened here and I am grateful to the Supreme Court and our client for allowing this injustice on the credit markets to be corrected."

Following the ruling, California lenders and borrowers are now free to contract without a law made by judges, Richard's says, that was inhibiting additional loans to the same borrower by the same lender.

## BOLD to Exceed \$1.7 Million

At their Tuesday Study Session the City Council discussed the initial proposals for this summer's BOLD (Beverly Hills Open Later) program.

The total cost of BOLD Summer 2019 is estimated at \$1,769,592, a ten percent increase from last year's \$1,600,000. Of this amount, \$1,462,154 has been requested by the Conference and Visitors Bureau, the Rodeo Drive Committee and the City.

Next Beverly Hills has also submitted a request for \$130,000 to fund the BOLD Summer Finale Next Night event.

Although each had its own set of propositions, each partner indicated to the City an interest in providing more quality-based, experiential programming. They outline a series of experiences designed to "create excitement and energy as a way to attract people to stay, shop and dine in Beverly Hills," according to the staff report.

The CVB requested elements like two curated art walks with panel discussions, flash mob activation (per the mayoral initiative), a BOLD summer art installation, and marketing and seasonal staff report.

The RDC requested Mr. Brainwash Artwork, an Oscar nominated artist to provide live-art, fireworks and a social art installation, and a performance by Spanish opera and rock singer Cristina Ramos.

Next Beverly Hills requested food trucks, beer and wine stations, art walls and floral corners, and a possible charity component.

The City approved four conceptual installations to be placed at the corner of Santa Monica Boulevard and Camden, South Beverly, Rodeo Drive and Beverly Canon Gardens.

The Chamber of Commerce has also indicated they will provide marketing and outreach support for BOLD.

## Council to Reappoint Commissioners

The City Council is expected to reappoint multiple commissioners for four-year terms.

They include Allison Balson of the Community Charitable Foundation, Anthony Spann and Sandra Pressmann of the Design Review Commission, Joshua Greer of the Public Works Commission, and Julian Javor of the Recreation and Parks Commission.

Their first two-year terms are ending on June 30, and each has submitted a correspondence expressing willingness to serve a second term.

Barring any discussion requests of particular appointments, the Council will formally approve the resolution at their May 21 meeting.

The Los Angeles Chamber Orchestra (LACO) rolled out the red carpet for Music Director Designate Jaime Martín, welcoming him to the LACO family prior to the launch of his tenure next fall, and honored Margaret Batjer on her 20 years as LACO Concertmaster at its annual Concert Gala on Thursday, May 2 at the InterContinental Hotel in downtown Los Angeles.

The Concert Gala was co-chaired by Carol Henry, a Pasadena resident, and Anne-Marie Spataru, a West Los Angeles resident. Proceeds benefit LACO's artistic, education and community engagement programs.

Among the festivities were a curated si-

## VEGAN VINO

### The Radnia brothers join forces to create a vegan canned wine

**Michael [Radnia], you and your brother Roddy [Radnia] have just launched a new wine line, "Besa mi Vino." What inspired this business and what makes your wines unique?**

That's a great question. We thought about going into the canned wine space because we've been seeing all these different types of beverages being canned-- sodas, energy drinks, coffee, you name it. So we're like OK, let's develop one of the most consumable products that people are drinking -- wine. Let's put that in a can, and see how people react to it. Originally, when we came up with the concept we thought that people would like to know the soil, where the wine was coming from, the wine maker tasting notes... but as we dove deeper and got a little more consumer feedback -- wait I have to ask you-- have you ever had vegan wine before?

**I have not.**

Do you know what makes wine vegan?

**No.**

So sometimes think "vegan" is like a "buzz word" in the

wine world, but it's absolutely not. Vegan wine is wine that is made not using any animal byproducts. Typically a lot of wineries use fish bladder, egg whites, crustacean shells - to refine their wine -- because wine doesn't always come out clean or smooth, so in order to remove the particles, certain extracts are used to do so. We use bentonite, which is a vegan based product, so whenever you do drink your wine, it's clear, silky, and smooth. We're certified organic, we don't use any foreign chemicals or preservatives on our products -- our products are 100% clean and natural and I think that's one of the biggest differentiators for us.

Also, our message is very important. It's probably one of the most important parts. The messaging behind the brand is about being present; always cultivating that into your everyday life. On the back of the can there is a line that says, "Be Present", and under that it says what present necessarily means. It's living in today, not living in yesterday. Because if you're living in the past, you're trying to re-hash things that are never going to happen again, and sometimes that causes anxiety. And if you're living in the future, you're trying to anticipate things

that may or may not happen -- and sometimes that causes depression. So, for us, if we can get people to live in the present and enjoy their moment today, and help do that with Besa, in my eyes, it would deem me to be successful if every person who saw Besa or touched Besa was present in the moment while drinking it.

**Where is the wine produced?**

Our wine is produced in Paso Robles, CA. Everything is California, everything is 2018 Vintage. Besides the fact that our wine is organic, vegan, and has all of these awesome attributes -- our wine is very high quality. Paso Robles is known for their wine and it's all fresh vintage, and we package in stainless steel. It is pretty awesome.

**Both you and Roddy are Beverly Hills High graduates. Were you entrepreneurs in high school?**

I graduated Beverly in 2012, and Roddy 2007. I wouldn't say I was entrepreneurial in high school -- I mean Roddy always had that itch. He always had that itch that he wanted to create a business, and he actually

had his first business while we were both in college in Boston. I went to BU, and he went to Babson. And whenever I was getting there, he was pretty much leaving, so we had 1 year together there. While we were there, he was developing this app called NestDrop, which was an alcohol delivery and marijuana delivery app.

**How long have you two been working on this line, and what made you decide to partner up?**

I got into this a year ago, and I believe that was 3 years after college, after I was working in the family business in real estate, in construction and development and senior housing. When we came up with the idea, we instantly loved it because it just made sense. The idea of packaged wine in a can, it clicked with us. To be able to have [wine] on the go everywhere you go, makes drinking wine that much more enjoyable. I'm just so crazy about it, because I think "how did people take wine on the go before it was packed in cans?" If you want to open up some wine, but don't want to waste a whole bottle, or for instance, you're at a restaurant and the bartender wants to

serve you a glass, but h/she doesn't want to go all the way to the back to open up a bottle of wine, and then hope that someone else has another glass later, it eliminates a lot of shrinkage problems. A lot of people are seeing that canned wine is a different alternative that is starting to make sense.

Roddy, at the end of the day is my brother and I love him, and we just get along really well. We have a great synergy when it comes to certain things. He's very creative and I'm very persistent. I handle more of the supply chain, and he is more of the creative branding side. And we've always gotten along in other business ventures, given real estate, and he's more on that side of stuff [in senior housing and real estate] where-

as this is my full time job whereas every day I live and breathe Besa and that's all I do. He's more of the strategic planning and I'm more of the implementing and putting the pieces together as far as our supply chain and our brand.

**Do you have any investors in your product?**

Right now it's self-funded by just us.

**Some people advise against doing business with family, are you concerned about launching a family business with your brother?**

That's a good question... yes and no, but I think family is always a great partner because through thick and stone you know you can trust each other, but at the same time, you have your boundaries as far as what you're delegating to each other. So as long as you guys know who is doing what, and you're not stepping on each other's toes, I think it could be an awesome relationship because there's no one who knows you better than your brother or sister.

**What is one learning lesson or piece of advice you could offer to our readers as a result of what you have experienced so far launching this wine brand?**

Just do it! Just push it! Whatever you're thinking, whatever you're passionate about, just do it -- move, and get through that one or two month phase where you don't know if it's a good idea, and put all you have into it. And even if it's a side job at the beginning, try to make it your full time job, as much as you can. Even if that means taking time off what makes sense or what structurally is the right thing to do, take what you love, and just act on it.

**Have there been any mistakes made or anything you have learned from along the process?**

Many, many, many. Giving out too much free product was a mistake, haha. [We've learned] being very analytical about every decision we're making and the partnerships we're creating. Making sure the people you're speaking to and getting in bed with are the right people and just analyzing that before executing certain contracts and developing long lasting relationships. And that kind of

goes back to your other question before [about family]; that's why someone like a brother or sister you know what you can expect from them, but sometimes it's not the easiest to get that from someone you're

just meeting over the phone or just through a couple of coffee conversations with.

**How has growing up in Beverly Hills and attending Beverly High impacted your venture?**

Amazingly, actually. I have a great support system with a lot of friends and family who went to Beverly. We just launched a campaign a couple days ago, and the majority of people who were pushing our products on their social media feed were our friends and family from Beverly High. I don't think that's something you can necessarily get from another school, where, you know, I could text anybody from my database from Beverly, even after not speaking to them for years, and they were more than happy to share our product. So I think that was super supportive and I love that I went to a school where people want to help each other versus trying to compete with each other.

**Yeah, that's how I heard about it. And I asked around about who was behind it?**

A lot of people just ended up figuring that we were the ones behind it, and without us even asking, they would promote it themselves. Which was also an amazing, beautiful thing to see from someone you haven't spoke to or seen in years. And they just want to help because they love you and they remember you and they want to see your product grow.

**What can we expect to see from your company in the next year?**

Hopefully you can expect to see us at grocery stores and a lot of fun bars and

restaurants within the LA market. I think for the next year we're hyper-focusing all of our effort within LA and then after that, we're going to start domino effecting into other states.

**Do you have plans to go international?**

Yeah, yes! I think Japan and India

would be great countries to release this in. Actually Roddy's friends from MBA school loved the product, and they have some awesome connections, and you never know...

**Who do you look up to the most?**

Hmm... I like to listen to a lot of different people and get people's opinions on how they started things. Someone I like

to listen to and would say I look up to is Gary Vaynerchuk [wine entrepreneur]. He's very passionate about what he does and he also started his own wine company back in the day, so I'm able to extract a lot of good information about his practices, and what he's done right and wrong. So if I had to pinpoint one person that I kind of had in my back pocket

that I've had to use as a guide, it would be him, because he's also gone through the same process that I'm going through right now.

**Lastly, for those curious to try the drink, where can the your wines be purchased?**

**h. Prevailing Wages:** In accordance with Labor Code Section 1770 et seq., this Project is a "public work," and thus, the Contractor and any Subcontractors must pay wages in accordance with the determination of the Director of the Department of Industrial Relations ("DIR") regarding the prevailing rate of per diem wages. Copies of those rates are on file with the Director of Public Works, and are available to any interested party upon request. Contractor shall post a copy of the DIR's determination of the prevailing rate of per diem wages at each job site.

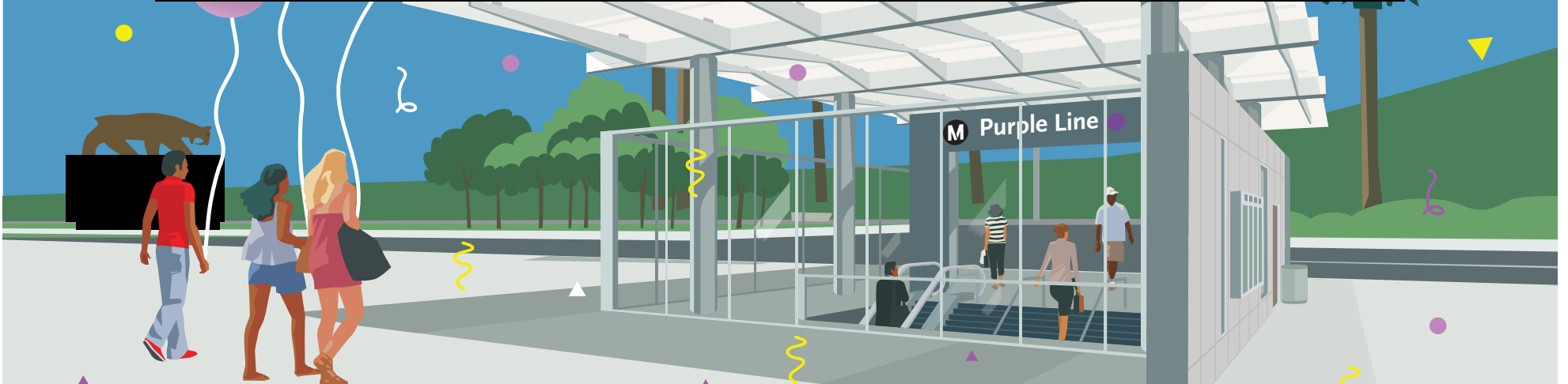
