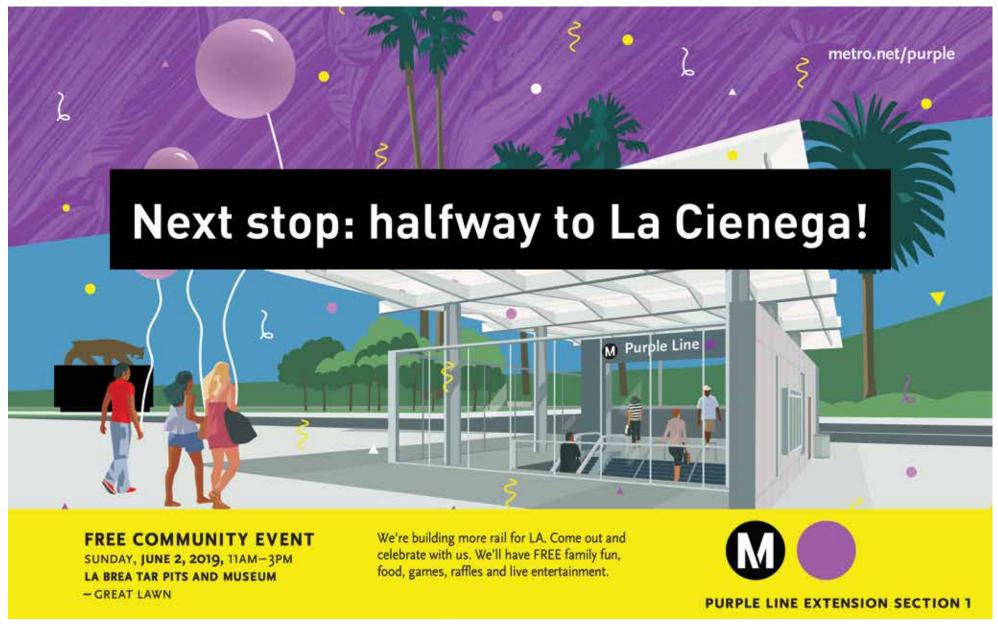

Board Talks Traffic Issues at Beverly Vista

At their May 7 meeting the Board of Education discussed the possibility of staggering the BHUSD start and drop-off times.

Although a concrete decision has yet to be made, Board members generally agreed that data and studies show that older kids, particularly of the middle and high school age, are more receptive to later start times because their circadian rhythms change.

"It doesn't matter [whether] they go to bed earlier or later-that's not what it's based on," said Board member Tristen Walker.

Walker pointed out that there is less traffic going from the east to the west so it would be ideal to start K-5 earlier, "because we know that the kids at that age group get up the earliest and are more receptive to learning earlier."

"At a time like this when we have the option to be progressive in our decision-making and to plan for the benefit of our students, I think we ought to take this time now and do that," said Walker.

Board president Noah Margo agreed.

"The older they get, the more they want to sleep in," said Margo. "When my child was young, K-5, they liked going to school. They looked forward to it. [I have to] drag my teenager out of bed. So why are we fighting that? We talk about doing

what's best for kids, so let's do what's best for kids. We're not robbing them of their education, we're just switching [the start

Public Works Commission Discusses Water Treatment Update

Last Thursday the Public Works Commission discussed an update regarding the Foothill Water Treatment Plant and the La Brea Subarea.

Initially approved on April 16, the design of a pre-treatment system for the Foothill Water Treatment Plant (FWTP) replaced the previous Phase 1Progressive Design-Build-Operate-Finance (DBOF) agreement.

City staff, Carollo Engineers staff and owner representative NV5 held the first workshop on May 1 to set parameters for the design and operational needs followed by a trial run of the FWTP from May 7 to May 9.

According to staff, the objective of the trial run is to characterize the current water quality conditions from the four Hollywood Wells and two Maple Wells in order to "effectively design and scale the pretreatment stage of the plant."

The next step to assess the overall per-

formance and condition of existing wells and water treatment equipment after more than two years of dormancy. Staff and NV5 will also work with NV5 to expedite the design schedule by pre-purchasing certain equipment.

Advantages of pre-purchasing include an "expedited design with early design collaboration between the vendor and the City's consultant and reduced equipment purchase costs," according to the staff re-

Regarding the La Brea subarea update, staff is currently focused on developing the Coffee Bean and Tea Leaf production well and corresponding conveyance pipeline to ensure maximum supply ca-

pacity for the Water Treatment Plant once it becomes available online

Staff is also working with a realtor to identify other additional properties in the desired hvdrogeological zone for future La Brea Wells. To date, several commercial/ industrial sites from approximately .25 to .5 acres have been identified.

Milles Could Join City's Art Collection

At their meeting last month the Fine Art Commission heard a presentation about Swedish artist Carl Milles, in hopes of possibly adding the artist's work to the City's collection.

Delivered by Millesgarden Museum Director Onita Wass, the presentation emphasized Milles' ability to tell a story, which she said Beverly Hills also does

Wass presented a slideshow of Milles' sculpture work as well as an in-depth biography of the artist's life.

Mayor John Mirisch-who lived in

Sweden for almost 20 years—attended the meeting, and urged for the additional of Milles' art to the City's collection.

"He was wonderful Swedish artist and we now have a unique opportunity to acquire something to add to our collection," said Mirisch. "We'd acquire something that would be made specifically for us; we'd be the first ones to have it.'

Mirisch inquired how long the entire process would take to recreate one of Milles' sculptures and bring it to the City, to which Wass said about one year.

The Fine Art Commission has yet to determine exactly what kind of sculpture would be recreated for the City.

AN ORDINANCE OF THE CITY OF BEVERLY HILLS AMENDING THE BEVERLY HILLS MUNICIPAL CODE TO CLARIFY THAT ACCESSORY STRUCTURES ON ESTATE LOTS IN THE TROUSDALE ESTATES AREA OF THE CITY MAY NOT BE CONSTRUCTED OFF THE EXISTING LEVEL PAD.

Currently, the Beverly Hills Municipal Code (BHMC § 10-3-2621) states that an applicant may request a Trousdale R-1 Permit from the Planning Commission to place an accessory structure anywhere on a site, if the site is an estate lot (24,000 square feet or larger) in Trousdale Estates. At a study session held on December 13, 2018, the Planning Commission provided staff direction to draft an ordinance clarifying that an applicant may request a Trousdale R-1 Permit to locate an accessory structure anywhere on the existing level pad, not anywhere on the site. The Planning Commission considered the draft Ordinance and adopted a resolution recommending the ordinance to the City Council on February 28, 2019. The proposed Ordinance would include modifications to the existing code language to make this clarification.

The Ordinance has been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the environmental regulations of the City. The adoption and implementation of the Ordinance represents minor language changes to the existing code to clarify a code section. There is no possibility that adoption and implementation of the Ordinance may have a significant effect on the environment because the Ordinance does not authorize construction and it would impose greater restrictions on certain development in order to protect the public health, safety and general welfare. Accordingly, the City Council will consider the staff recommendation to find the Ordinance exempt from the environmental review requirements of CEQA pursuant to Section 15061(b)(3) and Section 15308 of Title 14 of the California Code of Regulations.

The proposed Ordinance would: a) modify or eliminate zoning code language regarding time periods for review of the following types of entitlements: Variance, Conditional Use Permit, Zoning Amendment, Architectural Review, Extended Hours Permit, Adult Entertainment Business - Zone Clearance, and Design Review, and b) add findings for the Trousdale R-1 Permit pertaining to the location of accessory structures on a site. The proposed amendments included in the Ordinance would not represent changes to development standards. This ordinance is part of an ongoing effort to amend language in the municipal code to improve clarity and maintain consistency between various sections of the Code.

The Ordinance has been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the environmental regulations of the City. There is no possibility that the proposed code amendments that are not related to any specific development proposal may have a significant effect on the environment because the modifications do not enable any physical changes in the environment. Accordingly, the City Council will consider the staff recommendation to find the Ordinance exempt from the environmental review requirements of CEQA pursuant to Section 15061(b)(3) and Section 15308 of Title 14 of the California Code of Regulations because it can be seen with certainty that there is no possibility that the activity in question would have a significant effect on the environment.

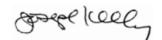
