# **Athens Employee Dispute Continues**

An ongoing dispute between Athens Waste Management and its employees continued with no resolution at last Tuesday's City Council meeting.

Although they didn't reach a final decision, the Council engaged in a lengthy debate regarding a labor dispute between Athens and its employees.

During public comment several speakers urged the Council to refrain from giving Athens a contract extension. They instead encouraged opening a bid in order to find the most reputable environmental waste company.

"The current provider Athens is a company that has promoted single-stream recycling in several other cities they operate in even as the state has recognized the importance of moving to dual-stream recycling systems," said "Don't Waste LA Coalition Director" Robert Nothoff. "You should not extend the contract. I believe this needs more time."

In Issue #1038, the Weekly addressed a Chinese import ban that Athens says has impacted the City's recycling program. Athens invested \$50 million into a new recycling facility amidst nationwide closures of other recycling centers.

"The Chinese market has very much

impacted requirements for contamination, which puts a heavier impact on 'dirty [MRF's]' because of the contamination costs," said Athens Vice President Greg Lammers of the investment.

During deliberation, Councilmember Julian Gold said that the Council was "too far down the rabbit hole" of its own employee negotiations to engage deeply with an outside issue.

"We're not labor negotiators. We're stuck in the middle of somebody else's dispute that we know half the facts of from both sides. I don't know how we can make a reasonable decision about how there's progress or not progress or who's right or who's wrong," said Gold.

Gold said that as long as Athens knows it's not a package deal, meaning that the City

doesn't have to make an eight-year commitment, he's okay with approving a contract that allows the City to withdraw if Athens doesn't resolve its employee dispute after two years.

But Councilmember Lili Bosse said that she wouldn't support such a deal, pushing for the issue to be resolved within those two years even though it's a monthto-month contract.

The Council decided to put off the vote until the December 10 meeting while they gather more information and determine the terms to which Athens would agree.

City Attorney Larry Wiener said that

by May 1, 2020, the City Council will determine that there has been "satisfactory progress toward resolution of the current labor dispute as it pertains to Beverly



The Amendment of the General Plan in order to incorporate the updated HMAP into the existing Safety Element is exempt from the environmental review requirements of CEQA pursuant to Section 15061(b)(3) of Title 14 of the California Code of Regulations. It can be seen with certainty that there is no possibility that the proposed amendments may have a significant effect on the environment, as they are in fact, designed to protect the environment from hazards. Accordingly, the City Council will consider the recommendation to find the Ordinance exempt from the environmental review requirements of CEQA pursuant to Section 15061(b)(3) and Section 15308 (Actions by Regulatory Agencies for Protection of the Environment) of Title 14 of the California Code of Regulations.

### **Prang Alerts Property Owners to Common Scans**

Los Angeles County Assessor Jeff Prang is reminding residents about scams and common real estate fraud, especially during the holiday season when unscrupulous individuals have been known to prey on the unsuspecting property owner

by way of unsolicited, official-looking mailers

Prang's Office was recently featured as a cautionary voice of reason in the Los Angeles Times business columnist David Lazarus recent

article, "That \$3 deed? They'll do it for \$89." Lazarus, an award-winning business columnist with the Times, points out that people need to be cautious about official-looking letters claiming to offer something for a cost when it's free or of very little expense.

"Property owners should closely examine any official-looking mailers," Prang said. "They should be aware of deed scams and unsolicited mailings designed to look as if they've been issued by a government agency. My website, assessor.lacounty.gov, has tips about similar scams and I encourage everyone to learn about these fraudulent practices."

Prang has combined many of the most common real estate frauds on his website that include foreclosure rescue, mortgage elimination, equity skimming, equity

fraud, fraudulent loan origination, land fraud and rental fraud, to name just a few.

Also, Assessor Prang reiterates that during the holiday season people may receive unsolicited letters or mailers that appear to be from a government agency that's asking for money for documents that are either free or of very little cost.

"Unfortunately, there are individuals that try to prey on those that are trusting, especially during the holiday season,' Prang said. "We are here to help and you can contact any one of my five district offices or my main office with any of your questions."

Assessor Prang was first elected in 2014

This Ordinance has been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA, Public Resources Code Sections 21000 et seq.), the State CEQA Guidelines (California Code of Regulations, Title 14, Sections 15000 et seq.), and the environmental regulations of the City. The adoption and implementation of the Ordinance represents minor changes to the existing code, and only involves procedural changes in public noticing. The California Building Standards Code, as amended, establishes requirements for the structural, plumbing, electrical and mechanical systems of buildings and structures, including historic and existing buildings, fire and life safety, water conservation, energy conservation and sustainability. The City amendments include: changes to wood, structural steel, and seismic design provisions. The other codes and administrative provisions adopted establish standards for property maintenance and revise water conservation regulations.
