



### "House of Bijan" Requests Encroachment Permit

Although they didn't make any final decisions, on January 9 the City Council considered a request by "House of Bijan for an encroachment permit to relocate three of its existing plaques.



If approved, the plaques currently installed in the sidewalk in front of 420 North Rodeo Drive to the sidewalk in front of the new store located at 443 North Rodeo Drive. There would also be a change in the curb alignment in front of the new store to create an additional on-street parking space with a decorative parking meter.

The request follows the Council's approval in 2014 for "House of Bijan" to install seven precast concrete plaques in the sidewalk and a decorative yellow parking meter adjacent to an on-street parking space located at 420.

The retail store, however, relocated to 443 last year. They submitted a formal application on September 26, 2019 that includes proposed work like removing and relocating the existing plaques, relocating and installing a new standard parking meter, and relocating a traffic signal pole, removing a palm tree and adjustment of utilities within the sidewalk due to the modification.

Because the encroachment will exceed one year in duration per the Municipal Code, the encroachment permit requires City Council approval.

Several community members expressed support for the request either at public comment or via mail.

"I am aware the Bijan intends to relocate the Bijan Yellow Parking Meter to

its new location," wrote Architecture & Construction Senior Vice President Franklin Dickinson, who noted that the Rodeo

> Drive Committee has expressed its unanimous support. "Kindly accept this letter in support of Bijan's application to remove and relocate the yellow parking meter."

But not all residents were on board. Former Recreation and Parks Commissioner Robbie Anderson encouraged the Council to further examine the request before making any final decisions.

"If you proceed and do this, does he own the space?" questioned Anderson. "Is this a con-

dominium space? Does he get to feed the meter? Is this his space in entirety? There are some questions here you need to ask about this. I know they're paying for this but property along there sells for \$2 million a foot. Don't be foolish on this."

During deliberation the Council discussed how to best approach the issue so as not to create traffic issues and instead encourage pedestrianism.

"The goal would be to have net plus minus zero of sidewalk space ideally, because part of Rodeo Drive is the pedestrian experience," said Mayor John Mirisch. "I think we can do it."

The item will reappear before the Council at a later date.

### **Greystone Theater Opening Scheduled for February**

Staff presented an updated Work Plan Implementation Table to the Arts & Culture Commission last Tuesday, which included a plan for the new Greystone Theater's grand opening.

The work plan serves as an update on the Ad Hoc Committee's efforts in gathering information, conducting research, putting policies and criteria in place, and "essentially establishing the infrastructure for the new purview" of the commission.

Assistant Community Services Director Pam Shinault said that all funding comes from the Community Services Department, with opening the Greystone Theater taking top priority.

Shinault said that staff visited with City Council Arts and Culture Liaisons to share

the preliminary program and event plan for the theater. The meeting also included the public, who provided feedback and suggestions. "We put to-



gether a framework, so there were different

stakeholder groups reaching out to get intertwined in our plan, so that we have things like movie nights, family activities, and [to] really demonstrate how the theater can be used for both film as well as small live performances," said Shinault.

Commissioner Zale Richard Rubins called attention to acknowledging the cost factor of putting on events like open houses and movie nights.

"I don't know that any of us are quite sure how that works, and I think that's something we need to be educated on," said Rubins. "It's easy for us to say 'Let's do this and let's do that!' but I want to know what reality is because it certainly shapes how we say 'Let's do this and let's do that."

Shinault responded by pointing out that each case will have a different cost--a large, "splashy" event with paid performers will cost more than a low-key movie night, for instance.

Other priorities include creating a draft of the new Arts & Culture website and community arts calendar; creating a kickoff celebration to launch an arts and culture initiative; reviewing the City's adopted goals and priorities regarding the commission projects; reviewing the Ad Hoc committees; continuing work on the

existing fine art and public art installations; and recommending and supporting the creation of one new event this year.

Shinault said that staff will present a funding request to the Council at its January 28 meeting. The theater's grand opening event is slated to take place in early to mid February.

### UTA, Historical Society Present at Arts & Culture "Listening Tour"

United Talent Agency (UTA) Artist Space and the Beverly Hills Historical Society gave presentations at the January 14 Arts & Culture Commission meeting as part of a months-long "Listening Tour" series.

The series offers an opportunity for arts and culture providers, businesses and non-profit organizations to share with the commission what services and events they provide and identify ways to expand arts



and culture in the City. The new commission. which has only been in effect for several months, plans to distill the data and information gathered at the "Listening Tour" into a

formal report in hopes of "[helping] guide the commission in the years ahead" and as the landscape of the expansion initiative unfolds.

"As the Commission establishes itself as a new Arts and Culture Commission in Beverly Hills, being informed about current offerings, gaps and opportunities will help to inform [its] work and help establish any processes [it needs] to invite and manage new ideas and partnerships," reads the mission statement.

At last Wednesday's meeting, UTA Artist Space Director Zuzanna Ciolek spoke about the organization's Fine Art division. The exhibition, she said, is committed to showcasing art "by globally recognized talent."

Established in 2016, the Artist Space has presented exhibitions like "Disembodiment" curated by Mariane Ibrahim and "Dark Fantasy" in collaboration with Carpenters Workshop Gallery.

Phil Savnick, a representative from the Beverly Hills Historical Society also presented, explaining the organization's mission and lasting attraction.

"Basically, our mandate is to try to entertain in an educational way to try to include what the City was," said Savnick. "Millions of people come here—what is the allure? Our feeling is that a lot of our culture, a lot of our past, the greatness that was here is really what the allure is about."

He highlighted the organization's dedication to sponsoring entertaining and educational events in addition to producing original content using an archive that consists of more than 200 hours of eyewitness interviews, 5,000 high-resolution photographs, and hundreds of hours of vintage footage from television shows and movies shot in the City.

The representative went on to assert that the City is in somewhat of a "cocoon period," from which it will eventually emerge "as a butterfly."

He advocated for the implementation of art initiatives and educational opportunities, as well as adding poster blow-ups to vacant buildings to inject more culture and history into the City.

During deliberation the commissioners considered the Greystone Theatre as a vessel through which the Historical Society could share their archive with the public.

Commissioner Stephanie Vahn suggested showing videos twice a month at the theatre, once it's finished.

The next "Listening Tour" installment will take place at the commission's February 11 meeting.

### **Bloom Reintroduces Legislation to Modernize Animal Blood Banking in** California

Assemblymember Richard Bloom (D - Santa Monica) who represents Beverly Hills, introduced Assembly Bill 1953, legislation to expand licensed veterinarians' scope of practice to include the collection and sales of blood and blood products collected from dogs.

Existing California law requires animal blood banks to collect blood exclusively from so-called "closed colonies" which confine donor animals to cages and kennels for months or years. By contrast, other states allow blood banks to collect animal blood in a community-based, voluntary setting. These programs don't rely on confined animals and lead to greater access and reduced waiting times, which can be critical in emergency situations.

Volunteer animal blood donor programs have now been established in many University-based veterinary teaching hospitals, including UC Davis, as well as at larger urban veterinary referral and emergency clinics.

"The legislature made progress during



the last session to envision a path forward to expanding the supply of blood for dogs through a volmoduntarv el similar to human blood banking," said Assemblymember Bloom. "Gov-

ernor Newsom has called on us to work with him and stakeholders to craft a better balance to ensure that we transition away from the outdated and inhumane model into one we can be proud of. We can do so much better for the animals in our state and we will aim to craft a bill that balances animal welfare and the need for safe, essential animal blood through voluntary, community-based collection methods."

AB 1953 is co-sponsored by the Beagle Freedom Project, the American Society for Prevention of Cruelty to Animals (AS-PCA), and Grey2KUSA.

Bloom represents California's 50th Assembly District, which comprises the communities of Agoura Hills, Bel Air, Beverly Hills, Brentwood, Hollywood, Malibu, Pacific Palisades, Santa Monica, Topanga, West Hollywood, and West Los Angeles.

Beverly Hills took a 2-1 lead in the 60th minute when freshman Rena Nassirzadeh scored off Chong's corner kick for her first goal.


The Normans tied the score 1-1 in the 48th minute on Talia Sarraf's unassisted goal.


