First Look at the Cheval Blanc Hotel

The City of Beverly Hills Planning Department held a virtual scoping meeting for the proposed Cheval Blanc luxury hotel earlier this month.

LVMH, the French multinational corporation that owns luxury brands like Louis Vuitton and Givenchy, announced its plans to create a Cheval Blanc hotel in Beverly Hills earlier this year. There are Cheval Blanc hotels located in Paris, Saint-Tropez, Courchevel, Randheli and Saint Barthélemy.

And now there could be one of the high-end hotels at the corner of Rodeo Drive and Little Santa Monica Boulevard. That is, if it gets the city council's stamp of approval.

But before the Planning Commission and then the City Council can consider the project, the city must first complete and certify an Environmental Impact Report. An EIR is required by California law to inform the public about any environmental impacts a proposed project can have on its surrounding areas.

City Principal Planner Masa Alkire, who is the project manager for the Cheval Blanc application, said scoping meetings are meant to provide early information to the public about a proposed project and

inform them about future opportunities to share comments.

"The primary purpose is to solicit input as to the scope of the environmental impact report that the city will be producing for the project," Alkire said.

Alkire also shared information about the project itself, including its proposed size and design.

"The project site runs from Rodeo Drive to Beverly Boulevard and along South Santa Monica Boulevard at the north end of the commercial section of Rodeo Drive," Alkire said. "It's made up of four parcels."

Cheval Blanc has proposed to have 115 hotel rooms, two swimming pools and a private club. It won't have a banquet or conference room, but it will have luxury retail stores, restaurants and spas.

Eystone Environmental is conducting Cheval Blanc's EIR. Laura Rodriguez, Eystone's Environmental Consultant Project Manager for the project, said the report will disclose the significant environmental effects of the project, identify ways to reduce those effects and consider feasible alternatives to the project.

She said that there was an initial study in which they found several areas where there could be a serious environmental impact. Those areas will need to be studied further, according to Rodriguez.

"Those [areas] are air quality, cultural resources, energy, geology and soils, greenhouse gas emissions, land use and planning, noise, transportation, tribal cul-

tural resources and utilities and service systems," Rodriguez said.

Public comments made during the scoping meeting will be part of the scoping comments received, Alkire said. This means that the EIR will take the comments into consideration when it is eventually released.

The EIR is scheduled to be released sometime in the summer or fall of 2021, after which there will be a 45-day public comment period. The Planning Commission is then expected to hold a hearing on the proposal. There will be a public hearing on the final EIR and project sometime in winter 2021 or early 2022.

Private Education Site Plans to Expand Operations Amid COVID-19

Private education institution Futures Academy plans to expand its operations by adding more teachers, students, staff and hours of operation, according to a Planning Commission meeting last Thursday.

The private school and tutoring facility, located at 8484 Wilshire Boulevard, has continued to operate online amid the pandemic similar to other educational institutions. But its educational model appears better suited to coping with an infectious disease outbreak – students are taught one-on-one rather than in large class-

rooms. They're able to take classes full-time to earn their high school diplomas or just get tutoring.

Planning Commissioners had previously approved a Conditional Use Per-



mit for Futures Academy to modify its hours, occupancy limits and interior. The educational institution requested the commission to amend its CUP to allow it to increase its maximum occupancy to 32 students and 16 staff. It also asked to extend its hours to be 8 a.m. to 8 p.m. from Monday to Friday.

A nearby resident and apartment building owner John Luca, however, shared some hesitations with the CUP amendment.

Luca said he was fine with the commission extending the school's hours, as long as something was done about students obtaining residential parking permits and parking on South Hamilton Drive.

"This became such an issue, in fact, that the head of parking enforcement along with BHPD had to do a sting operation with unmarked cars to retrieve these permits and issue citations," Luca said.

The academy offers two hour free validation for students at its parking lot. Luca suggested that it extend its validation hours, so that students who stay on campus longer don't look for alternatives to avoid paying for parking.

Commissioner Myra Demeter said she supports the educational model of the school, though she is concerned about the parking issue as someone who also lives in an impacted area.

"Unfortunately, we have seen parking passes for sale on Ebay [and] on all different sites," Demeter said. "We don't know how your students have gotten it or how many have gotten it."

She added that she'd like Futures Academy to solve the parking issue.

Commissioner Thomas Hudnut, who was formerly the headmaster at Harvard-Westlake School, said he thinks the parking issue was a red herring.

"I think we're getting all quacked out over one person's issues after 3,600 have been circulated twice and at the 11th hour there's a complaint about kids parking in the neighborhood," Hudnut said. "I'm not very sympathetic."

Futures Academy Real Estate Manager Lindsey Leblanc said she had not been aware parking had been an issue and said they will look into ways to address it. Suggested solutions included potentially extending validation hours, offering reduced parking fees and looking for oth-

er alternatives to prevent students from parking on the street.

The commission ultimately approved the CUP amendment with a 5-0 vote.

Beverly Hills Luxury Retailer Faces Parking Dilemma

French luxury jewelry, watch and perfume company Van Cleef & Arpels will have to remove one of the nine parking spots at its North Rodeo Drive location, according to a Planning Commission meeting last Thursday.

The Beverly Hills Municipal Code requires commercial buildings to have a certain number of parking spaces calculated by square footage. But while the Beverly Hills Business Triangle is known for its luxury goods, it is not known for having an abundance of parking spaces.



This is due to the In Lieu Parking program, which allows developers to pay the city a fee rather than provide the required number of parking spaces. Many businesses opt into this program simply because there is no available space for them to create parking for customers.

Van Cleef & Arpels will use one of its parking spaces to place an above-ground Southern California Edison transformer to power the building's elevator. The retailer is currently upgrading its electrical services.

The Planning Commission approved its participation in the In Lieu Parking program with a 5-0 vote. In addition to paying parking fees, the commission's staff report states that Van Cleef & Arpels plans to refinish its parking lot with metal screen panels and access doors to block the elevator transformer from view.

Commissioner Myra Demeter said she went to the parking structure to spot check the parking spaces.

"I did see where they proposed to put the [transformer] and I think it's a logical request," Demeter said.

Commissioner Andy Licht said Van Cleef & Arpels' request is straightforward.

"I was curious if there was any precedent for it but I think losing one [parking] space is not a bad thing and I see really no alternatives here so I can make the findings," Licht said.

Arts and Culture Commission Approves Sculpture for Chanel Beverly Hills

The Arts and Culture Commission approved a sculpture by the artist Jean-Mi-

chel Othoniel for the upcoming Chanel store on Rodeo Drive last Tuesday.

"The Golden Lasso," is an almost 30-foot tall sculpture that will look like a cascading string of golden pearls. Othoniel is well-known internationally for his large scale art installations, which often feature pearls. One of his sculptures was also unveiled at Chanel's New York flagship store in 2018.

The sculpture will be placed near the front entrance of Chanel's west coast flagship store on 400 North Rodeo Drive. This location is currently under construction and is expected to be complete in 2022.

Senior Project Architect Tobias Lundquist said the sculpture is estimated to cost \$571,000, which does not include shipping or engineering.

The sculpture is the central showpiece of the atrium inside the new flagship project," Lundquist said.

Commissioner Stephanie Vahn asked why Chanel chose a transparent material for the pearls, when Othoniel has used more visible colors for his sculptures in the past.

"With this very pale, translucent material that you've chosen it's hard to see," Vahn said. "It's hard to see in a photograph, as well as the obstructive line of sight so I was curious about your choice of material."

Lundquist said perhaps the sculpture's renderings don't do it justice, because the pearls are golden – hence the name "The Golden Lasso."

"There's nothing transparent about the art or the pearls [that] are located on the strand," Lundquist said.

Commissioner Zale Richard Rubins said the city has a series of walking art tours, which can sometimes have up to 50 people.

"If this was on the tour, what kind of security do you have at the door to have people come in and see something like this on that type of a scale?" Rubins said.

Murray Fischer, Chanel's legal counsel, said the Chanel store has always had a doorman.

"If you decide to put together a public walking tour, it would be our pleasure to have you put us on your list to have people come see it," Fischer said.

Commissioner Liliana Filipovic said she is very familiar with Othoniel's work and saw his pieces in France.

"I couldn't agree more with the choice of artist or type of material going with Chanel's legacy," Filipovic said.

The commission approved the sculpture with several conditions, including that the sculpture be a part of the city's fine art collection and that there be a sign recognizing the art near the store's entrance.

Beverly High Alumnus Runs for California Democratic Party Delegate

After graduating Beverly High in 2011, Daniel Bral wanted to make his mark in the music entertainment industry. He's now aiming for a different stage – to run for delegate to the California Democratic Party.

Bral announced last Monday he is run-

ning to represent the 50th Assembly District, which includes Beverly Hills. If he wins, he would be among 415 of California's pledged delegates representing the Democratic Party in political assemblies.

The son of Jewish Iranian immigrants didn't always plan to work in politics. But after completing a two-year stint at talent agency William Morris Endeavor Entertainment, he realized being a talent agent was not for him.

Bral then pivoted to a different scene – law school. He graduated from Loyola Law School in May and is currently waiting for his California Bar Examination results. Bral said he always had an interest in politics, but law school was the time when he got a chance to actually test out the political waters.

"I went and worked for [Los Angeles] Mayor Eric Garcetti for a little over a year and I was working in his office of economic opportunity, primarily with homelessness policies," Bral said.

Bral later worked as a communications associate and law clerk for City Attorney Mike Feuer. It was a lot of writing, research and policy work, he said.

"I really want to be in a position where I can help other people," Bral said. "That's always been my driving force."

Becoming a California Democratic Party delegate could be an entry point for him to do just that, he said.

There are a number of policies Bral said he plans to advocate for if he's elected, ranging from homelessness, domestic justice and inequality, to democracy reform. He said one of his goals is also a foreign policy that focuses on diplomacy.

"I think it's really important that we nurture relationships – not just with our allies but with countries that we don't usually have strong ties with," he said.

Bral credits his family for his empathy. He said he watched his mother donating to local charities throughout his childhood and now feels the same responsibility to others.

"I just want to help people who don't get attention, don't have a voice, don't have representation often, feel like they're overlooked and neglected," Bral said. "Because I have that empathy – which is so sorely lacking in our leaders right now – and I'm not doing this for selfish reasons, I feel like I'm the right person for [delegate]."

The Assembly District Election Meeting, which is when registered Democrats can vote for delegates to represent their district, will be conducted through vote-by-mail. Old Board Says Farewell, New Board Sworn-In

The BHUSD Board of Education held its installation ceremony Tuesday, in which it swore-in its newly-elected Board members Mary Wells and Amanda Stern. It also installed re-elected Board member Noah Margo.

Superintendent Michael Bregy installed Wells to the board. Wells said she was grateful for the trust placed in her to be the steward of Beverly Hills children.

“I believe in the singular power of education to transform the lives of those who are afforded it,” Wells said. “BHUSD is uniquely positioned to be able to facilitate great outcomes and I’m dedicated to working hard to ensure our students achieve both success academically and in life.”

Hawthorne Assistant Principal Kevin Painter installed Stern to the board. Stern said BHUSD schools and the students it

serves are in good hands.

“I hope to warrant your trust, your confidence and your support as we navigate these trying times,” Stern said.

to my colleagues in the next year as we continue to reimagine education in Beverly Hills.”

The board nominated Board member Rachelle Marcus to Board President and Board member Tristen Walker-Shuman to Board Vice President. Beverly Hills City Councilmember Lili Bosse installed Marcus to the board. Walker-Shuman’s husband David Shuman installed her to the board.

“I look forward to working with the five [Board] members, Dr. Bregy and all the members of the administration during the coming year,” Marcus said. “Thank you for your trust, [I] appreciate it.”

Outgoing Board members Isabel Hacker and Mel Spitz ended their five-year terms on the board and said their farewells.

Hacker served as board president from 2019 to 2020. Her accomplishments include reestablishing and implementing a Strategic Plan in the district, assisting in the reconfiguration of BHUSD schools and securing a Joint Powers Agreement with the City of Beverly Hills.

The board passed a resolution recognizing Hacker’s work on the board.

Hacker said it was an honor to serve as a board member. She said her intent and commitment was always to focus on students and their education.

“To the residents of Beverly Hills, my family and I are very thankful [to you] for entrusting me to serve as a governing board member representing our students and schools. A role I will forever keep in my memories,” Hacker said. “It has been a true honor to serve in this community and especially in this capacity.”

Spitz had previously served as a board member for nine years in the 1970’s and

ran for another term in 2015. He said he strived to achieve the objectives he advocated for as a candidate, which included ending the board’s micromangement, upgrading educational programs and improving the district’s financial condition.

He thanked the community for entrusting him to help oversee the public education of Beverly Hills children. It’s an awesome responsibility, he said.

“With the exception of declining enrollment, the district’s affairs are under control and the incoming board is inheriting a solid foundation for success,” Spitz said. “I wish you, one and all, god-speed.”

ORDINANCE NO. 20-O-2831

AN ORDINANCE OF THE CITY OF BEVERLY HILLS EXTENDING URGENCY ORDINANCE NO. 20-O-2826 MODIFYING MEDICAL USE REGULATIONS FOR CERTAIN COMMERCIAL ZONES IN THE CITY, AND DECLARING THE URGENCY THEREOF

THE CITY COUNCIL OF THE CITY OF BEVERLY HILLS HEREBY ORDAINS AS FOLLOWS:

Section 1. Legislative Findings.

The City Council of the City of Beverly Hills finds and determines that the ongoing COVID-19 global pandemic has required significant changes to the operations of businesses in the restaurant, retail, office, and service industries. This shift in operations has resulted in negative economic impacts, including the closure of businesses in the City of Beverly Hills, the substantial shrinkage of revenue in certain sectors, and the loss of jobs. The demand for brick-and-mortar office and commercial spaces has decreased, and further economic changes affecting commercial leasing demand are expected, while the demand for medical use space has remained more consistent and medical uses are more insulated from economic downturns. The City Council finds and determines that modifying the medical use restrictions will provide commercial landlords with greater flexibility to lease vacated commercial spaces, which may enable greater economic stability during the ongoing COVID-19 pandemic. Any vacant commercial space and associated blight resulting from declining businesses would create significant risk to the public, health, safety and general welfare of the City. As such, the City Council wishes to consider changes to the medical use regulations in commercial areas of the City.

Because the public process of adopting these ordinances may be lengthy, and to prevent the increase in vacant commercial spaces in the intervening period, the City Council adopted Ordinance No. 20-O-2826, an interim ordinance that took effect immediately on November 17, 2020, (the "Interim Ordinance"). The Interim Ordinance changes the medical use regulations for commercial areas of the City.

Section 2. Authority.

Pursuant to Government Code Section 65858, the City Council may adopt, as an urgency measure, an interim ordinance that prohibits any uses that may be in conflict with a contemplated zoning proposal that the City Council is considering, studying, or intends to study within a reasonable period of time. After public notice, the City Council may extend the interim ordinance by a period of ten (10) months and fifteen (15) days, pursuant to Government Code Section 65858. Notice of the public hearing at which the City Council considered adopting this extension ordinance was duly published on November 27, 2020 in the *Beverly Hills Courier*, and on November 26, 2020 in the *Beverly Hills Weekly*.

Section 3. Urgency Findings.

The City Council finds and determines that failing to implement immediate changes to its medical use regulations in commercial areas of the City would result in an immediate threat to the public health, safety, and general welfare. As described

in Section 1, the COVID-19 pandemic and the resulting closures of non-essential businesses and capacity limits on businesses is affecting the viability of City businesses and the City faces an increase in vacant commercial space.

Such business closures and capacity limits and the resulting economic impact are affecting landlords' ability to rent out vacant commercial space, which may cause blight and economic instability, and thus places the public health, safety, and general welfare at risk during the Council's review and consideration of permanent regulations. To preserve the public health, safety, and general welfare, the City Council declares it necessary that this Ordinance take immediate effect to prevent these harms.

Section 4. CEQA Findings.

The City Council hereby finds that it can be seen with certainty that there is no possibility that the adoption and implementation of the Interim Ordinance or extension thereof may have a signif-

icant effect on the environment. This extension of the Interim Ordinance does not authorize construction and, in fact, represents minor alterations in land use limitations and does not result in any changes in land use or density in order to protect the public health, safety, and general welfare. This extension is therefore exempt from the environmental review requirements of the California Environmental Quality Act (CEQA) pursuant to Section 15061(b)(3) of Title 14 of the California Code of Regulations.

Section 5. Severability.

If any section, subsection, subdivision, sentence, clause, phrase, or portion of this Ordinance or the application thereof to any person or place, is for any reason held to be invalid or unconstitutional by the final decision of any court of competent jurisdiction, the remainder of this Ordinance shall be and remain in fully force and effect.

Section 6. Approval and Extension of Ordinance.

This Ordinance, adopted as an urgency measure for the immediate protection of the public safety, health, and general welfare, containing a declaration of the facts constituting the urgency, and passed by a minimum four-fifths (4/5) vote of the City Council, shall take effect immediately upon its adoption and shall amend and extend the effect of the Interim Ordinance for a period of ten (10) months and fifteen (15) days. After notice pursuant to Section 65090 of the California Government Code and public hearing, the City Council may extend the effectiveness of the Interim Ordinance for an additional one year period, as provided in Government Code Section 65858.

Section 7. Publication.

The City Clerk shall certify to the adoption of this Ordinance and shall cause this Ordinance and her certification, together with proof of publication, to be entered in the Book of Ordinances of the Council of this City.
