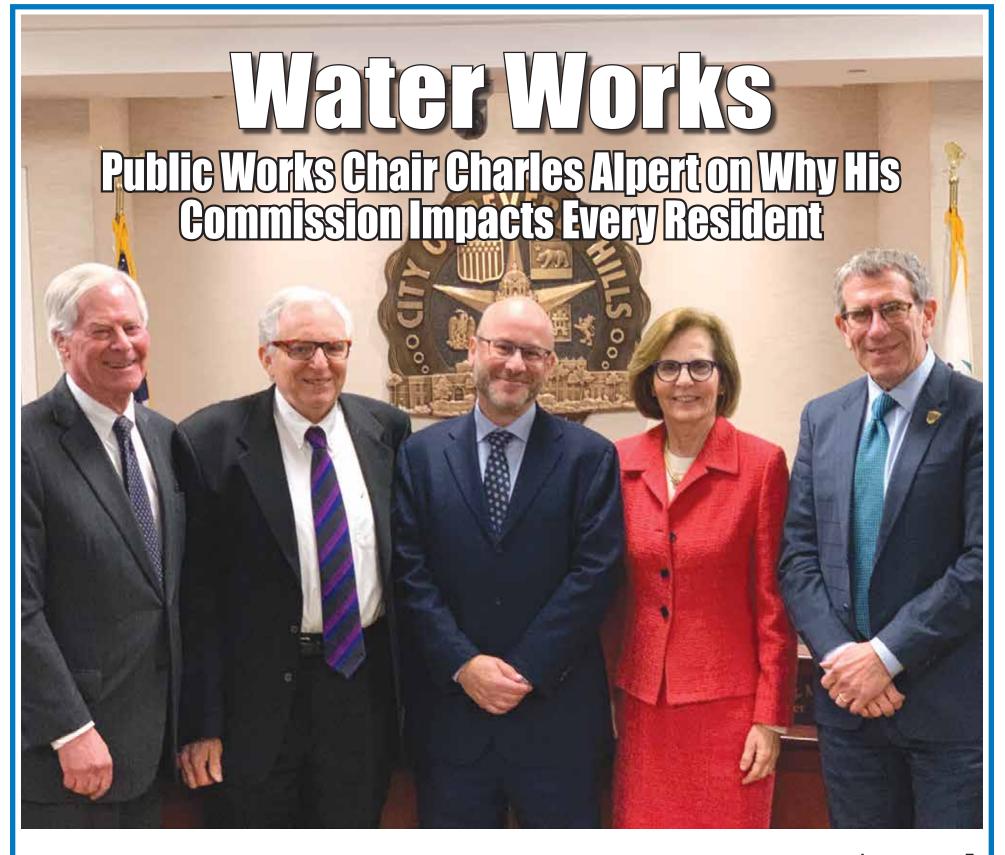

"What's Your New Year's **Resolution?**" [Issue #1109]

Thank you for your coverage of the Beverly Hills Board of Education election in November, in which I was a candidate.

Among the New Year's resolutions you featured this week is reelected BHUSD School Board member Noah Margo saying, "I resolve to always be part of the solution and never part of the problem."

Will vou ask BHUSD Board member Margo if he meant to imply that he is going to work to have the board repay the \$16 million dollars it improperly diverted from the Measure E school construction bond while he has been in office?

Critics say the BHUSD funds diversion served no purpose except to delay L.A. subway construction, something the City Council and BHUSD have worked together to try to block. Money raised by referendum to repair crumbling school buildings was instead squandered on paying lawyers to mount and lose many lawsuits, arguing that building a subway is unsafe. When the diversion of Measure E construction funds to instead pay for lawyers was voted by BHUSD, dissenting

members said they thought it may be illegal.

A solution to repay the missing Measure E funds could be the annual JPA funding provided by the City Council. The city pays the board \$11.5 million per year that BHUSD spends on whatever it wishes and has never been audited. The city has approved that expenditure for 2021, 2022 and 2023. The board could draw upon that \$34.5 million in funding to pay back money missing from Measure E.

Mary Wells, newly elected to the board, is also featured in your New Year's resolution cover story. Before being elected to the board, she sat on the Citizens' Bond Oversight Committee responsible for ensuring Bond Measure E and Bond Measure BH funds are spent responsibly. She was unable to prevent the Measure E funding being diverted while she was on the committee.

Wells, a new member of the board, now has fiduciary responsibility for BHUSD funds. Will you ask her, is she working to claw back money missing from Beverly Hills school bonds?

"City Allocates \$1.1 Million for Rent Subsidy Program" [Issue #1102]

For a mere few shekels of badly needed rent relief for tenants and to assist housing providers, the City of Beverly Hills is asking the city's rental housing providers to

sign, under penalty of perjury, a contract known as the "Landlord's/Representative's Declaration Under Penalty of Perjury" ("Declaration").

While the city's rental subsidy program is well-intentioned and would provide much needed assistance to renters and housing providers alike, because of the restrictions imposed under the declaration, it is suggested that housing providers steer clear. Here is what housing providers will be agreeing to when signing the declaration which is being signed under penalty of perjury:

• Not in default under a loan or property is not for sale, and tenants are not required to make payments to a lender, receiver, or trustee

• Provide notice on a city form to tenants to meet and discuss repayment of past due rent, and within 10 days of signing declaration provide a copy of notice to the city, schedule a meeting with the tenant within 15 days and hold a meeting within 60 days.

• Cannot serve a Notice to Pay Rent or Quit nor attempt to collect past due rent for a 12-month period after the city's emergency order is lifted (whenever that might be) and not charge interest nor late fees because of a substantial financial impact related to COVID-19.

• Cure all outstanding code violations. Similar requirements imposed by the City of Los Angeles has resulted in only very limited acceptance of that city's rental assistance program by housing provid-

ers. As a result, the city has now modified its program to remit funds directly to qualified renters leaving it up to renters to decide where the money will be spent, which we may only hope some portion will go towards rent.

Requiring owners to sign a contract under penalty of perjury that, among other things, prohibits owners from serving notice of non-payment, charging late fees or interest, or attempting to collect rent for 12 months following the lifting of an emergency order with no end in sight, is something owners should consider carefully.

While many of these contractual provisions may be covered under the city's ordinance, our Apartment Association of Greater Los Angeles has taken the position that these prohibitions are unconstitutional, and we have undertaken a constitutional challenge via a Federal lawsuit against the City of Los Angeles for these same issues.

Beverly Hills established its Rent Subsidy Program to assist renters financially impacted by COVID-19. The application period was November 16th through December 7th and the program provides for a maximum subsidy of \$3,000 for eligible low-income renters residing in Beverly Hills with payments made directly to rental property owners.

Housing providers should be aware of the conditions imposed under the declaration and should take care to read and understand what they are getting into. It is sometimes disappointing that our elected officials and the bureaucrats that run our local governments never seem to be able to step back for a moment and think how they might feel about being asked to sign a contract under penalty of perjury if they were sitting in our shoes, as if this were required for their person investment in rental property just to gain a couple of thousand dollars

Let us ask these elected officials and bureaucrats, does this make sense to you? It certainly does not make sense to me.

Planning Commission Looks At the Year Ahead

The Planning Commission has a number of upcoming projects to complete in the new year, according to Chair Peter Ostroff.

The City of Beverly Hills must finalize its revised Housing Element, which is part of the city's General Plan. The California Department of Housing and Community Development will certify it around late October.

But the city's Housing Element has been a subject of controversy among Beverly Hills residents and councilmembers. This is due to the Regional Housing Needs Assessment, which found that the city must add 3,096 housing units in the next several years. While the city is appealing this number, city staff have said it's unlikely to change. The city must show how it will accommodate sites for the RHNA allocation in its Housing Element.

Ostroff said the commission is working with a consultant and will have substantial community outreach as it develops the Housing Element. While the Planning Commission will develop the Housing Element, the City Council will have to approve it.

"It is likely that we shall consider identification of housing sites such as accessory dwelling units, new multi-family projects in the multi-family zoned areas including the mixed-use overlay zone and re-purposing of commercial buildings," Ostroff said.

Ostroff is referring to the new mixed-use overlay zone in certain commercial areas in the City of Beverly Hills, which the Planning Commission recommended and the City Council approved last year. The overlay zone will streamline mixed-use development in the city, which had previously only been approved on a case-by-case basis.

"Other significant projects include the One Beverly Hills project at the Hilton Hotel/Robinson/Union Oil station site at the intersection of Santa Monica and Wilshire Boulevards, the LVMH hotel proposal on Santa Monica Boulevard between Rodeo and Beverly Drive, the proposed office buildings for Lot 12 on Santa Monica Boulevard and the Saks Fifth Avenue project proposed for Wilshire Blvd," Ostroff said.

The One Beverly Hills project is a proposed hotel and condominium that would become the tallest building in Beverly Hills if it is approved. The Cheval Blanc hotel, proposed by the multinational corporation LVMH which owns luxury brands like Louis Vuitton, would be a luxury hotel if it is approved.

According to Ostroff, the commission will discuss the draft supplemental Environmental Impact Report for the One Beverly Hills project in a special meeting on January 28.

Bloom Announces Run for LA County Supervisor

Assemblymember Richard Bloom (D-Santa Monica) announced Wednesday he will run to succeed Los Angeles Coun-

ty Supervisor Sheila Kuehl, who has decided she will not seek a third term. Bloom is a former Santa Monica Mayor and longtime resident of the Third Supervisorial District. Bloom said

he is running for LA County Supervisor because he wants to build on Kuehl's progressive legacy and tackle critical issues.

"I will fight for humane solutions to our housing and homelessness crisis. Along with investment in affordable housing, that will mean doubling down on improving our public health, mental health, and justice systems," Bloom said. "It also means committing to equitable economic

recovery and growth as we strive not to return to 'business as usual' but to create a more just LA County with opportunity for all."

He added that he will continue to be a champion for addressing the causes of the climate crisis, holding polluters accountable, and for preserving and improving natural open spaces.

Bloom was elected to represent Assembly District 50, which includes Beverly Hills, in 2012. In the Assembly, he has advocated for the environment, affordable housing, renter protections, and services that address the root causes of homelessness. He has also advocated for an equitable economy.

Since 2012, Bloom has been Chair of the Assembly's Budget Subcommittee on Natural Resources, Energy, Climate Crisis and Transportation, overseeing the budgets of numerous state agencies, including the Natural Resources Agency, CalFire, CalTrans, DMV and others. He has also served on numerous committees, including Higher Education, Business & Professions and Local Government.

Before his election to the State Assembly, Bloom served for more than a decade on the Santa Monica City Council and as the city's mayor.

"I believe my background and experience are ideally suited to helping address the many issues that face the residents of Los Angeles County," Bloom said.

An independent redistricting commission will determine new Board of Supervisor district boundaries by August. While redistricting brings with it some unavoidable uncertainty, Bloom is moving ahead with his campaign.

Rent Stabilization Commission Will Debate Relocation Fees Again

The Rent Stabilization Commission will consider potential updates to the Rent Stabilization Ordinance's policies on relocation fees for the third time Wednesday night.

Landlords are required to pay relocation fees to qualified tenants if they are requesting them to vacate their units. Tenants can qualify for relocation fees under a number

of circumstances, including refusal to execute a lease, use by landlords and major remodeling.

The commission first debated updating the city's policies on relocation fees in November and December of last year. They discussed relocation fees requirements, reports on relocation fees, and more. In its last meeting,

Chair Lou Milkowski requested city staff to create a schedule of topics discussed and to highlight which questions by commissioners still need to be answered.

According to the commission's agenda

report, the following questions should be discussed in its January 6 meeting:

· Should relocation amounts be tied to the tenant's financial circumstances?

• Should additional fees be required for low-income households?

• Should relocation amounts be based on 10% of relocation fees for every year of occupancy so that after ten years the tenant would be eligible for full relocation fees?

• Whether to require relocation fees when evicting for use by landlords and the landlord's relative specified in the RSO? Or should there be a reduced relocation fee for landlord use?

• Whether relocation fees be required to go to the Rent Stabilization Commission or a mediation board for determinations?

• Whether relocation fees should be established for temporary relocations?

Design Review Commission Will Consider Permit for **North Bedford Drive Home**

The Design Review Commission will consider approving an R-1 Design Review Permit for the construction of a two-story

The project applicant is 621 Rodeo LLC. According to the agenda report, while the design proposal is more contemporary it would complement the existing traditional structure if approved.

City to Update Housing **Element of General Plan**

The City of Beverly Hills will be advancing its work on the Housing Element update of its General Plan, which will need to be completed by October 2021, this month.

The Housing Element will outline its future housing goals and identifies policies and programs that will be implemented to meet the needs of the community. The State of California requires each jurisdiction's housing element be updated every eight years and the final housing element must be approved and certified by the state.

Beverly Hills' Housing Element update will cover the period from 2021 to 2029.

Throughout the next several months, the city's Community Development staff will continue to work with the City Council, Planning Commission and community to develop a draft plan for adoption that can be reviewed and approved by the state.

The city will host a variety of public meetings and workshops that residents are urged to participate in so that the feedback and data can be used for the draft plan.

The first virtual community meeting will be held on February 1 at 6 p.m. For meeting log-in details and for more information, visit beverlyhills.org/housingelementupdate.

This exhibit features 51 international high school artists who submitted their artwork to the 2020 AP Art and Design exam. Amid a global pandemic, AP Art and Design students worked with diverse ideas, materials, and processes to create art. The artworks represent the resilience and perseverance of high school students worldwide as they create innovative works of art based on personal experience, some of which depict the impact of the pandemic. The exhibit features student and teacher reflections on these works, providing compelling insights into how artists make choices and approach art making.

During the AP Art and Design Exam adjudication, over 400 readers graded student portfolios submitted for review in 3-D Design, 2-D Design, and Drawing. The newly elected titled officers and executive board members will be sworn-in for a two-year term at the union's inaugural meeting via Zoom on January 11.

Public Works Chair Charles Alpert on Why His Commission Impacts Every Resident

What initially interested you in the **Public Works Commission?**

I've always been interested in working for the city if I could. I was on Team Beverly Hills and I did some work on the [Beverly Hills Fire Department's] firewise [designation]. I was on [Team] Beverly Hills] quite early, maybe the fourth or fifth class I think. It was fun. I learned a lot about the city and enjoyed

the experience. I'd recommend it to anyone.

Because I had a background working with engineering companies I thought that I would be a good fit for the Public Works Commission.

What are some of the challenges of being on the Public Works **Commission?**

Public Works has a great number of services it provides. As a commissioner you have to be able to understand the technical side of those services, the business side of providing those services - meaning the cost - and also the residents' point of view. What the expectations are for people in the community to

receive their services. It's sort of a complex organization, much more so than most people realize.

What is the status of the city's water treatment plant project at the former **Coffee Bean & Tea Leaf location?**

There's several projects going on at once. First the water plant – the water plant is being upgraded as we speak right now. The target is to complete the upgrade around the end of August and the beginning of September. So far it's moving on schedule and the commission reviews that every month.

and build a bigger one. That would hold help set the agenda for the meetings with more water and connect that reservoir up to the existing distribution. So there'd be some pipelines.

Outgoing Public Works Chair Joshua Greer spoke to the Weekly in Issue #1059 about the city becoming more sustainable. He said, "There are a lot of little things we can do to really improve; the challenge is that we want to do everything, but there's always a cost involved." Do you agree with his statement?

I think there's definitely things that all residents can do in terms of sustainability and do it better, whether it's recycling or how much water they use on their property. But I do think that the commission this year should look at identifying some potential projects for sustainability and environmental improvement at the city council. If they don't want to do them this year, they can maybe address those in future years.

I'm a big proponent of at least talking about what we can do right now. Even if the money's not there right now, we've had the discussions, talked about the feasibility of projects and put them forward to city council who are considering the future.

Do you have any ideas for sustainability and environmental improvement in the city?

Yes, a few and I've opened it to the commissioners to come up with ideas [too]. I'd like to see us do a better job for example of recycling cardboard. Also commissioners early this year will be talking about single-use plastic and what recommendations we can make for the council on that.

I'd also like the city to see how it can increase infrastructure for electric cars. I don't know if that will actually happen this year but I'd like the discussion to start happening, because I believe that electric cars are going to be more and more what we see on the road in the future.

What advice did outgoing Chair Greer give you?

Josh and I have been on the commission almost the same time. So we pretty much know how the commission runs. Additionally, he was unavailable once and so I've already as vice chair led the commission. I have a decent idea. I think the commissioners work well together and Josh and I have always worked well together. I think I'm well prepared. He did a great job and I appreciate that.

What qualities do you think make an effective chair for the Public Works **Commission?**

In a year from now, what do you hope to have accomplished as chair?

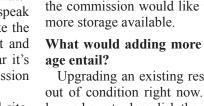

The plants have been closed for a number of years, so just having water flowing and having at least one well – that's great. But I think the challenges are to get additional emergency [water] storage. To get two more wells. And [last], I would say is to put some ideas for sustainability and environmental improvement in the city. If we can do all of those things, that would be a really successful year for the commission.

The Public Works department is considered essential and has continued to operate throughout the pandemic. What has that been like?

The department has been fully operative. The engineering and the technical staff have rotated tours in the building so that they're not all there at once, but everybody is working in-person or remotely throughout the pandemic. I think they've done a great job responding to the various new challenges as well as making sure that services have continued to the residents, like trash pick-up and water

The staff had to take on a lot of challenges during the COVID-19 period and during the protests that have happened in the city. I would like to say that the commission really appreciates all the efforts from [them] for responding to those challenges.

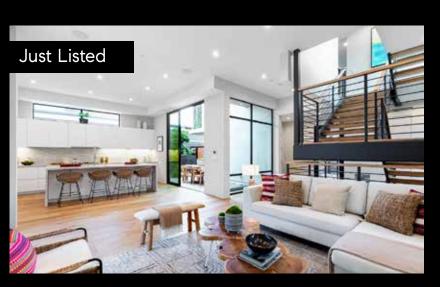

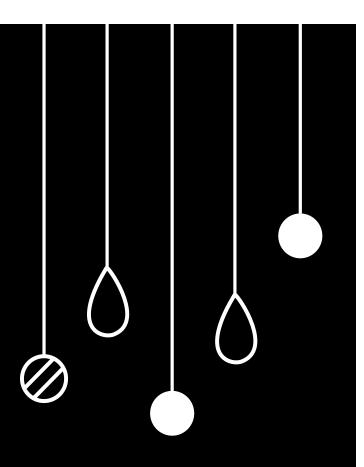
