Was staff using the Fine Art Fund to pay part of their salaries and the costs of consultants hired to shape the goals of the re-imagined commission? And while it wasn't asked, I wonder why the financial reports been adjusted so they no longer detail what expenses are being deducted from the Fine Art Fund which is supposed to be exclusively for the purchase and maintenance of the city's collection?

What is the status of and how much money has been advanced to the company (that staff intimated is about to be out of business) that was hired to re-fabricate our Kusama Hymn of Life sculpture? And are the molds that were made from the now dis-assembled sculpture available to accomplish the re-fabrication of the art? City Council approved an expense of over \$600,000 in April 2019 to make this change which doesn't sound like it has started

Why has the Bove sculpture in the Beverly Rodeo Park been disassembled for almost 2 years? And why are we building a 3rd way to display it?

It didn't seem to me that the commissioners were given direct answers to the questions that revolved around these issues. Finally, isn't it time to remove the fence around the Kusama, now that it will be made of steel and should not be harmed by admirers of fine art? Let's free the Kusama!

City Considers Emergency Call Response Upgrades After II Pastaio Shooting

The City of Beverly Hills may be upgrading its emergency call response services after evaluating its response to the Il Pastaio shooting and robbery earlier this month.

Beverly Hills Police Department Captain Elisabeth Albanese, who oversees the city's 911 Call Center, said the city received emergency calls approximately 15 seconds after the robbery began. She said a dispatcher picked up the first call within seven seconds.

"The first caller was able to provide us with great detailed information that helped

us get pertinent information to quickly dispatch our units," Albanese said. "The dispatcher keyed in the information into computer aided dispatch and program a second dispatcher who

was monitoring the room and heard that there was a shooting incident was already looking at his screen to determine which units we had closest available to respond."

According to Albanese, the first police officer arrived at the restaurant approximately two minutes after the robbery and shooting.

"The dispatch center received an influx of emergency calls in a very short period of time," Albanese said. "So within about two and a half minutes, the dispatch center received an additional 24 emergency calls."

She said that nine of the calls were answered quickly, while 15 callers disconnected the line. Dispatchers returned calls to those who had disconnected the line and were able to account for 14 of them, Albanese said.

According to the city council's agenda, there were two options to help support the Beverly Hills emergency call response during a high call volume incident. This includes continuing to work with the California Governor's Office of Emergency Services on an IP-based Nexter Generation 911 system, which will improve call routing and accuracy.

The second option was to evaluate using a Regional Interagency Next Generation 911 program, which would involve having a partnership with other police departments.

The council supported both options.

Councilmember Lili Bosse said what happened at Il Pastaio was a wake up call regarding the city's 911 system.

"I think there was a lot of concern from residents who had called 911 and they had to wait a while to get through, they were put on hold or they were in a queue," Bosse said. "That to me was a concern and it continues to be a concern. I'm happy to see we have some alternatives and some options to act upon – some that are short term and some that are longer term."

She added it's important the city finds a way to expand its emergency system because it has a limited amount of calls it can receive before it starts a queue.

"That there were so many calls in the system that it went to a queue and it gave the impression to residents that we weren't reacting which we currently were," Bosse said.

Mayor Lester Friedman said the response time for the BHPD was 91 seconds.

"But yet there's still the perception out there that, which was true, that people were not getting through and telling the 911 operators what was going on," Friedman said. "So that's why I felt that it was necessary to have this report, to have everybody see what the actual timeline is and why people may have been placed on hold."

He added there are advances the city can take and he was pleased to see the department was already moving forward with upgrading the system with CalOES.

Board Receives Updates on New COVID-19 Health and Safety Protocols

Los Angeles County has updated its COVID-19 health and safety protocols to align with the Center for Disease Control and the State of California, according to Superintendent Michael Bregy's presentation at the Board of Education meeting Tuesday.

The new protocols include requiring three feet physical distancing between students rather than the previously required six feet. This change may allow for more students per classroom.

Bregy said the district will research how the new protocol affects classrooms, but won't be recommending any changes to class sizes for its elementary schools for now.

"We're going into Spring Break as you're aware, so very cautious about making any changes right now. Good system at the elementary," Bregy said. "We want to keep everyone safe and so now that this has changed in the LA County protocols, we will examine how we can improve our elementary schedule. But at this time we're not recommending any changes to the current class sizes for our elementary TK-5 stable groups."

Stable groups will remain a requirement for transitional kindergarten through fifth grade students, but will not be required for grades six through 12.

Bregy said school districts cannot have stable groups for secondary level students since they are changing classes throughout the day and the county highly encourages block scheduling.

"So that students have a long class period with students and staff and less interaction throughout the day. So fortunately we were thinking ahead," Bregy said. "We have a block schedule that's in place. We negotiated that into our MOU in December."

In-person instruction for middle and

high school is expected to resume on April 8. Beverly Vista and Beverly High students will be placed into "A" and "B" cohorts if they choose to enroll in hybrid learning instead of continuing virtual instruction.

The A cohort will have in-person classes on Monday and Tuesday and the B co-

hort will have in-person classes on Thursday and Friday. All students will receive virtual instruction on Wednesdays.

Bregy said the county is suggesting that schools have no more than between 100 to 120 students in the cohorts.

Project Description: The 17.4 acre Project site consists of three properties: 1) the current location of the Waldorf Astoria Beverly Hills and Beverly Hills Boulevard), 2) the former location of the Robinsons-May Department Store (9900 Wilshire Boulevard), and 3) the location of a 76 service station (9988 Wilshire Boulevard). The 9900 Wilshire Boulevard portion of the site has an approved entitlement for 901,514 SF of future development that allows for the construction of up to 193 condominium units and a 134-room luxury hotel (9900 Wilshire Specific Plan). The Beverly Hilton/Waldorf Astoria Beverly Hills portion of the site has an approved entitlement (Beverly Hilton Specific Plan) that allows for the future construction of 110 condominium units and demolition and reconstruction of approximately 51,600 SF of retail, restaurant, meeting and office space. The Beverly Hilton Specific Plan totals 973.565 SF in floor area.

The proposed Overlay Specific Plan Project is a unified development plan that would allow for alternative site development of the Project site than the development authorized by the approved 9900 Wilshire Specific Plan, the approved Beverly Hilton Specific Plan, and the C-3 zoning designation applicable to the 9988 Wilshire Boulevard property. The proposed 1,933,436 SF Project includes the following components:

- 162 residential unit, 499,806 SF, 32-story, 410' tall residential building (Santa Monica Residences)
- 141 residential unit, 424,266 SF, 28-story, 369' tall residential building (Garden Residences)
 37 residential unit and 42 hotel room, 213,966 SF, 11-story, 124' tall hotel/residential building (Wilshire Building)
- 127,324 SF structure containing amenities and support areas, including 30 residential accessory spaces that could be used for staff housing (Promenade)
- 37,562 SF, 31' tall conference center for the Beverly Hilton Hotel
- 72,697 SF, 20' tall hotel restaurant, retail, 36 hotel room, and support area structure (Beverly Hilton Enhancement)
- 12.7-acres of open space, including an 8-acre botanical garden, of which 4.5-acres will be public.

Final Supplemental Environmental Impact Report (Final SEIR): The Proposed Project has been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA guidelines, and the environmental regulations of the City. The City of Beverly Hills prepared a Final SEIR to analyze potential environmental impacts associated with the Project. The latest proposal was for approval of aluminum fascia in conjunction with glazing systems, smooth cement plaster to replace natural stone cladding, removal of screening hedges, enlargement of the courtyard area that included water features and more.

The project applicant was John Gullixson, while the project representative was attorney Murray Fischer.

Chair Sheri Hirschfeld said the proposed dark color around the water feature would be very unforgiving in showing water spots.

"I always tell people to go look at the fountains on Pico [Boulevard], in front of Fox Studios," Hirschfeld said. "They basically have the fountain turned off most of the time and they're constantly cleaning it and it always looks dingy and cloudy. I mean, I don't even like to do dark colors in the shower for that same reason."

Commission Tim Devlin said it's great that plants are being irrigated but it would be nice for the drip lines to be concealed.

"I see the oak leaf hydrangea used in the planting bends and the individual planters as well," Devlin said. "Some concern with this – when its in some of the individual pots – because its deciduous so for a couple months it'll just be branches in the pot. As long as that's okay and people are okay with that, then that would be fine."

Some of the conditions of approval for the project included providing drainage for the planters, considering increasing the container sizes for the lid planters to ensure the planting overall is lush and considering alternate species for the proposed Fiddle Leaf Fig trees.

The project is located at 9200 Wilshire Boulevard and is a condominium development.

Board Approves Amendments to Armed Security Contract

The BHUSD Board of Education approved Tuesday an amendment to its contract with an armed security agent service.

Nastec International Inc. has had a contract with the BHUSD to provide armed security services at its schools since 2018. The board approved earlier this month a contract with the agency for the period of March 4 through June 9 in the amount of \$146,430.60.

But only elementary school students had returned to in-person instruction when the contract was adopted. Since middle and high school students are expected to return to in-person instruction in April, the amendment will add armed security to Beverly High and Beverly Vista starting April 6.

According to the board agenda, the amendment cost the district an additional \$74,232.76.

BHUSD Addresses Major Sewage Backup at Hawthorne School

The BHUSD Board of Education ratified Tuesday contracts for addressing a major sewage backup at Hawthorne School

The school experienced the backup in January, which resulted in one of its buildings being closed for repairs. According to the board's agenda, testing of the materials showed sewage contaminated asbestos.

In order to address the damage quickly, the district contracted Lucy Environmental for the asbestos abatement and Servpro for the repairs and water damage. The total cost is covered by the district's insurance except for a \$8,000 deductible.

BHUSD Enters Contract with Church for Beverly Vista Parking

The BHUSD Board of Education approved Tuesday a contract with the First Church of Christ, Scientist for use of its parking structure for Beverly Vista School employees.

According to the contract agreement, the district will pay \$1,000 a month to use the church's underground parking structure on weekdays except Wednesday from 7 a.m. to 5:30 p.m. The district will be responsible for opening and closing access to the structure.

The agreement will be in effect from March 23 to June 9.

Human Relations Commission Aims to Address Homelessness

The Human Relations Commission discussed last Thursday updates to the city's Homeless Initiative, which aims to address homelessness in Beverly Hills through community education and advocacy.

Commissioners have made several recommendations for the program, including having the city advocate for a social

worker who can assist law enforcement and for the City Council to advocate for legislative policy reform on homelessness as part of its legislative platforms.

Human Services Specialist Enisha Clark said city staff wanted direction regarding how to increase community education. She suggested creating a platform where residents can be heard and city staff can educate them about homelessness trends.

"As we all know, the pandemic has just worsened the homelessness problem throughout LA County and even making it more visible here in Beverly Hills," Clark said. "Staff is suggesting at this point to just really be an advocate for the community and a voice in terms of being proactive about what's going on."

Vice Chair Karen Popovich Levyn said residents need to be educated about homelessness and informed about the resources the Human Services Department offers.

"I love the virtual forums. I think that's the way to get it out there," Levyn said. "I'd love to have speakers at these forums, maybe, that help to understand about a homeless person. There's all different types – some that want help, some do not, some that have more mental needs.'

Commissioner Anette Saleh said there's a notion that the city just busts homeless people out of the city. She said she continually has to explain the services the city offers and the homelessness organizations the city supports.

"I think just having something on our website maybe, or something on the city's website giving all that information out would be great," Saleh said.

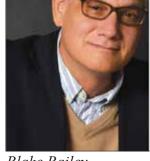

Judge Rules Ordinance Limiting Protests Is Unconstitutional

By Ani Gasparyan

A Los Angeles judge ruled Friday that the City of Beverly Hills' emergency ordinance restricting protests is unconstitutional.

The City Council adopted the emergency ordinance in response to Beverly Hills becoming a hub for social demonstrations, such as protests against the murders of George Floyd and Breonna Taylor. Among its restrictions, the ordinance limited protesters to three locations in the city if they did not have a permit and prohibited loud demonstrations of more than 10 people in residential areas at night.

Several legal analysts questioned the constitutionality of the ordinance at the time of its passing.

Los Angeles County Superior Court arrested around 24 of those protesters for Judge Mark E. Windham agreed with those concerns in a nine-page ruling issued last week. He said the ordinance violated the first amendment.

"Beverly Hills cannot prohibit legitimately targeted disturbances with a measure that equally prohibits innocent protected expression," Windham wrote.

Approximately 100 protesters, organized by the Black Future Project, had marched around North Santa Monica Boulevard and Rexford Drive last summer before entering a residential Mark E. Windham street around 10 p.m. Ac-

cording to eyewitnesses, the protesters shouted "Wake your rich ... up!" and several other phrases.

The Beverly Hills Police Department

violating the city's ordinance. But the city must now drop the charges against the protesters for violating the ordinance because of the judge's ruling, according

to the Los Angeles Times.

Public Information Manager Keith Sterling said the city believes that the ordinance was constitutional as a temporary restriction on demonstrations in residential areas.

"However, the city's ordinance permanent which regulates night-time demonstrations in residential areas, and has been in effect since last fall, does

not require silence and we believe that it meets the constitutional requirements of the decision by Judge Windham," Ster-

ORDINANCE NO. 21-0-2835 AN ORDINANCE OF THE CITY OF BEVERLY HILLS AMENDING THE BEVERLY HILLS MUNICIPAL CODE

EQUIPMENT AND SERVICES THE CITY COUNCIL OF THE CITY OF BEVERLY HILLS HEREBY ORDAINS AS FOL-LOWS:

REGARDING PURCHASING OF SUPPLIES,

<u>Section 1.</u> Articles 1, 2 and 3 of Chapter 3 of Title 3 of the Beverly Hills Municipal Code shall be amended as follows:

CHAPTER 3. PURCHASING PUBLIC WORKS CONTRACTS AND DISPOSITION OF PROPERTY

ARTICLE 1. GENERAL PROVISIONS

3-3-101: INTENT

4/1,8,15 2021

The intent of this chapter is to establish purchasing procedures for the purchase of equipment, supplies and services, to conform to the California Uniform Construction Cost Accounting Act (Public Contract Code section 22000 et seq.) and to establish procedures for the disposition of property. Nothing in this chapter is intended to require the City to solicit bids for equipment, supplies or services or accept the lowest bid to provide equipment, supplies or services, except as required by State law.

3-3-102: DEFINITIONS

Unless the context otherwise requires, the following definitions shall govern the construction

CHANGE ORDER: Change Order means a written authorization from the City directing an addition, deletion, or revision to an awarded purchase order or contract.

CONTRACTING OFFICER: Contracting Officer means the designated City employee authorized by section 3-3-107 of this article to engage in level 1, level 2 and level 3 purchasing transactions.

DIRECTOR OR PURCHASING AGENT: Director of Purchasing Agent means the Director of Finance, or his or her designee.

ELECTRONIC BIDDING PLATFORM: Electronic Bidding Platform means one or more computing or digital software platforms selected by City to solicit and receive written bids for goods, supplies, equipment and/or services as detailed in the rules and regulations adopted by the Director pursuant to this chapter.

PUBLIC PROJECT: Public Project means that term as defined in section 22002 of the California Public Contract Code, or the successor statute thereto

3-3-103: PURCHASES AND CONTRACTS REQUIRE ISSUANCE OF PURCHASE OR-

A. In order to more efficiently manage all purchases and other contracts, the City shall issue a purchase order to each vendor who agrees to provide goods or supplies to the City and the City shall issue a purchase order to accompany every contract for the performance of services or public projects unless otherwise authorized by an administrative regulation signed by the city manager or authorized by the rules and regulations adopted by the Director pursuant

to this chapter. Except as otherwise provided herein, no contract shall be deemed to be an authorization to proceed with work unless accompanied by a purchase order authorized and executed pursuant to this section, nor shall any vendor or contracting party be authorized to perform any service, perform any public project, or provide any supplies or equipment without first receiving a purchase order authorized and executed pursuant to this section.

B. Notwithstanding the above, litigation service contracts shall be exempted from the requirement to issue a purchase order due to the confidential nature of the fees anticipated. Litigation services shall be paid with a contract in place and the responsible department shall not pay more than the appropriated budget. If additional funding is required, an additional appropriation must be approved by the city council.

3-3-104: UNAUTHORIZED PURCHASES AND CONTRACTS

It shall be unlawful for any officer, employee, or agent of the City to order the purchase of supplies or equipment, or to contract for services or contract for the performance of public projects, or otherwise make any contract in violation of this chapter. Any order, purchase, or contract made contrary to the provisions of this chapter shall not be binding on the City, and the City shall not be obligated thereunder.

3-3-105: PROHIBITION AGAINST SPLIT-TING PURCHASES

Purchases of supplies, equipment, and services, and the performance of public projects shall not be divided or staged for the purpose of circumventing the requirements of this chapter.

3-3-106: SPECIALIZED CONTRACTING **PROCEDURES**

Nothing in this chapter shall prohibit the City from using specialized contracting procedures when authorized by state law. If state law authorizes such procedures, they need not also be specifically authorized by this chapter. Such specialized procedures may include, without limitation, prequalification of general contractors or subcontractors and design/build contracting procedures.

3-3-107: PURCHASING LEVELS AND AP-PROVAL AUTHORITY

Purchasing and contract procedures are categorized into four (4) different levels as set forth in sections 3-3-200 et seq. of this chapter. Each level shall govern purchase orders and contracts of different values. Level 1 shall govern the least expensive purchase orders and contracts and level 4 shall govern the most expensive purchase orders and contracts.

Level 1 purchases may be awarded in the maximum amount of ten thousand dollars (\$10,000) by the head of the City department or his/her authorized designee for which the purchase is

Level 2 purchases may be awarded in the maximum amount of fifty thousand dollars (\$50,000) by the Purchasing Agent or his/her authorized designee;

Level 3 purchases may be awarded in the maximum amount of one hundred thousand dollars (\$100,000) by the city manager or his/her authorized designee; and

Level 4 purchases exceed one hundred thousand dollars (\$100,000) and shall be awarded by the city council. The city manager's pur-chasing authority is increased to two hundred thousand dollars (\$200,000) if the city manager determines: (a) there is an urgent need to enter into a purchase order or contract and (b) the equipment, supplies or services is a budgeted expense as set forth in the City adopted budget. In such case, the purchase and/or contract shall be governed by the regulations applicable to Level 3 purchases and contracts. The purchase order or contract must be reported to the city council at its next regularly scheduled meeting.

3-3-108: BID SECURITY

Bid security shall be required as a condition of submitting a written bid unless deemed unnecessary in writing by the Purchasing Agent. Bid security shall be in the form of a cashier's check or surety bond and shall be no less than ten percent (10%) of the bid amount or such other amount as determined by the Purchasing Agent.

A successful bidder shall forfeit his bid security upon refusal or failure to execute a contract or

purchase order with the City. On refusal or failure of the successful bidder to execute the contract or purchase order, the City may award the bid to the next lowest responsible bidder who is willing to execute the contract or purchase order. In such case, the amount of successful bidder's security shall be applied by the City to the purchase or contract price differential between the successful bidder and the next lowest responsible bidder. The remaining security, if any, shall be returned

3-3-109: INTERPRETATION OF BID SPECIFI-**CATIONS**

Oral interpretation of written bid specifications shall not be made by the City to prospective bidders. If the prospective bidder discovers discrepancies or omissions in any specification, or if the bidder is in doubt as to the meaning of any specification, the bidder shall request a written interpretation or modification from the City. If interpretations or modifications are deemed necessary, the City will then issue a written addendum to all parties known to have received copies of the specifications.

3-3-110: CHANGE ORDERS

A. Any alteration to, amendment of, or deviation from an awarded purchase order or contract as to scope, cost, time for completion, material, or equipment furnished as a part of the purchase order or contract, or any alteration to, amendment of, or deviation from the nature of work to be performed, shall require the completion and issuance of a Change Order or execution of a contract amendment. Additions to work cannot be combined with deletions to work to avoid the Change Order requirement.

B. The appropriate Contracting Officer may approve a Change Order as long as the combined amount of the original purchase order and the Change Order does not exceed the Contracting Officer's purchasing authority. If the original purchase order or contract was approved by the city council, a Change Order may be approved in an amount that does not exceed the Contracting Officer's purchasing authority. All other Change Orders shall be approved by the city council or the person, if any, designated in a contract approved by the city council. No Change Order shall be binding on the City until approved as provided herein.

Change orders shall not be issued unless:

- a. The Change Order arises in good faith out of an unknown condition or unforeseen circumstance including, without limitation, unforeseen or unknown quantities of goods and/or services differing materially from the quantities of goods and/or services that were contemplated in the purchase order or contract, or, alternatively, the Change Order arises due to an error in the City's specifications that accompanied the bid solicitation; and
- b. The Change Order does not change the purpose of the purchase order or contract; and
- c. With regard to a service contract or a contract for public project performance, the Change Order is reasonably related to the scope of work authorized under the original contract; and
- d. With regard to the purchase of goods or supplies, the Change Order is required to allow the goods or supplies to fulfill the purpose for which they were intended.

C. Any Change Order for a public project shall be in accordance with the most current edition of the "Standard Specifications For Public Works Construction", adopted by the joint cooperative committee of the Southern California chapter of the American Public Works Association and the Southern California districts of the Associated General Contractors Of California.

3-3-111: ANNUAL REPORT

The Director shall make an annual report to the city council of the level 2 and level 3 awarded purchases and contracts.

3-3-112: EXCEPTIONS TO BIDDING RE-QUIREMENT

Except with regard to public projects of more than sixty thousand dollars (\$60,000.00), the bidding requirements of this chapter shall not apply in the following circumstances:

A. When the purchase order or contract is for utility or communications services; insurance; freight and courier services; postage; education and training expenses; subscriptions and memberships in professional organizations; attendance at meetings or conventions; and hotel and travel accommodations

- B. Where items to be purchased are for resale to the public.
- C. When the needed equipment, supplies or services are proprietary items of original equipment manufacturers and/or their authorized exclusive distributors.
- D. When the equipment is a component for equipment or a system of equipment previously acquired by the City, and is necessary to repair, maintain or improve the City's utilization of the equipment.
- E. Where items to be purchased are circulating library materials, including books, periodicals, films, and recordings; computer software, hardware maintenance services or software maintenance services; food, condiments and similar items; or art.
- F. Any contract involving the purchase of supplies, equipment or services entered into with another governmental entity.
- G. Any contract for professional services such as attorneys, physicians, architects, engineers, consultants, accountants, specialized printers or other individuals or organizations possessing a high degree of professional, unique, specialized or technical skill or expertise.
- H. When the requesting department determines in writing, after conducting a good faith review of the available sources, that there is only one source for the required equipment, supplies or services or that a sole source procurement is necessary to ensure compatibility with existing City equipment. The department requesting sole source procurement shall provide written evidence to support a sole source determination. Such evidence shall be approved by the Purchasing Agent. The city manager may require that negotiations be conducted as to price, delivery and terms. The city manager may also require the submission of cost or pricing data in connection with an award under this section.
- I. Emergency procurement as set forth in sections 3-3-206 and 3-3-303 of this chapter.

Nothing in this section prohibits the Purchasing Agent or appropriate Contracting Officer from requiring more stringent bidding requirements for a purchase that falls under one of the exceptions listed above.

3-3-113: MULTIYEAR CONTRACTS

Unless otherwise limited by law, the term of a contract shall be as set forth in the contract, and may include extensions as authorized in the contract. The appropriate Contracting Officer may approve a multiyear contract, provided that the annual value of the multiyear contract does not exceed three times the Contracting Officer's purchasing authority over the entire term of the contract. Otherwise, multiyear contracts shall be approved by the person designated in section 3-3-107 using the total value of the contract.

3-3-114: RULES AND REGULATIONS

The Director is authorized, subject to approval by the city manager, to promulgate rules and regulations to implement the provisions of this article.

ARTICLE 2. PURCHASING OF SUPPLIES, EQUIPMENT AND SERVICES

3-3-200: SCOPE OF ARTICLE

This article shall govern the purchase and contracting of supplies and equipment and services.

3-3-201: DEPARTMENT HEAD PURCHASES; LEVEL 1

Level 1 purchases and contracts may be awarded by the head of the department for which the purchase is made and is authorized without competitive bidding.

3-3-202: PURCHASING AGENT/DIRECTOR OF FINANCE PURCHASES; LEVEL 2

- A. Level 2 purchases and contracts may be awarded by the Purchasing Agent and shall require competitive written bidding. Bids shall be solicited and received in writing through an Electronic Bidding Platform, or an alternative method from a minimum of three (3) sources or the open solicitation of bids as set forth in the rules and regulations adopted by the Director pursuant to this chapter.
- B. The Purchasing Agent shall award the purchase of supplies, equipment or services to the lowest responsible bidder, or shall reject

- all bids for the purchase, after the receipt of bids from those who respond to the solicitation, The Purchasing Agent may waive any irregularities or informalities in any bid or bidding.
- C. The Purchasing Agent may waive the requirement to solicit written bids if the equipment or supplies are available from only one source as set forth in section 3-3-112(H) of this chapter and may solicit only two (2) bids if the equipment or supplies are available from only two (2) sources.
- D. Upon determining that conformance with the procedures set forth in this article would be contrary to the best interests of the City or upon determining that compliance with the procedures would be impractical, the Purchasing Agent may waive, in writing, any or all of the requirements of this section.

3-3-203: CITY MANAGER PURCHASES; LEVEL 3

- A. Level 3 purchases and contracts may be awarded by the city manager and shall require competitive written bidding as follows:
- 1. Bid specifications shall be prepared and written notices soliciting written bids shall be disseminated by an Electronic Bidding Platform, or an alternative method from a minimum of three (3) sources or the open solicitation of bids as set forth in the rules and regulations adopted by the Director pursuant to this chapter. Such notices shall include the closing date of the bid.
- 2. Bids shall be submitted to the Electronic Bidding Platform or an alternative method in writing and must be received prior to the bid closing date and time. Bids shall not be reviewed until the date and time designated in the bid specifications.
- B. With regard to the purchase of supplies, equipment or services, the city manager shall award the purchase to the lowest responsible bidder, or shall reject all bids. The city manager may waive any irregularities or informalities in any bid or bidding.
- C. The city manager may waive the requirement to solicit bids if the equipment or supplies are available from only one source as set forth in section 3-3-112(H) of this chapter and may solicit only two (2) bids if the equipment or supplies are available from only two (2) sources.
- D. Upon determining that conformance with the procedures set forth in this article would be contrary to the best interests of the City or upon determining that compliance with the procedures would be impractical, the city manager may waive, in writing, any or all of the requirements of this section.

3-3-204: CITY COUNCIL APPROVAL; LEVEL 4 PURCHASES

- A. Level 4 purchases shall be awarded by the city council and shall require competitive written bidding as follows:
- 1. Bid specifications shall be prepared, and notices inviting written bids shall be solicited by an Electronic Bidding Platform, or an alternative method from a minimum of three (3) sources or the open solicitation of bids as set forth in the rules and regulations adopted by the Director pursuant to this chapter.
- 2. Bids shall be submitted in writing to the Electronic Bidding Platform or an alternative method as set forth in the rules and regulations adopted by the Director pursuant to this chapter, and must be received prior to the bid closing date and time. Bids shall not be reviewed until the date and time designated in the bid specifications.
- B. With regard to the purchase of supplies, equipment or services, the city council shall award the bid to the lowest responsible bidder, or shall reject all bids. The city council may waive any irregularities or informalities in any bid or bidding.
- C. The city council may waive the procedures required by this section if the city council determines that the equipment or supplies are available only from one source as set forth in section 3-3-113 of this chapter and may send a notice inviting bids to only two (2) prospective bidders if the city council determines that the equipment or supplies are available from only two (2) sources.
- D. Upon determining that conformance with the procedures set forth in this article would be contrary to the best interests of the City or

upon determining that compliance with the procedures would be impractical, the city council may waive, by motion or resolution, any or all of the requirements of this section.

3-3-205: ALTERNATIVE PURCHASING PRO-CEDURES

In lieu of the purchasing and bid procedures set forth in this article, the following alternative purchasing procedures may be used in the discretion of the Purchasing Agent for the purchase of supplies, equipment or services in excess of Level 1 department head purchases.

- A. Purchases from the California department of general services, pursuant to California Government Code section 54205, or the successor statute thereto.
- B. Purchases from any joint powers agency or any agency with which the City has entered into a joint powers agreement for purchase of equipment or supplies; provided that the city manager determines that the item can likely be obtained at a cost which is less than the City could likely obtain through the purchasing procedures set forth in this article.
- C. Purchases of supplies, equipment or services where competitive bid procedures have already been utilized, such as purchases from federal, state or county governments, including, state of California agencies, counties, cities, joint power agencies, special districts, and nonprofit agencies whose main purpose is to assist cities or other public entities, and the supplies or equipment are supplied to the City at the same or better price, as was obtained through the competitive bid procedures of that entity.

3-3-206: EMERGENCIES

- A. In case of a locally declared emergency or if the city manager determines there is an emergency situation, the city manager, the assistant city manager or the director of emergency services, is authorized to expend City funds without limitation on amount and without following the purchasing or bidding procedures otherwise required by this article. An emergency purchase shall be limited to those supplies, equipment or services necessary to satisfy the emergency need.
- B. Expenditures made during a locally declared emergency, or in an emergency situation as determined by the city manager must be reported to the city council at the next regular council meeting if approval for such expenditures would otherwise have been made by the city council.
- C. As used in this section, an "emergency situation" is defined as an urgent unforeseen situation that threatens life, property or the general public health and safety.
- D. The Director shall, subject to approval by the city manager, promulgate rules and regulations to implement emergency purchasing practices that comply with state and federal law

ARTICLE 3. PUBLIC WORKS CONTRACTS 3-3-301: CONTRACTS FOR PUBLIC PROJECTS:

The following procedures shall govern the award of contracts for public projects, whereas the limits referenced in section 3-3-107 shall indicate the threshold for approvals by the city council:

- A. Public Projects Of Sixty Thousand Dollars Or Less: Public projects of sixty thousand dollars (\$60,000.00) or less, may be performed by City employees, may be awarded by negotiated contract, or may be awarded by purchase order. A contract or purchase order shall require competitive written bidding as described in section 3-3-202 of this chapter unless the Purchasing Agent determines that a different competitive bidding procedure is in the best interest of the City. In such case, the Purchasing Agent may solicit written bids as provided in section 3-3-203 of this chapter or solicit written bids as provided in section 3-3-204 of this chapter.
- B. Public Projects Of More Than Sixty Thousand Dollars, But Less Than Or Equal To Two Hundred Thousand Dollars: Public projects of more than sixty thousand dollars (\$60,000.00), but less than or equal to two hundred thousand dollars (\$200,000.00), shall require competitive written bidding as described in this subsection.

- 1. Bid specifications shall be prepared and notices inviting bids shall be solicited as set forth in subsection B2 of this section.
- 2. All notices inviting bids shall be sent to: a) the construction trade journals specified in California Public Contract Code section 22036, or b) a list of qualified contractors, identified according to categories of work and which has been developed in compliance with the criteria issued by the California Uniform Construction Cost Accounting Commission, or c) both, unless the supplies, equipment or services are proprietary. Such notices shall be sent not less than ten (10) calendar days before bids are due. The notices shall describe the project in general terms, how to obtain more detailed information regarding the project, and the time and place for the submission of bids.

If all bids received are in excess of two hundred thousand dollars (\$200,000.00), the city council may, by passage of a resolution by a four-fifths (4/5) vote, award the contract at two hundred twelve thousand five hundred dollars (\$212,500.00) or less, to the lowest responsible bidder, without complying with the bidding procedures set forth in subsection C of this section, provided that the city council determines that the cost estimate of the project was reasonable.

- C. Public Projects Of More Than Two Hundred Thousand Dollars: Public projects of more than two hundred thousand dollars (\$200,000.00) shall require competitive written bidding. A notice inviting bids shall be published and sent in compliance with the provisions of California Public Contract Code section 22037, or the successor statute thereto. In addition, bid plans and working details shall be adopted by the city council for all public projects exceeding two hundred thousand dollars (\$200,000.00).
- D. Bid Requirements: When written bids are requested, the bids shall be submitted to the Electronic Bidding Platform or an alternative method in accordance with the Public Contract Code and as set forth in the rules and regulations adopted by the Director pursuant to this chapter and shall not be opened until the time and place designated in the bid specifications. Bids must be received prior to the bid deadline to be considered.
- E. Award: When bids are solicited, the appropriate Contracting Officer or the city council shall award the bid to the lowest responsible bidder, or reject all bids pursuant to Public Contract Code section 22038, or its successor statute. The Contracting Officer or the city council may waive any irregularities or informalities in any bid or bidding.

3-3-302: CONTRACTING AUTHORITY FOR PUBLIC PROJECTS:

The City officials set forth in section 3-3-200 et seq. of Article 2 of this Chapter 3 shall have the authority to approve contracts for public projects in the amount that corresponds to their purchasing authority as set forth in those sections

3-3-303: EMERGENCY PROCUREMENT:

In addition to any other exemption from bidding requirements set forth in this chapter or otherwise provided by law, in a situation determined by the city manager to constitute an emergency for a public project pursuant to Public Contract Code sections 22035 and 22050 or in a locally declared emergency city council delegates to the city manager, the assistant city manager and the director of emergency services the power to order any action pursuant to Public Contract Code sections 22035 and 22050. The city manager, the assistant city manager, director of emergency services shall comply with the applicable provisions of section 22050.

Section 2. Severability. If any section, subsection, subdivision, sentence, clause, phrase, or portion of this Ordinance or the application thereof to any person or place, is for any reason held to be invalid or unconstitutional by the final decision of any court of competent jurisdiction, the remainder of this Ordinance shall be and remain in full force and effect.

Section 3. Publication. The City Clerk shall cause this Ordinance to be published at least once in a newspaper of general circulation published and circulated in the City within fifteen (15) days after its passage in accordance with Section 36933 of the Government Code, shall certify to the adoption of this Ordinance, and shall cause this Ordinance and his/her certification, together with proof of publication, to be

entered in the Book of Ordinances of the Council of this City

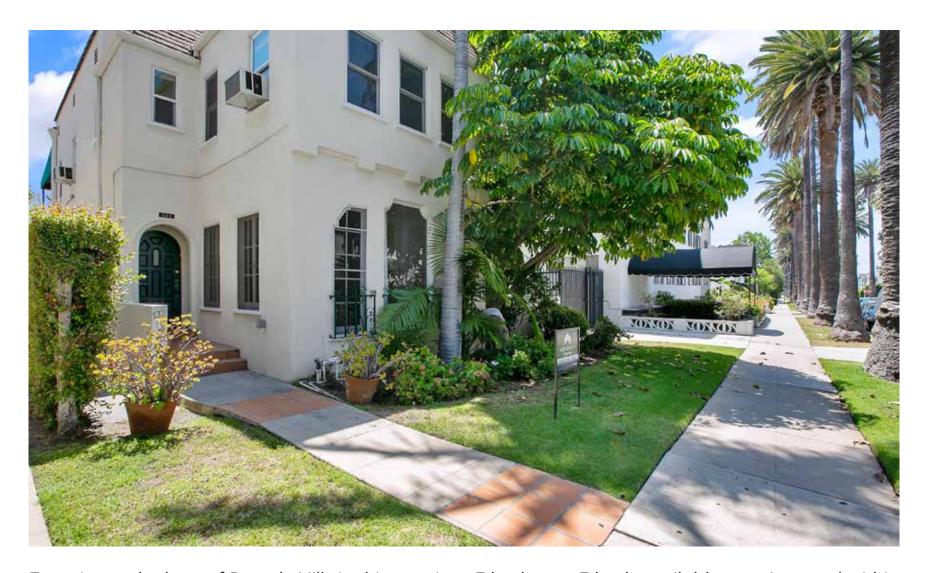
