

"Planning Commission Gives Go Ahead to One Beverly Hills" [Issue #1126]

Didn't we, the residents of Beverly Hills, already voice our opposition to a 26 storey tower in Measure HH, in 2016? Now we are looking at two towers, one 28 storeys tall and one 32 storeys tall in the overlay zone? This all feels like whiplash.

In the five years since voters nixed Measure HH, not much has improved in terms of climate crisis, drought, infrastructure issues, density, and traffic. What could the Planning Commission possibly be thinking, to okay these new massive structures? What does the city gain, besides increased water and infrastructure demand, and density? The pretty little park for the community is laughable – when half of it isn't even available to the public.

The community needs in-person meetings to discuss this. The members of the commission, and the members of the City Council, as lovely and well-intentioned as they are, need to tell us their relationships to the developer and to the lobbyists, consultants, and advocates. These relationships are germaine, and they matter to us. There's too much at stake – give us complete transparency.

Andrea Grossman Beverly Hills This communication concerns developments at various stages of approval in Beverly Hills Lots 12 and 13 and One Beverly Hills.

Understanding that the Planning Commission has held several public Zoom meetings regarding the development for One Beverly Hills and one Zoom meeting for Lots 12 and 13; I do not dispute that there have been opportunities for the public to ask questions and voice concern. However, given the turmoil of the past four years, Beverly Hills residents like the rest of the country are overwhelmed and exhausted. Is it any wonder why most of my family, friends and neighbors do not have the bandwidth to pay attention or as they say "Fight City Hall?"

These projects are massive and will have a great impact on our city and our individual properties and lives. Admittedly, I do not know enough about the projects including what the advantages would be for our city and residents. However, neither do most of my friends and neighbors. What I clearly understand is that these projects will impact us in the areas of density, traffic, noise, pollution, water, shadow, heat, and other environmental pollutants. There is not enough transparency nor adequate information for our residents to fully comprehend these issues.

One Beverly Hills was voted down by the city in 2016. The developer, Beny Alagem proposed one taller building instead of two smaller ones. The voters rejected the proposal.

As I understand the project and proposal today, Alagem is back this time with other investors and is developing all of the properties on the approximately 17 acre parcel. The units will be affordable only to the very wealthy. Several landmark structures including one of the towers and the pool will be demolished. In order to accommodate all of the residents, hotel guests, visitors to restaurants and bars, spa, attendees of the various events going on in the ballrooms, the conference center and outdoor areas, as well as staff; an underground parking structure for over 2,000 vehicles will be constructed.

Alagem's concession and "gift" to the city will be an eight acre "garden oasis." However, half of the gardens will be privately owned and not accessible to the public leaving 4.5 acres for public use. The project is estimated to take 50 months to complete which is equivalent to over four years. If the citizens of Beverly Hills voted down the proposal in 2016, isn't it the responsibility of our elected representatives to be certain that our residents are aware and informed about this massive development?

Lots 12 and 13, (the strip of land on Santa Monica Boulevard from Doheny to Civic Center) are a gateway for our beautiful city. When all we see are empty office and retail spaces, why would we need 11 new office buildings on such a narrow strip of land? Where is the consideration for our infrastructure? We are facing a climate change crisis – how will building on this strip of land impact that?

Many of our councilmembers have spoken or written about the balance between profit and preservation and our quality of life

In addition, several of you have spoken about the need for more affordable housing and bringing youth and families to revitalize our city as well as taking care of seniors and those less fortunate.

These developments do not appear to reflect any of these goals.

I am strongly requesting the following:

- A pause in any approvals or progress in moving these projects forward.
- Hold several town halls "in person" simulcast with Zoom for citizens to attend for the next few months.
- Send out emails, texts, and use robocalls to communicate the significance of these meetings along with information on where to learn about the projects and dates that the town halls will be held.
- Transparency regarding any prior relationships that anybody has on the Planning Commission or City Council with any of the developers either personally or professionally.

I am not naive to the financial burdens and needs of Beverly Hills. However, you were all elected to represent our interests which includes our quality of life and developing our city for the future. These projects if approved will change the landscape and the environment of Beverly Hills. Other than revenue, who is benefitting and how are we benefiting from these projects?

Our citizens need to be fully informed and understand what is at stake so we can all make these important decisions together.

Police Arrest Suspect in Robbery of Beverly High Students

Beverly Hills police arrested last Thursday a woman suspected of robbing two Beverly High students on their way to school earlier that week.

The students were returning to campus for an extracurricular activity when two women stole a necklace and attempted to steal a cell phone. No weapons were used during the robbery, police said.

Chakyra Sanford, 20, was arrested last Thursday morning and is being charged with robbery. Her bail was set at \$50,000 and her court date was scheduled for April 30 in Department 30 at the Airport Courthouse.

Police said they searched Sanford's car and home, where they discovered the stolen necklace. Police are still searching for the second suspect, as of press time.

Superintendent Michael Bregy, in an email, said the district is grateful to the Beverly Hills Police Department for making the arrest and recovering the stolen property.

"Both the City of Beverly Hills and the Beverly Hills Police Department work tirelessly to keep our community safe and we thank them for their ongoing partnership," Bregy said.

City Says Outdoor Dining Is Here to Stay

The City of Beverly Hills' "OpenBH" program, which allows restaurants to serve patrons outdoors even if they don't have patios, will likely be a mainstay of the city even after the pandemic is over.

Los Angeles County prohibited indoor restaurant seating throughout the majority of the pandemic, which negatively impacted restaurants' revenues as they were limited to takeout. But when the county allowed for outdoor seating, the city took the opportunity to allow restaurants to set up seating in non-traditional areas.

The OpenBH program allows restaurants to serve customers on sidewalks, in parking lots and in parklets. Many restaurants in the city have applied and been approved for the permit.

But even though the program was created with the pandemic in mind, the City Council unanimously voted Tuesday to extend it to the end of the year. This includes an extension of the waiver on applicable fees and costs associated with participating in the OpenBH program.

The Small Business Task Force, a group of local business owners and councilmembers dedicated to assisting businesses during the pandemic, suggested the extension at one of its meetings last year. Vice Mayor Lili Bosse and Councilmember Lester Friedman are the liaisons to the task force

One Beverly Hills Project Likely to Pay \$100 Million to the City

The Planning Commission will consider a development agreement for the proposed One Beverly Hills project Wednesday evening, which may include a \$100 million payment to the city.

Commissioners previously recommended the project for the City Council's approval on April 22. According to the commission's city staff report, it continued the public hearing to consider the development agreement on May 5 because it wasn't ready for consideration.

The city staff report states that the developer – Alagem Capital Group and Cain International – will pay a \$100 million dollar public benefit fee over the eight years after the agreement. \$5 million will be due within 90 days of the agreement.

The former Robinsons-May department store site, which now makes up one of the parcels of the proposed One Beverly Hills project, was previously owned by the Dalian Wanda Group. The Chinese multinational conglomerate had plans for a project at the site, but later sold to Alagem Capital Group and Cain International.

The group had been set to pay a \$60 million public benefit fee to the city, but the project never materialized.

If Planning Commissioners recommend the development agreement, the City Council will consider it for final approval at a future meeting.

Interviews Underway for New Assistant Community Services Director

The City of Beverly Hills is in the process of hiring a new Assistant Community Services Director.

Former Assistant Community Services Director Pam Shinault retired from the city last year.

Interim Assistant Community Services Director Patty Acuna provided an update on the hiring process in a Recreation and Parks Commission meeting last Tuesday. Community Services Director Jenny Rogers had not been able to attend due to another meeting.

Acuna said the first round of interviews were held in mid-April. Chair Susan

Mishler and Vice Chair Amie Sherry were part of the interview panel, according to Acuna.

"I believe that is step one of potentially a multi-step process," Acuna said. "So hopefully at next month's meeting, we might even get an announcement of our new assistant director but I'm not sure what the steps are."

Council Considers Temporary Art Installation

The City Council supported Tuesday a pop-up art exhibit, which would be featured at a vacant space on North Canon Drive.

The Next Beverly Hills Committee, Arts and Culture Commission and Human Relations Commission recommended the art installation titled "Visions of the Fu-

•Development Agreement: The applicant is seeking a development agreement with the City. Separate notice for a hearing on the Development Agreement will be provided after the Planning Commission has reviewed the Agreement and provided a recommendation to the City Council. The City Council hearing on the Development Agreement is tentatively scheduled for May 27, 2021.

The Overlay Specific Plan Project is a unified development plan that would allow for alternative site development of the 17.4 acre Project site than the development authorized by: the approved 9900 Wilshire Specific Plan (901,514 SF of future development that allows for the construction of up to 193 condominium units and a 134-room luxury hotel), the approved Beverly Hilton Specific Plan (973,565 SF in floor area including future construction of 110 condominium units and demolition and reconstruction of retail, restaurant,

meeting and office space) and the C-3 zoning designation applicable to the 9988 Wilshire Boulevard gas station property.

The proposed 1,933,436 SF One Beverly Hills Overlay Specific Plan Project includes the following components:

•162 residential unit, 499,806 SF, 32-story, 410' tall residential building (Santa Monica Residences)

•141 residential unit, 424,266 SF, 28-story, 369' tall residential building (Garden Residence



•37 residential unit and 42 hotel room, 213,966 SF, 11-story, 124' tall hotel/residential building (Wilshire Building)

•127,324 SF structure containing amenities and support areas, including 30 residential accessory spaces that could be used for staff housing (Promenade)

•37,562 SF, 31' tall conference center for the Beverly Hilton Hotel

•72,697 SF, 20' tall hotel restaurant, retail, 36 hotel room, and support area structure (Beverly Hilton Enhancement)

•12.7-acres of open space, including an 8-acre botanical garden, of which 4.5-acres will be public.

This project has been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the environmental regulations of the City. The City of Beverly Hills prepared a Final Supplemental Environmental Impact Report (SEIR) to analyze potential environmental impacts associated with the Project. The Final SEIR analyzes the following potential environmental effects of the Project:

•Air Quality •Land Use and Planning Biological Resources

•Biological Resources •Noise

Cultural ResourcesGeology/SoilsPublic ServicesTransportation

•Greenhouse Gas Emissions
•Tribal Cultural Resources
•Hazards and Hazardous Materials

Mandatory Findings of Significance

The Final SEIR impact analysis determines that, after mitigation, no significant environmental effects are anticipated except for: significant and unavoidable impacts to cultural resources (historic resources) and noise (in the event construction occurs outside the City's regularly permitted hours).

The City Council will consider the Final SEIR, and may adopt a resolution certifying the Final SEIR, adopting a Mitigation Monitoring and Reporting Program, and adopting a Statement of Overriding Considerations. The City Council will also consider whether to approve the proposed General Plan Amendments, Zone Text and Map Amendments, and conditionally approve the Overlay Specific Plan. As noted above, the Development Agreement will be formally considered at a public hearing to be noticed after consideration and recommendation by the Planning Commission.

At a Special Meeting on April 22, 2021, the Planning Commission of the City of Beverly Hills adopted three resolutions recommending to the City Council: a) certification of the Final SEIR under CEQA and related actions; b) approval of amendments to the General Plan to establish the One Beverly Hills Overlay Specific Plan Land Use Designation and clarify that the Project site is a gateway anchor location and adoption of an ordinance amending the Zoning Code text and map to include the One Beverly Hills Overlay Specific Plan zoning designation; and, c) adoption of the One Beverly Hills Overlay Specific Plan, subject to certain conditions of approval

Former Mayor Creates Bagel Scooper in His Mother's Memory

Longtime Beverly Hills resident Rita Brucker, who passed away in 2016, believed everyone should be able to enjoy a bagel with all of the schmear but less of the carbs.

Now her son, former Beverly Hills Mayor Barry Brucker, is releasing a product in her memory that'll let people do just that.

"Bubbie's Bagel Scooper" is a device that allows people to scoop out the inside of bagels but leave the outer crust. The patented product claims to reduce the calories and carbs of bagels by up to 50%.

Brucker, who owns several of his own patents, invented the bagel scooper with his mother before her passing. He said the experience brought them closer together.

"[Rita] created and patented her scoop [to] combine her love for bagels and her

love for living a healthy lifestyle," Brucker said. "We wanted to make the product not only useful, but we wanted to make it sort of a fun product and a legacy item for her."

Rita was around 89 years old when she began testing out the prototypes for the bagel scooper.

"We spent a lot of time testing out different size configurations and different patterns of tools to be as efficient possible," as Brucker said. [would] bring these to her house and sit around the breakfast room

According to Brucker, Rita passed away six months before the patent office awarded the patent for the bagel scooper. She never got to see it, but her name's on the patent because she was the primary inventor, Brucker said.

Recreation & Parks Programs Resume as COVID-19 Restriction Lift

The City of Beverly Hills' Community Services Department is revving up its in-person programming as COVID-19 health and safety restrictions slowly lift in Los Angeles County.

Several community services programs have already been underway, but had limited capacity or were conducted virtually due to the pandemic. Interim Assistant Community Services Director Patty Acuna said some of the programs are now increasing their pod sizes.

"At the start of the pandemic, we [had

a] coach or teacher ratio to children 2/10," Acuna said. "Those numbers have been increased now to a 2/15 or 2/20 based on the size and the occupancy numbers. Staff is currently working on some of the summer camps and increasing those numbers so that we can take children off of the waitlist.'

Acuna said that the city is hoping to add additional camps and potentially a reduced aquatic program. The program would take place in Beverly High's Swim Gym, which has been closed for the majority of the pandemic for

'Fingers crossed that the Beverly Hills [High School] Swim Gym will be open and ready to

start programming come June," Acuna said. "We should have a better understanding come next month when water gets put back into the pool and we see that it's functioning properly."

She added that the department is also looking to bring back the basketball program, though it may be relocated from Beverly High to Hawthorne School.

City Hall Reopens to the **Public**

Beverly Hills City Hall has reopened to the public, allowing for in-person appointments to be made across various city departments. Virtual services will also continue to be available.

Face coverings and symptom monitoring will be required to enter all city facilities in order to align with the Los Angeles County Department of Public Health protocols.

City Council and commission meetings will remain virtual until further notice.

Public Works Commission Proposes Ordinance that Impacts Single-Use Plastic Cutlery

The Public Works Commission has requested city staff to present an ordinance for the City Council's consideration later this summer that aims to reduce single-use plastic cutlery such as to-go cutlery at food service establishments.

If passed, the ordinance would require plastic cutlery to only be distributed upon customer request - a change that would help decrease environmental pollution as well as carbon emissions from manufacturing and disposal of plastic cutlery.

"This ordinance makes it simple for the community to eliminate one stream of single-use plastics – disposable cutlery, without much effort," said Public Works Director Shana Epstein.

Throughout the next several weeks, the city will host a series of informational public meetings regarding the proposed ordinance. The Public Works Commission is an advisory body and the ordinance would ultimately need approval from the City Council.

As Simpson meets with representatives of a major newspaper, he tantalizes them with a batch of correspondence between himself and Wallis Simpson in which she confesses her continued love for Ernest and her regrets over the disaster that her marriage to Edward became. While Ernest negotiates for the publication of his side of the story, he embarks on a relationship with Sheryl Adams, a member of the hotel's management who becomes an ally in his quest.

Ultimately, the question arises: is Ernest sincere in his wish to publish his tell-all book or is he using that possibility as a wedge to get from the Royal family the vindication and acclaim he feels he mer-



Retiring City Manager Mark Scott Looks Back on 40 Years in Municipal Government

By Ani Gasparyan

You're retiring after a career of almost 40 years in municipal government. How does that feel?

It feels very strange. My first job in local government was actually in 1971. It's been almost 50 years since I started. I've been doing this nonstop pretty much that whole time, except for a little foray in the American Airlines and going to [Stanford] business school. I don't know any other adult life than this. It does feel strange to stop. And I love it, so it's hard to leave.

Did you always know you wanted to work in city government?

I actually wrote a paper in fourth grade for a little Career Day thing that says I want to be a city manager. Of course, most people never heard of this. But I always had in the back of my head that I was interested in city work. So when I got to college and was looking for something to do, I took an internship. That was 1971 and [I] have been in local government pretty much ever since.

How did you first get hired in the City of Beverly Hills in 1983?

I was in Texas working for American Airlines [at] their headquarters. wife got pregnant our first child. We started feeling kind of bad being away from

family and so we looked at California.

There was this job they had that came up, that they were looking for an assistant to the city manager who had an MBA degree. That's unusual, they don't usually ask for MBAs. I thought, "Well, why not?" I had free flight privileges those days with the airlines. I hopped on an airplane, flew out for the interview, and they offered me the job before I left the building.

What were some of the key issues in Beverly Hills at that time?

One of the interesting things was that I got to the city just as they were deciding to build a Civic Center. In fact, it was in July of 1983, one of my first meetings. Architect Charles Moore came to a council meeting and gave the council his estimate of what it would cost to do this massive project. I remember [former Councilmember] Ben Stansbury was leading the charge at that time – that we needed to build this facility that would last us 100 years, he would say.

The council debated and debated whether they wanted to commit to such a project overtime and [it] prevailed. The city embarked on this multiphase effort to build the Civic Center.

That's ironic in a way because later on

in 1990, I became city manager only because the Civic Center project had spiraled out of cost control. There was a shake-up and I ended up the city manager to go over that same project that started two months after I arrived in Beverly Hills.

You helped launch the city's permit parking program as we know it today. Tell us about that.

We really set the tone for how it's done throughout the state. Part of it was because lots of it happened before I got there. It became a big deal. I tell people that when you're City Manager of Beverly Hills, you've got to be an expert on parking. People don't understand that, but it's

true. It's a big part of Beverly Hills life. Permit parking and downtown parking. I think we built something like 13 parking garages when I was in Beverly Hills.

You served as Beverly Hills City Manager from 1990 to 2003. How do you think working in Beverly Hills prepared you to work for other cities?

It was a great way for me to learn. People will say to me, "Beverly Hills must be really tough because people are used to being catered to and getting their way." And I say, "No, that's not really true." I don't find that Beverly Hills people are any more difficult than any other

People tend to judge their own lot

door is doing. Beverly Hills people are being involved in intellectual pursuits where they have debates and arguments. They're used to winning sometimes and losing sometimes. I actually found it easier to work in Beverly Hills than some cities where people don't know how to lose an argument.

Beverly Hills taught me how to work with communities [and] how to get consensus on difficult issues. It was actually in some ways safer than it was when I would get to Fresno - my hometown for instance – where you get some very complicated, difficult, challenging circumstances in the community because the town isn't quite so used to working together like the people of Beverly Hills

One of the first things that happened to me in Beverly Hills - we had a Planning Director at the time, Irving Kaplan. Quite a highly-regarded Planning Director. When I first interviewed him as a new employee, he said to me, "You're going to find that there's two Beverly Hills. There's Beverly Hills that the world knows and there's Beverly Hills that is real."

What he meant was it's not all the glitz and glamour. This is really a community. And it's a community where people know

each other. Beverly Hills' community is quite an extraordinary circumstance - I was very proud to have been there for so long.

You've worked in six other cities after Beverly Hills and are retiring from the City of Indio. How

does Beverly Hills civic government compare to other cities? It's more interactive. People in Bever-

ly Hills control their time more than people in other cities do. If somebody is on an 8 a.m. - 5 p.m. job, there's only certain times of the day that they can give you. People in Beverly Hills tend to control their own time and I think we had 30 City Council subcommittees when I was there. Most cities don't have any. Most city councils don't break up into constant subcommittee meetings.

So it was more complicated. Beverly Hills was more complicated. But it functioned well because the people that were involved were so capable. A city manager has to be more of the facilitator and sometimes even the convener in other cities, where people are not so used to working in that mode.

You hired many city employees who later became department heads, including City Manager George Chavez, former City Manager Mahdi Aluzri and former City Clerk Bryon Pope. How does it feel to see your protegees in positions of leadership?

Nothing better. Of all the things in my career that makes me most excited is seeing the successes that these differ-

in life by how the guy who lives next ent people have had. Not just in Beverly Hills, but in all the other cities as well. I think in every city, my assistant or a department head has followed me in the city manager role at some point. Maybe not immediately, but eventually.

> It's exciting to see that. It's exciting to see what George Chavez has done and what Mahdi Aluzri did. That's really one of the rewards of the work.

Looking back on your career, what are some of your most proudest moments?

It's the little stuff. I am so proud when I get to go to a retirement celebration or a retirement coffee or where they present a plaque or a cake or something to a retiree. Those are the proudest moments – when you see somebody leaving the job that they have spent their life doing and you can see the pride in them.

I love going to those because I like to say thank you on behalf of the community. Mostly, I want to say to them "Always think back about this and realize you did something important for your community and it mattered. Whatever the job was, it mattered because you were part of a team that will serve in the community."

That's the work we do. That's why I love it. I don't love it because we build things. I love it because we serve the community and we have a chance to make people's lives better. I have a hard

time leaving that role because of that. I'm proudest when I see employees get rewarded for what they've done.

What are your plans for retirement?

I wish I knew. There's a market for retired city managers,

believe it or not. When jobs are vacant, they will hire interim city managers to come in. Sometimes there's a challenge or two that needs to be tended to. I think I would enjoy doing that.


Since I've left Beverly Hills, I've really looked for jobs where there was a specific challenge for me to take on. I can still do that as interim city manager. Maybe six months a year I do [that], six months a year I watch reruns of "Family Feud" on TV or something I don't know.

Do you have any parting words for Beverly Hills Weekly readers?

I have parting words for [Beverly Hills Weekly publisher] Josh Gross. He's taken this paper and just done so much with it through the years. [It] became such an important part of the Beverly Hills community. He's been a friend to me for all of those years since I left and I thank
