

#### \$14,000 for Fern Pines Along **Beverwil Drive**

The Public Works Commission unanimously approved the placement of eight Fern Pine trees along the vacant lots on North Arden Drive at their July 8 meeting, but residents and business owners brought to the commission's attention during public comment that request tree replacements or removal from other sites that are damaging infrastructure mainly due to root

The \$14,000 project will fiscally impact the city but Urban Forest Manager Ken Pfalzgraf said he won't seek additional funding because the project's funding is included in the allotment designated to replacing trees in the community. The project now moves forward to the City Council for approval.

One public comment from Beverwil resident Kari Kramer expressed concern for the overgrown roots from a Ficus tree that has damaged the front of her property, as well as an additional request for the commission to consider.

"While you are cleaning up the block, I'm requesting that you please address the plantings in front of 419 Beverwil [Drive] that were privately planted and truly an eyesore," Kramer said.

As for the additional request not included in the original staff report to address the ongoing issue with private property, Pfalzgraf rebutted: "We do intend, with the commission's support, to put this on the City Council's agenda to seek their support and I would like to reference that we had the support of the [Public Works] commission."

"So what I'm hearing from the comments are people want their trees replaced but what I'm hearing from [Pfalzgraf] is you just want to go in and plant trees in the vacant slots," Commission Chair Charles Alpert said. "So why don't you want to go in and respond to the people who want their trees replaced? They seem to have legitimate reasons."

Pfalzgraf responded: "We can address that through the process but I think the first thing is rather than leave vacant sites, since we have an increasing number of those, we put new trees in and then once that is done we can deal with those other circumstances."

Residents can gather signatures and petition for tree removal or replacement, but the proposed sites will still go through an evaluation process and be reviewed. The evaluation process was put in place so the city does not unnecessarily cut down a healthy tree.

"When the neighborhood petitions for tree replacement and we have a certain percentage, then we can do that kind of whole replacement and do a master plan update," Public Works Director Shana Ep-

#### Will Residents Need Digital **Parking Permits?**

At the July 1 Traffic and Parking Commission meeting, BHPD proposed an all-digital parking permit program that would be linked to resident's license plates, making permits non-transferable and eliminating the use and distribution of preferential and overnight parking placards or rearview mirror tags. However, the implementation of this new digital program has to be approved by the City Council before going into effect.

As reported in Issue #1136, the City Council is expected to review the recommendations at their July 27 Study Session

#### **Historic Mural Under Investigation**

After a letter to the Editor in Beverly Hills Weekly Issue

#1136 brought attention to a historic mural in Beverly High's Swim Gym, Superintendent Michael Bregy doubled down on the Board of Education's plan to renovate the building's interior and add new school signage, estimating completion in late September. The BHUSD Board of Education has not made any final decisions in regards to the mural until they have concluded further investigation into the matter.

"There has been a lot of discussion about the mural, we believe that there is a lot to learn about the mural. I want to be really clear that there are no decisions at this point to tear anything down or to cover it," Bregy said. "It is still under investigation. I think that it's important that we learn a little bit more about it and that's what we continue to do."

ly need to talk about a painting right now. I hope the Board does not spend quality time together harboring on a painting," Margo said. #### **Rooftop Dining Permit Moves to City Council**

The Planning Commission unanimously approved the latest amended version of a Rooftop Dining Permit Request and Zone Text amendment to allow open air dining on the roof of 257 North Canon Drive at their July 8 meeting. The Beverly Hills Chamber of Commerce expressed support for the approval of the rooftop permit at

the previous Planning Commission meeting. Next, the City Council will be presented with the permit for approval.

The drafted rooftop dining ordinance includes guidelines such as any enclosed elements on the rooftop are not to exceed 15 feet and must be permanently affixed, as well as installing a living or non-living landscape buffer on the street side that does not exceed 42 inches in height.

The commission requested an Ad Hoc committee to form and make the amendments mentioned at their last meeting and represent it to the commission. Additional amendments from their most recent meeting includes clarification on audible music being limited to two live musicians, no singing, and or the same acceptable level of volume for background music. Another amendment was adding two more applicants for the newly proposed rooftop dining approval process, in addition to the three-story building permits.

"I was very happy with the proposed revisions that our Ad Hoc committee suggested, although I am very flexible on that," Commissioner Myra Demeter said. She also emphasized that their goal was to structure, not restrict, future projects.

As a result of the commission's June 23 meeting, the rooftop dining permit request included the creation of a permit process for rooftop dining approval. The commission also considered exempting this project from further review under provisions set by the California Environmental Equality Act (CEQA).

The City Council is expected to review the permit proposals at an August meeting.

#### \$1.7 Million Budgeted for Water Main Replacements

The City Council is expected to discuss a Water Main Replacement construction project to replace approximately 540 feet of water pipes between Summit Drive and Laurel Way, in addition to approximately 1,400 feet on Loma Linda Drive, at their July 15 meeting.

The existing pipes on Summit Drive and

Laurel Way were constructed in 1924. In exceeds the city's December 2017, the water main ruptured, leaving the water main out of service ever since. There was damage from flooding to the residential hillsides and impacted four properties. The original cast iron pipes, with an 8-inch in diameter, will be replaced by new 12-inch in diameter pipes made out of fusible High Density Polyethylene (HDPE) and Ductile Iron (DI).

The existing water main on Loma Linda Drive was constructed in 1974 out of cast iron. The new pipes will be made of

the new "resilient" materials: DI, steel or polyvinyl chloride (PVC) pipes. These new pipes will go from 6-inch in diameter to 8-inch in diameter.

A Water System Master Plan was established back in 2002 creating criteria that recommended replacing the city's water main between Summit Drive and Laurel way, and Loma Linda Drive

Both water main pipe replacements will increase in size and durability, made to, "en-

sure additional reliability and enhance the overall distribution of water flows in the area," according to the staff report.

The two street water main projects were combined into one single project granted to Ferreira Coastal Construction Co. The construction company bid \$1,554,091 and is not to exceed \$1,709,500.10 for project costs, including a 10% construction contingency allowance.

#### **Council Requested to Send** Letter of Support for AB 3

The City Council was asked by Assemblymember Vince Fong's (R - Bakersfield) office to sign a letter of support for his Bill "AB 3" for exhibition of speed on a highway to receive punishment. The council was scheduled to discuss AB 3 during their July 15 meeting.

Included in the bill are penalties for engaging in motor vehicle exhibition of speed, or participating in sideshows, with the penalties that come with illegal street racing. As a result of this bill passing, AB 3 would grant a court the ability to suspend a person's driver's license for 90 days to six months if convicted of taking part, or aiding and abetting, a motor vehicle speed exhibition. AB 3 will also grant the court abilities to restrict or limit a person's driving privileges during the suspension period to driving to and from work and places necessary for said job. Penalties such as these are equivalent to established laws against street racing.

From January to May, over 450 speed violation tickets have been issued by BHPD this year, according to their July 1 report from the Traffic and Parking Commission meeting. The Senate Public Safety Committee scheduled a hearing for AB 3 on July 13, but the City's Legislative Platform currently does not address matters in the assembly bill.

#### Second Story Approved; Mom's Moving In

The Planning Commission unanimously approved a second story housing unit that maximum of 14 feet in height to be built on top of an existing pool house at 507 North Oakhurst Drive at their July 8 meeting.

This new Accessory Dwelling Unit Use Permit will include bedrooms, two two bathrooms a kitchen and a floor area of 1,174 square feet, totaling approximately 2,186 square feet in total for the proposed-two-story unit. The addition's design will match the exist-

ing architecture as well as allow west-facing windows to be installed in either a fixed position or awning style. The commission allowed the applicant to install translucent, or frosted, glass to increase the amount of privacy between their neighbors but still let natural light in.

When the applicant presented to the commission, he expressed that this project would be necessary for his ailing mother to move in since he is her primary caregiver. But Commissioners Peter Ostroff, Myra Demeter and Gary Ross expressed concern about her living on the second floor and the potential danger of stairs and ADA ordinances, such as wide doorways, handrails, an accessible shower and or

"You should install an elevator, full stop," Ostroff said. "I'm in support of this project. It is consistent with our needs for more housing."

There was no mention of accessibility features such as an elevator in the original plans, but the applicant proposed installing an electric chair for the two sets of stairs or a lift, which has no restrictions. As a result, the commission requested a lift be added to the permit for when the applicant chooses to install it.

#### **BVMS Parking Lot Waiver** Approved

The Board of Education unanimously voted with one absentee, Board Member Mandy Stern, to approve a waiver for surplus parking at Beverly Vista Middle School for an option to expand parking

spaces for staff at their Tuesday meeting.

The District's Real Property Advisory Committee, or "7/11 Committee," presented a request for a waiver of Education Code section 17466 to instead submit a Request for proposal to seek a potential lease for a Beverly Vista Middle School's parking lot property rather than face re-

> strictions and number of other competitive parties that comes with tradition bidding auctions at the BHUSD Board of Education July 13 meeting.

> The committee's Request for Proposal comes after an April 27 board resolution that deemed the school's parking lot as "surplus" property. The committee seeks a potential lease agreement because, "the traditional auction would restrict the terms and conditions that the District could consider and may limit

the number of parties willing to submit a proposal for the lease of the Parking Lot Property," according to the staff report.

Included in the committee's proposed resolution are public notice and hearings, as well as a request to authorize the Superintendent as designee who is authorized and directed to submit a General Waiver Request to the state's Department of Education seeking the same waiver of the competitive bidding requirements under Education Code section 17466 et seq.


Some seating will be provided on a first-come, first-served basis, but the community is welcome to bring their own seating and blankets for the nearby grassy area. Picnics and packed meals are allowed and there will be food available for purchase at a local eatery. Parking is available adjacent to the gardens.

#### City Hall's Seismic Upgrade

The City Council is expected to review an agreement between the city and Raw International Inc., for architectural, seismic and engineering updates to improve City Hall Tower that will cost at least \$129,272, and is not to exceed \$640,737\$640,737, at their July 15 meeting.

In June 2018, the council previously approved Raw International Inc., to analyze the building's structure. They recommended strengthening the building due to age, configuration and, "inherent structural irregularities of the City Hall building," according to the staff report.

In order to seismically strengthen the building to withstand more powerful earthquakes or seismic activity, the contractors would break up the project into two phases: phase one will minimally impact

the existing tower and will increase the seismic performance of the Tower; phase two will address the remaining components necessary for a high level of seismic performance and can be done in the future.

#### **New Planning Commissioner Sworn In**

Gary B. Ross was sworn in as the newest member of the Planning Commission at their July 8 meeting. Ross began his term July 1. He is a partner at Ross & Morrison Law Firm and previously served on the Health and Safety Commission starting February 2014.

Ross' term will run through June 2023 and he takes the place of Commissioner Lori Greene Gorden.

"There's an old adage that everyone deserves a second chance and I really appreciate the city sticking with that and delivering me with a second chance as chair," Chair Andy Licht said, upon swearing Ross in.

One of Ross' first items to discuss and respond to was a Rooftop Dining Permit Request for the Business Triangle at 257 North Canon Drive and an Accessory Dwelling Unit Use Permit. He abstained from the Rooftop Dining Permit Request

Planning Commission's meeting was continuing virtual meetings through August. However, they came to a consensus that if the governor does not extend the Telecommuting Exemption of the Brown Act, the commission would return to in-person meetings. Masks would be optional for those who are fully vaccinated. City staff have been advised to wear masks at work to err on the safe side, but are not required.

#### Six of Eight Commissioners Join Community Advisory Committee

After the Feb 1. Public Works meeting, where a Climate Action and Adaptation Plan (CAAP) was presented to the commission, commissioners are starting to join the Community Advisory Committee (CAC) that is included in the plan to engage and inform the community about projects, more specifically, analyze details and provide feedback for the final CAAP before it is presented to the City Council at an upcoming August meeting.

So far, Recreation and Parks Commissioners Myra B. Lurie and Alissa Roston, Public Works Commissioners Wendy E. Nystrom and Sharona R. Nazarian, and Traffic and Parking Commissioners Lisa Kay Schwartz and Vice Chair Sharon W. Ignarro has been appointed to represent their commission and serve on the CAC. Representatives on the committee will be charged with ensuring there is a successful

CAAP put in place.

CAC members will meet four times throughout the process and because of the community-wide invite, these meetings are expected to increase interest, participation and engagement from the community.

Some goals that the CAAP's final plan will include achieving carbon neutrality, meaning the city will aim for net-zero carbon dioxide emissions, through capital investment and new or modified policies and programs. The purpose of the CAAP is to create a community-wide decrease in greenhouse gas emissions to reach carbon neutrality by 2045.

Of the 15 members in the CAC, 10 of those positions will include two commissioners each from Public Works, Planning, Traffic and Parking, Recreation and Parks and Health and Safety commissions. The remaining five seats are open to the public, but community members must submit an application by Aug. 6. Those interested in serving on the CAC can apply online or visit their webpage for more information.

# **Nearly \$2 Million in Grants for 22 Agencies**

The City of Beverly Hills' Community Assistance Grant Fund (CAGF) awarded nearly \$1,922,499 million to 22 local agencies who provide social services directly to those who are hit hardest in the community, such as homeless individuals, at-risk populations, older adults, diabled individuals and low-means residents.

Some recipients of the CAGF include: Affordable Living for the Aging, All Saints' Homeless Assistance, Beverly Hills Active Adult Club, Beverly Hills CPR, Beverly Hills Education Foundation, ETTA, Jewish Family Services, Miracle Project, Saban Community Clinic, The Maple Counseling Center, Theatre 40, Tower Cancer Research and the Wallis Annenberg Center for the Performing Arts.

Three organizations were nominated for the first time this year: Safe Parking LA, OUR HOUSE Grief Support Center and Collins & Katz Family YMCA. Step Up on Second's Homeless Outreach received an increased budget to the team to extend their hours, an additional geriatric social worker to be contracted through the Jewish Family Service and an increased budget for the Westside Food Bank.

Through the CAGF, the city created a social services safety-net continuum of care that increases accessibility and availability of services to community members across several different providers and programs.

To be considered for the CAGF, the

agency must be an existing Beverly Hills organization, has demonstrated previous cultural opportunities that meets a community need, as well as meet four criteria: the organization must provide a unique service that addresses an unmet need of the community that is not a duplication of an existing agency; the organization does not rely on community assistance funding to stay active and their services would cost more to the City if they provided them directly to the organization;

the organization must prove a service that supports the City's commitment to providing a social service safety net that conveys the safety, health and welfare of community members; and the organization must provide regional services that enables the City to meet it's regional obligation to help improve social issues.

#### Golden Shield Award Nominees

Six nominees were presented to the Cultural Heritage Commission at their July 14 meeting, three of whom were selected to be this year's nominees: Pioneer Hardware, The Luau and Harry Harris Shoes.

The commission came to a general consensus with one absentee, Commissioner Josh Flagg, for three award nominees for their local historical significance and being some of the longest running businesses in the city.

Although made out of bronze, the Golden Shield Awards are given to sites, structures, business and other public places that celebrate unique and historical significance around the city. The commission suggested adding original locations or sites where the business has previously been for context and more details on the plaque's recipient.

At the commission's June 30 meeting,

Landmark Nominations Subcommittee proposed six nominations for this year's Golden Shield Award: Pioneer Hardware, Hunter's Books, Harry Harris Shoes, Pixie Town, The Luau and Hans Ohrt Lightweight Bicycles.

To be considered for the award, the nominee must meet the following criteria: it exemplifies a certain way of life that helps strengthen the city's economy by being formally recognized; it promotes public appreciation and civic pride; it possesses artistic or aesthetic qualities or represents the unique characteristics of a certain style of architecture, period and method of construction; it's associated with community members, businesses or institutions or important events of cultural significance; is in a unique location with a singular physical characteristic, educational value, or is prominent within the community's landscape and culture; and the award's recognition is expressly agreed to by the owner(s) of the nominated property.

#### LA Apartment Association Urges Council to Cancel Eviction Moratorium

The Apartment Association of Greater Los Angeles (AAGLA) sent a letter to Mayor Robert Wunderlich and the City Council on July 12 urging them to end all emergency ordinances related to eviction moratoriums and rent increases under the Urgency Ordinances put in place last March in response to the pandemic. The City Council was initially planning to discuss the ordinance at their July 15 meeting.

The city's Urgency Ordinance provisions include: an eviction moratorium for not paying rent, tolling of no-fault eviction ordinances and a prohibition on rent increases in favor of the state's existing eviction moratorium that was recently extended through Sept. 30.

"Should the economic recovery be delayed or reversed at any time, the City Council has an immediately accessible mechanism to address those changes and provide needed council," the letter from AAGLA said. "Thus, [the] City Council is able to remove the Urgency Ordinance provisions now without substantial exposure to potential changes in economic circumstances moving forward."

According to the staff report, the Council was scheduled to have a quorum with the city's Rent Stabilization Commission during their July 15 meeting to consider how they should address residential evictions for those who have not paid rent due to COVID-19.

The AAGLA cited foreclosures or forced sales of smaller housing providers will force these property owners to, "permanently exit the housing industry."

"As a result," the letter said, "much of the most affordable housing in the City will be permanently lost with luxury apartments or condos taking their place."

# **Embrace Civility Award Applications Open**

The Human Relations Commission announced they are accepting applications for the 10th annual Embrace Civility Award for 2021 at the Mayor's Cabinet

Meeting on July 10. The award recognizes individuals in the community who acts as a positive role model of positive behavior, supports respect and responsible actions and promotes positive neighbor to neighbor relationships.

Applications can be found at the Farmer's Market, Beverly Hills Public Library or available for download online at their website. Applications for nominations will be accepted until Sept. 3.

The awards are not limited to one individual recipient; The 2020 Embrace Civility Award recipient was Beverly High senior Thomas Recupero, who served as Student Board Member for BHUSD's Board of Education, accepted the award over Zoom last October. In 2017, Ida Nalbandian and Karen Setian were recipients of the Embrace Civility Award for raising

awareness of distracted drunk diving with the Every 15 Minutes program and Vahagn Setian Charitable Foundation.

# Over \$12,000 Budgeted for Two New BHHS Consultants

For the upcoming school year, the District will hire two new independent consultants contracted for Beverly High's College and Career Center and KBEV Studio Installation Project.

Soo Hyun Lee will service Beverly High's College and Career Center as a video consultant from Aug. 10 to June 3, 2022. Lee's main charge is to provide video content creation for the College and Career Center's services. His fee for the term has a budget that is not to exceed \$7,200 and will be sourced from the CTE.

Former Media teacher Dave Stiles was contracted by the District to engineer, wire and provide digital equipment maintenance for the KBEV Studio Installation Project and will be contracted from July 1 to June 30, 2022. Stiles' fee for the term is not to exceed \$5,000 and will be funded by the high school's General Fund.

Stiles was Beverly High's KBEV program director from 1970 to 2005 before he retired. He will be their consultant and provide technical services, repair and maintain the high school Media Center's audio and video equipment.

As the city continues to reopen and update safety guidelines, the District's new contractors are required to comply with local and state COVID-19 ordinances and regulations, such as social distancing, staggered start times to decrease congestion, self-monitoring symptoms and staying home whenever feeling ill.

#### Trousdale Home to be Considered as Historical Property

At their July 14 meeting, the Cultural Heritage commission unanimously approved with one absentee, Commissioner Josh Flagg, to move forward with a proposal for the initiation of landmark proceedings to determine the eligibility of the property located at 1010 North Hillcrest Road to be placed on the Beverly Hills Register of Historic Properties.



1010 North Hillcrest Road

To be considered or recognized as a historical local landmark, the property must meet several criteria including: being at least 45 years old or of extraordinary significance; possessing high artistic or aesthetic value with distinctive characteristics and architectural style; [potentially] exceptional design to be done by a master architect; said [potentially] exceptional design was occupied and owned by individuals with great local prominence; along with going through the proper channels of notifying neighbors and the public.

The property in Trousdale Estates was completed in 1959 and designed by John Elgin Woolf, who is on the City of Beverly Hills List of Master Architects. The residence was originally built for prominent Southern California real estate developer

Paul W. Trousdale and his wife, Jean Trousdale. The two lived in the 5,500 square foot Hollywood Regency style estate for 30 years.

The Trousdale home is currently listed on the market for \$23.5 million and features three bedrooms, seven bathrooms and a pool on a three-quarter acre lot.

In order to complete the landmark designation process, the Cultural Heritage Commis-

sion will set a special meeting date before their Aug. 27 scheduled meeting so the nomination and Preliminary Evaluation hearing can be conducted before then to comply with the municipal code. With the commission's formal recommendation, this will move to be presented to the City Council for approval at their upcoming meeting.



It lasted for about six weeks and then he asked me to be his manager. I said, 'well, I know how to manage things.' I had over 300 employees [at the bank]. I said, 'I don't know if I know anything about the restaurant business and he said, 'If you know how to manage that you'll be able to do this,' and he just taught me how that particular location works and from then on it was like, 'you know what? I kinda like this, this is great!' And I've been in it ever since.

#### How old were you when you made that transition, that career change?

Let's see, I was probably mid to late

In a past interview with **Beverly Hills** Weekly Issue #1030, Kallick said she has seen both small and large businesses and the community in Beverly Hills grow and "become more and more visible and prominent." Is that still the case, even as we reopen after a year of COVID related closures?

Oh definitely, definitely. There were a lot of places that closed, but now that the city is opening up, all the signs that say 'For Lease' or that were all boarded up, they're coming down and now so-and-so is moving in and I'm like, 'ah that's great!' and there's a new shoe store that's opening up. Restaurant after restaurant are starting to open up so it's coming back faster than I thought it would. But, traffic is getting thicker

which means more people are coming to the city now, so it's taking me at least 10 to 15 minutes to get to work. It's still all good! I enjoy the crowds, I mean I work at The Grill [on The Alley] and it's packed with people and people right now are complaining that they can't find employees to work in the restaurant business and I have had absolutely zero problems finding employees. I just hired four new servers and three kitchen workers and a bartender. There were about six or seven people I had to turn away going, 'I'm full staffed right now, I don't have the room,' and everybody around me is complaining, saying, 'I can't find any staff!' I said, 'here take these people, here are some applications. I don't need them.' I'm just blessed with people actually coming to my front door who were qualified. So, the city is really coming back, it's really happening.

#### What is one single biggest challenge facing Beverly Hills businesses today?

Well, I guess I would have to say, and this is going to sound kind of biased, but if you are not part of an organization like the chamber or Rotary Club, you know things like that, those are the things that are going to connect you. If you don't make connections in Beverly Hills, it's going to be hard to get your business going because everybody here is like Mayberry, USA. You can walk next door and borrow a cup of sugar and sit out on your porch and say 'Hi' to your neighbor across the street. That's how it really works here and if you can't make those connections then I see businesses that just close up saying, 'I don't have the foot traffic,' or 'I don't have the port or people don't know my business so how am I supposed to get this going?" It's like, 'well, you got to do a little bit of the work and get out.

#### What do you hope to achieve during your time as Chairman of the Chamber of Commerce?

To get those people that aren't connected, connected. Because I walk these streets here and try to stick my nose into everybody's front door to say 'Hello' and see what it's all about and pass out my business card to let them know where I am and I talk about the chamber. And now that I have the [Chairman] title behind me and the support it's even better. Most people in town know me now before I even know who they are. I'm just walking down the street and they've already seen a few pictures of me and they're like, 'oh, hey it's you. Congratulations!' and I'm like, 'yay, who is that, I have no idea but they know me.'

#### Coach Details Progress by BHHS Football Team

Coach Marquis Bowling said the Beverly High football team has "created a little bit of a buzz" as it prepares to play for the first time since Nov. 1, 2019.

"I want people to know that the Norman football program is making its first steps toward redemption," said Bowling, who has been Beverly Hills' coach since spring 2020. "We have a reputation and I think

that we're in the process of changing people's opinion. I think they're going to be surprised by what they see."

Bowling credits Tim Ellis, the Beverly Hills Unified School District's director of district athletics, and Kelly Park, a physical education teacher at Beverly Vista Middle School, for getting students interested in the football program, which has long struggled because of a lack of play-

Bowling said 35 players have committed to play for the team, with an average of 27-30 participating in each practice, a figure he said he is "ecstatic" about.

The Normans have had nine consecutive seasons of three victories or less, including 2019 when it was 3-7. Plans to play a four-game schedule in March and April were dropped because Bowling had to leave the area because of the death of a relative, he said.

Beverly Hills is scheduled to open its season Aug. 27 by playing host to Maranatha at Nickoll Field.

The Normans "did really well" in a four-way joint practice with Santa Monica, Brentwood and Hamilton July 1 at Brentwood, Bowling said.

"We executed our routes well, completed passes and we defended really well, especially in the red zone," Bowling said.

Quarterback Will Harris "threw the ball really well" and ``so did our freshman quarterback, Matthew Recupero," Bowling said.

Brothers Taylor and Connor Saul, who are both defensive backs and receivers, ``played really well," and Nathan Yashouafar ``surprised us," catching ``a couple of passes," Bowling said.
