### Suspect in the Jacqueline Avant Homicide Pleads Guilty

On March 3 Aariel Maynor, arrested and charged with the murder of Jacqueline Avant, pled guilty to one count of first-degree murder, one count of attempted murder, one count of possession of a firearm by a felon, and two counts of first-degree residential burglary.

On Dec. 1 Maynor broke into the Avant's Beverly Hills home and fatally shot Jacqueline Avant. He also shot at a security guard, who was not injured. In the early morning hours of Dec. 2, Maynor was arrested by LAPD after he sustained a self-inflicted gunshot wound during the commission of a burglary in the City of Los Angeles.

"We are pleased to see Maynor will remain behind bars where he belongs. Our thoughts continue to be with the Avant family," Chief Mark Stainbrook said.

Beverly Hills Police Detectives were present at the March 3 court hearing.

"To the Beverly Hills Community, let me reassure you, this is one of the most protected and patrolled cities in the world. Crime of any kind will not be tolerated here. Let this be a message to anyone thinking of committing a crime in Beverly Hills – you will be caught and brought to justice," Chief Stainbrook said

at the time of Maynor's arrest.

BHPD said this investigation will remain open with the Beverly Hills Police Department until Maynor is sentenced.

### Planning Commission Expected to Rule on Time Extension for Wilshire Boulevard Project

The Planning Commission is expected to rule on a request for a one-year time extension for a previously approved Conditional Use Permit and Historic Incentive Permit to establish a 154-room hotel, with restaurant and ancillary uses, within an existing 10-story office building located at 9111 Wilshire Boulevard, at their Thursday meeting.

The project site for the complex was formerly home to the corporate head-quarters for Gibraltar Square Savings and Loan and Kate Mantilini restaurant. The Kate Mantilini space, which closed for business in 2014, will reopen as a restaurant.

The project was approved by the commission on Jan. 23, 2020. The project required the approval of a Conditional Use Permit to allow hotel use in a commer-

cial zone, which also included a request for off-site parking and modified loading spaces. Additionally, the project required a Historic Incentive Permit to allow deviations from certain development standards.

The approved project included a request to change the eastern portion of the adjacent alley from a one-way to a two-way alley. Any change in the direction of an alley requires City Council approval. On May 19, 2020, the City Council approved a change of direction to the eastern half of the alley.

Both the Gibraltar Savings building, a 1959 structure designed by noted architecture firm Victor Gruen Associates, and Kate Mantilini, originally built in 1968 and redesigned in 1985 by renowned architects Thom Mayne and Michael Rotondi of Morphosis, were declared official city landmarks by Beverly Hills in 2016.

The project site was designated as Landmark No. 30. The designation included the following three contributing landmark components: one-story with mezzanine, Banking Hall and Tower Base built in 1958 and designed by Pereira and Luckman; Cantilevered Office Tower, built in 1959, also designed by Pereira and Luckman; and one-story with mez-

zanine, Kate Mantilini building redesigned by Morphosis in 1986, originally constructed in 1968 as the National Bank building.

The project has not changed since it was originally approved and the applicant is not seeking any modifications.

## **Candidates File for City Council**

As of Tuesday, with a Friday deadline, the following candidates have filed for the June 7 City Council election: Kevin Kugley, who is the owner of Beverly Hills financial firm, Kevins7, and Councilmember John Mirisch. Last week the following candidates filed: Beverly Hills Freedom Rally founder Shiva Bagheri, attorney Darian Bojeaux, Councilmember Lester Friedman, Planning Commissioner Andy Licht, Public Works Commissioner Sharona Nazarian, and Mayor Robert Wunderlich. Incumbent Howard Fisher and Jake Manaster have filed for City Treasurer.

### Traffic and Parking Commission Approves Preferential Parking Permit Zone

At their March 3 meeting the Traffic and Parking Commission discussed and

approved establishing a preferential parking permit (PPP) regulation on the 500 block of North Arden Drive, south of Park Way to North Santa Monica Boulevard, as follows: "No Parking, 8 p.m. to 2:30 a.m., Daily, Permit 'O' Exempt."

The 500 block of North Arden Drive currently

does not have a parking regulation aside from the City's overnight parking prohibition between 2:30 a.m. to 5 a.m.

In March 2020, a qualifying petition signed by 100% (4 of 4) of the households on the 500 block of North Arden Drive, south of Park Way to North Santa Monica Boulevard, was submitted requesting an evening PPP regulation of "No Parking, 8 p.m. to 2:30 a.m., Daily" to address commuter parking impacts from West Hollywood businesses.

The regulation request is consistent with the existing Zone "O" evening regulation on the 500, 600 and 700 blocks east of North Arden Drive to Doheny Drive.

The 500 block of North Arden Drive between North Santa Monica Boulevard and Carmelita Avenue is approximately three quarters of a mile in length with 25 households and 54 parking spaces. The street block is divided by Park Way and includes four of the 25 households and approximately 12 on-street parking spaces.

Permit Zone 'O' was originally established in 1982 on the 600 block of Oakhurst and Doheny Drives to address evening parking impacts generated by

commercial and entertainment activity in West Hollywood. Starting in 2011, the 500, 600 and 700 blocks between North Alta and Sierra Drives successfully petitioned for day and evening parking regulations expanding Zone "O."

The permit was approved for the following reasons: 100% resident support from the project area; impacts from commuter vehicle parking; minimal parking impact on neighboring streets; and consistent regulation to match with neighboring Zone 'O' street blocks.

The cost to install new signs is approximately \$1,100 for materials and labor.

### Traffic and Parking **Commission Approves Motion to Join National** League of Cities

The traffic and Parking Commission approved a motion recommending that the City Council adopt a resolution joining the National League of Cities (NLC) "Safety First Challenge" and support a Safe System approach to eliminate serious injury or fatal crashes, at their March 3 meeting.

More than 20,000 people died on the nation's streets in the first half of 2021, according to the U.S. Department of Transportation (USDOT). This mortality

rate is an increase of nearly 20%

To address this matter, the NLC announced the Safety First Challenge initiative. Its goal is to build a coalition of more than 100 cities in the first 100 days of 2022 that want to advance a safety first approach to transportation decisions.

"The initiative aims to focus on efforts that will save lives, decrease crashes, and improve safety for everyone on streets and sidewalks. The Safety First Challenge also promotes the use of a "Safe System" approach to road safety," according to the staff report.

City staff has initiated the application to join the challenge with the following statement of purpose, "The City of Beverly Hills strives to improve the safety of all roadway users. Following the adoption of its first Complete Streets Plan in April 2021, the City is excited to participate in the 'Safety First Challenge' as we implement programs and projects that embrace safe mobility for all modes of trav-

Agencies that choose to participate in this challenge are asked to commit to taking at least one "challenge action" intended to advance street safety.

Some of the actions the City is currently taking include: piloting a bicycle safety project with the protected bike lane on the 400 block of South Roxbury Drive adjacent to Roxbury Park; the Neighborhood Slow Streets program; and the Complete Streets Plan.

The City is also planning on implementing software to compile and analyze traffic collision data to identify and address traffic safety risks

### **City Council Meetings to Return In-Person**

At their March 1 meeting the City Council unanimously approved the return of in-person City Council meetings beginning Tuesday, March 15, with the option for the public to still watch and comment virtually at beverlyhills.org.

Commission meetings will begin returning in-person later this month based on noticing requirements.

### **City Council Extends OpenBH**

At their Tuesday Study Session the City Council discussed and recommended the extension of the temporary OpenBh program to the end of this year.

The City created the OpenBH program in June 2020 to allow businesses to temporarily expand their services to adjacent outdoor areas such as private parking lots, sidewalks, and metered parking spaces, otherwise known as parklets, through a no-fee Special Event Permit. This was in response to the pandemic.

Since the program's creation, 136 businesses have received a permit to participate in OpenBH. Currently 85 businesses are using the OpenBH program to provide services outside, of which 74 are restaurants or hotels. The remaining 11 Open-BH permit holders include retail stores,

#### AN AMENDMENT TO THE GENERAL PLAN TO ADOPT AN UPDATED SAFETY ELEMENT

This project consists of an update to the Safety Element of the General Plan of the City of Beverly Hills. State law requires that every jurisdiction's General Plan includes a Safety Element to address the mitigation of short- and long-term risks resulting from disasters such as wildfire, flooding, and earthquakes. The City's current Safety Element was last updated in 2010, and is now being updated to include a Climate Vulnerability Assessment, which addresses the issues of climate change adaptation and resiliency, in compliance with recently adopted state laws. At this public hearing, staff will present an update on the status of the Safety Element Update, including revisions made to the Safety Element and the review process with state agencies. Staff seeks input from the Planning Commission and the public on this topic, and the Commission will consider adopting a resolution to recommend the adoption of the Safety Element to the City Council at a future public

This project has been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA, Public Resources Code Sections 21000 et seq.), the State CEQA Guidelines (California Code of Regulations, Title 14, Sections 15000 et seq.), and the environmental regulations of the City. Upon review, the project appears to qualify for a Class 8 Categorical Exemption (Actions by Regulatory Agencies for Protection of the Environment) in accordance with the requirements of Section 15308 of the State CEQA Guidelines, which is applicable to actions taken by regulatory agencies, as authorized by state or local ordinance, to assure the maintenance, restoration, enhancement, or protection of the environment where the regulatory process involves procedures for protection of the environment. This project consists of the adoption of new or updated regulations related to the protection of the environment through the mitigation of natural and manmade hazards. Accordingly, the Planning Commission will consider a recommendation to find the project categorically exempt, pursuant to Section 15308 from further environmental review under CEQA.

houses of worship, COVID testing sites, and salons who are continuing to use the program to provide outdoor services or line queuing.

# Two Men Sentenced in Hate Crime Attack

Two Los Angeles County men on Monday were sentenced to federal prison on conspiracy and hate crime charges for attacking five victims inside a Beverly Hills Turkish restaurant on the 300 block of South Beverly Drive in 2020 while shouting ethnic slurs, hurling chairs at the victims, and threatening to kill them.

William Stepanyan, 23, of Glendale was sentenced to five years in federal prison, and Harutyun Harry Chalikyan, 24, of Tujunga was sentenced to 15 months in prison. Both defendants pleaded guilty in Oct. to one count of conspiracy and one count of committing a hate crime.

In Sept. 2020, long-simmering tensions in Turkish and Armenian communities escalated worldwide – including in the United States – in response to a war breaking out between Armenia and Azerbaijan.

The defendants attacked the victims inside the restaurant on Nov. 4, 2020, because of their anger about Turkey's support of Azerbaijan in its conflict with Armenia, according to court documents. Earlier that day, Stepanyan sent a text message saying that he planned to go "hunting for [T]urks."

That evening, the defendants drove to the restaurant with a group of approximately nine individuals who planned to demonstrate outside the establishment because they considered it symbolic of Turkey. Upon arriving at the restaurant, Stepanyan and Chalikyan stormed inside, threw hard wooden chairs at the victims, smashed glassware, destroyed a plexiglass barrier, and overturned tables. One of the defendants asked the victims, "Are you Turkish?" and shouted, "We came to kill you! We will kill you!"

During the attack, three victims were injured, including one individual who lost feeling in their legs and collapsed multiple times due to the injury. Stepanyan also ripped out the restaurant's computer terminals and stole a victim's iPhone.

The attack caused at least \$20,000 of damage to the restaurant and physically injured multiple victims.

"These defendants were driven by hate, and their actions were deplorable. The physical injuries and emotional trauma to the victims cannot be understated. We hope that the sentences handed down today will help vindicate those harms," United States Attorney Tracy L. Wilkison said

The defendants were ordered to pay \$21,200 in restitution.

### Rent Stabilization Commission Discusses Habitability Standards

At their March 2 meeting the Rent Stabilization Commission discussed possible amendments to the City's Rent Stabilization Ordinance (RSO) regarding Beverly Hills habitability standards, proactive inspections, an administrative board to

address habitability violations and associated rent reductions, and to restrict rent increases for properties with habitability violations.

On Feb. 2, the commission was presented with reports on possible amendments to the RSO regarding Beverly Hills habitability standards; proactive inspections; mediation/administrative board to address habitability violations and associated rent reductions; and to restrict rent increases for properties with habitability violations

State regulations provide habitability standards. The City Council discussed that these standards are limited and suggested standards that exceed the state standards.

Beverly Hills currently has a complaint-based inspection process. The City Council discussed a proactive inspection process. Two types of proactive inspections that could be implemented are: a self-certification process or a proactive inspection process.

The Commissioners requested additional information regarding: the designation of habitability cases, and State law regarding tenant's responsibilities.

According to California law, a landlord must put a rental unit into a habitable condition at the beginning of the tenancy and make repairs throughout that are needed to keep the unit habitable. A landlord will also have no duty to repair, if the tenant substantially violates any of the following affirmative obligations or interferes substantially with the landlord's obligation to perform the necessary repairs: to keep the part of the premises which the tenant occupies and uses clean and sanitary; to dispose of trash from the unit in a clean and sanitary manner; to properly use and operate all electrical, gas and plumbing fixtures and keep them clean and sanitary; not to willfully destroy, damage, impair or remove any part of the structure, unit, or facilities, or equipment; and to only use those portions of the premises for living, sleeping, cooking or dining purposes that were designed for or intended to be used for such purposes.

The Commission approved a motion to recommend to the City Council that the City Council establish a proactive habit inspection program with an initial baseline inspection of all RSO units with units assigned to a tier based on the baseline inspection with three tiers. Tier 1, 2 and 3. 100% of units in tier 3 would be inspected every two years and 50% of the units in tier 2 would be inspected every four years and 25% of the units in tier 1 would be inspected every six years. A baseline inspection would also occur for any unit upon change of ownership. Landlords and tenants would share the cost of the proactive inspection program equally 50/50. The habitability inspection proactive inspection program is based on standards of habitability established by state law. There would be a prohibition on rent increases at such time a habitability violation is identified, until it's been cleared. And that the Rent Stabilization Commission be established as an administrative hearing board to determine rent reductions related to habitability violations.

And that the City Attorney's Office be directed to bring back a resolution setting forth these recommendations in resolution form to be presented to the City Council.

The motion was approved in a 4-2 vote with Chair Donna Tryfman and Commissioner Lou Milkowski voting against the motion.

The Commission will formally approve the motion at their next meeting.




#### Tell me about yourself.

None of the celebrities will ever let you know they are wearing a wig. Half of them won't let you like yourself. It is art back that they feel like know mey are going through breast cancer because they are worried that the network

will think it's affecting their work. My celebs don't want people to know. My normal women don't want people to know. They want to feel comfortable. So, what I try to provide is not only personal guidance and education but, what do you do when the wind blows? Do you stop dating? What do you do when he reaches his hand behind the nape of your neck and he's going to feel your wig? What do you do? That's why I wrote Sex, Wigs and Whispers: Love And Life With Hair Loss, available on Amazon. I keep

on giving women what they need to get them through all the challenges. That's why I just dropped 73 videos on Youtube. I don't care if you live in LA and can afford me, or you can't afford me. You need to know how to make whatever you can afford work for you. So what I am really committed to is making sure that whoever you go to, that you have the answers and guidance you need so that you're comfortable. And you know how to live a normal life like every other woman who is going out dating, playing golf, or going to work. There are plenty of women who stop their lives completely because of losing their hair.

#### You founded CreatedHair by Amy Gibson. Tell me about that.

CreatedHair was founded 21 years ago to help women on their journey from hair loss. Giving them all the tools they need. It's a company that is online and has a studio in Beverly Hills. We are very discrete. I don't give the address out unless I have your photo and I know what you need and I have what you need. I don't waste vour time or mine. We don't give the address out until I found out who you are. There's just too much going on in Beverly Hills right now and around the country when it comes to hair, that I really only want to help people that are very authentic.

CreatedHair was really founded from my own journey through hair loss. And my commitment to giving a woman's life back. That's what https://createdhair. com/ and salons do. We just moved to Beverly Hills to a private address. We were on Wilshire Boulevard at the Corridor for 20 years and I wanted something even more private. You walk in and it feels like a big home. It's not like a big store. It's like a private studio. And we only see one person at a time. You won't bump into anyone you know. I am really into discretion. This town is filled with gossip. That's the one thing I won't ever allow, to have my client be vulnerable to

### Tell me about your soap opera career.

I started out on Love of Life at 13, which is when I started losing my hair. I was in the hair and makeup room and they said 'let's try to brush your hair and do your makeup.' And the stylist says 'you know you have a bald spot in the back of your head that is the size of the palm of your hand.' I thought he was kidding around with me and he goes

'no, you really need to see this.' And he showed me in the mirror. I thought 'what is that?' I must have watched some sort of documentary on leprosy or something because the very first thing I thought was that I was going to lose my arm. I started to go into a spin. I was 13 years old and I went into this huge emotional spin. My aunt who is a very famous singer, her name is Georgia Gibbs, she knew this very well-known celebrity dermatologist in New York and she took me. And they said 'you have something called Alopecia and there's really no cure. Basically, what we are going to do is shoot these cortisone shots into your head.' When the nurses would put the numbing spray on me, I would breathe in the numbing spray because it would get me high enough for just that minute to block out the sound of Rice Krispies that came from the needle that kept entering my scalp. It didn't stop the hair loss from happening but what it would do is make the hair grow up in that spot. But that didn't stop another spot from happening. I was always on the defense looking for the next spot and it was really stressful. I did 20 years like that. That's when People Magazine covered me. They went to every single person I worked with in the industry and no one ever knew I had hair loss. That's how good I had gotten in understanding how to hide my hair loss. Then, when I lost all my hair, how to make the wigs work, what I had to do to keep it a secret. All those things I had for 20 years that were so painful, those secrets and tips are exactly what I share with everyone I opened this business 21 years ago

to really help women worldwide. Three times a week, three hours a day I am on skype. Working with women from here to Australia, to all over the world. And the rest of the time I see people in my studio Some of the women I work with I don't even meet. I work with them on zoom and skype and I send them samples of wigs, caps, and colors. And I work with them right on zoom. We get it cut on one of the models or myself and we video on Facetime. And the client can see exactly what we are doing. We do it all. It comes from a long journey. I am a wig designer who is out there really making a difference for women and children who are dealing with any type of medical hair

# TWO COMPETING **VIEWS ON BHUSD CONSTRUCTION**

### **Board Questions Funding Shortfall After Study Session from Citizens Construction Advisory** Committee

### By Danielle Berjikian

Friday the Board of Education held a study session where two competing assessments of the ongoing BHU-SD construction program, which has been controversy under lately, were presented between the Citizens Construction Advisory Committee (CCAC) members and some Board of Education members. Bond Manager Don Blake also gave a presentation regarding a construction update.

The CCAC was formed by Superintendent Michael Bregy and Blake and is composed of three people: Ted Fentin, and Jason Rund. They have met 22 times in the past three years. The purpose of the CCAC -Board member Gabriel Halimi to a \$69 million shortwas to help the Board provide accountabil-

times a year, at a regular Board meeting. However, this is the first time they have presented a report.

fully, actually in this particular case once we got into the walls and saw the condition of the footings, things were a little bit better than that worst case scenario that was discussed last year. Also those numbers and our \$69 million shortfall and even the number that was given last year, that number did not include this [State Seismic Mitigation Program] SSMP reimbursement. Our \$69 million, it does. That's our mid-range case of what we believe that we'll get back for the \$20 million dollars of SSMP reimbursements once the application is filed. The \$69 million is what the CCAC, what our Bond Manager believes the cost to complete all the work would be," Fentin said.

Fentin said that the bond management and construction program is working and that it does not need to be fixed, although some things may need to be tweaked.

"The buck stops with this Board. You've inherited things from previous boards, some which they did right, some of which they kicked the can too long and they couldn't come together to make hard decisions that for 30 years compounded problems that have led to where we are now. But the good news is we did pass a bond. We did get a Bond Manager who's now completed the first two buildings. We now know what we need to finish the project. We do know there is a deficiency and so the Board does have to figure out how to fill that gap. Some may think that the way to deal with this is to shut things down, take the fences down, plant grass on the front lawn and you know take a picture in front of the grass and say 'look we finished what we did and now we got these fences and now everything is great.' I just don't agree." Fentin said.

Fentin suggested that there may be some Board members who would not like to finish the remaining projects. However, the Board was in agreement that they wanted to see the projects completed and finished.

Board member Gabriel Halimi said there is a lack of transparency with the construction program.

"Yes, the buck does stop with this

Board. Yes, I want to see this program done. But I personally as a Board member am very frustrated that there has been a lack of discussion here, lack of information making its way to this board [to] what it feels like for years. So, we need to put in the time, we need to have more study sessions to really come and understand everything that's happened here and make decisions," Halimi said.

Halimi also mentioned how the Committee was supposed to have five to six members with terms, they were supposed to be selected by a facilities committee and that the Board was supposed to be getting quarterly reports at a minimum. Although, none of that happened.

"It feels like there's lack of governance and lack of accountability with how this whole process has worked over the years. And I think that even this Committee being here tonight and giving us a presentation now after years from what I understand is further evidence of the fact that we have not had the proper accountability and governance on this construction program," Halimi said.

Board President Mary Wells said that the bigger question is reviewing where the program is at this point and seeing why it is in the state that it is in. She also said that it is not about whether the Board wants to do these projects, it's a question of reviewing how the program management has been.

"From where I stand, we are \$129 million short. You can say a different number, but if you want to go ahead into transparency there are a lot of different numbers and how you want to present them, they can look different. But we know we are short and we didn't find out that we were short until recently and to me, that is an area that could have huge improvement. We should be having better reporting along the way instead of hearing about this at this stage in the game that now we are short," Wells said.

The CCAC is now recommending frequent study sessions to address issues identified by the CCAC, Citizens' Bond Oversight Committee, and Facility and Construction Committee.




