City to Not Enforce Potential **County Mask Mandate**

A potential new health order by the County that could mandate masking indoors will not be enforced by City staff, the City Council unanimously directed on Monday. The item was brought forward for discussion by Mayor Lili Bosse.

The Los Angeles County Department of Public Health (LACDPH) recently announced that for the second week in a row the number of COVID cases and the number of COVID related hospitalizations have pushed the county into the "high" level and subsequently a new mask order will likely go into effect on Friday, July 29 unless the hospitalization rate decreases by Thursday, July 28.

LACDPH is currently the public health agency for the City. However, city staff is researching the requirements for the City to form its own health department. The City and its businesses are currently subject to the health orders issued by the County at this time.

Although the City would be included in any new health order issued, they may or may not choose to utilize staff resources to enforce it.

The majority of public comments were against enforcement of a mask mandate

Planning Commission to Discuss Hedge Heights

At their Thursday meeting the Planning Commission is expected to discuss proposed regulations and changes pertaining to walls, fences, and hedges included in a draft ordinance.

On May 10 the City Council held a study session to discuss the rules governing the maximum height of hedges in residential zones and directed staff to work with the





Planning Commission to draft an ordinance that would allow taller walls, fences, and hedges in rear yards in residential zones.

The City has recently received an influx of inquiries regarding increasing allowable wall, fence, and hedge heights due to security concerns, particularly along rear alleys.

The Beverly Hills Municipal Code outlines the regulations that govern the height of hedges in the City. The allowable height is dictated by where in the City a property is located.

The maximum height in the City for rear yards is eight feet for most areas except in the hillside area where it is seven feet.

On June 9 the Commission discussed the existing allowable heights of walls, fences, and hedges in four residential zones across the city, and the heights allowed in neighboring jurisdictions. At this meeting, residents from Trousdale expressed a desire to forgo any changes to regulations.

During that meeting, the Commission expressed support for increasing the height of walls and fences in the rear and alley-facing yards of single-family and multi-family residential properties in the Central Area of





the city. They also expressed support for increasing the height of hedges in these zones.

Based on the discussion at the study session, the Commission is expected to approve adding an additional two feet of height for walls and fences, and an additional eight feet for hedges to the Municipal Code for single-family and multi-family residential zones in the Central Area of the city.

No regulation changes regarding any walls, fences, or hedges, are proposed for the Trousdale Estates area and the Hillside Area of the city as part of the proposed ordinance.

The BHPD also said that an increase of fence and hedge heights from eight feet to 10 feet does not have an impact on BHPD's response capabilities and that this may act as a deterrent to opportunist criminals because they generally look for the path of least resistance and potential soft entry points to a property.

If the Commission adopts a resolution recommending approval of the proposed ordinance, it will be recommended to the City Council for final approval.

Real Time Watch Center Catches Suspects

The Real Time Watch Center, which officially launched on June 7, was able to locate suspects wanted for a burglary that occurred in June. Lieutenant Giovanni Trejo gave an update to the Human Relations Commission at last Thursday's meeting.

The Real Time Watch Center allows for around-the-clock live monitoring of cameras across both residential and business corridors. It is intended to deter criminal activity and improve police ability to respond to public safety needs.

A crime bulletin was issued for suspects

969 Colorado Blvd., Suite 205 Los Angeles, CA. 90041 and a vehicle from a hotel burglary in June. Automated License Plate Readers (ALPRs) detected the vehicle entering the City 26 days later on Beverly Drive and notified the investigators. Drone and Video Ops monitored the vehicle and occupants and detectives confirmed the occupants were wanted for burglary.

Patrol units made the arrest while nearby security staff controlled traffic. One of the suspects 'flipped off' the drone as it hovered nearby, moments before the arrests.

The BHPD was also able to arrest another two individuals who were responsible for seven out of 12 commercial burglaries between March and May.

Eventually, their license plate was entered in the BHPD system which allowed detectives to be alerted when the vehicle entered the City. The vehicle was immediately tracked as it traveled through town. Upon seeing the police units, the suspects fled in their vehicle but were immediately located by police.

"The two cases are perfect examples of how the watch center works to accomplish goals to identify

and arrest and aid in the successful prosecution of those responsible for criminal activity." Trejo said.

PLANNING FOR THE **FUTURE**

Myra Demeter on Chairing the Planning Commission

"For me, process is

What drew you to the Planning Commission?

I had served for seven years on the Health and Safety Commission and during that time very important issues were brought forth, approved, and sent to the City Council. There were four no smoking ordinances, one of which was precedent-setting and I am not shy by

saying that I championed that. It was a very wonderful experience for me. In fact, of all the things I have done, I have found that these four ordinances really contributed to our City's health and welfare. I had to develop new skills in order to present the information to find advocates. People found me from Washington from San Francisco and we corralled the Medical Science Academy people have called me students - brought in these advocates - they spoke to them, and the students picked up the cause. They went before the Commission, they went before City


Council, and City Council passed each of these four [ordinances]. The fourth was precedent setting, no one in the United States had prohibited the sale of tobacco and we did. That was an extremely fulfilling piece of my service.

I was terming out and I felt that this experience was so positive and I learned so much, that I was ready to tackle the next step - which was Planning. In Planning you need a voice, you need to examine all different issues. I had to learn a lot. I am interested because I am a lifelong learner. I have a very strong background in some things and not in others. And I wanted to broaden my experience of expertise. I interviewed and literally the day after I left Health and Safety, I was installed into the Planning Commission. That was two years ago.

You previously served on the Board of Education from 2001 to 2009. How is serving on the Board different from serving on the commission?

As a school board member, you are an elected official. And the responsibility for the finances, the personnel, all those things come from the Board. The Board has a CEO who is the superintendent but the Board of Education is the final decision maker who sets the goals and you work with your superintendent to enact them. In fact, you even judge your superintendent on how well he or she enacted the stated goals. They have

a yearly review. The **Planning Commission** is advisory to the City Council. There are some things where we are the final decision maker but many things come to us and we discuss and research them and then they move on to the City Council. We are not elected officials, we are appointed. We don't make final decisions on all topics that come before us. We don't have a CEO, we have a minimal staff of planners.



I think that my belief about my role as

Chair stems from my experience on the Board of Education. While on the Board, I attended sessions and received a master's in governance from the California School Boards Association [CSBA] where we learned the roles and responsibilities of board members, presidents, and chairs to optimize operation. It was a very helpful set of workshops and it influenced me not only in my board service but also as Chair. I am going to really rely on the skills I learned there at those sessions. The Chair is a member of the commission and his or her job is to manage and moderate the meetings. The Chair is no more powerful or no more important than their colleagues. It is a responsibility to review and meet with staff before the meeting to make sure adequate materials were provided and that in-debt research has been done by staff to present in the staff report to commissioners. At the meeting, the chair manages the agenda, the time, and it's important for the chair to gather everyone's opinion and meld them into some sort of cohesive product. If compromises can be made, if things

can be worked out, that's her job to try and do that. But every vote is not unanimous. An elected board position is very different. Again, nothing has to be unanimous but open-mindedness, working together across lines, I think that's where the Chair role is most important. I don't have an agenda. I believe I have a critical eye. I keep all parties' interests in mind. I am going to ensure that there's a fair, impartial, apolitical, review of every issue and project.

I believe I am consistent and I know that I consider all solutions - very clearly resident's rights as well as developer's rights. There has to be a balance. For me, process is very important. Some people have called me 'Ms. Process' because I know wonderful, creative things can happen. And this is a point as Chair where I can make a contribution because I am a trained educator. My background is both school-aged up to graduate school. I often find that people come to me after the fact, after the meeting to say 'we didn't know what was going on.' I think that sends a message to us that even though we put things in the mail for people within a radius of a thousand feet around the project, and we put notices in the newspaper - we are not doing enough. If so many people come to me after and say 'I didn't know' then we have to do something better. I am going to be meeting the head of planning staff Timmi Tway to discuss some of these things and how we can work them better. I also think that this community - people are interested in issues that are not just relevant but involve them or their homes. That's the way it works all the time. People get involved in issues when it affects them. But I think that we are a community where every issue affects everybody. Whether it's traffic on Olympic and you live north or some building going up on Wilshire and you are all the way in the South. We are a small community. We need to listen, we need to encourage people to get involved community-wide. I am going to talk to Timmi Tway to see how we can educate more people as to the issues and the process. Where does it go from planning? Are we the end? What is the process? Frankly, too many people call after the fact.

Prior to the Commission sending back the Hillel project for additional revisions, a motion was approved to bring back a resolution to conditionally approve the project. You were the sole dissenting vote. Why was that?

My primary concern was safety. The proposed configuration of the drop off and pick up was a double lane. There were four cars for a total of eight in this double lane and each one would have at least three children in it. That meant, 24 children from preschool to eighth grade were exiting those cars. Twelve of them were passing over a lane of cars. I was very concerned about the safety issue there

I also did not feel that it was fair to exit onto [South] Oakhurst where there would be a crush of cars exiting the new pathway south of the project. And they were making a right turn and ending either back on Olympic or they were going through the alley and going to Palm. [They were] creating the same issue for residents on Palm that was on Oakhurst. I had concerns about that as well.

In issue #1084 former Chair Peter Ostroff said "Basically, in most instances we're not a 'Planning' Commission, we're a 'Reacting' Commission - we react to things that are presented". Do **you agree with that statement?**

Unfortunately, he's right. We are not the initiators of projects. What we can do is make suggestions in ordinances that will help developers feel more positive about coming to our community. I think that creative incentives are needed and we do that. We've got to improve our housing stock. We started with the mixed use and we are committed to our draft RHNA [Regional Housing Needs Assessment], which went before the state. And we have to do it if we are going to be certified. Otherwise, we do lose local control. Do we determine the projects that come before us? No, we don't. And there's a long process before it gets to us and there's a process when it moves on. So, we are open to hearing things and we do. But probably the one way we can enact change and encourage some sort of new development is by making ordinances that give creative incentives.

The Cheval Blanc [LVMH] luxury hotel project has been sent back many times for revisions before it was conditionally approved by the Commission. What specifically changed your mind to approve the project?

All the commissioners had questions and the preliminary hearings that we had, each of us aired our concerns. Whether it was parking, traffic, the alley, and the club. I was just one of five commissioners asking questions and giving them an opportunity to address them, which they did. They took everything very seriously. They addressed every single issue. Some of them didn't feel they could change and some of them did. So, I think by the end of the process, which was extensive, I was convinced that it was a workable solution and I was in favor of it. That's how I voted. I never started out with a negative view. I came in open-minded and thought it was going to be a great project but it needed some tweaking.

The Commission often dissects projects and makes them better. Do you find that part of the process rewarding?

I think it's wonderful because we each come with different perspectives, different backgrounds, and different concerns. And we come into a project and everyone puts their issues on the table. Sometimes people think of things that I didn't and I am so happy that they do because I really dissect and do my research. When

something comes up of - it's wonderful. We did that with the Cheval Blanc project, we did that with One Beverly Hills. We have an upcoming proposal that's

way in the future for the proposed Saks project. And we have a very strong new group on the Planning Commission and that's part of the excitement, creativity and joy in being part of a group that looks at things and is able to message them. I just want to mention that one of the things that [former] Chair Peter Ostroff is very good at and I need to incorporate is - he would always ask disputing parties to go back and talk between themselves and see if they can come up with a solution. He did this several times. He even did it with Cheval Blanc and some of the businesses that were questioning the direction of the alley. I have to give him credit and I really learned a lot from him.

Tell us about your professional career.

I was an educator for 20 years. Both

K-12 and University level before I came to Beverly Hills. I have a Ph.D. in Mathematics education and I taught math to middle and high school students in public schools. And I taught at Brooklyn College for 15 years, to help prepare people who wanted to go into the teaching profession. I also taught full time at the University of Hawaii when I moved to Hawaii. I am a trailing spouse. Which means, my husband was recruited for a position in California and we discussed it and felt that our future lay here. He was recruited as the CIO for a worldwide executive search firm. When I came to Beverly Hills, it wasn't by accident. We searched for public school districts for our four sons. I had gone to public school; my husband went to public school in Israel. My children went to public school in New York and I looked for the best public school system I could find and Beverly

Hills is where we said that I haven't thought

"I am going to ensure we have to be. While I have been I didn't re-I was here, I didn't really know anyone but I was an educator so I started going to PTA meetings at Hawthorne School where my three children were placed.

> Two years after I arrived, I was called to the principal's office and they said 'we want you to be PTA president.' You can imagine I was shocked. I had never spoken to anybody but I did workshops. So, I became PTA president. I am interested in process, so I read the whole book and it said 'for every fundraising event you need three career events.' So we did math night, we had psychologists come in; we did a lot of interesting things. And then my fellow PTA presidents said 'you're going to run for office.' And I realized I had a voice. I spoke at a board meeting once and it was recognized. I ran against two men, one was an incumbent and both grew up in Beverly Hills. And I won. That started an eight year journey that was very educational. My children con

tinued through the schools.

I am very proud of the things that we did. We could never cheer for our children at a home game because if it rained we had to go elsewhere. So, we put in artificial turf. People don't realize that that artificial turf meant our teams could have home cheers. We had online grading that was not here. Everything was done by mail. During the time I was on the Board, I advocated for it. It

was hard because teachers weren't used to it but now we swear by it. It really is a wonderful thing because parents are partners and they should be able to support their own children. You had to wait for the mail to come to see a progress report or report card. This way you have your own password and you can support your child.

Tell us about your family.

After the Board of Education, I was looking for another profession and unfortunately, my husband [Dan] had a massive stroke. All my plans went by the wayside and I devoted myself to his care. He had lost all functions. He couldn't walk, he couldn't talk, and he had double vision. And everything began to go, his heart, thyroid, everything. Dan is remarkable. He survived now 12 years. Dan was an officer in the Israeli army. He came here with just a suitcase. I met him when he was a tourist because all Israelis tour after their tour of duty. He was a can-do guy. There was never anything - whether it was a mission for the Israeli army and he had no equipment or coming to a new country and working on a truck in the day and going to school at night, taking 120 credits in economics paying full tuition. He finished degrees, and went on to get an MBA. He worked for Citibank for 16 years, and then was recruited by Korn Ferry where he spent 15 years before his stroke. He still has many disabilities and has made a wonderful life for himself. He is able to play chess online. He doesn't ambulate well. He cannot drive.

My four kids went through the Beverly Hills schools and we felt they would all go through the UCs when we moved here. It didn't turn out that way because we were privileged to offer them higher education institutions that fit them best. The reason I'll start with my youngest is because all the other boys sort of knew what they were doing. Roy didn't play an instrument. He was in theater. He's my youngest. He went to Northwestern

on a radio, TV, and film major. After Dan's stroke, he finished school, came to me a few years ago, and said 'he was profoundly struck and influenced by my husband's stroke.' He was actually home when the stroke hit and he wanted to go back to school to be a doctor. So, he went to USC's post baccalaureate program. It took him about six years to do that. He's now in his second year in medical school in Fresno. He's also married. He brought a lovely young lady who he met at Northwestern into our lives. It only took them 12 years to get married.

My eldest Ron is a graduate of Johns Hopkins. He is a senior partner at a national public relations firm. My second son, Gil, graduated from Haas, the business school [UC Berkeley]. He's a private equity fellow. My third son, Guy, found his perfect fit at the University of Chicago and he works for the federal government. I would be remiss if I didn't mention my three rescued animals. We are a big animal family. We have a bonded pair of cats and a Maltipoo named Kelly. They are really part of our family and they bring us great joy.

Have you considered running for City Council?

I have been approached several times by many people. I am just humbled by their interest. Right now I have four more years to go on Planning and I am really loving and learning. Of course, I'll never rule out a run for City Council, but I am very happy doing what I am doing now.

In short, how can the City be smart and considerate about development?

We have a lot to be proud of. We've done wonderful projects and we are going to be adding the Cheval Blanc property. We will have the world's finest five star hotel collection in our small area. I think that we also need to think about how we can revitalize some of the areas of our City that are not fulfilled in the way I think they have the potential to be. I think the mixed use ordinance is a beginning and I think that we can maintain the village arena if we do it smartly but we are going to have to do it more proactive. Since we haven't gotten more than a single handful of mixed use interests, we really have to look at what our incentives are and how we can make them more robust. We also need to make sure our community is alive and flourishing. We have a great business triangle and there are exciting things going on there but we need to look at some of the other areas that aren't designated in the mixed use ordinance to see how we can improve their desirability to developers.


