## Latest Updates in Election Results

As of press time, Culver City’s Measure VH is only five votes from passing, with 8,288 votes in favor and 8,291 votes opposed. This would allow Culver City residents aged 16 and 17 to vote on City and School District candidates and ballot measures.

West Hollywood City Council results continue to change. Incumbent Lauren Meister is in first place holding 16.46% (6,059) of the total votes, followed by Chelsea Byers with 10.74% (3,953). John Heilman is in third place with 10.64% (3,915) of the total votes. Zekiah Wright is just behind with 10.59% (3,897) and Robert Oliver is currently in fifth place with 10.21% (93,758) total votes.

## Traffic and Parking Commission to Discuss Stop Sign Request at Whitworth and South Palm

At their Thursday meeting the Traffic and Parking Commission is expected to discuss the establishment of an all-way stop control at the intersection of Whitworth and South Palm Drive, in coordination with the City of Los Angeles.

Last Aug. residents on the 400 block of South Palm Drive requested the City to install an all-way stop sign at the intersection of Whitworth and South Palm Drive due to concerns of collision experienced at the intersection.

The north half of Whitworth Drive is in Beverly Hills, while the south half of the street is in Los Angeles. City staff requested that the Los Angeles Department of

## Rotary Holds Food Drive

Councilmember Sharona Nazarian along with Rotary President JR Dzubak co-chaired in conjunction with the Beverly Hills Unified School District to provide meals for families in need of a Thanksgiving dinner. In celebration of this pairing, the LA Philharmonic Humanities department, in collaboration with the Arts and Culture Division, has created a series of public programs, welcoming audiences into a reimagining of the artistic community of the 1940s that the composer would have encountered or was flourishing simultaneous to his time in Beverly Hills. ## Suspects Arrested in Connection with May 2022 Armed Residential Robbery

Beverly Hills Police have arrested three suspects in connection with an armed residential robbery that occurred last May.

In the early morning hours of Tuesday, May 3, Beverly Hills Police officers responded to the 700 block of North Camden Drive for an armed robbery. Multiple suspects entered the location and forced the residents to surrender their property. The suspects fled in a vehicle that was parked in the alley.

On Nov. 16 BHPD detectives identified five suspects in connection with the crime. Three of the suspects were subsequently arrested: Charles Daniel Chiodo from Sylmar, Calif. - arrested by BHPD CIT detectives during a traffic stop. He was booked at BHPD for Felony robbery. Chiodo was in possession of a firearm at the time of his arrest and was also charged and booked for Felon in possession of a firearm. Anthony Chavez Avila Jr. from Northridge, Calif. - arrested by BHPD CIT detectives during a traffic stop. He was booked at BHPD for Felony robbery. Joseph Michael Haberlack from Sylmar, Calif. - arrested by BHPD CIT detectives during a traffic stop. He was booked at BHPD for Felony robbery.

Arrest warrants have been issued for the two remaining suspects. The investigation is still ongoing.

## WHAT'S NEXT FOR THE GASCÓN RECALL?

An order to show cause hearing is scheduled for next Tuesday after a judge granted an ex parte application for the Committee heading the recall efforts of District Attorney George Gascón for an expedited hearing. This required the applicant to have demonstrated irreparable harm would take place if the order was not granted.

As a result, the Los Angeles County Registrar of Voters will be required to show cause as to why a preliminary injunction for additional voter records and

expanded access to conduct the review of invalidated signatures should not be granted.

The County Registrar of Voters announced last Aug. that the petition was found to be insufficient to qualify for the ballot. Based on the examination and verification, 520,050 signatures were found to be valid and 195,783 were found to be invalid. To qualify the recall for the ballot, the petition required 566,857 valid signatures; therefore, the petition has failed to meet the requirements.

The court stated it was inclined to grant a substantial number of the Recall Committee's requests, including the disclosure of electronic versions of voter records, and that training materials relating to the Registrar's voter database may also need to be disclosed.

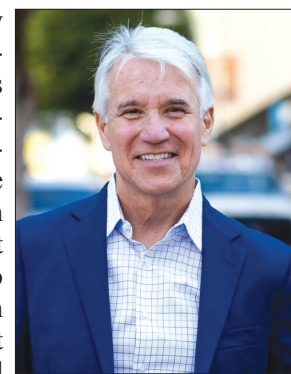
The court also stated the time, place, and manner restrictions placed by the Registrar on the review are unduly restrictive, and expanded access appeared to be warranted.

Since Sept. 6, volunteer attorneys for the Recall Committee have been conducting a review of invalidated signatures and said that clear, obvious, and legitimate challenges have been identified for at least 39% of the invalidated signatures reviewed.

"Throughout the counting and review process, the Registrar of Voters has fought tooth and nail against transparency and state Constitutional rights to

meaningfully review rejected signatures and the reasons for rejection. While this has been frustrating, it comes as no surprise given the rampant errors and significant amount of

wrongfully rejected signatures that have been discovered in the initial review. The people of Los Angeles should have the opportunity to recall George Gascón, and there is no doubt they will if given the chance." Recall DA George Gascón Committee Spokesperson Tim Lineberger said.

### BHHS Boys' Basketball Team Defeats Culver City in Season Opener

Junior guard Jon Mani scored 29 points, had eight rebounds and four blocked shots as the Beverly High boys' basketball team opened its season with a 71-61 victory over Culver City in the St. Monica Showcase Nov. 16.

Senior guard Jameson Caruso added 19 points, six assists, six steals and six rebounds, 6-foot-1-inch senior power forward Liel Yosian pulled down 15 rebounds and senior guard Lior Baradarian

had eight assists and eight points for the Normans.

The Centaurs' "size and athleticism definitely impacted us throughout the course of the game," Beverly Hills coach Jarvis Turner said.

The Normans "lack size and we lack athleticism so when we play bigger, stronger, athletic teams we're going to have to be a little bit more disciplined when it comes to boxing out and rebounding

the basketball and making sure we do a good job of taking care of the basketball," Turner said.

Despite playing a full schedule in the summer and fall, Turner called his team "a little rusty."

"The way the games are managed in the fall as opposed to the fall is a big difference," Turner said. "This year freedom of movement is a big emphasis for the officials so that means the whistle blows a lot.

"Because of that we had guys getting in foul trouble a little bit and ended up having some guys off the bench step up and make some contributions to help us win."

Turner described this team as "a different group" than last season's.

"Last year's team we had a couple of guys who moved into area late," Turner said. "This year's team our kids I've had in my program (the Dream Basketball Academy) since they were fourth and fifth

graders.

"It's a close-knit group. They're great kids, hard workers, great listeners."

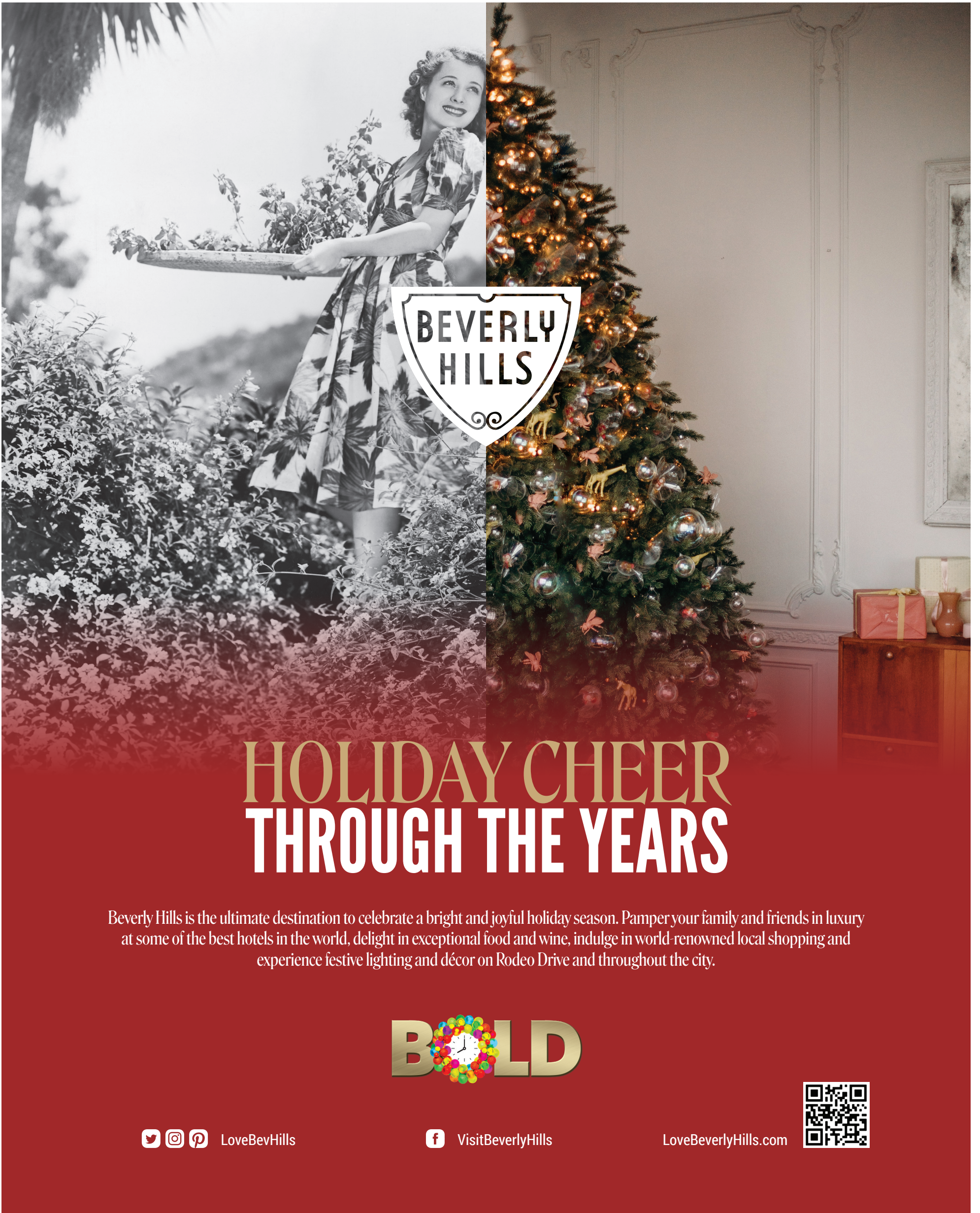
