Planning Commission to Discuss Hedge Heights

At their Jan. 12 meeting the Planning Commission is expected to discuss the rules regarding wall, fence, and hedge height requirements and possibly provide direction to staff regarding a draft ordinance that will be presented to the Planning Commission at a future hearing. The discussion will focus on hedge heights in side and front yards.

In Oct. City Council approved a recommendation from the Planning Commission to amend the Beverly Hills Municipal Code to increase the allowed height of walls, fences, and hedges in the rear yard and alley-facing side yard of single-family residential properties in the Central Area of the city.

The City regulates the allowable maximum height for walls, fences, and hedges in residential zones. Generally, the heights are regulated based on the zone of a property, as well as the location of a wall, fence or hedge on a property.

The City has recently received an influx of inquiries regarding increasing allowable wall, fence, and hedge heights due to security concerns, particularly along rear alleys.

No ordinance is proposed for the Jan. 12 study session. The Planning Commission is expected to discuss, but not take any formal action, on potential changes to the Beverly Hills Municipal Code.

If the Planning Commission provides direction to move forward with changes to the existing regulations, a future code amendment would require review by the Planning

City Seeking Input on Transit Study

The City is currently seeking input on a proposed local bus route for its Transit Circulator Pilot Program.

The City began a Transit Feasibility Study in June to determine whether the current and future planned transit services are sufficient to support the needs of the community. As a first step, the City is considering a transit pilot program that would consist of one fixed bi-directional route operating approximately every 15 minutes on major streets south of North Santa Monica Boulevard.

On March 15 the City Council directed staff to begin developing a transit service plan with the Traffic and Parking Commission as the advisory body.

The transportation planning firm of Kittelson & Associates Inc. was chosen to prepare the transit needs assessment, which will serve as the foundation for the operation of a transit system.

On Oct. 6 the Traffic and Parking Commission reviewed the Draft Transit Feasibility Study and Unmet Needs Assessment and Suitability Analysis Technical Memorandum and received public comment.

About 430 surveys were received in response to the transit survey released. A summary of the responses include: about 28% of respondents indicated that they are current or past riders of transit within the City;

43% indicated no experience as transit riders and expressed an interest in using public transit in the future; and 29% indicated no interest in using public transportation.

Kittelson also conducted interviews with Westside transit stakeholders, including West Hollywood and Culver City, to gather insight on local transit services, and with the Metro Westside planning group for NextGen operations and next steps. Each organization indicated ridership is trending toward shorter, faster trips with higher frequency.

West Hollywood operates a combination of fixed route service to supplement the Metro transit network and specialized on-demand service for individuals over 62 years of age and disabled persons of all ages. In June their City Council approved a proposal to explore a microtransit pilot project to transition away from the dial-a-ride system to provide a general-public microtransit service with priority given to seniors and residents with disabilities served

Dikeman Receives Recreation and Parks Commission Award

The Recreation and Parks Commission recognized aquatics instructor and adult educator, Clark Dikeman with the Recreation and Parks Commission Award at last Tuesday’s Meeting. The award recognizes citizens, groups, or businesses who go above and beyond in their dedication and service to making an outstanding contribution demonstrating a commitment to the field of Recreation and Parks and improving the quality of life in Beverly Hills.

“Clark Dikeman has made outstanding contributions to the Beverly Hills community with his kind, positive, energetic and encouraging demeanor as an instructor, friend and fitness influencer,” Chair Amie Sherry said. “His years of service and dedication are truly appreciated by the community and City staff.”

Kittelson believes a fixed-route transit and microtransit system are best suited for the City.

Fixed route transit operates like conventional public transportation, operating defined routes on defined schedules, and serving defined stops.

Previous public input indicated that interest is for fast connection to the upcoming Metro stations. The greatest transit circulation need is for north-south connectivity, according to community input. Kittelson also believes time-limited fixed route service could be effective during morning and afternoon peak-hour activity to connect parts of the city with the greatest concentrations of students to Beverly High and that connecting the Flats region to the upcoming Metro stations as part of a pilot program may be considered.

North-South Corridors would likely include Rodeo, Beverly, Canon, Rexford Drives, and Robertson Boulevard.

Microtransit is an option for geographies/

terrain more challenging for fixed-route transit. Kittelson believes a microtransit pilot is likely to be the most successful service strategy for portions of the city north of Santa Monica Boulevard. It uses apps to offer on-demand routing between more widely spaced origins and destinations using smaller transit vehicles.

The commission agreed to move forward with a pilot program and city staff is moving forward with developing details for the following considerations: route(s) and stop locations, operating hours, performance and safety standards, passenger capacity, and power options.

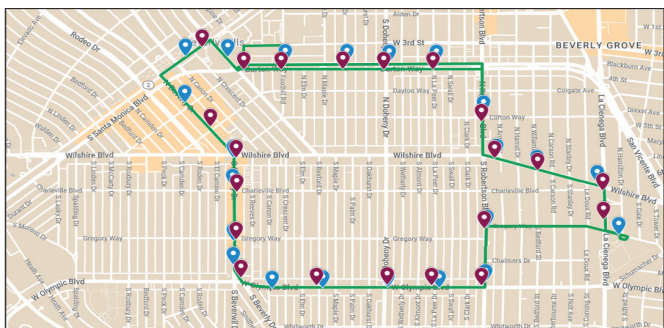
The preliminary estimated cost is estimated to be \$3.5 million for a one-year pilot program with one microtransit vehicle and one circulator route.

Per the direction of the City Council, staff has begun to study potential changes to the development standards that regulate walls, fences, gates, and hedges on single-family residential properties along the front, side, and/or street side property lines. These changes are being discussed due to concerns regarding the safety and privacy of residential properties. The study session topics that will be considered include:

- Maximum allowable height, overall configuration, and review processes for walls, fences, gates, and hedges located on the front property line, side property line, and/or street side property lines.
- Applicability and appropriateness of potential code changes as they relate to the Central, Hillside, and Trousdale Estates Areas of the city.

In October 2022, the Beverly Hills Municipal Code was amended to increase the allowed height of walls, fences, and hedges in the rear yard and alley-facing side yard of single-family residential properties in the Central Area of the city. At the January 12 study session, staff will present a staff report outlining the discussion topics listed above and seek direction from the Planning Commission regarding further potential changes to the Beverly Hills Municipal Code. No ordinance is proposed at this time and the Planning Commission will discuss, but not take formal action, on this agenda item. Should the Planning Commission provide direction to move forward with changes to the existing regulations, a future code amendment would require review by the Planning Commission, and adoption by the City Council.

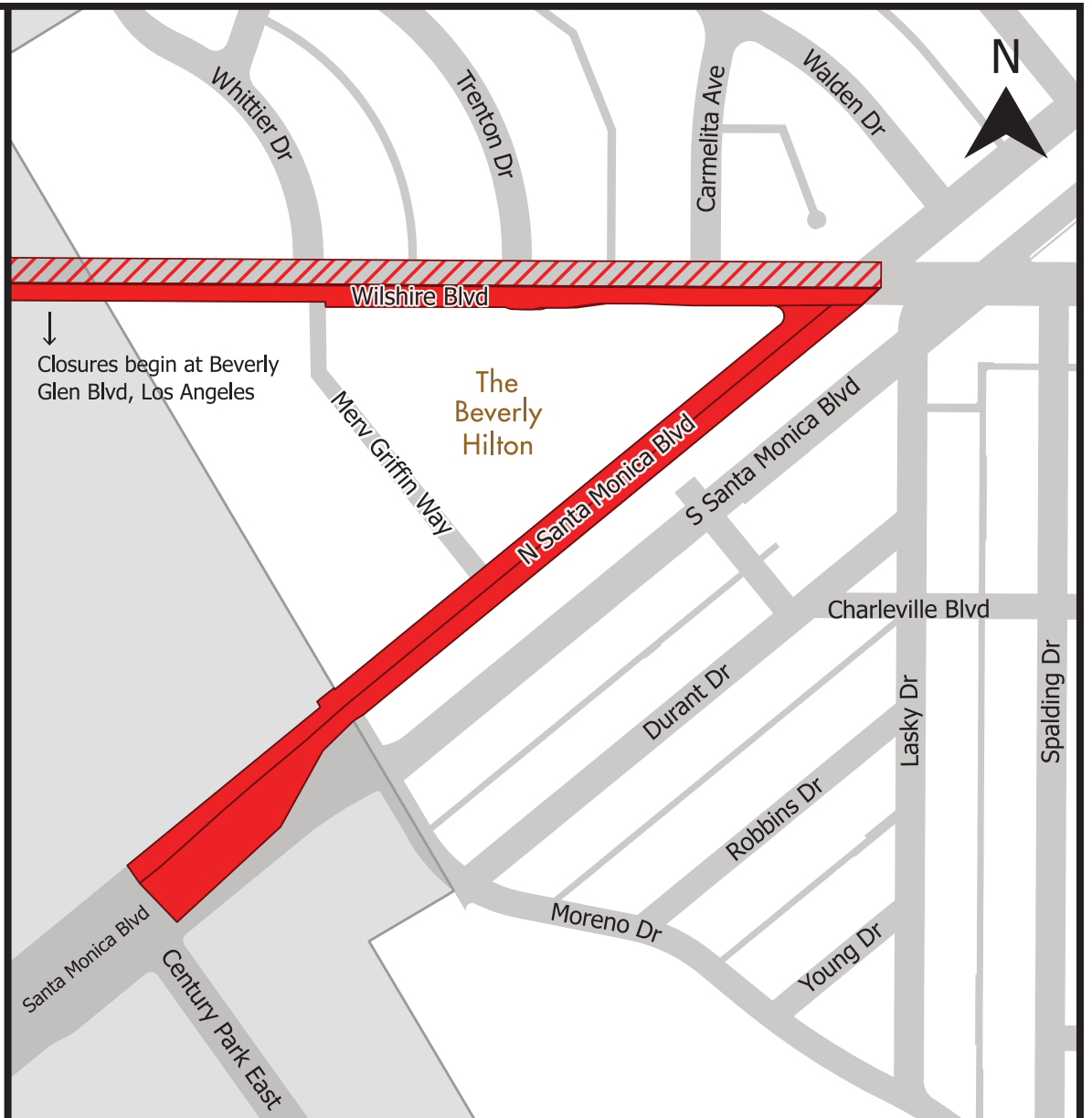

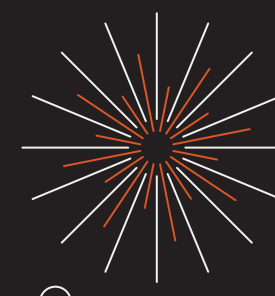
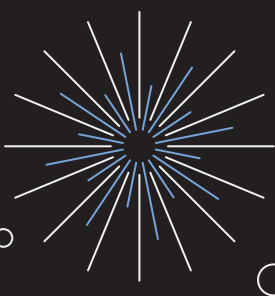
