“Beverly Hills Transit”

AN OPEN LETTER TO THE TRAFFIC AND PARKING COMMISSION:

This is an open letter to the Traffic and Parking Commission (TPC) regarding the Beverly Hills Transit item on its agenda for its meeting on Thursday, January 5.

In approximately August 2021 (nearly a year and ½ ago) the work of the Community Advisory Committee (“CAC”) for the City’s Climate Action and Advisory Plan (“CAAP”) commenced. Wendy Nystrom and Peter Ostroff were selected as Co-Chairs. The purpose of the CAC and CAAP was to develop a strategy to reduce Greenhouse Gas emissions (“GHG”) attributed to our City.

From the outset, we learned that approximately 50% of the City’s GHG were from motor vehicle trips to, from, or within the City.

We understood that in order to make a real impact on that 50%, we would have to develop a comprehensive transit system that would address all areas of the City and provide a means of transportation that would be sufficiently attractive to effect a major change in transportation habits and attitudes formed over lifetimes. Only a comprehensive system, not a halfway (or less) measure would offer any prospect for success. Of course, we recognized and continue to recognize that this effort and proposal was at once aggressive and ambitious and was not guaranteed to succeed. At the same time, we were and remain convinced that anything short of a comprehensive system was guaranteed to fail.

The conceptual proposal was described in an email exchange in early March, 2022 (ten months ago) that Peter Ostroff had with then Mayor Bob Wunderlich and then TPC Chair Sharon Ignarro, which is set forth at the end of this letter.

Shortly after that exchange, the Council asked the TPC working with the CAC to develop the proposal further. At the time, we advocated that a preliminary plan be drafted and that the input of vendors be sought regarding alternatives and costs. It was our strong recommendation that extensive community engagement be sought after a substantive proposal with specifics had been developed, not before.

We were concerned and advocated against simply delegating the issue of a City transit system to outside consultants (who have no experience with or knowledge about our City) would result in abstract surveys about attitudes rather than plans and be unduly time consuming and expensive without any corresponding benefit. We are informed that the Department of Public Works leadership and staff has no substantial experience with or knowledge about public transportation.

Notably, the attitude surveys that have been undertaken by the outside consul-

tants and acquiesced to by our Department of Public Works are particularly pointless as well as expensive. We know that the attitudes of most Beverly Hills residents are entirely hostile to mass public transit in southern California. One of the prerequisites to success of Beverly Hills Transit is to change those attitudes by offering a uniquely safe, reliable service for all parts of the City.

Unfortunately, our fears regarding this delegation have been realized. Months have gone by, an attitude survey entirely in the abstract was conducted, and we are now presented with a proposal for a system that seems designed to be rejected by Council (which, in our view, should happen) or fail after substantial expense.

Specifically, the current proposal for one fixed circle line that almost entirely overlaps with service provided by Metro and others, and ignores all of the City north of Burton Way, all of the City west of Beverly Drive, Wilshire Blvd., and most of the Business Triangle, has no north/south routes, and doesn’t really serve anyone’s transportation needs will attract few, if any, riders. The notion that the rest of the City (most of the land area of the City) can be adequately served by a single allegedly on demand “micro-transit” vehicle simply makes no sense. The delays and wait time would make this type of “service” unacceptable and unusable.

In short, the current proposal is not a step in the right direction. It will be costly and will not attract sufficient riders to make a difference.

It is not better than nothing. If it is commenced it will fail and put an end to any prospect that our residents’ mobility can be improved or that transportation related GHG emissions be positively affected.

It should be rejected out of hand by the TPC, the DPW and, if it gets that far, by the City Council.

Rather, we respectfully suggest that the TPC initiate a proactive role and request that “staff” and/or its outside consultants provide the following:

Alternative plans that include fixed routes as initially presented by the CAC that serve all areas of the City; and

A detailed breakdown of the costs of these plans.

Once this work has been completed, an effort should be made to obtain real and meaningful public reaction and input regarding these specific alternatives.

With the information that emerges, the TPC can make a principled recommendation for the Council’s consideration.

City Council to Pursue Vehicle Speed Contest Ordinance

At their Tuesday Study Session the City Council agreed to pursue an ordinance related to illegal speed contests, also known as street racing, due to the risk of injury to participants and non-participants. The City Council believes there are also public safety concerns due to the amount of spectators attracted to these events, especially when the illegal speed contest is publicized in advance on social media.

All forms of speed racing is illegal and punishable under state law. In 2019, the City Council adopted an ordinance that prohibits spectators at an illegal speed contest or where preparations are being made for an illegal speed contest. Spectators may be charged with a misdemeanor which allows for prosecution of the individual with a maximum sentence of six months in jail or a fine of \$1,000, or both. The violation may also be prosecuted as an infraction. If an individual is punished with an infraction, the first violation would be punishable by a \$100 fine, and a second offense committed within 12 months would increase the fine to \$200. A third offense, and any subsequent offense, would be subject to a \$500 fine.

In 2021, California Highway Patrol responded to nearly 6,000 street races and sideshows, issued 2,500 citations, made 87 arrests, and recovered 17 firearms, according to the Department of the California Highway Patrol.

City staff became aware of two ordinances adopted by the City of Paramount in 2020. The first ordinance established comprehensive regulations for illegal street racing, as well as a legal procedure of forfeiture of vehicles engaged in these activities. The second ordinance allowed for the misdemeanor prosecution of spectators at these events, which is similar to the city ordinance that is already in place. The primary focus of Paramount's Ordinance allows a police officer to declare the vehicle a nuisance in order for it to be seized and impounded.

According to the staff report, from Jan. 2021, through Aug. 2022, Paramount's ordinances have been effective to the following: 137 arrests, 272 citations for speeding,

modified exhausts, and illegal vehicle modifications, 78 citations for spectators, 145 administrative citations for spectators, and 117 vehicles impounded.

The City Council will pursue an ordinance that possibly includes the impoundment of vehicles that are seized, further cost recovery measures, such as allowing for the sale of the vehicle to recover the costs associated with the impoundment, and allow the legal owner of the vehicle, who may not have been involved in the illegal street racing, to recover the costs for the impoundment against the person who is responsible for the participation of the vehicle in the illegal street racing.

City Council Declines Review of 1510 Lexington Road Project

The City Council declined a request from Councilmember John Mirisch to determine if the council should call up the Planning Commission's decision to allow for the construction of a new single family residence at 1510 Lexington Road up for review.

On Dec. 8 the Planning Commission approved a resolution after several months of deliberations for the approval of this project that consists of a hillside R-1 permit to allow the total of the cumulative floor area developed on a site to exceed 15,000 square feet, a hillside R-1 Permit to allow more than 3,000 cubic yards of earth material to be exported from the project site, and a Tree Removal Permit to allow the removal of two protected trees at 1510 Lexington Road.

The applicant originally requested a Tree Removal Permit to allow the removal of a total of 10 protected trees, which included five existing heritage trees in the front and street-side yard and to formalize the removal of five heritage trees that were removed previously without a permit, for the total removal of 10 trees from the property.

At the Oct. 13 meeting, the Commission could not come to a consensus on whether or not to approve the removal of the trees and suggested leaving that out of the resolution to further study that issue. During the Commission's deliberations on the tree

removal permits, an arborist report that was submitted in 2018 was brought up where it was revealed that four of the trees are "declining, have decayed areas with drywood throughout, and are in precarious conditions and therefore should be removed," and one tree "is leaning toward the street, been topped in the past, and is in a precarious condition and therefore should be removed."

The Commission directed staff to obtain an independent arborist report on the condition of the trees at the applicant's expense to determine whether they are in fact a danger. On Nov. 3, Carlberg Associates and City staff conducted a site visit to evaluate the condition of the five existing heritage trees. The site visit revealed that three of the five trees that were proposed for removal were no longer on the project site, and it was recommended that those two remaining trees be removed.

The majority of the commission agreed to approve the removal of the two remaining trees and allow for staff to move forward with any penalties associated for the illegal removal of the former trees.

The Commission was also in agreement that there was a lack of credibility left by the applicant and said that the applicant acted inefficiently, negligent, and unprofessional. That said, the Commission made the findings to approve that project despite their feelings towards the applicant.

As part of the Planning Commission's review of the project, the Commission evaluated whether the project qualifies for the exemptions in the Basement Ordinance for consideration as a Pipeline Project. Commissioner Peter Ostroff previously expressed concerns over the applicability of the Basement Ordinance's pipeline provisions to this project, and whether revisions to the project over the course of its review resulted in significant changes compared to the project submitted in 2016.

In 2018 the Basement Ordinance was adopted by the City Council to address concerns raised about the scale of development in single-family areas with a focus on basements, retaining walls, and grading within the Hillside Area. Since there were

projects that were in various stages of review, the Council established pipeline provisions that would exempt several categories of projects from the Basement Ordinance due to the time, money, and effort that applicants had already put into projects.

The Commission ultimately decided it was a Pipeline Project in a 3-2

vote, with Chair Myra Demeter and Ostroff dissenting.

The majority of the City Council believed that because of the steps made by the commission to thoroughly review and approve the project, there was no need to call up the decision.

"I believe we have a planning commission in place for a reason. Their vote was 4-1. There were four meetings that were involved. I don't see a reason to [call it up]," Councilmember Sharona Nazarian said.

Public Works Chair Wendy Nystrom on Making Beverly Hills More Sustainable

What initially interested you in the Public Works Commission?

I wanted to see how the city worked. I moved here in 2013. My husband's family has been here since 1914 and they know every part of the city. I did not know who did what or how things happened. I always had an interest in government. I actually started attending meetings to see what the city was doing and the projects they were working on. My background being in environmental risk management and construction kind of made sense for me to go to those meetings. I was intrigued and it was actually [Vice Mayor] Julian Gold who told me to apply.

What's the status of the Coffee Bean and Tea Leaf water treatment project on La Cienega?

I do know that they are testing the water to see how clean it is. They have those tests being sent out now for analysis. It is a slow process because they want to make sure everything runs perfectly for the water treatment plant to make sure all of that is safe before we actually pump water into homes. The City is working with the contractor on warranty items needed to close out the project.

Are there any upcoming Public Works projects you're looking forward to?

My focus has always been sustainability. I know the city is going to be working on their Climate Action Adaption Plan.

Right now, Public Works is leading the charge on that but it is all departments and entire city staff involved. Beverly Hills as a whole is a little bit behind on our sustainability initiatives and our environmental awareness. I am now seeing that picking up and getting more rapidly developed.

Tell us about your professional career.

My degrees are Geology/GeoChemistry. I worked as an environmental consultant at the beginning of my career, but primarily worked in environmental risk management, which is environmental pollution liability. So, if you contaminate a property you are required to clean it up and there are specific insurance policies for that. I would work with corporations and executives on how to manage that risk, stop it before it starts, and then how to deal with it when it does happen.

I left insurance around 2018. I worked about 20 years in that industry and wanted to focus 100% on sustainability. So, I enrolled in UCLA to just take sustainability courses and get the certificate program to make

sure I knew what I was talking about and make sure I had the right education behind me. There are a lot of people who claim to know what they are talking about and unfortunately, they don't. I did not want to be that person. I did the work, I did the studies, and aggressively worked

provide for a housing provider to pass through certain expenses without undertaking a rent increase application process. Housing providers for both Chapter 5 and Chapter 6 tenants may pass through the following surcharges: water service penalties and/or surcharges, at a rate of 90% of the penalties and/or surcharges imposed by the City; and Refuse fees imposed by the City, at a rate of 100% of the fees.

with people. That was also when I was a commissioner so I was using that knowledge to talk about sustainability with the city. We had our movie night last summer, we organized that. The whole goal is to try and bring more environmental awareness but not in an aggressive way. I am not trying to scare people. I am just trying to let people know what is available. Small changes matter. You do not have to completely uproot your lifestyle. You can make small changes that will have a long-term greater effect. I think too many people, especially in the environmental world, tend to shame or blame people for not doing things right. We need to move away from that and tell people it is ok, you are going to be ok, we just need to make small changes.

You are Co-Chair of the Citizens Action Committee. What is the status of the proposed Beverly Hills transit system?

Right now they sent out a communication to do another public comment to review what the consultant put together with respect to the route map. They are waiting for that to come back in Jan. After that, they will hold public meetings for people to attend to see what the proposed routes are, how frequently, just more details. Right now it is still in public outreach.

You have served on several boards like the Community Advisory Council for SoCal Gas. How is that different from serving on the commission?

I am a huge fan of SoCal Gas with their transition to hydrogen. Hydrogen is a necessary renewable energy. We cannot have everything be electric. Having one source of energy is bound for failure. We have to have a diverse energy grid. SoCal Gas knows natural gas is on the way out, they know they have to change, and they are making aggressive efforts to do that. I am on their board. We talk about

how the community can engage and learn about hydrogen, the fact that it is a fuel cell. You are not lighting hydrogen on fire. You have an electric reaction and the off-gas is water. There is no negative to this. It is about letting people know.

One of the positions that I really love is called Girl + Environment.

Diamond Spratling is the founder. I met her on LinkedIn just by networking. She astounded me. She is very young, I think she is 25. Just her intelligence and capabilities blew me away. She started Girl + Environment to lift the voices of Black and brown girls across the county. I host a webcast called Environmental Social Justice. I had her on that a few times. She invited me to be on the board. I love what she does. She is spectacular and I think that girl is going places.

As you mentioned, your husband Mike Lloyd comes from a prominent Beverly Hills family, and is the son of well-known music producer Michael Lloyd. How did you two meet?

We met through a mutual friend of ours who he knew from [Beverly Hills] High School - Garry Gekht. I was networking at the Gay and Lesbian Chamber of Commerce. I met Garry and he introduced me to Mike. We have literally been inseparable ever since we met. That was 10 years ago.

What do you hope to accomplish as chair?

My focus is environmental awareness. Again, I am not forcing anyone to change. I am not demanding people change their lifestyles. I just want people to be aware of what is happening, what is out there, and what people can do. Every commissioner has their pet project, mine is going to be awareness. Letting people know what is out there, what kind of pollution there is, and what pollutants are. A lot of people use the word 'emissions' which almost sounds soft and easy. When the real word we should be using is pollution, because that is what it is. The more manufacturing we have that use fossil fuels, the more pollution we have. We have the resources to change, we just need to implement them.

pass through to a tenant of an apartment unit 50% of the current costs of the Rent Stabilization Ordinance Registration/Administration payable over 12 months.

The Commission is expected to discuss any revisions that may be recommended to the City Council to be made to the Rent Stabilization Ordinance regarding pass through costs for both Chapter 5 and Chapter 6.

City to Prepare Historic Resources Survey for Multi-Family Properties

At their Tuesday meeting the City Council approved an agreement with Historic Resources Group, LLC to prepare a comprehensive historic resources survey of multi-family properties in Beverly Hills. The City Council also approved a purchase order for a total of \$125,400 for the services to be provided.

The purpose of an historic survey is to identify, document, and evaluate places of historical, and architectural significance to provide the foundation for the City's historic preservation program. Survey data also provides information on potential historic resources to guide long-range planning decisions, inform project review, and support policy goals in the protection of eligible historic resources. This also allows for better identification of buildings that may be eligible for historic incentives, such as the Mills Act.

To date, the City has completed three historic resource surveys. Individual properties have also been surveyed in relation to development proposals.

In 1985 the City conducted a historic resource survey for Single-Family, Multi-Family, Commercial Properties built prior to 1945. This survey included 2,790 properties in total. Of those properties, 371 properties were identified as potential historic resources.

In 2004 the survey included 371 properties evaluated in the 1985 Survey, and Multi-Family Properties South of Wilshire Boulevard built prior to 1961. From this survey, 272 additional properties appeared as criteria for recognition.

In 2006 the survey included commercial properties evaluated in the 1985-86 and 2004 Surveys, and all commercial properties in the Business Triangle and along Wilshire Boulevard built prior to 1965. This survey evaluated 60 additional commercial properties that appear to meet criteria for recognition.

The new agreement includes the scope-of-work for a survey of multifamily properties only and does not include a survey of single-family dwellings, or commercial properties.

Climate Action and Adaptation Plan in Final Stages

At their Dec. 12 meeting the Community Advisory Committee (CAC) discussed moving the Draft Climate Action and Adaptation Plan (CAAP) forward to various commissions with the CAC's recommended Strategic Priorities for GHG Emission Mitigation and Climate Change Adaptation Measures as the foundation for the CAAP to recommend for City Council approval.

The Draft CAAP is a guiding document that is intended to lead the City to carbon-neutrality by 2045. The GHG mitigation measures and climate change adaptation measures were formulated from the Strategic Priority measures.

The Draft CAAP is divided into four chapters: Climate Change in Beverly Hills, Greenhouse Gas Mitigation, Climate Change Adaptation, and Implementation.

The plan is organized to help contextualize the process to reach carbon neutrality and community resiliency, as well as the community engagement process.

When the draft plan has been recommended by the Public Works, Planning and Traffic and Parking Commissions, staff intends to present it to City Council with anticipated adoption sometime in 2023.

Jack and Goldie Nomberg Foundation Grants \$1 Million for Student Tours at Holocaust Museum LA

Sandra Kanengiser has directed a \$1 million grant from the Jack and Goldie Nomberg Foundation to support free ed-

ucational tours for students at Holocaust Museum LA.

The Jack and Goldie Nomberg Foundation was funded by Sandra's uncle, Jack Nomberg, who died in 2019 at the age of 101. Both Jack and his wife, Goldie, were Holocaust survivors who met in Los Angeles in the 1950s and built a wholesale and retail textile business. The grant is in memory of Sandra's parents, Robert and Barbara Gerson, who were also survivors.

Students can view one of the exhibits at Holocaust Museum LA. In cooperation with teachers, museum staff customize



each docent-led tour to fit the particular classes and age level. The museum annually welcomes 30,000 fourth-grade through high school students. By 2030 the museum expects to welcome a half-million visitors annually, including 150,000 students.

"Sadly, our community of Holocaust survivors is shrinking; and conversely, Holocaust denial and antisemitism are increasing," said Beth Kean, CEO, Holocaust Museum LA. "Education combats misinformation and is our biggest catalyst for change. We are so grateful to the Kanengiser family for honoring the survivors in their family with this generous grant in support of our student tours program. Students who enter our museum as bystanders leave as upstanders."

Each school group is also given the opportunity to dialogue with a Holocaust survivor. In addition to free admission for all students, the museum offers bus transportation scholarships for Title I schools where field trips would otherwise be cost-prohibitive.

"My parents talked about the war frequently, and it was an important part of my children's upbringing, too. Our goal in making this grant is to further education toward reducing and eliminating antisemitism and hate crimes," Sandra Kanengiser said.

creditor of the decedent, you must file your claim with the court and mail a copy to the personal representative appointed by the court within the later of either (1) four months from the date of first issuance of letters to a general personal representative, as defined in section 58(b) of the California Probate Code, or (2) 60 days from the date of mailing or personal delivery to you of a notice under section 9052 of the California Probate Code.

Other California statutes and legal authority may affect your rights as a creditor. You may want to consult with an attorney knowledgeable in California law.

YOU MAY EXAMINE the file kept by the court. If you are a person interested in the estate, you may file with the court a Request for Special Notice (form DE-154) of the filing of an inventory and appraisal of estate assets or of any petition or account as provided in Probate Code section 1250. A Request for Special Notice form is available from the court clerk.

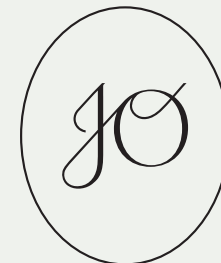
