

"LVMH Project"

With the No on Measures B & C vote prevailing, where do we go from here? What does this mean?

I do not place any fault on LVMH. It is expected that developers will try to maximize at whatever cost what is to their benefit without having any regard for its impact on the community. But SHAME on Beverly Hills City Council and staff for not understanding, appreciating, or respecting what built Beverly Hills and what Beverly Hills really is.

The City Council (with a single exception) and staff have shown to be advocates for developers rather than stewards for the community that has voted them in or hired them to serve. How did this happen?

Beverly Hills founders had a vision of the type of community Beverly Hills should be and the quality of life it should offer. I doubt we would have had the same Beverly Hills if founders strove for a high-rise and/ or high-density community and/or a community smothered by massive numbers of cars without adequate parking provisions. But that is exactly the type of development staff and City Council have been approving for the last several years. Exceptions to the General Plan are no longer "the exception" -- they are the norm. That is the problem.

This is what the May 23 election on Measures B & C was about. Residents have spoken. Beverly Hills has been compromised by the many years of "exceptions" to the General Plan and "in lieu of parking" payments. If anyone cannot see this, then they are either myopic or in denial--or both. About two weeks ago someone stopped me near Beverly Drive and asked me what it is like to live here. He then answered his own question by saying that he could not imagine why anyone would want to live here with all the traffic and noise that we have. That is what this visitor thought of Beverly Hills. I doubt he is the only visitor who has had this kind of reaction.

I hope that the results of this election will be a wake up call to the City Council and staff that Beverly Hills is not for sale -- nor should it be for any amount of money-- and does not need an outside party to give it celebrity, panache, or elevate its "brand". The many years of development "exceptions" have tarnished Beverly Hills. It is time to put on big boy pants and say No to developers whose proposals do not fit the profile of what Beverly Hills was intended to be . If Beverly Hills is as desirable as City Council claims, then developers will comply with the building parameters that are in place--The Peninsula did. And if they don't, then why would the City Council chase a project that does not respect the community that it claims to want to be a part of? Unlike

Santa Barbara which maintains its community integrity, Beverly Hills ,with its policy of "exceptions" and allowing developers to buy whatever they want to build, is quickly losing (lost?) that which had made Beverly Hills distinctive and I am not referring to any distinction that is attributed to a retail or business presence.

It is important to understand that the No on Measures B & C campaign was not an effort against development. It was a last straw response against the practice of giving developers carte blanche for a price at the expense of the residential quality of life. Isn't it time that staff and City Council applied the standards of the General Plan to developers to the same degree that the Planning Commission applies the standards of the building code to residents looking to (re)build their homes?

LVMH Election Not Over Ouite Yet

Alpine Drive resident Sunny Sassoon has requested a manual recount of ballots cast in a letter addressed to Los Angeles County Recorder Dean Logan as well as Beverly Hills City Clerk Huma Ahmed, relating to the special election for Beverly Hills Measures B and C after final results revealed the 'YES' campaign lost by about 80 votes.

Sassoon, a self-proclaimed "supporter of the passage of Measure B and Measure C", is the former owner of Coffee Bean and Tea Leaf.

Sassoon has requested the inspection of ballots and the following "relevant material": uncounted (rejected) provisional ballots and envelopes, under-voted ballots, over-voted ballots, and uncounted (rejected) vote-by-mail ballots and envelopes.

Sassoon has also requested to reserve the option to inspect the following material: vote by mail and provisional ballot envelopes; voter registration files of vote-by-mail voters and provisional voters for voter authentication purposes, including registration card signatures; rejected ballots that were received and voted at the precincts/vote-centers within the jurisdiction; audit logs; polling place/vote-centers event logs; precinct tally results; and central count tally results and consolidated results in a structured, non-proprietary format.

Sassoon has designated attorney Brian Hildreth to be present during the recount. Sassoon will be responsible for the daily cost of conducting the recount unless the results are reversed. Cost for the recount was not available as of press time

"I am not worried about the recount. The County Registrar employees seemed competent and honest. Votes were counted by machines which were calibrated before and after vote counts. My bet is on the accuracy of the County Registrar. Of course our group will participate in any recount, but I'm not really worried about it," Residents Against Overdevelopment Treasurer Darian Boieaux.

City Council Approves Extension of Temporary North Cañon Closure

At their Tuesday Study Session the City Council approved the temporary closure of North Cañon Drive for an additional six months.

On July 24, 2018, City Council approved the initial closure of North Cañon Drive in an effort to mitigate the impacts from the construction of the Metro Purple Line Extension project.

A cul-de-sac was created in Sept. 2019 after the street was closed, followed by the construction of the temporary sound wall at Wilshire Boulevard. The City Council approved a mural designed by Tomokazu Matsuyama, which was completed in Nov. of that year. On Sept. 21, 2021, the City Council approved a one-year extension until Sept. 30, 2022, and on Sept. 12, 2022, the City Council approved a nine-month extension of the temporary closure until June 30, 2023.

The Wilshire/Rodeo station construction along Wilshire Blvd has made about 60% progress in building the station structure, according to the staff report. The 20-foot tall sound wall at North Cañon Drive is in place as an effort to mitigate the impacts from noise and dust. The closure is also intended to provide access that is uninterrupted for businesses located on North Cañon Drive.

For the rest of 2023 and through 2024, Metro will continue to set up cranes to access deck panels along Wilshire Boulevard for material deliveries and pump concrete to continue to construct below ground station's entrance, concourse level, walls, roof deck, side structures, and other components. Wilshire Boulevard between Beverly Drive and Crescent Drive is typically reduced to a minimum of two lanes in each direction during the day and a minimum of one lane in each direction during the night for these activities.

Metro has also begun construction of multiple appendage structures at South Beverly Drive and South Cañon Drive and is expected to continue until early next year.

City staff is expected to continue maintenance of the mural and public information graphics on the sound wall and the landscaped planters in an effort to keep the cul-de-sac aesthetically pleasing. Staff is also expected to monitor concerns from the community.

Near the expiration date of the closure, staff will provide updates on the Purple Line Extension project to the City Council to consider whether or not to further extend the temporary closure.

City Council Reappoints Commissioners

At their Tuesday Study Session the City Council approved the reappointment of several commissioners as their first two-year terms are ending on June 30, and they are eligible for reappointment to a second term of four years. The Commissioners have indicated willingness to serve a second term from July 1, – June 30, 2027.

The following commissioners' first terms expire on June 30: Arts and Culture Commissioners Maralee Beck, and Karla Gordy Bristol, Charitable Solicitations Commissioners Laura Hornwood Margo and Vered Nisim, Traffic and Parking Commissioner Lisa Kay Schwartz, and Planning Commissioner Gary Ross.

City Council Modifies Issuance of Certificate of Appropriateness

At their Tuesday meeting the City Council modified a Certificate of Appropriateness decision issued for the historic property located at 910 North Bedford Drive, also known as the Anthony-Kerry House, after Mayor Julian Gold called this up for review due to a concern that one of the restrictions regarding the existing fence was not needed.

A Certificate of Appropriateness grants the owner of a historic property the permission to alter, restore, reconstruct, relocate, rehabilitate, stabilize, demolish, or change the exterior appearance of a designated landmark.

The Cultural Heritage Commission previously approved the Certificate of Appropriateness on April 12 for the proposal of a two-story addition to the existing house. As part of the approval, the Commission required the following condition "any front or side yard fencing shall be removed except for that portion encompassing the circular driveway which shall return to the commencement of the clinker brick wall The fence removal shall be completed within thirty (30) days after the date of the adoption of this Resolution. An alternate fence arrangement of that front/ side yard area may be proposed through a subsequent Certificate of Appropriateness application reviewed and approved by the Cultural Heritage Commission."

The City Council upheld the Certificate of Appropriateness but made it so the removal of the fence was no longer a condition of approval.

The City Council previously granted a continuance request related to an appeal hearing scheduled to consider the Planning Commission's decision denying a Historic Incentive Permit (HIP) for the property.

HIPs allow deviations and waivers

from development standards and are available to properties that are designated as local historic landmarks.

On Aug. 26, 2021, the Planning Commission adopted a resolution denying a Historic Incentive Permit for the property.

The commission was specifically concerned with whether the project met the intent of a HIP; the scale of the addition to the property; and maintaining the garden quality of the city.

The property is a two-story single-family residence with an area of approximately 33,971 square feet. The residence was originally constructed in 1909 on a property in Los Angeles. In 1923, the property was relocated to Beverly Hills by actor Norman Kerry after he and his wife purchased the house to avoid its demolition. The residence has retained most of its character-defining features and is known as the best example of high-style Craftsman architecture in the city.

The property owner formally applied for a Certificate of Appropriateness for consideration of a by-right project, one that would not require a Historic Incentive Permit, which was approved by the Cultural Heritage Commission last month.

The project is intended to complement and preserve the historic resource without compromising its existing character-defining features.

Since the certificate was granted, the property owner is expected to submit the plans to the City's Development Services Program for building permit plan review.

Rent Stabilization Commission Expected to Approve Amendments to Maximum Allowable Annual Rent Increase

At their Wednesday meeting the Rent Stabilization Commission is expected to discuss maximum allowable annual rent increases and pass throughs and surcharges, and possibly approve eight resolutions to be recommended to the City Council.

For Chapter 5, the maximum allowable annual rent increase is calculated monthly, using the lesser of 8% or the change in the CPI, calculated by the difference of the sum of the CPI for the 12 months preceding the most recent 12 months, and dividing that difference by the lesser of the two 12-month period's

sum, according to the staff report. For Chapter 6 tenants, the maximum allowable rent increase is the greater of 3% of the rental rate or the percentage increase in the CPI between May 1 of the then current year and May 1 of the preceding year.

On Oct. 3, 2022, the Commission voted to make a recommendation to the City Council to impose an overall cap on Chapter 6 tenants' annual maximum expense for rent and pass throughs and surcharges.

The Municipal Code currently provides for various pass throughs and surcharges that allow a housing provider to pass through to tenants certain expenses without undertaking a rent increase application process. Housing providers for both Chapter 5 and Chapter 6 tenants may pass through water service penalties and surcharges, at a rate of 90% of the penalties and surcharges imposed by the City to tenants.

In Feb. the Commission voted to make a recommendation to the City Council to delete the water service penalty surcharge from Chapter 5 and Chapter 6. They also voted to make no changes to the refuse fee surcharge for Chapter 5 and Chapter 6.

Housing providers for Chapter 5 tenants may pass expenses incurred by the housing provider for capital expenditures incurred after the date of the last preceding rent increase, according to the staff report. In Jan. the Commission voted to make no change to the capital expenditure surcharge for Chapter 5 and to not add a capital expenditure surcharge to Chapter 6.

The Commission also voted to make a recommendation to provide for a pass through of 50% of the cost of seismic retrofit that is currently mandated by law for tenants.

In May the Commission voted to make no change to utility expense surcharge for Chapter 5 and to add a utility expense surcharge to Chapter 6.

The Municipal Cope does not provide for a pass-through of the Rent Control administrative fee. In Dec. the Commission voted to make a recommendation to the City Council to add to both a provision allowing housing providers to pass through to tenants 50% of the current costs of the fee, payable over a 12-month period.

The Commission is expected to discuss and possibly adopt the resolutions for final approval by the City Council. Any discussion happened after the press time.

City Council Approves Transportation Zones Ordinance

The City Council approved a proposed Ordinance that amends the Beverly Hills Municipal Code to establish a list of conditionally permitted uses for properties located in the T-1 and T-2 transportation zones, at their Tuesday meeting.

The proposed Ordinance is related to a request for a Conditional Use Permit to allow for temporary uses consisting of construction parking and the staging of construction materials and temporary offices at 9900 North Santa Monica Boulevard, associated with the construction of the One Beverly Hills project located to the north of the project site. The Planning Commission previously considered this ordinance and recommended that the City Council adopt the amendments. The site is currently a vacant lot. It has recently been used for construction and parking for the Waldorf Astoria project. The project site is located within the T-1, Transportation Zone, which is part of a strip of properties that run along the south side of North Santa Monica Boulevard.

The T-Zone Parking Map was established for the allowable uses in the T-1 and T-2 zones. Properties located in the zone were able to establish surface parking lot uses if the property was identified on the map. Originally the map included three city-owned properties. These properties were removed from the map when the properties were rezoned in 1998.

From 1998 until 2015, no eligible properties were included on the T-Zone Parking Map. In 2015, the City Council adopted a resolution to temporarily add 9900 North Santa Monica Boulevard to the map. This amendment allowed that location to be used during the construction of the Waldorf Astoria.

Part of the resolution made it so that

the map will automatically cease to be in effect at the conclusion of the sixth year, unless the City Council approves an extension.

Since this approval was not renewed prior to its expiration, 9900 North Santa Monica was removed from the map. Subsequently, the map does not identify any eligible properties at the moment.

It was proposed that instead of using a process where properties are temporarily added to allow for parking and construction-related uses, that the municipal code be amended to instead allow these uses be approved through a conditional use permit.

This is intended for a more regular process through which the Planning Commission may review each request.

Recruitment Period Now Open for Team Beverly Hills

Applications for the Team Beverly Hills program are being accepted now through Friday, July 14. Formed in 1996, Team Beverly Hills provides residents with a hands-on look at the operations of local government.

This program features a variety of class sessions and includes interactive experiences with many departments. Program participants explore the behind-the-scenes operations of the City including Public Works, Emergency Management, Information Technology, Community Services and Public Safety. At least 750 residents have completed Team Beverly Hills and over 70 percent of all current elected officials and City Commissioners are Team BH alumni.

The Team Beverly Hills program will select 50 residents (30 appointed by the City Council, 18 selected by a random lottery, and two selected by the Beverly Hills Unified School District) for its upcoming class. Five representatives from the City's business community that are appointed by the City Council will also be selected for the program, which kicks off later this year.
