Wells was the only candidate BHFA has interviewed so far.

"We are still in the process of meeting with other candidates for possible endorsement. We have not concluded that process, so it is still possible for more endorsements," BHFA President Vic Gutierrez told the *Weekly*.

### City Council Denies Appeal for 55 North La Cienega

The City Council denied an appeal of the Planning Commission's decision approving a Development Plan Review and Density Bonus Permit to allow the construction of a new mixed use development, located at 55 North La Cienega Boulevard, at last Tuesday's meeting.

On July 5, Lozeau Drury LLP, on behalf of Supporters Alliance for Environmental Responsibility ("SAFER"), filed an appeal, seeking that the Council require additional environmental review for the project.

Specifically, that the project may have a "significant impact on air quality as they assert that the project would likely expose future residents living at the project to significant impacts related to indoor air quality, and in particular, emissions of the cancer-causing chemical formaldehyde that may be present in modern building materials."

On June 22, the Planning Commission adopted a resolution approving the construction of the development. The project site is currently developed with a vacant commercial building that was formerly used for the restaurant "The Stinking Rose".

The project includes the demolition of the existing vacant commercial building and the construction of a mixed use project with ground floor retail spaces and 105 units for rental above the ground floor, 11 units of which would be reserved for very low-income households.

The Commission's approval of the Development Plan Review and Density Bonus Permit included incentives/concessions, to accommodate the provision of the 11 proposed affordable units.

The incentives/concessions included the following:

- Building Height: Increased the building height from 45' to 66'-6";
- Number of Stories: Increased the number of stories from three to six; and
- Rear Setbacks: Reduced the rear building setback on the third and fourth floors from 20' to 16'

According to the staff report, the appeal was based on new information that was not considered nor presented to the

Commission as part of the original project approval.

### Arts and Culture Commission Approve Proposed Site for Installation of Trinity by Judy Chicago

The Arts and Culture Commission approved the proposed site for Trinity by Judy Chicago in a 3-2 vote, with Commissioner Liliana Filipovic and Vice Chair Karla Gordy Bristol abstaining, at Tuesday's meeting.

The selected location was expected to

be at the Northwest corner of Crescent Drive and South Santa Monica Boulevard adjacent to the Crescent Drive parking structure at City Hall. However, the Council decided it would be best to install the statue at Beverly Gardens Park. The Council also previously directed staff to secure a 10-year warranty from the fabricator, Ironwood.

Staff was informed that Artist Judy Chicago no longer supports Beverly Gardens Park as the installation location. The piece is now being proposed to be showcased adjacent to the Wallis An-

nenberg, in the former site of the temporary installation Coups de Pinceau by Roy Lichtenstein that was placed there in 2013.

With the new proposed site, the installation will require additional elements:

- Excavation of the cement Lichtenstein base
- Reroute irrigation drip lines
- Re-configure the lighting electrical grid
- New landscaping

These items will exceed the original request for \$150,000 for ancillary costs. The Commission approved a fee increase of at least \$100,000 to accommodate the additional site work required to install the artwork at this location. This will bring the overall acquisition and installation to a not-to-exceed cost of \$650,000.

Filipovic brought up concerns with the rising cost of the project due to it taking so long to go through the approval process, as well as the location not being ideal for foot traffic as it will mostly be seen as people drive by.

These items will be brought to the City Council Liaisons for approval and then brought before City Council for final approval.

### Board Approves COVID Contact Tracing Contract for 15k

At Tuesday's meeting the Board of Education approved an agreement with

### Architectural Commission Reviews 227 South Tower Drive

At their Wednesday meeting the Architectural Commission was expected to discuss a new five-story, ten-unit multi-family residential building with landscaping at 227 South Tower Drive.

The proposal is for a new multifamily building to replace the existing two story duplex structure at the subject site.

On July 14 the Planning Commission approved the applicant's request for a Development Plan Review to construct the building over one level of subterranean parking with a Density Bonus. Additional incentives were granted in conjunction with affordable housing units provided on site.

The Commission was expected to hold the public hearing to discuss the project details and possibly provide the applicant with an approval.

The planned meeting was expected to occur after *Beverly Hills Weekly's* deadline.

### Turf Replacement Project at Hawthorne Completed

As of Oct. 19, the turf replacement project at Hawthorne Elementary School has been completed.

The District believed the turf needed to be replaced because it failed to pass GMAX testing. The replacement was considered an emergency due to safety issues, the loss of the school programming, and JPA access.

This project was completed for a total cost of \$424,458.

### BHPD Awarded Grant from the Office of Traffic Safety

The Beverly Hills Police Department was awarded a \$80,000 grant from the California Office of Traffic Safety (OTS). The grant will support ongoing

enforcement and education programs that are intended to help reduce the number of serious injuries and deaths on the road.

"This funding will strengthen our commitment to public safety in our community," Police Chief Mark Stainbrook said. "We will be able to increase our efforts in making our roads safer for everyone and focus on critical areas such as distracted driving, impaired driving, and speeding."

The grant will provide additional programs and resources, including:

- DUI checkpoints and patrols focused on stopping suspected impaired drivers.
- High visibility distracted driving enforcement operations targeting drivers in violation of California's.
- Hands-free cell phone law.
- Enforcement operations focused on the most dangerous driver behaviors that put the safety of people biking or walking at risk.
- Enforcement operations focused on top violations that cause crashes: speeding, failure to yield, stop sign and/or red-light running, and improper turning or lane changes.
- Officer training and/or recertification: Standard Field Sobriety Test (SFST), Advanced Roadside Impaired Driving Enforcement (ARIDE), and Drug Recognition Expert (DRE).

The grant program will run through Sept. 2024.

### Founder Of Beverly Hills Luxury Watch Consignment Store Charged With Defrauding Victims Via Ponzi-Like Scheme

A Los Angeles man who previously operated a business in Beverly Hills known as "Gentlemen Timepieces" appeared in court last week after his arrest by FBI agents on charges of defrauding customers of his luxury watch consignment business.

Anthony Farrer, 35, who until recently lived in downtown Los Angeles, was charged in a federal criminal complaint with wire fraud, a felony that carries a statutory maximum sentence of 20 years in federal prison.

Farrer, who also was known as "The Timepiece Gentleman," was arrested at a storage facility in Venice and was held in federal custody overnight. He made his initial appearance in United States District Court, and an arraignment was scheduled for December 14.

According to an affidavit filed with the complaint that was unsealed, Farrer founded the company in Texas in 2017 and opened a location in Beverly Hills in 2022. Farrer used this business to connect purchasers and sellers of high-end watches. He would typically collect a watch from an individual and have them sign a consignment agreement that stipulated he would collect a commission from the sale, typically 5 percent.

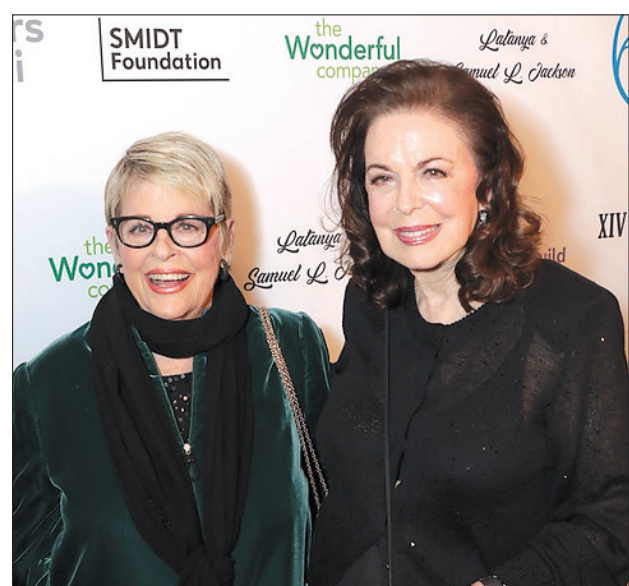

until the summer of 2023, when he promised customers he would sell their luxury watches on consignment. Rather than remitting funds back to the customers less the commission, he kept the proceeds for himself.

Farrer lived in a luxury rental property and was known to drive a Lamborghini and Ducati motorcycles. He traveled frequently to, and engaged in gambling in, Las Vegas, according to the complaint.

Farrer induced victims into wiring funds for the purchase of luxury watches and, instead of purchasing the agreed upon watch, he would send them a different watch, the complaint alleges. In one case, a victim received a Rolex watch from Farrer in lieu of money Farrer owed, but the Rolex belonged to another victim who had provided the watch to Farrer to sell on consignment and did not authorize Farrer to use the watch as payment for his debts to other victims.

The complaint further alleges that Farrer operated a scheme in a similar manner to a Ponzi scheme and would lull victims into a sense of security by engaging in smaller successful transactions prior to requesting or engaging in significantly larger transactions.

Multiple victims contacted law enforcement to report that they wired funds to Farrer for the purchase of a watch, or mailed him a watch to consign for sale, but were never paid for the watch or never received their watch back. To date, law enforcement estimates that victim losses currently total approximately \$3 million. The investigation is ongoing and law enforcement is in the process of identifying additional victims.

Farrer apparently abandoned the Beverly Hills store in Aug. 2023 and began posting about his various travels throughout the United States on social media. As recently as Oct. 2023, Farrer

continued to advertise watches for sale on his social media platforms, according to the complaint.

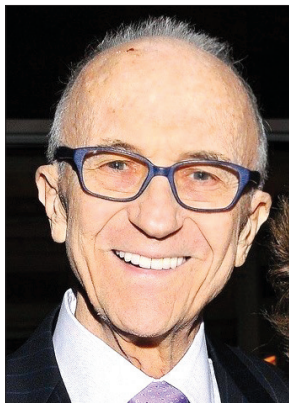

## OBITUARIES

### Charles “Chuck” Aronberg

August 30, 1930 - November 9, 2023

Former Mayor of Beverly Hills Charles “Chuck” Aronberg moved to Los Angeles at the age of 10 after his father died. Chuck graduated from Los Angeles High at the age of 15, attended college at UCLA and medical school at UCSF. Chuck dedicated his life to the service of the community and others, including 12 years on the Beverly Hills City Council (1972 - 1984) and being the first male member of the League of Women Voters. Among the public health causes he championed were his work to secure seat belt legislation, and clean air and clean water legislation on both a local and federal level. Chuck was awarded Alumnus of the Year for Community Service at UCLA. An ophthalmologist devoted to his patients, he was also a leader in the field of sports medicine as team doctor for the Lakers, Kings, Raiders and for three Olympic Games. A recognized medical expert and qualified medical examiner, Chuck treated Rodney King after the infamous beating, and provided meaningful testimony in the pivotal Federal Civil Rights trial. He was also a proud SAG member with 12 film credits. May his life of service and commitment to his profession and community be a source of inspiration to all who knew him. He is survived by his wife Sandra Aronberg, MD, daughter Cindy Aronberg, and his grandchildren Leo Rheinheimer and Kate Rheinheimer.

## WHERE WERE YOU WHEN JFK WAS SHOT?

### Residents Discuss Where They Were When They First Heard The Legendary News

I was 15 years old and a sophomore at St. Paul's Catholic High School in Santa Fe Springs, California. I had never seen the nuns who taught me so

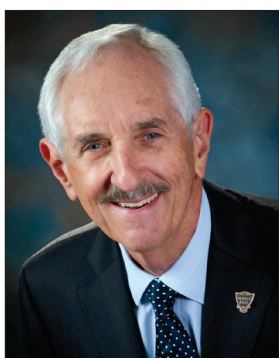


I will never forget that day. I was at law school at UCLA. My wife [Lynn] was at the medical school on the south end of campus. We had

There was that unbelievably sad picture of Jackie Kennedy in her blood stained suit. There was not a dry eye in the room, and just dead silence. It was just something that was totally incomprehensible.

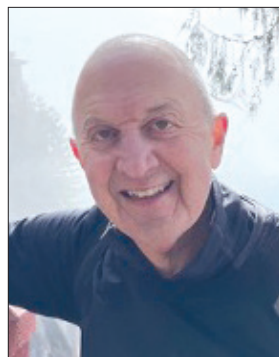


I was standing on the playground at Horace Mann School waiting for a class to arrive. It was my first year teaching Physical Education in the District.

I was Editor in Chief of the twice weekly (Fridays and Tuesdays) student newspaper and the Friday edition had just been published.

Someone who had been watching television nearby shouted out: "The President has been shot!" I watched the 13 inch black & white screen for a few minutes and rushed to the newspaper offices to create and manage our coverage of the shooting (we did not immediately know that the President was dead) for the Tuesday November 26 edition.

The Tuesday edition had a banner headline that read: "CAMPUS MOURNS KENNEDY"

I wrote a front page editorial entitled "A Challenge".

It read in part: "Political opinions and ideologies have seldom been so tenaciously held and violently expressed as they are today. Hate for our fellow man has seldom been so widely articulated and accepted. This tragic event was the paramount articulation of this hate and misunderstanding all too widespread in these times. "These all-encompassing hatreds are the heritage of America's youth. It is the duty of our generation to destroy it and wipe out all traces of its odious existence. The possibilities for freedom and genuine civilization of the world depend on our response to this challenge."

And how is that working out?

I was in the 8th grade in Fresno, California coming out of a Speech Arts class. I ran home worried the assassination represented an attack by Russia.

He said to me, "Hey, if the Russians were to decide to launch an attack, Fresno would be the last place they would target."

The next week of national mourning was somber and poignant. I will always remember the riderless horse in the funeral procession and John-John's salute.
