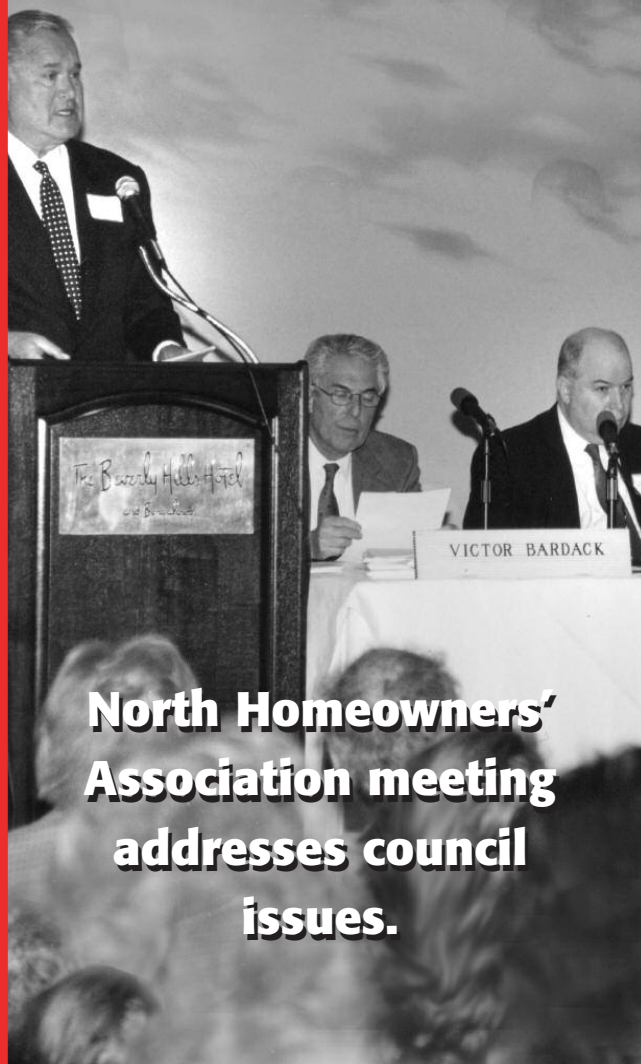

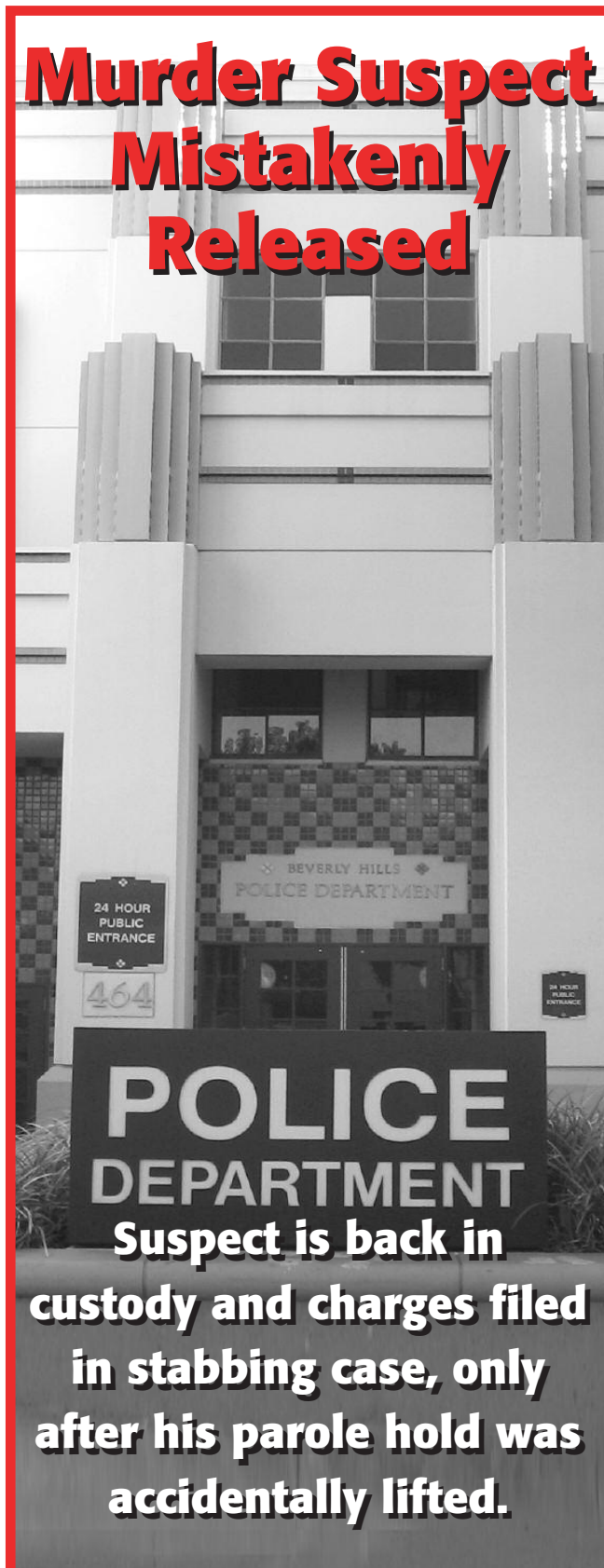

The City Council of Beverly Hills, at its REGULAR meeting to be held on Tuesday, February 7, 2006, at 7:30 p.m., in the Council Chambers of the City Hall, 455 N. Rexford Drive, Beverly Hills, CA 90210; will hold a public hearing to consider the following two ordinances regarding Common Interest Developments:

1. AN ORDINANCE OF THE CITY OF BEVERLY HILLS AMENDING REGULATIONS APPLICABLE TO COMMON INTEREST DEVELOPMENTS, AND AMENDING THE BEVERLY HILLS MUNICIPAL CODE (continued from January 3, 2006)

At its meeting of September 29, 2005, The Planning Commission adopted a resolution recommending that the City Council adopt an ordinance to amend Article 7 of Chapter 2, Title 10 of the Municipal Code regulating common interest developments or "CIDs" (e.g., condominiums, housing stock cooperatives, planned unit developments and community apartments); Article 28 regarding multi-family residential development standards; Article 30 regarding Architectural review criteria; Article 31 regarding Development Plan Review standards; and the City's General Plan to reflect that these changes will be consistent with the goals and policies of the Housing Element.

2. AN ORDINANCE OF THE COUNCIL OF THE CITY OF BEVERLY HILLS EXTENDING ORDINANCE NO. 05-O-2465 ENACTED PURSUANT TO CALIFORNIA GOVERNMENT CODE SECTION 65858 AMENDING REGULATIONS APPLICABLE TO COMMON INTEREST DEVELOPMENTS AND DECLARING THE URGENCY THEREOF

The proposed ordinance extends the expiration date of an interim ordinance regarding Common Interest Developments, which expires on March 2, 2006. This extension would allow the urgency ordinance to remain in place pending adoption of a comprehensive ordinance regulating these types of developments.

These projects have been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the environmental regulations of the City. No significant environmental impacts are anticipated; therefore, a Negative Declaration has been prepared.

All interested persons are invited to attend and speak on this matter. Written comments may also be submitted and should be addressed to the City Council, c/o City Clerk, 455 N. Rexford Drive, Beverly Hills, CA 90210 and should be received prior to the public meeting.

Originally approved as a Track I project, requiring only city staff approval, the Design Review Commission overruled staff on Monday, voting 4-1 to recommend the project at 800 North Linden Drive to the City Council as Track II, requiring commission approval. Chairperson Hamid Gabbay cast the only dissenting vote.

Commissioner Eleanor Schapa said at the meeting "this has to be one of the most garish, inappropriate pieces of architecture I have ever seen." Schapa continued to say the design is not Italianate nor Greek Revival and is out of scale and mass with the surrounding homes.

"We have seen way too many homes that are

not what this city is about," Schapa said.

As reported last week in the *Weekly* [issue #330], construction plans for a home at 800 North Linden have created divide among residents and the project's developer over one property owner's right to privacy and another's right to approved construction.

Neighbor Robert Schwab at 802 North Linden, opposes the approved plans for a new, larger house directly next door at 800 North Linden and further expressed his discontent at Monday's Design Review meeting, along with his attorney Ron Rosen, who urged the com-

AN ORDINANCE OF THE CITY OF BEVERLY HILLS AMENDING REGULATIONS GOVERNING ALTERATIONS TO NONCONFORMING BUILDINGS AND AMENDING THE BEVERLY HILLS MUNICIPAL CODE.

Under the city's current regulations governing remodels and alterations to nonconforming buildings, the threshold at which a remodeled building loses its nonconforming rights and is required to be built to current zoning standards (with respect to setbacks, height, etc.) is based on the percentage of the replacement cost of the building. The proposed Ordinance would amend these regulations for buildings on single family lots and will employ an objective method to determine this threshold by calculating the percentage of the combined area of the roof and exterior wall that is removed or replaced.

The City has determined that it can be seen with certainty that there is no possibility the adoption and implementation of the proposed Ordinance may have a significant effect on the environment. The Ordinance is therefore exempt from the environmental review requirements of the California Environmental Quality Act pursuant to Section 15061(b)(3) of Title 14 of the California Code of Regulations.

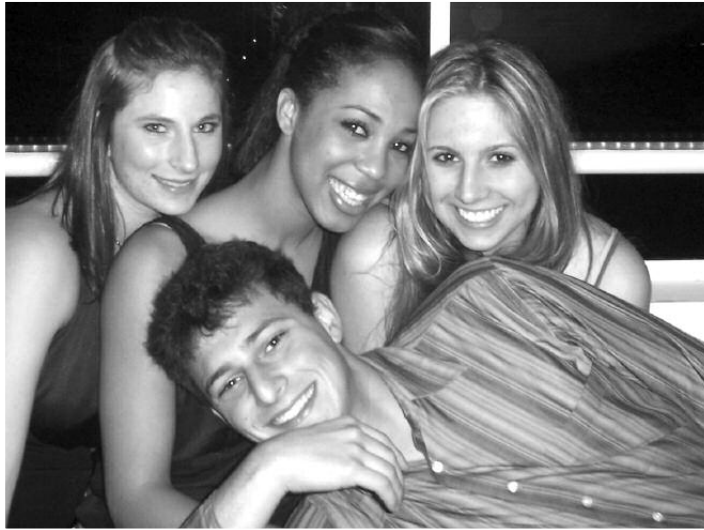

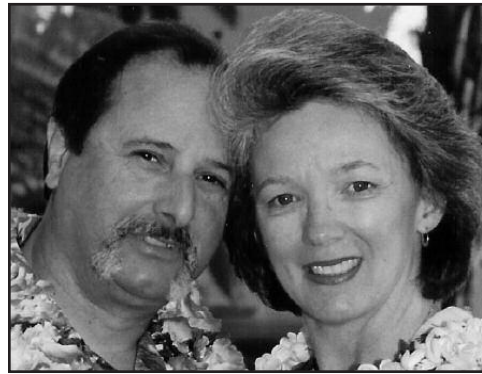

How did you both get to Beverly Hills?

Roxie: I actually started in the district in October of 1978, at Horace Mann as a playground aide. I worked at Horace Mann for seven years and then I went to work at the high school in the library and I also did all the transcripts. I started over there as a clerk and I worked for seven departments. Then I got a job in December of 1989 working at the district office. I was over there in a position called "Instructional Media Computer Operations Specialist." I was there for a number of years until September of 2001. My position had been eliminated over there [at the district office] and I went back to the high school in 2001, and cannot recall the position they gave me, but I was in that position for approximately a year. Then I was asked to go down to the Maintenance and Operations Department and I was a sec-

retary there until I retired in December of 2003.

Lyle: I started April Fools Day, 1977. [Former Superintendent] Ken Peters hired me. I started off as a plumber and then I advanced to senior plumber. The senior plumber at that time was John Carolan and he retired. I was a plumber for about 11 or 12 years and then I was promoted to Buildings and Grounds Manager around 1988-1989. I ran the maintenance department all those years and you get to know a lot of people. After the [Northridge] earthquake in 1994, I was given a special award for being one of the only people that responded to the district after the earthquake because I lived so close. I was able to shut down all the buildings and the gas and the water, and I prevented probably thousands of dollars worth of damages. The only



administrator that was able to respond at that time was [former Assistant Superintendent] Bert Pearlman [interviewed in issue #206] and a few board members like AJ Willmer, Jo Ann Koplin, Lillian Raffel [and] Richard Stone. So between all of us we took care of the building. We probably worked about 24 hours straight getting the buildings all shut down. At Beverly Vista, the B building is still shut down.

I retired in September of 2002. My position was eliminated as Buildings and Grounds Manager and they moved me over to be the Athletic Facilities Manager. It was a wonderful last year of my career with the school district. I had to retire because while I was out, I had to have surgery. I found out while I was having surgery, they eliminated my position over in the gym. The doctors wouldn't let me come back to work as a plumber. I had rights to go back to one of my original positions as plumber, and I was basically forced to retire. I couldn't continue the manual labor type of job. I had been a manager all those years. [Superintendent] Jeff Hubbard was supposed to work some-

thing out for me, but I guess he was too busy trying to become the new superintendent and he forgot about us old-timers. I don't want to go into that, but I worked with a lot of wonderful people.

Who were some of the people you remember working with most?

Lyle: Ken Peters was wonderful. [Former Superintendent] Sol Levine is my favorite. I loved working with Sol. He was such a wonderful person. I worked with [former Superintendents] Bob French [interviewed in issue #223] [and] Leon Lessinger. After Sol Levine left, in my opinion, the school district started to go a bit downhill. A lot of new people came in, interim people, and they were trying to make names for themselves. It seemed like they wanted to get rid of the old-timers. We might have been a threat to them, I don't know. I might have still been working there.

Roxie: I worked with some wonderful people. When I started out at Horace Mann Rita Piccone was the secretary and I also worked with Mary Shushan and just a number of wonderful teachers-- Ron Brown, Bliss Trafton, Steve Kessler, just a wonderful group of teachers over there. Then when I went to the high school, actually, Sol Levine who hired me, he was at that time the principal of the high school. I had a real nice rapport with Sol. I truly enjoyed working for him. He was a real people person when he was in charge; just somebody that you could feel real comfortable talking to. At the high school I worked with a number of great people over the course of the years.

When I went to the district office, Jan Miller was over there [and] Eloise Metcalfe [interviewed in issue #275]. I actually went to work for [former Beverly Vista Principal] Dave Reinstein at the district office and he was a wonderful man, and [Former Assistant Superintendent] John Scoggin. Corolla Drew, was a wonderful lady who [recently retired].

The last four years I was at the district office I was the union president for the office of technical employees and that was a wonderful experience. Of course I was very good friends with [El Rodeo Office Manager] Susie Wallach. I got to know people all over the district because the job I had allowed me to communicate with all the staff-- the office staff, the custodial staff. [Former Beverly Vista Assistant Principal] Fred Rutberg [interviewed in issue # 213], another wonderful man, he retired some years ago, with [Former Beverly Vista Principal] Nadine Breuer. There were some people that I had some difficulty with, but then again, I think we all do. I have to say, at the district office Bert Pearlman [was] just a jewel of a man. I can't say enough good things about Bert. He was my boss over there. We had a fantastic rapport with one another. And then of course there were the board members I was friendly with as well-- Jo Ann Koplin; Lilian Raffel; Dana Tomarken; Frank Fenton, who Lyle and I were both friendly with; Betty Wilson; and Mark Egerman. Generally speaking, just a really good group of people to work with. A very good friend of Lyle's and mine who left the district [is] Barbara Miller [interviewed

in issue #319], whose position was eliminated. She was a terrific person. As a matter of fact, we're still friends. I actually knew her before she went to work in the district. I will echo what Lyle said about Sol Levine-- when he was there, you felt like it was family. There was just a real close feeling in the district. When he left that seemed to fall apart a bit, everyone seemed to have their own agenda. It was just a different atmosphere in the district. I could feel it working at the district office because I was right there at the hub of everything going on.

What was your role in the teachers union?

Roxie: I was the union president of the office and technical, and years before me Lyle was the president of the classified union, which incorporated at that time all the maintenance and operations staff of the trades people, the custodial people, the secretaries, the cafeteria workers. It was everyone that was a classified employee. And then the unions split, and the union that I was in charge of, the office and technical, was all the office staff, the clerical staff and so forth in the district. I was a co-president with Stewart Horowitz and then he was president. When Stewart stepped down, [Adult School Principal] John Borsum became the president and so I worked with both of them.

Lyle, we understand that you were part of the Disaster Communication System (DCS). What was your role?

Lyle: I was actually one of the co-

founders with the Beverly Hills DCS. I worked with [BHPD Officer] Ron Derderian. He's still there in emergency management. I was pretty instrumental in bringing the emergency system to the school district and getting everybody certified how to use a HAM radio in case of emergency.

Tell us about the DCS?

Lyle: It's a "disaster communication system." In case of a disaster or emergency in the city, it puts everybody in radio contact with the police department. The school district, being the evacuation centers for the city, was a very important department to be in contact with so we could get the buildings ready. That was my part of it. And plus, the children, in case it happened during school hours, of how to communicate with the police department and get the children home to their parents. It was a wonderful experience.

Who did you train for DCS?

Lyle: All the administrators at that time. We had classes and got everybody certified with the HAM Radio Operators license. We used to have practices continuously with the police department and the school district. A lot of community members, [like] Nancy Blumenfeld was a very big part of the DCS, and [former Board of Education member] Jo Ann Koplin. It was very well-received by the district. I did it all voluntarily and I got a commendation from the city for volunteer service to the City of Beverly Hills and nice dinners and stuff. It was great to be a part of that.

As you know a lot of the buildings in Beverly Hills were built in the 1920s and 1930s. Did you experience any problems because of the age of the buildings?

Lyle: Oh, god yes. Basically, we kept them all running in the conditions that they were in, up until the bonds were passed where they would have funds to modernize them. It was quite a task, believe me, to provide heating and air conditioning in the buildings. We desperately needed those bonds to pass, and they did. And hopefully the schools are in better shape. I provided a lot of the history of construction before the projects got underway and a lot of the new people, unfortunately, didn't want to listen to us old-timers that knew a lot about the history of the buildings. They wanted to do things their way, and we had no choice but to let them do it their way. There was a lot of money spent, that in my opinion, if they did a little research or listened to the information that they had right under their noses, they could have saved probably millions. But that goes without say. I hope everything turned out alright. I drive through town once in a while, and still Beverly Vista is boarded up. I'm in touch with some of the guys. Once and a while they call me to see how things are and they say they still have some problems.

Who do you keep in touch with?

Lyle: I speak to Eddie Casiano, Eddie Sabocor, and Alfred Ruiz calls me once in a while to see how I am. Jim Fahey is the director of maintenance and used to keep in

touch with my wife. [Former Assistant Superintendent] John Scoggin [and] Susie Wallach we're in touch with quite often.

What is one of your most interesting memories while working for the district?

Lyle: President [Ronald] Reagan landed his Marine One helicopter on the football field during his first year as President. My job was to turn the sprinklers on and wet the field down and then turn the systems off. It was such a memorable event to have President Reagan land on the football field. He came there about three times. One time he got so close it blew all the roof shingles off of the dance studio.

How did you two meet?

Lyle: I'm going to let Roxie tell you that one; it's a funny story.

Roxie: Well, we met in the summer of 1965. They used to have drive-in movies, where you drive your car in and park it and watch the movie. The Edwards drive-in in Arcadia, that's where we met. We dated one year, we were engaged for two while Lyle went to Vietnam. He was drafted and when he returned from Vietnam we got married in July 1968.

Tell us about your family?

Roxie: We have two daughters, Heather Muth ('87) and Jennifer Gerber ('89). They both are Beverly graduates and both went to Horace Mann. Jennifer still lives in the city; she's a very successful business woman in promotional advertising. My daughter Heather, she lives in the Santa Clarita Valley and she's married with three wonderful children-- a son and two daughters.

Is there anything else that either of you would like to share with the community?

Lyle: After my 25-plus years of service, and I felt pretty hurt, the school district never recognized me for my 25-plus years of service. I know my name was turned in as a retiree and I never got the recognition that everybody else gets [with] the little plaques and everything. It bothers me. I spent a good part of my life there. I worked with the city before I came to the school district and between my city service in the Public Works Department and the school district, I walked out of there with 32 years of service and 25 plus years at the school district. And that really bothers me.

Roxie: I retired with 25 years of service to the district. So between the two of us, we gave [BHUSD] a lot of years. Although in return, they educated our two daughters.

How are you enjoying retirement?

Roxie: Well, of course we enjoy our grandchildren as often as we can. We've done some traveling. We're just enjoying life meeting new people in our community [and] getting involved with them.

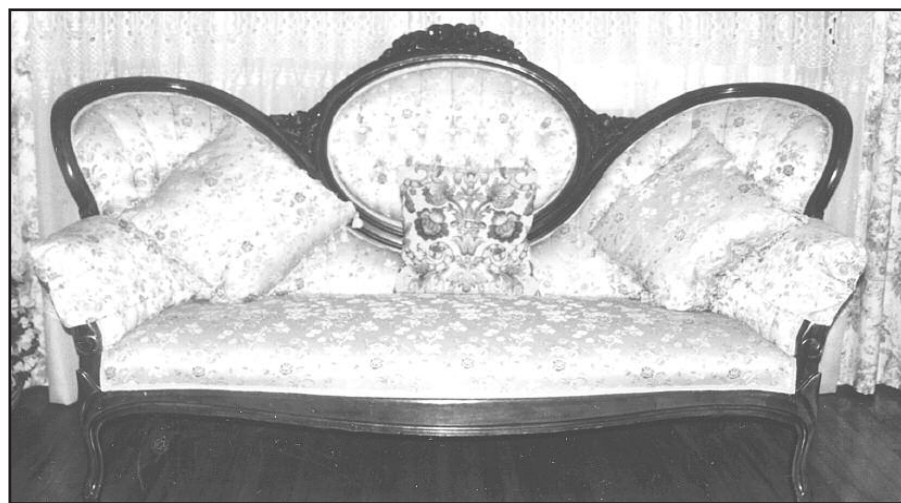

Condominium prices in the Beverly Hills 90210 decreased on six condos by 27.4 percent, increased in the 90211 on one condo by 13.8 percent and increased on three condos by 69.9 percent in the 90212.

The median price for single-family residences in the 90210 zip code is \$2.1 million; in the 90211,

\$1.375 million; and in the 90212, \$1.852 million.

The median price for condominiums in the 90210 zip code is \$718,000; in the 90211, \$760,000; and in the 90212, \$1.47 million.

In Los Angeles County as a whole, sales of single-family residences are up 19.3 percent to a median price

of \$520,000, and condominium prices are up 18.3 percent to a median price of \$400,000 since December 2004.

BHEA To Negotiate With School District On Hours Monday; Agreement Reached On Salaries

Since September the Beverly Hills Education Association (BHEA) has been in negotiations with

the BHUSD regarding two articles of the teachers' contract including salaries and hours, the latter of which will begin Monday.

Salary talks, concluded last November, yielded a 4 percent increase in teachers' pay, according to BHEA President Chris Bushee. This increase applies to hourly rates across the board, including substitute pay, as well as additional stipends paid to teachers for overseeing extracurricular activities such as coaching sports teams. The new pay rates, which apply retroactively from July 2005 through 2006, were reached through an interest-based problem solving model. As opposed to traditional negotiation, where both parties come to the table with set demands and compromise accordingly, Bushee said, talks began with the two sides agreeing upon their mutual interests, for example, increased morale among teachers.

From there, they were able to mutually come up with a figure that would satisfy both sides, Bushee said.

Regarding hours, the issue at stake is the current structure of the school day for K-8 teachers, and whether it should be changed to allow for greater flexibility. A similar change made to the high school teachers' contract last year resulted in a bi-weekly double period, which created three hours of "unstructured" time during the school week, to be used for activities such as labs, assemblies and make-up tests. The bargaining teams are in the process of surveying the BHEA membership to gauge teachers' attitudes towards the current K-8 schedule.

There is no firm deadline for when negotiations will conclude, but Bushee expects final decisions to be reached by summer.

"Heart to Heart with the Mayor"

In recognition of February as Women's Heart Month, Mayor Linda Briskman, in partnership with Cedars-Sinai Medical Center, recently hosted a luncheon, "Heart to Heart with the Mayor."

"My goal is to raise awareness about how heart disease affects women. When people think about heart disease, they immediately think of it as a man's disease," Briskman said. "However, heart disease is the number one killer of women in the United States. Over 6 million American women have heart disease and one in two will die from it."

Briskman learned about these statistics at a presentation on women and heart disease at the U.S. Conference of Mayors in Washington, D.C. Women mayors were challenged to bring what they learned back to their communities. When she returned, Briskman met with cardiologist Dr. C. Noel Bairey Merz, holder of the Women's Guild Chair in Women's Health and Medical Director of the Women's Health Program and the Preventive and Rehabilitative Cardiac Center at Cedars-Sinai Medical Center, to discuss reaching out to the community.

Female executives and leadership from professional and civic organizations were invited to the luncheon held at Spago to hear Dr. Merz speak about this issue.

"The purpose of your being here today is for you to take information back to your organizations and workplaces to help spread the word about the importance of heart screenings and preventive measures in women," Briskman said at the luncheon.

The program began with a video presentation, "A Woman's Heart", which illustrated the failure to recognize and diagnose cardiac events in women. This program will be aired for the community throughout this month on the city's cable access channel, BHN-10. Check the city's program guide or website at www.beverlyhills.org for air dates and times. Dr. Merz advocated that women of every age take responsibility for their own personal health by seeking health care to determine their risk early in order to prevent future problems.

According to Dr. Merz, research in heart dis-

BHUSD To Sell Salvaged BV Materials

Most of the stuff worth salvaging we're reusing in the building, so it's hard to say because we're putting it back into the existing structure. So we may not have too much that's valuable."

Demolition of the western side of the B Building will begin in March.

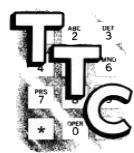
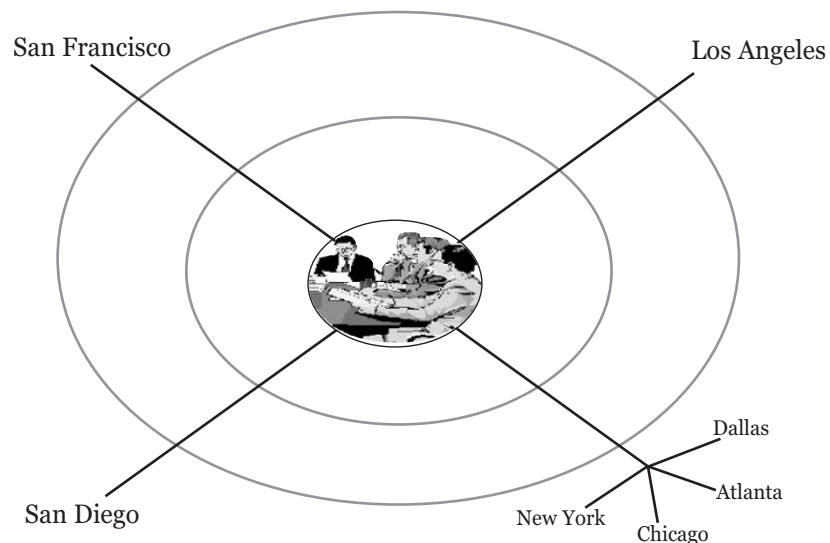

mission to allow this project as a Track II design and to allow the architect redesign the residence.

Schwab believes the new remodel will impact the amount of privacy at his residence, but insisted at the meeting it is not just a privacy issue and that he doesn't want to "make the neighborhood any worse."

Through the course of construction, trees that serve as a border between the two houses will be eliminated, creating a direct view of Schwab's backyard from second-story window of the new residence.

800 North Linden owner Laarni Omingo, who is building the home as a "spec" house, was also in attendance.

Stuart Raffel and Steven Lewis spoke on Schwab's behalf.

All construction in the city is classified under Track I or Track II and the property to be built on the corner lot of 800 North Linden, a two-story Italian villa style residence with a basement, originally fell under Track I jurisdiction. The application was reviewed by staff and approved last December. Under Track I the property owner chooses a design from a catalog the city provides and construction can commence once the design has been approved by staff.

If the proposed development is not represented in the catalog, the construction is categorized as Track II and property owners must seek approval from the Design Review Commission.

The commission's main objective Monday was to issue an advisory opinion to the City Council. Commissioners had to come to a conclusion on whether they felt the proposed project, which is within code, is a "pure" Italianate design, which does not need to be sent to the

Design Review for discussion.

Robert Weiss, attorney for the real estate company for 800 North Linden, said at the meeting Rosen "deliberately misled the commission" into thinking that his client's opposition only had to do with the design, but really had more to do with landscaping.

Commissioner Brandy Alexander Kern said

she doesn't believe it is an Italianate style, adding, "It looks like it belongs in Palms Springs on a golf course."

"Because of the privacy as well as the style, I think it is Track II," Kern said at the meeting.

Commissioner Gary Gilbar, who is also an architect, also said he believed it was not a "true style."

"If we had been asked before, this house should have probably come to us in the second category," said Gilbar, who also said he felt bad for the applicant.

Gilbar added that he feels almost every proposal should come before the commission for review.

Gabbay, an architect, agreed.

"Absolutely. There is a group of people

against that, but every city and neighborhood has an Architectural Commission and a Design Review Commission and I don't understand the rationale that we shouldn't do it," Gabbay told the Weekly. "We paid a heavy price just by postponing creation of a commission and right now this new code is somehow benefiting the city, but still there are some areas that are not clear cut

and until we have a clear legislation for projects, we will be facing these issues."

At the meeting, Joe Tilem, attorney representing Omingo, said, "It is not the role of this com-

mission to have every house come before them" and that is the purpose of having the ordinance include Track I and II.

"My client met every standard asked by staff and staff did make the determination," Tilem said at the meeting.

"It's very interesting. They submitted a design, called Italianate, to the city after going through the book for standard styles accepted by the city. They submitted a plan to the Planning Department and [Director] Mahdi Aluzri and he consulted with the two architects on the commission, Gary Gilbar and Hamid Gabbay, and came back with a list of nine changes and directed our

architect to make the changes to stay in Track I," Tilem told the Weekly. "We thought that was the end of it and it was not. One of the elements changed was something that this particular commission didn't like. We're back to designing a home designed by five people. It's almost a distortion of what was intended by the council."

Tilem's client cannot move forward until the matter is heard by the council, and he said the delay is costing her about \$2,000 a day.

"It can happen to any single homeowner who decides to buy land in Beverly Hills and build on it," Tilem said.

Gabbay said he wasn't "going to say that staff made the wrong judgment."

"Based on the guidelines at the beginning of our commission that we gave to the staff, they went ahead and decided first that this project had to come to the commission and in almost four meetings with staff, the owners have changed so much of the facade already that in my opinion it was complying with the style represented," Gabbay said after the meeting.

"I think the owners of the house have done everything that staff and the Planning Department have asked them to do and it's wrong to punish to them," Gabbay added.

The council may hear the issue on Tuesday.

"There's always a project in the history of a new ordinance that presents the city with a great opportunity to direct that the right action be taken to implement the intent and purpose of an ordinance," Rosen told the Weekly. "This project presents that opportunity. We are hopeful the council will confirm the recommendation of the DRC [Design Review Commission] to send this to them for a Track II review as intended by the ordinance."

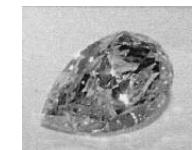
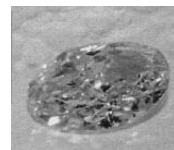

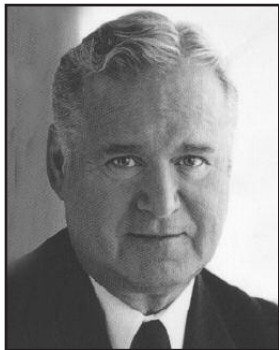

HEATED MEETING REFLECTS COMMUNITY DISSENT

North Homeowners' Association meeting addresses council issues.

It was standing room only at last week's joint town hall meeting of The Municipal League and Beverly Hills North Homeowners' Association, with the mayor and fellow council members at the center

of discussion.

League and Association leaders made sure to mention that all comments made by representatives and audience members were being recorded and would be sent to council members.

Moderated by former Mayor and North Homeowners' Association Secretary Robert K. Tanenbaum, seated at the dais included North Homeowners' President Victor Bardack, Municipal League President Thomas White, Betty Harris, Lou Lipofsky and Marilyn Gallup.

The packed house of more than 200 also included such city and school district officials as Councilmembers Barry Brucker and Jimmy Delshad and Board of Education President Myra Lurie. Councilmembers Frank Fenton and Steve Webb were not in attendance. Mayor Linda Briskman was in Washington, D.C. on city business.

Kicking off the meeting, Tanenbaum briefly commented on Briskman's column in the *Weekly's* "Ring" column in issue #330, to which he refuted.

After introducing the night's speakers, Bardack prefaced the evening saying, "We support development, but development that is compatible with the General Plan," like such developments as The Rodeo Collection, that is within code.

In keeping with the points made in the Association's mailer, Harris, the city's representative on the Metropolitan Water District Board, discussed the 26 percent compounded increase in the city's water bills by July of this year. Harris said she thinks the raise, which began last July with a 6 percent increase, last month with 8 percent and July with 12 percent, is "terrible."

"MWD has not raised its rates like that," Harris said at the meeting. She added after the meeting that it only raised its rates by about 3.5-4 percent this year.

With a Water Enterprise Fund intact, Harris said, "I don't know what they're spending the money on," and according to Tanenbaum, the North Homeowners' Association plans to investigate.

"One question that's lingering out there is

what is the state of our enterprise funds? Substantial millions have been taken out and where have they gone and how does the council expect to repay them?" Tanenbaum said after the meeting.

The problem, she said, is we're running out of water, and there's going to be an intensive campaign in the city to conserve water. Harris added that seven states pull water from the Colorado River, including California, and with their demands the river doesn't have as much water as it used to.

"They're trying to adjudicate it and there is no agreement," Harris said after the meeting.

Association member and attorney Larry Larson was also asked to speak about the Montage project, more specifically addressing another comment made by Briskman in the *Weekly* article: "There is no \$32,270,000 debt service obligation. The City is loaning money to itself (from one fund to another) at a 6 percent rate. Interest will not be owed or paid to any third party." To this, Larson said there's "never a loan that doesn't have to be paid back."

Attorney Robert Silverstein, representing the Alliance in the Montage Hotel/Measure A appeal, presented an update to the audience on the status of the appeal, to which he said the case will soon be in front of the California Court of Appeals. With The Athens Group already having commenced demolition on the site, Silverstein said "they do so at their own peril" and "the fight continues."

Lipofsky then took to the podium to speak about ethics in government. Citing a recent *Weekly* article regarding a new state law prohibiting council members from addressing the City Council to represent a client for at least one year after leaving office, he urged the audience to back a plan for terms limits and for City Attorney Larry Wiener to draft an ethics ordinance for council members. Lipofsky then pointed to a recent cocktail reception hosted by The Beverly Hilton celebrating the hotel's 50th anniversary in which guests, including BHUSD teachers, City Council members and many community members, received a gift certificate for a free night stay at the hotel.

An ethics ordinance, Lipofsky said, would include prohibitions on accepting free lodging and attendance at cocktail receptions.

"The council and community members are invited to numerous openings, parties and receptions. I have never seen nor would believe that any councilmember would ever compromise their integrity," Brucker said after the meeting. "Establishing a 'code of ethics' will insure that the 'public's work is done in public' and that there is a greater emphasis on community dialogue and input. At all times, an elected or appointed official

needs to go above and beyond in maintaining a higher standard of ethics so as to insure that there is no confusion or inference of any impropriety."

Brucker added that he's always endorsed establishing a "robust" code of ethics for elected and appointed officials and has requested that it be placed on an upcoming study session for discussion.

But what Brucker said he found "disturbing" was the association's implication of council members' receiving gifts from the Hilton.

"Three hundred community members were invited to the opening of the hotel and were given a voucher for a free night stay as a way of saying, 'Look and see how we have improved.' I have not used it and would not use it for two reasons," Brucker said after the meeting. "Firstly, as an elected official, with pending development proposals coming before our desk, I would find accepting any gifts of this nature and magnitude inappropriate. Secondly, if I wanted to stay at one of our city's fine hotels, I'll pay for it myself."

After about an hour into the meeting, the floor was open to questions from the audience which varied among topics such as water supply, the Robinsons-May project, the Cultural Center and even the potential of a recall campaign.

With Robinsons-May property owners David Margulies and Arnold Rosenstein of New Pacific Realty sitting in the audience, residents asked the podium members what they wanted to see built at 9200 Wilshire.

Bardack said, "We have no objection to condominium or commercial use on the site, but it must be compatible with the size, scope and density of the city's General Plan, which is 45 feet in height."

The proposed plan for the site, fliers of which were also distributed at the meeting by New Pacific Partners and not in association with the North Homeowners', comprises two 12-story buildings, townhomes, and two four-story loft buildings over one-third of the eight-acre site.

White also pointed out his concern that the intersection at Santa Monica and Wilshire is one of the worst in Los Angeles County.

Former Planning Commissioner Rose Norton, after serving on the Commercial Standards Topic Committee for the General Plan, strongly urged the audience to follow the process and demand that the proposed projects at 9200 Wilshire and The Beverly Hilton, which recently announced it hired an architect for possible condo development, be viewed by the council as one project.

Resident Debbie Grossman, who is also president of the Beverly Hills Symphony, said she doesn't see anything happening in the

Cultural Center and believes residents are not getting their money's worth with its lease set at \$1 a year to the city.

"We need candidates for City Council who we can truly back," Grossman said.

Mitch Waldow commented on what he thought is bias reporting in the local newspapers. He said it is "unlikely that the community will see fair and decent coverage if they're getting money from the city."

Other speakers included residents Lois Hirt; Anitra Eskovitz; Susan Mishler, who said the city should get rid of "Team Beverly Hills"; and Gunther Schiff, who recommended starting a movement to recall council members, saying, "I don't care which one of the three," that of which Brucker said he paid no attention to.

"I've heard it [recall] over the years on the school board and now on the council and I think it was unnecessary and overly dramatic so I just ignored it," Brucker said.

At one point, the audience questioned the tandem parking at the Montage, which Tanenbaum asked Brucker to address. Brucker responded at the meeting that, "there were many unfortunate situations with the line of communication."

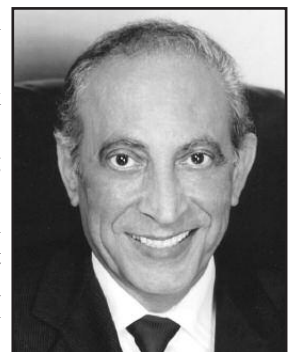
"The Montage referendum became a painful learning experience for the community at large," Brucker told the *Weekly*. "All parties learned a lot about the need for better communications and greater mutual respect."

After the meeting, Tanenbaum questioned why Delshad didn't speak to some of the issues.

"It would have been nice if Delshad had responded to some of the questions asked," Tanenbaum said. "For example, two-hour free parking, the sports center and the suppressed important information for the Cirrus Medical project. But just to stand there and watch. If you're not contributing, what is he doing there?"

Delshad said he purposely arrived late during the meeting because he had already heard the arguments made by the homeowners' leaders themselves, and he wanted to hear what the audience had to say.

"I wanted to be there when the residents talked. To me, that's very key and important. I wanted feedback on what the citizens were saying regarding the information given to them. I wasn't there to defend myself or the City Council, but to learn more about

the issues from the residents' point of view," Delshad said. "If I spoke, it would have been considered defending or attacking. My purpose was not to defend or attack, but to hear input."

What did Delshad hear from the residents?

"The residents have really wonderful questions, but there were really no good answers," Delshad said. "The leaders didn't have the

knowledge to answer the questions. They were giving opinions, but not answers."

The end of the meeting marked the opportunity for the North Homeowners' Association to invite all council members to a town hall meeting to discuss the issues at hand. Both Brucker and Delshad said they would participate.

"I think it's a great idea to have a [town

hall] meeting like this with all the council members invited to participate," Brucker said. "Better communications, open dialogue and mutual respect is the formula for maximizing our quality of life here in Beverly Hills."

"As long as the law allows us, I have no problem discussing any questions," Delshad added.

Tanenbaum insists that the Association will

continue to invite individual members to come to meetings in the future to answer questions.

"It's a shared view amongst residents who believe that commitments have to be honored and promises can't be broken," Tanenbaum said. "Politics of deceit or dishonor are just not acceptable."

Ambient air data from sampling conducted last November are consistent with previous CDM and the Southern California Air Quality Management District (SCAQMD) studies, according to a report released this week, which have shown that airborne chemicals at Beverly High are consistently below any health limits established by the State of California.

A trial date regarding the lawsuit has been set for October, alleging that emissions from the oil derrick and power plant on Beverly High's campus have been responsible for hundreds of cases of cancer and other health problems suffered by area residents and former students from the high school over the last 20 years. The case proceeds with discovery at this time.

As with earlier studies, the data provides no basis for believing that ambient air at the high school is adversely impacted by oil well operations or central plants, or that air at the high school is substantively different than air elsewhere in the Los Angeles area.

CDM collected ambient air samples on November 16, 2005 at Beverly High to continue to gather additional data to monitor ambient air quality. At the time, Venoco wells were in operation and produced 512 barrels of oil and liquids and 323,000 cubic feet (mcf) of natural gas.

Samples were collected over an eight-hour period during representative school and after-school activity hours from about 7 a.m. until 5 p.m. and collected at the same 11 locations used in CDM's previous ambient air investigations.

Ambient air samples were collected from a height equivalent to the breathing zone (approximately 5 feet above the ground). In addition, samples were collected from the ground surface at three locations. No noticeable difference in chemicals or their concentrations between ambient air samples collected at the breathing height and at the ground surface was observed.

Results of the ambient air sampling performed in November are comparable to

ambient air data collected in previous investigations by SCAQMD and CDM through June 2005. Toluene concentrations were detected at only one location at a concentration of 9 parts per billion by volume (ppbv). The detected concentrations in the remaining samples were "non-detect" due to presence of measurable concentrations. Toluene was not detected above 3 ppbv at upper ball field, which registered the highest concentration of 30 ppbv during the February 2005 sampling. Similarly, benzene concentrations were not detected above 1.1 ppbv during the November 2005 event, which is below the highest concentration of 1.5 ppbv observed to date in previous sampling events. Other chemicals detected in the air at the high school continue to be measured at concentrations below any limits established by the State of California to protect human health, according to the report.

The report also stated that monitoring of the air quality in the Los Angeles Basin routinely reports a variety of chemicals,

including those detected in the current sampling at Beverly High. Vehicle emissions and emissions from refueling are responsible for a large percentage of the chemicals detected in Los Angeles Basin air.

Benzene has been a focus of previous investigations due to concerns that it may be released from oil well operations. This chemical was found in the ambient air at levels consistent with those commonly reported by SCAQMD from routine monitoring of air quality throughout the basin. The investigations conducted by CDM continue to indicate that no unusual source of benzene exists at or near the high school.

The conclusion was made that the overall ambient air on the campus is not measurably affected by oil well operations or central plants, and that air quality at the campus is not notably different from air quality reported by SCAQMD for monitoring stations elsewhere in the Los Angeles Basin.

Additional ambient air sampling will be scheduled to continue monitoring ambient air quality in the near future.

MURDER SUSPECT MISTAKENLY RELEASED

Suspect is back in custody and charges filed in stabbing case, only after his parole hold was accidentally lifted.

The suspect allegedly connected in the stabbing death and attempted murder of two men in Beverly Hills was mistakenly released from jail Saturday and rearrested Tuesday morning after his sister arrived at the Beverly Hills Police Department to reclaim his impounded car.

Deputies released Nathan Hall from the Men's Central Jail in Downtown L.A. on Saturday morning, apparently unaware he was being held without bail.

According to Lt. Mitch McCann, the BHPD were alerted of Hall's release yesterday, after state parole officials lifted his parole hold inadvertently.

"Apparently, parole from the state sent a teletype releasing Hall's parole hold after originally telling BHPD and the DA's office they weren't going to do that, and the sheriff's department just complied with the release," McCann said.

Hall, 50, is suspected of attacking two

painters, leaving one dead and the other injured.

The crime occurred Dec. 14 at 6:45 a.m. when Hall, 50, allegedly got out of his car and stabbed 75-year-old Helmut Mende, who was painting the wall of the parking lot near the Wells Fargo bank branch in the 9300 block of Wilshire Boulevard at Crescent Drive. Mende's co-worker, Jurgen Hapke, 65, came to his aid and was subsequently stabbed in the chest and later pronounced dead at the hospital. Mende sustained serious injuries, but has since been released from the hospital. The motive is still a mystery.

It was the first homicide in Beverly Hills in four years.

Hall has an extensive criminal history including alleged acts of violence and similar crimes. At the time of his arrest, Hall had a parolee-at-large warrant, which led to a delay in filing charges, McCann said. Due

to the ongoing investigation, police have not released the details of Hall's criminal history.

Hall was scheduled to appear with his defense attorney Tuesday morning at Los Angeles County Superior Court to answer charges in the case, when Superior Court Judge Elden Fox announced that Hall had been released from custody. A couple hours later, BHPD officers located him in parking area of City Hall when his sister arrived to pick up his car and was denied.

According to McCann, Hall initially tried to walk away, but eventually complied. Last month when police officers arrested Hall at his residence in South Los Angeles efforts had been made to contact the suspect via telephone with no answer and family members inside the residence denied that Hall was present. After several attempts to reach Hall, the department's Special Response Team made a forced

entry and found Hall hiding in the attic, covered with a mattress and insulation materials. After repeated demands by the police, Hall surrendered and was taken into custody.

"[This is] very unusual," McCann said. "I don't want to point fingers, but we [BHPD], certainly along with the DA, weren't anticipating him being released."

After his rearrest, Hall was charged the same day with murder and attempted murder by the District Attorney's office. McCann said Hall's family members will not be charged.

According to McCann, state parole officials are investigating how the release occurred and the BHPD will remain in contact with them to "prevent this in the future."

A preliminary hearing is set for Feb. 28.

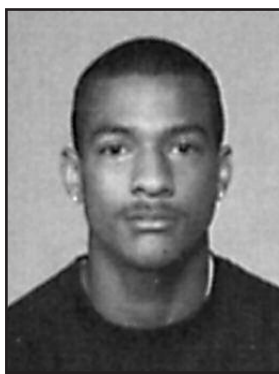
Beverly High wide receiver-safety Spencer Paysinger has committed to Oregon, Norman coach Carter Paysinger said Friday.

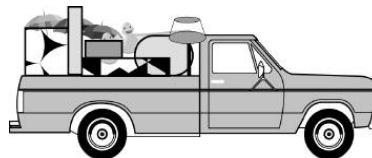

ORDINANCE NO. 06-O-2494

AN ORDINANCE OF THE CITY OF BEVERLY HILLS ESTABLISHING MAXIMUM WIDTHS AND DEPTHS FOR SINGLE FAMILY RESIDENTIAL LOTS IN THE CENTRAL AREA OF THE CITY, ESTABLISHING RESTRICTIONS ON SINGLE FAMILY RESIDENTIAL STRUCTURES IN THE CENTRAL AREA OF THE CITY OCCUPYING MORE THAN ONE LOT AND AMENDING THE BEVERLY HILLS MUNICIPAL CODE THE CITY COUNCIL OF THE CITY OF BEVERLY HILLS HEREBY ORDAINS AS FOLLOWS:

Section 1. Legislative Findings. The City Council finds that the scale and massing of buildings in the R-1 Zone in the Central Area of the City is of concern to the community at large. Beverly Hills residential neighborhoods have traditionally been renowned for their beauty, quality, and value and provide the City's residents with an unparalleled quality of life. However, emerging trends have led some owners and developers in residential areas to disregard prevailing styles and neighborhood character in an effort to maximize development and density, resulting in the explosion of imposter homes and the mansionization of the City's residential neighborhoods. A home becomes a imposter when its size greatly overpowers the general local lot-to-house size ratio. In todays maturing urban areas, imansionization is the perception of a remarkable progression of entire neighborhoods growing wildly out of scale for the lot and street proportions initially intended. One manner in which this trend manifests itself is through the accumulation and consolidation of multiple smaller lots to create a single larger lot which enables the construction of substantially larger homes than the City's R-1 development standards would otherwise permit. These homes are grossly out of scale and character with existing development in the City's residential neighborhoods in the Central Area, and such mansionization poses a serious danger that such overbuilding will degrade and depreciate the character, image, beauty, and reputation of the City's residential neighborhoods with adverse consequences for the quality of life of all residents. The City Council is concerned that continued unregulated development in these residential neighborhoods will erode the existing character of the City's residential neighborhoods and degrade the quality of life of all Beverly Hills residents. Therefore, the City Council finds it necessary to amend its regulations to establish maximum lot dimensions for all single family residential lots in the Central Area of the City and to prohibit the issuance of building permits and other land use entitlements that would allow construction across lot lines in the R-1 Zone in the Central Area of the City. The City Council further finds and believes that implementation of these amendments will allow the City to more effectively address the harmful effects of mansionization in the Central Area of the City and protect the existing quality of life for residents in these neighborhoods.

Section 2. The City Council considered this Ordinance at a duly noticed public hearing on December 20, 2005. Evidence, both written

and oral, was presented at said hearing.
Section 3. New Section 10-3-2428 is hereby added to Article 24 of Chapter 3 of Title 10 of the Beverly Hills Municipal Code to read as follows:

10-3-2428. Maximum width and depth established; prohibition on multiple-lot developments.

A. Notwithstanding any other provision of this Code, the following width and depth restrictions shall apply to each R-1 Zone lot in the Central Area of the City:

(1) Width. The maximum width of any R-1 Zone lot in the Central Area of the City shall not exceed the average width of the lots in the same block.

(2) Depth. The maximum depth of any R-1 Zone lot in the Central Area of the City shall not exceed the average depth of the lots in the same block.

B. In addition to the restrictions imposed by paragraph A of this section, no single family residential development in the Central Area of the City shall be permitted to occupy more than one lot, nor shall any residential structure in the Central Area of the City be erected or enlarged across a lot line in an R-1 Zone.

C. Exception: Notwithstanding any other provision of this section, the City Council may waive the limitations set forth in subsection A of this section by issuing a Central R-1 permit pursuant to Article 24.5 of this chapter. Additionally, the City Council may waive the provisions of subsection B of this section in connection with a remodel of an existing home that occupies more than one lot provided that the remodel does not involve an increase in the square footage of the existing home. In addition to the findings required by section 10-3-2453 of this chapter, the City Council shall not issue a Central R-1 permit to allow a single-family residential development on multiple lots, to allow a residential structure to be erected or enlarged across a lot line, or to allow a lot to exceed the maximum width and depth limitations imposed by this section unless the City Council makes the following additional findings:

(1) The Central R-1 Permit does not enlarge any single lot by more than ten (10) percent of the average width or depth of the lots in the same block.

(2) The proposed development is designed to appropriately minimize the appearance of scale and mass and enhances the garden quality of the city and appropriately maximizes the use of required open space within the proposed architectural style;

(3) The proposed development will enhance the appearance of the neighborhood;

(4) The proposed development appropriately balances the applicant's reasonable expectation of development with the neighbors' reasonable expectation of privacy; and

(5) The proposed development respects the character of the existing neighborhood and prevailing site design patterns, carefully analyzing the characteristics of the surrounding group of homes, and integrates appropriate features that will ensure harmony between old and new.

In making this determination, the City Council may look at such factors as the impact of the proposed development on the scale and massing as viewed from adjacent properties, the impact of the proposed development on available light in neighboring yards, and the cumulative impact to adjacent properties from the proposed development in combination with existing multiple lot developments in the vicinity.

Section 4. Application. This Ordinance shall apply to any R-1 Zone development in the Central Area of the City that has not been issued a building permit prior to the effective date of this Ordinance and shall apply to any other approval that would alter the depth or width of a lot and that has not become effective prior to the effective date of this ordinance.

Section 5. The City Council hereby finds that it can be seen with certainty that there is no possibility that the adoption and implementation of this Ordinance may have a significant effect on the environment. The Ordinance does not authorize construction not already permitted under the City's existing codes and, in fact, imposes greater restrictions on certain development in order to protect the public health, safety and general welfare. The Ordinance is therefore exempt from the environmental review requirements of the California Environmental Quality Act pursuant to Section 15061(b)(3) of Title 14 of the California Code of Regulations.

Section 6. Severability. If any section, subsection, subdivision, sentence, clause, phrase, or portion of this Ordinance or the application thereof to any person or place, is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remainder of this Ordinance. The City Council hereby declares that it would have adopted this Ordinance, and each and every section, subsection, subdivision, sentence, clause, phrase, or portion thereof, irrespective of the fact that any one or more sections, subsections, subdivisions, sentences, clauses, phrases, or portions thereof be declared invalid or unconstitutional.

Section 7. Publication. The City Clerk shall cause this Ordinance to be published at least once in a newspaper of general circulation published and circulated in the City within fifteen (15) days after its passage, in accordance with Section 36933 of the Government Code; shall certify to the adoption of this Ordinance and shall cause this Ordinance and his certification, together with proof of publication, to be entered in the Book of Ordinances of the Council of this City.
