

## "Roxbury Park Master Plan leans towards Plan B"

As a 68 year resident of Beverly Hills, 48 of them next to Roxbury Park on Spalding Drive, I am horrified at the city's persistent plans to destroy the park. I have been to five meetings, attended by the consultant, at each of which he produced basically the same plan. To destroy the natural park of trees, grass and plants where people can read or sunbathe, or just sit, and stuff in all the programmed athletic activities the residents turned down in the planned athletic facility in the industrial zone.

This is the only park left in Beverly Hills and was designated a Memorial Park, not a Municipal Athletic facility with all space

designated to an organized use. We do not need a two story 365 car garage spewing out families into the total residential area. Every resident who spoke at the meetings wanted the natural park preserved and measures taken to repair and renovate what needed repair and renovation. Such as the leaking roofs of the buildings, the floor of the auditorium, and the repulsive bathrooms and electric wiring of the community center.

The building is fine if it is fixed up and maintained. We do not need a new multi-story building. All the surrounding residents agree there should be a plan put forward to fulfill these purposes instead of the boondoggle so far presented.

The consultant says that he has been forbidden by the Council to do this. Seeing as they are supposed to save us, and we don't want \$150 million desecration, I suggest that they reconsider.

## Brian Goldberg to run for Board of Education

Former Maple Counseling Center CEO says background will aid school district

Former Maple Counseling Center CEO Brian David Goldberg filed papers on July 23 to run for a seat on the Board of Education election November 6.

“Beverly Hills Unified School District is the crown jewel of schools districts,” said Goldberg. “This is why I want to get involved in the school district that is ranked sixth in the state. It is a phenomenal district.”

Goldberg, a political science professor at the American Jewish University and CEO of the non-profit organization, Casa De La Familia, has been a resident of Beverly Hills for two years.

Casa De La Familia, a non-profit group sponsored by the state to help victims of crime, is one of many non-profit agencies

Goldberg has served on. Goldberg previously worked at the Jewish Federation of the Greater San Jose, Anti-Defamation League and the Women’s Commission for Addiction. Goldberg completed his doctoral dissertation on Proposition 140, studying the impact of term limits on the California Assembly.

The South La Peer Drive resident has been active in the city as a coach for the Beverly Hills’ basketball league, AYSO soccer, and is the former CEO for the Maple Counseling Center. His daughter Sophia, 6, will enter second grade next year at Horace Mann, his daughter Esther, 4, and son Ari, 2, are future Horace Mann students.

As a professor at the university for three years and a current CEO of a non profit, Goldberg said he thought his background as an educator and leader of non-profits would aid the Board of Education.

“I thought with my background as an educator and CEO of a non-profit I could help the board move forward to be the best pos-

sible board it can be,” said Goldberg.

Goldberg said he can help implement engaging curriculum for students.

Involvement with the Maple Counseling Center three years ago allowed Goldberg to work one-on-one with the school district, said Goldberg. Stating the experience gave him better insight to Beverly Hills’ schools.

After about a year, Goldberg said he left the Maple Counseling Center because he

“I think [Goldberg’s election aspirations] is excellent,” said Step Jones, who served with Goldberg on the Maple Counseling Center Board from 2004-05. “Brian is a very good leader. He thinks out of the box. Brian and I worked closely together to further the Maple Counseling Center. Brian came up with different ways to raise money for the center like corporate sponsorships.”

The Weekly spoke to other members of

and then-newly appointed president Les Bronte had a different vision for the center. Also, at the time Goldberg said he was offered other opportunities and felt it was the appropriate time to move forward.

“We had a set of goals for Brian to achieve over a time table and he did not meet those goals,” said Bronte. “At the time he did have some liaison to the school district, but it did not represent a lot of time and skill. The BHUSD is a very demanding and complex organization requiring high levels of expertise, commitment and a history with the schools and their needs.”

Other former members of the Maple Counseling Center Board said they thought Goldberg would be an excellent candidate for the board.

the Maple Center Board who worked with Goldberg, including Tom Korey. Korey would not comment.

Goldberg has been following the board meetings for the past year. If elected he plans to address the concern of prejudices that have been raised, he said.

The issuing of permits is something Goldberg said he would also like to look further into if elected, he said. Goldberg said he is not opposed to permits, but would like to look into the reasons why Beverly Hills residents are leaving the public education system.

## Susie Curtis to depart BHUSD after 28 years

Coming to Beverly High as a new special education teacher in 1979 from El Segundo, Susie Curtis has worked with some of the BHUSD's "greats" during her time in the district. Dr. Nancy Wolf, former Beverly High principal Ben Bushman and Tanis Harris are among the people Curtis said she enjoyed working closely with and have instilled in her encouragement and support. After 28 years of working with BHUSD, Curtis leaves for the Las Virgenes Unified School District.

Curtis's fondest memories are of faculty, families and students at the high school before she took her administrative role.

"Working with the staff members and the families [are Curtis' best memories]," said Curtis. "I have a lot of families I have known for many years. A lot of the staff members were my previous aides. It was nice," said Curtis.

In 2001, Curtis was selected to oversee all the special education for the district as special education coordinator. Her involvement with the program allowed her to see many

changes that occurred in special education from the early 1980s until now.

"Special education has become much more visible," said Curtis. "Staff and families have been much more open to students with special needs, and willing to help them. We are always changing things as needs change. We have made adjustments at all the school sites as numbers have changed and students needs have changed."

On August 1, Curtis will start as the director of pupil services in the Las Virgenes School District. With approximately 12,000 students, Las Virgenes is over twice the size of BHUSD, said Curtis. There are three high schools, three middle schools and seven elementary schools to oversee from a district office in Calabasas. This will present new challenges for Curtis.

"I am going to have a lot of new staff and families to be working with," said Curtis. "Here I am so familiar with everybody. I know the names of everybody. They have some interesting challenges out there that I will have to brush up on. It is a much larger special education program, but they apparently have some wonderful programs in operation."



## More Hotel Notes

Two in Board Challenge

It really says something about the importance we attach to hotels, and especially the Peninsula, when the resignation of a hotel managing director last week makes more news than the city council.

**Ali Kasikci** is not exactly your average hotelier. In the years he has been with the Peninsula, he has emerged as one of the most highly regarded people in the hospitality industry – and far beyond our borders. It is only natural that his future plans should make news and bring speculation on where he might finally land.

As reported here last week, one of the most persistent rumors we heard, inside and outside the city, was that he would become manager of the Montage Hotel and Gardens of Beverly Hills. Neither the Montage management or Kasikci confirmed the story or were our sources.

Kasikci is likely to remain at the Peninsula through this year and has undoubtedly received many offers. When

he says that he is exploring many options, we should take him at his word.

Another newspaper erred in describing the owners of the hotel as the Hong Kong company that manages the Peninsula's. It was that company which brought Ali to Beverly Hills, but the owners are very local – the Zarnegin family and their company, Probity.

This column also missed one element of the story. Although **John Rucci**, the Peninsula's resident manager, is also leaving, he has not signed with the Montage. According to our sources, Rucci will become general manager of the Santa Monica Fairmont. He will reportedly take over there this week.

Interesting historical paradox: In the late 1970s, the Swig family, the legendary owners of the San Francisco Fairmont, explored the possibility of coming to Beverly Hills. Where? At almost the same site that has become the Peninsula.

face **Steven Fenton** and **Brian David Goldberg** (see page 3), who filed early this week.

Fenton has the advantage of having one of the most familiar names in Beverly Hills. His father Frank has been president and member of the school board, an elected city treasurer and now member of the City Council. He has always been a formidable candidate. **Judie Fenton** is a long-time political activist and a well known consultant with clients that have included the police and fire associations and a number of charities. Her firm, FTA, specialized in event planning, but it has grown beyond that to include community outreach projects.

The younger Fenton has his own credentials and school involvement, including a support group for high school athletic programs. He has defined some problems he feels need fixing and has said his campaign will be on issues and not just who can muster the most impressive list of endorsements, although his early backers included some very high profile civic leaders.

Having a prominent political name has advantages and some drawbacks. Inevitably, any possible problems the Fenton's have had on issues or government process will have some effect on Steven. As an example, **Zev Yaroslavsky** is probably the most popular elected official on the west side, winning elections to the L.A. City Council and the Board of Supervisors easily and often without opposition. But when he gave up his Fifth District council seat to run for

Two years ago, not one possible candidate emerged to challenge two candidates for school board, and the election was cancelled. There was one incumbent, **Myra Demeter**, and **Nooshin Meshkaty**, who had been an El Rodeo PTA leader, but was not exactly well known, or someone with an educational agenda that defined her interest in serving. She had been supported and encouraged to run by now vice mayor **Barry Brucker**, a former board president who left the board to run for council.

As for Demeter, her four years on the board had not been without some controversy, including her often confrontational style, and issues she had with some school administrators. Although her educational credentials are impressive, it was somewhat surprising that no candidates emerged to challenge either her or Meshkaty.


This year will be very different. With three incumbents seeking reelection and no "open" seat, there will be at least two challengers with both name recognition and community support. **Myra Lurie** and **John Milan** are running for a second term and **Alissa Roston** for a third. They will

retiring **Ed Edelman's** spot on the County Board, his popular wife Barbara was not able to win election to succeed him on the council, losing to **Mike Feuer**, then making his first try for public office.

Although Fenton said he is not targeting any one of the three incumbents and is running on his own credentials and his plans for making the schools better, the third term issue will have some bearing on Roston's campaign, as will her involvement in the departure of a school principal in her own elementary school area.

Even Fenton agrees that the strongest of the three incumbents is Myra Lurie, who served with great distinction as board president during a very difficult period, including the departure of many school administrators. Lurie is an attorney, and for the first time in my memory, the only lawyer to hold any elected office in our city. We have had as many as three lawyers on the City Council at one time, and some on our board, but now, none on the Council.

This would be Lurie's second term and while she has her own service filled resume, she also benefits from her marriage into one of the city's best known leadership families. Her mother-in-law is the legendary **Sooky Goldman**. Lurie has also gathered endorsements from many who had not supported her four years ago and who backed the losing incumbent, **Virginia Maas**.

Milan is a strong consensus builder and is very non-controversial or confrontational. He too has a strong community oriented family, by marriage and has built a good

reputation as a quiet leader, especially on construction matters, a resource he brings to the board from his professional experience in school building.

There have been few issues that have divided this board, unlike past boards that were often locked in personality conflicts and education program disputes.

There are some very interesting differences between Board of Education and City Council elections. First, board candidates need only file their notice of intent and are not required to even secure a minimum number of signatures on nominating petitions – just their own signature. Second, the campaigns have no spending limits and no rules on contributions, except those governed by state law. City elections have individual limits and a cap on spending.

The candidates may set some voluntary rules on campaigning. There may be a proposal to abandon lawn signs. How effective they are is questionable. In the last City Council election, then Mayor **Steve Webb** probably had the most, and yet lost, and **Nancy Krasne** the least, but ran first. On the other hand, lawn signs do alert voters to an upcoming election and in our traditionally low voter turn out, any tool that stimulates interest might be worth keeping. But they are an ugly eyesore.

All three incumbents will have to work hard and not take the election as a walk. Fenton is a vigorous contender and is very likely to walk the whole city – something that doesn't always happen in board races.

There are issues: The problems articulated by the Beverly Hills Education Association – the teacher's union, have resonated in the city and school community. The union will undoubtedly play a significant role in the election, which is their absolute right. There is also concern about the turnover of administrators, and most important, the out of district registration program.

The out of district issue could become important, but it needs to be put in perspective. One parent told us recently that she resented having to pay taxes for children who come to Beverly Hills for a better education, but live elsewhere. Not exactly the facts or the reality. Our taxes pay only a small percentage of school funding, and we receive state money based on school population, or ADA, average daily attendance. We could not survive without out of district students and certainly not have the means to keep class size at current levels. Remember, school population does not necessarily effect numbers of administrators and other non-class room professionals needed to maintain the highest levels of educational services.

Are the Beverly Vista parents still angered by the departure of their principal, **Irene Stern**? The main target of their angst was the then school superintendent **Jeff Hubbard** who has left for greener, in every sense, pastures in Orange County.

As for the second non-incumbent candidate, he has made a very late entry into an election where the one challenger and three incumbents have been hustling for

endorsements and even starting their walking efforts.

**Brian David Goldberg**, the latest contender, is not, however, new to civic affairs. He served for some time as executive director of the Maple Counseling Center, leaving after a disagreement with his board on a public policy matter, not related to his talents as an administrator. The Maple board is a powerful group of city leaders– it will be interesting to see if Goldberg obtains their support.

\*\*\*

The city lost another generous and admired city leader with the passing of **Harold Kapelovitz** (see page 4), who had been ill for many months. It was always wonderful to see Harold and his wife **Lee** together – they were so obviously dependent on and devoted to each other – they were really a couple. I had the pleasure of serving for many years with Lee on the Greystone Foundation board. She and I were among the original members appointed by the City Council.

Harold was a modest person, but a generous one and he cared for our community. He will be missed.



## BHUSD'S NEXT-GEN WOMEN

Newly appointed BHUSD PTA presidents discuss their lives and goals for their schools

**Jennifer Schwartz**  
Co-President  
Beverly Vista

Not many people can say they have known their best friends since kindergarten. Jennifer Schwartz can, and part of it is due to the foundation that was set for her by growing up attending Beverly Hills' public schools, she said.

A 1978 Beverly Vista graduate and former B.V. student body president herself, Schwartz progressed through the Beverly Hills' school system and graduated Beverly High in 1982. After, Schwartz was accepted to the University of California Berkeley. Upon graduation, she pursued a career in pharmaceuticals and returned to Beverly Hills.




