“What to Do About the Permits?” [Issue 533]

I sat in awe Tuesday night as my eyes were glued to Channel 6. In a never-ending filibuster by supporters of the opportunity permits I witnessed a barrage of insults and an almost broken-record like content of speeches. As a resident of this community, I have, at times, been pained and ashamed by the rhetoric that has clouded the permit debate. Yesterday's performance by several of our “leading” civic leaders, including Robert K. Tanenbaum, Rudy Cole and Board of Education member Myra Lurie was nothing

short of DISGRACEFUL.

It can be argued that a compromise was struck; that is true only if you believe that non-resident children should have privileges and guarantees that our own resident children do not. It can also be argued that it was a compromise, but only if you are willing to accept that we now live in a city where PUBLIC POLICY is driven by NON-RESIDENTS.

The FACTS are plain and simple. WE KNOW for a FACT that plenty of notice was given; this debate has been going on for three years. We KNOW for a FACT that these permits were to be renewed annually. A policy which in the final analysis was racist by aiding and abetting those deserting their neighborhood schools, a policy which encouraged and rewarded White Flight!

It was no surprise to see Ms. Roston and Mr. Millan arguing on behalf of the non-residents as it was their failed policy which put us in this mess in the first place.

And finally the MORAL ARBITER OF THE EVENING, MS. MYRA LURIE. . . Last time I checked, I thought that she represented our children and our community on the school board; seemingly, I was mistaken. When all other reasonable argument had failed, and when the eyes of the world were upon us, Ms. Lurie pulled out her old

trump card . . . The RACE CARD . . . and in her summation many of us were reduced to mere xenophobes SHAME.

When did it become acceptable for our elected officials to lobby on behalf of non-residents? When did it become acceptable for us as a community to be so maliciously maligned?

For those of you who like me thought that our schools were the crown jewels of Beverly Hills, I invite you to reconsider and remember that not all that glitters is gold!

Permit Saga Continues

Board Allows Ninth-Graders to Graduate, but K-6 Permits Won't be Renewed

A crowd of roughly 400 people gathered at Tuesday night's Board of Education meeting as police officers and Beverly High security barred the entrance of the Science and Technology Center. Purses were searched; people were turned away and ushered into an adjacent overflow room.

Nearly three hours of angry permit parents and frustrated residents voicing the well-known, double-sided issue ended with an hour-long board discussion — and a verdict.

Compassion was a frequently-uttered word. And it was a "compassionate" phase-out that board members unanimously approved. To the relief of ninth-grade parents, who comprised at least half of those in the main room, ninth-graders will now be allowed to apply for the annual opportunity-permit renewal, along with the board's original intention of letting seventh-graders finish middle school and 10th and 11th graders complete high school. Opportunity permits for students in other grades will not be renewed.

But the compromise did not come easily.

About 100 students, parents, residents, teachers and community leaders stepped up to speak to the five-member board, including former Mayors Robert K. Tanenbaum and Chuck Aronberg and former Board Presidents Alissa Roston, Nooshin Meshkaty and John Millan.

"Asking these kids to leave is like putting your kid up for adoption," said Beverly High junior and resident Tatiana Spottiswood. "Don't disown my friends."

And despite a warning from Board President Steven Fenton that audience members who did not show respect would be asked to leave, two permit par-

ents were kicked out of the room.

"It's remarkable what a public education will do," quipped one permit parent after Fenton mispronounced a speaker's name and twice forgot that the speaker had conceded her time. The parent was immediately asked to leave.

Board member Myra Lurie seconded an original motion by Fenton, influenced by Planning Commissioner Lili Bosse's suggestion, to amend board direction and also allow sixth-graders to finish middle school, as well as letting ninth-graders complete high school. Though the motion failed in a 3-2 vote, it prompted a nearly 20-minute long speech by Lurie encompassed by the theme of "irreparable harm to children."

The speech was followed by several more monologues from Lurie. When board member Lisa Korbatov attempted to speak, Lurie would not allow her to interrupt.

"As if you haven't talked enough tonight," Korbatov said.

Fenton also read several letters from community members, including City Councilmember John Mirisch, who implored board members to put resident families first.

Many board members reiterated the need for parents concerned with their child's educational continuity to move into the city.

"There are apartments in Beverly Hills waiting for you to move in tomorrow," Fenton said.

He added that even after the phasing out of opportunity permits, BHUSD will still be doling out more permits than any other district statewide.

"In my opinion, we are the most compassionate school district in the state," Fenton said. "This has been the single most controversial issue since I've been on the board. The fact that we got a 5-0 unanimous vote on this is a huge win for everyone."

Board member Jake Manaster said two city councilmembers told him they would consider reducing the Joint Powers Agreement in the event permits aren't phased out. In light of comparisons made by Lurie and permit parents that other districts have allowed students to matriculate, Manaster said those districts "allowed matriculation only because it's a few kids," unlike BHUSD's 484 opportunity permits.

Manaster also proposed implementing

a recertification process in order to weed out illegally registered students.

Following Tuesday's meeting, board member Brian Goldberg has been targeted by permit parents, who are now seeking a recall against Goldberg, and/or are planning on suing BHUSD.

It remains unclear, however, whether non-residents can initiate a recall of a resident.

"Well, now they know how I feel, because I didn't get everything I wanted either," Fenton said. "That's why the only solution is a compromise, and I feel we obtained that last night."

Goldberg said the intended recall is a move to "frighten" and "intimidate" the board to change their stance on opportunity permits.

"I don't regret any actions that have been taken on my part in terms of advocating for the residents and the resident children," Goldberg said. "I've been more than fair, and I've offered compromise over compromise."

Goldberg said he believes he was singled out because of the lingering sentiment from his civil action lawsuit — brought on Lurie's crusade to oust Goldberg by attending the trial — and the recent failure of many community members to secure Goldberg's resignation.

"I will vigorously fight any recall

effort because I feel I have served this community well," Goldberg said. "I will continue to make my arguments. We found a delicate balance between the needs of residents and taxpayers and the compassion toward our opportunity permit students, and with that, I'm being met with more personal attacks and more threats and potential lawsuits against the district."

Goldberg said he will not allow this recall effort or possible lawsuit to distract the board from moving on.

"I think the board getting a 5-0 vote was a very good thing for the community," Goldberg said. "They saw that the board was able to compromise and come up with a fair solution to the out-of-district situation as we enter basic aid, and I'm hopeful that the noise is going to die down and allow the board to focus on improving on our academic excellence."

Permits that are not renewed can be appealed to the Los Angeles County Board of Education in April. However, other counties' Board of Education has generally upheld denials of permits in districts that have become basic aid.

Richard Rust, a permit parent, did not return calls made by the Weekly as of press time.

Lurie declined to comment, saying she doesn't speak to the Weekly.

Corman, Egerman, Ostrom Inducted to BHHS Hall of Fame

The Beverly Hills Alumni Association announced three new members of its Hall of Fame.

The new inductees are Roger Corman, Mark Egerman, Class of 1960, and Elinor Ostrom, Class of 1951.



Elinor Ostrom

Corman began his career in 1953 as a producer and screenwriter, and made his directing debut in 1955. He has directed dozens of films, sometimes as many as seven films a year. Corman shot films quickly, setting a record with the completion of

1960's "The Little Shop of Horrors" in two days and one night.

Corman filmed various well-known Edgar Allan Poe stories, including "House of Usher" (1960), "The Pit and the Pendulum" (1961), "Tales of Terror" (1962), "The Raven" (1963), "The Haunted Palace" (1963), "The Masque of the Red Death" (1964) and "The Tomb of Ligeia" (1964) — all of which starred Vincent Price. He has worked with many film directors early in their careers, such as Francis Ford Coppola, Martin Scorsese, Jonathan Demme, James Cameron, Peter Bogdanovich and Joe Dante.

Corman retired in 1971 to concentrate on production and distribution through his company New World. He was honored with the Lifetime Achievement Award at the 2005 New York City Horror Film Festival and an Honorary Lifetime

Achievement Oscar from the Academy of Motion Picture Arts and Sciences in 2009.

Egerman is a founding member and partner in Egerman & Brown, LLP. He is a former mayor, city councilmember (1997-2005) and Board of Education member (1983-1987).

Egerman also served on the Public Works Commission for seven years prior.

Ostrom was the first woman to be awarded a Nobel Prize in Economics last month. She was recognized for her groundbreaking work in the management of common resources, which could shape efforts to prevent another global financial crisis. Ostrom demonstrated how common resources, such as forests, fisheries, oilfields, grazing lands and irrigation systems, can be managed successfully by the people who use them, rather than by governments or private companies.

Ostrom received a Ph.D. in political science from UCLA in 1965, and is currently a political scientist at Indiana University.

Carey Attends Vienna Film Festival

Timothy Carey — the late father of Beverly High's media director Romeo Carey — was recently honored at the Vienna International Film Festival for his influential work in film.

"It was great," Romeo Carey said. "A film festival recognizing him not just for his acting is a testament that once you put the energy into something artistically, at some point, the pennies are going to drop and people are going to recognize the real value of his creation."

Timothy Carey passed away in 1994, but was known for his method acting in sinister roles.

"I know how hard my father worked and what he sacrificed to make films," Carey said. "It's great, too, because my father always knew he was appreciated when he was alive."

Timothy Carey has worked with several renowned actors and directors such as Clark Gable, Lee Marvin, Marlon Brando, James Dean, Stanley Kubrick, John Cassavetes, Jack Nicholson and Quentin Tarantino.

Beverly Hills Opens New Emergency Operations Center

The City of Beverly Hills recently unveiled its new, high-tech Emergency Operations Center, a central point of coordination and information dissemination in the event of a disaster. The state-of-the-art center provides citywide departments with real-time mapping, interactive displays, CCTV field cameras and other leading-edge technologies being tested in the city.

Scientists warn that there is a 98 percent chance that a significant earthquake will occur in the next 30 years. The city is also a high-risk area for the three biggest disasters: earthquakes, urban wild fires and terrorism. Through the efforts of the city's Office of Emergency Management, in conjunction with all city operations, Beverly Hills is addressing the potential for each type of emergency. This center supports those efforts by providing a single location where departments would come together to develop a uniformed response. It would also allow the city to coordinate efforts with its partners at the county, state and federal levels.

"The role of the council starts and ends with keeping our city safe," Mayor Nancy Krasne said. "It is the most important job we do, and that is why we have been so committed to making this Emergency Operations Center a priority. While I hope that we never have to use this center for a real emergency, I sleep better at night knowing what we have here. Our residents should feel secure knowing that in any emergency, services will operate in a coordinated effort, under one roof, no matter what happens."

Carey said he was invited by Martin Scorsese, his father's friend, to the Munich Film Festival where Timothy Carey was also honored.

"Martin Scorsese was in charge of choosing what he thought was the best rock-and-roll films, and he chose my father [for 'The World's Greatest Sinner']," said Carey, who added that one of his father's films was recently featured on Turner Movie Classics.

Viennale is an annual film festival in Vienna, Austria that takes place every October since 1960, with an average 75,000 visitors.

SEC Charges Persian Radio Host John Farahi of \$20M Scam

The U.S. Securities and Exchange Commission has accused John Farahi, the host of a popular Persian-language radio talk show, of defrauding investors out of more than \$20 million in a long-running investment scheme that targeted the Iranian-American community.

Farahi, his wife, Gissou Rastegar Farahi, and their company, NewPoint Financial Services, allegedly lost millions of dollars in volatile investments they had promoted to investors as low-risk, according to a lawsuit filed Monday, Jan. 11 by SEC in a Los Angeles federal court.

The SEC alleges that the Farahis transferred their clients' money to bank accounts controlled by NewPoint executives, and used some of the money to build a multimillion-dollar home in Beverly Hills. More than \$18 million was lost through risky options futures trading from 2008 to early 2009.

The 52-year-old host of the daily financial talk show "Economy Today" has worked at the station KIRN-AM (670) for about eight years. John Paley, the station's general manager, reported to the Los Angeles Times that the one-hour pro-

gram, which aired weekdays at 1 p.m., has been suspended because of the allegations.

Farahi told listeners during his show about developments in financial markets and answered questions from callers. The SEC alleged that the Farahis or company controller Elaheh Amouei scheduled appointments with listeners to discuss investment opportunities offered by NewPoint. More than 100 victims were misled to invest more than \$20 million between mid-2003 and mid-2009.

A judge issued an order temporarily freezing company assets, as well as those of the defendants, reported the LA Times.

According to the lawsuit, many investors were falsely told that they were investing in federally insured certificates of deposit, government bonds and companies backed by federal bailout money. The Farahis and Amouei guaranteed clients that their money would be returned, but the company currently doesn't have the funds to reimburse investors.

Mark Stern to Release New Book on David Franks

Mark Abbott Stern, husband of retired Beverly Vista Principal Irene Stern, is releasing a new book this June titled "David Franks: Colonial Merchant."

Stern, a retired engineer and amateur historian, spent 11 years researching Franks, a Philadelphia merchant who was an important figure in American Jewish history in the 18th century.

The book follows Franks, who was part of a prominent Jewish family, through his trials for treason and his exile in the post-revolutionary period.

"After reading brief paragraphs about various aspects of David Franks' existence, I tried to find a biography covering his whole life," Stern said. "There were none. Eleven years ago, I determined to do so myself. I tried to give his memory

the justice he was denied during his lifetime. Knowing that goal has been achieved would please me."

William A. Pencak from The Pennsylvania State University writes in his review that Stern's "well-written and extremely well-researched biography of Philadelphia merchant David Franks (1720-1793) ranks among the best works on early American Jews. It is also the finest study I know that clarifies the complicated story of arm contracting during the French and Indian War and the bureaucratic intricacies of caring for prisoners of war during the American Revolution."

Beverly Hills PTA and BHEF to Hold Town Hall Meeting on Education

The meeting will follow a "question and answer" format, with a moderator addressing the invited panelists, including Superintendent Jerry Gross and his senior staff, as well as Board of Education members and Principals J Guidetti, Erik Warren, Patricia Escalante, Toni Staser and Dawnalyn Murakawa-Leopard.

The community will be asked to submit questions in the weeks leading up to the meeting, both by e-mail and at the five school campuses. Questions will be selected and read by the moderator and the student hosts.

Coffee and refreshments will be served in the lobby at 6:30 p.m. Beverly High broadcasting students will film the meeting, co-host the discussion and air it on KBEV.

The town hall meeting immediately precedes a PTA/BHEF/BHUSD meeting

Heartless in Beverly

Although some kids saved

As some of you may know who attended or watched Tuesday night's bizarre school board meeting, I gave up the sanctity and safety of only writing about events and not being in the front line of the battle to speak out and work for allowing all the out-of-district kids now in our schools to graduate.

If you read the coverage in the Los Angeles Times Wednesday, you would have the impression that this was solely a battle between permit parents who live outside the city and hard-nosed residents who wanted the kids out.

However, the supporters of the opportunity permits managed to collect over 2,600 petitions from residents who approve allowing the students now in the schools to graduate with their class, regardless of their current grade.

That needs to be put in context, because it is a very impressive number. More actual residents, 2,600, gave their names to prevent a mass ouster of kids than voted for any candidate for school board

in the last school board election.

The most imperative argument of those who felt a responsibility to support the opportunity students was a very simple plea: The district welcomed the opportunity parents when we desperately needed to increase enrollment and then summarily prepared to boot them out when we didn't.

The financial impacts, although debatable as to real dollars, were tied to the way the district receives money for its schools. Since the passage of the draconian property tax reform ballot measure called Proposition 13 or the "Jarvis" referendum in 1978, named for political gadfly and ultra conservative **Howard Jarvis**, money for schools and local government changed. Instead of the local property tax, schools became almost totally dependent on the state.

However, this fight was not really about maintaining community based schools. Clearly, students should attend schools in their own communities. The reason we

have local school districts is, obviously, because we want community control of school policies; voters should determine the educational policies that impact their children. That is not a pure condition since many of the rules governing educational services are decided by both state and federal law, but it is still an ideal worth preserving. That wasn't the issue. The opportunity permit program had ended; now it was only about being humane, fair and responsible to the children attending our schools and who have done absolutely nothing wrong.

We also are not exactly ruling out all permit programs. As an incentive for city employees, including our police and fire departments, we provide their children with permits and we do the same for many, but not all, of our school district staff, mostly full-time teachers. There are other categories too, including the vaguely named "legacy" type granting permits to children of grand parents who still live here. That program does trouble me and others.

But I passed a historical flash back Tuesday night that few in the room would have even understood, and less actually remembered or experienced. Sitting in one of the back rows was **Marty Prince** and standing only a few feet away was **Herb Young**.

Who are Young and Prince? It has been about three decades since Prince was defeated for re-election to the school board because he was a supporter of another permit program at the time: diversity. Who was a member of the slate that ousted Prince? Young. I haven't seen Prince for years, but Young and his often political buddy and then-slate member **Mel Spitz** are very visible. Together, these two former board members campaigned against the recent school bond Measure E, and they were very active supporters of **Lisa Korbатов** in the last board election.

But what was the "diversity" program Young and Spitz disliked so intensely? Then-school board member **Dr. Arthur Malin** and Prince, and the legendary school Superintendent **Kenneth Peters** had a very important vision for our schools. They perceived our kids going through their whole educational life without ever having any touch with the real world, the one where every child is not driven to school in expensive cars and where at least some of their classmates are people of color. It is also important to understand that some 30 years back, a majority of the population had kids in our schools; they lived mainly in the north and in the more expensive homes in the flats. Today, probably fewer than 36 percent of our population has school-age children and many of the larger houses are childless.

When Young and Spitz were elected, it also meant the end of the Supt. Peters era. True, he retired, but Ken told me later he

would have remained longer if he had been asked by the new board. They made no such move because they saw Peters as one of those favoring "diversity." Yes, there were other issues such as enforcement of the dress codes, but not nearly as pervasive as the permit issue.

So, was this a repeat of history? Not exactly. The opportunity permit students are not all that different than their classmates who live here, an argument used by those board members who wanted them out now.

It does seem reasonable, or does it? Why should the taxpayers of Beverly Hills pay for the education of kids who live outside our city and as the more zealous point out, some in larger homes than those in Beverly Hills. Or as school board member **Dr. Brian David Goldberg** put it when he thought the camera was not rolling during an interview aired by the Huffington Post, "in order to keep my kids in our schools I have to live in an (expletive) little house." Goldberg later said he did not know what he said was on camera and that he had been assured it was "off the record." He even came to a rally of those supporting the opportunity permits "to apologize if my words offended or hurt anyone." Gracious gesture, but this was not an admission that he might be wrong, only backing off the language he used.

At one point during the highly contentious session, **Lisa Korbатов** asked **Myra Lurie** if she could interrupt. Lurie refused and Korbатов mumbled, "As if you haven't talked enough tonight." Not exactly collegial behavior.

But I do admire Korbатов. She is very clear on her views, makes no pretense about being any kind of education liberal and sticks to her ultra conservative political posture. Who else but a conservative could have argued that "membership has its privileges" translated into if you can afford to live here, you deserve all the benefits, including having your children attend our schools without blushing, if not, out.

Yes, I thought, although I did not endorse her, that her business experience could benefit the district, which I wrote in this column, and, no, I did not fault her for not having been involved in education programs such as PTA or the Beverly Hills Education Foundation prior to becoming a candidate. But I really had no idea how right-wing Republican her posture was on national and international issues. Nor did our heavily Democratic-registered voters. She had been in office for only a few days when she hosted an event, using her title as a board member, which was her right, for a conservative Republican office holder and candidate from outside our state.

But Korbатов is what she is without any apologies, and I admire that. Strange though that some of her so-called liberal colleagues voted as she did.

But are we as liberal as we were, or were we ever? Not really sure. The late and really great former mayor, **George Slaff**, a hard-core civil libertarian, once put it this way: "The people of Beverly

Hills are staunch supporters for the civil rights (pause) for the people of Pasadena.

However, there is one thing of which I have absolutely no doubt. If this were put to a vote, the people of our city would overwhelmingly support allowing all the children now in our schools to graduate. Although it can not, unfortunately, be put to a referendum or even initiative, if the board majority is really certain it is right, why not a purely advisory citizen vote? The costs of the election would have to be covered by voluntary contributions. That would be far less painful or divisive than the recalls now being talked about.

I had heard so many tales of woe about the behavior of the permit parents that I was not prepared for the responsible and totally mature behavior of almost all of the ones I have come to know. It was a side benefit of this effort to become friends with **Jillian Neal, Michelle Menna** and the **Formans, Wassermans** and so many others. Those who worked on the incredibly successful resident petition drive had an enormous success; it was historic. There have been few solicitations of support that gathered so many signatures so quickly as this group of volunteers.

As for the three former mayors who gave their names and time to this effort, no words can express the appreciation I feel for their efforts. I know most people in our city share that view.

Although there are few people in this city with whom I have had more political differences than **Robert K. Tanenbaum**,

his strength, dedication and involvement were the inspirational high point for all those involved. I also need to thank Robert for lending his name to the successful school-bond election.

Dr. Charles Aronberg may not be as dramatic and spellbinding as Tanenbaum, but he brought something very special to the effort. First, it was Aronberg who actually conceived the concept and implemented the first passage of the Joint Powers Agreement when he was mayor. As board member **Jake Manaster** said Tuesday, without referring to Aronberg, we might not have a school district without the JPA. (Side note: Manaster called it a gift from the city. Although the council voted to provide funding for school uses by the city for over \$10 million again this year, a "gift" is not legally sustainable and could even create a challenge to the whole program.)

What made this trio of mayors so significant, especially for long time city hall watchers, was the coming together of Tanenbaum and former mayor **Maxwell Hillary Salter**. Although it was never really personal, Robert and Max were the bickering Bickersons on the council, seldom even agreeing on a motion to adjourn. But they both shared a common bond: Working to give all the kids now in our schools the right to graduate.

Tuesday's board meeting was held in one of the Science Building's rooms. It would have been beyond ironic had it been kept in the Salter Family Theatre, our best auditorium named for the former mayor

and his family for their enormous generosity to our schools. Would they have voted against something Salter supported in his own house? Probably.

Lastly, a special note of appreciation to **Lili Bosse**. She worked hard to broker some kind of compromise and succeeded in at least saving the kids in the ninth grade. Board president **Steven Fenton** acknowledged her good work when he made, what he called, his move toward "compassion." Fenton also told us he was pleased "to get a five to zero vote on the most controversial issue since I've been on the board was very satisfying. I'm extremely grateful to all my colleagues."

Board member Myra Lurie who was the lone vote for allowing all opportunity permit students to graduate, said she had very mixed feelings about voting for any compromise, but finally voted with her colleagues to at least save the ninth graders. Ironically, board member Jake Manaster called for a "recertification" of all students in our schools to weed out those here illegally. The permit students played by the rules, but those not in the high school will be out even as we seek out the illegals.

While the fight to allow all the children who are in our schools to complete their education here suffered a major setback Tuesday, it is important to note what was achieved. The board majority voted to include the ninth grade and much earlier, to let those in our high school graduate with their class. The very first scheme was to not renew any permit at the end of

this school year.

What options are there? Many. Parents could take their case to the county, which has the ability to overturn, on a case-by-case basis, any students denied the right to a renewed permit. Second, and this would admittedly be very divisive, recall any board member who voted to oppose matriculation. Their immediate target some said would probably be Goldberg. Korbatov could not be recalled until the end of April as would Manaster. No newly-elected office holder can be recalled until they have been in office for six months.

Certainly, something is better than nothing in any disagreement or negotiation. Some kids were saved. But what concerns me most, aside from the parents and their children who may be forced out of schools they consider their own, is how this makes us look to the rest of the real world. Many other districts in exactly the same position voted to let their students graduate, some with fewer students and some with more.

As long-time community leader and former chair of the Planning Commission **Kathy Reims** said to me last week: "This just doesn't feel right."

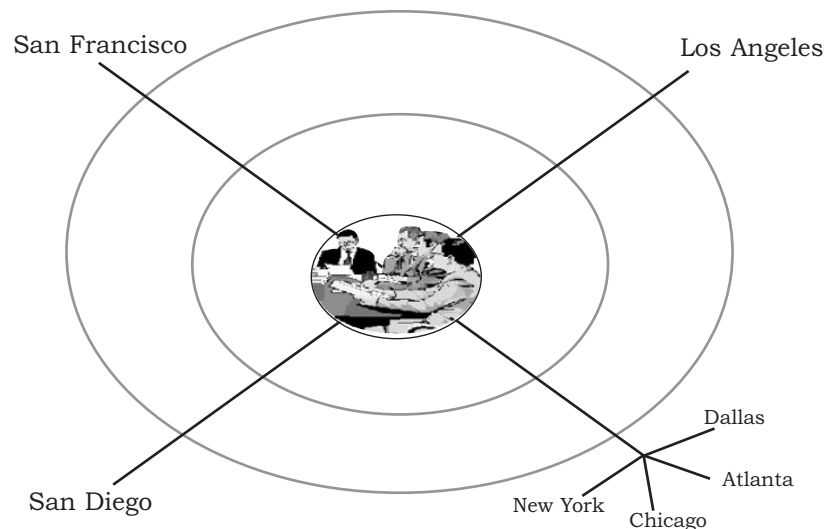

A FAREWELL TO PARKS

The Weekly's exclusive interview with retiring Community Services Director Steve Miller

What's the status of the park's master plan?

We're certainly disappointed that when we had an all-cash deal to start to build the Roxbury Community Center, it didn't happen. We went through three years of community meetings and outreach meetings. It was just meetings after meetings and working it down to where we finally felt we had a general consensus from all the key players for the plan of La Cienega and Roxbury parks and to make Roxbury Community Center the first step in restoration.

But at the end of the day, there's still a master plan for whoever takes my place to continue working with the council, and hopefully, when the time is right, the council will want to finally take that big step in getting the master plan off the ground. The 1950s-era building at Roxbury has lots of band-aids on it, and it's getting to a point where it's just not cost effective to keep trying to invest money when it'd be cheaper to just tear it down and build a state-of-the-art facility that can far more better serve this community for the next 25, 40 years over what we have today. Someday the council will want to finally move that along.

Who uses park facilities in terms of the ratio of residents and non-residents?

We have strong detailed accounting of all of our fee-based programs in terms of the resident and non-resident make-up, and by far the vast majority are residents in all of our fee-based classes both in the library and in the recreation division.

In terms of just general users of the park, when you have your two major parks right on the border of the City of Los Angeles, that's Roxbury and La Cienega, of course you're going to have a significant amount of Los Angeles residents because that's their neighborhood park. So on any given day you can figure that probably half the people out there are from the City of L.A. These parks are just getting worn out from extensive use, and that's where it needs a reinvestment of capital in order to get these parks back up to where they can better serve the overall community.

What is the range of programs?

We have everything from infancy shortly after birth all the way to our active adult senior programs and everything in between. We have programs for preschools and teen programs and young adults program and the baby-boom middle-aged generation. We try and cover all the needs. Sometimes we do a great job; sometimes we're missing the boat, so we're always trying to have a pulse of the

community of what should we be doing that we're not doing. We know sometimes our limitations are just facilities. We don't have enough room space to offer the classes. Hopefully one day with the park master plan we'll have better facilities that will better meet the program needs that a lot of our residents like.

What is the annual budget for the current fiscal year?

Currently, the community services budget is about \$42 million. That's for the library, recreation and park, human services. And the current year we cut back just under \$3 million out of our budget, so we try to be like all the departments of city: very sensitive to negative impacts to the city. There was some hard decisions to make and harder decisions from the city council of where to cut, as well as recom-

mending areas for new revenue to generate, that would be the new sports fees that we're implementing for this current fiscal year.

What impact did these cuts have on services?

It changes the life in some respects; for example, we had to start charging higher fees for some of our senior programs. For those seniors with extremely fixed

income that somebody would really gain from in participating.

What are your plans on retiring and when will that be official?

I've actually formally retired as of Dec. 28, and I started back as the interim director of community services under contract as of Jan. 4. I will remain until the new city manager has gotten himself established here and figure out the priorities of all the things he's going to have to do and the process of filling this position. It'll probably be a couple of months to figure out the process: is he going to open it up and recruit, or is it going to be an in-house candidate? If it's an open recruitment, that could perhaps take a few more months, so I would assume that I might be here through April or May through the budget process and allowing Jeff [Kolin] sufficient time to determine his schedule for recruitment.

What major changes have you made in the organization?

I first was appointed as a director by [former City Manager] Mark Scott in November of 1992. At that time, we went through, for many years, a number of organization changes to be more streamlined. We contracted out a variety of services, like our tree maintenance and turf maintenance. A lot of my focus for a number of years was the aging infrastructure in our park system. I really spent the 1990s pretty much mapping out a lot of the unseen ugly stuff, if you will, in the infrastructure, such as irrigation lines and sewage lines that ran through our parks. Getting those replaced so our parks would operate effectively and then getting into more cosmetic things.

I've been able to bring in a variety of partnerships with private individuals and organizations to help fund some of our projects, including the Beverly Hills sign through the Beverly Hills Rotary. Most recently in the last five and a half years when [retiring City Manager] Rod Wood came on as the city manager, he reorganized a lot of the city departments, and he created the community services department, which really merged the library

department and recreation and parks department and created the human services division and putting all of those under one umbrella in community services. He asked me to take on the leadership as the director of the community services department.

I've really been trying to get those independent departments to row the boat in the same direction and work together and try to look for opportunities to streamline and try to minimize duplication of services.

What are your proudest accomplishments?

The renovation of Will Rogers Park back in the late 1990s and most recently in a series of restorations: rebuilding the fountain, totally renovating the park, yet trying to keep its historic character. It's the city's first park which was a gift from the Beverly Hills Hotel. It was originally called Sunset Park and then was renamed by the council after Will Rogers back in the 1950s. So we certainly want to do a correct job in restorations, and we're very proud of how that's turned out.

A park right near the Weekly, the Reeves Park. Once upon a time back in the 1990s and 1980s, it was a pretty sorry-looking park. We did a full restoration, basically just wiped everything clean and rebuilt the entire park brand new probably about eight years ago. We're very proud of that local neighborhood park and how that turned out.

I've gone through renovations of all our fountains in our parks. All of our mini parks have been completely renovated. The next park we master planned is across the street from Coldwater Canyon Park and that's the Coldwater Reservoir Park site on top of the reservoirs that has been under construction for several years. It will actually be opened up and ready for dedication in April of this year, and we're excited to see that finally come on board.

Another project I was very proud of was leading the process with great staff team to select Kelly's Coffee and Fudge from a process that lead to their leasing space in the library, which has become a great part of the Civic Center neighborhood. Also, working with our fabulous library staff and the Great Friends of the Library organization, we moved their book store from upstairs in the library down stairs to a much better location which has resulted in higher sales for the friends since they have moved.

The last one and maybe right on top of the list is historic Greystone Park Mansion. For many decades, that park site had virtually no investment by the city. The park was pretty much falling apart. And what I was able to do with the Recreation and Parks Commission was to recommend to the city council how we should go about restoring and renovating that park site. We really started renovating the park grounds through a series of phase upgrades through our master plan effort. And we're just now getting ready to start the third phase of grounds restoration for

that park, and that will begin in the next month. And we're slowly getting the grounds all back to a lovely historic appearance with all brand new infrastructures, irrigation and drainage. We recently finished the full restoration of all the electrical lighting, all new plumbing for the bathroom, and we're currently under construction for the catering kitchen.

What are your plans after retirement?

I'm going to have a variety of interests and hobbies that I hope to have more time to take on. I have two daughters. One is in college and another one will begin college in the fall of this year. My daughter Lauren is in her second year at [Arizona State University], and then my daughter Jennifer is a senior at Redondo Union High School. Hopefully, I'll have more time with my wife to do a little bit of traveling this summer. My wife Candice and I have been married for almost 25 years. We're actually going to be celebrating our 25th anniversary this July, and we're going with some friends on a cruise of the Danube River in the Germany, Austria area. We're looking forward to that.

In terms of hobbies, I'm a pilot so hope-

we've been able to find a third party that they could donate to who would in turn donate to us. We think there's a lot of potential partnerships out there that would want to come together and help fund certain restoration projects in our facilities or help fund certain services or programs that we either had to cut back on or have not been able to deliver in the past. That private funding makes it easier to not have this roadblock in the way.

The second part of that will be the actual marketing part of it, and that will be in April. So if the council says yes to creating the 501(c)(3), the second part will be coming back to show them the marketing opportunities of how we would market it to make sure people are aware of how they can partner with the city.

What we are also planning to do is, in two years, roll out the first in probably a three-phase effort to do some gentle renovation of the interior of the library to make it more usable, to make it better for programming, for technology. We are also going to create a much more extensive teen-zone area, a mix of study opportunities, tutoring opportunities, down time, fun time, a safe area to be where they don't have to interrupt any other library users.

fully I'll have more time to do a little bit of flying. I've had [my pilot's license] since 1971. I like motorcycles and motorcycle riding. I'm into astronomy; I've got a large telescope set up, all computerized.

What are some things you are working on now?

We're going to be bringing to the city council, probably in February, a discussion on creating the 501(c)(3) program that allows for charitable donations to the city. The problem has been that we've run into roadblocks with some corporations, foundations, charities that would want to donate to a program, service or project but their bylaws say they can only give to 501(c)(3) organizations. Because the city has not been a 501(c)(3), we were not able to accept the money. Or in a few cases

How did you get involved with community services, recreation and parks?

I'm kind of a byproduct of that. My father worked for the city of Los Angeles Recreation and Parks Department where he retired after 35 years, and he was the superintendent of recreation, so I kind of grew up on parks my whole life in L.A. I eventually started working part time in the 1960s for the City of Los Angeles Recreation and Parks. I used to drive the trolley car and worked in Griffith Park in different sites and parks, and then went on to the City of Carson, where I worked for 11 years as supervisor and park director, and then I came to Beverly Hills in January of 1984. I've been here ever since.

What are you going to miss about the job?

It's really the people. Working in Beverly Hills, you've probably heard this from others, it really is a special community in so many ways. I've had the luxury of meeting so many wonderful people, working with so many wonderful commissioners, councilmembers over the years, heads of organizations, of little league and soccer and certainly the staff. That has just made it a very rich experience for me.

Who have you enjoyed working with the most?

It's hard to list one or two or three. There's just several thousand people, probably because of the nature of this job, and you're working with the community in so many different ways and meeting so many wonderful people who really care about this community. It would be too hard for me to measure it down to one or two people.

I'm just very thankful to my former boss Rick Putnam for hiring me back in late 1983, to Mark Scott for appointing me to director and for Rod Wood for giving me this opportunity for the last five and a half years to take on this bigger assignment. Rudy Cole has been a huge part of my 26 years here. Working with him on the commission, before the commission and after the commission, and working with the Greystone Foundation that he was running. Rudy has been a great person to go to to really help get some insight on thoughts and ways of trying to make a difference in this community.

What's the most memorable moment in your career?

I think in terms of my internal legacy, I've been known to have a sense of humor, and I like to keep the group laughing at the department head level and working. I like to kind of keep the group well-oiled with humor, and I'm trying to introduce it into some of my council and budget presentations.

What are your goals for the near future?

We're trying to wrap up some capital projects that I've had my fingerprints on for a while, both at Greystone and at Coldwater Reservoir Park, and we're working on the budget process right now. And I'm doing a lot of transitioning, getting key staff in my division to know that there's a new director coming and to be ready for a transition without a blink of the eye. At the end of the day, we're just gatekeepers for a period of time. It's really about the residents and the services provided, and behind the scenes, there's wonderful people that work for the city that, by and large, love what they're doing and love the city that they're fortunate enough to work in.

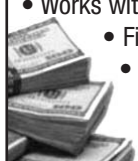
