Moving planetarium dome could be complicated, manufacturer says

In the event the Board of Education decides to demolish Building A and relocate Beverly High's planetarium to a newly constructed building, the planetarium's 30 foot dome could lose its smooth surface, according to planetarium manufacturer Spitz Inc.

"When you take [the dome] apart, what happens when you pull the rivets off, there gets to be some wrinkles in the panels, so when we go to put it back together again, it's a little bit lumpier than it was when it got taken down," said Customer Accounts Director Joyce Towne. "It's possible that it could be moved. It's just that we do it on what's called a best effort basis."

Beverly High's Building A houses a planetarium that was installed in 1969, which includes a 30 foot dome and an A-4 Spitz Star projector. Towne said it would cost the district around \$80,000 to \$100,000 to move the planetarium.

Towne said she would need to look into the old files to determine if the 1969 dome has the early "butt-seams" or not.

According to Towne, butt-seam is an industry term for early types of seaming technology.

While butt-seam domes are movable, most people faced with the challenge of moving a dome end up simply buying a new one to ensure a smooth surface, said Towne.

Towne said if the district had interest in moving the planetarium, the cost of relocating the planetarium would depend on the number of trips made or whether or not the equipment would be moved all at once.

Though movable, the room in the new building would need to be built specifically for the planetarium's use, ostensibly on the top floor.

"If they kept that dome, which is 30 feet across, they'd need a space that is 30 feet across in every direction, 30 feet by 30 feet wide," said Towne. "And the height is much higher than a normal room. They'd need 24 feet of height to get the dome in there, the same size they have now."

Towne said the projection equipment is easy enough to move, but its capabilities extend to simply projecting the stars on certain nights.

"Compared to the latest technology that's been out for 10 or 20 years, digital planetariums play shows on other topics like chemistry, biology, weather, earth science," said Towne. "If they were able to upgrade to a digital planetarium, they could do a thousand things more and that's not an exaggeration of a number."

Towne said a new digital planetarium would cost about \$400,000 for the projector and dome.

Board of Education President Jake Manaster said the Board has not yet reached that part of the discussion and the fate of the planetarium and other programs would be decided after April 30 when DLR Architects are due to submit conceptual designs for Beverly High to the Board.

"We haven't discussed any of that; we haven't gotten to it, that's why it's both premature and irresponsible," said Manaster.

"We're only looking at programmatic issues at the moment meaning that we're trying to figure out what size the classrooms should be and what can go into the building and then we are going to receive a proposal about the modular additions to the classrooms that would allow certain types of labs, certain types of engineering rooms, certain types of all kinds of different things," said Manaster.

The Board of Education has not made any formal decisions regarding Measure E construction at Beverly High. Preliminary discussions have suggested interest in demolishing Building A, which houses the planetarium, the KBEV studio, and library.

BHUSD Consultant Tim Buresh, who has been contracted to oversee Measure E construction, said whether or not the planetarium would be moved in the event Building A was demolished depended on whether or not students would use it.

"Unless it was part of the educational program, there probably isn't much sense in saving it and right now, I think it could be a cool part but that's going to come out of the instruction whether it makes sense or not," said Buresh.

The planetarium has not been in use for about four or five years, according to Chief Academic Office Jennifer Tedford, who said the program was mainly discontinued because the facility is not in great condition.

Towne is familiar with the Beverly High planetarium and said she had spoken to the school district a few months ago.

According to the International Planetarium Society, Beverly High is one of only 245 high schools with a planetarium in the entire country.

Tedford said there was district interest in offering astronomy again because it aligns with Science, Technology, Education, and Mathematics (STEM) education, which the district has made a priority.

Planning Commission approves new jazz club, Infiniti project

The Planning Commission unanimously approved a conditional use permit for the Infiniti project location at 9031 Olympic Boulevard at the commission meeting on March 28. The CUP was approved 3-0.

"I think it's a nice project for our City," said Commissioner Dan Yukelson. "It's great to have another high end car dealer operating in our City."

Planning Commission Chair Craig Corman and Vice Chair Brian Rosenstein did not attend the meeting. The meeting was chaired by Yukelson.

This location is one of four proposed sites within the City of Beverly Hills. The 8825 Wilshire Boulevard location will contain the sales operations for Infiniti.

The other locations at 9000, 9001, and 9031 Olympic Boulevard are planned to be utilized for vehicle service and preparation operations. Conditional use permits were previously granted by the Planning Commission for 9001 and 9000 Olympic Boulevard and 8825 Wilshire Boulevard to allow vehicle sales and service uses, so new conditional use permits are not required.

The 9031 location needed a conditional use permit because it is currently being occupied by an antique rug dealer. The site was previously occupied by Hillcrest Motor Company, which sold and serviced Cadillacs up until 1986. Antiquarian Traders now occupy the space.

"We put a few more conditions on it just to make sure that there's no possibility of any impact of residents that live on South Wetherly," said Yukelson. "We changed the pattern that the cars would need to circulate between dropoff and driving into the repair facility."

The 9031 location would work in conjunction with the 9000 and 9001 locations. Patrons would drop their vehicles off for service at the 9001 location. It would serve as the designated drop off and pick up location. A porter would take patrons' vehicles from 9001 to 9031 Olympic Boulevard.

The commission also approved an in-lieu parking pilot program for Spaghetini, a new restaurant and jazz club at 184 North Canon Drive.

"It's very challenging to open and operate a restaurant. Those are businesses that don't always make it and they're extremely risky. In order to operate in Beverly

Hills, they would be required under our current code to purchase 59 in-lieu parking spaces," said Yukelson.

The commission approved a zone text amendment that allows Spaghetini to pay a reduced fee of \$45,135 paid annually in perpetuity for 59 in-lieu parking spaces.

Under current code, the restaurant would be required to pay \$139,063 annually over a period of 10 years.

"If they were to do that, the business could just not operate successfully," said Yukelson. "In order to enable them to open and come into Beverly Hills the city suggested a pilot program be created that's really going to be geared towards businesses like Spaghetini that bring certain attributes into the City like some nightlife or things like that."

The municipal code currently allows the planning commission and city council to reduce or waive in-lieu parking fees, but only for museum uses and adaptive reuse of buildings listed on the National

Register of Historic Places.

The planning commission approved this as a test case to see if the City ultimately benefitted by allowing a reduction of in lieu parking fees.

Spaghetini also requested an extended hours permit to operate until 1 a.m., which was also approved.

"They're designing the space so there's a significant amount of sound barriers and sound cushioning inside, so there's absolutely no way, according to the sound engineers that looked at it, that there would be any spillage of sound that would impact the apartments that are on the other side of the alley," said Yukelson.

The planning commission also discussed automatic parking where one's car is parked mechanically by an automated parking system. The item was put on the agenda at Yukelson's request.

Beverly Hills could not accommodate

The public is invited to attend. At the City Council's formal meeting on **Thursday, April 11, 2013 at 7:00 p.m.**, the City Council will provide questions to staff regarding the Gateway properties and the proposed Gateway Project (see below) so staff may prepare information and respond to the questions at a future City Council public hearing that will be separately noticed. The City Council meetings on April 11, 2013 will be held in the Council Chambers of the City Hall, 455 N. Rexford Drive, Beverly Hills, CA 90210.

The Gateway Project is a proposed ordinance of the City of Beverly Hills that would create the Commercial Planned Development Gateway Overlay Zone for three parcels of former railroad right-of-way property located at 9900 Santa Monica Boulevard, 9848 Wilshire Boulevard and 9817 Wilshire Boulevard currently zoned Transportation (T-1) and all immediately adjacent parcels currently zoned for Commercial (C-3) use (the "Gateway properties"); and, a General Plan land use amendment for future commercial developments of these parcels. Development under the proposed overlay zone would be consistent with the objectives and development standards associated with the proposed overlay zone.

The properties, which together total approximately 4.6 acres in size, are located between the north roadway of Santa Monica Boulevard and the south roadway of Santa Monica Boulevard, on either side of the intersection of Santa Monica and Wilshire Boulevards.

The Gateway Project was reviewed at City Council public hearings on June 19, 2012 and July 24, 2012 and videotape of these meetings, as well as copies of all documents provided to the City Council for these meetings, may be viewed on the City's website at www.beverlyhills.org.

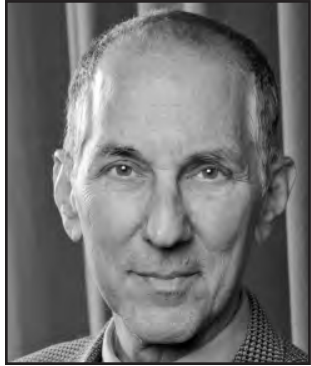

Pressman blasts Board of Education

Retiring choral director Joel Pressman said the real reason he announced his retirement after 38 years at Beverly High was “not because [he doesn’t] love teaching [his] students, but because [he] feels that we’ve lost a certain collegiality.”

“I feel that we’ve lost respect for the professional educators and the stress of that is something that in my current state, I’ve had enough of and I need to go to a more stress-free environment,” said Pressman.

Pressman addressed the Board of Education last Thursday and said he was responding to an unspecified Board member, who said that “I believe that any administrator or teacher who takes the position that some students simply cannot meet these raised standards and expectations with our current accommodations simply do not belong in public education.”

Pressman said in his nine minutes in front of the Board that all students do not learn the same way and expecting all students to meet the University of California’s A through G requirements to graduate was setting students up to fail.

“When we took away some of those lower level classes for lack of a better term, we set kids up for failure, and then we blame teachers,” said Pressman.

Horace Mann Spartans go to Disneyland

Pressman said that though the current Board of Education was more civil than some boards in the past, he believed there was a tendency to “think that because I’m elected to the school board, I know a lot more than other people.”

City Council votes 3-2 to extend e-mail retention policy

The Beverly Hills City Council voted 3-2 to extend the City’s email retention policy from 30 days to two years in one of the first decisions made by the newly-installed city council on Tuesday night. Councilmembers Willie Brien and Julian Gold dissented.

The agenda item came at the request by Mayor John Mirisch. The Mayor made a similar request last October when the then-City council discussed the policy during a study session and the majority of the then-council recommended the policy remain at 30 day retention.

“I don’t see how making files more accessible to the public involving our interactions with the public or the public’s interaction with city hall is anything but something that’s promoting the goals of transparency and open government and participation,” said Mirisch.

In 2005, the city established a 30-day

retention period for the contents in the email system. However, emails that were considered in the public’s interest would be preserved in a hard copy or in electronic storage and retained for a longer period of time.

The principal driver of the 30-day policy was because the city did not have the appropriate infrastructure to hold emails for a longer period of time. That problem no longer exists and storage space is a non-issue, according to Chief Information Officer David Schirmer.

The policy encouraged “best practices” in determining whether an email was public record or not. Schirmer said that was usually determined by whether an email was project related.

Beverly Hills Rotary Club President AJ Willmer said he worried that residents would send private information in email form to city employees, which may be entered into the public record without their knowledge or consent.

City Councilmember Nancy Krasne said what you put in the e-mail is your choice.

“You could just pick up the phone and call somebody,” said Krasne. “You opted to use this email for whatever reason that you want...if you write it in an email, you better be prepared to let it be in the newspaper.”

Krasne said she supported transparency.

"This is a transparent city and I ran on transparency and sunshine is the best disinfectant I know," said Krasne.

Councilmember Willie Brien suggested the City look into sending a warning or alert to residents, so they would know their email would enter the public record for two years.

"I find it from my perspective offensive to even suggest that we would not allow the community and the residents who own city hall to have access to everything we do in this city, so for me there's no question whatsoever that this is a wonderful idea," said Vice Mayor Lili Bosse.

Beverly Hills City Council approves wood roof ordinance; goes into effect May 2

The Beverly Hills City Council unanimously approved the wood roof ordinance at the formal meeting on Tuesday.

The ordinance accepts six amendments to the current ordinance, which was last revised in 2007. The ordinance was originally adopted in 1987 requiring Class A roof assemblies for all new construction and replacement roofs. In 1993, the ordinance was revised so that it would require that all wood roofs would be replaced by July 1, 2013. The ordinance was approved for a second reading.

In 2007, the ordinance was amended to ban wood roofs altogether.

The amended ordinance extends the date for compliance until July 1, 2014. By that point residents must either replace their wood roofs to a class A non-wood roof or spray them with a fire retardant spray.

A certified applicator must apply the spray and the spray must be reapplied every five years. The entire roof must be replaced upon sale or transfer of the property.

There are currently 151 noncompliant wood roofs in the City of Beverly Hills.

The City can assist residents who may not be able to afford to comply with community development block grant funding. The City has received 11 responses from low annual income residents who would like to participate in the program.

The City can provide up to \$15,000 per resident and can accommodate 13 people.

Houses that are eligible for historical recognition are exempt from compliance.

Vice Mayor Lili Bosse said she was comfortable with the ordinance, but was not comfortable with the amendment that said the roof must be replaced at time of sale. Bosse said she felt the City was penalizing people for selling their homes.

"I don't feel that we are being fair in some regard because on one hand we're saying people can keep their roof with the fire retardant indefinitely every five years and in the next breath, if the next door neighbor is selling their home they have to pay for a new roof or the person who's buying the home has to pay for a new roof," said Bosse.

Bosse suggested the council require replacement of roofs upon sale in homes located north of sunset, where there was a higher risk of homes catching fire.

Brien responded saying to him it was a public safety issue and though he understood the burden, he felt it was talking out of "both sides of the mouth" to impose different requirements based on geographic location of homes.

Bosse said she was prepared to move forward with the ordinance as written to ensure public safety in the community.

Board of Education reacts to critical Measure E performance audit

The Board of Education voted 5-0 at the formal board meeting last Thursday to accept the performance audit regarding Measure E for the 2011 to 2012 year.

The audit was performed by Harvey M. Rose Associates. Fred Brosseau, a principal with the firm, presented the audit to the Board of Education.

Board of Education member Lewis Hall said some of the items in the audit had concerned him. The audit said that as of June 2012, the Board had not completed more than concept drawings with the exception of the new auditorium at Horace Mann. Hall said schematic drawings had been completed on all buildings at Horace Mann by that time.

Brosseau said when Hall had mentioned the discrepancy the audit was already at the end of its process. Brosseau said the audit had been previously reviewed by district staff, which provided corrections and clarifications.

Certain findings in the audit suggested

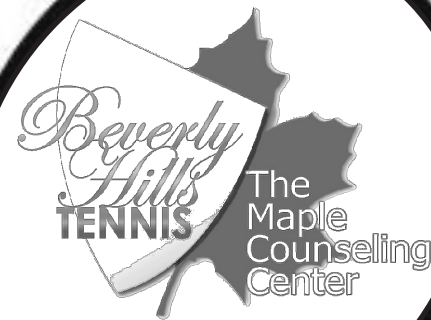

the district faced a certain risk because consultant fees are a large portion of Measure E bond money related to the MTA case.

The auditor recommended the district provide the COC with legal invoices, name of consultants, amounts paid to each, and a brief description of the case matter to "facilitate transparency and compliance with laws and regulations."

"We are not saying anything about the nature of the case or whether or not it was appropriate. What we are addressing is the budgetary process surrounding the funds used for that and expenditure controls, so the contract administrative process, which we found deficient and the budget process which did not adequately disclose what was proposed and what was actually spent," said Brosseau.

Board of Education member Lisa Korbatov said it was hard to project expenditures because the situation is "fluid." She said there was probably no other high school who has had to deal with this situation.

"The [California Geologic Survey] report I think basically makes the case that we did a phenomenal job as a board. We found out that the land is fault free and we can build on every inch of it. I appreciate it doesn't follow your normal pattern but I want to say to you and to the public that we're really in uncharted waters," said Korbatov.

Korbatov said she took the constructive criticisms with a "grain of salt" because many do not apply. The Board did not want to make their efforts known to their opponents in the case.

Board of Education Vice President Noah Margo said it was important to note

that the audit is a different time and many of the criticisms had been improved on.

Board of Education President Jake Manaster said one of his biggest problems on the audit is that it relies heavily on the 2008 draft master plan.

"I think everybody here knows, but that particular plan as it's referenced over and over again in the performance report, was the subject of a civil suit, was the subject of a criminal investigation and it resulted in two convictions of two former employees," said Manaster. "To me, that says an awful lot about why we're not relying on it."

Manaster said that he felt the report was incomplete because it lacked some of the contextual background.

Bruce Cole released from jail

Beverly Hills resident and former Mamtek CEO Bruce Cole was released from jail on March 26 after the judge granted him a bond reduction.

Cole's bond was reduced to \$10,000 from \$500,000. Cole had previously said in court he can come up with funds to pay for an attorney if released on bond and allowed to travel to California.

Cole is being represented by Public Defender Raymond Legg.

The public defender commission who runs the public defender system filed a request for the public defender to withdraw because Cole's assets exceed federal poverty guidelines, but Legg said he continues to represent Cole.

It is unclear if Cole returned to California. Though he Legg is aware of Cole's location, he is under court order not to release that information.

Cole is being charged with five felonies

-- one count of theft and four counts of securities fraud in relation to a failed business deal in Moberly, Mo.

Cole had been in custody since Sept. 15.

Legg said up next are pretrial motions related to discovery. Legg said he did not have a timeline on future motions.

BHUSD lawyers ask Metro to withdraw approval of Westside Subway Extension route

BHUSD's legal team sent a letter to the Metropolitan Transit Authority's legal counsel requesting Metro withdraw approval of phases two and three of the Westside Subway Extension.

In a letter dated March 20, Hill, Farrer & Burrill sent a letter to Metro's lawyers asking that the governmental entity take into consideration evidence provided by the district that no faults exist under Beverly High, as described in Metro's geologic study.

The letter to Metro's counsel followed a letter from the California Geologic Survey, dated March 15, confirming the district's claims that there are no faults located beneath the high school. The letter from CGS clears the campus for construction related to the Measure E bond.

"The District now requests that Metro set aside its approval of phases two and three of the project and initiate further environmental analysis in compliance with CEQA," wrote Kevin Brogan, the lead attorney in the CEQA case.

The California Geologic Survey sent a letter to the school district last week confirming results and conclusions reached by Leighton Consulting, the firm used by BHUSD to test for faults under Beverly High.

Board of Education member Lewis Hall said the CGS letter gave the district more clout in its lawsuits during the oral communications portion of last Thursday's board meeting.

"Usually when the California Geologic Survey issues a letter clearing a high school site for building which is critical for us, it's usually a one page letter, which one of their geologists signs. This letter was seven pages and it was also signed by three of their top geologists, so that makes a statement," said Hall. "This is definitive. Don't mess with us."

The Metro Board of Directors certified the Final EIS/EIR based on information provided by Metro's geologic consultants that said active faults under Beverly High extended under the proposed Santa Monica Station.

The CEQA challenge filed by both BHUSD and the City challenges the EIR used by Metro to approve phases two and three of the Westside Subway Extension.

Beverly Hills business owner sentenced to 10 years in federal prison

John Farahi, of Bel-Air Estates, was sentenced on March 18 to 10 years in federal prison for running an alleged \$24 million bond scam. He was ordered to pay over \$24 million in restitution to 59 victims.

Farahi ran Beverly Hills-based New Point Financial Services and had a radio show on KIRN-AM.

Farahi pleaded guilty to mail fraud, loan fraud, selling unregistered securities and conspiring to obstruct justice in June 2012.

His outside counsel, David Tamman was convicted of 10 counts last year, including obstruction of justice, altering records in a federal investigation, and being an accessory after the fact to Farahi's crimes.

Tamman, a partner at Nixon Peabody, was suspended by the California Bar and will be sentenced on May 20.

The SEC sued Farahi and New Point in January 2010, and eventually froze his assets and appointed a receiver for New Point.

Concerts on Canon to return this summer

The City will offer a free concert and movie series for the fourth year in a row beginning in June.

"Concerts on Canon," held in Beverly Canon Gardens, will include 11 Thursday concerts and five Sunday movie nights. Concerts will begin at 6 p.m. and end at 8 p.m.

The first concert will open June 6 with the last on Aug. 29. There will not be a concert on June 13 and July 4. Groups confirmed to perform include the Beverly High Jazz Band and the Tokens, featuring Phil and Board of Education Vice President Noah Margo.

City Council reviews regulation of nonconforming uses for vacant properties

The Beverly Hills City Council reviewed the use of conditional use permits for properties that have been vacant for a period of time at the study session on Tuesday.

"My thought was that this would give the city more opportunity to fulfill whatever vision it may have for certain land uses that if a piece of property is vacant for a period of time and it has a nonconforming use then it becomes appropriate for the city to say well it's been vacant for that period of time, the benefit of the nonconforming use should no longer apply," said Mayor John Mirisch who requested the discussion. "I think it would give the City more latitude to pursue whatever visions we may have for land use decisions."

The City's zoning ordinance regulates the size and location of buildings and permitted land uses. Some land uses are permitted by the City's zoning ordinance by right, others may be conditionally permitted, and some are prohibited.

Conditional use permit entitlements run with the land given there is not intervening use in between.

Director of Community Development Susan Healy Keane said other communities have implemented regulation that a nonconforming use of a property would

no longer apply if left vacant for a period of time.

The council has asked the Planning Commission to review what other communities have done and the implications for implementing such a policy.

Krasne said she would not support something that would preclude businesses from operating in the City.

Vice Mayor Lili Bosse said she felt it was a policy worth exploring. Councilmembers Julian Gold and Willie Brien said they would review a study and proposal, but were skeptic about the initial idea.

Keane said the code was unclear as to whether conditional use permits had an expiration date and would review the policy with the City attorney's office.

A separate item was placed on the study session agenda by Mayor Mirisch to discuss ways to incorporate input on projects from the Southeast Task Force prior to commission review.

Councilmember Julian Gold said he felt the south east residents should be involved, but that that extended to all residents in the city. Gold agreed the community should be engaged, but with a balance, so that processes would not be duplicated.

Councilmembers Willie Brien worried about adding a new layer to slow down the process.

All councilmembers supported initiating greater outreach to residents. City Manager Jeff Kolin said staff could bring proposals back to council. Kolin also sug-

gested presenting the City website's various features at a future meeting. Kolin said the website allows residents to subscribe to receiving emails and text messages based on commission agendas or geographic locations.

Beverly Hills hosts Earth Day celebrations at Farmers' Market

The City of Beverly Hills' Public Works Department will celebrate Earth Day at the Beverly Hills Farmers' Market on April 14 from 9 a.m. to 1 p.m.

The celebration includes displays about water conservation and management, energy efficiency tips and recycling booths.

There will be a mobile earthquake simulator with emergency kits and equipment available for purchase, appliance rebate information via the SoCal Edison Mobile Unit, free 20-pound bags of compost while supplies last and a used battery/printer cartridge drop-off center. There will also be free document shredding.

Children will be invited to make pots out of newspaper and plant fava beans that they can take home and cultivate. They will also be invited to help paint an ecologically-themed mural using earth-friendly materials.

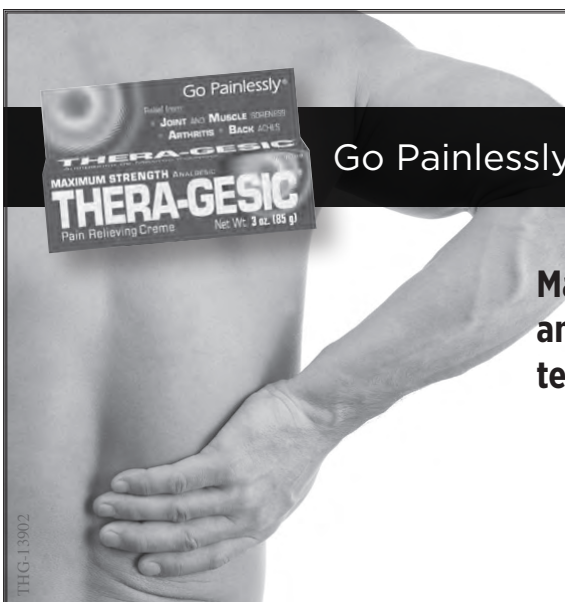

ART TALK

The Weekly's exclusive interview with Fine Art Commission Chair Fiona Chalom

What is the fine art commission up to right now?

Well, we have several things on the docket. The biggest thing before us right now is the fine art ordinance, which [we are] trying to update and revise to comport more with the needs of the City and the Fine Art Commission in terms of the process to make it clearer to developers and to enhance for future commissions what constitutes fine art and how to deaccession it if something is no longer an appropriate piece for the City. We got the *Millard Sheets' Mural*, which are going to be unveiled May 7 at 1 p.m. and they're beautiful and they're at the library. Another thing is trying to put a protective barrier around the Kusama [*Hymn of Life: Tulips*]. That's been a very big issue because we had it vandalized and people seem to want to use it as playground equipment when it isn't.

The commission has dedicated special meetings to revising the Fine Art Ordinance. Tell us about some of the revisions.

Many of the revisions are in a desire to clarify and streamline the process at how the fine art commission works, which is whether a company or developer wants to give money to the fine art commission, that then we can pull to purchase [public] fine art or to maintain the art that we have existing or the process that they need to go to if the developer wants to purchase and retain a piece of fine art that would stay with the property. In the past five years that I've been on the commission, there have been numerous occasions where there's been controversy or difficulty with regard to exactly what and how their obligation can be met or should be met, what constitutes fine art and those kinds of things. This is an attempt to try to clarify that so that it's more structured and standardized. When a project comes forward they know what to expect and future commissions will have clearer guidelines as to how to proceed. We've had a number of situations that make it contentious and difficult.

What are some specific issues that led to revision of the ordinance?

Some of the revisions were [because of] the Joel Shapiro that occurred at the former CAA building -- that was a point of difficulty. What to do with certain things that were gifted to the City through past commissions. What constitutes fine art from the past to present -- when other commissions, and we're talking 30 years ago, what their standards were and how do we incorporate them or not incorporate them? You know, those kinds of things.

Can you explain what happened with Joel Shapiro?

The owner of the building who was Michael Ovitz had purchased the Joel Shapiro. He had purchased the Joel Shapiro for the fine art obligation for that building, so what happened was that he then removed that piece of sculpture inappropriately from the site. When a developer buys a piece of art, the art is supposed to stay with the property in perpetuity. You can't then substitute it out because that specific piece has been approved for that site for that price point. When he removed it, there was then this big controversy as to what and how to then replace it and what then is fair and equitable. That's part of the fine art ordinance to make all of those issues absolutely ironclad.

So he moved the art piece to [the new CAA building in] Century City?

No, he moved the piece to his home.

So the former CAA building [on Wilshire] no longer has an art piece with it?

That's right. So that's what then has taken probably the last two years of either bring it back or pay the fair market value and then the City attorney's office came up with an agreement. The fine art ordinance is trying to close up all of these loopholes, so we don't have any more of those kinds of issues.

How did you get involved with the Fine Art Commission?

I got involved because I've lived here in Beverly Hills for 25 years and I thought

some of the art I liked and some of the art, I didn't like and interestingly it was my son, who said, "Mom, you're interested in art, I think you should be on the art commission," and I said, "Oh I don't think they would want someone like me. What do I know about it all?" He actually went online and found that there was an opening and held my hand because I'm not a computer savvy person and had me apply and lo and behold, I was accepted to my absolute surprise and chagrin. I have my son, Daniel, to thank for getting the ball rolling.

What are your goals this year as chair of the commission?

What I would like to do is to really work assiduously -- right now, the ordinance is with the City attorney's office -- [to] work with them hand in hand to get this finalized and to the city council. I'd like to work closely with recreation and parks so that we're pulling together for the betterment of the fine art in the park so that we're enhancing the public space to the best of our abilities. I would like also to look, since we've purchased the Plensa, if there is anything else out there in the next year that we would like to contemplate purchasing because the process is very slow and it may take several years to find something that is appropriate, so we need to keep our eyes open. Some of the other things that we'd like to do is certainly make sure that the art that is developer-owned art is actually onsite and is being maintained, as they are contractually obligated to do so, so we would like to make sure that's occurring. I'm hoping things can be consolidated and moved forward. There's a lot of things at play, so [my goal is] to make sure they don't get derailed or jettisoned.

What are some things you look for when purchasing a public art piece?

Some of the criteria are that the art is renowned and that renowned is either nationally or internationally; that the person has a stature that is established, you know, not just someone who is aspiring. That has different litmus tests which are that they have a track record, either a primary or secondary market that's been substantiated, that they're not fluctuating wildly, that they are by represented by fine art galleries or agents, and that they have had showings at well established galleries, museums, venues like that so that the art is an established one.

What public art piece are you most proud of obtaining for the City?

I know that when you're asking people that are collectors and I'm a collector, it's always the last piece you bought or the one that you're hoping to get, so I'm very happy with the Plensa. I think it's a beautiful piece. It speaks very nicely to the community given that it's a multi-language piece and internationally. I love all the other pieces as well, but I think that's a very nice piece and it fits beautifully in the [Beverly Gardens] park there.

You mentioned you were an art collector. What kind of art do you collect?

I collect 19th century art. My collecting venue is significantly different than the type of pieces that are purchased for public art. I don't have anything that would be considered public art.

Why 19th century art?

When I started collecting, I wanted to collect art that had what I consider a conveyance of something. That to me was either something that was mythological, allegorical or religious in its content and so the 19th century lends itself very neatly, if you will, to that type of imagery.

What are some of the challenges to working on the fine art commission?

Some of the challenges are that things move slowly. It can be cumbersome at times. You want to get something done and working in a City organization can sometimes take longer than it would in private industry. But having said that, I've been so incredibly impressed with how hard working and dedicated people at the city are to do what they can do to move things along. It's just a large organism that is slow with its process, which in some ways is good because there are checks and balances but in other ways, it can be frustrating, because you can't go, "okay here's the check. Go put up the fence around [an art piece]" and get it done. You have to go through a multitude of layers and committees. That I find somewhat difficult but at the same time I understand the whys and the wherefores for it.

Tell us about yourself.

I have a Ph.D. in marriage and family counseling and I have a part time private practice and I teach at Pepperdine University in their doctoral program. I supervise doctoral students at the clinic and that's what I do when I'm not at the art commission. I'm the mother of four children. My children range in age from 15-25. I have Moriah, and she's 15 and she's a 10th grader at Shalhevet High School. Then I have Daniel and he's 19, and he's a freshman at Vanderbilt University. Then, I have Sarah, and she's a graduating senior from USC and she's 23. Then, my oldest is Rachel and she's a first year law student at Hastings up in San Francisco.

How did you end up in Beverly Hills?

Well, my husband [Joel Aronowitz] is a plastic and reconstructive surgeon and in 1987, we were living in Texas, and the economy in Texas plummeted and we decided that we would move to Los Angeles. He had come to a medical conference out here and my parents had been living in Beverly Hills, but I had never lived here. And we decided that we would move to Los Angeles and we did. We moved out here July 1, 1987 and that was it.

What are your plans for after working on the Commission?

I'll just go back to doing what I typically do. I'll continue in my private practice and teaching at Pepperdine and doing other things. I've become more active at the Getty. There's an art group there I'm involved in.

What is the art group?

The art group at the Getty is a works-on-paper group and what it does is it looks to acquire pieces of art for the Getty that are works on paper, so they're drawings, prints, etchings, that sort of thing. It's a small group, but it's a very dynamic and invested group in terms of wanting to really acquire truly masterpiece items for the Getty.

What's your favorite part about living in Beverly Hills?

I don't think that it's a favorite thing. I think it's really a composite. It's a wonderful place to live. It's beautiful. It's well organized. There are lots of amenities in terms of whether you're safe, a great library and facilities, the shopping. There are just numerous things that make Beverly Hills a truly wonderful place to live. We just came back from Italy and we're getting in the car and I'm glad we went and we had a wonderful time, but every time we come back, we say, oh, we are so glad to live here.

Costas (0-2) pitched a complete game, allowing six runs (four earned) and 10 hits in nine innings, striking out one and walking one.

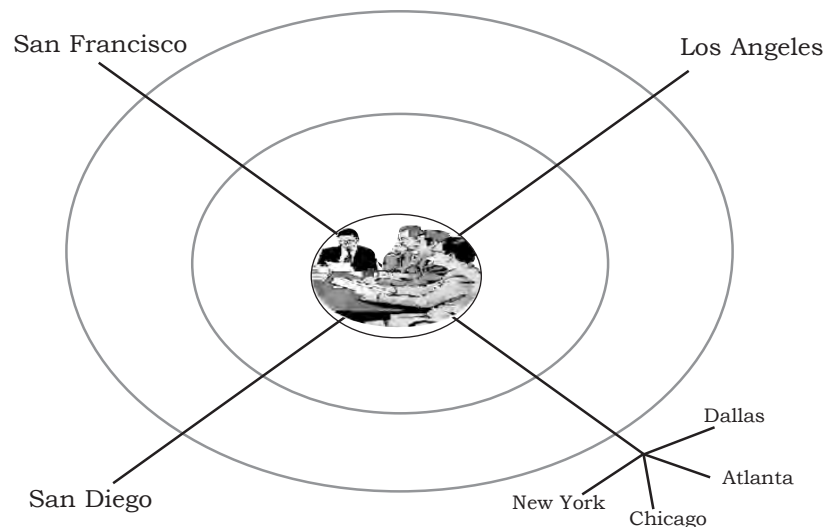

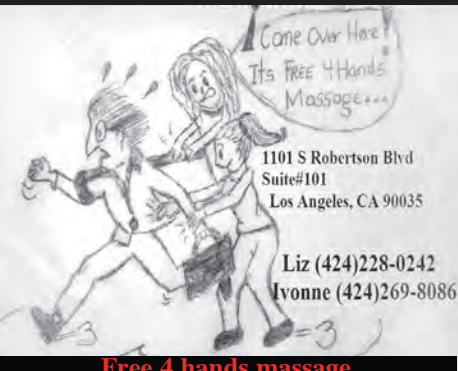
